Title: Amend House of Deputies Rule IV.7 [Legislative Committees]
Legislative Action Taken: Adopted
Final Text:

Resolved, That the Rules of Order of the House of Deputies be amended to read as follows:

IV. Legislative Committees.

7. Not later than 60 90 days in advance of the opening date of the Convention, the President may appoint the following Legislative Committees, and such other committees as may be deemed necessary, and shall designate the Chair, Vice-Chair, and Secretary thereof,
