Resolution Number: 2006-A072
Title: Gather a Culturally and Linguistically Diverse Collection of Music
Legislative Action Taken: Concurred
Final Text:

Resolved, That the 75th General Convention direct the Standing Commission on Liturgy and Music to gather a collection of music to broaden the cultural breadth of the music of the church, and to make native-language materials available to non-English speaking worshiping communities; and be it further

Resolved, That the means of gathering and development of these materials use models which would innovatively draw on and reflect our Church's liturgical, cultural, racial, generational, gender, and ethnic diversity; and be it further

Resolved, That the Standing Commission be directed to appoint a Committee to oversee the collection of this music; and be it further

Resolved, That the General Convention direct the Joint Standing Committee on Program, Budget and Finance to consider a budget allocation of \$35,000 for implementation of this resolution.
