### SUMMARY OF THE COMMITTEE'S WORK

The Committee on Pastoral Development provides support to the body and members of the House of Bishops by acting as a Council of Advice for the Office of Pastoral Development and as a sounding board for the Director of the Office of Pastoral Development and by helping to discern the pastoral needs of the larger Church.

The Committee generally met twice a year during the triennium. During these meetings the Committee acted as a resource to Bishop Hopkins, the Director of the Office of Pastoral Development, and to the Presiding Bishop in areas relating to the episcopate. Particular emphasis has been on transitional issues for newly elected bishops and their spouses, deployment and career matters, pastoral concerns, and wellness. The Committee worked with Arlin Rothauge in its consideration of the diocese as a system, part of the Committee's ongoing commitment to consider and examine the relationship between the mission of the Church and diocese, and the Committee continued its discussion and research on the major paradigm shift from parish ministry to the episcopacy with the aim of writing a theological reflection on the office of the episcopacy.

During the triennium Beverly Wolfrum and Bishop Frank Griswold submitted their resignations to the Committee, and the members of the CPD acknowledge with great appreciation their efforts and commitment to the Committee.
