
You are hereby notified as follows:


(i) The Ecclesiastical Trial Court of the Episcopal Diocese of Bethlehem, PA, entered a Judgment on August 22, 2002, as amended on October 25, 2002, that the Respondent had committed the offenses of Immorality and Conduct Unbecoming a Member of the Clergy; and

(ii) The Ecclesiastical Trial Court of the Episcopal Diocese of Bethlehem, PA, adjudged a sentence of Deposition with respect to Count I of the Presentment, Immorality, and a sentence of deposition as to Count II of the Presentment, Conduct Unbecoming of a Member of the Clergy; and

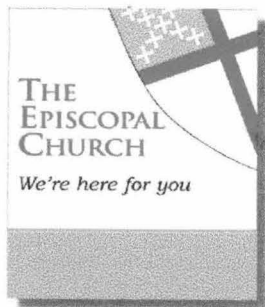
(iii) The undersigned intends to pronounce the sentence adjudicated by the Ecclesiastical Trial Court.

You are further notified that within thirty (30) days after service of this Notice, the Respondent may appeal to the Court of Review of the Third Province by serving a written notice of appeal on the Ecclesiastical Authority of the Third Province, the Right Reverend Robert W. Ihloff, and a copy on the Presiding Judge of the Ecclesiastical Trial Court, John E. Feather, Jr., Esq., and the Presiding Judge of the Court of Review. The Notice shall be signed by the Respondent or the Respondent's counsel, and shall briefly set forth the decision from which the appeal is taken and the grounds of the appeal, and a copy of the decision of the Trial Court shall be attached.
