In accordance with Canon IV.3.13, the Church Attorney, on September 16, 2008, submitted to the Committee his findings and recommendations based on his investigation into a Charge under Canon IV.3.5 that Rev. Randolph M. Bragg ("Respondent") may have committed one or more canonical Offenses.

The Committee considered the Report of the Church Attorney dated September 16, 2008 (the "Report"), the Temporary Inhibition against Respondent issued by Bishop Lee by letter dated July 22, 2008, and the Report of the Diocesan Response Team dated May 1, 2008.

After review of all the information before it, and upon due deliberation, the Committee concluded under Canon IV.3.14(c) that the information, if proved at trial, provides Reasonable Cause to believe that the Offenses described below were committed and that the Respondent committed the Offenses.

COUNT I – Immorality

- 1. In or about March of 2005, Respondent was Rector of St. Andrew's in Arlington.
- 2. Beginning in the fall of 2004, the Complainant, Plan, began attending St. Andrew's.
- 3. In or about March or early April of 2005, Ms. P encountered the Respondent on the walkway outside the main entrance to the Church as she was leaving after a Sunday service. The Respondent wrapped his arm around her back and put his hand on the side of her breast and also kissed her briefly on the lips.
- 4. In or about April of 2005 or approximately one month after the incident described in Count I above, Ms. P again encountered the Respondent on the walkway outside the main entrance to the Church as she was leaving after a Sunday service. After a discussion about the sermon with Ms. P , Respondent placed his hands on her breasts and kissed her on the lips.

The Committee charges that the Respondent, by the conduct recited above committed the Offense of Immorality, contrary to Canon IV.1.1(b).

COUNT II - Violation of Ordination Vows

- 5. In or about March of 2005, Respondent was Rector of St. Andrew's in Arlington.
- 6. Beginning in the fall of 2004, the Complainant, Person, began attending St. Andrew's.
- 7. In or about March or early April of 2005, Ms. P encountered the Respondent on the walkway outside the main entrance to the Church as she was leaving after a Sunday service. The Respondent wrapped his arm around her back and put his hand on the side of her breast and also kissed her briefly on the lips.
- 8. In or about April of 2005 or approximately one month after the incident described in Count I above, Ms. P again encountered the Respondent on the walkway outside the main entrance to the Church as she was leaving after a Sunday service. After a discussion about the sermon with Ms. P , Respondent placed his hands on her breasts and kissed her on the lips.

The Committee charges that the Respondent, by the conduct recited above committed the Offense of Violation of Ordination Vows, contrary to Canon IV.1.1(h).

Count III - Conduct Unbecoming a Member of the Clergy

- 9. In or about March of 2005, Respondent was Rector of St. Andrew's in Arlington.
- 10. Beginning in the fall of 2004, the Complainant, Beginning in the Complaina
- 11. In or about March or early April of 2005, Ms. P encountered the Respondent on the walkway outside the main entrance to the Church as she was leaving after a Sunday service. The Respondent wrapped his arm around her back and put his hand on the side of her breast and also kissed her briefly on the lips.

12. In or about April of 2005 or approximately one month after the incident described in Count I above, Ms. P again encountered the Respondent on the walkway outside the main entrance to the Church as she was leaving after a Sunday service. After a discussion about the sermon with Ms. P , Respondent placed his hands on her breasts and kissed her on the lips.

The Committee charges that the Respondent, by the conduct recited above committed the Offense of. Conduct Unbecoming a Member of the Clergy, contrary to Canon IV.1.1(j).
