## PRESIDENT'S ADDRESS

---

Members of the Woman's Auxiliary in the Diocese of Albany:

The close of the year since the adoption of our new constitution, with its radical changes in policy of administration, brings us face to face today with the conduct of our first election with the parish branches voting as units.

For forty-one years the officers of the Executive Board of the Woman's Auxiliary in this Diocese have been appointed by the Bishop. The trend of the times in this democratic age is for officers to be elected by the organization which they are to represent. It is the method recommended by the National Executive Board, and that followed by nearly all of the dioceses of the Church at large. It is a fact to be recorded that the change from the old order to the new in the Diocese of Albany occurred the same year that General Convention elected a Presiding Bishop for the first time in its history of one hundred and forty-four years.

The right of a Bishop to become automatically the Presiding Bishop of the Church by seniority, when that office became vacant, gave way to popular election at the General Convention held in New Orleans in 1925.

The Most Rev. John Gardner Murray, Bishop of Maryland, is the first Presiding Bishop to be so chosen.

We regret exceedingly that our Presiding Bishop can not be with us today. We rejoice that Bishop Murray is on the high road to recovery after his recent illness, and our prayers and hope are that his pastoral visit is only deferred.

The reports just presented show that the past year has been an active and successful one. A special effort for Japan Reconstruction was launched in November, by asking for contributions for a Gold, Silver and Jewelry Offering for St. Margaret's School, Tokyo.

The Auxiliary's sincere thanks and deep appreciation go out to the twenty-three parishes that so generously responded to the call; to Mr. Henry D. Rogers, Treasurer of the Albany City Savings Bank, for storing the collections, when received, in the vaults of the bank; to the Church Service League of St. Peter's Church, Albany, for splendid co-operation in having the offerings displayed for sale in connection with its annual fair in the Hotel Ten Eyck; to the appraisers from the Van Heusen Charles Co.; to Mr. John P. Failing for use of fine show rooms at 184 State Street for the continuation sale in December; to the Municipal Gas Co., for use of tables; to St. Peter's parish house for chairs; to the Albany Police Department for special protection; to Mr. Robert Brabb, jeweler, for sending used stuff to the United States assay office in New York City for melting; and

lastly, to the members of the committee who gave so unselfishly of their energy and time that the Diocese of Albany might present a creditable offering to this worthy enterprise. About \$1,400 was realized from the effort.

Appreciation for the aid to the Building Fund is best expressed by Miss Heywood, a U. T. O. worker, and Principal of St. Margaret's School, when she states "that plans are to be made for a group of buildings which shall worthily represent the missionary faith of America, of which the central building is to be the chapel, showing what St. Margaret's has done and can do, creating new links in the chain of mutual understanding, and a common faith that will do more than ambassador or statesmen to bind our countries together in peace."

Our program for 1926 now spreads before us. We are pledged to the Resolution on the Message adopted in New Orleans,—Payment of all general Church quotas; so in planning our financial program the Executive Board had in mind our Auxiliary pledge to general missions. This counts on the parish quota for budget and helps our diocese do its share of the Church's work. It heads our list of pledges, and is placed at \$3,000.00, an increase of 100 per cent. over that of many previous years. Let it be the aim of every parish to contribute to this pledge.

The Corporate Gift is a special within the Church's Program, and differs from the Emery Fund and the Bishop Tuttle Fund, which were specials outside the Church's Program. Our pledge to the Corporate Gift is \$150 for St. Agnes' School, Kyoto, and \$150 for St. Mark's School, Nenana, Alaska, and it counts on our diocesan quota for advance work. Every branch is asked to participate in the Corporate Gift. Will not every branch make a study of the year book just published, giving careful attention to the budget and pledges for 1926?

Let us, the women assembled here today, go back to our parishes with strong determination to do all in our power to further the work of the Auxiliary, realizing that only through faith and personal dedication to Jesus Christ, can we hope to bring to fruition our human endeavors. Let us be satisfied with nothing less than our best in prayer, study, work and gifts, confident that His power, His will, His life in us, make it all more than "worth while."

## MINUTES OF THE ANNUAL MEETING, 1926

---

The Annual Meeting of the Albany Diocesan Branch of the Woman's Auxiliary to the National Council of the Church was held in St. Paul's Church, Albany, April 28 and 29, 1926. The meeting opened with a service in the Church at 8 o'clock Wednesday evening, the sermon by the Rev. Charles E. McAllister, General Secretary, Field Department.

Holy Communion was celebrated at 9:15 a. m., Thursday, with the Rector, Archdeacon Brooks, Celebrant, assisted by the Rev. Alfred J. Miller. The U. T. O. Offering was presented at this service.

The President, Mrs. F. Herbert Grey, called the business meeting to order at 10:15. A most cordial welcome was given to the delegates by Archdeacon Brooks.

Minutes of the Semi-Annual Meeting, held in St. John's Church, Ogdensburg, November 4 and 5, 1925, were accepted as read.

Annual reports were presented by Treasurer, Treasurer of U. T. Offering, Box Secretary, Corresponding Secretary, Educational Secretary, Chairman of Committee on Altar Supplies. All reports accepted.

A motion made by Mrs. Seede, seconded by Miss Tibbits, was carried, "That the goal for the U. T. O., to the next Triennial at Washington, D. C., 1928, be \$15,000."

Motion made by Mrs. Francis T. Brown, seconded by Mrs. Conover, and carried. "That we of the Albany Diocese uniformly, follow the directions issued by New York Headquarters, and report the actual value of Mission boxes sent; giving as a separate item, any transportation expenses incurred."

Mrs. Rogers, our Treasurer, spoke of the "Standard of Excellence" suggested for Parish Branches of the Auxiliary. The Diocese of Newark is now using it and hopes more will report in 1926.

The Gold, Silver and Jewelry sale reported a result of \$1,337.17, 23 branches contributing. This sale was for St. Margaret's School, Japan. A letter of thanks and great appreciation was received from the U. T. O. Missionary there.

The six objects of the "Corporate Gift," for which the Woman's Auxiliary has undertaken to secure offerings, were brought before the delegates. The two for 1926 will be: St. Agnes' School, Kyoto, Japan; St. Mark's School, Nenana, Alaska—"Specials." \$150 for each has been pledged from the Diocese of Albany.

The Report of the C. P. C. is given in the Year Book. Mrs. Kearton, the Diocesan Correspondent, was unable to continue, we very much regret.

Report from Girls' Friendly was presented. The President's address to the Woman's Auxiliary is given in the Year Book.

On roll call, 374 delegates responded, representing 55 branches. Luncheon was served at 1:15 in the parish house.

Business resumed at 2:15, when the election of officers took place. Miss Ruth Hall, Educational Secretary, was reelected; and Mrs. T. A. W. Shock, as Recording Secretary.

A Resolution was presented by Miss Tibbits and voted, "That the Woman's Auxiliary of the Diocese of Albany send to the Presiding Bishop of the Church, the expression of our great regret at his inability to be with us at our Annual Meeting, and of our warm wishes for his restoration to health, with the assurance of our devoted loyalty to the great and blessed work for Christ in which he and our Council are leading us."

A Resolution was presented by Mrs. Conover and voted:

"Mrs. Gage, Secretary for the new branch, St. Margaret's, Menands, underwent a very serious operation this morning. It was for her we prayed at the Celebration. I move that the sincere sympathy of this meeting be sent to Mrs. Gage, with the assurance of our earnest prayers for her complete recovery."

Silent prayer.

It was suggested by Miss Townsend, and proposed by Mrs. Sawyer, of St. Peter's, that a letter of appreciation be sent to the Rev. Charles McAllister. A resolution was then offered that a letter of hearty thanks be extended to St. Paul's Branch, for the hospitality we all so much enjoyed.

The meeting was then declared adjourned.

The Semi-Annual Meeting of the Albany Diocesan Branch of the Woman's Auxiliary to the National Council of the Church was held in St. James' Church, Oneonta, October 27 and 28, 1926. The Rector, the Rev. W. Hubert Bierck, gave a hearty welcome to the delegates and read a letter from Bishop Nelson, regretting he could not be present. The President, Mrs. F. Herbert Grey, presided at the business meeting, which was held at 2:30. Minutes of the Annual Meeting, held at Ogdensburg, were accepted as read by the Secretary. Annual reports were presented by the following: The Treasurer, Treasurer for the United Thank Offering, Corresponding Secretary, Box Secretary, Extension Committee and Educational Secretary, Church Periodical Club, Committee on Altar Furnishings, Managers of Susquehanna, and accepted. The President's Address was then given and will be in the Year Book of 1926. At the roll call 126 delegates responded.

The President appointed Mrs. Hinsdill Parsons, Mrs. Babcock and Miss Townsend, a Nominating Committee for the election of a Second Vice-President, Corresponding Secretary and Box Secretary, whose term of office expire in April. It was announced that the Annual Meeting would be held at Troy, in April.

Miss Powers, one of our U. T. Offering missionaries in China, was present, and gave an intensely interesting talk on her work in Yanchow, China.

At 5 o'clock, evensong and prayers. At 8 o'clock, service in the church, with the address on "The Bishops' Crusade," by Bishop Oldham.

Thursday, SS. Simon and Jude. Holy Communion was celebrated at 7:30, with the Rector as celebrant. At 9:30, Bishop Oldham was celebrant, assisted by the Rev. Gregory Prout. The U. T. Offering was presented at this service.

At 10:30, a conference on "Rural Work In the Diocese of Albany," was held. The Rev. George A. Perry presented the Missionary side; the Rev. Louis Van Ess spoke for Religious Education, and Miss Agnes M. Penrose, the General Secretary of the Church Mission of Help, for Christian Social Service.

The following speakers responded when asked to express their views on "Rural Work:" The Rev. Mr. Ellsworth, of Johnstown; the Rev. Mr. Prout, of Lake Delaware; the Rev. Mr. Springsted, of Richfield Springs, and the Ven. Yale Lyon, Archdeacon of the Susquehanna.

Luncheon was served in the parish house at 1:15. Mrs. Conover, of Schenectady, offered the Resolution: "That a rising vote of thanks be given to the Rector and the women of St. James' for their generous hospitality," which was unanimously carried.

The meeting was then declared adjourned.

## REPORT OF CHURCH PERIODICAL CLUB

---

We have at present on our files 421 periodicals which are being sent by 207 donors. During the past year 429 books and a complete set of Dickens were sent to various individuals and libraries. Catechisms, calendars, odd magazines, Easter and Christmas cards, totaled over 8,000. Several lots of Bibles, Prayer Books and Hymnals were sent, but the number of each was not always reported. Twelve different institutions in the diocese are being assisted.

We sent Miss Thomas \$24, which will be used for the libraries of Boone University and St. Luke's Hospital, Tokyo. This sum was derived from contributions and from the sale of C. P. C. Christmas cards.

There are persistent rumors of lower postal rates. In the meantime we may take courage from the amazing amount of faithful work that is being done by secretaries and donors.

## DIRECTIONS FOR PARISH SECRETARIES

---

Always mention your parish and your town in every communication.

1. The Box Secretary of the Diocesan Branch has on hand letters sent from the Church Missions House, stating needs of missionaries, hospitals and schools in the mission field; also letters approved by our Bishop, which state the needs of the missionaries in our own diocese. When your branch is ready to start work, write to the Box Secretary for such letters.

2. When your branch has undertaken the work for which your selected letter calls, notify the Box Secretary at once, sending her the name and address in such letter, and your address and parish.

3. It is of the utmost importance that, immediately after such decision, all rejected letters be returned to the Box Secretary.

4. Write to the missionary at once, stating when and from whom he may expect a box.

5. Write to the missionary as soon as the box has been dispatched, also to the Diocesan Box Secretary, with a statement concerning the value of the box.

6. Blanks will be sent for a report of the year's work. Read them carefully and fill them out fully. Return them to the Box Secretary at once, correcting any errors which appear in the last report. At this time also write to the Manager of your division, giving any details of work and method in your branch.

7. All boxes of books, single books or magazines, should be reported through the Church Periodical Club.

8. Auxiliaries working on Missionary Boxes other than those specified in the year's allotment will not receive credit from the Church Missions House.

9. Always notify the Corresponding Secretary of any change of branch officers during the year. Keep in touch with the manager of your division, and for any desired information write to the diocesan officers having such matters in charge.

### THE DIOCESAN CORPORATE COMMUNION

January 6th, the Feast of the Epiphany, has been selected by the President and Executive Board as a most fitting time for the Diocesan Corporate Communion, and it is hoped that all the branches in the diocese may unite in this special service.

## CONSTITUTION

Adopted April 30, 1925

### ARTICLE I

**Name**—The name of this Organization shall be "The Albany Diocesan Branch of the Woman's Auxiliary to the National Council of the Church."

### ARTICLE II

**Object**—The object of this Organization shall be to assist in carrying out the purposes and work of the National Council.

### ARTICLE III

**Membership**—The membership of this Organization shall consist of those baptised women in the Diocese of Albany who have agreed to take part in its work.

### ARTICLE IV

**Officers**—The officers of this Organization shall be: A President, a First and a Second Vice President, a Recording Secretary, a Corresponding Secretary, a Box Secretary, an Educational Secretary, a Treasurer, a Custodian for the United Thank Offering, one Manager for each Archdeaconry or division thereof, and a Diocesan Correspondent for the Church Periodical Club. These officers shall constitute the Executive Board. The Executive Board shall formulate the policies, direct the active work of the Organization, have power to adopt and amend by-laws, and receive the resignation of its members.

### ARTICLE V

**Elections**—The President, Vice Presidents, Secretaries and Treasurer shall be elected by ballot at the Annual Meeting, for a term of three years, and shall not be eligible for re-election to the same office for more than two consecutive terms. The United Thank Offering Custodian and Diocesan Correspondent for the Church Periodical Club shall be appointed by the Executive Board for three years, and may be reappointed. The Managers of the Archdeaconries, or Divisions thereof, shall be elected by the branches in said Archdeaconries or Divisions, meeting separately or collectively. This election shall be called by a member of the Executive Board, appointed by the President; the term of office shall be three years, and managers shall be eligible for re-election.

### ARTICLE VI

**Vacancies**—Five members of the Executive Board shall constitute a quorum. Vacancies on the board shall be filled by appointment of the President for the unexpired term.

## ARTICLE VII

**Amendments**—This Constitution may be amended by a two-thirds vote at any Annual or Semi-Annual Meeting, provided that notice of the proposed amendment or amendments have been given with the call to such meeting.

## BY-LAWS

## ARTICLE I

## Duties of Officers

Section 1. The President shall call meetings and preside over them, and further the work in all its phases. She shall serve as Chairman of a Committee on the devotional life of the Branch.

Sec. 2. In the absence of the President, the First Vice President shall act in her place.

Sec. 3. In the absence of the President and First Vice President, the Second Vice President shall perform the duties of the President.

Sec. 4. The Recording Secretary shall send all notices, keep the minutes of all meetings, and shall send a summary of the minutes of every executive meeting to each member of the Executive Board not present at such meeting.

Sec. 5. The Corresponding Secretary shall conduct the correspondence of the Organization, and shall be responsible for the publication and distribution of the Annual Report.

Sec. 6. The Box Secretary shall receive and distribute all information relating to the Missionary Boxes.

Sec. 7. The Educational Secretary shall organize the Parish Branches for educational work and stimulate them by every possible means, coordinating the work with the Diocesan educational plans.

Sec. 8. The Treasurer shall receive, record, disburse and keep account of all money contributed, except that for the United Thank Offering, and shall make a report at the Annual and Semi-Annual Meetings. The Executive Board shall appoint annually an auditor, who shall examine the accounts of the Treasurer before they are presented at the Annual Meeting.

Sec. 9. The Custodian of the United Thank Offering shall be responsible for the collection and presentation of that Fund.

Sec. 10. The Diocesan Correspondent of the Church Periodical Club shall attend to the distribution of religious and secular literature to Missionaries, Laymen or others, and Institutions.

Sec. 11. Managers shall endeavor to stimulate the formation of new parish branches, to infuse greater missionary spirit throughout the archdeaconries, and shall seek to increase intelligent interest in the missionary work of the Church. At least one general meeting shall be held during the year in each archdeaconry. Each Manager shall make a statement of the work done in her archdeaconry to be published in the Annual Report.

## ARTICLE II

### Elections

Section 1. Election shall be by ballot, every Parish Branch being entitled to one vote.

Sec. 2. At the Annual Meeting in 1925, the President, First Vice President and Treasurer shall be elected for three years; the Second Vice President, Box Secretary and Corresponding Secretary for two years, and the Educational and Recording Secretaries for one year; and thereafter, at each Annual Meeting, the offices which become vacant shall be filled.

## ARTICLE III

### Divisions of Archdeaconries

#### Albany—

First Division—Albany County, and that portion of Rensselaer County which lies south of the southern boundaries of the townships of Brunswick, Grafton and Petersburgh.

Second Division—Greene and Columbia Counties.

**Mohawk**—Herkimer, Hamilton, Fulton, Montgomery and Schenectady Counties.

#### Ogdensburg—

First Division—St. Lawrence County.

Second Division—Franklin and Clinton Counties, with the townships of St. Armand and North Elba in Essex County.

#### Susquehanna—

First Division—Otsego and Schoharie Counties.

Second Division—Delaware County.

#### Troy—

First Division—Washington County, and that portion of Rensselaer County which lies north of the southern boundaries of the townships of Brunswick, Grafton and Petersburgh.

Second Division—Saratoga County.

Third Division—Warren County, and all of Essex County, except the townships of St. Armand and North Elba.

## ARTICLE IV

**Meetings**

Section 1. The Annual Meeting shall be held in April, the time, place of meeting, and program to be decided by the Executive Board.

The Semi-Annual Meeting shall be held in October, in the several Archdeaconries, in rotation, the time, place, program, and order of rotation to be decided by the Executive Board.

Sec. 2. The Executive Board shall meet monthly from October to May, inclusive. Special meetings of the Executive Board may be called by the President, or at the request of three of its members.

## ARTICLE V

**Finance**

A current expense fund shall be provided for printing, postage, stationery, traveling expenses of speakers for the Annual and Semi-Annual Meetings, and for other legitimate expenses.

This fund shall be made up of branch fees, due in January of each year. The minimum branch fee shall be \$2.00.
