JOURNAL

FIRST DAY.

The Twenty-first Annual Convocation of the Protestant Episcopal Church in the Missionary District of Arizona met in St. Andrew's Church, Nogales, on Tuesday, April 15th, 1913, at 11 A. M.

The Holy Communion was celebrated by the Bishop, assisted by the Rev. James H. McPherson and the Rev. Stephen F. Power. At this service Rev. Mr. Power gave an address.

The Convocation was called to order immediately after this service by the President. The roll of clergy entitled to seats and votes was called from a list furnished by the Bishop. Those marked with a star were present: Bishop, *Rt. Rev. J. W. Atwood; Presbyters, Rev. Frederick T. Bennett, Rev. Malbone H. Birckhead, *Rev. Bertrand R. Cocks, *Rev. William J. Dixon, Rev. Robert H. Herron, *Rev. J. Rockwood Jenkins, *Rev. James H. McPherson, *Rev. Joseph Lyons Meade, *Rev. Stephen F. Power, *Rev. William J. Scarlett, *Rev. Ernest W. Simonson, Rev. Creighton Spencer, Rev. Jacob M. White.

The roll of Wardens was read from a list furnished by the Bishop and the following were present: St. Andrews Church, Nogales, W. C. Budge.

A quorum being present the Bishop declared the Twenty-first Convocation to be duly organized.

It was resolved, That the courtesies of the Convocation be extended to the Rev. Mr. Hunting, Secretary of the Eighth Department.

A recess was taken to 2:30 P. M.

At 2:30 P. M. Convocation re-assembled. The Committee on Credentials made its report.

Your committee on credentials reports that seven parishes and missions have elected lay delegates to this Convocation. They are Phoenix, Douglas, Prescott, Flagstaff, Globe, Tucson, and Nogales.

The Secretary appointed the Rev. Mr. Meade as his assistant.

The Bishop read his Annual Address and Charge (see appendix A). The Bishop introduced the Rev. George C. Hunting, Secretary of the Eighth Missionary Department, who addressed the Convocation.

REPORT OF THE PROTESTANT EPISCOPAL CHURCH CORPORATION OF ARIZONA.

On call of the Right Reverend Julius W. Atwood, President of the Board of Directors of the Protestant Episcopal Church Corporation of Arizona, the Board of Directors convened in Phoenix, Arizona, on February 10, 1913, and there were present Right Reverend Julius W. Atwood, President, the Hon. John J. Hawkins, Chancellor, and N. A. Morford, Secretary and Treasurer.

The President of the Board presented the Petition of the Rector, Wardens and Vestrymen of Grace Episcopal Church of Tucson to sell certain property in Tucson, held by Grace Church, and described in the Resolution and Petition presented, for the value of \$25,000.00.

Upon consideration by the Board of Directors, the Petition appearing to be regular in all respects and the sale of the described property desirable, upon motion, duly seconded, it was unanimously voted by the Board of Directors, that the Petition be granted. On motion of the Chancellor, the President and Secretary of the Board of Directors were authorized to execute, acknowledge and deliver a suitable Deed to the Property in the name of The Protestant Episcopal Church Corporation of Arizona, in which the title to the property rests.

On motion, it was further ordered, that the Secretary of the Board request the Rector, Wardens and Vestrymen of Grace Episcopal Church to furnish the Directors of this Corporation with the form of Deed, and Copy of the Contract of Sale, if desired, to be executed by the Board of Directors.

On motion, the Petition, letters, etc., regarding the sale of the property were made a part of the Minutes of the Board of Directors. On motion the meeting then adjourned.

Under the direction of the Board of Directors above noted, the President and Secretary took up the matter of the preparation and execution of a proper Deed to the property, in favor of Mr. Mose Drachman, of Tucson, which Deed was placed in Escrow in Arizona National Bank at Tucson, under the direction of the Committee of Vestrymen of Grace Church, chosen to handle the business for the Church.

REPORT OF COMMITTEE ON WORK AMONG BOYS.

Your Committee on Work Among Boys respectfully report that we appreciate and recognize the great value and importance of definite work among the boys of this Church, and such boys also as this Church can reach, as helping in no small degree to develop the churchmen and citizens of the future, as well as tending now greatly to increase Sunday School attendance. We would therefore recommend to all the clergy of the District who have no organization for boys as yet, that they endeavor as soon as possible to form some such organization in connection with their Sunday Schools, and that as far as possible they give their personal supervision to such organizations, or else secure the services of experienced laymen for that purpose.

Further: While we do not at present suggest any particular form of organization for boys or any special plan for the unification of the work, we would recommend to each of the clergy of the District to read such books as Stanley Hall's "Adolescence" (the one volume abridged edition) and Byron Ferbush's "Church Work for Boys."

We would also be glad to correspond with any of the clergy on this important subject and hope that some time for its presentation and discussion may be allowed during the present session of Convocation.

The Bishop appointed Lay Readers for the current year.

SOCIAL SERVICE COMMISSION REPORT.

The Committee on Social Service appointed at the last Convocation begs leave to report on its year's work as follows:

In order that it might be facilitated in any work it might undertake by finding the proper machinery ready at hand for the carrying on of its plans, the Committee first undertook the organization in every parish or mission in this district of a branch Social Service Committee. This organization is not as yet complete. Some parishes have reported the formation of such a committee; others have not. It is hoped that those not yet having formed a Social Service Committee will speedily do so, as this is a great help to the district committee.

Last fall the Committee originated and carried on in this State an Educational agitation for clean marriages. We urged the prohibition of certain classes of marriages—those of unsound mind, those in the advanced stages of tuberculosis, those afflicted with venereal diseases, the chronic alcoholics, and the habitual criminals. We advocated the requiring of a medical certificate before marriage. Through the efforts of the Commission and some of the branch committees some ministerial and medical associations took up the campaign. A bill, embodying the above suggestion, practically in the form drawn up by the chairman of this Commission, was introduced into the State Legislature. It passed the Senate by a vote of fourteen to four. On being referred to the House it was reported out favorably by the Committee, but owing to the congested condition of legislation failed to come before the House as a whole before adjournment. The bill will be re-introduced into the present session, however, and a still more vigorous effort made to carry it to a completely successful issue.

Your committee has also been advocating and fighting for the uniform State law on marriage and divorce now before the Legislature.

Your committee sees much work of a varied nature before it, vital, interesting and most useful, and begs for the hearty support of the Church in this District.

The following preamble and resolution were adopted:

Whereas, it is generally agreed that there is an increase in the number of mental, moral and physical delinquents; and,

Whereas, one of the most prolific sources of this evil today is the indiscriminate mating of those who are not fit to bring into the world strong and healthy children; and

Whereas, much time and energy are consumed in dealing with the frequent results of the marriage of the unfit—trying to eliminate hereditary disease, insanity, perversions, degeneracy and divorce—and

Whereas, the cause of much of these evils has been largely overlooked, and

Whereas, more and more social workers of all kinds are turning their attention to this root evil;

Be It Resolved, That this convocation urge and impress upon the clergy of this missionary district the need of safeguarding the integrity of the race and the home so far as the power lies with them by assisting in the education along these lines of their congregations and fellow townsmen, and by encouraging, if not insisting upon, the presentation before marriage of a medical certificate signed by a reputable physician certifying that the applicants for marriage are mentally and physically sound, have no contagious or communicable disease, and in his opinion, are free from any condition incompatible with the ends of matrimony; and further, that the clergy and social service committees are urged to assist in the movement for social and moral betterment by initiating and encouraging special legislation looking to the prohibition of the marriage of those mentally and morally and physically unfit; and, further, that the clergy of this district and the social service committees be urged most earnestly to do all in their power to secure the passage of the bill now before the State Legislature to prevent the marriage of five classes of persons—(a) those mentally unsound, (b) those in the advanced stages of tuberculosis, (c) those having any venereal disease, (d) the chronic alcoholics, and (e) the habitual criminals, by requiring a medical certificate signed by a reputable physician before such license to marry may be issued.

And, finally, that this convocation send a memorandum to the Legislature now in session in Phoenix urging most emphatically the passage of this health bill, known in the last session as S. S. B. No. 89.

It was resolved That this convocation urge upon the Legislature now in session the passage of the bills known in the previous Legislature as S. S. Bills Nos. 69, 70.

At 12 o'clock recess was taken until 2:30 p. m.

Convocation reassembled at 2:30 p. m. and the report of the Committee on Work Among Boys was read and discussed.

It was Resolved, That the convocation endorse the report of the Committee on "Work Among Boys," thank them for this sugges-

tions and that a portion of the next Convocation be set aside for a full consideration of this subject.

Reports of the work in the field were made by the Missionaries and also of the work in the various parishes.

It was Resolved, That each clergyman be asked to send to the Registrar a history of his parish or mission, so that a history of the church in Arizona may be compiled.

At 4 p. m. there was a joint session of the Convocation and the Woman's Auxiliary. At this meeting a report of the year's work was made by the Secretary, Mrs. Wm. J. Dixon. (See Appendix B.) The Rev. Geo. C. Hunting, Secretary of the Eighth Missionary Department, addressed the meeting.

It was Resolved, That this meeting of the Woman's Auxiliary and the Convocation recommend that a committee be appointed by each branch of the Woman's Auxiliary, whose work it shall be to solicit joint subscriptions for the Spirit of Missions and the Arizona Record.

THIRD DAY.

9:30 a. m. Thursday—Morning Prayer was read by the Rev. Joseph Lyons Meade. At 10 o'clock Convocation was called to order by the President and the Minutes of the previous day were read and approved.

Mr. N. A. Morford was re-elected Treasurer.

The Report of the Committee on next Convocation was read and adopted.

REPORT OF COMMITTEE ON NEXT CONVOCATION.

The Committee on the meeting of the next Convocation recommends the acceptance of the invitation extended by the vestry of Trinity Pro-Cathedral, Phoenix. They recommend further that the date of the next Convocation be Tuesday, April 28, 1914.

REPORT OF THE COMMITTEE ON SUNDAY SCHOOL WORK.

Your Committee on Sunday School Work begs leave to report as follows:

That it has suffered a severe loss along with the rest of this Missionary District, in the removal to work in the East of its Chairman, the Rev. J. S. Moody. Owing to the fact of Mr. Moody's absence, this vacancy has not been filled and there has been no meeting during the year of the Commission.

We now suggest, however, that a Sunday School Exhibit be arranged for the next Convocation, which exhibit shall show in conve-

nient form several suggested courses of instruction: various methods of work; the details of the business organization of the Sunday School, and such other suggestions and plans for Sunday School work as would be of practical value to the members of this Convocation.

The Committee renews its recommendations made at the last Convocation.

The Committee urges the vast importance of Sunday School work, and begs that a new committee be appointed whose duty it shall be during the coming year to investigate new methods of Sunday School work, make suggestions from time to time to the clergy, and arrange for an Exhibit for the next Convocation, if this suggestion be accepted.

The report of the Sunday School Work with its recommendations was adopted.

REPORT OF THE COMMITTEE ON STATE OF THE CHURCH.

The Committee on the State of the Church begs leave to report as follows:

A study of the records and statistics of the parishes and missions shows us that a year of excellent progress has just been completed—such progress that we can truly thank God, take new and high courage, and fire our wills to maintain the growth we have begun.

In some ways the development of the church work in Arizona has not been so spectacular as last year. Then, due to an influx of a larger number of clergy than had ever worked here before, the opening up of new fields where the church had never been, or at least not for many years, we experienced a sudden leap forward.

This year we can again report splendid progress—in some departments much greater than last year—and we feel that we have now come into our normal stride, and that each year the growth will be ever steadily onwards and upwards.

The number of clergy has remained the same, though the personnel has changed—losses deeply regretted, and additions most cordially welcomed. Much new equipment has been added in the way of church buildings, parish houses, etc. By this enlargement of the church plant we have been able to touch the life of the communities in more and varied ways. Several new mission stations have been opened up, where the church has been eagerly received, and where the opportunities are unbounded, and the outlook most promising.

A more definite idea of what has been done can be gleaned from a few statistics. The number of Sunday School scholars has grown from 681 to 807; the number of communicants from 1,346, reported last year, to 1,807, a gain of 461 over last year, whereas the gain last year over the previous year was 220; and the total contributions from \$18,500 in 1912 to about \$27,000.00, an increase of over \$8,000.00. Comparing this with the year before, shows that then a gain was made of about \$4,000.00 over the figures of the previous year, whereas this

year we report an increase double that amount. The number of confirmations fell short of those recorded last year by 16; 131 this year, being added by this method, as against 147 in 1912. This we expected owing to the larger number of new fields opened last year. The number of confirmation this year is, however, almost double that of two years ago. This all shows a fine growth, of which we may all be proud, and for which most thankful.

The Woman's Auxiliary sounds a forward note, and reports much progress.

We may be pardoned a little self-congratulation if we point again to the excellent work done this year by St. Luke's, our home for tuberculosis in Phoenix. More patients have been treated than ever before, and in a better way. New equipment has been added, new appliances. The laboratory is doing not only the bacteriological work of the Home alone, but also a great amount of work for the community and State. It is one of the two bacteriological laboratories in the State, and is indispensable to the physicians of this commonwealth, and to the health of the community. St. Luke's work is not confined within the boundaries of the Home, but in many ways reaches out into the community, and leads it into healthier paths. St. Luke's is growing; its opportunities widening; and we are fortunate in having at the helm men who have the vision of this opportunity. The value of St. Luke's cannot be over-estimated, and she is extending the work of the Church in this splendid way of ministering to the health of the community.

With equal pride we consider the work of our Hospital of the Good Shepherd at Fort Defiance. The hospital stands on the Navajo Indian Reservation, and ministers to thousands of Indians. For years it stood alone. It has always been overcrowded. Recently, it was decided hereafter to receive only eye, ear and throat cases, the others of the sick being turned over to the government hospital, recently established. As trachoma is very prevalent, this field makes unlimited demands. Besides helping those who come to its doors, the superintendent makes journeys into the surrounding country looking for those who need medical assistance, and literally compelling them to come in—a good shepherd indeed! The modern equipment of the hospital is also loaned to other surgeons; so that the work of the Good Shepherd Hospital is not confined within its four walls.

In conclusion, the year has been one of expansion into new fields, but primarily of deepening our influence, and tightening our grip in the places where the Church had already gone. We are stronger in every way than at this time last year. The Church means more in and to the State than ever before. And never did a Church have a greater opportunity in any State than this Episcopal Church in Arizona. The door is open, and the call sounds clear. The harvest truly is ripe. May the Lord of the harvest speedily send into this district of ours, more laborers—men who have the vision, can see the need, and have the

power to satisfy it. With more men, and the money to support them, this Church could penetrate into every nook and corner of this State.

We who are here have no need to be reminded of the opportunity. The State is leaping forward in its material development. May we labor that the Son of Man may also find faith in Arizona. The results of the year's work just past confirm our belief in the great appeal this Church makes to this State. May God grant each one of us a deeper consecration of ourselves to this great work for Him, so that, meeting together next year, we may point to new fields conquered, new victories won, for Christ and His church.

The Bishop appointed the following Committee on General Missions: Rev. J. L. Meade, Rev. Jacob M. White, Rev. J. Rockwood Jenkins, Mr. W. Roy Lyon, Flagstaff; Mr. McDonald Robinson, of Williams.

The report of the Hospital Mission of the Good Shepherd was read. (See Appendix C.)

It was Resolved. That the report of the Hospital Mission of the Good Shepherd be adopted and the warm thanks and deep appreciation of this Convocation be sent to Miss Thackara and Dr. Wigglesworth for their splendid work on the Navajo Reservation.

It was Resolved, That the Committee on General Missions be continued and instructed to co-operate with the Department Commission.

It was Resolved, That this Convocation, following the suggestion of the Diocese of California, memorialize the General Convention that a committee of seven Bishops, seven Presbyters, and seven Laymen be appointed to consider the question of Prayer Book Revision; particularly urging upon their attention the revision of the Baptismal and Burial offices; and urging a definite recognition of larger flexibility in the use of rubrics.

It was Resolved, That we urge upon the Legislature now in session in Phoenix the passage of the bill known in the last Legislature as S. S. Bill No. 73.

It was Resolved, That a committee of three be appointed to take up with the Railroads the question of securing reduced rates to the next Convocation. The President appointed Mr. Franklin D. Lane, Mr. E. J. Bennett and the Secretary as this committee.

It was Resolved, That the President be requested to appoint a Committee on Constitution and Canons consisting of five members, two of whom shall be the Bishop Ex-officio and the Chancellor of this Missionary District to draw up a set of canons for use in the Missionary District of Arizona, using as a basis the fundamental forms set forth by the General Convention and in accordance with the requirements of the general canons and to report at the next Convocation. The Bishop appointed Rev. E. W. Simonson, Rev. Wm. J. Dixon, Hon. E. W. Lewis.

It was Resolved, That it is the sense of this Convocation that the time has not yet arrived when it is in the interest of the Church to

change its name and the Convocation desires to memorialize the General Convention to this end.

It was Resolved, That as a partial recompense for his labors as Secretary, the sum of Fifty Dollars be paid the Rev. B. R. Cocks.

It was Resolved, That this Convocation express its appreciation to the Rector and Congregation of St. Andrew's Mission by a rising vote of thanks for the very cordial welcome and entertainment of its members.

It was Resolved, That copies of the Journal of this Convention be printed for distribution, the number of the same to be left to the discretion of the Bishop and Secretary.

The President appointed the following Sunday School Commission: Rev. E. W. Simonson, Rev. Stephen F. Power, Mr. C. H. Fitch, Phoenix, and Mr. C. M. Rathbun, of Nogales.

The Bishop appointed the Social Service Commission as follows: The Rev. Wm. J. Scarlett, the Rev. Robert H. Herron, Hon. Edward Kent, Phoenix, Mr. Preston Locke, Ray.

Recess was taken until 2 p. m.

At 2 p. m. Convocation reassembled. The minutes of the day being read and approved, after prayers by the Bishop the twenty-first annual Convocation of the Missionary District of Arizona adjourned, sine die.

Appendix A

Third Annual Episcopal Address and Charge of the Right Reverend J. W. Atwood to the Twenty-First Convocation of the Missionary District of Arizona, St. Andrew's Church, Nogales, April 15, 1913.

Dear Brethren of the Clergy and Laity:

Grace be unto you and peace from God our Father and from the Lord Jesus Christ.

Two Bishops of the church have passed from the ranks of the Church Militant to those of the Church Triumphant since the meeting of our last Convocation. The Right Reverend Charles Chapman Grafton, D. D., Bishop of Fond du Lac, who died last summer, was for many years a picturesque and interesting figure in the House of Bishops. He was born of a Unitarian family in Boston in 1830. In his early manhood he was converted to our church and soon after gave up his business career to study for Holy Orders. The first years of his ministry were passed in Maryland. He was deeply influenced by the so-called Tractarian Movement in the Church and passed some time in Oxford where he became a member of the Society of St. John the Evangelist, commonly known as the Cowley Fathers. He returned to his native city of Boston to become Rector of the Church of the Advent, where he was soon joined by two English members of the order, who later, like himself, became Bishops in the Church. These three men, by their mental and spiritual attainments, by their devotion and aggressive work, exerted a powerful influence in the life of the Church in Massachusetts. There came among them later differences of opinion, and perhaps of a deeper nature which separated them in their work.

Bishop Grafton was a preacher of the Evangelical type, in spite of his theological views. He was earnest and persuasive, although sometimes characterized by a certain amplitude of utterance. He was courteous and kindly in his dealings with others. He was an aristocrat in one sense of the word and yet he was also most democratic in his mode of life and his sympathy. To his sympathetic and affectionate nature may be traced what may have struck some as certain inconsistencies in his opinions and his character. He once told me that he considered himself an evangelical in his heart and a broad churchman in his mind, and yet all this was in accord with his position as a leader of the extreme high church party. I have known him, although

never intimately, from the beginning of my ministry. In these later years I have met him less frequently. But I was with him in Providence at the time he received the telegram informing him of his election as Bishop of Fond du Lac. I was struck with the deep emotion with which he received the intelligence. It was the call of God. He was always ready, I imagine, to make any sacrifice that might be required of him. He would seem from his training, and the experience of his former ministry, to be little adapted to the life of a missionary Bishop. But he was ready with cheerfulness and devotion to undertake any task. He was glad to give up whatever fortune he might possess in order that the church might benefit thereby. His work, however, was not confined to his own diocese. He was a prolific writer and a good deal of a controversialist. Beneath a certain ostentatious sweetness, which R. H. Hutton once described as a characteristic of the men of the Oxford School, there was great inflexibility and firmness and courage in maintaining his opinions and expressing them. He was a great influence in the lives of many living outside of his diocese, and differ as one might from him, it would be hard to cherish any but kindly and generous feelings for one who was so full of the spirit of kindness and generosity himself.

Radically different from Bishop Grafton was the Right Reverend Thomas A. Jaggar, D. D., sometime Bishop of Southern Ohio, but who, at the time of his death last winter, had charge of the American Churches in Europe. He differed in physical appearance, in mode of thought and in the outward experiences of his life. Bishop Jagger was the son of a New York merchant, well educated, and from the beginning of his ministry, he held important rectorships in Yonkers, New York, New York City and Philadelphia, where he succeeded Philipps Brooks as Rector of Holy Trinity Church, from which church he went to become the first Bishop of the newly organized diocese of Southern Ohio. In his early life he was a staunch Evangelical, when party lines were closely drawn. But he broadened in his views with the growing years. He was a preacher of great power with a commanding presence and voice, with a rich and copious command of language. His sermons were full of thought and evangelical fervor, recalling the best preachers of a former generation. His Episcopate was clouded by a long and trying illness, but after years of inactivity he recovered largely his health and again became widely known as a preacher, although he never took up his work again in his old diocese, the duties of which he had assigned to his coadjutor. It was my privilege to know him in the later years of his life. He was always kindly and courteous and appreciative of others; a man of varied accomplishments and deeply interested in what concerned especially the spiritual side of the church's life. Along with this went appreciation of the good things of this world.

The ranks of our own clergy have remained unbroken by death. But I must briefly mention the loss that we have sustained in the death of Mr. John Lowell, Jr., a vestryman and treasurer of St. Mark's Church, Mesa. Mr. Elliot Evans, at one time a vestryman of Trinity Church, Phoenix, and Mrs. J. Mills Kendrick, the wife of the late Bishop of this Missionary District.

WORK IN ARIZONA.

The church has advanced very greatly along material lines this past year. New buildings have been erected and almost every church in the district has been made more attractive and beautiful by improvements and new equipment. I rejoice to believe that there has been progress in spiritual matters as well.

PHOENIX.

Soon after the meeting of our last Convocation, Institutes were adopted by the Bishop on the one hand and the Parish of Trinity on the other whereby the church became a pro-cathedral. The Bishop resigned the office of Rector and the Vice-Rector, the Rev. Wm. Scarlett was nominated to the vestry as Rector by the Bishop, which nomination was confirmed and the new Rector became ex-officio Dean. This arrangement is a temporary one, and can be done away with at the wish of either party, or on the formation of a cathedral organization. We recognize the difficulty of joining a cathedral system with a parish organization, but this would seem the only plan in a place like Phoenix, if we are to have a cathedral at all.

The Church is growing with the development of the city of Phoenix, which has had a remarkable growth and which is bound to increase in population and wealth even more in the future. The value of the church lots, centrally located on the principal avenue, has largely increased. The site of the old church building, which is already becoming too small as well as inadequate for the work, is a valuable one. So already we are in possession of considerable property. While the greater part of the funds must probably come from the people of Phoenix for the erection of the group of buildings, yet it is hoped that people outside of the city, living in various parts of Arizona, will do their part, and it is believed that friends at a distance, realizing that the cathedral will be a center for missionary work and enterprise, will contribute to the fund.

The Dean is hoping during the coming year to hold services regularly in at least two places near Phoenix.

TUCSON.

This church has made progress along many lines of development. The most important event in its recent history is the proposed sale

of the church and the purchase of new lots in another part of the city, on which it is the intention to build a new church, parish house, and rectory.

The Duplex Envelope System has been adopted in this parish with great success. I am confident if it could be adopted in all our churches we should have a great increase in offerings for church expenses, as well as missions.

BISBEE

St. John's Church has been without a Rector for sometime, and this has interfered somewhat with the work. The Rev. Creighton Spencer, who has served the church with fidelity for almost two years, has been compelled to retire on account of the illness of a member of his family, and he has returned east. Fortunately, the Rector of Douglas has been able to join the charge of Bisbee to the care of his own church, and services have been regularly maintained. An effort was made at Easter to remove the indebtedness resting on the church. In the Autumn we expect to have a new Rector to take up the work in this important mission.

PRESCOTT.

A beautiful new altar and raredos were consecrated in St. Luke's church on last Whit Sunday, and the church has also received a legacy of \$1,000.00, which will be the nucleus of a parish house fund,

which is greatly needed for the development of the work. The city itself has not grown of late, but with the opening up of new mines and the development of old ones, it is expected that greater prosperity will return to this beautiful mountain city, where the church has always been strong. By the appointment of two new lay-readers the Rector has been able to devote himself still more to the missionary work in the neighborhood of Prescott.

JEROME.

Especially noticeable has been the increase of interest in Christ Church Mission, where the Rector of Prescott has been holding services in the Congregational Church. Lots have been procured and the money is already on hand for the erection of a simple wooden chapel and Guild house. Nearby is being founded the new town of Clarkdale. It is hoped that some day we can have a settled minister at Jerome who can minister to both of these towns.

WICKENBURG.

The mission at Wickenburg has taken on new life with the improvement in mining conditions and services have been maintained regularly by the Rector of Prescott, assisted by Archdeacon Cocks.

DOUGLAS.

St. Stephens's Church has been made attractive and beautiful throughout its interior by many improvements, at a cost of about \$2,000.00. The chancel has been enlarged, a fine east window given, new chancel furniture, and new pews placed in the church. The Rector, in addition to the care of Bisbee, has temporary charge of Tombstone, and is looking out for other points where he can establish the services of our church.

GLOBE.

St. John's Church has again been unfortunate in losing its minister during the past year, who was obliged to return to his former home in the south on account of the continued illness of a member of his household. The Rev. Robert H. Herron has succeeded to the temporary charge of this mission, and in spite of the limitations of his health, has heroically thrown himself into the work, and endeared himself to the people through his preaching and his personality. The interior of the church has been greatly improved by new pews and other changes in the lighting and heating of the building.

NOGALES.

St. Andrew's Church has felt the disturbance of the war in Mexico as have none other of our missions. Situated on the frontier, business has been sadly interfered with, but in spite of all this trouble, the church has held its own. It is a power in this community for good, and the faithfulness of both priest and people is telling upon the life of the city. The Rector has added to his work the care of unorganized missions at Elgin and Calabasas. The church has a lot for a rectory, and a considerable building fund on hand. This is greatly needed as are rectories in many of our missions. Homes for our clergy would help to solve the financial problem of their support to a certain extent, and add much to their comfort. When not in use by the clergymen the rent paid would be a welcome addition to the income of the parish or mission.

YUMA.

Last year in speaking of the mission at Yuma, I said in my Convocation address: "All we need is a consecrated man, not afraid of work among a pioneer people. A great harvest would follow speedily upon the coming of such a man." This hope and prophesy is receiving its fulfilment today. The services of the church have largely increased in number and attendance. There is new life everywhere. The city is growing and the church is growing. The interior of the church building has been greatly improved by new chancel furniture throughout. New pews have been ordered and a considerable indebtedness resting on the mission removed.

WINSLOW.

Further improvements have been made in the interior of the church and parish house in Winslow. The debt of the latter building has recently been paid in full. There is a new piano, a new carpet on the chancel, new glass in the windows, new chandeliers, and the outer walls of the church have been strengthened. With the building of new and large railroad shops in Winslow, a still greater opportunity is opening before St. Paul's Church. The people are already contemplating the erection of a rectory on the lot which the Woman's Guild has bought and paid for.

The Rector has also been looking after Holbrook where services have been regularly maintained, and he has also visited Ft. Defiance, and intends to hold a service in Adamana, where the Bishop held a service in the Autumn.

FLAGSTAFF.

Epiphany Mission has made rapid history during the past year. The new church, the corner stone of which was laid in October, was ready for services on Palm Sunday. It is a beautiful structure, churchly and dignified, built of stone and fully equipped at a cost of nearly \$10,000.00, including the price of the land. A considerable debt still rests upon it, but it is felt that this can be paid by the people in the not remote future. There is sufficient land adjoining belonging to the church on which a parish house can be built some day. Flagstaff is our only mission with a settled minister whose salary is entirely paid by the congregation. The spiritual life has kept pace with material development. This is seen from the fact that the number of confirmations have been larger in Flagstaff this year, as was the case last year, than in any other parish or mission in this district.

WILLIAMS.

St. John's Mission has had during the past year regular services conducted by Archdeacon Meade twice a month on week nights, and for a part of the time, on two Sundays of the month by Archdeacon Cocks. The imperative need in Williams is for a settled minister and we have long been on the lookout for the right kind of a man. During the year just past a combined chapel and club-house has been built and fully equipped and furnished with no indebtedness resting upon it, at a cost exclusive of land of \$1,500.00. This has become a center for both the religious and the social life of Williams.

MESA.

St. Mark's Church was fortunate in securing the services of a settled clergyman in the person of the Rev. Malbone H. Birckhead of New York in the early Autumn, but unfortunate in losing his services

in December on account of illness. But rapid progress was made during his short ministry. The congregations increased and new impetus and life were put into the church. He was succeeded by Mr. Frederick T. Hall, a student of the divinity school in Philadelphia. A new organ has been purchased and placed in the church. A communion set, a cross, vases for the chancel, and a Lectern Bible have been given recently, all in memory of the late Mr. John Lowell, Jr.

TEMPE.

Only a few services have been held during the year in St. James' Mission. We must wait patiently for future growth in a town already over supplied with churches. This is perhaps the only place in Arizona where our church has been established, where this fact holds true. The reasons for our establishing services was due to the considerable number of our church people who were living in Tempe, a few years ago, many of whom have since removed, and the fact that Tempe is the seat of a large Normal school.

TOMBSTONE.

St. Paul's the oldest church in Arizona, has had only occasional services. Owing to the closing of all work in connection with the mines, the population of Tombstone has dwindled to a few hundred people. There is a Methodist or Congregational church here where services are regularly held. Like the mission in Tempe, the work in Tombstone must be cared for by a neighboring clergyman who will minister to our few church people as occasion demands awaiting the possible future when more aggressive work will be required. But these two missions are the only ones that have not made decided progress during the year.

RAY.

Last year we reported Ray as an unorganized mission in which one or two services had been held. This year we report it as an organized mission under the name of St. David's. Archdeacon Cocks has held services regularly once a month here. This new and important mining camp has grown largely. Many men of influence and education are affiliated with our church. Two fine lots in the best part of the town have been given and the sum of \$1,500.00, largely contributed by the people of Ray is on hand towards the erection of a concrete building which will serve the two-fold purpose of a chapel and clubhouse. This is the most important new work undertaken during the year.

INSTITUTIONS.

St. Luke's Home for the treatment of tuberculosis has increased in the number of its patients and also in efficiency. The bacteriological laboratory has carried on a large and valuable work. A new bunga-

low has been erected and funds given for another. \$1,500 has been recently added to the endowment fund. Another benefactor of the Home has given a free bed in one of the bungalows for the year 1912-13. There is great need for a new administration building which will contain a kitchen and dining room to be placed near the present infirmary. This would lessen the labor of carrying food from a distance to the bed patients living in the infirmary. \$10,000.00 will be required for this purpose. A small sum has already been given towards the building fund. When this building is secured the old administration building could be used as a recreation house and for other purposes. We have recently secured at least temporarily the services of a matron who will greatly relieve the already overburdened superintendent of the Home. It is hoped that funds may be secured to make this arrangement permanent.

HOSPITAL OF THE GOOD SHEPHERD.

Our Indian hospital at Ft. Defiance has made a somewhat radical departure in deciding to receive hereafter only eye, ear and throat patients. Trachoma is the most prevalent disease among the Navajo Indians, and we have been most successful in treating it, saving from total and partial blindness many patients. But the hospital would be overcrowded all the time if we took in patients with other diseases, especially those suffering from tuberculosis. It was decided to leave such cases to the government hospital to deal with. The Indians themselves cannot and do not pay anything for their care and hospital expenses. The work is entirely charitable and it costs from \$5,000.00 to \$6,000.00 each year to carry it on. We must bear our testimony to the self sacrifice and devotion of Miss Thackara, the superintendent, and Dr. Wigglesworth, the physician in charge, both of whom receive only meager salaries as we would to the same qualities shown by the superintendent, the Rev. B. R. Cocks and the resident physician, Dr. Watkins of St. Luke's Home.

THE GENERAL CONVENTION.

This year the Church will hold its triennial session in New York. At least two matters of considerable importance will come before it.

The change of name of the Church will undoubtedly be considered. Those most violently opposed to the present name seem to have settled upon that of The American Catholic Church. The whole subject seems to be an unfortunate one to come up at this time, as it will very likely interfere with unity and good will inside, and unity and good will outside of our branch of the Church Catholic.

There are those deeply attached to the present name who feel that the word "Protestant" is not simply a negative word, but means that we hold to, and are loyal to, the principles of the English Reformation.

They maintain that there is something besides recognition of the Papacy which divides us from the Church of Rome even today. They would hold that our second name of "Episcopal" indicates our apostolic origin and the historic ministry of the Church.

The creed itself shows that we believe ourselves to be a part of the Holy Catholic Church, and that word belongs to the whole church and should not be appropriated by one branch of it. In popular opinion, the word "Catholic" is assigned to the Roman Church, which claims it for itself. We have always held that there was a certain arrogance in this assumption. Might we not be guilty of the same thing in assuming the name of The American Catholic Church? We are certainly not that yet in spirit or in fact. The assertion is sometimes made that the missionary work of the church in the United States is hampered by the name we bear. I have never found this to be true in Arizona. On the other hand, I fear the assumption of the name American Catholic Church might alienate from us some members of other religious faiths or of no church connection at all, who would otherwise affiliate themselves with our church.

I do not class myself among those who are devotedly attached to the present name. A man may not care particularly for his own name, but if it has been borne by his family for a long time, he hesitates to change it except for good and sufficient reasons.

Our church is both Protestant and Catholic. I can understand the feelings of those who object to the word "Protestant," but as it occurs very rarely in our formularies and we express in the creed our allegiance to the Holy Catholic Church, it would seem that our Catholicity is not denied by the legal name of our branch of the Church. If there are some who think of us as Protestants, there are others who always think of us as Catholics. It is the glory of our church that it repudiates the sectarian idea and requires of its members allegiance only to the Apostles' Creed, which is becoming more and more the accepted creed of all who call themselves Christians.

The church from which we received our Episcopate is called the Episcopal Church of Scotland. Very likely when the Church of England is disestablished, it will become The Episcopal Church of England. If a change were made now, it would be better for us to take the name The Episcopal Church of the United States. This would have the advantage of a common name for all branches of what is generally known as the Anglican Communion. The word "Episcopal" describes us better than any other name. Yet, in the years to come, a better and even more comprehensive name may be found. but with the strong feeling that prevails and the divisions that are sure to follow, it would certainly not seem wise or right to attempt to change the name of the Church at the present time.

CHURCH UNITY.

The report of the commission on Faith and Order will be made to the convention. A vast amount of work has been done by the commission, and we shall hear something of its achievements.

There seem to be two ways of promoting church unity. The one is to call for the meeting of a great council, representative of all Christian bodies who will send representatives. Such a council conceivably might bring about organic union on the basis of faith and order.

Another way of promoting unity is through church federation. It would leave each church independent as regards its own government and doctrine but bring all Christians together for common prayer and work and a union along certain practical lines.

This would probably be better described as Christian than Church unity but may this not be the more feasible working plan at present? We know that differences of opinion separate the members of every communion even now, and if organic unity were accomplished, would there not soon come divisions again? The differences, for example, between our church and the Church of Rome and the Greek Church, on the one hand, and the Protestant churches on the other, are so great that organic union would seem out of the question at present, nor might it not be desirable even if it were accomplished. But loyalty to the Incarnate Christ, which is the faith of all who call Him Master, ought to bring us into such close union with our fellow Christians by whatever name they are called, that peace and good will should prevail; and this spirit is growing stronger every day.

The commission on Faith and Order, the Federation of Churches, the Missionary work abroad and at home, are all aiding in the growth of this spirit. Christian men and women are becoming more eager to emphasize the things that unite rather than those that divide them. If there be different folds, we remember that there is but one Shepherd over all. Actuated, it may be, by different motives and methods and working along different lines they are all seeking to make this world the Kingdom of God and His Christ. We may be true to the great nation to which we belong and one with it, even though we are living in different commonwealths and are loyal to our own state. After all, the republic is one.

In spite of seeming contradictions and almost insurmountable difficulties, the Church will yet be one. We may be perfectly loyal to our own church and yet believe that the Universal Church, which is the Body of Christ, is much larger and more comprehensive than any subdivision of it.

CONCLUSION.

In reviewing the work of the past year in Arizona, we find much to stimulate and encourage us. This Missionary District is stronger than it was last year, although we have failed to advance along certain lines as rapidly as might be expected.

Our clergy list, in number, is the same as last year, but better work has been done in many ways. Those of the clergy who have been with us more than one year, from their knowledge and experience, have become more effective and useful both in the churches which they serve and in the communities in which they live. We have welcomed new workers in this missionary district, who have all done good work, some of whom still remain, while others, on account of illness, have been compelled to retire from the field.

Our confirmations, one hundred thirty, are a little less in number than last year, but that was an exceptional year, when the number, one hundred forty-seven, was almost double what it had ever been in the history of this district. The number this year, however, is almost double what it was two years ago. There are several classes waiting to be confirmed during the next few weeks. Our lay-readers have increased from ten to eighteen. Other statistics, I think, will show increase all along the line, and notably in the offerings that have been made for all church purposes, the large amount contributed being due in part to the church and parish houses that have been erected.

So the note that I strike today is one of hopefulness and gratitude. There is peace, and unity, and co-operation within our borders, and we devoutly thank God for His loving mercies to us as a Church and a people to whom a goodly heritage has been given if we are faithful to the trust and the great commission that rests upon us, both priests and laymen, as members of the Church of Christ in Arizona.

Appendix B.

REPORT OF THE WOMAN'S AUXILIARY.

The work of the Woman's Auxiliary in the Missionary District of Arizona has gained considerably in strength during the past year. Its roots have gone deeper in many places; and it has spread out and touched upon bigger things than it did the previous year.

We regret that one of its branches has decided that it can accomplish more for the Missionary cause working independently rather than in unison: that same branch viz., Douglas, having last Convocation, sent a generous contribution of \$10.00, of which \$9.50 went to Miss Thackara, and 50 cents to assessment dues. Some day soon we hope it will again see the benefit to be gained from united effort.

There are on the other hand various marks of growing strength. These are some of them: To begin with, our organization began to assume shape from its rather chaotic condition, when at our last annual District meeting held in Tucson, we adopted a Constitution embracing ten articles; and also increased our list of District officers from those simply of President and Secretary to those of Vice-President and Educational Secretary as well, the office of Treasurer being added to that of Secretary. The prospect of having an Educational Secretary of our own, brought with it suggestions of great promise especially as it was in the hands of an experienced Woman's Auxiliary Worker, Mrs. Moody of Globe. This hope, however, waned with the departure of the Rev. Mr. Moody from Globe, and until our present meeting no one has been elected or appointed to fill her place. Later in the year, at Miss Emery's suggestion, an officer was chosen to arouse greater interest in Arizona in the Missionary Magazine, "The Spirit of Missions," and to increase the number of its subscribers. Our Vice-President, Mrs. Burgoon of Nogales, was chosen for this work.

Our branch has, during the past year, made an attempt to influence legislation in Washington. Bishop Rowe of Alaska sent an appeal regarding the setting aside of Indian reservations in his territory, where schools could be erected, and where medical aid could be furnished them. This he looked on as one means of counteracting the wide prevalence of disease and vice in Alaska. A committee of two was appointed at our last annual meeting, Mrs. A. M. Franklin and Mrs. W. J. Dixon, to confer with the Rev. Mr. Jenkins, and as a result letters were sent to our Arizona Senators at Washington, the Hon. Mark Smith and the Hon. Henry Ashurst, as well as to our represent-

ative in Congress, the Hon. Carl Hayden, urging them to take an interest in legislation leading to the setting aside of these Alaskan reservations. Copies were forwarded to them of the resolution adopted in respect to this at our annual meeting. To these letters I received courteous replies, with promise of action.

One big event of the year, and one in which we in Arizona had an active part, was the meeting of the Woman's Auxiliary of the Eighth Missionary Department in Los Angeles, on Friday, October 18th, last, with representatives from most of the Dioceses and Missionary Districts belonging to the Department. The Woman's Auxiliary meetings held then were an inspiration to all who were present; and I am glad to say that Arizona was well represented, our District President, Miss Jenkins of Prescott, giving an excellent ten minute address. The evening meeting succeeding the dinner of Woman's Auxiliary delegates, to which the Bishops were invited, was unusually impressive, each Missionary Bishop telling the tale of the peculiar conditions under which he has to live and work. I think each one there returned home feeling that the Missionary work she was engaged in, and the organization of which she was but a fractional part, were for bigger things than she had dreamed; and more interested in the bringing about of that "One far off divine event to which the whole creation moves."

Another step in advance made by our Arizona Branch within the year has been the formation of a Junior Auxiliary Department. True, it has as yet only one local branch, that of Tucson. This branch has at present a membership of fourteen children. It is to be hoped that other parishes will form similar Branches.

Then as to the Spiritual and Devotional side of the work. I know of at least two parishes where the membership in the Prayer League has increased, viz., Prescott and Tucson. There may be other Branches of which this is also true.

Just last week, the children of St. Christopher's Band, the Junior Auxiliary of Tucson, adopted the Junior Auxiliary Prayer League leaflet. Too, courses in Mission study have also been adopted in some of the Branches, such as Flagstaff, Prescott, Phoenix, Nogales.

As Secretary of our District Branch I have sent off about one hundred and seventy communications, and I have received about one hundred and two reports, Prayer League Leaflets, letters, cards, etc. inclusive. The following sums of money have passed through my hands:

Of the \$10.00 from Douglas, brought me by the Rev. Mr. Simonson to Convocation last year, I sent \$9.50 (having first paid their assessment) to Miss Thackara for use in the Hospital of the Good Shepherd at Fort Defiance.

I sent \$10.00 on to Archdeacon Cocks for use in St. Luke's Home, which Phoenix sent through Mrs. Farish, and also \$10.00 from the same source I sent on to Miss Thackara for the Good Shepherd Hospital.

October 6th, Mrs. Ross sent me a postoffice order for \$12.18 which I deposited, and which is to be forwarded to New York next September. Of this \$9.73 goes as United Offering from Prescott, and \$2.45 goes towards Miss Emery's gift at the "Triennial." Later, Miss Ross sent from Prescott an additional \$4.85 for the United Offering fund, and 50 cents towards Miss Emery's present.

Flagstaff, through Mrs. Pollock, has sent \$3.40 to be deposited towards the United Offering Fund, and Tucson has given \$13.00 for the United Offering and \$1.00 towards Miss Emery's gift. Nogales gave \$5.00 to United Offering, these sums added together making \$69.43 apart from assessment dues, which has passed through my hands. Of this I have on deposit \$39.83.

Appendix C.

REPORT OF THE HOSPITAL MISSION OF THE GOOD SHEPHERD.

For the year ending Easter Monday, 1913, this Hospital has had under treatment 180 Indians. The number of Hospital days for the males being 1,764, the Hospital days for the females 1,648. The current expenses for the year amounted to \$5,318.00.

It gives me pleasure to announce the complete success of our plan to do Special Work only, at the Hospital of The Good Shepherd. We continue to have many patients, while also educating the Indians to seek relief from their Eye, Ear, Nose and Throat Diseases.

Soon it will tax our capacity to accommodate the eye cases alone. An editorial in the Journal of American Medical Association gives the number of Navajos as 30,000. Of these 30 per cent are said to have the eye disease called Trachoma and Trachoma is the main cause of so much blindness. In round numbers then we have some 9,000 cases to treat of this disease alone. Of course now we get only the very worst cases, but some day they will learn to seek aid earlier when the eye is much more curable. Later on the Government will force them to treatment in order to avoid the contagion they spread.

Our results are wonderful in these eye cases considering the severity and duration of the infection. It is wonderful in our throat cases also to see how removal of Tonsils will change an invalid into healthful person. The bad effect of Adenoids on the growing child is well known. Our ear cases are mostly those with suppurating middle ear disease. To free these from discharge and odor is a blessing to the patient, and his friends also. A running ear is likewise a menace to life in that an abscess may at any time develop from it, either in the brain or in the mastoid cells back of the ear.

The Government Hospital is now taking the cases that so distressed us formerly. Those cases are Lung, Bone and Glandular Tuberculosis. The lung cases come in only when nearly dead and the others taking years to recover, make them difficult cases to help. By our present plan we now help so many more and have such greater success.

As the Hospital of The Good Shepherd was the pioneer in the field among the Navajos, it is also the only one with anything like sufficient equipment and we are continually called on to give aid with our instruments and the like. Several times lately it has happened that major

operations at the Government Hospital could not have been done had it not been for the generous loan of some very necessary instruments by Miss Thackara. It will be thus seen that the usefulness and scope of work of the Hospital of The Good Shepherd is not bounded by its four walls.

If other hospitals enter the field (and we need them) it must not be forgotten that their success will in large part be due to this trail-blazing institution.

We take only such cases as are suffering and eligible for register. No malingers allowed and we have not been bothered by fakirs for years. Our records are carefully kept and we can find any Indian we have treated when we wish. It has been over zealous in some to magnify their cases in order to show a large number treated. To our mind a few cases correctly diagnosed and properly treated show better work than a mere jumble of guesses. A well trained physician only should attempt to diagnose or treat disease.

Appendix D.

REPORT OF THE BOARD OF TRUSTEES OF ST. LUKE'S HOME.

In submitting our report for the year 1912 we are reminded that five years of work have now been completed. The Home, which began with a small administration building and eleven tent houses, Jan. 1, 1908, with no endowment, has now become a considerable institution with a hospital for advanced cases, a bacteriological laboratory, bath houses, residences for the superintendent, the physician and the chaplain of the Home, with the addition of many new bungalows. The Endowment Fund now amounts to \$13,000.00, having been increased during the past year by a gift of \$1,000 from Dr. Endicott Peabody, in memory of his father and mother, Mr. and Mrs. S. E. Peabody. In addition to this gift, Dr. Peabody is also supporting a free bed or bungalow. There has been little addition to our equipment this past year, but a new bungalow is soon to be erected, the gift of Mrs. W. Scott Fitz, of Boston. The expenses of the Home have steadily increased from year to year, with the increase in the number of patients and the upkeep of a plant that has been constantly growing. At the end of the year our reserve fund of \$2,000, from which we borrow in order to enable us to not overdraw our bank account, or get into debt to outside parties, has been reduced about one-half. We shall need larger endowments to enable us to do more charitable work, to aid those who are not only unable to pay the actual cost of maintenance but can pay but a small sum towards their support. Patients coming to Phoenix with sufficient means can generally find a place in which to live with comparative comfort, but it is the men and women of scanty means for whom St. Luke's Home was especially founded, to whom we chiefly minister, and who otherwise would be unfriended and unhelped, left to die perhaps without nourishing food and proper care. It is for this reason that we appeal to the public to support our work and enlarge its usefulness. The number of those who are bed patients or in an advanced stage of the disease is out of due proportion to the whole number of patients, and the cost of maintaining them is so great that we will be compelled to limit their number. The problem of chronic cases is one that is difficult to solve. We have been far more liberal than other sanitariums, but it may be questioned if it is right to keep for an indefinite period those who make practically no improvement, not only in justice to other patients, but also because they keep out others who might be benefited and restored to health, if we had the room for them.

We believe that St. Luke's is unique among sanitariums, in that it aims to realize its name of a home and to carry out the family idea, which indeed would be in great danger of being lost if it was greatly enlarged, even if we had the necessary funds for increasing the plant.

The average number of patients in the Home for the last year has been a little over twenty-six. Over ninety persons have been treated and almost all of these have been treated for considerably less than the actual cost of maintenance, while a number have been cared for free of charge, supported by the endowments or by money from the general fund. Other matters are not here referred to as they are contained in the reports of the superintendent and the resident physician.

We would express our grateful appreciation to those who have generously helped us by their gifts in the past, some of whom have showed their continued interest by yearly subscriptions and we no less cordially welcome new contributors to our work from abroad, from whence most of our patients come, also from Arizona and especially from Phoenix, the people of which city show their interest by annual subscriptions of money and also through the annual Donation Day established last spring to aid in the support of the Home.

During the Lenten season of this year, I assisted the Rector of St. Luke's Church up to and including Easter Day. And in the absence of the Rector I took full charge. On two of these occasions I was assisted by Mr. Dise, our other Lay Reader.

As Lay Reader, I commenced services at St. Luke's Home at the beginning of 1913, and have since held in all twenty-four services, a morning service each Sunday for the Infirmary patients, and an evening service in the dining room. Twice the addresses have been given by Archdeacon Cocks, who also administered the Holy Communion to about twenty patients on Easter Sunday. The services are short and informal, various religious denominations being represented among the patients.

As opportunity offers, personal work on the lines of the Brotherhood of St. Andrew is done.
