Whole number of ballots for Chancellor 31, of which Mr. John T. Hicks received 19, and was declared duly and constitutionally elected.

Mr. Fay Hempstead was unanimously re-elected Registrar.

On motion of Mr. Joseph A. Reeves the thanks of the Council were, by a rising vote, tendered to Major P. K. Roots for his long and efficient service as Treasurer, and the Secretary was instructed to cast the vote of the Council for him, which was done, and he was declared duly and constitutionally elected Diocesan Treasurer and Treasurer of the Fund for Aged and Infirm Clergy.

On motion of Mr. Joseph A. Reeves the thanks of the Council were, by a rising vote, tendered to Colonel W. G. Whipple for his long (16 years), faithful and efficient services as Chancellor, to which Colonel Whipple feelingly responded.

The Secretary was instructed to cast the vote of the Council for Mr. S. S. Faulkner as Trustee of the Permanent Episcopate Fund, which was done, and he was declared duly and constitutionally elected.



The Bishop appointed Ven. W. D. Williams, D. D., a member of the Committee on Education, and the Secretary was instructed to cast the vote of the Council for the present incumbents for the elective members, which was done, and they were declared duly elected, as follows:

On nomination Mr. W. G. Whipple and Mr. John Gatling were elected members of the Committee on Judiciary.

Upon ballot, duly reported by the tellers, Rev. G. DeWitt Dowling was declared elected Clerical Delegate, and Mr. J. Conway Fitzhugh Lay Delegate to the Missionary Council.

Mr. John M. Daggett was unanimously re-elected Trustee for the University of the South, for term expiring 1906.

Ven. W. D. Williams, D. D., was unanimously elected Trustee of the General Theological Seminary.

The Bishop retired and Rev. C. H. Lockwood took the chair as President *pro tempore*.

On motion of Rev. R. W. Rhames the report of the Treasurer of the Fund for Aged and Infirm Clergy was read for information, and Archdeacon Williams made an extended verbal report of the action of the Committee appointed at the last Council, to whom was referred the subject of a merger of the Diocesan Fund with the General Clergy Relief Fund. No further action by the Council at this time was deemed necessary.

On motion of Mr. S. S. Faulkner the subject of Clergy Relief was made special order for to-morrow morning at 11 o'clock.

On motion the Council took a recess until 8 o'clock p. m.



## EVENING SESSION.

Council met pursuant to adjournment.

After prayers the Bishop read that part of his address relating to the change of name of the Church, and at its conclusion offered the following resolutions:

1. *Resolved*, That the Council of the Diocese of Arkansas does not desire a change in the legal title of the Church.
2. *Resolved*, That this Council desires that the phrase "According to the use of the Protestant Episcopal Church of the United States of America" be omitted from the title page of "The Book of Common Prayer."
3. *Resolved*, That a minute of the action of this Council be sent to the Joint Committee on the Change of Name.

The Rev. G. Gordon Smeade offered the following as a substitute:

*Whereas*, The General Convention, through a committee, solicits an expression of opinion as to the present name of the Church, known in law as the Protestant Episcopal Church of the United States;

*Resolved*, That we, the Council of the Diocese of Arkansas, do not regard a change in name as necessary or expedient.

Remarks were made by Colonel W. G. Whipple, Fay Hempstead, Rev. G. DeWitt Dowling, Rev. W. Allen Fair, Rev. W. D. Buckner, Rev. D. L. Trimble, John T. Hicks, Rev. Dr. George B. Norton, Rev. R. W. Rhames, Archdeacon Williams, and Rev. G. Gordon Smeade.

The motion being upon the adoption of the substitute the Roll of Clergy was called, and twelve voted in the affirmative and five in the negative, those voting in the negative being the Bishop, Rev. David L. Trimble, Rev. Joshua B. Whaling, Very Rev. J. Percy Robottom, and Rev. George B. Norton, D. D.

Thereupon the Roll of Parishes was called and all the Parishes present, ten, voted aye.

The Secretary in casting the vote of his Parish explained that he did so under instructions by a vote of 14 to 2, while



personally he was most heartily in favor of a change in the legal title.

Council adjourned till to-morrow at 10 a. m.

### THIRD DAY.

Council convened pursuant to adjournment, Rev. C. H. Lockwood, President *pro tem.*, in the chair.

Record of the Journal of second day's proceedings was read and approved.

The Bishop appeared and resumed the chair.

Special Committee on Auxiliary submitted the following report:

*Whereas*, The Council has received from the Woman's Auxiliary, Diocese of Arkansas, now holding its annual meeting at Christ Church, this city, a communication with the good news that it has paid in full the apportionment made upon it by the General Church;

*Resolved*, That the Council of the Diocese now assembled in annual session in Trinity Cathedral, places on record its high regard for and grateful appreciation of the work that the Woman's Auxiliary is doing for the Church in this Diocese as well as for the Church at large.



The Rev. Dr. Lloyd was next invited to speak. He responded at length, and in a most happy manner, to the interest and edification of all present. He emphasized the fact that the Christian religion is a missionary religion, or it is nothing. He assured the Diocesan Board of Missions, as he did the large congregation in Christ Church the evening before, that the General Society extends to us its sympathy as well as its aid, and will be glad to continue to do all in its power to strengthen our hands and encourage our hearts.

At the conclusion of his remarks he invited the members of the Board to ask questions. The "apportionment plan" proved a fruitful theme for comments and inquiries. He stated that the plan seemed to produce desirable results and spur the people to increased endeavor. That both patriotism to evangelize our nation and compassion to save the world should stir our Church to larger giving.

The remarks as well as the addresses of Dr. Lloyd simplified the "apportionment plan," and interested every listener to fall in line and do our best to make good the expectations of the general society.

The third meeting of the Board was held in the Bishop's office, at 8 p. m., February 17. There were present the Bishop, Rev. Canon Lockwood, Rev. Canon Smeade, Archdeacon Williams, Messrs. N. B. Trulock, John Gatling, H. C. Rather. By courtesy the Rev. Canon Rhames and Dean Robottom were present, and contributed to the interest of the evening.

After transacting the routine business of the evening, the Bishop read his proposed Lenten Pastoral, and also his address on "Work Among Colored People." He solicited comments from those present, all of whom availed themselves of the opportunity to express their opinions freely, in compliance with the privilege extended.

The last meeting for the conciliar year convened in the Bishop's office, May 12, at 8:30 p. m. Present, the Bishop, Rev. C. H. Lockwood, Rev. G. Gordon Smeade, Rev. W. D. Williams, D. D., Mr. N. B. Trulock, Mr. H. C. Rather. The Treasurer read his report, exhibiting the receipts and expenditures, and showing a balance on hand of \$1,060.89.

The committee on a new site for St. Philip's Church reported that two places had been considered during the year; but each involved a larger expenditure than the funds at present available would warrant. It was therefore the judgment of the Board that the intention to purchase and build cannot, as yet, be carried out.

## APPENDIX VIII.

### ADDRESS OF PRESIDENT WOMAN'S AUXILIARY.

*Reverend Father in God, Memblers of the Woman's Auxiliary and Friends:*

In giving an account of my stewardship for the year, I regret I cannot tell more of personal work done. I think most of you know that until the past two months, owing to ill health, your President has been able to do but little, even in the way of writing and answering letters. Upon my co-workers, more especially the Diocesan Secretary, all labor and responsibility has devolved. In a most systematic, beautiful and characteristic manner she has guided us, and she assures me that the watchword has been progress, not in the number of new branches added, but in the quality of work done. After being invalided for months, I asked the Bishop to appoint someone in my place, but he kindly replied that he thought no change necessary at present, as he considered the society sufficiently well organized to await further developments. I then wrote as strong an appeal as I could to our Secretary, begging her to reconsider her resignation, which she had sent in at our last annual. We had been unable to find anyone who was willing to assume the duties which we know to be irksome to a degree, and past relations had shown us her fitness for the place. She generously consented to resume the office during this trying term, when it looked as though we might go to pieces. I trust the time is close at hand when God will give me the strength to gather up the broken threads, unite the scattered ends and once more carry on the duties of life.

It is very gratifying to know that all the branches of the Auxiliary so willingly adopted as their Lenten work, that which has been so dear to my heart, the Foreign Field, more especially China, where our effort has been to provide scholarships, so that we may help to carry out the Grand Commission—"Go teach." We in this State should feel an added interest in the Christianizing of the great Empire, since one of our Diocesan officers has given one of her dear boys to that immense work, which should appeal to all who bear the name of Churchmen or women.



This year's report will bring no record or but few of boxes sent out, but of growth in the study of missions. Some branches I know formed study classes during the six weeks of Lent, and found it not only interesting and broadening but fascinating. Learning about peoples differentiated from us by homes and civilization, the lives of some were found to be quaint and picturesque, while that of others, especially the women and children, were revolting. It is necessary for us to know the wants of these peoples, and the means the Church has taken to fulfill them. Any cause for which we study and work and give our time will grow dear to us, and what we love we pray for, and when we reach the condition of prayer we are safe. Then giving of our substance, which is so hard for some unless they have been trained from infancy, will follow easily.

Another branch has resolved on the penny-a-day system for the "United Offering," or the first of each month gives thirty cents to be turned over to the Secretary or Treasurer and put out at interest.

I believe if as many of the branches or individuals as can will do this and do it systematically, we may have an offering for 1904 of which we will not be ashamed.

When the "Apportionment" plan was decided upon the Woman's Auxiliary was asked to give a hundred thousand a year as their share. At the Council meeting held last year in Helena, we calculated that if each member of the Auxiliary in this Diocese would give thirty or thirty-five cents it would make our pro rata. I am not sure whether all did or not, but I know a great many gave. It can still be given. Another thing I would like to be arranged would be a Board meeting at least once between the times of the annual meetings. A face to face talk of five minutes about the best means of extending and emphasizing our work is worth a dozen letters. I am familiar with the objections which can be raised to this suggestion, the expense, the distance, not so much in miles as in poor railroad facilities, especially in the Eastern part of the State, but the secular societies and clubs seem to be able to overcome these difficulties, so why cannot we in this nobler aim, which means not only a higher culture, a broader education, but even life itself. Oh, women, nothing is efficient except it be real, and it is the real force of woman not the unreal which we want. It is not the mere ornamental service which we need, but the greatest moral development in her spirit, her heart and her life. Woman is said to be the conscience of the world; if that be true, then her heart and soul must be filled with the Divine power and beauty, love and service for her fellow beings that she may leave the world better for having lived in it.

The test of the value of either men or women organizations in the Church is the truth and earnestness of their missionary spirit.



If for themselves only they exist for their own pleasure or profit without endeavoring to become trained in ideals of unselfishness and helpfulness, based upon Christ-like principles, they will be no more benefit than any other secular society. The every day life can become one of self sacrifice and heroism if it be governed by loyalty to our Saviour's command, "Bear ye one another's burdens." I believe if the effort was made we could form a Church Periodical Club, and thus send to the small towns and country districts books and periodicals which would as truly clothe and feed the naked and hungry as the material commodities. Have one woman who would interest herself to collect the books and send them on their missionary journey. No matter how many read a good book, it is just as helpful for the next one who reads it. You will recall that at the last General Convention there were five new Missionary Jurisdictions formed. In addition to Porto Rico and the Philippines, there was Western Kansas, an additional one in China, and since the English Church has retired from Hawaii, that is also left to our care. This means a much larger outlay for the Board of Managers, and as they have only what the Church gives them to dispense, I earnestly urge that each branch of the Auxiliary no matter how poor, will try and give more and designate it for General and Foreign work. As we are the Woman's Auxiliary to the Board of Missions, we ought to feel pledged to the help of it in every way we can. One fact that ought to cause serious thought, is that we do not seem to be reaching the younger women as we should. Very few of the young matrons are members, the fault must be ours. Possibly we have not been the mothers we should, in a figurative sense. The Junior and Baby branches are not doing what they can. For awhile they seemed so full of promise, and we congratulated ourselves that in them we saw the future Auxiliary, and some who would be glad and willing to give their lives to Christ's service. Young womanhood is full of enthusiasms, so why should not her enthusiasm be turned into missionary channels, where her sympathies, which belong to woman's heart, may be enlisted and she may familiarize herself with this grand work, which must inevitably fall before many years to the younger generation. The time is short and some have already borne the burden and heat of the day. We realize that many who have faithfully served in the past will before a great while be going out from among us and leaving their work to others. Who those others shall be is a question for the coming years to solve. There will never fail some who will labor for Christ's kingdom, but there is a great company of young women who should belong to the Auxiliary, and we will fail of our duty if we do not try to influence them to come in.

May God bless you, one and all, and make this the very best and most helpful meeting we have ever had.

## APPENDIX IX.

## REPORT OF SECRETARY OF WOMAN'S AUXILIARY.

To the lasting regret of all, both officers and members of the Woman's Auxiliary in Arkansas, Mrs. George H. Lee did not see her way clear to accept the Diocesan Secretaryship to which she was unanimously elected last May, and our President performed the duties of that office as well as her own, until she was compelled by her severe illness to ask for help. At the request, and by Bishop Brown's appointment, Mrs. Rhames consented to act as Secretary for the remainder of the conciliar year. The Bishop's appointment was dated from January 15.

Immediately after this date a letter came to the Secretary from Miss Emery asking that a special effort be made to raise the Arkansas Auxiliary apportionment for General Missions, which amounted this year to \$274.00.

Your Secretary made a journey to Little Rock to talk the matter over with the Bishop, the Diocesan officers and the officers of the Little Rock branches.

As a result of this conference, a definite sum was asked of each branch as a special Lenten work. They have responded nobly, as the branch reports will show, some branches increasing rather than diminishing the sum expected from them, and all responding so cheerfully and encouragingly that the Secretary found her task materially lightened.

I wish I might urge the delegates present at this meeting to pledge their respective branches for the same sum for the Auxiliary apportionment, which they have been able to give this year, making it again our special Lenten work.
