NOTES ON THE TREASURER'S REPORT

Pay all assessments and pledges promptly. There are two assessments, the Diocesan Tax and the Synod Tax (see constitution). In addition to these there is the Provincial Pledge. All are due January 1 of each year. The obligations we have assumed are to the President's Extension Fund and to the Triennial Expense Fund. These should be met as early in the year as possible. The books of all the treasurers must be closed December 31. All pledges and assessments of whatever character must be paid to the Diocesan Treasurer.

THE TRIENNIAL EXPENSE FUND.

At the Annual Meeting at Newport it was decided to create a fund to defray the expenses of the Diocesan President at the Triennials. The details were referred to the Executive Board for action. At a meeting of the Board June 4, 1932, it was decided to ask each branch to pay a per capita tax of ten cents toward this fund. This tax to be paid each year to the Diocesan Treasurer and to be allowed to accumulate between the Triennial Meetings.

THE WORK AMONG THE ISOLATED AND THE RURAL WORK

Mrs. A. N. Tanner, Director of Work among the Isolated, and Mrs. M. O. Bennett, Rural Work chairman will co-operate in their labors. The Church Periodical Club Chairman and the United Thank Offering Treasurer will serve with them to promote interest in the work undertaken among isolated church people and in rural communities. The Special Offering made at the Annual Meeting will be used as a start toward procuring a "Church-on-Wheels" to be employed in forwarding the rural work in the diocese.

Rural Work

Mrs. M. O. Bennett, Rural Work Chairman, made the following recommendations:

As chairman I should like to recommend that a rural conference be held in every district in Arkansas this fall, at which time research work may be done and a survey of plans for work made.

No 1—Newport, Batesville, Blytheville, Jonesboro, Searcy, Augusta.

No. 2—Helena, Forrest City, Marianna, Wynne, Brinkley.

No. 3—Pine Bluff, Arkansas City, Camden, El Dorado, Fordyce, Lake Village, McGehee, Monticello, Stuttgart.

No. 4—Little Rock, Bauxite, Hot Springs, Hope, Toliville.

No. 5—Fort Smith, Eureka Springs, Fayetteville, Foreman, Mena, Van Buren, Winslow.
