


### THE PRAYER FOR THE WOMAN'S AUXILIARY

**MINUTES OF THE 21st ANNUAL CONVENTION OF THE  
WOMAN'S AUXILIARY TO THE COUNCIL OF THE  
DIOCESE OF ATLANTA**

The 21st Annual Convention of the Woman's Auxiliary of the Diocese of Atlanta was called to order by the President, Mrs. Henry Davis at 10 A. M., January 25, 1928, at Rome, Ga. The Rev. C. K. Bentley of Christ Church, Macon, said the opening prayers.

A telegram of good wishes from the Federated Church Women of Georgia was read. Mrs. A. H. Sterne moved that a message of thanks be conveyed to them by the Secretary.

Mrs. J. H. O'Neill, of St. Peter's Church Woman's Auxiliary, made a most gracious welcome in the name of her church and of Rome. Miss Rosa Woodberry in a delightful and feeling way responded.

The President's address was then made, and received with appreciation. Mrs. Davis drew our attention to the fact that next year we would have to elect new officers and named Miss Lucinda Snook, Chairman of the nominating committee. Mrs. J. N. Talley, Mrs. Frank Noble, Mrs. Frank Woodruff and Miss Louise Schilling. Mrs. Davis then read a letter from Miss Lindley, then a letter from Mrs. Pancost about the Gold and Silver Offering for St. Margaret's School, Japan, asking our co-operation in completing this fund. Then Mrs. Davis read Senator Capper's "Proposed Reply to the Brand Peace Offer" which looks toward renunciation of war as our national policy and calling for settlement of international disputes by arbitration. This had been sent from head quarters and Mrs. Davis recommended individual branches and members to write Senator Capper (Kansas) at Washington of their approval.

Mrs. Davis then read a message of greetings from Mrs. Pettigrew and Mrs. Harrison, which was received with deep emotion. Miss Rosa Woodberry moved that a letter of appreciation be sent Mrs. Pettigrew and Mrs. Harrison.

The Convention received a lovely bunch of red roses from Mrs. Puryear of the Rome Flower Shop. It was moved that a letter of thanks be sent Mrs. Puryear. Mrs. Davis then called upon Mrs. Graham, whom she had appointed Secretary to fill Mrs. Harrison's unexpired term, for a brief report, and to make the Memorial Report. The Auxiliary stood as the names of our co-workers who had passed away were read. They were:

Mrs. Davis appointed the following to serve on the courtesy Committee: Mrs. Jno. F. MacDougald, Chairman, Mrs. Chas. Harrold, Mrs. Frank Noble, Mrs. Joseph Williams, Mrs. Thos. H. Johnston.

Resolutions from the 9 o'clock meeting of the Board were introduced. Mrs. Frank Bone recommends that a committee be appointed by the President looking to the change in the by-laws concerning the per-capita Expense Fund—seconded and passed.

Mrs. MacDougald recommends that the Board meet annually at the hour immediately preceding the meeting of the Auxiliary Convention. Seconded and passed.

Mrs. Chas. Harrold recommends that if there be a deficit in the diocesan Expense Fund that the branches be asked to accept their pro-rate share. Seconded and passed.

Miss Woodberry made the report of Religious Education, especially stressing the class which Bishop Mickell taught during Lent on "Women of the Bible" which was a great success participated in by all Auxiliary branches in Atlanta. She also mentioned Dr. Tucker's class on "The Drama of the Covenant." Mrs. Jno. E. Talmadge, Jr., U. T. O. Custodian, stated that she had in bank a total of \$4,574.99 for the United Thank Offering to be presented in October. She urged all to assist her in reaching the goal hoped for, \$7000.00 from the Women of this Diocese.

Mrs. H. N. Hurt gave the Treasurer's report which was accepted with thanks for her untiring efforts. Mrs. Hurt reported all obligations met, and stated that the yearly meeting in January would be a great help to the Treasurer. Mrs. Frank Noble gave a very interesting report of the recent Synod meeting held in Columbus.

Mrs. Allen Gray announced that there would be a meeting of Young Woman's Auxiliaries on March 10th at St. Philip's, Atlanta, and urged every branch of the Auxiliary to see that young women from their parishes be urged to attend that more young women's branches may be formed throughout the Diocese.

Mrs. Chas. Harrold made the report for the Appleton Church Home Fund. She did not quite have the \$1200.00 hoped for. The deficit was quickly subscribed.

The Rev. F. H. Saumenig said the noon-day prayers and then spoke a few words of greeting expressing his gratification at having the Convention at St. Peter's.

Branch reports were made until 1 P. M. when the ladies adjourned for luncheon with the members of the Council. After reconvening branch reports were continued until 4:30, when the body adjourned for the day.

At 9 A. M. Thursday, January 26th, the President called the Auxiliary to order, and the meeting opened with prayer.

Mrs. Davis announced the following committee for change in By-laws concerning Expense Fund: Mrs. Russell K. Smith, Chairman; Mrs. Allen Gray, Mrs. Earle Bassett, Mrs. Jno. MacDougald, Mrs. C. E. McCann, Mrs. H. N. Hurt. Mrs. Davis then appointed the following delegates to the Triannual at Washington: Miss Snook, Mrs. A. H. Sterne, Miss Tinsley, Mrs. Henry Davis; Alternates: Mrs. J. H. O'Neill, Miss Rosa Woodberry, Mrs. A. B. Dudley, Mrs. Robin Graham.

The program for the day consisted of Departmental reports and conferences.

Miss Tinsley, Chairman of Missionary Education, made a most interesting report, urging more discussion Study Classes, attendance at Sewanee and use of the Program of Study and Study books. Mrs. A. H. Sterne, Prayer Partnership Chairman, urged every branch to have a Prayer Partner, a Prayer Circle, and a study of Prayer. She stated that the aim was: "More time for Prayer, Take time to be Holy". Miss Mary Thomas, of New York, Executive Secretary of the Church Periodical Club, was introduced by Mrs. R. J. Sauls, director for the Diocese of Atlanta of C. P. C. The Auxiliary gave Miss Thomas a rising vote of welcome on this her first visit to the state of Georgia. Miss Thomas wanted us to remember as her message: "The Friendly thought in sending a magazine." She thrilled many with a new interest in the work, and opportunities for service, and all felt very grateful for the opportunity of meeting Miss Thomas and understanding C. P. C. work better.

Rev. W. W. Memminger, Chairman of Religious Education for the Diocese, asked the privilege of giving his report to the Auxiliary and

asked the ladies to back up the work of the church schools more vigorously.

Noon-day prayers were said by the Rev. Robt. Patton of the Church Institute for Negroes, who then made a short address especially about our own school, the Ft. Valley High and Industrial School for Negroes. Mrs. Jno. MacDougald reported the work of the Supply Department which showed a large amount of interest and work. She urged proper valuation and more new things. Mrs. Thos. Johnston made the report of the Corporate Gift in Miss Snooks' absence. Over \$400 was paid in but all the balance for the Gift must be in hand early September, and she urged the branches to make this their first obligation for the new year.

Social Service Work showed great strides under the guidance of the chairman, Mrs. Thos. Johnston. She made a most interesting report of a visit to state institutions at Milledgeville, Ga. Mrs. Downing reported the work done at St. Luke's with the Family Welfare Society and Mrs. Woodruff spoke on prisons she had visited in Europe.

Mrs. H. N. Hurt reported for the negro fund that it had been fully met, and that we would endeavor to raise a like amount this year to aid negro missions in the Diocese.

At 1 P. M. the meeting adjourned for luncheon served by St. Peter's Guild in their lunch room, The Dogwood Tea Room. On reconvening Mrs. Talmadge spoke on the U. T. O., especially urging that the offering be taken in March, and early in September so as to reach her for the presentation in Washington in October. Mrs. Chas. Harrold spoke for the Appleton Church Home and mentioned that the Home needs eighteen beds which can be purchased at \$19.00 in Macon,  $\frac{3}{4}$  sheets  $2\frac{1}{2}$  yards long, kindergarten chairs, book cases and victrola records.

Mrs. R. J. Sauls spoke very briefly of the C. P. C. work in the Diocese.

Mrs. Pitner reported that sixty-five delegates had registered. The courtesy committee made the following report:

It is our privilege to express our grateful thanks for the hospitality of beautiful Rome and its people, especially to our hostesses who have so royally entertained us, and to the Automobile Committee who have been untiring in their efforts. Our thanks to St. Peter's Parish and Auxiliary, to the Baptist Church congregation for the use of their meeting rooms, to Mrs. Barry Wright for the charming dinner given to the Executive Committee on Tuesday evening, to Mrs. J. H. O'Neill for the lovely tea at her home, and to the Guild of St. Peter's for the luncheon at the Dogwood Tea Room. We want to acknowledge the flowers sent for the meeting from Mrs. Puryear.

We wish to express our deep regret at the absence of Mrs. Sauinenig, wife of our presiding minister of St. Peter's, and trust that she will soon be restored to health.

Our deepest sympathy to Mr. and Mrs. E. A. Heard in their recent sorrow, and to Mr. and Mrs. Price in their bereavement.

Our grateful thanks is due to the newspapers of Rome for their co-operation, and to Mrs. Pitner, chairman of registration.

Last but not least, our loyal appreciation to our presiding officer, Mrs. Henry Davis, for her tact and unfailing courtesy and efficiency in conducting our proceedings and rejoice with her in the report she

has presented to the Council today showing advance in all departments.

**MINUTES OF THE MEETING OF EXECUTIVE BOARD,  
ROME, GA., JANUARY 25TH**

The meeting of the Parish Presidents and Executive Committee was called to order by Mrs. Henry Davis at 9 A. M., January 25, 1928, in Rome, Ga. The meeting was opened by prayer by Mrs. A. H. Sterne, Chairman of Prayer Partnership. Mrs. Davis then explained Article 4, section 3 of the By-laws which defined the Executive Board as composed of Parish presidents, department chairmen, and the officers and past Diocesan presidents. Mrs. Davis explained that this Board had never functioned, but that the Executive Committee of this Board had functioned with three annual meetings.

Mrs. Davis asked the Board to consider the best time for meetings of the Board.

Mrs. Jno. MacDougald moved that the Board meet annually at the hour preceeding the meeting of the Auxiliary Convention. Seconded by Miss Woodberry. Voted and passed.

Mrs. Davis then spoke of Article 8, section 2 of the by-laws which provides for twenty-five cents per capita annually on each member of the Auxiliary for the Diocesan Expense Fund. There being some confusion about branches paying this per capita assessment it was deemed wise for the Board to take some action on the matter. After considerable discussion, Mrs. Chas. Harrold moved that if there be a deficit in the Diocesan Expense Funds that the branches be asked to accept their pro-rate share of the Expense Fund. Seconded by Mrs. Thos. Johnston. Voted and passed. Mrs. Frank Bone recommended that the President be asked to appoint a committee to look to the change in by-laws of article 8, section 2, and bring in a report at the 1929 meeting. Seconded by Miss Sondley.

The President asked the Branch presidents or their representatives to stand. There were sixteen present, and all members of the Executive Committee except Miss Snook who was ill. The meeting then adjourned.

**PRESIDENT'S ADDRESS—WOMAN'S AUXILIARY FOR  
YEAR 1927**

Once again our Auxiliary Ship comes into port at the end of her year's sailing. Stock will be taken of her list of sailings and of her various cargoes collected and discharged during the past year.

It seems to me that we can safely say that our trade has not lessened. While perhaps there has not been any very marked increase, there has certainly been no lessening in the number of her spiritual voyages, nor in the cargoes of helpful endeavor.

Considering the handicaps under which we have worked in several directions, for instance in our irreparable loss by removal of our Diocese of both our secretary, Mrs. John Harrison, and of our chairman of the Negro Fund, Mrs. Chas. Pettigrew, and through the changing of hands in the work of several of the branches during the year. I feel that if we have managed to hold our own, we have, in reality, done more than this.

So much for our actual work, I shall not take your time to go fully into the splendid work done by almost all of the departments, the reports of which you will have from the chairmen themselves. Suffice it to say, that their interest, their real endeavor, their loyal co-operation and willingness to help with the added burdens which they have so generously shouldered has been the means of carrying on the year's program and bringing the work to the full fruition of what it was the year previous.

To them especially, and to the branches as well, I tender my real gratitude and loving appreciation.

But the year 1927 has been really a banner one for the Diocese of Atlanta, for during this year it has been her privilege to entertain many members of the National Board who have come to us, giving us freely of their helpful teachings and inspiration. And it has been our outstanding privilege to be the Hostess' Diocese for the Synod of the Province of Sewanee, entertaining it in conjunction with the meeting of the Auxiliary and the other women's organizations at Columbus, Georgia, in October last, where with the most adequate and hospitable arrangement of the Columbus people, we had a most spiritually helpful and socially delightfully occasion. We felt that several forward steps were taken which mean real growth in the Auxiliary work of the Province—perhaps of the nation. This we feel redounds largely to the credit of our Diocese.

As you all know, my third year in the highly prized and privileged capacity as Captain of your ship will expire a year from this time, and it will be the duty of this body, through their nominating committee to choose the officers who shall replace those of us who go out of office at that time. I am, therefore, appointing that nominating committee, so that they may take under consideration that matter and bring in their report at our next annual meeting. For chairman of the nominating committee I appoint Miss Lucinda L. Snook. The following ladies will please act with her on this committee: Mrs. J. N. Talley, Mrs. Frank Noble, Mrs. Frank Woodruff, Miss Louise Schilling.

I also have the good fortune to announce to you that Miss Snook has been good enough to promise to keep for the next year the Chairmanship of the Negro Fund in conjunction with her capacity as Chairman for the Corporate Gift.

This year upon which we are now about to relaunch our Ship is one which should prove for our Auxiliary life a very epoch. Bringing as it will the Triennial Meeting this year at Washington, D. C., the Nation's capitol, and bringing also with it the probable decision of several

vital questions concerning the future status and prescribed functioning of the Woman's Auxiliary. We shall find that the year is one which (if I may predict) will stand out almost as markedly as the year of that meeting whereat the Auxiliary was first given recognition as our aid to the Council and all its departments.

Let us, therefore, strive to begin this year's work with an added interest and zest, so that when the Triennial time arrives we shall feel that we have not been slothful but have really been very earnestly about "Our Lord's Business".

In the next year I am sure that you will all rejoice with me in the acceptance of Mrs. Robin F. Graham to fill the unexpired term of Mrs. John Harrison as your secretary.

Mrs. Graham holds the position, as you know, of Publicity Chairman, and this she will continue with the secretarial work of the ensuing year. I count myself most fortunate in having one so capable and so gifted as Mrs. Graham to work with in this capacity.

And now I will let her have a few words with you, but not before thanking you each and every one for your earnest, loyal, and affectionate co-operation with me during the past two years, and urging you to make this third year, 1928, truly a banner one.

**REPORT OF THE DEPARTMENT OF RELIGIOUS EDUCATION  
OF THE WOMAN'S AUXILIARY, DIOCESE OF ATLANTA,  
1927, Rosa Woodberry, Chairman.**

The Auxiliary has centered its activities in religious education the past year largely in the Adult Division, promoting Bible Classes. Many of the Auxiliary members are leading these classes, not only in the Auxiliary but in Church schools, guilds other parish organizations. The Diocesan branch fostered two notable series of Bible classes in Atlanta, a Lenten class by the Bishop, and a pre-advent class by the Rev. Gardner Tucker.

Bishop Mikell gave a series of six addresses during Lent on the women of the Bible, which will long be treasured for their beauty and spiritual helpfulness. They were given in All Saints Church and attended by hundreds at each session, representing all the parishes in the city.

Dr. Tucker gave six lectures on the drama of the covenant, an outline study of the Old and New Testaments. This course is an accredited teacher's course, and many will complete the credit. This also was given at all Saints Church, and attended by many from the various parishes of the city, who were most grateful for this splendid instruction.

Both series were the outcome of a deep conviction of our Diocesan Auxiliary Board that the study of the Bible should be provided for more widely. It is with deep thankfulness that the Board can announce that Bishop Mikell has consented to again conduct a class in Bible study during Lent of 1928. The addresses will be given at All Saints.

Besides these notable classes, Bible classes under the auspices of the Auxiliary are reported from the Epiphany, All Saints Young Woman's Auxiliary, St. James, Marietta, Christ Church, Macon, St. Paul's, Macon, St. Peter's, Rome, Trinity, Columbus, St. Luke's, Atlanta.

Prayer Book classes are reported from Christ Church, Macon, St. Paul's, Macon, St. James, Cedartown.

One of the greatest contributions to religious education that the Auxiliary is making is in teaching in the Church School. About one hundred are enlisted in this service: All Saints, 4, All Saints Y. W. A. 5, St. Luke's, 6, St. Philip's, 1, St. Philip's Y. W. A., 4, Epiphany, 8, Church of our Saviour, 5, Incarnation, 1, Holy Trinity, Decatur, 2, Marietta, 3, Christ Church, Macon, 11, St. Paul's, Macon, 3, St. James, Macon, 4, St. James, Cedartown, 2, Rome, 5, Trinity, Columbus, 12.

The use and distribution of prayer leaflets and of other religious literature has been a splendidly worth while activity of the parish branches, reported by many.

The use of the Department's publication, "Findings", is strongly urged upon the branches. Especial attention is called to a most thoughtful and stimulating article, "Why Have a Bible Class", in the January Spirit of Missions.

#### REPORT OF SECRETARY OF MISSIONARY EDUCATIONAL DEPARTMENT

The Missionary Educational Department has much to look forward to this year, and the future looms large in unusual interest for the study classes.

The subjects given by the National Council—A study of the Bible during the season of Epiphany, and a course on personal service in making known to all the world the mission and message of the church, fit most appropriately into the teachings of the church year. At Epiphany, that picturesque season of light and radiance, we seek illumination on the Bible and in Lent, the season of sacrifice and meditation we have the subject of personal service.

The text books—"A Discussion Course on the Bible" by Miss Boyer, and Mrs. Haas, and "A Church Awake" by Dr. Sturgis afford a delightful background for the programs.

The summer conference at Sewanee had brilliant advantages for the study classes and there were many representatives from the auxiliaries of the diocese—All Saints, Atlanta; Trinity, Columbus; Saint Luke's, Atlanta; Christ Church, Macon; Saint Paul's Church, Macon; Saint James, Marietta.

The courses given by Miss Boyer on the Discussion Methods, and the one by Dr. Loving Clark were high places in the curriculum. Miss Boyer thoroughly won over her classes to the advantages of the discussion method, so ably presented by her, and it is gratifying to know we have splendid material to draw upon in those who took her classes.

A Year Book of study has been prepared and sent to all the parish presidents for a guide to the programs. Additional programs are inserted on the two great tasks for the women of the church—"The United Thank Offering," and the "Corporate Gift." These have not

only a heart interest for us, but an educational one also, and deserve a place on our programs. "More things are wrought by prayer, than this world dreams of," so let us add to the success of our classes in this way, and please allow a program on "The Prayer Partnership Plan."

May we hope for a year of splendid achievement in our educational department, emphasizing that the mission and message of our church is to "Proclaim to every kindred, tongue, and nation, that God in whom we live and move is love."

#### REPORT OF CHRISTIAN SOCIAL SERVICE OF THE DIOCESE OF ATLANTA

Madam President and women of the Auxiliary:

My report is necessarily somewhat different from one given last May in Cedartown, in that it deals more with the detailed work accomplished during the last seven months. The Parish reports are very encouraging and I find the same line of work going on that will always constitute the main part of Christian Social Service—supplying clothing and food and the privileges connected with Hospital work.

The total sum of money expended is \$3,395.31 last year, \$2,592.32—an increase of \$1,202.99.

The two Young Woman's Auxiliaries, All Saints and St. Philip's, deserve especial mention. All Saints branch made over 6000 surgical dressings for Grady Hospital; 100 visits there and sent over 500 magazines to the wards. These girls are very active in every line and so ready and willing to respond to any call. St. Philip's Y. W. A. has continued the weekly Thursday night visits to Hospital No. 48 all year and entertained our disabled shut-in soldiers, and this evening is looked forward to eagerly by the boys as one of the brightest spots of the week. One of the young women in her work as attendance Officer for the schools pursues a splendid welfare work of her own—she comes constantly to homes of the poor and sick and has raised \$75.00 herself to use for most serious cases. She also secured a scholarship for a young girl badly in need of a change of environment.

Mrs. Houston Johnston, of All Saints, and her committee are following the National Program of Prison Work more than any other Parish reported. They have been instrumental in securing a hearing on the manner in which prisoners are shackled at the City Stockade. So far shackles have been welded on both legs and have caused much pain and soreness as it was impossible to remove them even from one ankle for sleeping. In future we hope for locks and the possibility of eliminating some suffering.

Mrs. Downing at St. Luke's has been active in arranging committees to carry children to and from the Tuesday and Thursday clinics; also furnishing a monthly sum of \$6.00 for milk fund for children who need it.

St. James, Cedartown, reports second largest amount in their budget. I am very proud of this little Parish.

Most of the reports were accompanied by enthusiastic letters about their own work and some asked for information in regard to extending the work. We are obliged to judge our life in our social service, our activities, by our financial reports, yet we know that it is not the most important—it is the personal touch, the influence given by a kind word and a smile of friendliness and a hand clasp.

A very fine report came from Fort Valley. They are teaching health and cleanliness throughout their community. Women are

joining the first aid classes and working with the nurses. They send health literature to the rural schools and a nurse takes picture charts to these same schools, and lectures also.

At Christmas they distributed about 100 tooth brushes and tubes of paste. All this work deserves much praise.

Our own little struggling Mission in Atlanta, St. Matthias, is working to teach, clothe and feed a number of colored boys and girls. They always look clean and are well mannered children, as one will see upon entering the school. I could go on indefinitely giving very interesting examples from all over our Diocese, but there isn't time.

Let us each do a little more this year, give more money and more of ourselves to our less fortunate brothers and sisters. Perhaps in assisting to unlock their shackles we may loosen some of our own.

#### REPORT OF BOX SUPPLY DEPARTMENT

In giving my report, I feel this past year has been a most successful one as all Parish Auxiliaries seem well educated in this piece of their Missionary work to our neighbors, through the Woman's Auxiliary.

The allotments seem well filled and the reports came in nicely before January, 1928, which made it so much easier for me in sending my New York report to Mrs. Wade and in getting up this one.

It was a real inspiration and help to have had our National Box Supply Secretary, Mrs. T. K. Wade, to come to us in November, after having visited nine other Dioceses in the South. She having been in this work for seven years and instrumental in putting this system of box work into effect in the United States and abroad.

We have sent out during 1927 from this Diocese forty-two boxes with twenty-three Parish Auxiliaries contributing, at a total valuation of 2,127.25.

Fifteen Missionary boxes to Miss Edwards, Lower Pocosan Mission, McMullen, Virginia. Total, \$476.38.

Twenty-one Missionary boxes to Miss Ella Pier, Bear Mountain or Christ Mission, Amherst, Virginia. Total \$1,584.88.

Three personal boxes under one allotment from three Auxiliaries contributing to Rev. Thos S. Forbes, Emmanuel Church, Accomac, Virginia. Total \$60.99.

One Christmas gift to United Thank Offering Missionary, Miss Sarah Ashurst, Guantanamo, Cuba. Total, \$5.00.

The medical supplies included were entirely taken care of to Bear Mountain or Christ Mission, Amherst, Va., by the Young Women's Auxiliary of All Saint's Church, Atlanta. They also making and sending a complete baby layette with this allotment.

As we were working and giving in the name of Christianity it has been added to us in the following allotments from other states, as follows:

To St. Elizabeth's Mission (Col.) LaGrange, Ga.

To St. Mathias Mission (Col.) Atlanta, Ga.

To Fort Valley High and Industrial School (Col.) Fort Valley, Ga.

In closing, I wish to thank each Parish secretary and everyone for their suport in making this a successful year in the box work and a very happy New Year that is upon us now to be filled with good deeds.

### ANNUAL REPORT CHURCH PERIODICAL CLUB, DIOCESE OF ATLANTA, 1927

Madam President and Co-workers:

At our last convention, I begged you to let me come before your body the next time filled with gratitude and praise for you in the splendid co-operation you had given in this department of your church work. So today I want to personally thank all of you who contributed the past year to the Church Periodical Club, by contributions, service and prayer. The few of you who have assisted, have helped very much to carry on this beautiful work; but for our sakes, as well as for theirs, I so earnestly wish that many more of us in this diocese, could appreciate the privilege of caring in this way for our workers and sisters and brothers less fortunately situated than we, and so not only do their full parts, but reap the true joy inevitably accompanying such service for our Lord. During 1927 we sent more magazines regularly, but your annual reports showed a gain of only seven more donors of same—72 interested and working people among over 7200 confirmed members in the diocese. Was YOUR name among them?

For the year, the current periodicals sent regularly numbered 109; donors of same, 72; Bibles, Testaments and Hymnals, 62; Books 57; Tracts and Catechisms, 2405; Odd magazines, 5137; Christmas and Easter cards, 439; Church calendars, 57; Music in books, sheets or records, 150; Pictures, games and scrap books, 742; Institutions in diocese aided, 12.

Your local secretaries are, on the whole, doing splendid work, tho often handicapped and greatly discouraged by the indifference so generally met. They are powerless without the co-operation of each member of the diocese; and to you, who have assisted them in any way, I want to express my deep appreciation.

The used magazines distributed locally have materially increased in number, and much good has been accomplished by same. But may I again plead with you not only to pass on your used reading matter, but also to honor your Lord with the FIRST fruits of your substance, His own blessings bestowed upon you, by sending one new subscription annually to some missionary or worker in the field? Surely He is worthy of our best, and is calling for nothing less from us. Send your new subscription first, and THEN pass on your used periodicals, so that at home and abroad, our workers may be strengthened and cheered by knwing we care—not just the 72 out of our more than 7000, but ALL of us. "Inasmuch as ye have done it unto one of the least of these my brethren, ye have done it unto me."

**CONSTITUTION AND BY-LAWS OF THE WOMAN'S AUXILIARY  
OF THE DIOCESE OF ATLANTA****ARTICLE I—NAME**

The name of this association shall be the Atlanta Diocesan Branch of the Woman's Auxiliary to the National Council.

**ARTICLE II—OBJECT**

The object of this association shall be to promote within and without the Diocese the great aims of Christian service in Missions and Church Extension, in Religious Education, and Social Service.

**ARTICLE III—MEMBERSHIP**

1. The Bishop and clergy of the Diocese shall be ex-officio members.
2. Any baptized woman whose declared intention is to actively engage in any branch of the work of this organization shall be eligible to membership.
3. Others on vote of the organization may be admitted as associates and known as Auxiliary Co-Workers.

**ARTICLE IV—ORGANIZATION**

1. This association shall be organized with departments along the lines of the National Council.
2. The officers shall be a President, three Vice-Presidents who shall be Department Chairmen, a Corresponding and Recording Secretary, a Treasurer, a United Thank Offering Custodian.
3. There shall be a Diocesan Board of Directors composed of the officers, the Department Chairman and Parish Presidents, and past Diocesan Presidents. This Board shall have power to organize departments along the lines of the work of the church at large. Each department shall make an annual report.
4. There shall be an Executive Committee of the Board of Directors consisting of the Officers and Department Chairmen.

**ARTICLE V—ELECTIONS**

1. All officers shall be elected at the Annual Convention for three years, and shall not be eligible for re-election to the same office.
2. Nominations shall be made by a nominating committee, appointed by the President, and the election shall be made by ballot.
3. The Secretary of the Convention shall notify in writing all officers and chairmen of their election immediately after adjournment.

**ARTICLE VI—REPRESENTATION**

Each parish and mission shall be entitled to two delegates and its president.

The clergy, board members and officers shall be entitled to one vote.

No person may have more than one vote and no proxies are allowed.

### ARTICLE VII—MEETINGS

1. The Diocesan Branch of the Woman's Auxiliary shall meet annually on the day preceding the meeting of the Diocesan Council.

The Executive Committee shall meet at least three times a year, preferably in January, October, and preceding the annual Convention.

The Auxiliary Board of Directors should meet preceding the annual convention.

A quorum of the Executive Committee shall be five. A quorum of the Board of Directors shall be 10.

### ARTICLE VIII—FINANCES

1. The fiscal year shall be from January 1st to January 1st.

2. The Diocesan assessment shall be 25 cents per capita annually on each member of the Auxiliary for Expense Fund.

3. The Executive Committee shall order the disbursement of funds, subject to the action of the Annual Convention.

4. The several departments may hold and disburse funds acquired for their specific work. They shall make an itemized statement of receipts and expenditures at the Annual Convention.

### ARTICLE IX

This Constitution may be amended at any Annual Convention by a majority vote, provided due notice has been sent every branch of the proposed amendment, and a copy of the same.
