MINUTES OF THE 23D ANNUAL CONVENTION OF THE
WOMAN'S AUXILIARY TO THE NATIONAL COUNCIL
OF THE DIOCESE OF ATLANTA

The 23d Annual Convention of the Woman's Auxiliary of the Diocese of Atlanta was called to order by the President, Miss Theodosia Tinsley, at 10:30 A. M., Wednesday, January 22, 1930, in Eggleston Hall of All Saints' Church, Atlanta. Mrs. William Parker, Jr., Diocesan Chairman of Prayer Partnership, opened the meeting with prayer.

Mrs. Henry Davis asked the privilege of the floor to bring before the meeting the question of the entertainment of future conventions. This matter had been discussed in the Diocesan Board meeting but no action taken. Mrs. Davis asked that the Diocesan Board empower the Executive Committee to act upon this matter after a questionnaire had been sent over the diocese to obtain a consensus of opinion. The question was put, seconded and carried, giving the Executive Committee power to act for the Diocesan Board.

Mrs. Thomas Morgan, President of All Saints' Woman's Auxiliary made a gracious welcome to the delegates and visitors in the name of her parish. Mrs. Frank Bone of Milledgeville made the response for the delegates.

Miss Tinsley then gave the President's address. Mrs. John F. MacDougald made the Treasurer's report, which was accepted with thanks.

The Rev. W. W. Memminger, Rector of All Saints' Church, asked the privilege of welcoming the Auxiliary to his parish, which he did in a cordial manner.

The report of the Secretary was read by Mrs. F. R. Graham and accepted with thanks.

Miss Tinsley appointed the following courtesy committee: Mrs. L. E. Bassett, Cedartown, Chairman; Mrs. Joe Ezell, Macon; Mrs. James O'Neill, Rome; Miss Elinore Ravenell, LaGrange.

Mrs. John Talmadge, Jr., Custodian, made the report for the United Thank Offering, reporting \$2,038.41 collected for 1929. Mrs. Talmadge reminded the convention of the resolution of 1925 when March and September were the times set for collecting the offering, asking the members to send in their offerings promptly that the full interest might be earned and the books closed promptly.

Mrs. Henry Davis then brought a message from the recent synod meeting in Columbia, S. C. Mrs. Davis worked on the Committee on By-laws and saw that they were printed. By a new rule the officers are elected for three years. The province voted \$300.00 to the department of Religious Education, and every diocese was asked to take a part in providing for this in the future. Mrs. Davis spoke of the Emerald Hodgson Hospital Fund of Sewanee, Tenn., and stated that our diocese had not contributed to this fund, and that Bishop Mikell had said that the collection from the services at this meeting could be devoted to this purpose so that our diocese could be represented.

Miss Louise Schilling, Vice-President and Chairman of Rural Work, made the report of Rural Work which is a new department in our Auxiliary. Miss Schilling reported that ten branches had done some rural work. Miss Schilling asked for time later to discuss further the rural program for the diocese.

Miss Tinsley then appointed the following committee on Resolutions: Mrs. Arthur Tufts and Mrs. Robert Alston.

Mrs. A. H. Sterne made the report of the Department of Missionary and Religious Education. Mrs. Sterne reported that the Book Tables were successful where ever tried out, and made an earnest request for the branches to do more spiritual reading and Bible study. The Bishop's Bible Class to be held each week in Lent at All Saints was announced.

The report of Christian Social Service was made by Mrs. Walter T. Downing. She made a plea that each parish should give money support to the parish Social Service Chairman, and that each branch aim to give a Social vision to the whole parish.

A letter from Mrs. Thos. Johnston, our former Social Service Chairman, sending greetings, was read by Mrs. Davis. Miss Rosa Woodberry brought a message of loving greetings from Mrs. Mallory Taylor, Mrs. Chas. Pettigrew and Mrs. E. LeC. Furman, all former officers. Mrs. John MacDougald moved, seconded by Miss Snook, that the Secretary write letters to these former faithful workers sending them our loving greetings, and to Mrs. Will Erwin, our Gift of Life Chairman, whose illness prevented her attendance at the meeting.

Mrs. James O'Neill, Box Supply Chairman, made her report, requesting that all parishes promptly notify the chairman of their acceptance of their allotment, and then report promptly when the box is sent.

The noon hour having arrived, Dean de'Ovies of St. Philip's Cathedral, said the prayers and held a beautiful meditation on Prayer which touched the hearts of all present.

The Secretary read the Memorial and the Auxiliary stood as the names of our co-workers who had passed away was read. They were: Miss Mattie Williams, Mrs. Stephen Reade, St. Luke's, Atlanta; Mrs. R. H. Arnold, Mrs. George H. Noble, Mrs. J. A. LaFitte, St. Philip's, Atlanta; Miss Ruth Jane Elmer, Epiphany, Atlanta; Miss Mamie Cox, Miss Alice Curtis, Trinity, Columbus; Mrs. Evelyn Cleyborn Dimmock Henry, Mrs. C. F. O'Keif, Miss Louella Shoen, St. Peter's, Rome; Mrs. A. B. Scott, St. Stephen's, Milledgeville; Miss Mattie Eppes, Grace, Clarkesville; Mrs. J. E. Lewis, Calvary, Mt. Airy, Deaconess Katie Campbell, Appleton Church Home, Macon. The Secretary read a letter in tribute to Mrs. J. E. Lewis of Cornelia, who for many years has been the lone representative of the Auxiliary in that community.

Mrs. Henry Davis made the Corporate Gift Report stating that we had given more than asked of us. Mrs. Davis stated that there would be no new Corporate Gift and read the resolution concerning it in the Spirit of Missions for January 1930, explaining that the women would work with the men in the forward movement of advance work.

Mrs. MacDougald put a motion that a Diocesan Auxiliary Scrap Book Chairman be appointed, Mrs. Henry Davis to be asked to be the Chairman. The motion was seconded by Miss Snook, put and carried. Miss Tinsley appointed Mrs. Davis.

Mrs. C. C. Harrold reported for the Diocesan Negro Fund a total of \$452.85 had been collected. Mrs. Harrold made a plea for the women to interest themselves in inter-racial work.

Mrs. H. N. Hurt reported for the Bishop's Educational Fund for training men for the ministry, and stated that eight young men are being helped with their education. The amount collected this year was \$1,063.01 which fell short of the pledge of \$1,200 which we hope to reach next year.

Mrs. Thomas Morgan introduced Mrs. Dan Harris, President of All Saints' Guild who assisted the Auxiliary in entertaining the conventionat luncheon. Mrs. Harris extended the invitation to luncheon.

Mrs. H. J. Mikell extended the invitation for 5 o'clock tea which was to be given that afternoon by Bishop and Mrs. Mikell. The motion was then made to adjourn for luncheon.

At 2:30 P. M. the meeting was called to order by the President who asked for the report of the Appleton Church Home Fund. Mrs. Banks Yonge, Chairman, asked the privilege of having Miss Crawley, Executive Secretary of the Home, make the report and tell something of the Home. Miss Crawley reported \$1,076.82 had been given through the Woman's Auxiliary. Miss Crawley spoke on Mother's Aid, stating that Georgia was one of the four states without such provisions. Miss Crawley asked the women to create a Mother's Aid Fund to be administered through the Appleton Church Home. No action was taken.

Mrs. G. J. Springman of Columbus, Director for the diocese of the Church Periodical Club, made a talk pointing out six ways to help the C. P. C. and stating her aim "A branch of C. P. C. in every parish."

Mrs. William Parker, Jr., Chairman of Prayer Partnership, reported 28 branches praying and working for their missionary and seven isolated church women who have adopted a partner.

The report of the Registration Committee was made by Miss Lambert of All Saints who reported that 110 had registered consisting of 12 parish presidents, 35 delegates, 14 officers and chairmen and 49 visitors.

The Gift of Life Chairman, Mrs. Will Erwin, was ill and no report was made of this work.

Parish reports were then called for and made. Every branch being represented except five. Mrs. B. M. Waller of Holy Trinity, Decatur, who was retiring after serving for ten years as President of her branch, was applauded for her long and faithful service which has been an inspiration to all who have known Mrs. Waller.

The report of the Resolutions Committee was made by Mrs. Arthur Tufts:

In view of the fact that the Negro Fund is under-subscribed, Be it resolved, that the deficit be paid from the General Expense Fund. Mrs. C. C. Harrold seconded by Mrs. A. H. Sterne. After a good deal of discussion Mrs. Davis offered a substitute, that after the chairmen have submitted their bills, if there is a residue, then the deficit of the Negro Fund can be paid from the residue. Mrs. Harrold accepted the substitute motion and it was carried.

President's Expense Fund: Mrs. H. N. Hurt made a motion, seconded by Mrs. J. H. Williams that the sum of fifty dollars a year be set aside from the Expense Fund to defray the expense of our President to the Triennial Convention which will be held in Denver in 1931. After discussion this motion was carried.

Mrs. Davis made a motion, seconded by Mrs. MacDougald, that all resolutions with reference to money and funds be submitted to the Executive Committee before they are submitted to the convention. Carried.

The following resolution was offered by Mrs. Henry Davis, seconded by Mrs. A. H. Sterne: That the Woman's Auxiliary petition the Executive Board of the Diocese and members of the Council not to reduce the space allotted to the Woman's Auxiliary in the Diocesan Record. We feel that the publicity given through the Record is of invaluable help to us in the conduct of our business. Carried.

Miss Tinsley read a letter from Mrs. Allan Gray, Episcopal Editor of the Federated Church Women of Georgia, asking that the Auxiliary

branches send in notices to her to be published in the Sunday edition of the Atlanta Constitution.

Mrs. Arthur Tufts spoke of the Illiteracy Campaign being conducted in Georgia, urging the women to help in any way possible. Mrs. William Parker, Jr., said the closing prayers and the meeting was adjourned until next day.

At ten o'clock, Thursday, January 23d, the meeting was called to order by the President and the opening prayers were said by the Rev. W. W. Memminger, Rector of All Saints. As the meeting from ten o'clock to twelve o'clock was to be a Christian Social Service conference, Mrs. W. T. Downing, Chairman, introduced the speaker, the Rev. Dr. Cary Montague of Richmond, Va., Executive Secretary for the Board of Social Service of the Diocese of Virginia. The first half of Dr. Montague's address was on the "Principles of Social Service," using the Bible as the text book, pointing out that Social Service is religion in action. The second half of his lecture was given over to practical suggestions as to how to organize a parish for Social Service work, and gave twenty-five examples of kinds of work to do, laying stress on co-operating with all existing agencies of organized civic social work. Dr. Montague held an open forum, answering questions asked. Miss Wolfork of the Atlanta Family Welfare Society made a plea for all to stand behind the Community Chest.

The State Public Welfare Department was represented by Miss Louise Fitzsimmons who explained the work done at the Capitol in supervising state institutions. The Social Service Exchange was represented by Miss Ansley who explained the work done by this agency. The Child's United Social Agency was represented by Miss Fitzsimmons and the Children's Aid Program that is being formulated was explained. Mrs. Henry Davis spoke briefly for the Traveler's Aid. About a hundred and fifty were present at this conference.

Following the conference the convention was called to order by Miss Tinsley, and Miss Schilling discussed the Rural Work program for the diocese, asking for suggestions. It was suggested that we get the co-operation in the county and have a service in some of the empty churches although of other denominations, each Auxiliary could try to have such a service.

The Rev. C. E. Bentley, Chairman of the Appleton Church Home Board, made an appeal for Mother's Aid, asking the Auxiliary to allow the board to use some of the maintenance fund for Mother's Aid.

The Treasurer, Mrs. MacDougald, announced that the offering taken for the Emerald Hodgson Hospital, Sewanee, Tenn., was \$67.05, which was forwarded to Mrs. Loring Clark, the Provincial Chairman.

Mrs. C. C. Harrold made a motion, seconded by Mrs. A. H. Sterne, that we act upon the Mother's Aid request of Mr. Bentley. After much discussion the following resolution was put and carried: "That if the Appleton Church Home Board so desires, the Woman's Auxiliary will transfer a part of the Appleton Church Home Maintenance Fund to Mother's Aid Fund, the amount to be used to be left to the discretion of the Board."

Mrs. Russell K. Smith made a motion, seconded by Miss Snook, that all funds be closed January 1, so that the Diocesan Treasurer can close her books and give a balanced report so that the affairs of the Auxiliary can be put upon a proper business basis. Carried.

The report of the Courtesy Committee was made by Miss Ravenell of LaGrange. Courtesy Committee Report:

The Woman's Auxiliary in Convention assembled at its 23d annual meeting, wishes to express its hearty thanks and appreciation for the hospitality extended by the women of All Saints, both to the Auxiliary and Guild. Especially we wish to thank them for the delightful supper served to the Executive Committee Tuesday evening and the delicious luncheon on Wednesday. We have had a very happy visit to All Saints, and we will go back to our homes with renewed interest in our work.—Mrs. L. E. Bassett, Mrs. Joe Ezell, Mrs. James O'Neill, and Miss Ravenell, Committee.

The meeting was then adjourned and dismissed by prayer by Miss Rosa Woodberry.

MINUTES OF THE MEETING OF THE DIOCESAN BOARD, ALL SAINTS, ATLANTA, JANUARY 23, 1930.

The meeting of the Parish Presidents, officers and chairmen forming the Diocesan Board of the Woman's Auxiliary, was called to order by Miss Tinsley at 10 A. M., January 23d, in Eggleston Hall of All Saints Parish, Atlanta. Miss Tinsley then explained that a good deal of extra and unnecessary work was put upon the Diocesan Treasurer by the branches not sending in their checks promptly when due and requested that all funds be paid into the treasury before January 1st.

Miss Tinsley then asked that the entertainment of delegates at future conventions be discussed. The Diocesan Secretary explained that under the plan of the Council introduced at Macon, delegates to the Council are expected to be provided for by their own church or mission paying their expenses. This year the Auxiliary felt obliged to follow this plan, but an embarrassing situation for the entertaining parish arises and to avoid this, the officers felt the branches should express how they wished to proceed in the future. Each President is asked to go back to her Auxiliary branch and to discuss the matter and get an expression from her branch and answer a future questionnaire which will be sent out, and then empower the Executive Committee to act. No action taken.

Miss Tinsley asked for a discussion of the question, should the method of gathering reports be changed. It was brought out in the discussion that diocesan chairmen want itemized reports but only totals should be sent to the Secretary.

It was suggested that carbon copies of reports of branch chairmen be given to the Branch President so that the reports that come to the Secretary will tally and be correct. At the present time there is confusion in the reports. Mrs. Shepard of Griffin asked that there be a discussion of the kinds of reports wanted in Social Service. Mrs. Downing, Diocesan Social Service Chairman replied that the branch should report the collective work of the branch, and not the efforts of individual members unless acting for the branch.

As the half hour for the meeting was up at this point, the meeting was adjourned. There were about thirty present.

REPORT OF SECRETARY

The work of the Woman's Auxiliary of the Diocese of Atlanta for 1929 has gone steadily forward. We have had this year a Chairman of Rural Work and a Chairman of Gift of Life, which are new chairmanships. All of the Chairmen have been active and faithful in the performance of their different duties.

There have been three meetings of the Executive Committee; in January, April and October, and one meeting of the Executive Board held in Macon, January 23, 1929. We were represented at the meeting

of the Provincial Synod at Columbia, S. C., November 6, 1929, by three of our Chairmen, Mrs. Davis, Mrs. Downing, and Mrs. Talmadge.

The following special services were held: Diocesan Corporate Communion held at Christ Church, Macon, Diocesan Lenten Corporate Communion, first Friday in Lent, held at St. Luke's for Atlanta branches, and at the same time at St. Paul's, Macon, for Macon branches; at St. Peter's, Rome, Corporate Communion and presentation of the U. T. O. Maundy, Thursday, and at St. Paul's, Macon, on St. Luke's Day, October 18, Corporate Communion and U. T. O. presentation for the three Auxiliary branches of Macon. There was also held an Inter-Parochial meeting of Atlanta branches at St. Luke's on February 1, 1929. The Inter-denominational Day of World Prayer was also observed in February, the Episcopal Church women being represented on the program held in Atlanta, by Miss Rosa Woodberry and Mrs. A. H. Sterne. Two diocesan movements were directed by your Secretary, namely letters and literature were mailed all branches and co-operation asked in stimulating the interest in the parish in the Good Friday Offering, this being a request of the National Council, the other a provincial project, namely the Campaign for Home Co-operation in Religious Education.

Your Secretary has prepared and had printed one hundred copies of the Annual Report. Your Secretary has month by month prepared and collected material for the Woman's Auxiliary pages in the Diocesan Record, and furnished material and co-operated with the Federated Church Women of Georgia, whose page is published weekly in the Atlanta Constitution.

REPORT OF THE DEPARTMENT OF RELIGIOUS AND MISSIONARY EDUCATION

The Department of Religious and Missionary Education has had for its aim this past year an awakening of its spiritual and missionary conscienceness, "creating a broader vision of the purpose of God in the

life of the world, and for realizing our share in the building of the Kingdom." It has tried to lead us from our pre-occupation with the forces of materialism and convince us beyond all argument that the great experience for us as well as the great hope of the world lies in understanding and following, not, material but spiritual things."

Through the columns of the Record this department tries to keep all of the branches informed as to books for their study groups, books for individual study or reading, and helpful leaflets for the book tables. In some of the parishes where the book tables have been tried out they have been most successful, filling a long felt need.

There have been reported a number of study classes, Bible classes, prayer book classes, program meetings, a large number of auxiliary members teaching in church schools, and leaflets and church papers have been widely distributed.

REPORT OF FIRST VICE-PRESIDENT, CHAIRMAN OF MISSIONS AND RURAL WORK

The Department of Missions and Rural Work has only recently been organized as it was in New Orleans in 1925 at the General Convention that a committee was appointed whose purpose was to survey, through research, the Church's work in the region covered and to study the means by which to compass the extension, the better equipment and the increased efficiency of that work. As there had been no program for Missions and Rural Work outlined in the diocese, your chairman was at a loss just how to approach this work, especially as there was no precedent to follow. After a study of all literature available from our Church Missions House and from the "Rural Messenger," a paper published by our Church in Mississippi, a letter was sent to each auxiliary, asking them to observe May 5th, Rogation Sunday, as Rural Work Sunday, and programs and follow-up work and activities for some were printed in the Record. Your chairman also asked co-operation for Rev. Geo. H. Harris in the splendid work he is doing in North Georgia.

In accordance with the idea of "County approach," your chairman made a survey of the diocese and apportioned the eighty-one counties therein to the auxiliaries, about thirty-two in all. Also prayers, programs and activities as outlined for Parish and Diocesan work were sent to each auxiliary and printed in nearly every issue of the Diocesan Record. Now follows the report on our efforts to place this work before the auxiliaries.

Two branches reported observance of "Rural Work" Sunday.

About ten branches reported having written to Superintendents of schools with little response, and no progress made.

Chapter K, Athens, reported distribution of magazines in the county through the Curb Market.

Marietta sent about 300 magazines to the county alms house.

All Saints' branch rendered aid to families in Fulton County.

Decatur branch contributed clothing and school supplies to rural schools.

Cedartown contributed food, clothing, flowers and fruit to the amount of \$42.00 in Polk County.

St. Anne's branch, Marietta, has done some follow-up work in regard to Cobb County.

Incarnation branch, Atlanta, reported one teacher and four pupils in Eatonton who were Episcopalians and they were to write for more information.

Epiphany branch reported an auxiliary member who spent her summers in Helen and held prayer book services and a Sunday school when possible. Another member who visits the Battle Hill Sanitarium and holds Bible classes and evangelical meetings. Another member who visits the alms house.

The Ft. Valley High and Industrial School for colored men and women also sent in a splendid report. They look after the afflicted, prepare girl graduates for the Nurses' Training School and Social Service work in Raleigh. Through the Puublic Health Chairman they give instruction to children in rural schools, also Family Welfare work, reading the Bible to old people, and encouraging the young people to keep the "Sabbath Day Holy." Their report ends, "Our auxiliary is interested in every phase of Mission and Rural Field work." What a wonderful vision. We pray God to bless their efforts.

Our missionary program in the rural field must be one commendable in the sight of men as well as acceptable to God. It must have Christian leadership, the souls of men must be captured for Jesus Christ, not just for the Episcopal Church.

At the triennial meeting held in Washington in October, 1928, it was decided at the request of Bishop Murray, that the Woman's Auxiliary under take to raise another Corporate Gift to be completed by Epiphany, 1930. At the December meeting of the Executive Board \$50,000 was the goal set and the objects selected were as follows:

The National Executive Committee divided the amount to be raised into allotments for the dioceses and Mrs. Robert Burkman was again appointed General Chairman. The amount asked from the Diocese of Atlanta was \$256.00 and Mrs. Henry W. Davis was appointed chairman for the diocese. A tentative allotment for the diocesan branches was made out by a committee and the information distributed to the branches.

The diocese responded willingly and effectively to the request, thirty-two branches having contributed, realizing by Easter one-half of the sum which was then sent in to Mrs. Burkham, and by Epiphany the other half, and reaching by the time of our recent annual convention the sum of \$268.27, or \$12.27 over our allotment.

As chairman of the Gift for the diocese I want to express my appreciation and gratitude to all of the women of all of the branches for their willing and courteous co-operation. It is particularly inspiring and noteworthy that all of the regular branches as well as several guild-auxiliaries have contributed, and I am grateful for the interest so well demonstrated.

CONSTITUTION AND BY-LAWS OF THE WOMAN'S AUXILIARY OF THE DIOCESE OF ATLANTA

ARTICLE I—NAME

The name of this association shall be the Atlanta Diocesan Branch of the Woman's Auxiliary to the National Council.

ARTICLE II—OBJECT

The object of this association shall be to promote within and without the Diocese the great aims of Christian service in Missions and Church Extension, in Religious Education, and Social Service.

ARTICLE III—MEMBERSHIP

1. The Bishop and clergy of the Diocese shall be ex-officio members.
2. Any baptized woman whose declared intention is to actively engage in any branch of the work of this organization shall be eligible to membership.
3. Others on vote of the organization may be admitted as associates and known as Auxiliary Co-Workers.

ARTICLE IV—ORGANIZATION

1. This association shall be organized with departments along the lines of the National Council.
2. The officers shall be a President, three Vice-Presidents who shall be Department Chairmen, a Corresponding and Recording Secretary, a Treasurer, a United Thank Offering Custodian.
3. There shall be a Diocesan Board of Directors composed of the officers, the Department Chairman and Parish Presidents, and past Diocesan Presidents. This Board shall have power to organize departments along the lines of the work of the church at large. Each department shall make an annual report.
4. There shall be an Executive Committee of the Board of Directors consisting of the Officers and Department Chairmen.

ARTICLE V—ELECTIONS

1. All officers shall be elected at the Annual Convention for three years, and shall not be eligible for re-election to the same office.
2. Nominations shall be made by a nominating committee, appointed by the President, and the election shall be made by ballot.
3. The Secretary of the Convention shall notify in writing all officers and chairmen of their election immediately after adjournment.

ARTICLE VI—REPRESENTATION

Each parish and mission shall be entitled to two delegates and its president.

No person may have more than one vote and no proxies are allowed.

ARTICLE VII—MEETINGS

1. The Diocesan Branch of the Woman's Auxiliary shall meet annually on the day preceding the meeting of the Diocesan Council.

The Executive Committee shall meet at least three times a year, preferably in January, October, and preceding the annual Convention.

The Auxiliary Board of Directors should meet preceding the annual convention.

A quorum of the Executive Committee shall be five. A quorum of the Board of Directors shall be 10.

ARTICLE VIII—FINANCES

1. The fiscal year shall be from January 1st to January 1st.

2. The Diocesan assessment for Expense Fund shall be forty cents per capita annually on each member, this assessment to be collected and provided for by the auxiliary branch rather than from the individual members.

3. The Executive Committee shall order the disbursement of funds, subject to the action of the Annual Convention.

4. The several departments may hold and disburse funds acquired for their specific work. They shall make an itemized statement of receipts and expenditures at the Annual Convention.

ARTICLE IX

This Constitution may be amended at any Annual Convention by a majority vote, provided due notice has been sent every branch of the proposed amendment, and a copy of the same.
