

Pray ye therefore the Lord of the harvest, that He will send forth labourers into His harvest.—S. Matt. 9, 38.


THE PRAYER FOR THE UNITED THANK OFFERING

MINUTES OF THE 24TH ANNUAL CONVENTION OF THE
WOMAN'S AUXILIARY TO THE NATIONAL COUNCIL
OF THE DIOCESE OF ATLANTA

The 24th Annual Convention of the Woman's Auxiliary of the Diocese of Atlanta was called to order by the President, Miss Theodosia Tinsley, at 10 A. M. Wednesday, January 28th, in Trinity Church Parish House, Columbus, Georgia. Mrs. William Parker, Jr., Diocesan Chairman of Prayer Partnership, opened the meeting with prayer. Mrs. Banks Yonge, president of Trinity Church Woman's Auxiliary, made a gracious welcome to the delegates and visitors in the name of her parish. Mrs. Arthur Tufts, of St. Luke's, Atlanta, made the response for the delegates.

Miss Tinsley then gave the president's address. Mrs. John F. MacDougald made the Treasurer's report, which was accepted with thanks. The Secretary's report was read by Mrs. F. R. Graham and accepted with thanks. Mrs. MacDougald stated that more funds should be provided for the Secretary as a former resolution passed several years ago providing ten dollars annually did not cover the expense incurred. Mrs. Sterne moved that funds should be provided from the Expense Fund to cover the necessary expenses of the office of the Secretary not to be limited to ten dollars annually. This motion was seconded by Miss Rosa Woodberry with the suggestion that the Executive Committee handle this, and pass upon it, before the money is paid out as provided in our by-laws—seconded and carried.

In the absence of the United Thank Offering custodian, Mrs. John E. Talmadge, Jr., the United Thank Offering report was read by the Secretary, and a strong appeal was made for the women to pray and work for the offering that our goal of \$7,000.00 to be presented in September in Denver may be realized. A telegram was received from Mrs. Talmadge and read by the Secretary. Mrs. Banks Yonge moved, seconded by Mrs. Tufts, that the Secretary send a telegram to Mrs. Talmadge expressing our regrets at her absence.

Miss Tinsley appointed the following committees: Time keepers, Miss Rosa Woodberry, Miss Helen Miles; Courtesy, Mrs. Arthur Tufts, chairman, Mrs. Russell K. Smith, Mrs. Woolsey Couch; Resolutions, Mrs. W. E. Haskell, Mrs. S. A. Wragg, Mrs. Scheusler.

The report of the chairman of Missions and Rural Work was made by Miss Louise Schilling. Mrs. A. F. Sterne, chairman of Missionary and Religious Education, asked permission to file her report with the Secretary and be allowed to speak of forward work. Mrs. Sterne made a strong appeal for a definite program of education for each branch, to extend throughout the year, that each meeting might have a definite message, that the women realize that the depressed times are a challenge to us in our daily Christian life.

Miss Tinsley then announced the appointment of Mrs. Henry Davis to fill the unexpired term of Mrs. W. T. Downing, as chairman of Christian Social Service. Mrs. Davis to serve for the year 1931.

The report of the department of Christian Social Service was read by the Secretary, Mrs. Graham. Mrs. Arthur Tufts moved, seconded by Mrs. Sterne, that a rising vote of thanks be given Mrs. Graham for compiling this report.

The Roll Call of Branches was made with the following attendance: Atlanta, All Saints, 10; Church of Our Savior, 1; Epiphany, 2; St. Luke's, 3; St. Philips, 6; Macon, Christ Church, 1; St. Paul's, 3; St. James, 2; St. John's, College Park, 1; Holy Trinity, Decatur, 1; Trinity, Columbus, 21; St. James, Marietta, 2; St. James, Cedartown,

2; St. Peter's, Rome, 1; St. Mark's, LaGrange, 1; St. Timothy's, Kirkwood, 1; High and Industrial School Chapel, Fort Valley, 1.

The report of the Box Supply Secretary was read by Mrs. Graham, in the absence of Mrs. J. H. O'Neill. Mrs. MacDougald made a motion that a letter be sent by the Secretary to Mrs. O'Neill expressing our regrets at her absence, seconded and carried. Mrs. Parker asked that a letter also be sent Mrs. C. D. House, of Holy Comforter, Atlanta, for her long years of faithful service, seconded and carried.

The report of the Appleton Church Home was made by Mrs. Banks Yonge. Mrs. Yonge stated that the failure of a bank in Macon had affected the funds of the Home and asked the branches to send in funds as quickly as possible to meet this emergency. Mrs. Ed. Harrold, a member of the Executive Committee of the Home, answered questions and explained the financial arrangements of the Home. After some discussion Mrs. R. K. Smith moved that the Appleton Church Home Maintenance Fund go direct to Mrs. Banks Yonge, specials to be sent direct to the Home. Seconded by Mrs. Chase. Miss Woodberry moved, seconded by Mrs. Saumenig, that any large sums go through the Diocesan Treasurer as a special. All other specials in money to go to the Diocesan Treasurer. Boxes for the Appleton Church Home to be reported under Social Service.

The Diocesan Negro Fund was reported by the chairman, Mrs. C. C. Harrold, who made an appeal for more inter-racial work and for branches to make a pilgrimage to see the High and Industrial School at Fort Valley.

Miss Rosa Woodberry made an appeal for the Auxiliaries to contribute to the National Deaconess Fund, details of this appeal to be published in the Record.

The noon hour having arrived, the Rev. G. I. Hiller, of Athens, said the prayers and held a beautiful meditation on Ps. 121:1, "I will lift up mine eyes unto the hills, from whence cometh my help."

Bishop Mikell then addressed the meeting, thanking the officers and chairmen for their work, and all the members of the Auxiliary for the help given the Diocese through the Educational Fund, the Negro Fund, and the Appleton Church Home Fund. The Bishop asked the aid of the Auxiliary in helping to carry out the Advance Work Program of the church, our projects being a building at Fort Yukon, Alaska, and help at Cape Mount Liberia, Africa. The Bishop stated that the outlook of the diocese was most encouraging, and a student worker for the University of Georgia was being planned for. The Bishop then introduced Miss Amelia Hill, of St. John's in the Wilderness, Alaska. Miss Hill gave a most interesting account of seven years of service spent as a nurse in the Artic region with the nearest doctor 1,800 miles away. Miss Hill spoke of the work at Ft. Yukon and the need of the building which the Advance Work Program of the diocese will provide.

The meeting then adjourned for a delicious luncheon served by the ladies of Trinity Church. On reconvening, Mrs. Wm. Parker, Jr., made the Prayer Partnership report, stating that every branch had a prayer partner, and six isolated church women of the diocese also had their partners.

Miss Woodberry asked that the Auxiliary take action on definite plans to aid the Bishop in raising funds for the Forward Movement project, a building at Ft. Yukon, Alaska. Mrs. Graham stated that the Bishop desired a committee from each Auxiliary branch to cooperate with its rector in seeing that those persons who had not

responded to his letter appeal do so, and aid in every way the raising of this fund. Many branches offered themselves as ready to co-operate with this request.

Branch reports were called for, with the request by the President, that no financial figures be given. This request was complied with, and an interesting and inspiring hour was spent listening to the reports of the splendid things done by the twenty branches represented.

Miss Crawley, Executive Secretary of the Appleton Church Home, thanked the Auxiliary for the help given the Home through the maintenance fund, special gifts, and about \$700.00 worth of clothing in boxes received.

A forum on young women's auxiliaries was held. Miss Helen Miles of All Saints, Mrs. Allan Gray of St. Philip's, Mrs. J. E. Wilkins and others contributed to this helpful discussion. The Social Service forum was led by Mrs. Arthur Tufts, of St. Luke's; Mrs. Martin Amorous, Mrs. Parker, Mrs. Hinshelwood, and Mrs. Henry Hunt, and others gave experiences in making this work most effective.

At the request of the Rev. S. A. Wragg, Miss Tinsley appointed Mrs. C. C. Harrold, Mrs. A. H. Sterne, and Mrs. Martin Amorous a committee to confer with the Rev. G. I. Hiller and the Rev. S. A. Wragg on the question of changing the time of meeting and the separation of Council meetings and Auxiliary meetings, and the future entertainment of delegates.

The Secretary read the Memorial, and the Auxiliary stood as the names of our co-workers who had passed into Eternal Life was read. Harden, Mrs. Mary Ayres Pearson, Miss Callie Pearson, St. John's, College Park; Mrs. Joel K. Kershaw, Mrs. R. L. Singleton, Mrs. T. O. Plunkett, Holy Trinity, Decatur; Mrs. H. E. Barton, Mrs. T. P. Christian, Jr., Mrs. Emma Screeven Trinity, Columbus; Mrs. Martha W. Curtis, St. James, Cedartown; Mrs. Seaborn Jones, St. George, Griffin; Mrs. M. T. Morris, St. Paul's, Macon; Mrs. Thomas E. Artope.

Mrs. Banks Yonge extended the invitation for five o'clock tea at the home of Rev. and Mrs. S. A. Wragg and the meeting was then adjourned.

At 9:30 o'clock, Thursday, January 29th, the meeting was called to order by the President, and the opening prayers were said by the Rev. S. A. Wragg, rector of Trinity Church with about forty ladies present. Miss Tinsley appointed the following committee for nomination of officers and chairmen for the triennium beginning 1932: Mrs. Henry Davis, chairman; Mrs. Russell K. Smith, Miss Rosa Woodberry, Mrs. W. P. Nicolson, Mrs. H. N. Hurt. Delegates to Denver for the general convention, Miss Schilling, Mrs. H. N. Hurt, Mrs. A. H. Sterne, Mrs. J. E. Talmadge, Jr., Miss Tinsley; alternates, Mrs. Chas. Harrold, Mrs. John MacDougald, Mrs. Henry Davis, Mrs. Arthur Tufts.

The Rev. William Turner, Canon of the Cathedral, was introduced and spoke on the value of the Bishop's Educational Fund. Mrs. Graham read the report of the Bishop's Educational Fund in the absence of Mrs. Hurt, the chairman, and mentioned that Mrs. Hurt had not missed a meeting before in 18 years. The secretary was in-

structed to send Mrs. Hurt a letter expressing our regrets at her absence.

Mrs. G. J. Springman, diocesan director of Church Periodical Club, expressed her thanks for the help and co-operation of the Auxiliary in carrying forward this important work. Miss Emma Twiggs, representative of the National Headquarters of the Girls' Fiendly Society, spoke interestingly of this work. Miss Tinsley called for a report from the committee on place and time of meeting and Mrs. C. C. Harrold reported: "That hereafter the annual meeting of the Woman's Auxiliary continue to meet at the same time, and in the same place as the Diocesan Council, and that the Auxiliary be self-entertaining." This was acted upon, passed, and a copy sent to the committee of the clergy.

The Rev. C. E. Bently, chairman of Executive Committee of Appleton Church Home, expressed thanks for the assistance of the Auxiliary, and spoke of Miss Crawley's constructive work, and the letter of thanks of the Public Welfare Department of Georgia for the piece of constructive work done recently by Miss Crawley at Marietta. Miss Crawley's resignation to take effect in June was announced as a greater disaster than the recent bank failure. Miss Crawley then made an interesting talk about the Home, answering many questions which were asked.

Mrs. W. H. Haskell read the resolutions. President's Expense Fund, Be it resolved: That the motion for fifty dollars voted by the Woman's Auxiliary at the convention held at All Saints Church in January 1930 to be given to Miss Tinsley in the year 1930, and another fifty dollars to be given in 1931 out of the expense fund to help towards her traveling expenses, as the Woman's Auxiliary representative to the Triennial at Denver, Colo., the fall of 1931; Be it resolved that if she is prevented from going by some unforeseen reason, that another person appointed may be allowed the same amount for the same purpose. Mrs. A. H. Sterne, seconded by Mrs. C. C. Harrold, motion put and carried.

Negro Social Welfare Worker: "Realizing the desire some years ago of Miss Bertha Richards to place a Social Welfare Worker at the Fort Valley School, Be it resolved by the Woman's Auxiliary of the Diocese of Atlanta that we appropriate six hundred dollars (\$600) toward the salary of a Rural Social Welfare Worker at said school for the year beginning September, 1931. A Fort Valley girl is now in the Bishop Tuttle Memorial School at Raleigh. This girl is also a graduate nurse from St. Agnes Hospital Training School." Signed, Mrs. H. A. Hunt, Woman's Auxiliary, Fort Valley High & Industrial School.

This resolution brought forward a great deal of discussion. Mrs. Hunt spoke to her motion; both Mrs. Sterne and Mrs. Tufts favored our taking this forward step. Mrs. Tufts suggested that we might interest other church people and laymen in raising this sum. Mrs. Graham suggested that we ask the Bishop if the \$500 pledged for the Negro Diocesan Fund can be used for one year for this welfare worker. Mrs. Sterne moved that we appoint a committee to consult with the Bishop on this whole question. Seconded by Mrs. R. K. Smith. Miss Tinsley appointed the committee: Mrs. A. H. Sterne, Mrs. Arthur Tufts, Mrs. C. C. Harrold. This committee to report to the Executive Committee Meeting in the spring.

The report of the Courtesy Committee was called for, and made by Mrs. Arthur Tufts: The members of the Woman's Auxiliary in the Diocese of Atlanta wish to express to the members and friends of Trinity Parish and to the Rev. and Mrs. S. A. Wragg, their deep ap-

preciation for their gracious hospitality and many courteous attentions during the session of the Church Council and the annual meeting of the Woman's Auxiliary held at Columbus. We go back to our own parishes refreshed in mind and body; and inspired and stimulated to do better work for the Master. Your committee asks that this report be accepted and adopted by a rising vote of thanks.— Mrs. Arthur Tufts, Mrs. R. K. Smith, Mrs. Woolsey Couch, committee."

The meeting was then adjourned and dismissed by prayer by Mrs. Parker.

MINUTES OF THE MEETING OF THE DIOCESAN BOARD,
TRINITY CHURCH, COLUMBUS

The meeting of the Parish Presidents, officers and chairmen forming the Diocesan Board of the Woman's Auxiliary was called to order by Miss Tinsley, the President, at 9:30 A. M., January 28th, 1931, in Trinity Parish House, Columbus, Ga. The meeting was opened with prayer by Mrs. Wm. Parker, Jr. Mrs. A. F. Sterne then brought a recommendation from the Executive Committee asking that the Woman's Auxiliary of this diocese raise a fund of \$50.00 to be given to the Department of Religious Education of the Province of Sewanee of which Dr. Gardiner Tucker is Executive Secretary. Mrs. Sterne spoke of the need of this fund, and of the splendid work being carried on in the Province by Dr. Tucker and his co-workers. Mrs. Sterne asked that the branches send sums of one, three, or five dollars as they were able, to her towards this fund. Mrs. Arthur Tufts spoke commanding the recommendation. The resolution was then put, voted upon, and carried.

Mrs. Parker requested that a notice be sent to the parish presidents about the budget for 1931. Such notice to be published in the Annual Report and Record, making it perfectly clear to whom funds are to be sent, so that new incoming presidents will not be confused.

Mrs. MacDougald, the Treasurer, requested that all parish treasurers send in funds before December as the books must close promptly January 1st in order to be audited.

Miss Kidd, of All Saints Y. W. A., asked information concerning Box Supply apportionments. Mrs. MacDougald replied as did Mrs. Graham. Miss Schilling moved that the Secretary write a letter to Mrs. O'Neill, Box Supply Secretary, expressing regrets at her absence.

One branch asked information concerning by-laws for a parish branch, and it was suggested that branches follow the by-laws of the Diocese in compiling them for themselves. Mrs. Nicolson asked about the rule for election of parish officers. Miss Tinsley replied that it is left to the individual branches. The discussion brought out that most parish presidents were elected for one year, although many were re-elected for a second year, the Cathedral electing its president for a three-year term. Mrs. Arthur Tufts, St. Luke's, Atlanta, suggested that each president keep a note book to be passed on to the next president so as to help her to know what has been done and what to do.

As the half hour for the meeting was up, the meeting was adjourned. There were about twenty present.

PRESIDENT'S ADDRESS**Theme: "Christ, the Way of Peace"**

Again, dear auxiliary friends, it is my happy privilege and pleasure to greet you.

Traveling together through auxiliary life, each one of you has become very dear to me, in the bond of His service "where friend holds fellowship with friend."

I regret my inability to visit every branch and I feel I lose much from the inspiration of a close intimate contact, but for each branch I experience an especial personal interest and the glow of warm affection.

I perforce must leave your needs and wishes in the hands of your capable department chairmen, to whom you have only to indicate a desire and a ready response will flow out to you.

The annual meeting which brings us happily together in Columbus this year looms large in importance and opportunities and I pray it may be filled with splendid achievements.

The big objectives of 1931 let us seize with faith and high courage. How many times our hearts have faltered at the suggestion of a proposed responsibility or undertaking and we have felt as Moses did, "Who am I that I should go to Pharaoh?" May we never fail to make the rich choice of splendid auxiliary service in His name.

Throughout this meeting and the remaining days of the Triennium may our minds be turned toward peace. Grant us the spirit to think peace, to talk peace, to work for peace.

A thought was expressed by some one that we should emphasize being peace makers. Peace being an active quality, not a passive one, we must ever go on creating it. Being auxiliary to the National Council, our work is linked with it in all fields of activity following the departments mapped out by it. We endeavor to keep abreast of our apportionments and to keep closely in touch with its spiritual aspect.

It would be an inspiration if we could have Miss Lindley with us in person, as she undoubtedly is with our meeting in spirit and we shall hope for her presence before the close of our three-year cycle.

We are affiliated too in work and gifts with the Province of Se-
wanee, of whose prominence, especially in the realm of religious education we are so proud, more so now than ever since our bishop is its distinguished head.

Mrs. James Wheeler, of the Diocese of Tennessee, represents our province on the national board. Through her charming and informational letters, she keeps the workings of the council before us.

At the last meeting of your executive board, it was voted to publish her echoes of the events of the national council in the Diocesan Record, and I hope all of you will search them out. Later in the meeting our secretary will give you her good wishes for the success of this gathering.

We are asked through our province chairman, to emphasize again the fact that the Woman's Auxiliary in the Triennial Meeting in Washington voted to make the development of rural work a very definite objective for this Triennium.

Our rural problems are well handled, we feel sure, according to the findings of the committee by our capable dean of rural women, Miss Schilling. It was a source of great pride to us, that her plans of

activities attracted such attention that she was asked to be on the program at the Madison conference.

Our nearest approaching diocesan event is the annual corporate communion the first Friday in Lent. Let us be arranging our time and our hearts for a participation in this yearly high privilege of rededication.

Quoting from Miss Lindley's letter, we are remembering, of course, that 1931 will hold our Triennial Meeting in Denver. We shall want to prepare our minds and hearts and no less spiritually our gifts. Those of money are three—our share of the Quota—the Advance Work and the United Thank Offering. We are pledged to do all we can to see that our quota of parish and diocese is paid. Closely related to it is our desire to finish our share of the Advance Work. Then with these two gifts—Quota and Advance, comes our great privilege—the United Thank Offering.

The program of this, our annual meeting, centers around two impelling subjects—Social Service and the Young Woman's Auxiliary.

Never before has Social Service presented such an appeal and has never been before so rich in opportunities for service.

Never before has the value of the Young Woman's Auxiliary been more appreciated. Through our Auxiliary life, it flows, a rich and refreshing stream.

Our plans and program are now before you. We bespeak your loving interest and participation. May our counsels and deliberations be abundantly blessed. May our feet be guided into the way of peace—peace in our Church, peace in our hearts, peace in our lives, through Him, who is the Prince of Peace.

REPORT OF THE SECRETARY

The work of the Woman's Auxiliary, Diocese of Atlanta, for 1930 has been faithfully performed. All the chairmen have been active and diligent. Mrs. W. T. Downing, owing to her removal from the diocese, resigned the chairmanship of Christian Social Service in May. Mrs. William Erwin, chairman of Gift of Life, likewise resigned on account of serious illness. The resignation of both of these splendid workers was a distinct loss.

There have been three meetings of the Executive Committee, in January, May, and October, and one meeting of the Executive Board held at All Saints, Atlanta, January 23, 1930. The Auxiliary was represented at the Provincial Synod at Jackson, Miss., November 11, 1930, by Mrs. John E. Talmadge, Jr.

The following special services were held: Diocesan Corporate Communion held at All Saints Church, Atlanta; Diocesan Lenten Corporate Communion, first Friday in Lent held in St. Philip's Cathedral for Atlanta branches, and a similar service was held at Christ Church, for Macon branches, also at St. Peter's, Rome; Corporate Communion and presentation of the U. T. O. on Maundy Thursday.

The Interdenominational Day of Word Prayer was observed March 7th, 1930, at St. Philip's Cathedral with Bishop Mikell and Dean de Ovies taking part as well as representatives of all Protestant churches in Atlanta. There was also held an inter-parochial meeting of Atlanta branches at St. Luke's on February 28th, Bishop Peter Rowe,

of Alaska, being the speaker. A similar meeting was held at Christ Church, Macon, for Auxiliary branches.

Last year we had thirty-five branches but several of these have been consolidated, and one branch, Holy Comforter Mission, Atlanta, owing to changes in residence and other causes, has asked to be discontinued as a branch. This faithful branch, headed by Mrs. C. D. House for the past fourteen years, have contributed their U. T. O. this year but feel they can no longer be considered an Auxiliary branch.

Your Secretary has prepared and had printed one hundred copies of the Annual Report. Your Secretary has month by month prepared and collected material for the Woman's Auxiliary pages in the Diocesan Record, and furnished material and co-operated with the Federated Church Women of Georgia, whose page is published weekly in the Atlanta Constitution. Your Secretary has written 256 letters, 25 post cards, mailed 122 copies of the Annual Report, and 46 copies of the Record, a total of 549 pieces of mail.

From reports sent in to the Secretary, we gather the following facts: Number of branches, 30; Diocesan Corporate Communions, 2; Special Branch Corporate Communions, 13; Prayer Partners and Prayer Groups, 25; Study Classes, 25; Program meetings, 156; Pageants presented, 4; Woman's Auxiliary members teaching in church schools, 75; number of members reported, 700.

REPORT OF FIRST VICE-PRESIDENT, CHAIRMAN OF MISSIONS AND RURAL WORK

The survey of the Diocese in 1929, by counties, each of which was apportioned to some branch of the Auxiliary, was continued into 1930. At the meeting of the Executive Committee in May, it was decided to raise a fund to be used to send a student from the Rural field to Sewanee, the Rev. Geo. Harris, our North Georgia Missionary, to name the person to be benefited by this scholarship. Miss Ellinor Ravenel was selected and greatly appreciated this privilege. We are sorry to know that Miss Ravenel has since left our diocese.

Your chairman was invited by the Rev. H. W. Foreman, chairman of Rural Work of the National Council, to attend the National Conference on Rural Church Work held at the University of Wisconsin, at Madison, Wis., in July. There were about 300 pastors, laymen and women at this conference. We received a great amount of information and inspiration from the classes and conferences which were held for two weeks.

As Christian Social Service is stressed in Rural Work, through the efforts of the Auxiliary of St. James, Marietta, Miss Charlotte Crawley was brought to Marietta, and made a survey of the social needs of Cobb County. She remained for two weeks, and did a very valuable piece of work. A letter has been received from the Public

Welfare Department of the State of Georgia thanking us for this constructive piece of work.

Articles on Rural Work have been published in Cobb County papers and these have led to contacts with church people of other denominations, which have been helpful.

The Auxiliaries of Marietta report magazines sent to County Alms House, and others distributed through Cobb County by the County Health Nurse. All Saints Auxiliary of Atlanta reports a Pilgrimage made in automobiles to Clarkesville and Toccoa on May 25th. The rector, Dr. W. W. Memminger, the choir, members of the vestry, and Woman's Auxiliary, made this trip. A service was held at each place, and so many attended these services that they could not be accommodated. The Rev. Geo. H. Harris had charge of these missions and greatly appreciated this effort. This pilgrimage was a wonderful contribution of a city church to the rural missions and we hope it is the beginning of similar efforts. All Saints' also sent Easter Cards to all children at the State Tubercular Hospital at Alto, Georgia. St. Philips Auxiliary reports magazines and church literature distributed in Walton County. Chapter K. Athens, reports magazines distributed through the Curb Market, and a complete outfit for a mountain girl at Tallulah Falls School. St. James, Cedartown, reports clothes, food and toys given valued at \$116.00, magazines and prayer books distributed and personal visits establishing many contacts in the rural field. Holy Trinity, Decatur, reports prayer books distributed at the county jail. St. Peter's, Rome, reports clothes sent to child at hospital at Alto, and gifts distributed in the county at Christmas. St. Lukes, Atlanta, reports help given in Illiteracy Campaign in DeKalb County. Fort Valley High and Industrial reports work done in three counties for rural negroes in public health, farm and home demonstration and Bible study together with distribution of clothing, magazines and church literature.

The ultimate aim of our work is to see that the claims of Christ are presented to every family in every county in all departments of life, religious, educational, physical, and recreational, with particular stress upon religious instruction in homes, in church schools, and when possible, in secular schools. We should attempt to work out a program to give the whole ministry of the Church to the rural communities of the Diocese.

REPORT OF THE DEPARTMENT OF RELIGIOUS AND MISSIONARY EDUCATION

The reports show that splendid work has been done by some of our branches and we feel that we have progressed a long way from the time when the Lenten study class was our only educational work.

Besides the regular classes on the New Africa, Our Common Life, a book that deals with practical Christianity, was studied with much enthusiasm by a number of branches.

The Bible lectures given by our Bishop during Lent were largely attended and deeply appreciated, especially by this department. More and more interest is being taken in the book tables and Church literature is more widely distributed.

There was a good increase in the number attending summer conferences; too much stress cannot be laid on this fact for it is only as we come in contact with the leaders and their work that we gain inspiration to go forward.

From the reports we gather the following facts: Branches reported having mission study classes, fourteen; discussion groups, 7; pageants, 4; book tables, 8; program meetings, 13; Bible study, 8; having chairmen of the Spirit of Missions, 14; attended summer conferences, 8; Sewanee, 7; University of Wisconsin, 1; had corporate communions, 13; distributed literature, 10; did library work for students, 1; auxiliary members having taught in church schools, 75.

May our aim for 1931 be that every branch have a definite plan of study for the whole year through, thereby enriching the lives of all members.

REPORT OF CHRISTIAN SOCIAL SERVICE

On account of the resignation in May of Mrs. W. T. Downing, chairman for 1930 of Christian Social Service, and our failure to find a chairman to fill Mrs. Downing's office, there has been no chairman of this important department of our work; hence the reports which have been sent in to me have been most gratifying. They show that the branches that have caught the vision of the possibilities for service have availed themselves of many opportunities for very splendid work.

The financial figures for Social Service disbursement is \$5,735.54. As large as this sum is, I know that many branches did not properly value their service or it would have been larger, for much valuable service has been rendered and no account kept of it. The reports show that the branches have been working side by side with the following institutions: Family Welfare, all hospitals in big and small places, all children's homes, community houses, city stockades, jails, juvenile courts, alms houses, state and county sanatoriums for tubercular, for the insane, county organizations, then the American Legion, Salvation Army, Travelers' Aid, and all Community Chest projects.

Much coal, food, clothing, medical attention, many magazines and flowers carried to sick and shut-ins, as well as employment found for those out of work. Much valuable aid is being given in the church and in the community reached by our church, whether strong parishes, weak missions, with the sick and needy. We seem to be carrying out the request of the National Council to bring into closer sympathy and co-operation the church and civic social service organizations. We are working together with them, using their agencies of investigation and methods of planned service, and yet with the love of Christ being shown forth.

**CONSTITUTION AND BY-LAWS OF THE WOMAN'S AUXILIARY
OF THE DIOCESE OF ATLANTA**

ARTICLE I—NAME

The name of this association shall be the Atlanta Diocesan Branch of the Woman's Auxiliary to the National Council.

ARTICLE II—OBJECT

The object of this association shall be to promote within and without the Diocese the great aims of Christian service in Missions and Church Extension, in Religious Education, and Social Service.

ARTICLE III—MEMBERSHIP

1. The Bishop and clergy of the Diocese shall be ex-officio members.

2. Any baptized woman whose declared intention is to actively engage in any branch of the work of this organization shall be eligible to membership.

3. Others on vote of the organization may be admitted as associates and known as Auxiliary Co-Workers.

ARTICLE IV—ORGANIZATION

1. This association shall be organized with departments along the lines of the National Council.

2. The officers shall be a President, three Vice-Presidents who shall be Department Chairmen, a Corresponding and Recording Secretary, a Treasurer, a United Thank Offering Custodian.

3. There shall be a Diocesan Board of Directors composed of the officers, the Department Chairman and Parish Presidents, and past Diocesan Presidents. This Board shall have power to organize departments along the lines of the work of the church at large. Each department shall make an annual report.

4. There shall be an Executive Committee of the Board of Directors consisting of the Officers and Department Chairmen.

ARTICLE V—ELECTIONS

1. All officers shall be elected at the Annual Convention for three years, and shall not be eligible for re-election to the same office.

2. Nominations shall be made by a nominating committee, appointed by the President, and the election shall be made by ballot.

3. The Secretary of the Convention shall notify in writing all officers and chairmen of their election immediately after adjournment.

ARTICLE VI—REPRESENTATION

Each parish and mission shall be entitled to two delegates and its president.

No person may have more than one vote and no proxies are allowed.

ARTICLE VII—MEETINGS

1. The Diocesan Branch of the Woman's Auxiliary shall meet annually on the day preceding the meeting of the Diocesan Council.

The Executive Committee shall meet at least three times a year, preferably in January, October, and preceding the annual Convention.

The Auxiliary Board of Directors should meet preceding the annual convention.

A quorum of the Executive Committee shall be five. A quorum of the Board of Directors shall be 10.

ARTICLE VIII—FINANCES

1. The fiscal year shall be from January 1st to January 1st.
2. The Diocesan assessment for Expense Fund shall be forty cents per capita annually on each member, this assessment to be collected and provided for by the auxiliary branch rather than from the individual members.
3. The Executive Committee shall order the disbursement of funds, subject to the action of the Annual Convention.
4. The several departments may hold and disburse funds acquired for their specific work. They shall make an itemized statement of receipts and expenditures at the Annual Convention.

ARTICLE IX

This Constitution may be amended at any Annual Convention by a majority vote, provided due notice has been sent every branch of the proposed amendment, and a copy of the same.
