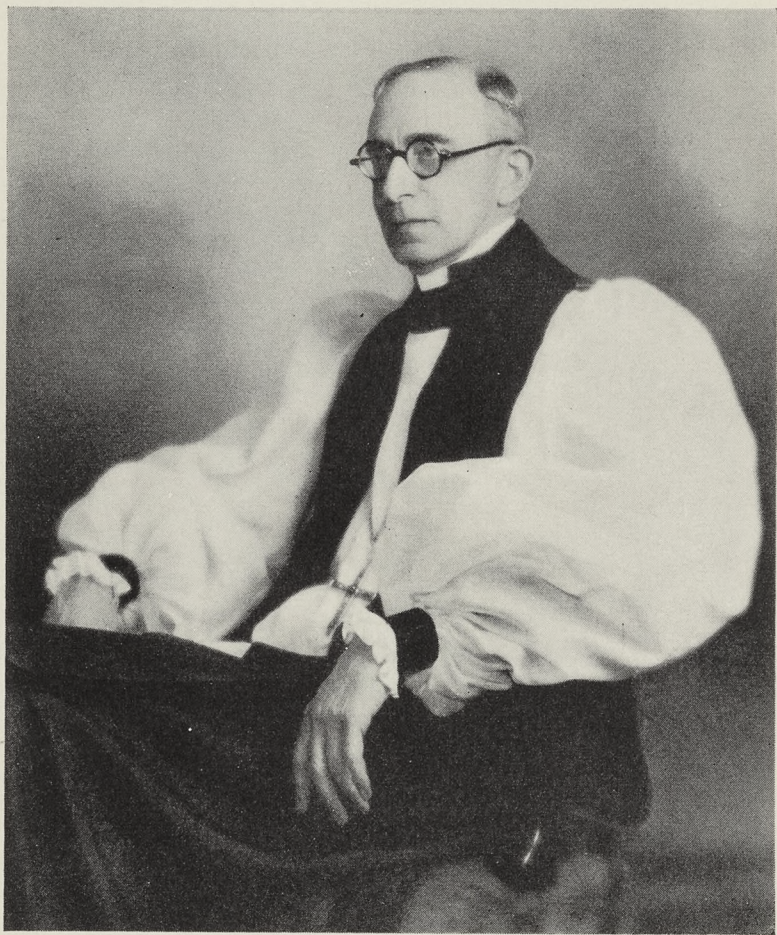

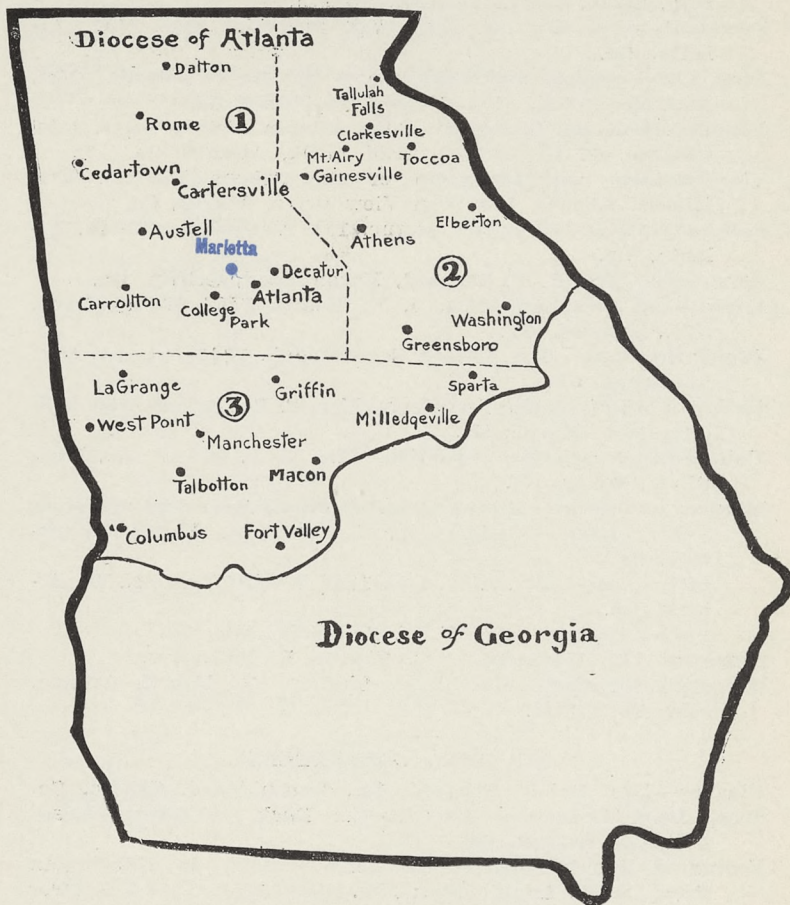

THEME: "FELLOWSHIP IN FAITH AND WORK"**MINUTES OF THE THIRTY-FIRST ANNUAL MEETING**

The thirty-first annual meeting of the Woman's Auxiliary of the Diocese of Atlanta was called to order by the President, Miss Mary King, at 10 o'clock, Wednesday morning, January 26th, 1938, in St. Luke's Church, Atlanta.

The meeting opened with a song after which the devotional was led by Bishop Woodcock of Kentucky. He spoke on sacrifice as a privilege and emphasized the wonderful part the Woman's Auxiliary has in sharing in God's work.

Mrs. Wm. Warren Owens, president of the Woman's Auxiliary of St. Luke's, Atlanta, gave a very cordial welcome to the delegates and visitors. The response was given by Mrs. LeConte Smith, St. James, Macon.

The following committee appointments were made:

Timekeepers: Miss Caroline Nicolson, Bishop's Branch, Atlanta, and Mrs. F. A. Sheils, Holy Comforter, Atlanta.

Resolutions: Mrs. R. E. Bruce, Jr., All Saints, Atlanta, chairman; Mrs. Roy Newnan, Grace Church, Gainesville; Mrs. Alan MacDonell, Macon.

Courtesy: Mrs. H. Gordon Smith, St. Mark's, LaGrange, chairman; Mrs. John Soper and Miss Rosalyn Lumpkin, Ascension, Cartersville.

The president announced that the Chairmen of Religious Education and the Forward Movement had interesting displays of books and other literature, and that the N. & I. School of Fort Valley had an exhibit of their handiwork.

The president gave a splendid address and said that 1937 had been a happy and successful year for the work of the Woman's Auxiliary. (See full report).

Chapel, Fort Valley, 2; St. Andrew's, Fort Valley, 1; Grace, Gainesville, 7; St. George's, Griffin, 2; Good Shepherd, LaGrange, 1; St. Elizabeth's, LaGrange, 1; St. Mark's, LaGrange, 4; Christ Church, Macon, 10; St. James, Macon, 8; St. Paul's, Macon, 5; St. James, Marietta, 10; St. Stephen's, Milledgeville, 3; Calvary, Mt. Airy, 2; St. Peter's, Rome, 7; St. Matthias, Toccoa, 1. Total, 228.

At this point copies of the yearly reports of the Branches were given to each president.

Mrs. Harold Castleberry, Grace, Gainesville, introduced Mrs. Wm. J. Gordon, of Spray, N. C., Diocesan President of the Auxiliary of North Carolina, who spoke on "Fellowship in Faith and Work." Mrs. Gordon gave a most inspiring talk and said that a truly Christian church united would be the mightiest power on earth. She said that the world looks on with criticism at the ineffectual failure of the church to meet the needs of the day, and pointed out that it is only through fellowship with Christ that we attain the Power of the Holy Spirit.

Mrs. Marshall Ellis, St. James, Macon, read the names of those Auxiliary members who have passed into Eternal Life and asked that we think of them as only on the other side of the veil in the Sunshine of God's presence.

Following this memorial the meeting adjourned at 12 o'clock to meet with the Diocesan Council at which time Bishop Mikell delivered his annual address.

The meeting reconvened at 2 o'clock following luncheon at St. Luke's tea room.

The Rev. Woolsey E. Couch, of St. John's, College Park, announced that on February 3rd, the Bishops of the Fourth Province and the Rt. Rev. Henry St. George Tucker, presiding Bishop of the Episcopal Church, would meet in Atlanta. A luncheon was to be given at which time Bishop Tucker would speak. The Auxiliary women were invited to attend.

The president appointed the following timekeepers for the afternoon session: Mrs. Wayne Patterson, Trinity, Columbus, and Mrs. Bryant Willingham, Our Savior, Atlanta.

Mrs. R. P. Shapard, treasurer, gave the annual report which showed that all pledges were paid in full. This was a splendid report.

The Romance of the 1938 Budget was given by Mrs. H. Gordon Smith, St. Mark's, LaGrange. This was presented in a most interesting manner. Using the words of our Lord, "It is more blessed to give than to receive," Mrs. Smith explained in detail where each item on the Budget was to go.

Mrs. Wm. Warren Owens, St. Luke's, Atlanta, moved the adoption of this budget. Mrs. Marshall Ellis, St. James, Macon, seconded the motion which was unanimously adopted.

Mrs. J. T. Springman, Trinity, Columbus, one of the Church Periodical Club secretaries, of the Diocese of Atlanta, read a letter from a missionary in Tokyo on "Missionary Interprise in Japan." She wrote an interesting letter and thanked the Auxiliary women for providing books and magazines for these people on foreign soil, particularly the isolated ones.

A letter was read from Mrs. Stephen Ives, president of the Atlanta League of Women Voters, stressing the importance of women voting and urging the women of the Auxiliary to co-operate with this organization.

The president announced that this year's contest sent out by the Field Department is entitled "What is the Church?" and entitles the winner to a scholarship to Sewanee or Kanuga.

The Branch presidents were introduced to the Auxiliary women at this time.

Mrs. W. H. Irvine, Incarnation, Atlanta, chairman of the Program Committee, introduced Dr. W. A. Smart, Professor of Biblical Theology, Emory University, who spoke on "Fellowship in Faith." Dr. Smart gave a splendid and helpful talk and one that can be applied to today's needs. He said that while the home used to provide for almost all functions that today these functions are taken outside the home and given to other agencies, and that there is a growing awareness that we must do something about this inadequacy. He stresses the importance of the home influence upon the lives of today's and tomorrow's citizens.

The meeting then adjourned to be followed by discussion group meetings conducted by officers and secretaries of the various departments.

The meeting was called to order at 10 o'clock Thursday morning by the president. The Rev. John Moore Walker, St. Luke's, Atlanta, gave the devotional. He spoke on the responsibility of church people toward race relationships, particularly in the South.

The president appointed the following timekeepers: Mrs. John M. Flanigen, St. Timothy's, Atlanta, and Mrs. Gray Carter, Trinity, Columbus.

The president introduced Dr. John W. Wood, secretary of Foreign Missions of the Episcopal church, who spoke on "Fellowship in Work." Dr. Wood said that the welfare of the women and children of the world depends upon application of the Christian Gospel to all phases of life. He told of the work of certain missionaries and said that they are meeting the vital human needs of men and women. Dr. Wood said that all over the world people are seeking after God and that the church is a great mother to so many homeless and helpless people.

The Registration Committee gave the following report: delegates, 131, visitors, 154, making a total of 285 present.

Mrs. R. E. Bruce, Jr., All Saints, Atlanta, chairman of the Resolutions Committee, submitted the following resolutions from the Executive Committee of the Woman's Auxiliary:

1. That the Woman's Auxiliary of the Diocese of Atlanta send the sum of \$100 to the China Relief Fund.

2. That the Provincial Gift be raised through a Corporate Communion to be held the second Friday in Lent; \$25 of which goes toward Provincial projects and the balance toward work for the deaf in the Fourth Province.

3. That a letter be written to Mr. H. M. Heckman and the Rev. David C. Wright, Jr., in appreciation of the splendid work they have done in connection with the Diocesan Record.

Mrs. Bruce moved the acceptance of the first resolution which was seconded by Mrs. Mildred Rhodes, Emmanuel, Athens. Mrs. Bruce moved the acceptance of the second resolution which was seconded by Mrs. C. C. Harrold, Christ Church, Macon. Mrs. Bruce moved the acceptance of the third resolution which was seconded by Mrs. Thos. Morgon, All Saints, Atlanta.

Mrs. J. W. Lea, chairman of the Gift of Life Plan, presented Miss Virginia Hoge, student worker at the University of Georgia. She gave her impressions of the University and students and told of her work with them.

Mrs. H. Gordon Smith, St. Mark's, LaGrange, chairman of the Courtesy Committee, submitted the following: "Something we feel in our hearts is often a difficult thing to express in words. The appreciation which the Woman's Auxiliary of the Diocese of Atlanta, wishes to express to the hostess Auxiliary of St. Luke's Church, the Parish and Rector, the Rev. Mr. Walker, is one of those things. But I am sure I speak for all who have been guests here, that the courtesy shown us by St. Luke's Auxiliary and by those who have so generously opened their homes to us, has been most delightful, and we thank each one for her part in the fine hospitality which we have enjoyed. Spencer says, "Thankfulness is the tune of angels" and we feel that is a fitting expression of our thankfulness and gratitude to those who have made this such a pleasant meeting together.

Many, including our Bishop and officers, have worked hard and thoughtfully to make our programs helpful and inspiring, and we feel it is a challenge to each auxiliary branch, and to each member of that branch, to do her part in carrying on the work of the Woman's Auxiliary cheerfully and efficiently. When we report next year on our accomplishments, let us look back to this meeting and to its speakers who have been our inspiration, and be grateful to all who have made it so pleasant and instructive.

Again, we thank St. Luke's Auxiliary, and Mr. Walker, St. Philip's, our Bishop and Officers, and our individual hostesses."

The president introduced Mrs. Fred D. Ramsey, of Knoxville, Provincial President of the Woman's Auxiliary, who gave a splendid talk on "Fellowship in Work." She said that if we

carry out the meaning of fellowship in work and pray with humility we cannot fail to go forward with Christ.

Mrs. Mildred Rhodes, Emmanuel, Athens, made a motion that the minutes be printed in the year book. Mrs. A. H. Sterne, All Saints, Atlanta, seconded the motion.

Mrs. Ramsey announced that a three-day institute would be held in August at Sewanee with interesting courses provided.

Following the benediction by Bishop Mikell, Mrs. Rhodes made a motion to adjourn. Mrs. John MacDougall, All Saints, Atlanta, seconded the motion.

PRESIDENT'S ADDRESS 1938

To you my Auxiliary friends, I bid you welcome to this, our 31st Annual Meeting. Before proceeding further I want to express my appreciation of the President and Finance Committee of the former regime. Through their efforts and careful study our budget was revised and established on such a basis, that the incoming officers merely had to follow their example and advice and come out "on top."

We have completed a very happy and successful year. For the second time we have met our budget in full and have shown definite steps forward. It seems astounding to record the fact that you have raised a total of \$14,730.23. Our budget of \$3,850.00 plus special gifts of \$237.00, supply boxes of \$611.00 clothing for Appleton Home girls and Social work \$4,337.86, work in parishes \$7,360.71, United Thank Offering \$2,050.00, work among the deaf and blind \$133.60, bring the grand total to \$14,730.23.

While these figures represent splendid work there is one item I particularly want to speak of—SUPPLY BOXES. Five years ago we were giving \$1300 plus and have consistently dropped year by year until we reached the low of \$530. Although we have given an increase this year, it is not a representative amount for us to send from our Diocese. I do hope we may interest ourselves in this department of our program more intensively in 1938. The Supply Secretary is most eager to co-operate with all needed information.

Some very bright spots for us to think of are: the forming of a new branch at St. Matthias, Toccoa, which we welcome to our family. Then too, our largest parish has become a single unit under the Auxiliary. This leaves only one of the larger parishes with the women's organizations divided. We hope before another year they, too, will see that the whole parish will be strengthened by this unifying of women's interests.

I am delighted to report the growing number of groups of business women meeting in the evening, and also groups of younger women. While speaking to these two groups I want you to know that each has contributed to the efficiency of our meeting today. The program for this Annual Meeting has been planned by a group of six young women from six parishes in Atlanta. Their grasp of the situation has been most inspiring and I am sure we will benefit and enjoy this splendid program. Then, one of the business groups—the Bishop's Branch—has made our booklet of reports which we want you to be sure to take with you, as it contains a record of all work done by our women. I wish to thank these two groups of young women in your name, and assure them of our great appreciation of their efforts in our behalf.

Another "bright spot" is the great co-operation you have given the department chairmen in the matter of reports. Never before have they come in so promptly and we have been able on account of this to have our Diocesan report in New York on schedule time.

Through these reports we have learned many valuable facts. The Educational Department has been most noticeable. The growth in study classes and interest in them, as well as the desire to conform with the suggested outline of programs.

Our newest department, that of the Forward Movement, has done a splendid piece of work, and we hope through this chairman to place the literature in every parish and mission this next year.

The Christian Social Service Department has developed a program that is to be used as a Provincial Program. Also through this department institutes are to be held in strategic points.

May I urge that each person here, whether a delegate or not, attend one of the group conferences to be held at the close of our meeting today. If possible I hope each branch will arrange to have a representative in each group.

This past autumn we held our Triennial Meeting in Cincinnati. It is impossible to express all of the inspiration and information we received. I want to thank our delegation at this time for their loyal and able support. Not once was there a vacancy in our allotted seats. Then, too, we had many women to attend as visitors and I am sure the whole Diocese will reap a great benefit for the inspiration received by all those who were in attendance. The whole General Convention was permeated with the spirit of Unity and Christian Social Service in their many ramifications. Before the year is completed I beg that each branch will ask someone who attended to come to give first hand information on what will truly go down in history as a great council. Perhaps the most arresting single thought I brought back with me was one given by Dr. Wei at the Forward Movement mass meeting: "We may feel our efforts are only a drop in the bucket, but that drop will color the water in the whole bucket, for it is God's drop."

Friends, these are troubled times. These are times when our faith is sadly tried. At the great Youth Convention held here recently by one of our sister denominations, all speakers seemed to dwell on one essential point: the need of building a better youth—not a better world as has been the urge of former years. Build a better youth—a better individual. After all it sifts down to the individual and the individual's ability to deal with today's problems and conditions. May we not take this as our challenge for 1938? Not only for our YOUTH but for OURSELVES.

A more strict adherence to our daily quiet time—a more regular attendance at public worship—a more co-operative spirit in the work of the CHURCH, not just our own parish, and Diocese, but the GREAT FELLOWSHIP. May each one of us adopt for our slogan the cry of the Chinese Church: "LORD REVIVE THY CHURCH BEGINNING WITH ME."

A DEDICATION FOR WOMEN

I love Jesus Christ and want to be His disciple. Therefore I must set forward His Kingdom on earth.

To do this I must prepare myself by study, worship and prayer. Having prepared myself, I must work individually and in my group in the Five Fields of service—the parish, the community, the diocese, the nation and the world.

I cannot do all of the work of the world, so I must give as generously as possible that others may do it.

Finally, I believe that it matters tremendously whether or not I, one woman, do this, and it will affect the progress of the Kingdom.

- Rosa Woodberry Fund**—A fund devoted to developing leadership in both white and negro workers through scholarships to Summer Conferences, and helping support a student worker at the University of Georgia.
- Advance Work in the World**—A gift sent each year to meet some urgent need in the work our Church is doing throughout the world.
- Advance Work in the Diocese**—An allotment recently inaugurated to strengthen weak points in our Diocesan work.
- Dues—Woman's Auxiliary—National**—Used for running expenses at National Headquarters.
- Dues—Province**—Used for expenses of the Provincial set-up of the Woman's Auxiliary.
- Dues—Federate Church Clubs of Georgia.**
- Triennial Delegates**—A fund put aside each year to accumulate so that the five delegates from the Diocese may be assisted with expenses to the General Convention.
- Forward Movement**—A small amount used by the Forward Movement Chairman in expanding the use of Forward Movement literature in our Diocese.
- Christian Social Service**—To be used for material to build a better understanding of the place Christian Social Service has in our Parish life.
- Religious Education**—Used by the Chairman of Religious Education to advance the use of program material.
- President's Expense**—A discretionary fund used by the President in the discharge of her duties.

GIFT OF LIFE

"I am come that they might have life, and that they might have it more abundantly." These words of the Great Missionary are the theme of our Gift of Life work. We want to pass on, not only to those of other lands, but to our own neighbors, the joy of that abundant life which comes to us only when we take an active part in God's work. We can more effectively accomplish this with two things—Knowledge and Training. And so each year the Woman's Auxiliary of the Diocese of Atlanta offers to its Branches three Scholarships to Summer Conferences. One to the adult conference at Sewanee, one to the adult conference at Kanuga, and one to the Negro conference at St. Augustine's.

In the spring each branch President or Gift of Life Chairman receives a letter from your Diocesan Gift of Life Chairman asking for the name and qualifications of a member of her Parish whose attendance at a summer conference would be a benefit to that Parish.

In 1935 we were able to award only one scholarship. Miss Martha Gramling of St. James, Marietta was sent to Kanuga. We were, and are, so delighted with the results of her training that the following year Mrs. Ellis included in the budget enough to put into operation our present plan of awarding three scholarships annually. Accordingly in 1936 we sent Miss Muriel Turner of St. Peter's, to Sewanee and Miss Hazel Hayes, of St. Paul's, Macon, to Kanuga, and Miss Edith Coles to St. Augustine's. In 1937 the scholarship to Kanuga was awarded to Mrs. Crawford Barnett of St. Philip's Cathedral and the scholarship to Sewanee to Miss Adele Connor of St. James, Macon. The Negro delegate was unable to attend.

We firmly believe that the training received by these delegates will be of great benefit not only to their own Parishes but also to the whole Diocese, and we earnestly request the cooperation of each Branch President in our efforts to find the young women most suited for this training.

CONSTITUTION AND BY-LAWS

(Revised at the annual meeting of the Woman's Auxiliary, held at Trinity Church, Columbus, January 27th, 28th, 1937)

CONSTITUTION

Article I—Name

The name of this organization shall be the Atlanta Diocesan Branch of the Woman's Auxiliary to the National Council of the Protestant Episcopal Church, and to the Bishop and Council of the Diocese.

Article II—Object

The object of this organization shall be to carry forward the missionary, educational, and social service work of the Church in the home, parish, community, diocese, nation and world, through prayer, study, work and gifts.

Article III—Membership

Section 1—Any woman or girl who is willing to help further the object of this organization shall be eligible for membership.

Section 2—The members of a parish or mission, together with such other girls and women as are willing to co-operate, shall constitute a parish or mission branch of this organization.

Section 3—Any group of women (outside of parish or mission), approved by the Bishop, may co-operate in the work of this organization.

Section 4—Each branch or group so co-operating shall make an annual report to the organization.

Article IV—Organization

Section 1—The members of this organization shall be grouped together in Districts.

Section 2—The officers of this organization shall be:

President

Three Vice-presidents (one for each District and resident thereof)

Recording and Corresponding Secretary (combined in one person)

Treasurer

Educational Secretary

Supply Secretary

Custodian of United Thank Offering

Secretary Christian Social Service

Secretary of Missions and Church Extension and Forward Movement.

Section 3—Such assisting officers as may be necessary shall be appointed by the Executive Board.

Article V—Elections

Section 1—All officers shall be elected for a term of three years. No officer shall be eligible to the same office for two consecutive terms.

Section 2—Delegates to the Provincial Auxiliary meeting, five in number (and their alternates), shall be appointed by the President.

Section 3—Delegates to the Triennial meeting, five in number (and their alternates), shall be appointed by the President at the Annual Meeting immediately preceding the Triennial.

Section 4—Names of all officers shall be presented for election by a nominating committee. Additional nominations may be made from the floor.

Section 5—All elections shall be by ballot, a majority constituting an election.

Section 6—Any vacancy occurring during the year in any office shall be filled by the Executive Board.

Article VI—Annual Meeting and Representation

Section 1—The Annual Meeting of this organization shall be held at the time and place of the Diocesan Council.

Section 2—One-fifth of the branches of this organization, and not less than thirty-five members, shall constitute a quorum.

Section 3—Each parish or mission having twenty-five members or less shall have the right to representation by its President, or her alternate) and two delegates. The President and the delegates shall each have a vote. Every additional twenty-five members shall entitle the branch to one additional delegate, with power to vote.

Section 4—Each Diocesan officer shall be entitled to one vote.

Article VII—Amendments

This Constitution may be amended at any Annual Meeting by a majority vote, provided due notice has been sent to every branch of the proposed amendment, and a copy of the same.

BY-LAWS

Article I—Executive Board

The Executive Board shall consist of the Bishop and the officers. It shall be entrusted with the general supervision of the work of the Auxiliary, and shall exercise such powers as are necessary to forward its work. It shall bring before the Auxiliary plans of the program and work of the Bishop and Council of the Diocese and of the National Council. It shall meet during the interim three times a year, one meeting preceding the Annual Meeting. Five members shall constitute a quorum.

Article II—Duties of Officers

The President shall preside at all meetings, appoint all chairmen of committees (unless otherwise stated in By-laws), and shall have general supervision of the work throughout the Diocese. She shall be ex-officio a member of all committees.

The Vice-presidents shall have general supervision of the work in their respective Districts. In the absence of the President they shall, in order of their rank, perform all duties of that office, it being understood that the Vice-president of the District in which the next annual meeting is to be held shall rank as first Vice-president. They shall stimulate the activities of all parish and mission branches; form new branches; preside at all District meetings; attend to the publicity in their respective Districts, and make reports to the Annual Meeting. They shall notify the Secretary of any changes that occur in the branches in their Districts.

The Secretary shall keep a correct record of the proceedings of all meetings of the organization and of the Executive Board; issue notices of all meetings; conduct the correspondence; submit a written report to the Annual Meeting; and prepare and edit, with the President, the Annual Report (or Year Book).

The Treasurer shall receive all monies except the United Thank Offering and shall deposit the same in the name of the Woman's Auxiliary in such bank or banks as she may determine, with the approval of the Executive Board; keep an accurate account of all receipts and disbursements; serve on the Finance Committee; make a report to the Executive Board; and submit a written report to the Annual Meeting. At the end of the fiscal year her accounts shall be verified by an auditor.

The Educational Secretary shall prepare with her committee all educational programs and shall distribute same to the educational secretaries in the parishes and missions in the Diocese. She shall co-operate with the Educational Secretary of the National Auxiliary in all plans for education, and each year, follow, as far as possible, the study courses presented. She shall submit a written report to the Annual Meeting.

The Supply Secretary shall have charge of all Box Work and gifts for the Supply Closet, receive allotments from the Woman's Auxiliary Supply Secretary (Church Missions House, New York City), and shall re-allot the same. She shall make a report to the Annual Meeting and shall send a report to National Headquarters.

The Custodian of United Thank Offering shall endeavor to increase knowledge and deepen interest in this offering, so that every woman in the Diocese may take a part therein; she shall furnish "Blue Boxes" to the branches and groups in the various

parishes, missions and rural communities; provide literature pertaining to the offering and in other ways bring to the attention of Church women the purpose of the offering. She shall keep a list of all gifts and take semi-annual offerings, these offerings to be deposited in such bank or banks as she may determine, with the consent of the Executive Board. In June and December of each year she shall forward this offering to the Treasurer of the National Council, and every third year shall take the offering to the Triennial Meeting. She shall submit a written report at the Annual Meeting.

The Secretary of Christian Social Service shall plan a suggested program for the Diocesan Auxiliary and for the parish branches; to co-operate with the social service department of the Bishop and Council; of the Provincial Council; and of the National Council; and with other Church organizations. To arouse interest in Diocesan institutions such as Appleton Church Home, schools, social centers, community houses, nurseries, hospitals, penal institutions, etc.; to co-operate with the committee on Rural Work of the National Council, with the American Church Institute for Negroes, and with the Interracial Committee; to co-operate with community social service agencies and with undertakings of an inter-denominational character. She shall submit a report to the Annual Meeting.

The Secretary for Missions and Church Extension and Forward Movement shall have under her supervision— (a) the furthering of the work of the Forward Movement in the various branches; to deepen the spiritual life of the women through prayer groups, days of intercessory prayer, quiet days, corporate communion, etc. (b) She shall, as secretary for Gift of Life, interest young people who are beginning to think of their life work; to get in touch with young people who may be available for some type of Church Work and award scholarships to the summer conferences under the Rosa Woodberry Memorial Fund. (c) As Secretary of the Prayer Partnership Plan, she shall secure the names of Prayer Partners from the Executive Secretary of the Woman's Auxiliary (Church Missions House, New York City), and to assign these names to the various branches and explain the plan.

Article III—Standing Committees

Section 1—The Standing Committee shall be appointed by the Executive Board to serve for the Triennium and shall be:

Finance: It shall be the duty of this committee to prepare a proposed budget for the year, in consultation with the Executive Board; to submit this budget to the branches at least two months before the Annual Meeting. It shall make a report to the Executive Board.

Section 2—Such other committees as are necessary shall be appointed by the President.

Article IV—Fiscal Year

The fiscal year shall be from January 1st to December 31st.

Article V—Amendments

These By-laws may be amended at any Annual Meeting by a two-thirds vote of the members present, provided that the proposed amendment or amendments have been submitted, in writing, during the first hour of the first morning session of the Annual Meeting.
