MINUTES

OF THE

ANNUAL MEETING OF 1917

The thirty-fifth annual meeting of the Bethlehem Branch of the Woman's Auxiliary to the Board of Missions was held in Christ Church, Towanda, Pa., May 2nd, 1917, the president, Mrs. Coxe in the chair.

After the opening prayer, Bishop Talbot, in his greeting, spoke about the approaching thirtieth anniversary of his consecration; requested the help of the Auxiliary in the work of the Bishop's Extension Fund; and asked for new subscribers to the

"Bethlehem Churchman." Mrs. Coxe said that all Auxiliary women should subscribe for the "Bethlehem Churchman" for the Auxiliary news contained therein; and announced that Mrs. Hildebrand, of Wilkes-Barre, would take subscriptions for that paper, and also for the "Spirit of Missions."

Roll was called by the secretary and responses made by forty-seven delegates, representing twenty-one parishes, as follows:

This number was increased later in the day, and does not include a large delegation from Christ Church, Towanda.

The President then read her address.

The Treasurer's report, showing a large deficit in the Current Expense Fund, was read and discussed. The assessment of each parish branch to pay the current expenses of the Society was suggested and strongly urged. Mrs. Wood's motion that a committee of three be appointed by the president to make plans to meet the

deficit, and to suggest methods for raising the Current Expense Fund was seconded and carried.

The United Offering Treasurer made her report.

The Organizing Secretaries of Reading and Scranton read their reports, including those of Section B, the Junior Branch, Little Helpers, Educational Secretary, and Secretary of the Church Periodical Club.

Bishop Talbot announced that a Summer School would be held in Bethlehem in June, and urged the members of the Auxiliary to attend.

Hear us, O gracious Father, in these our humble supplications for the sake of Thy Son, our Saviour Jesus Christ.

The minutes of the meeting were read and approved.

PRESIDENT'S ADDRESS

This year marks the thirty-fifth anniversary of the Bethlehem Branch of the Woman's Auxiliary to the Board of Missions. During that time we have had five presidents, Mrs. M. A. de Wolfe Howe, Mrs. E. G. Scott, Mrs. Rogers Israel, Mrs. Gilbert Sterling, and myself. This year also brings to a close the fifteenth year I have served the Woman's Auxiliary in some official capacity. I am not going to review the successes and failures of the five years I have been your president. We know that which counts is the part of ourselves we put into anything. We must give of ourselves, our menas and our time, and if our diocesan auxiliary has grown stronger in methods, in educational work and in numbers, it is because the women of this Auxiliary have given time and thought and prayer to all its departments.

During the past year resignations have been received and accepted from the following officers: Mrs. Guy Johnson, who made such an efficient and acceptable organizing secretary for several years, and whose place has been filled by Mrs. J. P. Ware; Mrs. Taylor, our first diocesan secretary for the Spirit of Missions, whose place has been filled by Mrs. Adam Hildebrand; Miss Mary Hill, editor of the Woman's Auxiliary page in the Bethlehem Churchman; Mrs. Baird Cooper, vice president and chairman of Section B, and Miss Elizabeth Donnelly. Various and good reasons have been the cause of all these resignations, but I would especially call your attention

to the resignation of Miss Donnelly, who for many years has given time, strength and health to the work. She has done the work of chairman, vice-chairman, secretary and treasurer of the Juniors faithfully, year in and year out, though many times physically unable. We owe her a debt of gratitude for her faithfulness and the good work she has accomplished. The time has now come when there must be a complete organization of the Junior Auxiliary, when each officer will willingly assume certain responsibilities and all work together in harmony for the spread of the Master's kingdom.

As to the resignation of your president, her only reason for resigning is for what she believes to be the good of the Woman's Auxiliary. We believe in rotation of office, and that a change of officers is beneficial to organizations, as surely as a change of air, or scene, or work is beneficial to an individual. We hope this change will mean new life and energy to the Woman's Auxiliary. To me personally the work has brought a larger vision and great blessings. It has been a great privilege and a great responsibility.

For the first time in twenty years your president was unable to attend the Triennial Meeting held in St. Louis last October, but we are pleased to record a full representation from this diocese.

Our delegates were Mrs. W. A. Lathrop, Mrs. Robert Linderman, Mrs. A.

The Chairman of the Nominating Committee reported that twenty-two parishes had replied to the notices sent out by the committee, and presented the nominations as follows: For President, Miss Ruddell and Miss Anne Boyer; for Vice President, Mrs. Ware and Mrs. Thompson; for Secretary, Miss Hill and Miss Macfarlane; for Treasurer, Mrs. R. P. Linderman.

Mrs. Lathrop, chairman of the committee to raise the Sara F. Israel Memorial Fund, reported progress, and explained that the sum of \$1000.00 was to be raised, which will yield \$50.00 annually. This amount is to be used to support a scholarship in St. Mary's School, Shanghai, China.

The report of the committee appointed to secure nominations for the offices of the Junior Branch of the Auxiliary was read. The nominees for Secretary are Miss Helen Ware and Miss Katharine Horton; for Treasurer, Miss Janet Pearsall and Miss Helen Turner.

Mrs. Ketchum's motion that a committee of three be appointed to prepare a card catalogue of the members of the Woman's Auxiliary in the diocese, and to report at the next annual meeting was seconded and carried.

Meeting adjourned at 11.50 to attend a Quiet Hour conducted by the Rev. Dr. Hagerman, of Binghamton, N. Y., after which luncheon was served.

Meeting again called to order at 2.10.

Mrs. Coxe called for nominations from the floor. Mrs. Ware withdrew her name as candidate for vice-president, and Miss Macfarlane also withdrew as candidate for secretary. Mrs. Hildebrand was nominated for secretary, and balloting was next in order.

While the tellers were counting the votes, a letter from Miss Lindley was read.

Mrs. Wood's motion that the title of officers, method of election and tenure of office be discussed at the Archdeaconry meetings and be brought before the next annual meeting for decision was seconded and carried.

Mrs. Johnson's motion that a committee be appointed to bring the matter of Definite Representation at the Annual Meetings before the next Annual Meeting was seconded and carried.

Mrs. Ware read the following resolution, which was ordered spread upon the minutes:

"Mrs. Coxe having resigned our Presidency after years of faithful and most efficient fulfillment of its arduous duties, the members of the Auxiliary wish to express the profound regret with which they accept her decision, together with the assurance of their conviction that the present prosperous condition of the Auxiliary is, in a large measure, due to her wise and gentle administration; and that its future prospects are brighter for the certainty of her continued sympathy and co-operation."

The secretary was instructed to send a note of greeting to Miss Boyer.

Mrs. Ketchum moved that a rising vote of thanks be extended to the ladies of Christ Church, Towanda, for their delightful hospitality.

Mrs. Glick, for Miss Boyer, spoke about the Summer Conferences at Cambridge, Geneva and Silver Bay, and urged attendance at one of them.

Mrs. Coxe suggested that the parish branches of the Auxiliary should send to the diocesan president the names of those members of the Auxiliary who have died during the year, so that they might be remembered at the Corporate Communion at the Annual Meeting.

The following resolution was read, ordered to be put upon record, and a copy sent to Bishop Talbot:

"We, members of the Woman's Auxiliary in the diocese of Bethlehem, extend to Bishop Talbot our love and esteem, in appreciation of his hearty sympathy and co-operation with us in our work. We pledge him our loyalty, and extend to him our congratulations on the approaching thirtieth anniversary of his consecration."

The president announced that the following committees had been appointed:

For Definite Representation at the Annual Meetings, Mrs. Guy Johnson, Mrs. Andre Beaumont and Mrs. Miner Dodson.

Finance Committee, Mrs. A. M. Hildebrand, Mrs. James P. Ware and Mrs. A. N. Cleaver.

Committee to prepare a card catalogue of all the members of the Auxiliary in the diocese, Mrs. A. E. Ketch-

our branch is and where it needs strengthening. This idea of a card-catalogue of membership is being advocated by Rev. Wm. C. Hicks, secretary of the Province of Washington.

It is generally found necessary for every large organization to have some kind of definite representation for the election of officers. I therefore recommend that every Auxiliary branch in this diocese be allowed two votes for the election of officers, and that they send that number of accredited delegates or their proxies to every annual meeting.

Believing in rotation of office, I hereby recommend that all offices of the Bethlehem Branch of the Woman's Auxiliary be elective and have a time limit of from one to five years. This would bring to each department of the work the benefit of a different view point every few years.

To the women of the Auxiliary let me express my appreciation of all the courtesies extended to me in the past

and for the willingness with which you have responded to all requests. To my fellow officers I wish to express my heartfelt thanks and appreciation for their unfailing loyalty and co-operation.

With the new conditions that have come to America in the last few months we women have got to deal. As women we will be called upon to make many sacrifices; let us do it willingly, let us do all we can to help our country, but don't let us forget or neglect our missionary work. Let our motto be God and our Country, and our prayer

"Teach us, O Father, to serve Thee as Thou deservest; to give and not to count the cost; to fight and not to heed the wounds; to toil and not to seek for rest; to labor and not to ask for any reward, save that of knowing that we do Thy will."

E. Ketchum, Mrs. Lawrence Thompson and Miss Laura Boyer. Our meetings during the winter have demonstrated the good they received and the immense amount of enthusiasm and help they brought back to the Diocese.

The pledges made at the Triennial by your representatives were seventy-five dollars for Christ Church, Anvik, the church built with the first United Offering, and seven hundred dollars for St. Agnes' School, Kyoto. The latter is to be given for the Dormitory which is to be a memorial to Miss Sallie Stuart, one of the founders of the Woman's Auxiliary. We hope all of this pledge will soon be paid.

The Bethlehem Branch had the honor of having its educational secretary, Miss Boyer, teach one of the Normal Study Classes during the Triennial. Soon after her return she was taken ill, and has been unable to take any active part in the work during the winter. We are now glad to say she will soon be able to resume her duties as educational secretary. Through a desire to help Miss Boyer some of our young women offered their services as educational leaders during Lent with splendid results.

Soon after the Triennial last fall we were startled to receive notice that Miss Julia Emery, General Secretary of the Woman's Auxiliary, had resigned. We have looked upon her as peculiarly belonging to the Auxiliary and it hardly seemed possible that the time had come for some one else to be at the helm and guide our great missionary society on its journey to the port where she would be. Fortunately for all concerned Miss Grace Lindley has, at the solicitation of Bishop Lloyd, accepted, until the next Triennial, the office vacated by Miss Emery. Miss Lindley has been with us in the diocese of Bethlehem many times. We all know and admire her and extend to her our loyal support in all her undertakings for the good of the Auxiliary.

During the year it has been our great privilege to take part in the Pilgrimage of Prayer, suggested by Miss Emery. It seemed very appropriate that the dioceses of Harrisburg and Bethlehem should be linked together for their Pilgrimage of Prayer week. As the Woman's Auxiliary of

the old Central Pennsylvania diocese worked and prayed together so the Auxiliary of Harrisburg and Bethlehem tried to arrange for their Pilgrimage of Prayer Week in such a way that we might unite once again in work and prayer. All those who took part in this Pilgrimage were spiritually blessed and I am sure that if we continue the Pilgrimage by praying week by week for the dioceses that follow, we will obtain an added blessing for ourselves as well as bring a blessing to others. We must not lose sight of the fact that this journey of prayers will continue until, on the Sunday next before Advent, November 25th, 1917, all members of the Auxiliary throughout the Church have a corporate communion, offering unitedly the intercessions of the Pilgrimage of Prayer.

Last summer three young women from this diocese went with our vice president, Mrs. Cooper, as missionaries to the District of Wyoming. Two of them were obliged to return in the Fall. The other is still working in the Shoshone Indian School. This summer two young women from Wilkes-Barre expect to go to North Dakota to work under Bishop Tyler.

The Summer is drawing near and the question comes how and where are we going to spend our vacations? How are we going to make them worth while? Last year five of our young women went to the Summer School at Cambridge, which they realized was a great privilege. We earnestly hope as many more will go to Cambridge this Summer.

We have made what we consider a decided improvement in our annual meetings, in doing away with the reading of nearly all reports and using the time thus saved for conferences. The conference a year ago proved most helpful, and those for the present meeting you will find equally so.

For the coming year, I would suggest that a card catalogue be made of all members of the Auxiliary in the different parishes with a list of unproductive fields and the reasons therefor. We have never been able to get any adequate idea of the members of our Bethlehem Branch and we should know definitely how large

READING ARCHDEACONRY

Owing to the resignation of Mrs. Guy D. Johnson, Organizing Secretary of the Reading Archdeaconry, on account of her removal from the Diocese, the Bishop appointed me to succeed her, in July last. It has been comparatively easy to resume the work again, and the good foundations laid in the past are yearly being strengthened and built upon.

This being the first report following the meeting of the General Convention, it is my pleasure to say, that the financial exhibit is larger than ever before, due to the fact that the United Offering has increased, and the contributions to two specials, which the General Convention authorized, and to which the parishes have responded so well.

The Branches of the Auxiliary have not lost sight of the original purpose of their being, that is, to be true helpers to the Board of Missions.

As a loving memorial to Mrs. Israel, for so many years the President of the Auxiliary of the Diocese, \$308.63 has been given toward a thousand dollar scholarship, at St. Mary's School, Shanghai, the money coming from twenty parishes and missions.

The Organizing Secretaries have two definite aims before them:—to establish the Auxiliary in every parish and mission in her Archdeaconry, and to strengthen it where it already exists. With the latter aim in mind, I have urged the holding of Neighborhood Meetings, forming parishes into groups and appointing committees from the group to plan for such meetings.

Two important and interesting Neighborhood Meetings were held the past year, one at Hazleton where the parishes of White Haven, Sandy Valley, Freeland, Eckley, and Drifton were represented, the speaker being the Rev. Mr. Whittle, of Porto Rico;

the offering amounting to \$7.02 was given to Miss McCullough's School, Porto Rico. The other meeting, held in Mauch Chunk, had representatives from Lansford, Lehigh, Palmyra, East Mauch Chunk, Tamaqua and Summit Hill, and the needs of St. Mary's School, Shanghai, and St. Agnes' School, Kyoto,, were presented; the Pilgrimage of Prayer was also explained. At this meeting the offering of \$17.08 was sent to St. Agnes', Kyoto.

The regular Fall meeting of the Archdeaconry was held in St. Paul's Church, White Haven, in November. Sixty delegates were in attendance. The Rev. Mr. Mosher, of Wusi, was the speaker and gave an interesting account of his work in China.

The Mid-Winter Meeting was held in the Church of the Mediator, Allentown, in January. Bishop Talbot spoke of the Pilgrimage of Prayer a call, from the Triennial gathering of the Woman's Auxiliary to all the Auxiliary. Bishop Tyler spoke in an interesting manner of the work among the White population and the Indians in his district.

SCRANTON ARCHDEACONRY

To regularly report in detail the semi-annual Archdeaconry General Assembly may seem a superfluous rehearsal of an established occurrence, but since it is only at these meetings that we are able, collectively, to confer in a comprehensive manner, and to determine efficient methods of administration, we are coming to more fully recognize the importance of these meetings, in affording a clearer apprehension of our united effort, as well as furnishing the inspiration to carry it forward. This was the expression of opinion at the close of the Autumn Assembly, which was held in St. David's Church, Scranton. Rev. W. S. Claiborne was the speaker at a Missionary Service held on the evening of November 8th, and all were thrilled by his graphic account of the life of the Tennessee mountaineer.

The day of the regular meeting, November 9th, began with a celebration of the Holy Communion at eight o'clock. The business session which followed was marked by animated discussion, following the reports of the delegates who represented the Bethlehem branch of the Woman's Auxiliary at the General Convention in St. Louis, October 11th-24th.

Following the consideration of the Sara Israel Memorial, the special undertaking of our Diocesan branch for 1916-17, the program as outlined by the Auxiliary in St. Louis was the subject of discussion. The proposed change in the method of conducting the work of the Junior department, the pledge of \$50,000.00 to St. Agnes' School, Kyoto, (the Authorized Special of the Board of Missions for 1916-17) were reviewed, and lastly, a full explanation was given of "The Pilgrimage of Prayer"—a season of invocation to be undertaken by every member of the Woman's Auxiliary during the coming year, each Diocesan branch to have special services at a definite time set apart for its participation. This event, to which the Bethlehem branch made its contribution during the week of February 11th—we may here report—was very gen-

erally observed throughout the parish branches, and the Mid-Winter General Assembly was held in St. Clement's Church, Wilkes-Barre, on Thursday and Friday of that week, which increased the opportunity to enter abundantly into this great adventure of supplication. The program of this Assembly was designed to emphasize the "Place of Prayer" in the Woman's Auxiliary, and a part of the first session was given over to a comprehensive consideration of the subject by Rev. E. G. N. Holmes; at the close of the meeting, the following day, we were privileged to share in a most inspiring Quiet Hour of the Pilgrimage, led by Rev. J. A. Glasier.

At a Missionary service held the evening of the 15th, the address was given by Dr. Arthur R. Gray of the Board of Missions, the subject being "The Latin-Americans." At the conclusion of his talk, he briefly outlined the Mission-Study textbook for this year,—"The New World," of which book he is the author.

The advisability of assembling the parish branches within the Scranton Archdeaconry into sectional groups, looking to a more thorough, broader understanding of the Woman's Auxiliary in the parish branch, and also to the accomplishment of more aggressive work in the parish branch, which we trust would be the logical outcome of the more personal intercourse of the smaller Assembly meetings, has been a subject of discussion at various times during the past year. May we earnestly bespeak for this matter the serious consideration of all who are vitally interested in our well-being—and if any plan along this subsidiary procedure can be evolved by which the efficiency of the Diocesan branch may be increased, by all means let us carry inspiration and information to the outlying parish branches, particularly those, who, by reason of location or other unusual circumstance, have not an equal incentive with those at the "four corners."

JUNIOR AUXILIARY

SECTION 2.

A brief review of the work accomplished during the year 1916-17 by the Junior Department of the Woman's Auxiliary in this Diocese shows that 31 of the old branches have been actively at work. Five old branches have lapsed. Six new branches have been organized: At Church of the Holy Apostles, St. Clair; St. James, Freeland; St. James, Eckley; two branches at St. Stephen's, Wilkes-Barre; Boys' branch at St. Luke's, Scranton, making the total number of branches on our list 37.

There were no general or Archdeaconry meetings held during the year.

As usual our first work was the collecting, packing and forwarding of the gifts for the Christmas Boxes which were sent last November to the Indians at Pine Ridge, South Dakota, the mountaineers at Waynesville, North Carolina, and the Colored Mission at Palatka, Florida. 27 branches contributed over 1000 gifts which were packed and forwarded by the Juniors of St. John's Church, East Mauch Chunk. We were also able to send to each mission a cheque for ten dollars to purchase candy for the trees.

Since the first of the year we have been diligently at work on our gifts to be sent next fall to the Indians at Standing Rock, S. D., and to the Colored Mission at Union Level, Virginia;

and the reports show that in most instances they are nearly completed, and ready to forward as soon as the fall work begins. The Juniors of St. Mark's, Mauch Chunk, will receive and forward these gifts. Due notice of the time for forwarding them to Mauch Chunk will be sent out early in September and each leader should see that their contribution is forwarded promptly, as any delay in forwarding the gifts from even one parish holds up the box, and may be the cause of preventing our gifts arriving at their destination in time for distribution at Christmas time, and consequently cause a great disappointment which could easily be prevented.

The results in all departments of our work, during this time of waiting for reorganization, have been very gratifying. Eighteen of the twenty-four branches replying to the question, report having had either a Mission Study Class, Missionary reading or a Missionary play during the year.

All of our pledges have been met and the total amount of our contributions is \$104.99 larger than last year.

We have long realized the necessity for a complete board of officers to carry on the work of the Junior Department in an aggressive manner, and various methods have been tried to secure this board but without success. At the Annual Meeting of 1916 a plan

was suggested and adopted whereby the Junior leaders of the Diocese were to nominate and elect their own board of officers—excepting the chairman, who is appointed by the Bishop. The nominating committee, appointed at that time, reported at the meeting for Junior organization held in connection with the Woman's Auxiliary meeting on May 2nd in Towanda, and while we did not secure the whole board at that time, a Secretary and Treasurer were elected, and we are confident the board will be complete before very long—we hope before this report is in the hands of the leaders.

It is with deep regret that your chairman finds she is obliged to resign her office, but Miss M. L. Farrer, our well known United Offering Treasurer, has consented to take up the Junior work and I bespeak for her the loyalty and co-operation that have been such an inspiration and made the work such a pleasure to me. Under her leadership, with the help of the new officers, Miss Helen Ware, of Drifton, Secretary, and Miss Janet Pearsall, of Mauch Chunk, Treasurer, we are looking forward to splendid things from our Juniors in the future.

A brief summary of the work done during the last ten years may be of interest to you:

62 branches have been organized. 8 branches have graduated into the Woman's Auxiliary; 46 meetings have been held; Christmas boxes valued at \$3065.92 have been sent; value of other boxes sent was \$2717.28; our contributions in money were \$3725.87, making the total value of our work \$9509.07.

EDUCATIONAL DEPARTMENT

The Educational Department has been conducted this winter by the various interested and devoted parish educational secretaries and mission study leaders. Too much credit cannot be given these leaders on whom the entire educational work of the year fell so unexpectedly. The illness of the Diocesan Educational Secretary was so sudden and so overwhelming that not even the usual outline plans for the Diocese could be prepared and sent out. But the work has been carried on throughout the Diocese without the Educational Secretary in a splendidly capable way. In the Archdeaconry of Reading, Mrs. A. H. Glick, parish educational secretary of Frackville, represented the Educational Department at the midwinter meeting at Allentown. In the archdeaconry of Scranton, Mrs. E. M. Chance, parish educational secretary of St. Stephen's, Wilkes-Barre, represented the Educational Department at the midwinter meeting at St. Clements, Wilkes-Barre. The correspondence of the Educational Department was carried on by Miss Anne Boyer, of Pottsville.

The loss of two mission study classes in comparison with the Educational report of last year can be easily explained by the fact that the Educational Secretary herself did not lead any classes. In spite of the apparent loss, we have really progressed, particularly in developing several splendid new mission study leaders. We have progressed also in the understanding of what mission study really means, and a corresponding enthusiasm for it. One parish reports mission study meetings during the year

and a mission study class in Lent, and says that they plan for next year to have not only the same but better and more progressive educational work. One parish asks to be notified if the subject of next year's course so that they may do summer reading for it. One parish reports as the aim for study class, 'To learn how to qualify ourselves individually for personal work in the Kingdom of Christ.' Let every class take this aim for its own next year. Then the Diocese of Bethlehem will have a system of vital mission study—mission study that counts for the extension of the Kingdom of Christ.

The Educational Secretary since the last annual meeting has attended the Cambridge Conference, led a normal class as a substitute for Miss Tiltonson at the Conference of the Province of New York and New Jersey, at Geneva, New York, and led a normal class at the General Convention at St. Louis.

The following report of mission study in the Diocese is based on 34 reports which have been sent in to the Educational Secretary.

Mission Study Classes have been held in the following parishes:

Allentown (Grace Church), Allentown (Church of the Mediator), Dorranceton, East Mauch Chunk, Frackville, Lansford, Mauch Chunk, Plymouth, Reading (Christ Church), Reading (St. Mary's), Sayre, Scranton (Good Shepherd), Wilkes-Barre St. Stephen's). Bethlehem reports a class to be held in the spring.

Total mission study classes reported, 15.

ARTICLE IX.

The duties of the Organizing Secretaries are to form new parish branches in their Archdeaconries, to stimulate the Missionary spirit and to increase intelligent interest in the Missionary work of the Church. They are authorized to hold meetings within their Archdeaconries and are free to conduct their work under the general approval of the President of the Society and the Bishop of the Diocese.

1. They shall receive from the parish branches reports of all work done by them and all monies contributed by them or thru them and give a receipt for the same.

2. Each Organizing Secretary shall send to the Treasurer of the Society all monies, except the United Offering, received from its branches immediately on receipt of the same, together with a detailed account designating the source from which, and the object for which they were received.

3. The Organizing Secretaries shall make an annual report to the Secretary of the Auxiliary of the work done in their Archdeaconries, the same to be printed in the Annual Report of the Diocesan Branch.

ARTICLE X.

At each Annual Meeting the President shall appoint a committee of two persons whose duty it shall be to audit the accounts of the Treasurer, and the United Offering Treasurer.

ARTICLE XI.

Before May 1st of each year each Parish Branch shall send to the Organizing Secretary of its Archdeaconry all monies contributed for the Society, and also reports of all work done, including the furnishing of boxes for Missionaries.

ARTICLE XII.

There shall be one general meeting of the Society in May of each year at such time as may be designated by the Bishop.

ARTICLE XIII.

Special meetings of this Society may be called by the President at the request of the Board of Managers or of four parish branches.

ARTICLE XIV.

This Constitution may be amended by a two-thirds vote of the members of the Society present at any Annual Meeting.

CONSTITUTION

ARTICLE I.

The name of this Society is the Bethlehem Branch of the Woman's Auxiliary to the Board of Missions.

ARTICLE II.

The object of this Society is to diffuse knowledge of the Missionary work of the whole Church among all people in the Diocese; to increase their interest and activity in that work; to encourage the formation of branches of this Society in every Parish and Mission of the Diocese: and, by means of united and systematic effort, to promote the work of Church extension.

ARTICLE III.

The Church is the Missionary Society. Every Baptized person is a member of this Society; therefore all baptized women who aid the Missionary work of the Church by their prayers, work or offerings are recognized as actual members of the Woman's Auxiliary.

ARTICLE IV.

The officers of this Society shall be a President, a Vice-President, a Secretary, a Treasurer, a United Offering Treasurer, an Organizing Secretary for each Archdeaconry of the Diocese, and an Educational Secretary. Other officers may be chosen at the discretion of the Society.

1. These officers (except the Organizing Secretaries and the Educational Secretary, who shall be appointed by the Bishop) shall be elected by ballot at the Annual Meeting of this Society.

2. A Nominating Committee shall be appointed by the President two months previous to the Annual Meeting, whose duty it shall be to prepare a ticket containing, if possible, the names of two candidates for each office.

3. A Treasurer of the United Offering shall be elected once every three years, at the May Meeting in the same year as the Triennial Meeting of the Woman's Auxiliary. Her election shall take effect November 1st of that year, and she shall hold office until her successor is elected.

4. The Chairman of the Junior Aux-

iliary and the Chairman of the Babies' Branch shall be appointed by the President and approved by the Bishop.

5. The above officers shall constitute a Board of Managers to which the affairs of the Bethlehem Branch shall be entrusted.

ARTICLE V.

The duties of the President are to call all meetings, to preside at them, and to have the general oversight and direction of the work of this Society.

ARTICLE VI.

The duties of the Vice-President are to assist the President, and in her absence, to preside at all meetings of the Society.

ARTICLE VII.

The duties of the Secretary are to prepare a report of the work of the Society for its Annual Meeting; to keep the minutes of all its meetings; to have charge of the printing of its reports and other documents, and to conduct such correspondence with the parent Society and ther branches as the President may direct and approve.

ARTICLE VIII.

The duties of the Treasurer are to receive all monies of the Society, to keep a full and accurate record of all receipts and disbursements, and to present to the Society at the Annual Meeting a full report of the same. She shall pay out money only by the direction of this Society, or its Board of Managers, except such sums as may be received for definite purposes. All money received for purposes outside the Diocese shall be forwarded to the Treasurer of the General Board of Missions.

1. The duties of the United Offering Treasurer are to increase and deepen interest in the United Offering, to receive all money for this offering through the Organizing Secretaries and the Junior Board and with the advice of the Board of Managers to place this money at interest until it is presented at the next Triennial Meeting of the Woman's Auxiliary.
