

THE UNITED THANKOFFERING is the offering presented at each Triennial Service of the Woman's Auxiliary. The offering at the Triennial Celebration in October, 1922, at Portland, Oregon, is for Woman's Work in the Foreign and Domestic Fields, after reserving one-tenth as a permanent fund, the interest of which shall be used for retired United Thankoffering Missionaries, and a sum not less than \$10,000 for a building in the Mission Field. Every woman may share in the great Thankoffering. Gifts and pledges received at any time.

THE BISHOP'S AUXILIARY FUND is a general fund raised by the Auxiliary and placed at the disposal of the Bishop. At present he applies it to the support of workers in the Diocese.

The Bishop asks every woman in the Diocese to give to this according to her means, that "The Bishop's Auxiliary Fund for the support of Workers in California" may parallel in enthusiastic interest and generous giving the United Offering's great mission in the National Church.

DIOCESAN BRANCH EXPENSES: It is obligatory on every parish branch to pledge a definite sum to the Fund.

RESOLUTION ON ALASKA BOX WORK, passed by Diocesan Board May 27th, 1908:

Resolved, That Branches are requested to place no value on second-hand clothing sent to headquarters for shipment to Alaska Missions, it being understood that the packers will value such articles at rates at which they would sell as second-hand clothing and apply them to the Missions for which they are fitted, unless designated, crediting them to the Branch contributing.

RESOLUTION ON THE APPORTIONMENT to the General Board, May, 1912:

All moneys raised by Parish Branches for the apportionment made by the General Board shall be sent directly to the Treasurer of the Diocesan Auxiliary, as heretofore, the Treasurer of the Parish Branch being careful to report promptly this action to the Treasurer of her Church. The Treasurer of the Diocesan Branch will forward these sums to the Treasurer of the Diocese, stating amount given from each parish, that he may so credit it.

SPECIALS TO MISSIONARY BISHOPS should be sent through the Diocesan Auxiliary Treasurer, the Branch Treasurer notifying the Bishop and thus receiving his acknowledgment direct.

To SECRETARIES: Do not fail to report to Diocesan Secretary change of address or absence, or change in list of officers, as it is absolutely necessary to the success of the work that Diocesan officers should know at all times to whom to send notices of meetings, and other important communications. See that all packages are forwarded, prepaid. In case very heavy boxes are sent by freight, mail way-bill at once to the Secretary, who will forward to shipper bill for cartage from station. Send boxes for distribution by Diocesan officers to 1215 Sacramento Street, addressed to Woman's Auxiliary.

THE ANNUAL SERVICE AND MEETING

February 6, 1920.

The Annual Service was held on Friday, February 6th, in the Cathedral. Bishop Nichols celebrated the Holy Communion, assisted by Bishop Parsons, Archdeacon Emery and Canon Hayes. The Rev. Bayard F. Jones preached from the text, "God, Who at sundry times and in divers manners, spake in time past unto the fathers by the prophets hath in these last days spoken unto us by His Son." He said that the motive of the Nation-wide Campaign is the same as that of Missions—the awakening of conscience. The lack of keen interest in Missions has for years been due not only to lack of information, but to our changed belief about the future of the heathen. Our ancestors believed that those who knew not Christ were doomed to eternal suffering, and their missionary zeal corresponded to their doctrines. Our generation, with a belief that the religions of the pagans are a groping after God, are tempted to ask why we should seek to impose the Christian faith upon them. The answer is that the Christian faith furnishes the only enforcing clause to ethical teaching. Pagan philosophies have excellent precepts, but Christianity alone promises the enabling grace and power of Christ. And we, in our daily life, whether we will or not, are witnesses to the world of His power.

As in previous years, Trinity Branch was hostess to the Auxiliary at a delightful luncheon hour.

The Annual Meeting was convened at two o'clock in the Cathedral, and opened with a brief service. After the roll-call, answered by thirty-seven Branches, the President asked all present to join her in a short thanksgiving for the service of Mrs. Monteagle—for twelve years the President of the California Branch.

Mrs. Monteagle then made an address covering that part of the year during which she was President, and touching the Convention in Detroit and the beginnings of the Nation-wide Campaign. Mrs. McLeish followed with a brief forward look on the work of the coming year with its three aspects of service—prayer, service, giving. She stressed the importance of prayer, and suggested a plan for a special subject of prayer for each month—the subject for February being "Renewed Consecration of Ourselves." The task this year before our Branch is to see that every woman is a member of the Auxiliary.

There were no further nominations and the Secretary was instructed to cast the ballot for those nominated, and they were declared elected.

The visiting missionary who had been asked to address the meeting was Mrs. John Ely, teacher in St. Mary's School, Shanghai, returning from her furlough. She brought to us the call of China for help in this crisis of her development. She described the power of the student class and spoke especially of the girls in the schools—their bright minds and eagerness to learn, their initiative and their missionary spirit. St. Mary's School is educating 250 girls and could have many more if there were sufficient buildings.

Bishop Nichols in his address gave a clear statement of his views on the subject of the plan of extending the legislative power of the House of Churchwomen. He applied the principle of equality but not identity of service and opportunity, speaking of the twin parables of growth, the man sowing the seed, the woman mixing the leaven—the man's work and the woman's work. At one time, more effective service was done in the extension of the Church by four women than by all the men. They were Clotilda, Bertha, Ethelberga and Hilda—and each did her part in the womanly way. The application of the principle demands time, but the House of Churchwomen has demonstrated some of the things that woman can do, and with patience, the development will come.

A letter from Bishop Rowe was read, telling of the increased cost of caring for the children in school at Anvik and Nenana, and asking scholarships to enable him to keep the schools open. The offering was taken for the purpose of helping Bishop Rowe in this emergency. It was \$103.79.

THE ANNUAL SERVICE AND MEETING

February 4, 1921.

The Annual Service was held in Cathedral on Friday, February 4th at 10:30. Bishop Nichols celebrated the Holy Communion, assisted by Bishop Parsons, the Rev. Edward Morgan and Canon Hayes. The Rev. R. H. Trilease, the Rev. J. A. Collins, the Rev. W. M. Bours and the Rev. Bayard Jones were also in the chancel. The Rev. C. T. Leachman preached from the text, "Are they ministers of Christ? (I speak as a fool) I am more." He pointed out that St. Paul felt the folly of defending himself from the detractions of his enemies by enumerating his advantages or his sufferings, and knew that his real defense was a recognition of his constant need for God's help. And in the history of woman's position in the Church, this attitude has been her strength, so that she has reached a stage of more active participation in the counsels of the Church without arousing rancor.

After partaking of the delicious luncheon provided by Trinity Church, the members of the Auxiliary assembled at two o'clock for the Annual Meetings, Mrs. L. C. Lance presiding.

Bishop Nichols opened the meeting with a brief service. A letter from Mrs. McLeish was read by Mrs. Kroll, expressing her regret at being obliged to resign the Presidency, and her appreciation of the co-operation of the Branches during the past year.

By a rising vote the Secretary was directed to write to Mrs. McLeish a letter conveying the sorrow of the members that illness compelled her to resign the Presidency, which meant so much to the Auxiliary, and their hope for her speedy and complete recovery.

The Treasurer's Report followed, showing receipts of nearly five thousand dollars.

The Secretary and Treasurer of the United Thank Offering read their reports for the year.

The Nominating Committee presented the following names, Bishop Parsons taking the chair:

For President, Mrs. L. C. Lance of St. Clement's, Berkeley.

For Librarian of the Church Periodical Club, Mrs. Sidney M. van Wyck of Trinity, San Francisco.

For Delegates to the next meeting of the Synod of this Province: Mrs. Clifton H. Kroll, Mrs. Lloyd M. Robbins, Mrs. L. C. Lance, Miss P. Coppie, Mrs. H. P. Sherman.

For Alternates: Mrs. George Wakefield, Mrs. C. Edward Holmes, Miss Helen Swayne, Mrs. D. C. Tessenden, Miss Helen G. Barker.

There being no other nominations, it was moved and carried that the Secretary cast the ballot for those nominated, and they were declared elected.

In relinquishing the chair to Mrs. Lance, Bishop Parsons paid a tribute to those women who had preceded her in office and prophesied an equally efficient administration under her leadership, to which Mrs. Lance responded, saying that only by the co-operation of all the numbers could our work be successful.

Mrs. Monteagle then spoke of the organization of the Auxiliary in the Province of the Pacific, and of the Auxiliary's Fiftieth Anniversary, to be celebrated in October by the creation of a fund, the income of which will be used for the benefit of missionaries on furlough, for medical treatment, study or pleasure. The fund is to be at least fifty thousand dollars, of which the sum of twelve hundred dollars was to be the aim of this diocese. Bishop Nichols also spoke of the Fiftieth Anniversary. Then an opportunity was given for Branches to make pledges, and so eager was the response that more than fifteen hundred dollars was promised.

Mrs. Bacon of San Jose had offered a motion, which carried, that our goal should be at least fifteen hundred dollars, and probably considerably more will be given, as some Branches were not prepared to promise definite sums, but will doubtless contribute.

As a fiftieth birthday gift, Bishop Nichols offered the Auxiliary a gavel of olive wood from Jerusalem, which was gladly accepted.

The Rev. Dr. Buttrum then spoke briefly on the Lambeth Conference and its decisions on the status of women in the Church. The Conference recommended the restoration of women to that position which they had in the New Testament time:

1st. The recognition of Deaconesses as a ministerial order, paralleling the Order of Deacons, and the preparing a service of ordination for them, and defining their functions.

2nd. Sisterhoods are continued in their present status.

3rd. Laywomen are acknowledged to have the same right to minister as laymen, and the right to sit, deliberate and vote in the Councils of the Church.

The final address was given by the Rev. C. W. Baker, missionary to the Indians on the Klamath River. He spoke of his people, many of whom were hearing the Gospel for the first time, of their eagerness for Christian ministration, and of the help the Auxiliary had given him in his isolated field.

The meeting was closed with the benediction by Bishop Nichols.

REPORT OF THE RETIRING PRESIDENT

In spite of the fact of my absence from the diocese for four and a half months, the past year has been marked by a splendid advance in all the three departments of Auxiliary work—prayer, giving, and service.

And this advance is due to two causes: the inherent strength of the Auxiliary and the devoted leadership of the diocesan and parochial officers.

We have cause for thankfulness that we financed easily our annual obligations, and paid all the pledges—nine hundred dollars in all—made at the Triennial in Detroit.

But we have a still deeper cause for thankfulness in the formation in so many parishes of prayer circles under the leadership of Miss Coppée. Marin County has a prayer circle in each parish, and in all but one of the missions; and it is Miss Coppée's most earnest wish that each parish during this year will allow her to visit the Auxiliary and describe her work.

There has been a stimulating growth in the membership of many Branches, but the problem of reaching the younger women still remains partially unsolved.

In conclusion, I want to thank every member of the Auxiliary for the loyal co-operation I have had during my term of office.

The work was a constant source of happiness, and it is a great grief to me to give it up; but I know that the Auxiliary will go forward to bigger and better things under the wise leadership and consecrated effort of our new President, for whom I ask your prayers and your co-operations in the work that lies before her.

REPORT OF THE SECRETARY

The year 1920 has been one of reorganization in the affairs of the Church, and the Auxiliary in California has endeavored to understand and adapt itself to the changes. The National Woman's Auxiliary has been made the Woman's Auxiliary to the Presiding Bishop and Council, and consequently its scope has been enlarged to include Religious Education and Christian Social Service, as well as Missions. The California Branch has long had its Educational Department, but has not yet organized a Department of Social Service, nor become a part of the Church Service League. The circumstances here differ somewhat from those in other dioceses, and it has been thought wise to advance very slowly.

In the box work, however, we have been able to conform to the new plan and receive all our allotments from the General Supply Secretary in New York. A Christmas box was sent to a domestic missionary, and the Branches are now busy preparing the very valuable Alaska box which was assigned us. The box sent to Alaska last May was on the old plan. Dr. Chapman has written how welcome were the articles sent.

At our last Annual Meeting we received with deep regret the resignation of our President, Mrs. Louis F. Monteagle, to whose initiative and devotion for the twelve years of her service was due so much of the progress of the Branch.

And we welcomed with great pleasure a new President, Mrs. A. L. McLeish, well known to us and to the General Officers as a woman of singularly keen insight and devotion to the Church. Her work has been much interrupted by illness and by her visit to Honolulu at Bishop Restarick's request in the interest of the Nation-wide Campaign. Yet we have felt her wise guidance in these reconstruction days, and are now distressed that she has been obliged by ill-health to resign the Presidency.

The regular monthly meetings have been held, giving our members the opportunity of hearing passing missionaries: Bishop Roots of Hankow, Miss Dodson and Mrs. John Ely of Shanghai, Rev. and Mrs. E. J. Lee and Miss Kent of Anking. When Miss Dexter of Wuchang General Hospital passed through San Francisco in the middle of July, Mrs. Monteagle gathered a large number of Auxiliary members at her home to hear Miss Dexter speak of her work, in which we have an added interest because of Miss Grace Crosby's participation in it. In March, when no visiting missionary was at hand, Miss Swayne of Alameda and Miss Barker of Trinity, San Francisco, read papers about two of the eight fields to which our delegates pledged help in Detroit. These pledges, amounting to nine hundred dollars, have been raised during the year by the co-operation of nearly all the Branches. At the conference of diocesan and parish officers last February, the objects and amounts of the pledges were explained by Mrs. Monteagle, and immediately the Branches gave their promises of support, so that the whole amount was paid without further solicitation.

The Bishop Coadjutor conducted the Quiet Days for the Auxiliary, one in St. Peter's, Oakland, and the other at St. Stephen's, San Francisco. His kindness was greatly appreciated, for the two days were taken from time over-crowded with his new duties.

The Altar Day Service was held in St. Luke's Church, Bishop Nichols making it a memorial service for Mrs. James Newlands, for years the beloved President of the California Branch of the Auxiliary, a leader whose close walk with God and uplifting example are among our treasures in the Auxiliary life.

The United Thank Offering Service was held in October, Bishop Nichols being with us as usual. The United Thank Offering Treasurer reported more money in the account than ever before in the first year of the triennial period.

As we meet here today we miss not only dear Mrs. Newlands, but also Mrs. Helen Willett and Mrs. William Leacock, respectively President and Secretary of St. Clement's Branch. They had worked faithfully together for years to make that Branch a factor in the Auxiliary life of the diocese, and we shall miss them sadly.

The Auxiliary work in three of the parishes has been revived and strengthened during the year—Church of the Advent and St. Peter's, San Francisco, and St. Stephen's, San Luis Obispo, and Christ Church, Alameda; St. Clement's, Berkeley; St. Paul's, Oakland; St. James, San Francisco, and others report large increase in membership and interest. We cannot express the joy with which we see younger women coming forward to take up the work which we older ones must soon relinquish. Especially do we welcome the new Assistant Treasurer, Miss Gwen Jones, whose help enables Mrs. Robertson to continue to care for the funds of the Branch in this diocese.

It has been a year of growth and promise, for which we thank God.

REPORT OF THE EDUCATIONAL SECRETARY
EDUCATIONAL DEPARTMENT

MOTTO:

*"We must know in order to love,
We must love in order to serve."*

Following is the report of the work done in our diocese during 1920 towards the definite study of Missions through organized classes.

The general subject of the year's work as arranged at the Church Missions House was Christian Americanization with "Neighbors" as the text-book.

Preceding and during Lent a Normal Class was held at the Diocesan House giving Parish class leaders a first experience in the discussion of the subject matter in preparation for their own classes. The attendance was fairly good in numbers and very good in the contribution each member made to the interest of the class.

Leaders from St. Stephen's Parish, San Francisco and from St. Mark's Parish, Berkeley took advantage of this Normal Class and report excellent results and well sustained interest in the Parish Classes led by them.

At All Souls Parish, Berkeley, the Rector used the text-book "Neighbors" for readings and discussion with his Auxiliary group during Lent. This was also the plan of a class of seventeen members at St. Peter's, Oakland, who met regularly during Lent under the leadership of their Rector.

At the Old Ladies' Home, San Francisco, the Chaplain held a reading and discussion class on the same subject.

Our Diocese was unfortunate in losing from our midst several of our experienced and ever-willing Class Leaders, Mrs. Elliott, Mrs. Clennell, Miss Von Holt, Miss Langdon and Miss Josephine Clennel. None have as yet come forward to take their places, so we have fewer Study Classes to report than for many years.

Working in conjunction, however with the Board of Christian Education we claim as educational opportunities Dr. Powell's excellent interparochial Bible Class held weekly from January to June, and resumed again in September, at which an average attendance of forty or more vouches for the good instruction and benefit received. Also the Summer Church Conference, combined with the former Summer School for Teacher Training, held at Mills College in July was much appreciated by the many able to attend.

I cannot impress too strongly upon our Parish Auxiliary Branches the benefit of some definite study of Missions. Like good illustrations in our magazines and books, a Study Class throws light upon and shows the point and purpose of all our missionary work and will vitalize the Auxiliary Branch in a remarkable manner. Do try it and see the result. For the coming season our subject will be Alaska, using as our text-book an up-to-date publication by the late beloved Alaskan Missionary, Archdeacon Stuck, in press at the time of his death.

As our Auxiliary in California has always considered Alaska our special field of interest, and every parish yearly contributes to our Alaska Boxes, it would surely seem that a class to study Alaska and its Missions would appeal to and interest every Auxiliary member. Try it. Get the text-book, and hold a class in your parish this coming Lent. It would be wonderful to be able to report next year a Student Class on Alaska in every parish in our Diocese.
