## President's Address.

### DEAR WOMEN OF THE AUXILIARY:

"Lo I am with you alway even unto the end of the world." As we are gathered here upon the anniversary of the ascension of our Blessed Lord, to review the work we have done in His name during the past year, I am sure we can all bear testimony that this promise is being constantly verified. Have we not all been conscious of a Divine Presence helping us to accomplish what in our weakness seemed beyond our power, rebuking our little faith by giving abundant success to our imperfect efforts, giving us wisdom to plan and strength to execute methods for the advancement of Christ's kingdom on earth, thus enabling us in some degree to obey the command, "Go into all the world and preach the Gospel to every creature"?

The year has been one of progress in every department of the work. In every district new branches have been formed, until in some of them almost every parish and mission station has a branch of the Auxiliary. I earnestly hope that at the close of another year this may be affirmed of every parish and mission station in the Diocese. There is no reason why the women of even the weakest mission station should not be led to realize that as great a responsibility rests upon them as baptized members of the great missionary society, the Church, to help in its work, as upon those connected with stronger parishes, and that they will be called upon to give account of the talents committed to their charge, and that their smaller efforts, if the best they can do, are just as important and just as acceptable as the larger gifts of those more favored. In this way a larger number can be interested to learn of missions and then to pray and work for them.

The most important and satisfactory advance has been the permanent organization of Junior work in the Diocese. Much good work has been done in past years by the children and young girls, but with the limited amount of time I am able to give to the work of the Auxiliary, it has been impossible for me to give the attention to the Junior work which its importance demands. I have therefore been anxious for some time that a separate department should be organized, with some capable woman to take charge of it, and this year Providence has given me a most earnest and efficient assistant, by whose aid I have been able to carry out my desire for a special department for this branch of Auxiliary

work. In every pistrict but one, Junior Superintendents have been appointed and the work placed upon a substantial basis.

I wish to call your attention to the Diocesan pledges. At our Diocesan meetings we pledged ourselves for objects to be our united work. These meetings are made up of delegates from the different districts, and the districts should consider themselves bound by the action of their delegates, and so before taking up any other work in which they may be interested, should see that their proportion of the sums for which the Diocesan branch is pledged is provided for. District officers are hampered, and your Diocesan president given a great burden of anxiety, because the parish branches either do not consider themselves bound by these pledges, or else thoughtlessly fail to assume their share of them. Those to whom the money is pledged look to me for it. I must turn to the district officers, and they can only redeem their part of the pledges by the parish branches religously endeavoring to do their part in the matter. It is of very serious importance that this shonld be remembered, for failure to meet these pledges means serious loss to our faithful missionaries. For instance, the Bishop has just put into our hands the providing the salary of Rev. John Scott, our missionary at the Reservation. If each district would give its just proportion this would be easily done, and the districts could do this without trouble if every parish would feel bound to contribute toward it. The past winter Mr. Scott was obliged to appeal to the Bishop, who could only turn to me, and for some months I was constantly anxious for fear the entire amount would not be contributed. I should like each district to make this their first work in the fall and see that whatever is pledged for this object is paid in by or soon after Jan. 1st, and so make it impossible that Mr. Scott should apply for a quarter's salary and find nothing in the treasury to meet it.

Another matter of importance is with regard to reports of work. It can easily be understood that Miss Emery must have a correct statement of where and to whom boxes have been sent, not for publication, for as you know the names of clergymen are not mentioned in our reports, but to avoid the possibility of some needy missionary failing to receive assistance, while some other one might have a double portion. Diocesan and district officers are helpless in the matter unless parish officers make full and complete reports. We often get reports of boxes sent to a missionary in Iowa or Minnesota or some other state or territory. Of course this is very indefinite and really conveys no information

as to who is the beneficiary. If the district officers will make it understood by parish officers that the full name and address of the missionary aided must be given, and then if parish officers will be careful to keep correct record and thus report, much annoyance and confusion will be avoided.

At the General Meeting of the Auxiliary held in Baltimore last autumn, it was decided that the United Thank Offering of the Auxiliary, to be presented at the General Meeting in 1895, should be given for the endowment of a Missionary Jurisdiction. This requires \$66,000 for a Domestic and \$56,000 for a Foreign Jurisdiction; but when we remember that the magnificent offering of more than \$20,000 which was presented in Baltimore was really the result of a few months work, there seems no doubt but that if we begin in earnest the adequate sum can easily be raised. District officers should try and interest parish branches at once in this offering. Mite boxes will be furnished at the mission rooms upon application, and I am sure many who are not in the habit of regular giving can be persuaded to make a beginning in this way. Oh, if we could only arouse Church women to a sense of the great debt they owe to Christ and His church for the blessings they enjoy, and the positions of influence and honor they occupy, I am sure they would find some means of making some practical acknowledgment. How ready we are to acknowledge and strive to repay the favors bestowed by earthly friends; but how slow to recognize the blessings bestowed by the Great Benefactor, from whom indeed "cometh every good and perfect gift." Let us earnestly endeavor to awaken a feeling of gratitude in those about us that will lead to increased interest and work. If we really have the devotion to the cause which we profess, we shall certainly make it manifest and others will catch something of the same spirit.

CONSTITUTION  
—OF THE—  
CENTRAL NEW YORK  
JUNIOR BRANCH OF THE WOMAN'S AUXILIARY.

Adopted at B'ngham'on, N. Y., May 12th, 1893.

ARTICLE I.

This organization shall be called the "Central New York Junior Branch of the Woman's Auxiliary to the Board of Missions."

ARTICLE II.

The object of this Organization shall be to interest and instruct the youth and children of the church in the mission work, and to impress upon them a sense of responsibility as baptized members of the same to assist in advancing the great object for which the Church was established.

ARTICLE III.

The Diocesan Branch shall consist of the District Branches corresponding to the six convocation Districts

ARTICLE IV.

The officers shall be a Diocesan Superintendent, appointed by the Diocesan President of the Woman's Auxiliary, and a Board of Managers, consisting of the Diocesan Superintendent and a District Superintendent from each district, who shall be appointed by the Woman's Auxiliary from her district.

ARTICLE V.

It shall be the duty of the Diocesan Superintendent to have entire management of the Junior work in the Diocese subject to the approval of the Diocesan President of the Woman's Auxiliary.

ARTICLE VI.

It shall be the work of each District Superintendent to take charge of the work in her district, under the supervision of the Diocesan Superintendent.

ARTICLE VII.

General meetings of the Diocesan Branch shall be held at the discretion of the Diocesan Superintendent with the approval of the Diocesan President of the Woman's Auxiliary.

ARTICLE VIII.

This constitution may be changed or amended by the Board of Managers at their discretion.

# CONSTITUTION

## OF THE

Woman's Auxiliary of the Diocese of Central  
New York to the Board of Missions.

Amended and Adopted at Annual Meeting held in St.  
Paul's Cathedral, Syracuse, May 24th, 1894.

### ARTICLE I.

This Association shall be known as the Woman's Auxiliary of  
of the Diocese of Central New York to the Board of Missions.

### ARTICLE II.

The object of this Association shall be to extend a knowledge  
of the work of the Church among the Churchwomen of the Dio-  
cese, to awaken greater interest and sympathy for her missions  
and missionaries, (such interest to be shown by earnest, practical  
work for them,) and to endeavor to promote spiritual life and  
activity among its members.

### ARTICLE III.

This Association shall be composed of six Districts, correspond-  
ing to the six Convocation Districts, each District electing its  
own officers and managing its own work, subject to the approval  
of the Diocesan President.

### ARTICLE IV.

SECTION 1. An Annual Meeting shall be held at some conven-  
ient date in May for the presenting of reports from District  
Branches, and for the transaction of such other business as may  
properly come before such meeting.

SECTION 2. A Semi-annual Meeting may be held in the Fall  
at the discretion of the President.

### ARTICLE V.

The Officers shall be a President, Vice-President, Correspond-  
ing Secretary, Recording Secretary and Treasurer, (appointed by  
the Bishop,) who with the several District Presidents shall con-  
stitute an Executive Committee.

## ARTICLE VI.

SECTION 1. The duty of the President shall be to preside at all meetings of the Association and have general charge of the work under the direction of the Bishop.

SECTION 2. The duty of the Vice-President shall be to preside in the absence of the President, and to co-operate with her in the general work of the Association.

SECTION 3. The duty of the Corresponding Secretary shall be to conduct the necessary correspondence of the Association under the direction of the President and to make an annual report.

SECTION 4. The duty of the Recording Secretary shall be to keep a record of the annual and semi-annual meetings, to call the roll at these meetings and to read such papers as may be ordered to be read.

SECTION 5. The duty of the Treasurer shall be to receive and hold all moneys sent to her by the District Treasurers, to disburse the same to the objects designated by the senders, viz: Diocesan or other Missions, Missionaries, Scholarships, etc., and to make an annual report.

## ARTICLE VII.

This Constitution may be altered or amended at any Annual Meeting by a vote of two thirds of the members present, subject to the approval of the Bishop.

## BY-LAWS.

SECTION 1. Special meetings may be called by the President at such time and place as she may designate for the purpose of stimulating interest in the work.

SECTION 2. The regular order of business at the annual and semi-annual meetings shall be:

1. Offices of Devotion.
2. Roll Call.
3. Reading of Minutes of Last Meeting.
4. Reports of Officers and Committees.
5. Unfinished Business.
6. Miscellaneous Business and Addresses.

SECTION 3. The By-Laws may be amended at any regular meeting by a vote of a majority present.

# CONSTITUTION

OF THE

## CENTRAL NEW YORK BRANCH OF THE WOMAN'S AUXILIARY.

---

Adopted at Annual Meeting held at St. Paul's Cathedral,  
Syracuse, Nov. 13, 1889.

---

### ARTICLE I.

This Association shall be known as the Central New York Branch of the Woman's Auxiliary to the Board of Missions.

### ARTICLE II.

The object of this Association shall be to extend the knowledge of the Mission Work of the Church among the Churchwomen of the Diocese, with especial reference to the necessities of the field in our own Diocese.

### ARTICLE III.

This Association shall be composed of six Districts, corresponding to the six Convocation Districts, each District electing its own officers and managing its own work—subject to the approval of the Diocese President.

### ARTICLE IV.

An Annual Meeting shall be held at the discretion of the Bishop, for the presenting of reports from District Branches and for the transaction of such other business as may properly come before such meeting.

### ARTICLE V.

SECTION 1. The Officers shall be a President, Vice-President and Secretary (appointed by the Bishop) who with the several District Presidents shall constitute an executive committee.

SECTION 2. The duty of the President shall be to preside at all meetings of the Association and have general charge of the work under the direction of the Bishop.

SECTION 3. The duty of the Vice-President shall be to preside in the absence of the President, and to co-operate with her in the general work of the Association.

SECTION 4. The duty of the Secretary shall be to keep a record of the annual meeting and conduct the necessary correspondence of the Association, under the direction of the President.

#### ARTICLE VI.

This Constitution may be altered or amended at any annual meeting by a vote of two-thirds of the members present, subject to the approval of the Bishop.

## BY-LAWS.

---

1. Special meetings may be called by the President at such time and place as she may designate, for the purpose of stimulating interest in the work.
2. The regular order of business at the annual meeting shall be:
  1. Offices of Devotion.
  2. Roll Call.
  3. Reading Minutes of Last Meeting.
  4. Reports of Officers and Committees.
  5. Unfinished Business.
  6. Miscellaneous Business and Addresses.
3. The By-Laws may be amended at any regular meeting by a vote of a majority present.
