All yearly reports MUST be sent to the District Secretary NO LATER than January 1st of each year.

Each Parish Branch should have its annual election of officers no later than December 15th of each year.

Answer all letters and inquiries promptly.

Please write at once to the Missionary, for whom you have been asked to supply clothing, stating when he may expect a box and from whom. As soon as a box has been shipped, please notify at once your District Supply Secretary by filling out the necessary card, giving its estimated value, plus parcel post, express or freight.

No credit can be given for boxes unless the work has been assigned by the Diocesan Supply Secretary.

Any assistance given Missions in the Diocese should be reported in the same manner as assistance given outside of the Diocese.

The fulfillment of these requests will greatly aid the Diocesan and District Officers in their work.



## MINUTES OF THE ANNUAL MEETING

The Annual Meeting of the Woman's Auxiliary of the Diocese of Central New York to the National Council was held in St. Peter's Church, Auburn, New York, May 22nd, 1931. The Holy Communion was celebrated by Bishop Coley at 10:00 A. M. The business meeting was called to order by the President at 11:00 o'clock.

Opening prayers were read by Bishop Coley who then congratulated the Auxiliary on its fine work in completing its gift for the church at Langell Valley, Oregon. He made special mention of the gift of an altar for this church from the Fourth District in appreciation of the life and work of Mrs. Hixson and Mrs. Clift.

The Rev'd Norton T. Houser, Rector of St. Peter's Church, gave a cordial greeting to the members of the Auxiliary.

The minutes of the Officers' Meeting of May 21st were approved as read.

The Treasurer read the amounts received from January 1st, for pledges and specials as follows:—

The reports of the District Presidents were the next order of business.

Mrs. Anna G. Huggins reported that the work has been progressing very favorably in the First District, and that the devotional life of the Auxiliary in this District is felt to have grown during the past year.

For the Second District, Mrs. W. B. Crouse reported increased interest and attendance in many of the branches, and the prospect of form-

ing two more branches. She also spoke of the necessity for interesting younger women in the Auxiliary work, whereupon it was suggested from the floor that in many places evening branches have been formed for younger women who cannot attend daytime meetings.

Work in the Third District was reported by Mrs. M. S. Ciscoe, who said that special interest had been shown in the educational program. Most of the branches reporting mission study have used the topic "India."

Enthusiastic reports of definite progress in all lines of endeavor were given by Mrs. Harry E. Clarke, President of the Fourth District. In this District the educational program has been planned with the special thought of reaching those not already interested.

Miss Bonker reported for the Fifth District that progress was being made and that they were all looking forward to a successful year.

At the conclusion of these reports Mrs. Hixson took the opportunity of saying that the total diocesan work has shown a remarkable record this year.

Noonday prayers were read by the Rev'd Mr. Houser.

Mrs. Clift then reported on the United Thank Offering, showing a total of \$29,331.13 on hand, which is \$3,000.00 more than at the same period of the last Triennium.

For the Corporate Gift, Mrs. Clift reported a total of \$2,846.30, with more in prospect. The Secretary read an article from The Oregon Trail Churchman describing the consecration of the Church of St. Barnabas at Langell Valley.

A summary of the Supply Secretary's report was read showing total box work of \$5,868.94 reported since January 1st.

Mrs. Thayer, retiring Educational Secretary, gave a summary of her report.

The Chair called on Mrs. Goodale to say a few words. Mrs. Goodale spoke of the fine record of progress in the Diocese and especially in the Fifth District. Speaking of the Clearing House, she said that old clothing could always be sent to the Reservation or to St. Philip's Church, Syracuse, where it could be sold and the proceeds used for the work.

Roll call showed 225 present.

An invitation was extended by Grace Church, Willowdale, to attend an afternoon meeting there on July 22nd.

Consideration of the proposed Constitution was the next order of business.

It was moved, seconded and carried that the Constitution be voted on as a whole. The Secretary then read the proposed Constitution.

Upon motion, all Articles of the Constitution were accepted as read. The Secretary then read the proposed By-laws.

Upon motion, the By-laws were accepted as read.

It was moved, seconded and carried that the Secretary send a note to Bishop and Mrs. Fiske regretting their absence.

The meeting adjourned for luncheon and re-assembled at 2:15 P. M., Bishop Coley reading the opening prayers.

Miss Charlotte Tompkins spoke briefly about the Skaneateles Conference to be held June 28-July 3, and invited the members of the Auxiliary to attend.

Mrs. Leland E. Palmer, incoming Educational Secretary, spoke of the work for the coming year, asking the continued co-operation of all

the members of the Auxiliary in the educational work. She said that there would be a special day, July 2nd, at the Skaneateles Conference when the two books for next year would be reviewed.

Miss Edna Eastwood, Secretary for Home Study at the Church Missions House, spoke of the ten thousand isolated adults and children in twenty-odd dioceses who were receiving religious instruction. She said that lantern slides showing the work among the isolated could be obtained from the Church Missions House.

Miss Edith Vrooman, who is leaving soon to become a United Thank Offering worker in Nevada, was presented to the meeting.

Mrs. Benson, Executive Secretary of the Church Mission of Help, thanked the Auxiliary for its splendid contributions to the work. She asked the co-operation of the Auxiliary in the efforts of this Society to gain a thousand new members this year.

The Ven. Harrison W. Foreman, Archdeacon of the Diocese of Erie, was introduced by the President. His theme was the Woman's Auxiliary and Rural Work. Speaking of what the Auxiliary has done in a national and promotional way in the rural field, he said that its book, "Beyond City Limits" had been the most widely studied text book throughout the Church in recent years, and that while it did not cover the situation, it had awakened great interest in the work in rural communities. The Woman's Auxiliary, through its gifts, has made it possible to send seminarians into the rural field for three months' work during the summer under trained workers. The Auxiliary has also fostered summer conferences dealing with rural work. After citing several instances of rural work in various parts of the United States, Archdeacon Foreman said in conclusion that a wonderful opportunity for the love and devotion of the Woman's Auxiliary was offered by the 25-35% of country boys and girls who are not going to church or Sunday School anywhere.

Mrs. Goodale spoke with deep appreciation of the devoted work of Mrs. Harry S. Thayer, the retiring Educational Secretary of the Diocese, and upon motion a rising vote of thanks was given Mrs. Thayer for her untiring efforts.

Mrs. Huggins invited the Auxiliary to hold its Annual Meeting in Trinity Church, Watertown, next May.

A rising vote of thanks was given to Archdeacon and Mrs. Foreman.

In appreciation of their cordial hospitality, a rising vote of thanks was offered to the women of St. Peter's Church and St. John's Church.

After the Benediction by Bishop Coley, the meeting was declared adjourned at 3:50 P. M.

# CONSTITUTION

---

## Article I. Name

This organization shall be known as the Woman's Auxiliary of the Diocese of Central New York to the National Council of the Protestant Episcopal Church in the United States of America.

## Article II. Objects

The objects of this organization are to unite the branches in a common interest; to promote the cause of Missions and Church Extension, Religious Education and Christian Social Service; to collect funds for these various purposes and to carry out the purposes and work of the Woman's Auxiliary as approved by the National Council.

## Article III. Membership

This organization shall be composed of the women of the Diocese representing the various Parish branches, organized in the five Convocation Districts of the Diocese, each District electing its own officers and managing its own work.

## Article IV. Annual Meeting

An Annual Meeting shall be held at some convenient date in May, this meeting, so far as the order may be followed, being held in each of the Districts, consecutively. Reports shall be presented by the Diocesan and District officers and such other business transacted as may properly come before such meeting.

## Article V. Officers

The officers shall be President, Vice-President, Secretary, Supply Secretary, Educational Secretary, Treasurer, and United Thank Offering Treasurer. These officers, with the Presidents of the Districts, shall constitute an Executive Committee. The District Presidents shall constitute the Nominating Committee. Other nominations may be made from the floor. Elections are subject however to the approval of the Bishop.

## Article VI. Election

Section 1. In elections, each parish branch represented shall have one vote.

Section 2. The election of officers shall be by ballot, a majority vote constituting an election.

Section 3. Any vacancy occurring in any office shall be filled for the unexpired term by the Executive Committee with the approval of the Bishop.

## Article VII. Fiscal Year

The Fiscal Year of this organization shall be from January 1st to December 31st.

## Article VIII. Amendments

This Constitution, with the approval of the Bishop, may be altered, amended or repealed at any Annual Meeting by a majority vote of the members present, when such amendments have been submitted in writing thirty days previous to the meeting and approved by the Executive Committee.

### BY-LAWS

#### I. Duties of Officers

Section 1. The President shall preside at all meetings of the organization and of the Executive Committee; call special meetings and have general supervision of the work.

Section 2. The Vice-President shall preside in the absence of the President and co-operate with her in the general work of the organization. In the absence of both the President and Vice-President the meeting shall elect and call one of the District Presidents to the chair.

Section 3. The Secretary shall send all notices, keep the minutes of the meetings and send a summary of the minutes of Executive Meetings to each member of the Executive Committee not present at such meeting.

Section 4. The Supply Secretary shall have charge of all box work, receiving allotments from the Woman's Auxiliary Supply Secretary at the Church Missions House and re-allotting the same. She shall make reports at Diocesan meetings and to the National Headquarters.

Section 5. The Educational Secretary shall co-operate with the Departments of the National Council and the National Educational Secretaries of the Woman's Auxiliary in their plans for education, adopting as far as possible, the study courses presented by them.

Section 6. The Treasurer shall receive all moneys contributed, except the United Thank Offering, disburse the same, keep a record thereof and make a report at Diocesan meetings.

Section 7. The United Thank Offering Treasurer shall take charge of all moneys contributed for that object.

#### II. Amendments

The By-Laws may be amended by a majority vote of the members present at any annual meeting, when such amendments have been submitted in writing thirty days previous to the meeting, and approved by the Executive Committee.
