Please see that all notices of meetings sent out by the Secretary are printed in Church Bulletins or read by your Rector at the Church Services.

Send all checks and money for **ALL** purposes payable to your District Treasurer. Designate to whom and for what purposes the money is sent. Remember your money will be sent to whatever cause or person you may designate.

As the fiscal year of the Protestant Episcopal Church ends December 31st of each year, the Woman's Auxiliary closes its books at the same time.

All yearly reports **MUST** be sent to the District Secretary **NO LATER** than January 1st of each year.

Each Parish Branch should have its annual election of officers no later than December 15th of each year.

Pay pledges promptly.

Answer all letters and inquiries promptly.

Please write at once to the Missionary, for whom you have been asked to supply clothing, stating when he may expect a box and from whom. As soon as a box has been shipped, please notify at once your District Supply Secretary by filling out the necessary card, giving its estimated value, plus parcel post, express or freight.

No credit can be given for boxes unless the work has been assigned by the Diocesan Supply Secretary.

Any assistance given Missions in the Diocese should be reported in the same manner as assistance given outside of the Diocese.

The fulfillment of these requests will greatly aid the Diocesan and District Officers in their work.

## MINUTES OF THE ANNUAL MEETING

The Annual Meeting of the Woman's Auxiliary of the Diocese of Central New York to the National Council of the Protestant Episcopal Church in the United States of America was held in Trinity Church, Syracuse, May 23, 1935.

Holy Communion was celebrated at ten o'clock by Bishop Fiske, assisted by Bishop Coley, Dean Leyfield, and Reverend Messrs. Cooper and Merriman.

In opening the business meeting, Mrs. Hixson welcomed us to the Fourth District and stressed the importance of the Diocesan meeting, asking that every branch try to be represented, even if it were only possible to send one woman.

The minutes of the Officers' Meeting of May 22nd were read and accepted.

Mrs. Manross expressed her thanks for improvements that the Auxiliary had made possible at the Onondaga Reservation.

Mrs. Hixson spoke of Bishop Fiske's letter urging our support and interest in the Forward Movement.

Letters were read from the Rev. E. Lee Rose thanking us for our support of the work in Sagada and from Bishop Colmore expressing appreciation for our choosing the Dispensary at Barahona, Puerto Rico, as part of our Corporate Gift.

Mrs. Stuart gave the treasurer's report from Jan. 1st to May 1st, 1935. Mrs. Stuart explained that undesignated pledges mean money from our pledges, which does not apply on the Church's program.

The U. T. O. Report was given by Mrs. Clift. Offerings amounting to \$1,513.82 have been received. Mrs. Clift urged each one to try to interest more women in the Blue Boxes.

Mrs. Mills told us of an interesting visit she made last March to the hospital at Raleigh, N. C., to see Claudia Beatrice Alston.

Mrs. Mills assured us that Claudia is well worthy of our interest, and that she is very appreciative of our efforts in her behalf. Mrs. Hornsby also spoke interestingly of a visit she made to this hospital and nurses' home.



The Rev. C. H. Leyfield, rector of Trinity Church, spoke a few words of welcome, and then said the noon-day prayers. Mrs. Hixson urged the Branches to undertake more supply work if possible, in order to complete our 1935 assignment.

The president then introduced the Rev. V. L. Dowdell, who told us of conditions in Puerto Rico, where part of our Corporate Gift is to be sent for a Dispensary. The standard of living in Puerto Rico is low and our money goes a long way there. The people are hungry for the Gospel and Mr. Dowdell urged us to pray more for Puerto Rico, and to give of our alms, as God has given to us, so that the ills of those people may be cared for and their spiritual life administered to.

Roll call showed 16 present from the First District, 48 from the Second District, 32 from the Third, 233 from the Fourth and 4 from the Fifth District, making a total of 333.

Adjournment for luncheon was made at 12:45 and the meeting was resumed at 2 o'clock. Opening prayers were read by Rev. C. H. Leyfield. Mrs. Hixson asked for co-operation from every district in the Prayer Partnership plan.

The president reminded us that credit could only be given to the branches for supply work that has been regularly assigned by the District Supply Secretary.

Mrs. Palmer gave the report for the Educational work from Jan. 1st to May 1st, 1935, which showed that 73 of our 122 branches had educational classes. Each branch was advised to have a member in charge of subscriptions to the Spirit of Missions and we were all urged to subscribe to the Church Messenger.

Miss Regina Lustgarten, the speaker of the afternoon, was introduced by Mrs. Hixson. Miss Lustgarten told us to remember that we are the result of a mission church and we must be interested in the Church's Mission, and if we expect Japan to treat us as she should, we must look for the best in Japan, and see that she may become a Christian Nation. We belong to one family, with God as our Father, and it depends on us today whether men and women know God. Miss Lustgarten urged us to think of our missionary work, not as a burden, but as a privilege, and not to think of our missionaries as people to be supported, but to consider them as friends, who are giving themselves to our work for the Master.

Mrs. Hixson announced that the next annual meeting would be held in the Fifth District, May 1936, place and date to be named later.

The total amount of the offerings was \$85.00. Mrs. Goodale took the chair for the election of officers. Mrs. Burke reporting for the nominating committee read the nominations for officers as follows:

Mrs. Goodale referred to the thirty-five years of service that Mrs. Clift has given as an officer of the Auxiliary and then presented a prayer book and hymnal to Mrs. Clift as a reminder of our love and appreciation.

Mrs. Hixson resumed the chair and thanked us for our confidence and co-operation.

Mrs. Goodale expressed our gratitude to Trinity Church for our entertainment and a rising vote of thanks was given.

Closing prayers were said by the Rev. W. M. Higley and the meeting adjourned at 3:30 P. M.

## CONSTITUTION

### Article I. Name

This organization shall be known as the Woman's Auxiliary of the Diocese of Central New York to the National Council of the Protestant Episcopal Church in the United States of America.

### Article II. Objects

The objects of this organization are to unite the branches in a common interest; to promote the cause of Missions and Church Extension, Religious Education and Christian Social Service; to collect funds for these various purposes and to carry out the purposes and work of the Woman's Auxiliary as approved by the National Council.

### Article III. Membership

This organization shall be composed of the women of the Diocese representing the various Parish branches, organized in the five Convocation Districts of the Diocese, each District electing its own officers and managing its own work.

### Article IV. Annual Meeting

An Annual Meeting shall be held at some convenient date in May, this meeting, so far as the order may be followed, being held in each of the Districts, consecutively. Reports shall be presented by the Diocesan and District officers and such other business transacted as may properly come before such meeting.

### Article V. Officers

The officers shall be President, Vice-President, Secretary, Supply Secretary, Educational Secretary, Treasurer, and United Thank Offering Treasurer. These officers, with the Presidents of the Districts, shall constitute an Executive Committee. The District Presidents shall constitute the Nominating Committee. Other nominations may be made from the floor. Elections are subject however to the approval of the Bishop.

### Article VI. Election

Section 1. In elections, each parish branch represented shall have one vote.

Section 2. The election of officers shall be by ballot, a majority vote constituting an election.

Section 3. Any vacancy occurring in any office shall be filled for the unexpired term by the Executive Committee with the approval of the Bishop.

### Article VII. Fiscal Year

The Fiscal Year of this organization shall be from January 1st to December 31st.

### Article VIII. Amendments

This Constitution, with the approval of the Bishop, may be altered, amended or repealed at any Annual Meeting by a majority vote of the members present, when such amendments have been submitted in writing thirty days previous to the meeting and approved by the Executive Committee.



## BY-LAWS

---

### I. Duties of Officers

Section 1. The President shall preside at all meetings of the organization and of the Executive Committee; call special meetings and have general supervision of the work.

Section 2. The Vice-President shall preside in the absence of the President and co-operate with her in the general work of the organization. In the absence of both the President and Vice-President the meeting shall elect and call one of the District Presidents to the chair.

Section 3. The Secretary shall send all notices, keep the minutes of the meetings and send a summary of the minutes of Executive Meetings to each member of the Executive Committee not present at such meeting.

Section 4. The Supply Secretary shall have charge of all box work, receiving allotments from the Woman's Auxiliary Supply Secretary at the Church Missions House and re-allotting the same. She shall make reports at Diocesan meetings and to the National Headquarters.

Section 5. The Educational Secretary shall co-operate with the Departments of the National Council and the National Educational Secretaries of the Woman's Auxiliary in their plans for education, adopting as far as possible, the study courses presented by them.

Section 6. The Treasurer shall receive all moneys contributed, except the United Thank Offering, disburse the same, keep a record thereof and make a report at Diocesan meetings.

Section 7. The United Thank Offering Treasurer shall take charge of all moneys contributed for that object.

### II. Amendments

The By-Laws may be amended by a majority vote of the members present at any annual meeting, when such amendments have been submitted in writing thirty days previous to the meeting, and approved by the Executive Committee.
