## PRESIDENT'S REPORT.

In reviewing a year in the life of the Woman's Auxiliary, there is usually some out-standing accomplishment or event.

The year 1920 was no exception.

The most important task assigned to the Auxiliary this past year by the National Executive Board, was to bring about, as far as lay within its power, the formation of the Church Service League in every Diocese.

The Chicago Branch of the Woman's Auxiliary accepted this responsibility, and at that splendid meeting of the Churchwomen of Chicago on January 12th, the League was most auspiciously launched in this Diocese. It was the result of much prayerful thought and careful planning.

In the preparatory work your president attended many conferences—with our two Bishops, with the officers of the Women's National organizations represented in this Diocese, and with other women prominent in the work of the Church.

Beside assisting in the consummation of this plan of the National Committee, our branch has made distinct contribution to the Church Service League in turning over to it two departments well equipped and doing fine work, the Social Service and the Religious Education Departments. These two Departments are under the able leadership of their respective chairmen—Mrs. George Pollock and Mrs. Charles W. Scott.

There have been two changes in the personnel of your Executive Board this year. One was occasioned by the removal from the Diocese of Mrs. J. W. Burt. She had done a real constructive work and her going was greatly regretted.

She was succeeded by Mrs. George Mason, whom Mrs. Burt herself had succeeded. Mrs. Mason was warmly welcomed on her return to the Board, and re-assumed the duties of her office in her usual capable way.

The other vacancy was caused by the death of our very efficient chairman of the Department of Religious Education, Miss Clara Griswold. She brought to her work a loyalty and a self-sacrificing spirit which was an inspiration to all of her co-workers. Her abiding faith and trust in Our Heavenly Father made her passing from this life into the Church Expectant as beautiful as her life of devoted Christian service had been in the Church Militant.

Her department is now under the leadership of Mrs. Charles W. Scott, who with her enthusiasm and intelligent grasp of the work has, in this short time, produced telling results.

Our program for the monthly meetings has been carried out as planned. We have had three representatives from the Church Missions House, the Rev. Mr. Burgess, presenting to us the Americanization work of the Church; Mrs. Biller, in the interests of the Church Service League, and Miss Hendricks, Recruiting Secretary of the Board. The Junior Auxiliary presented a very interesting program—the last before their transfer to the Church School Service League.

The five fields of service have been outlined at these meetings—the Parish, in our conferences on Presidents' Day, The Diocese on Bishop's Day, the Community, by the Social Service Department, The Nation, in

the vision given us by Mrs. Biller, and the World, in the Rev. Mr. Flemming's graphic account of the Lambeth Conference and the Anglo Catholic Congress.

The Annual Presentation of the United Thank Offering was made at LaGrange. It had a three-fold interest this year. It was a Memorial Service for our beloved former president, Mrs. Greeley; it was the presentation of the Offering which was so near to her heart and which is to be used in part toward the Florence Greeley Memorial—and at the afternoon meeting, we were addressed by a United Thank Offering Missionary, Miss Whitley of Urbana.

The Annual Day of Prayer at Christ Church, Winnetka, conducted by the Rev. Mr. Way, was very well attended and gave us the keynote for the year's work.

Three new branches have been organized this year: one at All Saints, West Pullman; one at Harvey, and one, only last week, at the Church Home for the Aged, with an enrollment of thirty-two members. It was a rare privilege to go to the Home and to help the devout and faithful women there organize this new branch. Through their own branch they will feel the contact with the Diocesan and General work, and their interest in the advance of Christ's Kingdom, which many of them had in their earlier life, will be kept alive and active.

Two branches which have been dormant for several years have awakened and taken on new life.

Your president has visited eighteen branches this year; she now has visited just one more than half of the organized branches in the Diocese.

She has had thirteen conferences with individuals and committees, attended the Racine Conference, the meeting of the House of Church-women in Grand Rapids, and four meetings of the Missions Committee of the Bishop and Council.

You have heard the Annual letter from Miss Lindley and will observe that we have already complied with several of the requests therein made.

First: The report of the Chairman of the United Thank Offering shows that the interest in this offering is ever increasing.

Secondly: A Chairman has been appointed for the Emery Fund and a good beginning has been made in the raising of our share in this most worthy enterprise. This, with the United Thank Offering and the Florence Greeley Memorial, must be our three objects for the coming year.

Third: The Social Service Department has been working along the lines of the betterment of conditions for women and children.

Fourth: We have already taken our part in establishing the Church Service League in this Diocese as requested in the annual letter, and

Fifth: The need for educational work is ever kept before us.

The Supply Department, under the splendid guidance of Mrs. Ruthven Deane, is meeting the requirements called for in its re-organization, and another year will see it fully organized and better equipped than ever before to meet the needs of the missionaries in their work.

I wish to express my appreciation of the hearty co-operation of the members of the Woman's Auxiliary which has brought about these results and the patience with which you have met the delays caused by the

adjustments made necessary by the re-organization. To the Executive Board, with which it has been my great privilege to work this year, I extend my sincere gratitude for the loyalty and devotion with which they have served.

We all looked forward to the year 1920 with not a few misgivings and with some trepidation on account of the re-organization of women's work in the Church, but God has blessed the work and we may look back upon the year as one of definite accomplishment.

May the year 1921 see the Woman's Auxiliary to the Presiding Bishop and Council settled into a normal course after four years of stress and reconstruction and re-organization, and may it bring greater effort in the endeavor to carry out Christ's Great Commission.


A motion that the Secretary cast the ballot for the ticket as presented was seconded and carried.

Pop: 11,880



#### REPORT OF MONTHLY MEETINGS, 1919-1920.

Eight meetings have been held in Washington Hall, State-Lake Building, with an attendance of 1305—an average of 163 from 48 parishes.

The offerings have been \$476.00.

The Corporate Communion Service, a Memorial to Mrs. Frederick Greeley, was held in Emmanuel Church, LaGrange, on May 29th, with an attendance of 375.

The United Thank Offering presented at this service, \$3,574.63.

The Day of Prayer was conducted by Rev. Wm. C. Way in Christ Church, Winnetka, on September 30th. There were 125 present. The offering of \$52.20 was given to the Greeley Memorial.

The Executive Committee has held ten meetings.

### REPORT OF THE CHURCH SERVICE LEAGUE.

In the absence of Bishop Anderson, a call was sent out by Bishop Griswold to representatives of the four national organizations of women working in the Diocese—The Girls' Friendly Society, The Daughters of the King, The Church Periodical Club, and the Woman's Auxiliary—asking them to come together for the purpose of forming a nucleus of the Church Service League. At this informal meeting, attended by representatives from each of these organizations, temporary officers were appointed by Bishop Griswold and tentative by-laws were read and adopted.

Later in the summer, Bishop Anderson added to this small body a group of members at large, composed of women active in various lines of church, civic and general philanthropic work, and called them together for a first regular meeting of the Diocesan Council of the Church Service League early in November, at which time the Departments of Supply, Religious Education and Social Service were formed, and chairmen appointed.

Programs of work have already been inaugurated by these departments and another year's report should show definite results.

On January 12th, 1921, the first annual meeting of the Church Service League was held in Washington Hall, State-Lake Building, with a most gratifying attendance. The invitation had been extended to "all women interested in service for others" and the number who responded, filling the hall to overflowing, gave practical demonstration of their interest in this subject. While it was much to be regretted that some should have been obliged to stand during the meeting and addresses, and the committee in charge sincerely deplores anyone having suffered this inconvenience and fatigue, yet that great interested gathering was a most encouraging sight.

Bishop Anderson presided, conducting the brief business of the occasion, which involved the election by the meeting of the officers and other members of the Diocesan Council, who had previously been appointed as such by the Bishop, pending the action of this meeting, and the adoption by vote of the meeting of the suggested by-laws.

Then followed an address by Bishop Anderson on the topic "What Does the Church Service League Mean?" and one by Miss Grace Lindley, Executive Secretary of the Woman's Auxiliary, on "The Church Service League in Action." Both of these addresses were so clear, so forceful and so inspiring they could not fail to carry to every hearer a conviction that the project was indeed to be a mobilizing of the women of the Church for the work of the Kingdom.

In order to secure a financial backing, the Council of the Church Service League has inaugurated a plan for carrying on a sale of pencils throughout the Diocese, the proceeds to go into the Treasury of the League, to defray current expenses of printing, postage, and other items, and also to form a fund with which to purchase materials at wholesale for sending out to parish units, as well as such articles as shoes, stockings, etc., which are needed to make up the contents of missionary boxes.

It is earnestly hoped that each parish representative will undertake to dispose of at least as many pencils as there are communicants, and

as these have been readily sold in other Dioceses for this cause, there should be no reason why the Diocese of Chicago should not be able to carry this simple project for raising funds to a successful issue. Mrs. F. H. Bartholomew, Treasurer of the Church Service League, is in charge of the sale, and will be glad to supply the pencils to all parishes not already furnished with them.

A number of parish units of the C. S. L. have already been formed, and the Bishop has expressed his intention of shortly addressing a letter to the clergy, commanding to them the plan of organizing such units in their parishes, so that undoubtedly many more will soon come into being. These units may bear any preferred title, calling themselves what they will, the only condition of membership in the Church Service League being that some work must be done in each of the five fields of service during the course of the year, and that the name be reported to the Secretary of the Diocesan Council.

No matter what the machinery of administration may be, nor how well organized the Diocesan Council of the League, it will be of no worth without the parish units, for in the parishes and the women of the Church lies the strength of the Church Service League.

Therefore we earnestly hope that more and more, as these weeks go by, we shall hear of parishes co-operating in this effort to enlist all the resources of women's work for the task which is before our church in setting forward Christ's Kingdom on earth.

#### REPORT OF SOCIAL SERVICE COMMITTEE.

During Lent we held study-classes under Dr. Ross on Fridays at the Church Club Rooms. Twenty-three parishes were represented; the attendance averaged 30. Five parishes contributed \$7.00 apiece in support of Greek children for whom Dr. Ross requested it.

We held two other meetings; Mrs. Joseph T. Bowen spoke to us on the bond issues then before the electorate and Miss Fulmer, superintendent of Cook County nurses, talked on our county institutions at the first meeting. Much interest was aroused in soldiers at Oak Forest.

There were fifty people present at our May luncheon at the Woman's City Club, when Mrs. Kenny told us of the Vocational Training Bureau, and spoke of the need of money to keep delicate children at home and school instead of at work. Ten parishes pledged \$10.00 a piece; it was paid in full this fall.

We tried to arrange for entertainments at Oak Forest; the parishes could not give them in the summer and this fall it did not suit Mr. Bailey, the superintendent. He has agreed we may have a musical for the blind. Three of us went, in May, to The Chicago and Cook County Home for Boys at Riverside and took a foot-ball. Adjourned until fall.

In December, Miss Houghteling talked to the Diocesan branch of her work with The United Charities. Mrs. Duyzers addressed us also, briefly, on the Christian work among the Jews of Chicago.

You kindly gave us \$50.00 at this meeting. \$10.00 we gave Miss Houghteling; \$10.00, Mrs. Duyzers; with \$18.00 we bought kindergarten chairs for children at Oak Forest. With \$5.00 and much work and interest from Mrs. Austin in Riverside, our Social Service chairman, we gave many games and playing cards to Mr. Milliken for The Chicago and Cook County Home for Boys. She also reported the need for a Protestant minister's services for the boys.

Miss Prentiss of the Social Service Department of Cook County Hospital, asked us for an entertainment for Ward 43. Largely through the kindness and able assistance of Mrs. H. E. Mason of Highland Park, and Mrs. Phillips of Saint Paul-by-the Lake, we had this entertainment. We sang carols and songs with the women and girls and distributed cake, ice cream and candy in tarleton bags contributed by Mrs. Mason.

At present, Mrs. Joseph T. Bowen and Mrs. Ira Couch Wood, assisted by Dr. Caroline Hedger, are giving lectures on "Child Problems" at the Art Institute. We've had from 44 to 60, with 20 parishes represented. We are deeply indebted for these lectures, as our only part was to advertise and attend them.

Through the great activity of Mrs. Frederick Test, chairman of our "Committee for Recreational Work for the Blind," all the blind assigned us have been assigned different parishes for friendly visitors and reading.

On February 15, 22, and March 1, 8, 15, the United Charities are to give us a course of lectures at the Y. W. C. A., 59 East Monroe Street, at 11:00 A. M., just before the noon-day service.

We have chairmen for 27 parishes.

We need a stenographer, people to address and send out notices, and a place to hold meetings.

We hope to hold a meeting soon for all workers with the blind, to be addressed by Miss Campbell, superintendent of The Illinois Society for the Prevention of Blindness.

We want to take a survey for Mrs. Joseph T. Bowen, if we get enough of an organization.

## REPORT OF CHURCH SCHOOL SERVICE LEAGUE.

At the last annual meeting of the Woman's Auxiliary, the report given for the Junior Department related that this diocese had accepted the suggestions of the Triennial of 1919, in that the Junior Auxiliary be merged into the Church School Service League. A new future was at that time opening for this important branch of the Church's work.

The year 1920 has been the formative period for the establishment of the Church School Service League.

The name Church School Service League indicates the unity of the League with the Sunday session of the Church School, and is virtually the School in week day activity, emphasizing SERVICE instead of INFORMATION. Because of this necessarily close connection, in the Church School, of religious service with religious information, the department of the Church School Service League was correlated with the Department of Religious Education, and it is under the Department of Religious Education of the Diocese that the Church School Service League has its authority for operating.

Early in 1920, four members were placed on the department for the purpose of organizing the Church School Service League in the Diocese. These members were Rev. Charles H. Young, Mrs. W. S. Bishop, Miss Ellen Van Schaick and Mrs. Curtis B. Camp, the latter named as Diocesan Director of the Church School Service League.

This committee outlined a plan for an organization for the Diocese along the lines of Miss Withers' "In the Service of the King," which is briefly explained as follows:

There are six grades, or cycles, in the League, corresponding to the various ages of children throughout the Church School. Each cycle is in charge of a Secretary, who is responsible for the plans of work for that particular cycle, and who is anxious to give such assistance as is needed in carrying out the plans in the parishes. The Secretaries are:

A program of work for the five fields of service—Parish, Community, Diocese, Nation, World—divides the year into five blocks.

A general Diocesan meeting of the Church School Service League Workers is held at the beginning of each block, when definite suggestions are given for the work of that block, by each of the Cycle Secretaries.

The Church School Service League Committee of the Department of Religious Education, under authorization of the Bishop and Council, prepared and printed for distribution a pamphlet, which gives all the concrete information as to how the League operates in a parish. There is a devotional section, a work section and block program for each of the six cycles, or grade, of young people.

A great deal of interest has been manifested since the publication of this pamphlet in November.

Forty-one parishes have responded to the request for an appointment of a parish director of the Church School Service League.

Under a report of activities in the five fields of service since the organization of the Church School Service League we submit the following:

In Block I. Opening of School to Advent.

Community work represented by Thanksgiving baskets sent from nearly all parishes.

Nation work represented by 4,000 gifts in missionary boxes sent from 47 parishes.

In Block II. Advent to Epiphany.

Diocesan work represented by slip attached, from 100 parishes.

In Block III. Epiphany to Lent.

Nation and World work represented by mission study and missionary plays.

In Block IV. Lent to Easter.

Nation and World work will be continued through mission study and plays.

Parish work will be represented by attendance at Lenten Service and attention to Mite Boxes.

There is no financial report of the Church School Service League, as it has been considered best to train the children to give through the Church School in duplex envelopes, and all funds would go through the Church School Treasurer in the regular manner.

It would seem that in this one year of our existence, the Church School Service League has made a firm foundation, and with the continued support of the Woman's Auxiliary, the inspiration for service among our boys and girls will be increased greatly, so that the Church School Service League will become a great factor in making our future men and women anxious to give continued service to the Church.

#### REPORT OF THE CHURCH PERIODICAL CLUB.

At the close of the General Convention of 1919 the Church Periodical Club entered a new phase of life as the organization of the Church Service League opened new fields of work and created a closer bond of union with the other great National Organizations.

During the year 1920 the Periodical Club has been following the plan suggested by the National Committee and has worked successfully in the "Five Fields" of Service.

In the Parish the Librarians have been urged to help the Church Schools with illustrated matter for lessons and in turn obtain material for other schools. To collect data for the Parish Study Class and when possible to act as the Librarian. To this end each Librarian has been furnished with a list of the leaflets published by the Literature Department.

In the Diocese and Community—Sent literature to the Deaconesses for the Institutions. Co-operated with the Educational Secretary. Sent letters to Woman's Auxiliary offering help and material for Study Class Work. Supplied two of the Visiting Committee with data and illustrated note books.

In the Nation—Sent magazines, books and illustrated matter to schools, hospitals and private individuals throughout the country.

World—Books and magazines to Africa, China and Japan.

Our Needs—More women to act as Librarians. At present we have 26 enrolled but want one in every parish. Money to help purchase books for the new St. Paul's Library at Tokyo. Magazines for our many needy friends. The help of every parish branch of the Service League.

The Church Periodical Club wishes to co-operate with all parish and Diocesan Organizations and to that end asks for suggestions on new lines of work.

## ARTICLES OF INCORPORATION.

STATE OF ILLINOIS, } ss.  
COUNTY OF COOK,

To James A. Rose, Secretary of State:

We, the undersigned, Marie M. Hopkins, Emily Pardee Street and Frances E. McDermid, citizens of the United States, propose to form a corporation under the Act of the General Assembly of the State of Illinois entitled, "An Act Concerning Corporations," approved April 18, 1872, and all acts amendatory thereof, and that for the purpose of such organization, we hereby state as follows:

I. The name of such corporation is

**"The Chicago Branch of the Woman's Auxiliary to the Board of Missions."**

II. The object of this corporation shall be: (a) To interest all of the congregations in the Diocese of Chicago in the different branches of missionary work, as conducted by the General and Diocesan Boards, and to the purpose of aiding said societies in carrying on the said missionary work in connection with the said Diocese and the said General Church. (b) An Auxiliary to the General Board of Missions and to the Board of Missions of the Diocese of Chicago of the Church known in law as "The Protestant Episcopal Church in the United States," and its management is to be in accordance with the constitution and canons of said Diocese of Chicago and of said Protestant Episcopal Church and not for pecuniary profit.

The corporations shall have power to receive donations, subscriptions, legacies and bequests to be used for the carrying on of the said missionary work and of the said Church in the said Diocese of Chicago and of the missionary work under the jurisdiction of the General Board of Missions of the Protestant Episcopal Church of the United States.

III. The Board of Managers shall have power to organize branches or recognize existing branches in every parish or mission in said Diocese under the rules as they may adopt from time to time. Any branch so organized, upon payment of the Annual Membership Fee, to be fixed from time to time by the By-Laws, shall be entitled to representation at the meetings of this Board, each Parish or Mission voting as a unit when demanded by two Parishes or Missions.

IV. (1) The officers of the Society shall be a Patron, a President, not less than five (5) Vice-Presidents, a Corresponding Secretary, a Recording Secretary and a Treasurer. (2) The Bishop of the Diocese shall be the Patron ex-officio.

V. The management of The Chicago Branch of the Woman's Auxiliary to the Board of Missions shall be vested in an Executive Board of not less than nine (9) nor more than eighteen (18) Directors, of whom the Patron, the President, the Vice-President, the two Secretaries and the Treasurer shall be a part.

VI. (1) The Board of Directors shall consist of not less than nine (9) nor more than eighteen (18) members, of whom the Bishop of said Diocese of Chicago shall, ex-officio, be one. All of the elective Directors shall be elected at the annual meeting of said corporation, which shall be held on the day after the close of the Diocesan Convention, except when the day falls on a legal holiday, when the Executive Committee of the Board shall appoint another day for the election of officers. The number of said Directors may, with the approval of the Bishop from time to time, be varied, and the Directors shall be elected in accordance with the statutes of the State of Illinois, and the By-Laws of said corporation, to be hereafter adopted. The Executive Committee shall meet monthly, except during the months of July and August.

(2) The Executive Committee shall have power, as necessity may arise, to appoint annually, with the approval of the Bishop, other officers, who shall not, however, be members of the Executive Committee.

(3) The duty of the President shall be to preside at all meetings of the Association and of the officers, to arrange for the organization of branches, to visit the same and to have the general charge of the work under the direction of the Bishop.

(4) The duty of the Vice-Presidents shall be to choose one of their number to preside in the absence of the President, to co-operate with her in the general supervision of the work of the Association and to take charge of the departments of work to which they may be assigned by the Executive Committee.

(5) The duty of the Corresponding Secretary shall be to conduct the necessary correspondence required by the Auxiliary, and to prepare such reports as are needed. The duty of the Recording Secretary shall be to send out notices of all meetings, to keep a record of the same, and to assist the Corresponding Secretary in the preparation of reports.

(6) The duty of the Treasurer shall be to receive all special and general funds; to disburse the former as the donors indicate, and the latter under the direction of the Executive Committee, and to render an account of the same at the annual meeting.

(7) There shall be a committee of two appointed to audit the Treasurer's accounts each year.

VII. The following persons are hereby selected as the directors to control and manage said corporation for the first year of its corporate existence:

Eleanor M. Duncombe, Vice-President.

Addie S. Chenoweth, Recording Secretary.  
Emma J. Hoyne, Treasurer.

The said Directors shall hold office until the next annual meeting of said corporation and shall then be elected at the said annual meeting herein provided.

VIII. The Bishop of the Diocese of Chicago shall ex-officio be the Patron of the said corporation, and all of the acts of the Executive Committee and Society shall be subject to his approval.

IX. These Articles of Incorporation may be altered or amended at any annual meeting by a vote of two-thirds of the members present, subject to the approval of the Bishop, and by complying with the statutes of the State of Illinois.

X. The location is in the Diocese of Chicago, in the County of Cook, in the State of Illinois, and postoffice address of its business office is at No. 510 Masonic Temple, State Street, Chicago, Illinois.

## BY-LAWS.

I. The election of officers at the annual meeting shall be by ballot, each Parish or Mission having one vote.

II. When a vacancy shall occur in the Executive Committee by death or resignation, or removal of residence from the Diocese, the members of said Committee shall have power, with the advice and consent of the Bishop previously obtained, to appoint an officer to fill the vacancy. The officer so appointed to serve until the next annual meeting.

III. Special meetings shall be called by the President, at such time and place as he may designate, for the purpose of stimulating interest in the work.

IV. It shall be the duty of every parochial branch to contribute annually a sum of money, the amount thereof to be determined by itself, to the Executive Committee of this Diocesan Branch, to be appropriated by them according to their discretion in the missionary work of the Church, which money shall constitute the General Fund of the Chicago Branch, and shall be so designated by the contributors.

V. The regular order of business at the annual meeting shall be as follows:

1. Office of devotion.
2. Calling of roll by branches.
3. Reading of minutes of last meeting.
4. Reports of officers and committees.
5. Election of officers.
6. Unfinished business.
7. Miscellaneous business and addresses.

VI. These by-laws may be amended at any annual meeting by a majority vote of the branches present.

Amendment to By-Law VI. The Annual Day of Prayer for Missions; the Annual Meeting; the Executive Committee and Monthly Meetings, heretofore held on fixed dates, will be subject to change, and for a sufficient reason may be held on dates to be determined by a majority vote of the Executive Committee, due notice of such change being given to all parochial branches.

VII. The Treasurer shall furnish bond for such amount as shall be determined by the Executive Committee, such bond to be paid for from the funds of the Woman's Auxiliary.

The Annual Meeting is held on the day after the close of the Diocesan Convention.

A meeting of the Diocesan officers is held on the first Thursday of each month.

Different branches are asked to co-operate with the President in taking charge of the noon-day meetings. Interesting papers are read and missionaries speak on the work in their jurisdiction.

It is hoped that each branch will send at least two representatives to these monthly meetings.
