## PRESIDENT'S REPORT.

The close of the year 1921 completes my third year as President of the Chicago Branch of the Woman's Auxiliary.

My heart is full of thankfulness and gratitude for the work which we have been permitted to do together.

During the trying years of readjustment after the great World War, the Woman's Auxiliary has kept the faith and has gone on with an ever-widening vision of the work which God has called us to do.

A review of the year shows a very greatly increased interest by an ever-growing body of women in winning the world for Christ.

The Chicago Branch has carried on its work this year, under the new plan, in three departments—Missions, Social Service and Religious Education. The new machinery set in motion two years ago does not yet run with perfect smoothness, but adjustments are being made which are steadily improving its effectiveness.

The Woman's Auxiliary has financed the Supply Department and the Social Service Department this year, both of which are really parts of the Church Service League.

It has been auxiliary to the Bishop and Council in study, in prayer and in gifts of service and money.

We have had eight monthly meetings with very gratifying attendance. We have been able to carry out our program exactly as outlined, owing in several instances to Mrs. Kirkland's indefatigable zeal and her "compelling" power as correspondent. Expressions of appreciation of the help and inspiration which these meetings have been, have reached me again and again.

Two events of the year stand out as deserving of special mention: the very helpful Day of Prayer held at the Church of the Atonement, with Dr. Arthur Rogers of St. Mark's Church, Evanston, leading, and the Presentation of the United Thank Offering at St. Luke's Church, Evanston, during the pageant "The Oblation of the Cross." This beautiful pageant was prepared by the four Parishes of Evanston under the skillful direction of the Rev. Morton Stone of the Church of the Nativity, Chicago.

Our United Thank Offering is steadily growing; it has already exceeded the total of our Diocesan offering at the last Triennial. With eight months more in which to give expression of thankfulness to God for His many mercies to us, we ought to be able, at the next great service of presentation, at Portland, to place on the alms basin a very much larger sum than we did at Detroit.

The Emery Fund claimed special attention this year. The interest on this fund will be used to provide spending money for missionaries at home on furlough. We are happy in having a goodly share in the \$91,000 to which the fund has grown. To this amount has been added a beautiful country home for the use of these faithful missionaries.

It must have been a source of great happiness to Miss Julia Emery, for whom with her two sisters this fund was named, that she lived to see its completion. She was laid to rest in the churchyard of the Church at Scarsdale, New York, on the 19th of January, on a beautiful winter afternoon just at sunset. Bishop Rowe, one of our great missionary bishops, officiated.

In Miss Emery's death the Auxiliary has lost a friend whose interest in our work dates back to the very beginning and who stood closer to women workers all over the country than any other woman.

Under Mrs. Deane's able direction, we filled the quota assigned to us by the Supply Department in New York.

Our missionary boxes have been carefully prepared and must have brought joy and satisfaction to many missionaries who are carrying on our work in various mission stations.

We have overpaid all of our pledges. Our Treasurer's reports are always thrilling. They take us far afield and bring to us a realization of the fact that we are having a part in extending Christ's Kingdom to all the world.

As President of the Auxiliary, I have attended all of the monthly meetings, all but two of the Church Extension meetings of the Bishop and Council, visited twenty-one branches, held nine personal conferences, attended three meetings of the Church Service League, three of the Nation-Wide Campaign Committee of the Diocese, one meeting of the Daughters of the King, and was the speaker at one of the Girls' Friendly Society Training Classes.

Again I must voice my appreciation of the very hearty co-operation with which you have carried on the work in every department, and the ready response with which you have met every appeal.

To my co-workers on the Executive Board I extend my thanks for their loyal support and the very efficient way in which every member has carried her responsibilities.

May God bless the work and workers in the coming year.


The Chair called for nominations from the floor. There being none, the above ticket was duly elected.

# MAP OF DIOCESE OF CHICAGO


TOTAL AREA: 15,328 Sq. M

POP: 112,840





## THE DEACONESS AID FUND.

During the year 1921 pledges to the Deaconess Aid Fund from twenty-eight (28) parish branches have amounted to \$325.00, special gifts to \$144.75, which includes \$50.00 sent in response to Christmas appeals, making a total of \$469.75. #### REPORT OF THE CHURCH SERVICE LEAGUE.

The Church Service League, formed to co-ordinate all the work done by the women of the Church in the Diocese of Chicago, has made a steady if not rapid progress during the past year.

Eighteen (18) Parish Units have been formed and reported to the Secretary, and there are undoubtedly others which have not yet registered their names. Some of these Units are exceedingly comprehensive, actually including most of the women of the parish in one form or other of their work. Others are feeling their way toward a larger development. But it seems as if the general plan were proving helpful and efficient and bringing more and more women into some form of service for the Church.

The Annual Meeting was held on January 12th, with an attendance of one hundred six (106) from thirty (30) parishes, Bishop Anderson presiding and several of the clergy appearing to be interested in the reports and discussion.

Miss Edna Foley, who is Chairman of the Committee on Nurses, reported that a special service had been held on the Sunday nearest the Florence Nightingale anniversary, in the Church of the Epiphany, at which a large number of nurses were present and Bishop Anderson had preached the sermon. It is hoped to make this an annual event.

Deaconess Fuller, representing the Order of Deaconesses on the Council of the Church Service League, reported that a quiet day for women had been held in the Chapel of Epiphany Church which had been of much spiritual value and helpfulness.

Reports of great interest were presented by the heads of the national organizations in the Diocese: The Girls' Friendly Society, Woman's Auxiliary, Daughters of the King, and the Church Periodical Club, each one having a record of fine accomplishment.

The reports of three departments, Supply, Social Service, and Religious Education, made an inspiring part of the program.

It is hoped that many more parishes will, during the coming year, form units of the Church Service League, and any member of the Diocesan Council of the League will gladly assist in any desired way to this end, by visiting the Parish and giving such suggestions as may be needed. Shall we not have fifty instead of eighteen units registered at the next annual meeting?

#### REPORT OF SOCIAL SERVICE COMMITTEE OF THE CHURCH SERVICE LEAGUE, DIOCESE OF CHICAGO.

January 1921-1922.

During February and March the United Charities gave us a most instructive course of five lectures at the Y. W. C. A. Thirteen to twenty-six attended.

March 26th the Committee of Recreational Work for the Blind had an enthusiastic meeting at the Chicago Woman's Club. Twenty-six people were present. Miss Campbell, of the Illinois Society for the Prevention of Blindness, addressed us. Under the able leadership of Mrs. Frederick Test sixty blind have been visited by members from eighteen parishes. Where needed the visits are continued. One lady told me she would not give up her blind friends for anything.

April 18th we held our first business meeting. Fifty people were present, representing twenty parishes. Mrs. Broomell of the Atonement was elected Vice Chairman. Miss Reardon Corresponding Secretary, Mrs. Oliphant Recording Secretary, and Mrs. Robinson of the Daughters of the King, Treasurer. We voted to have three meetings a year, with annual dues of \$2.00 from each parish. Three minute reports were requested from all parishes, and 27 responded, either verbally or by sending in written reports.

Miss Harriet Houghteling spoke splendidly on the work of the Y. W. C. A.

We have 45 chairmen from the parishes, some being Auxiliary presidents, and are in touch with 52 women interested in Social Service, representing as many parishes, out of a list of 94.

Our second meeting was held October 31st in the Church club rooms. About sixty were present, representing 20 parishes. Mrs. David Thomas of St. Chrysostoms was elected Treasurer and Mrs. Ainsworth of Trinity Recording Secretary, to take the places of Mrs. Robinson and Mrs. Oliphant, resigned. Dr. Stewart of St. Luke's, Evanston, and Mr. Hunter of the United Charities, spoke to us.

Under the efficient leadership of Mrs. Taylor of the Atonement, splendid work has been done for the Illinois Eye and Ear Infirmary.

Visits have been made to the Hospital twice a month, and toys and games taken. Ten parishes have aided Mrs. Taylor, and she has collected \$131.75 to buy playground equipment for the Hospital, and Deaconess Fuller's Playground at the Mission House. This Committee is now under Mrs. Legrand Smith of LaGrange, who has semi-monthly trips to the Hospital arranged till February 15th. Mrs. Taylor is to have charge of recreational work for the blind, Mrs. Test resigning.

During the Summer our Committee to aid The Chicago Flower Mission under Mrs. Davies of St. Barnabas, sent enough flowers for 650 bunches, which were distributed in the Hospitals. Our ladies aided in arranging and distributing. The Mediator, Morgan Park, and Emmanuel, La Grange, sent every week during the summer and supplied workers.

Mrs. T. W. Robinson of St. Luke's, Evanston, is in charge of our work with the Woman's Church Federation Protectorate. Miss Sarah King, of St. Peter's, connects the Episcopal girls with the parish near them. The year of 1921 the parishes contributed \$279.00 to the Protectorate.

The Auxiliary put its December meeting in our charge, when Mr. Reynolds of the Chicago Council of Social Agencies spoke to us on unemployment, and Mrs. T. W. Robinson on the Protectorate. The collection of \$42.00 so kindly given us we sent \$10.00 to the Cathedral Shelter, \$12.00 to Miss Campbell to buy glass eyes, and \$20.00 to the Woman's Church Federation Protectorate.

I have visited fourteen parishes, Mrs. T. N. Robinson, two.

Forty-three parishes have reported their work. All reports show some of our Church institutions aided; some parishes are helping all of

them, and many are aiding outside charities. We have ten Social Service Committees. Eight Committees have members on the United Charities District Councils, nine are actually aiding the charities.

Five are doing recognized work with Soldiers in the United States Health Hospitals, one parish furnished a recreational room at the Speedway, and weekly entertainments.

Much personal service is given in visiting, teaching English and tutoring children.

We distributed 100 copies of the Shepherd-Towner bill, and 100 copies of Urban League literature.

The interest of the women in Social Service is most enthusiastic. Without their help it would be impossible to make this report.

The policy of the Social Service Committee is to have the Parish Committees a clearing house for the social service work of the Parish; to call attention to the needs of our own institutions; to make a record of the social service work already being done; to inspire more interest in work for social service, and to educate in Social Service work by having good speakers once a month when possible. Many cannot have a large committee, but the Guilds will often let them have a speaker to address them. Many of the suburbs are helping Chicago Charities. It is the hope of the Committee that more and more those who draw their living directly or indirectly from Chicago will realize the responsibility to her poor by contributing to her recognized charities.

#### REPORT OF CHURCH SCHOOL SERVICE LEAGUE.

The Church School Service League has become firmly established in the Diocese during 1921 and has been appealed to in helping other Dioceses to establish the C. S. S. L.

The pamphlet which was published by the Department of Religious Education as a program of the C. S. S. L. for this Diocese has been requested from fourteen other Dioceses from New York to Texas and Pennsylvania to California.

Co-operation in the parishes as to work and interest is significant when our records show 48 parishes have appointed a parish director of the C. S. S. L. and that 3,900 gifts for the missionary boxes were sent from 37 parishes.

Diocesan interest was manifested by gifts sent as follows: 135 to Lawrence Hall, 75 to Providence Day Nursery, 25 to Kindergarten at Chase House, while an indefinite number of gifts were sent to Chase House to be used by the Deaconesses. 450 boxes of candy were sent to Deaconess Parsons for the County Hospital children.

Community and parish service is not tabulated in the Diocesan records as that represents two fields of service of such intimate and far-reaching effect that pages and pages would be covered in reporting it to you.

Mission Study as suggested by the League was taken up in many parishes through pageantry and the dramatization of mission stories. The Church School Service League holds five diocesan meetings during the year, when the parish directors receive the definite instruction and inspiration from the speakers of the day, for the acts of service in the five fields: Parish, Community, Diocese, Nation, World.

I wish to commend to you the members of the Executive Board of the C. S. S. L. They are ten in number appointed by the Department of Religious Education, and are in charge of the programme, of work and the responsibility of its being carried out in the parishes. They are most loyal, faithful and resourceful and they have a deep rooted faith in the belief that children well trained in service today will be the mainstay of the Church tomorrow.

## ARTICLES OF INCORPORATION.

STATE OF ILLINOIS, } ss.  
COUNTY OF COOK, }

To James A. Rose, Secretary of State:

We, the undersigned, Marie M. Hopkins, Emily Pardee Street and Frances E. McDermid, citizens of the United States, propose to form a corporation under the Act of the General Assembly of the State of Illinois entitled, "An Act Concerning Corporations," approved April 18, 1872, and all acts amendatory thereof, and that for the purpose of such organization, we hereby state as follows:

I. The name of such corporation is  
**"The Chicago Branch of the Woman's Auxiliary to the Board of Missions."**

II. The object of this corporation shall be: (a) To interest all of the congregations in the Diocese of Chicago in the different brances of missionary work, as conducted by the General and Diocesan Boards, and to the purpose of aiding said societies in carrying on the said missionary work in connection with the said Diocese and the said General Church. (b) An Auxiliary to the General Board of Missions and to the Board of Missions of the Diocese of Chicago of the Church known in law as "The Protestant Episcopal Church in the United States," and its management is to be in accordance with the constitution and canons of said Diocese of Chicago and of said Protestant Episcopal Church and not for pecuniary profit.

The corporations shall have power to receive donations, subscriptions, legacies and bequests to be used for the carrying on of the said missionary work and of the said Church in the said Diocese of Chicago and of the missionary work under the jurisdiction of the General Board of Missions of the Protestant Episcopal Church of the United States.

III. The Board of Managers shall have power to organize branches or recognize existing branches in every parish or mission in said Diocese under the rules as they may adopt from time to time. Any branch so organized, upon payment of the Annual Membership Fee, to be fixed from time to time by the By-Laws, shall be entitled to representation at the meetings of this Board, each Parish or Mission voting as a unit when demanded by two Parishes or Missions.

IV. (1) The officers of the Society shall be a Patron, a President, not less than five (5) Vice-Presidents, a Corresponding Secretary, a Recording Secretary and a Treasurer. (2) The Bishop of the Diocese shall be the Patron ex-officio.

V. The management of The Chicago Branch of the Woman's Auxiliary to the Board of Missions shall be vested in an Executive Board of not less than nine (9) nor more than eighteen (18) Directors, of whom the Patron, the President, the Vice-President, the two Secretaries and the Treasurer shall be a part.

VI. (1) The Board of Directors shall consist of not less than nine (9) nor more than eighteen (18) members, of whom the Bishop of said Diocese of Chicago shall, ex-officio, be one. All of the elective Directors shall be elected at the annual meeting of said corporation, which shall be held on the day after the close of the Diocesan Convention, except when the day falls on a legal holiday, when the Executive Committee of the Board shall appoint another day for the election of officers. The number of said Directors may, with the approval of the Bishop from time to time, be varied, and the Directors shall be elected in accordance with the statutes of the State of Illinois, and the By-Laws of said corporation, to be hereafter adopted. The Executive Committee shall meet monthly, except during the months of July and August.

(2) The Executive Committee shall have power, as necessity may arise, to appoint annually, with the approval of the Bishop, other officers, who shall not, however, be members of the Executive Committee.

(3) The duty of the President shall be to preside at all meetings of the Association and of the officers, to arrange for the organization of branches, to visit the same and to have the general charge of the work under the direction of the Bishop.

(4) The duty of the Vice-Presidents shall be to choose one of their number to preside in the absence of the President, to co-operate with her in the general supervision of the work of the Association and to take charge of the departments of work to which they may be assigned by the Executive Committee.

(5) The duty of the Corresponding Secretary shall be to conduct the necessary correspondence required by the Auxiliary, and to prepare such reports as are needed. The duty of the Recording Secretary shall be to send out notices of all meetings, to keep a record of the same, and to assist the Corresponding Secretary in the preparation of reports.

(6) The duty of the Treasurer shall be to receive all special and general funds; to disburse the former as the donors indicate, and the latter under the direction of the Executive Committee, and to render an account of the same at the annual meeting.

(7) There shall be a committee of two appointed to audit the Treasurer's accounts each year.

VII. The following persons are hereby selected as the directors to control and manage said corporation for the first year of its corporate existence:

Katharine D. Arnold, Vice-President.  
Vincy B. Fullerton, Vice-President.  
Emily Pardee Street, Vice-President.  
Eleanor M. Duncombe, Vice-President.  
Jessie Peabody Butler, Vice-President.  
Frances E. MacDermid, Corresponding Secretary.  
Addie S. Chenoweth, Recording Secretary.  
Emma J. Hoyne, Treasurer.

The said Directors shall hold office until the next annual meeting of said corporation and shall then be elected at the said annual meeting herein provided.

VIII. The Bishop of the Diocese of Chicago shall *ex-officio* be the Patron of the said corporation, and all of the acts of the Executive Committee and Society shall be subject to his approval.

IX. These Articles of Incorporation may be altered or amended at any annual meeting by a vote of two-thirds of the members present, subject to the approval of the Bishop, and by complying with the statutes of the State of Illinois.

X. The location is in the Diocese of Chicago, in the County of Cook, in the State of Illinois, and postoffice address of its business office is at No. 510 Masonic Temple, State Street, Chicago, Illinois.

## FORM OF BEQUEST.

I give, devise and bequeath to

**The Chicago Branch of The Woman's Auxiliary to the Board of Missions,**  
of the Protestant Episcopal Church in the Diocese of Chicago, for the use  
of said society .....

## BY-LAWS.

I. The election of officers at the annual meeting shall be by ballot, each Parish or Mission having one vote.

II. When a vacancy shall occur in the Executive Committee by death or resignation, or removal of residence from the Diocese, the members of said Committee shall have power, with the advice and consent of the Bishop previously obtained, to appoint an officer to fill the vacancy. The officer so appointed to serve until the next annual meeting.

III. Special meetings shall be called by the President, at such time and place as he may designate, for the purpose of stimulating interest in the work.

IV. It shall be the duty of every parochial branch to contribute annually a sum of money, the amount thereof to be determined by itself, to the Executive Committee of this Diocesan Branch, to be appropriated by them according to their discretion in the missionary work of the Church, which money shall constitute the General Fund of the Chicago Branch, and shall be so designated by the contributors.

V. The regular order of business at the annual meeting shall be as follows:

1. Office of devotion.
2. Calling of roll by branches.
3. Reading of minutes of last meeting.
4. Reports of officers and committees.
5. Election of officers.
6. Unfinished business.
7. Miscellaneous business and addresses.

VI. These by-laws may be amended at any annual meeting by a majority vote of the branches present.

Amendment to By-Law VI. The Annual Day of Prayer for Missions; the Annual Meeting; the Executive Committee and Monthly Meetings, heretofore held on fixed dates, will be subject to change, and for a sufficient reason may be held on dates to be determined by a majority vote of the Executive Committee, due notice of such change being given to all parochial branches.

VII. The Treasurer shall furnish bond for such amount as shall be determined by the Executive Committee, such bond to be paid for from the funds of the Woman's Auxiliary.

The Annual Meeting is held on the day after the close of the Diocesan Convention.

A meeting of the Diocesan officers is held on the first Thursday of each month.

Different branches are asked to co-operate with the President in taking charge of the noon-day meetings. Interesting papers are read and missionaries speak on the work in their jurisdiction.

It is hoped that each branch will send at least two representatives to these monthly meetings.
