## ANNUAL REPORT OF THE PRESIDENT FOR THE YEAR 1928.

Your President begs leave to submit the following report for 1928.

In ending my report of last year I said that while I had been happy in all that we had accomplished in 1927, I realized that there was a great deal more to be done and that if I had the strength given me to carry on I should try to accomplish it.

The last year in a Triennium is always a big one. This has been a tremendous year. Many splendid things have happened to us and therefore I can rejoice with you in having had a part in its achievements.

The treasurer's report, with receipts of \$19,158.27 as against \$21,668.84 of the preceding year, may not appear to the casual observer so good. However, when you realize that in the \$21,668.84 is included the \$5,002.00 which was really a special, as the result of the gold and silver offering of last year and that the \$19,158.27 is the regular, steady giving of the parishes throughout the diocese, you will see that the parishes have made better payments and that we have just cause to be most happy in this increase. I am happy to announce that we have received \$15,000 from Bishop Anderson as our share of the \$910,000 received from the Estate of Jane Cox, deceased. This item does not appear in the treasurer's report because it was received after the books were closed. I need hardly say that we are grateful for this, the largest gift we have ever received.

The allotment received by the Supply Department from New York was about the same as the year 1927. It has all been taken care of. Only in two cases were allotments returned. In addition to the \$14,000 worth of work done in the Mission Field and Diocesan Institutions, the Supply Department has sent out more than three thousand glasses of jelly. Miss Caroline Larrabee, Mrs. A. R. Simpson, Mrs. Ruthven Deane and Mrs. Lucien P. Hoyt deserve much credit for their efficient management of this department. Our quota of \$3,000 for the Woman's Auxiliary Special, known as the Corporate Gift, was not only paid but we went over the top. Our total was \$3,462.35 and best of all we are at the head of the list in our province, The Fifth, in which there are twelve dioceses. Do you wonder that I am deeply grateful to Mrs. John Henry Hopkins, Custodian of this Fund, for her splendid work and untiring interest?

The amount of the United Thank Offering for the past year which means the May and October collections, was \$11,928.89. The goal we set for ourselves was "The Largest United Thank Offering ever sent to the General Convention" and the beautiful part of it is that we did it, \$31,740.00. If you had been in that great cathedral in Washington when it was presented where nearly 14,000 women went to take part in the service, and in the evening had been present at the mass meeting and had seen the figures flashed upon the screen, \$1,101,451.40, you would have been so thankful and happy to think that you had had a part in it and that you women of the Auxiliary in the Diocese of Chicago had realized your blessings and in doing so had remembered the little Blue Box. If you could have seen many of our United Thank Offering missionaries home on furlough, who were at the missionary mass meeting that night, and could have heard



what the Bishops of the missionary districts had to say, you would have been more than thankful that you had had the blessed privilege of contributing to the support of women workers in the field.

The report of our educational secretary, Mrs. Harvey G. Edwards, was enthusiastic over the number of copies of "A Church Awake" sold in the diocese last year, more than 500, and the large registration for the Institute of 1928. The Department also helped in sending several clergy and auxiliary women to the conferences in Racine and Madison by giving scholarships amounting to \$425.00. I feel that this is a splendid record for this department and I am proud of its work. The conference held yesterday afternoon at St. James Parish House, Chicago, had for its subject "Personal Religion" and "Evangelism," which Mrs. Colton C. Daughaday as chairman, and Miss Margaret Marston, educational secretary of the Woman's Auxiliary, as leader. Too much cannot be said of the scheme and plan gotten up by Mrs. Daughaday herself for this discussion.

There were only forty women present at this worth while Conference, but so genuinely interested were they in this subject that the time passed all too quickly. We owe a debt of gratitude to Mrs. Daughaday for her expert handling of this subject.

This year I can report having organized three new branches. At St. Edmund's Mission I organized a new colored branch which bids fair to be a strong one. At Hinsdale I organized the Junior Guild and Auxiliary of Grace Church, a perfectly splendid strong branch of young women. Another branch of young women was organized at Winnetka, called the Junior Guild and Auxiliary of Christ Church, and a third young woman's branch was organized by one of our vice presidents, Mrs. Leete, in the southwestern district, at Lockport, known as the Evening Auxiliary. These new branches of young women are most encouraging, for in them we see the future Woman's Auxiliary.

We now have one hundred nine organized branches operating in one hundred parishes and organized missions and several others working through the Supply Department, or the United Thank Offering, or doing some phase of Auxiliary work without a regular auxiliary organization. It is difficult to report this exactly.

There have been eight regular monthly meetings. All except that of February 9 were held at the State-Lake Building. They have all been well attended although we should work for greater attendance, when you consider what interesting worth while speakers we have. Just look back over the program of this past year. The Rt. Rev. Logan H. Roots of China, Bishop Cross of Spokane, Bishop Hulse of Cuba, Bishop Oldham of Albany and our own Bishop Anderson, and such well known people as Mrs. Biller of Taylor Hall, Racine, and Dr. R. J. Colbert from the University of Wisconsin, who delivered one of the most splendid talks on social service we have ever had given to the Auxiliary, and then that much talked of and well known Dr. Rudolph Teusler, and many others. A very comprehensive program. I feel keenly that the women of the diocese should be regular in their attendance at these well thought out programs.



I want to thank Mrs. Halsted, director of the monthly meetings, for attending to all details and helping to get the speakers, also for her splendid record of attendance. She has not missed a single meeting in the four years of her service. I also want to thank Mrs. Fowkes and Miss Larrabee for their hard work in getting out the auxiliary report and Mrs. Fowkes, the corresponding secretary, for preparing all articles sent to the Diocese and Living Church. We had a most helpful and inspiring Quiet Day on September 29, at St. Peter's Church, conducted by Father Bowen. We had a very good attendance, far better than last year, but my only regret is that more women do not avail themselves of this rare opportunity. Also we must not forget our splendid United Thank Offering Service on May 24, at Grace Church, Oak Park, where from five to six hundred women gathered for the Corporate Communion and Thank Offering Service. These women represented seventy-four branches of the Woman's Auxiliary in this diocese.

As your President, I have visited twenty-six branches of the Auxiliary during the year. I have attended and presided at eight regular meetings of the Executive Board and three extra all day meetings, February 17, May 31 and September 21, and presided at eight regular meetings of the Auxiliary. Your president also attended one Quiet Day at St. Peter's Church, Chicago, and the Annual Thank Offering Service at Grace Church, Oak Park, May 24th, also a four days' conference at Racine, Wisconsin. Also a day in June at Racine when I took charge of the Auxiliary Conference. I have attended four meetings of The Church Extension Committee, The Chase House Sale, St. Mark's Silver Tea, The Cathedral Ball, United Thank Offering Tea and two Church Club Dinners, November 15 and February 4. I have also been present at some eight small conferences and committee meetings of different auxiliary committees, the regional luncheon given for Dr. Teusler in Chicago, four luncheon meetings for the St. Luke's International Medical Center campaign. I attended the convention in Washington as your delegate from October 9 to 24th, not missing a single hour or session of the Woman's Auxiliary Triennial meeting. I also attended the Day of Intercession Quiet Hour, closing service and all the mass meetings but two.

Now my fourth year as your President comes to a close and I want to say that it is with sincere regret that I say goodbye. I feel we have accomplished many big things in the last four years but it would have been simply impossible for me to have done this work without the loving and loyal support of my strong and fine executive board. Mrs. Clinch's devoted service as treasurer and her wise counsel has helped me more than I can tell you. Mrs. Kirkland, our United Thank Offering Custodian, my vice presidents, who have always done cheerfully what I have asked of them, Mrs. Staley and Mrs. Fowkes, our secretaries, and that splendid organization known as the Supply Department, manned by Miss Larrabee, Mrs. Simpson and Mrs. Deane; Mrs. Edwards, the educational secretary, all of them, each one doing her own part so well that I have not had the worry of their work on my shoulders. The experience that I have had is invaluable. Whatever I have given to the Auxiliary has been thrice repaid by what I have gained



myself in serving it. I have never asked a woman to help me on a committee or to act as chairman of a committee who has not accepted cheerfully. The crowning effort of my term of office has been in securing Mrs. Thomas I. Stacey as chairman of our new Corporate Gift of the Diocese, and Mrs. Robert B. Gregory as chairman of that tremendous undertaking "The helping to raise a million dollars" as the Woman's part in the St. Luke's International Medical Center. You will never know what joy it gives me to be able to turn over to the new president and board of the Woman's Auxiliary these two chairmen so well started in their work. Mrs. Gregory said I might tell you that she thanks me for having asked her to assume this chairmanship. I want you to know that I have been very happy in this work and the fact that I have been able to attend every meeting and keep every engagement I have had in the last four years of the Auxiliary, never **missing one**, proves that strength from above was given me and I know it will be given to the new president. I thank you all from the bottom of my heart for your loving and loyal support.

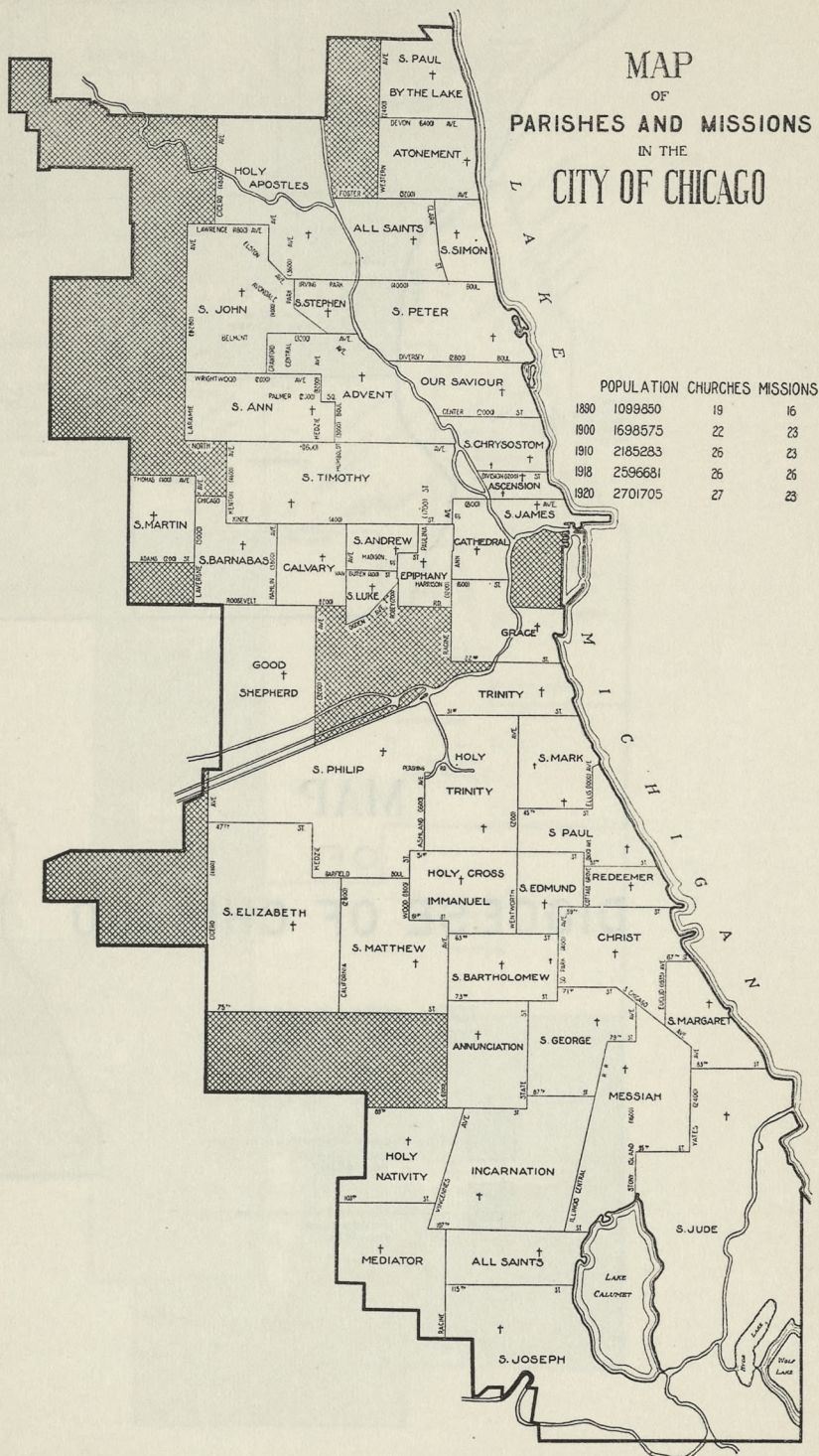
Mrs. Williamson replied, speaking of the honor she had received and asked for the prayers and support of the members of the Auxiliary. A rising vote of thanks was given to the Rector and women of St. James Cathedral for their gracious hospitality to the Woman's Auxiliary.

Mrs. C. Colton Daughaday read an expression of gratitude and appreciation from the Executive Board to the retiring President, Mrs. Mason, and Mrs. Clinch, the Treasurer, for the last eighteen (18) years.

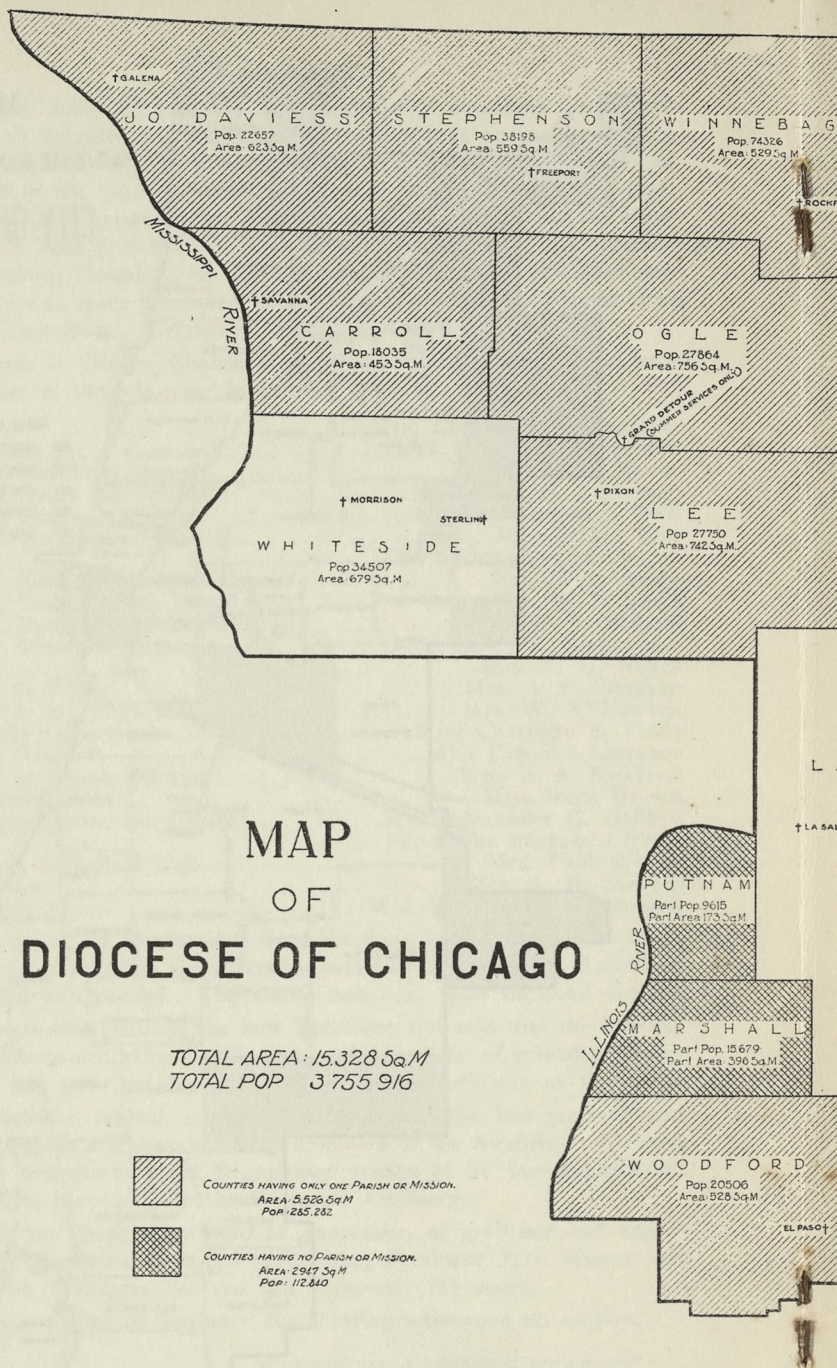
There being no further business, the meeting adjourned on motion.

## REPORT OF THE DEACONESS AID FUND FOR 1928.

The City Mission Deaconesses are very grateful for the money given to The Deaconess Aid Fund in 1928 from seventy Auxiliaries and Guilds, two Individuals and the Members of the "Clerica." This is the largest number that has ever responded to the letters sent out, and the receipts being more generous, we were able to help many more persons than ever before, both in and outside of the Institutions visited; notwithstanding this, we still had, from lack of sufficient funds, to refuse some help to those who needed it.

Owing to scarcity of employment, and much sickness, there are many of our people who on leaving the hospitals or other institutions have no means for immediate needs.

The year has fifty-two weeks, three hundred and sixty-five days, and day after day, the City Mission Deaconesses are meeting old and new people, who appeal to them not only for advice to help solve their difficulties, but for temporary assistance until they are again able to care for themselves.

Our Lord says, "The poor ye have with you always, and whensoever ye will ye may do them good." True, our first care in our Mission work is for the spiritual needs of our people, but we cannot and dare not neglect the material ones without disobeying our Master.

Each year our work in the City Mission Field grows, and just think of the many we come in touch with, not only in the twenty institutions one or other of us visit, but the people we follow up after they leave them, they, necessarily also increase in numbers, so each year we find greater need for more money.

There are some Auxiliaries and Guilds who have never failed for several years to respond to our Appeal according to their means, and we certainly appreciate their faithfulness; then there are others who failed this year for the first time to remember the needs of our poor people, but we are happy to say that thirteen new names were added to our list (see those



marked with a star), we most assuredly welcome them, and trust they will continue to be our helpers in this great work. There are still some Auxiliaries (too many, I am sorry to say) who have never placed The Deaconess Aid Fund on their budget, we are hoping that in the year 1929 we can count some, if not all of them among our numbers.

Let us again thank all who contributed to this Fund, also asking for more and if possible larger contributions in the new year, so we will not have to refuse any worthy soul needing assistance.

A special letter of appeal was again sent out for the Christmas Fund. The Deaconesses greatly appreciate the generous response to this from several individuals and the following auxiliaries, etc.:

The Men's Club at the Church of the Atonement, again gave their wonderful party and beautiful gifts to one hundred children from the Municipal Tuberculosis Sanitarium, and last but not least, the Church School of the Church of the Holy Spirit, Lake Forest, sent one hundred stockings, filled with candy and other goodies, for the children at the M. T. S. who could not go to the party.

The City Mission Children's Party was held as before in the large Club Hall at Chase House; all said they had a fine time, and returned to their homes laden with gifts.

The Deaconesses were specially asked in some institutions to provide Christmas cheer for a number of inmates who were without friends, and would otherwise not have had anything. We were pleased to be able to give each one something.

With the help given through these various sources, we were able to provide gifts of all kinds, according to needs, from a stove, blankets, various articles of clothing, subscriptions to special magazines, etc., to a paper of pins and shoestrings, besides groceries, fruit, candy, ice cream, cakes and Christmas cards for 4,500 men, women and children in the twenty institutions we visit and families or individuals in their homes, all of whom appreciated what was given them, and join with us in again thanking all those who made these gifts possible.

### REPORT OF EDUCATIONAL SECRETARY FOR 1928.

The registration at the Mission Study Institute for 1928 was 69 from 43 parishes, the largest attendance so far and more parishes represented. Mrs. W. F. Pelham of St. Mark's, Glen Ellyn, acted as leader.

More than 500 copies of the book used "The Church Awake" by Dr. Sturgis were sold in this Diocese, an unprecedented number.

Four hundred twenty-five dollars was distributed in whole or part "Scholarships," sending clergy and auxiliary women to summer conferences, at Racine and Madison.

Greater interest was shown last year in the increase in Mission Study Classes and Bible Classes than previously, the exact number can not be given as the reports are always incomplete, so many parishes fail to make reports. Talks on "Mission Study" were given before thirteen auxiliary and four sectional meetings.

### REPORT OF SUPPLY DEPARTMENT, 1928.

Before giving our attention to the report of work done by the Supply Department in 1928, let us imagine ourselves in Porto Rico just after the hurricane. The darkness is intense, the rain is pouring down and there is still sufficient wind to keep the loosened debris banging against the standing walls of the St. Luke's Memorial Hospital. We stumble along over the ground and see on all sides the flattened huts of the Natives. As we draw close to the building, we see lights in the Chapel, for that is where some of the patients have been brought by the nurses for safety. Then we hear singing; in this first lull after the long strain, a native nurse has seated herself at the little melodeon and all are joining in the hymns, "Nearer My God to Thee" and "There's a Wideness in God's Mercy."

Another visit we should like to make is to All Saints Church, St. Thomas, Virgin Isles, where some of the Sisters of St. Anne are stationed. It is early morning, Dec. 28th, and crowds of women with little children and



babies are going into the Church for the Communion Service; for it is the custom there on Holy Innocents Day to bring the children of the parish, for a special blessing. All through the service the baby voices may be heard, cooing, gurgling and singing; then at the end, they are brought up to the Altar for the Priest's blessing.

Just one more glimpse: this time of St. Mary's on the Mountain at Sewanee. It is a Tuesday, the day the Mission room is open for those who wish to buy. Perhaps we should see the old man who was there not long ago, trying to find some article for each member of his family; or we might meet the two old sisters who always come together and whose only thought seems to be the fear that one will get something the other wanted. They will stand for ten minutes over a wornout shawl, one saying to the other, "You take it, Becky," "No, Susie, if you want that shawl, you take it; I'll have this sweater."

These places mentioned are types of the Mission that have been helped by your Boxes during 1928, and the same kind of work is before us this year. There are always hospitals to be supplied, there are always personal boxes for priests and sisters to be sent; you remember how Bishop Cross stressed the necessity of this branch of our work; there are always allotments for Centers like that at Sewanee, where the Sisters of St. Mary are doing Christian Social Service.

These boxes are given you indirectly by the National Council, through the Supply Department and you are urged to do your utmost, so that this Diocese may fill its quota. Just now, this is especially necessary, as there is much to be bought. The Supply Department will do all that it can, but with \$800.00 to be spent for rent and custodian's salary you can see that we need more and larger pledges. One cannot but notice as the parish reports are returned that a great deal of money is given to community organizations, instead of to Church institutions that are doing the very same sort of work. Dr. Teusler spoke of this characteristic of our Church people and of the difference it would make if the preference were given to activities in the Church.

Do help us so that we may give the sweaters, stockings, underwear and household supplies to the blind Indian children at Good Shepherd Mission in Arizona, to the Patterson Industrial School, in N. C., to the boys and girls of St. Peter's Mission, Cass Lake, and to the other centers where our substantial encouragement is needed. There are eight Individual Personal Boxes to be taken now. Four for children, four for adults. The necessary information is here. The Department hopes that there are Branches who will come forward after the meeting and get these names and also that there will be others who will be responsible for some of the articles needed in our hospitals and schools so that nothing may be returned to New York.

The full financial statement of the Supply Department will be in the year book, but the value of allotted work is as follows:

## CHURCH PERIODICAL CLUB DIRECTOR 1928 REPORT.

Our organization consists of a Director, Assistant Director, Secretary and Treasurer and donors of magazines.

During the past year six (6) meetings have been held, including the Conference meeting in February, with an average attendance of ten members; the number of active members being twenty-nine (29), we consider this a very good average.

In October, on account of removal of her family from Chicago, we were obliged to lose the services of Mrs. Herbert Beck, of the Church of the Redeemer, as Secretary and Treasurer.

In December Mrs. R. W. Bailey, of the Church of the Advent, was obliged to resign on account of illness.

Both officers were efficient and untiring in their services for the Church Periodical Club.

In the death of Mrs. Thomas Balmer, of St. Mark's Church, Evanston, a most beloved and loyal Secretary was taken from us.

Six (6) of our Secretaries have resigned.

There have been appointed eight (8) new Secretaries in as many parishes; there are now on the roll call twenty-eight Secretaries.

The Church of the Atonement heads the list of branches for magazines sent regularly; the number being sixty-eight. Other branches are doing splendid work, the total reported being:

The life and growth of the Church Periodical Club depends wholly upon the active interest of the parishes and the number of earnest women who act as Parish Secretaries. Let me appeal to you more strongly than ever for a Secretary in each parish represented here today, which has not yet registered with us.

We feel especially favoured to have had so outstanding a Church woman, so spiritually and mentally endowed, to speak for us, and we



gratefully welcome this opportunity of thanking the Auxiliary for making her coming possible.

## ARTICLES OF INCORPORATION.

STATE OF ILLINOIS, }  
COUNTY OF COOK; } ss.

To James A. Rose, Secretary of State:

We, the undersigned, Marie M. Hopkins, Emily Pardee Street and Frances E. McDermid, citizens of the United States, propose to form a corporation under the Act of the General Assembly of the State of Illinois entitled, "An Act Concerning Corporations," approved April 18, 1872, and all acts amendatory thereof, and that for the purpose of such organization, we hereby state as follows:

I. The name of such corporation is  
"The Chicago Branch of the Woman's Auxiliary to the Board of Missions."

II. The object of this corporation shall be: (a) To interest all of the congregations in the Diocese of Chicago in the different branches of missionary work, as conducted by the General and Diocesan Boards, and to the purpose of aiding said societies in carrying on the said missionary work in connection with the said Diocese and the said General Church. (b) An Auxiliary to the General Board of Missions and to the Board of Missions of the Diocese of Chicago of the Church known in law as "The Protestant Episcopal Church in the United States," and its management is to be in accordance with the constitution and canons of said Diocese of Chicago and of said Protestant Episcopal Church and not for pecuniary profit.

The corporation shall have power to receive donations, subscriptions, legacies and bequests to be used for the carrying on of the said missionary work and of the said Church in the said Diocese of Chicago and of the missionary work under the jurisdiction of the General Board of Missions of the Protestant Episcopal Church of the United States.

III. The Board of Managers shall have power to organize branches or recognize existing branches in every parish or mission in said Diocese under the rules as they may adopt from time to time. Any branch so organized, upon payment of the Annual Membership Fee, to be fixed from time to time by the By-Laws, shall be entitled to representation at the meetings of this Board, each Parish or Mission voting as a unit when demanded by two Parishes or Missions.

IV. (1) The officers of the Society shall be a Patron, a President, not less than five (5) Vice-Presidents, a Corresponding Secretary, a Recording Secretary and a Treasurer. (2) The Bishop of the Diocese shall be the Patron ex-officio.

V. The management of The Chicago Branch of the Woman's Auxiliary to the Board of Missions shall be vested in an Executive Board of not less than nine (9) nor more than twenty-one (21) Directors, of whom the Patron, the President, the Vice-President, the two Secretaries and the Treasurer shall be a part.

VI. (1) The Board of Directors shall consist of not less than nine (9) nor more than twenty-one (21) members, of whom the Bishop of said Diocese of Chicago shall, ex-officio, be one. All of the elective Directors shall be elected at the annual meeting of said corporation, which shall be held on the day after the close of the Diocesan Convention, except when the day falls on a legal holiday, when the Executive Committee of the Board shall appoint another day for the election of officers. The number of said Directors may, with the approval of the Bishop from time to time, be varied, and the Directors shall be elected in accordance with the statutes of the State of Illinois, and the By-Laws of said corporation, to be hereafter adopted. The Executive Committee shall meet monthly, except during the months of July and August.



(2) The Executive Committee shall have power, as necessity may arise, to appoint annually, with the approval of the Bishop, other officers, who shall not, however, be members of the Executive Committee.

(3) The duty of the President shall be to preside at all meetings of the Association and of the officers, to arrange for the organization of branches, to visit the same and to have the general charge of the work under the direction of the Bishop.

(4) The duty of the Vice-Presidents shall be to choose one of their number to preside in the absence of the President, to co-operate with her in the general supervision of the work of the Association and to take charge of the departments of work to which they may be assigned by the Executive Committee.

(5) The duty of the Corresponding Secretary shall be to conduct the necessary correspondence required by the Auxiliary, and to prepare such reports as are needed. The duty of the Recording Secretary shall be to send out notices of all meetings, to keep a record of the same, and to assist the Corresponding Secretary in the preparation of reports.

(6) The duty of the Treasurer shall be to receive all special and general funds; to disburse the former as the donors indicate, and the latter under the direction of the Executive Committee, and to render an account of the same at the annual meeting.

(7) There shall be a committee of two appointed to audit the Treasurer's accounts each year.

VII. The following persons are hereby selected as the directors to control and manage said corporation for the first year of its corporate existence:

Emily Pardee Street, Vice-President.  
Eleanor M. Duncombe, Vice-President.

Addie S. Chenoweth, Recording Secretary.  
Emma J. Hoyne, Treasurer.

The said Directors shall hold office until the next annual meeting of said corporation and shall then be elected at the said annual meeting herein provided.

VIII. The Bishop of the Diocese of Chicago shall ex-officio be the Patron of the said corporation, and all of the acts of the Executive Committee and Society shall be subject to his approval.

IX. These Articles of Incorporation may be altered or amended at any annual meeting by a vote of two-thirds of the members present, subject to the approval of the Bishop, and by complying with the statutes of the State of Illinois.

X. The location is in the Diocese of Chicago, in the County of Cook, in the State of Illinois, and postoffice address of its business office is at No. 510 Masonic Temple, State Street, Chicago, Illinois.

## BY-LAWS.

I. The election of officers at the annual meeting shall be by ballot, each Parish or Mission having one vote.

### Amendment to By-Law No. 1

Beginning with 1928 and thereafter on the even calendar years, the first, third, fifth, seventh and ninth Vice-Presidents, the Treasurer, Recording Secretary, the Chairman of Box Work, the Chairman of the Social Department and the Chairman of the Department of Education shall be elected by the Woman's Auxiliary at its Annual Meeting, to serve for a term of two years.

Beginning with 1929 and thereafter on the odd calendar years the President, second, fourth, six and eighth Vice Presidents, the Corresponding Secretary, the Chairman of the Supply Department, the Chairman of the Speakers Bureau and the Director of the Monthly Meetings shall be elected by the Woman's Auxiliary at its Annual meeting to serve for a term of two years.

No member shall serve on the Executive Board (in the same office) more than two consecutive terms.

The United Thank Offering Director shall be elected for a term of three years, serving through a Tri-ennial Convention.

II. When a vacancy shall occur in the Executive Committee by death or resignation, or removal of residence from the Diocese, the members of said Committee shall have power, with the advice and consent of the Bishop previously obtained, to appoint an officer to fill the vacancy. The officer so appointed to serve until the next annual meeting.

III. Special meetings shall be called by the President, at such time and place as he may designate, for the purpose of stimulating interest in the work.

IV. It shall be the duty of every parochial branch to contribute annually a sum of money, the amount thereof to be determined by itself, to the Executive Committee of this Diocesan Branch, to be appropriated by them according to their discretion in the missionary work of the Church, which money shall constitute the General Fund of the Chicago Branch, and shall be so designated by the contributors.

V. The regular order of business at the annual meeting shall be as follows:

1. Office of devotion.
2. Calling of roll by branches.
3. Reading of minutes of last meeting.
4. Reports of officers and committees.
5. Election of officers.
6. Unfinished business.
7. Miscellaneous business and addresses.

VI. These by-laws may be amended at any annual meeting by a majority vote of the branches present.

Amendment to By-Law VI. The Annual Day of Prayer for Missions; the Annual Meeting; the Executive Committee and Monthly Meetings, heretofore held on fixed dates, will be subject to change, and for a sufficient



reason may be held on dates to be determined by a majority vote of the Executive Committee, due notice of such change being given to all parochial branches.

VII. The Treasurer shall furnish bond for such amount as shall be determined by the Executive Committee, such bond to be paid for from the funds of the Woman's Auxiliary.

---

The Annual Meeting is held on the day after the close of the Diocesan Convention.

A meeting of the Diocesan officers is held on the first Thursday of each month.

Different branches are asked to co-operate with the President in taking charge of the noon-day meetings. Interesting papers are read and missionaries speak on the work in their jurisdiction.

It is hoped that each branch will send at least two representatives to these monthly meetings.



## CHARTER.

To all to whom these presents shall come, Greeting:

Whereas, a Certificate, duly signed and acknowledged, has been filed in the office of the Secretary of State, on the 12th day of May, A. D. 1906, for the organization of—

The Chicago Branch of The Woman's Auxiliary to the Board of Missions, under and in accordance with the provisions of "An Act Concerning Corporations," approved April 18, 1872, and in force July 1, 1872, and all acts amendatory thereof, a copy of which certificate is hereto attached:

Now, therefore, I, James A. Rose, Secretary of State of the State of Illinois, by virtue of the powers and duties vested in me by law, do hereby certify that the said

The Chicago Branch of The Woman's Auxiliary to the Board of Missions, is a legally organized Corporation under the laws of this State.
