





### PRESIDENT'S REPORT FOR 1931.

It is a fact of common knowledge that spiritual values rise coincident with the decline in material values. Probably, as never before it has been impressed upon the consciousness of the women of the Church that "men cannot live by bread alone"—and there has been a resultant energy and progress in the Woman's Auxiliary along all lines.

The year began auspiciously with a very large attendance at the Annual Meeting at St. Paul's Church at which time our Bishop apparently inoculated us with his vision and his enthusiasm which has permeated the whole body and reached its fruition in the remarkable attendance at the United Thank Offering Meeting in May when over seven hundred women nearly filled St. Luke's Church, Evanston.

The Quiet Days held in April at St. Chrysostom's in conjunction with the Daughters of the King with Bishop Keeler as Conductor and in October at the Church of the Advent with Dr. Charles McAllister as Conductor, did not have a numerical attendance commensurate with their outstanding spiritual opportunities, but was at the same time memorable for their spiritual atmosphere—in truth a quiet day with God—and the sense of help and strength the representatives of many parishes felt, as they returned to the city's noise and turmoil and the struggle of leading a consistent Christian life. We would here make a plea for recognition of the great value of these Quiet Days which shall mean a larger attendance in the future. They repay whatever sacrifice of time and effort they may involve.

The General Convention gave an added impetus and interest to our work which reached a high point of enthusiasm when we had the pleasure of entertaining delegates and guests en route to Denver. No call to service was ever answered more promptly or spiritedly than by the women of the Auxiliary when asked to meet our guests, drive them about the city and act as hostesses at the luncheon following.

You were represented at Denver by a full delegation, four delegates and four alternates who spent two weeks and more attending all sessions and mass meetings as well as classes. Each went assigned to a definite subject and study group for which she had made careful preparation during the summer by reading and study. Ours was the task to acquaint ourselves with what is being done in other dioceses, to contribute from our own experience and obtain knowledge of the great problems the world presents today, the responsibility that is ours, and what, with God's grace, our approach to their solution must be.

The timely and vital subjects presented for your study, reflection and action were: Family Life; Interracial Contacts; Christianity and International Relations; Property and Economic Conditions and Religious Thinking of Today. Churchwomen have the responsibility of leadership. If so we must have an intelligent understanding of these problems and make our contribution to their solution by holding firmly to convictions which shall help to create public opinion; by conscientious use of our suffrage; by example and by prayer. Your interest in the deliberations at Denver has been shown by the number of Sectional meetings as well as parish meetings you have attended when we have attempted to recreate for you the atmosphere of the Convention and give you an outline of these subjects presented and findings brought in. We commend to you therefore as YOUR responsibility to the work of the Church, a careful study of these presentations, copies of which can be procured from the Chairman of Religious Education or from The Church Missions House, 281 Fourth Ave., New York, also from The Church Book Store here. These subjects are also incorporated to a certain extent in the scope of our Study Class this year. It is a cause for congratulation that so large a number are attending the class for leaders now being conducted by Dr. Daniel McGregor on "Building a Christian Nation." Every parish should have a Mission Study class. What other means have we of reaching the women of the Church, of carry-

ing out the resolutions made at the Triennial of making each of us realize her responsibility in making this nation Christian with all that that implies?

A step forward in this direction, halting at first because of inadequate funds, is the creation of a circulating Religious Library. This venture, with your help as readers and donors, can be a very real force in building an educated and spiritually vitalized body of Churchwomen. The Church Periodical Club finds in this activity a natural phase of its work and is eager to co-operate.

Shall we not resolve to increase our intellectual and spiritual resources during the approaching Lenten season by systematic reading and study and so fortify ourselves for the task that is ours in this day when a sane and courageous Christian outlook and leadership is so sorely needed?

At some cost of self-denial may we plead with those of you who do not subscribe to a Church weekly to do so, if not as individuals, then as parish branches? Unless some financial backing of this kind is given, our Church papers will have to suspend publication, which, with their excellent editorials and world news of the Church, would be a calamity of far-reaching influence. This is a matter of grave concern to the National Council.

The report of the United Thank Offering Custodian reveals many new givers and offerings from branches which entailed real sacrifice. Had all branches taken up a Fall offering, the amount taken to Denver would undoubtedly have reached as large a sum as at the last Triennial. It is hoped that in the future we may have one hundred per cent co-operation in this. Mr. Franklin reported the interest on the amount in his hands accumulating during the three-year period as over eighty thousand dollars, and even in one diocese the interest for six months is not a negligible amount.

We could not but wish as we knelt, over two thousand in number, in hushed silence at the celebration of the Holy Communion when the Triennial United Thank Offering was presented that you might all have had the great privilege that was ours. As the "offerings of praise and prayer" were placed on the great golden alms basin, it was with a feeling of restrained exultation that we visualized young women going into our student centres to "hold the line for Christ" in our institutions of learning; Orientals going in and out of Brent House where they learn what true Christian fellowship is; the walls rising of the Community House at Anchorage, Alaska. If the scales could be made to fall from the eyes of so many in the Church who do not see the glorious opportunity of building the Kingdom, what might we not accomplish? Was there ever a time of greater opportunity? Let us go forward with renewed zeal to our goal—every baptized woman with a little blue box.

Never before has the Church had so great a call to be socially minded as now, and our parishes have co-operated as organizations and as individuals with existing agencies in relieving distress. This has not been a time to set up new activities, but to stand by. You have shown your Bishop your desire to hold up his hands by enthusiastically pledging one thousand dollars to his fund for emergency relief for our Diocesan Institutions.

Your Treasurer's report shows consistent and consecrated giving. We accepted as our share of the Advance Work assigned to our Diocese the sum of fifteen hundred dollars, and by your generous gifts you made it seventeen hundred. Your Chairman of Box Work has reported prompt acceptance of allotments, and many gifts of valuable personal boxes—all this in a year when we have had a carefully scrutinized outgo as income has decreased. This is a record in which you may have pardonable pride.

The help of your Advent Intercessions in meeting the world's great need is something that cannot be estimated, but if we believe in prayer, and we do, we know that our Lord has heard and will answer in His good time.

The Sister Mary Elizabeth is getting splendid results at Dwight and Joliet with the women prisoners, soon to be transferred to the Woman's Reformatory at Dwight. At the head of this institution we have a consecrated Churchwoman who will do all in her power to further our efforts, and we hope, in line with our Bishop's expressed desire, we can in the near future enlarge the scope of our work here.

The needs of the Rural Parish and the splendid work Archdeacon Zeigler is doing in this field, deserve all the response of which we are capable, and it is with a sense of gratitude that we can tell you that Mrs. Leete has consented to accept the Chairmanship of Rural Work and that the Finance Committee has found it possible to contribute a sum monthly for the work of Deaconess Adams with shut-ins and the isolated.

A model Constitution and By-Laws for Auxiliary branches has been carefully drawn up by a committee appointed for that purpose, using the one suggested by the National Board as well as others and adapting them to our needs. We wish that it might be adopted by all branches which would assure our working under similar methods of procedure. We would especially commend its provisions for rotation in office, realizing as we do that responsibility creates interest and should be shared in turn by the whole group.

A survey of the Diocese is being prepared from data supplied by your Vice-Presidents, based on their observations as their duties have carried them into different parishes, and also upon the information that you have given them. This should be a very real help in bringing the need and a way to meet it together; in helping us to serve you more effectively; to co-operate better in extending and intensifying your work. It seems to show a healthy growth numerically and a reaching-out for the young woman, giving her the opportunity of decision as to how she can make her contribution and searching out the task that demands the best of which she is capable. It is a joy to record the formation of six new branches this year, two of them made up of young women.

Your Officers have entered upon and carried out their work with great enthusiasm and unfailing devotion. The attendance at the eight monthly Board meetings has been about one hundred per cent. At many of these we have had the help and stimulus of the attendance of the Chairman of the Church Periodical Club and a representative from the Girl's Friendly Society. Membership on different committees has demanded additional time and work from the members of the Board, and the trip to Denver entailed a greater measure of sacrifice. You can be proud of the fidelity, competency and singleness of purpose reflected in these officers you have chosen to represent you.

The duties of your President have carried her to many parishes near and remote where it has been refreshing to meet with real enthusiasm for constructive work, but there are many branches to which she is still a stranger and would rejoice in knowing, especially the small groups that have discouraging problems to solve.

As a member of the Church Extension Committee she has attended all meetings save one, when a sectional meeting coincided; attended all meetings of the Social Service Council of the Diocese and acted as a representative at the Peace Through the Churches Convention; spoke at the Pre-Convention luncheon and Past-Convention dinner, and because of membership in the group on Family Life at Denver has had the privilege of speaking on this subject to groups outside the Church.

It was her privilege at Denver, with the co-operation of Mrs. Almon Abbott of Lexington, Kentucky, to write the memorial to Bishop Anderson as late Primate of the Church. Her work has been made easy and a joyful service because of the whole-hearted co-operation of each and every one of you.

Your attendance at the Monthly Meetings has risen in number and in proportion of parishes represented, not we believe because of the excellence

of the programs offered, although we think that they have been stimulating, but because each one of you is earnestly seeking the way by which she can enter into a fuller life with Him and so throw all of the vigor and enthusiasm of which she is capable into winning a troubled and distracted world for Christ. In this spirit may we go forward this coming year.

Since the last Annual meeting there have been nine meetings of the Executive Board, eight meetings of the Chicago Branch and the Annual United Thank Offering meeting in May, Mrs. Williamson presiding at all meetings.

The programs have been quite varied in scope and full of challenge and thrills. Our own Diocese provided three of the speakers, up to the summer recess, presenting work among young colored boys, the meaning of Christian marriage and his twenty-three years in the Philippines, with Father Sibley. In the fall, work in China, Japan, Brazil, Honolulu and Missions and Workers encountered by Mrs. Thomas I. Stacey on a trip around the world. Problems in our own Diocese the opportunity church women have to help the Illinois Society for Prevention of Blindness in its legislative program and finally a stirring missionary talk by Rt. Rev. George Craig Stewart, Bishop of Chicago.

With the steady increase in attendance annually and the continued growth devotionally and spiritually of the members under the consecrated leadership of Mrs. Williamson, as President, the future of the Chicago Branch looks very hopeful.

#### REPORT OF THE CORRESPONDING SECRETARY.

January 1931 to 1932.

The Year Book is the important part of my work, and due to the fact that the branches were more prompt in sending in their reports, it was possible to get the book out sooner, and again, March 1st, is the latest date on which to receive new lists of officers.

Four hundred copies were printed and sent to the presidents, secretaries and rectors of each branch, all executive officers and special committees, and others on request.

In addition to the book and general correspondence, I took over the sending of notices of monthly meetings, 375 postals each month.

In September with Mrs. Williamson, we communicated with women throughout the diocese, who were willing to furnish cars and hostesses, for the entertainment of the Pre-Convention luncheon guests. Assignments to depots and general information were sent to several hundred women.

In November, 4500 Advent Intercession cards were sent to all branches, and in January, Convention programs were sent to all presidents.

## REPORT OF THE SUPPLY DEPARTMENT.

The Advisory Committee of the Department held five meetings during the year with a good attendance. Reports were read and a record kept and the following summarizes the work done:

The Box work assigned to this Diocese for 1931 was as follows: 11 Personal Boxes for Missionaries and their families, 11 \$5.00 Christmas Boxes for Women Missionaries (the value of these came to \$1,484.88), 26 Allotments for Missions, to which the Parishes of the Diocese responded with a total of 184 boxes, the combined value being \$3,988.50. The striking contribution of this Diocese in this work is shown in filling the quota of St. Michael's Mission Boarding School at Ethete, Wyoming, with gifts amounting in value to \$1,633.34.

Many boxes have been sent through the donations to the Emergency Shelf, which was ably handled by Miss Jeanné Street. The recipients of these boxes responded with touching gratitude.

The Diocesan Pantry appeals sent by Miss Mary Brown have resulted in an 85 per cent response, showing 4,598 glasses of jelly valued at over \$900.00.

The work of Surgical Dressings and Bandages has been carried on by Miss Gertrude Hoag, with several days of instruction during Lent and one this Fall. 2,615 dressings were made by Branches for the two hospitals allotted us.

At this time we wish to make mention of the great need of Surgical Dressings for Emerald Hodgson Hospital, Sewanee, Tenn., which has met with serious loss owing to the recent fire.

Mrs. Ellis, Chairman of Vestments, reports the receipt of both new and old Vestments and Altar linens. Five Missions have been benefitted by articles from the stock on hand. The Diocesan Altar Guild will in future carry on this work that up to this time has been a part of the Supply Department.

It may be of interest to you to know that 60 Parishes have taken advantage of purchasing through the Supply Department. This seems to be the opportunity to give credit to the efficient work done by our Custodian, Mrs. Hoyt, who throughout the year has cut bolts of goods, sent innumerable packages and through it all has shown such fine courtesy.

In April three Sectional meetings were held.

On April fifteenth the Guild at St. Bartholomew's Church entertained representatives from the South Side parishes. The Rev. Alfred Newbery, Rector of the Church of the Atonement, addressed the meeting.

On April twenty-first the Rev. Harold Holt of Grace Church, Oak Park, gave an interesting talk on Christian Social Service to representatives from the North Shore and North Side parishes. This meeting was held at the Church of the Atonement.

On April twenty-eighth the Rev. Edward S. White of the Church of the Redeemer spoke at St. Barnabas Church to representatives from the West Suburban and West Side parishes. The average attendance at these meetings was forty.

The Auxiliary at St. Bartholomew's Church held its Social Service meeting on June third. Dr. Charles E. McAllister, Rector of St. Luke's, Evanston, was the speaker.

Increased interest in the various Diocesan Institutions has been shown this year by many of the Parishes.

Gifts of money and of service have helped these over-taxed agencies to carry on.

I have attended the monthly Board Meetings of the Church Mission of Help, and of the Social Service Committee of the Diocesan Council.

Stacey gave a bird's-eye view of our Mission stations which she had recently visited. Mrs. Cooper spoke of student work at the U. of I.

## REPORT OF CHURCH PERIODICAL CLUB FOR 1931.

During the year 1931 the Church Periodical Club held eight meetings with an average attendance of twelve secretaries.

We have been co-operating with the Department of Religious Education in helping to form a Loan Library for Mission Study Classes and with Deaconess Adams in sending the Diocese and The Spirit of Missions to isolated persons in the Diocese, and with the Deaconess in supplying magazines, post cards, Victrola records, playing cards and books in our city institutions. In all we have aided twenty institutions in the Diocese. \$606.43 passed through the hands of our secretaries for magazine subscriptions, books and the Endowment Fund.

We have had as speakers during the year Mrs. Otto Heinigke, National President of the Church Periodical Club, Mrs. David Larcomb, our Provincial Secretary and Mrs. Biller of Brent House.

I have been greatly assisted in my work by the kindly co-operation of Mrs. Henry Armstrong, Assistant Director, and Mrs. Roland Wilder, Secretary-Treasurer, and the twenty-three parish secretaries.

## REPORT OF THE DEACONESS DISCRETIONARY FUND FOR 1931.

The City Mission Deaconesses are very thankful to all who contributed to the Deaconess Discretionary Fund last year. Although we did not reach our goal of the minimum amount of Fifteen Hundred Dollars hoped for, still, in spite of bank failures, unemployment, etc., we heard from nine more Auxiliaries and Guilds than in 1930, making a total of ninety-seven contributing. Fifty-four gave the same amount as before, \$629.00, twenty-one (marked by star \*) increased their pledges \$212.00, making total amount given by them \$370.50, eleven new ones (marked by double star \*\*) all missions but two, gave \$35.50, five that had not given recently renewed, \$29.00, six were obliged from various causes to decrease their amounts to \$31.00 and five were unable to keep promises made early in year. Total amount received from the 97 branches, Ten Hundred and Ninety-five Dollars and Fifty Cents; added to this One Hundred Dollars from the Diocesan Poor Funds, and Twenty Dollars and Twenty-seven Cents from special offering at a Clergy Conference, (both of these through Bishop Stewart), from six individuals (including personal gift of Twenty-five Dollars from the Bishop) Sixty Dollars, and from the Members of "The Clerica" Ten Dollars, (double the amount they gave before), making a grand total of Twelve Hundred and Eighty-five Dollars and Seventy-seven Cents, against Ten Hundred and Forty-seven Dollars given in 1930, an increase of Two Hundred and Thirty-eight Dollars and Seventy-seven Cents.

We all feel the Mission Branches should be especially thanked, as they were the most generous according to the number of their members, and we earnestly hope they will be able to help us again.

Of course the increase of money received helped us to give to a few more of our City Mission people, but our numbers of those needing help have increased much more, so we were still unable to give financial assistance to all who really needed it, and many had to be refused, which we greatly regretted, but we can only give from fund that is on hand, and cannot borrow or go in debt, when we do not know whether the money will be forthcoming.

It can be seen from the daily papers how inadequate the Governor's Fund and the United Charities are, as each week the number of persons applying for assistance increases.

These Emergency Funds are used mainly for the unemployed, and especially for those with families, none of them touch the people in any of the Public Institutions where the City Mission Deaconesses visit; we find most of them overcrowded, and in some of them their income curtailed, so they can do nothing extra for the inmates. Some of the people who in past years had relatives or special friends to help them a little, now find that they are having to be helped themselves; a year ago some had small savings in a bank, now that is all used up, or the bank has failed and they have lost all or most of their savings.

We have therefore more often to provide real necessities in special clothing and other things that our people may at least be warm and comfortable, and for the sick ones, little extras that mean so much to those spending often their last days in bed, without any friends but their Deaconess to look to for help: and for our people outside, some waiting to go to an institution when there is a vacancy, others dismissed from a hospital, still too weak to work (even if they had a job waiting for them), no money for rent, fuel or food, they are our Church people, and in a way we are responsible for them. How much can a Deaconess do for them on Fifteen Dollars or occasionally Twenty Dollars a month, and that is all we each have from the Deaconess Discretionary Fund to supply even the most urgent needs of our many poor and sick City Mission people, both in and outside of the institutions.

Here is one case, father, mother and three children, 13, 8 and 5 years of age, the father had no regular work in nearly two years, shoes so old his feet almost bare, no warm coat or sweater, wife and children without any warm underwear or stockings, except some too far gone to patch any more, oh! how grateful they were when these necessities were given them, overwhelmed when they saw all the things were new, for they only expected secondhand things; shoes were given also to the eldest boy, now they can all go to school and be reasonably warm, but it took more than the month's allowance of the Deaconess to buy these things, as she had none of them on hand. Another case, a crippled colored boy trying his best to keep out of the Poor House (up to the present his clothing provided by the Deaconess), living on Twenty-nine Dollars a month, with this pittance paying room rent, laundry and food, etc., do not you think he often goes to his news stand at night hungry? We could tell of many even more pitiful cases, but there is not time.

Look at the crowds we see outside the theatres, the cost of even one movie would provide milk and bread for at least two days for some poor half-starved soul.

The number of people needing our help will keep on growing larger, until work is more plentiful.

We therefore beg the Members of every Auxiliary and Guild to give as generously as last year in answer to the Annual Appeals now being sent out, if possible to increase, but on no account to decrease their pledges to our Fund. Deny yourselves some little pleasure, if that is the only way you can give more to help these less fortunate brothers and sisters in Christ, for "Inasmuch as ye did it to one of the least of these My brethren, ye did it unto Me." "He that hath pity upon the poor lendeth unto the Lord, and that which he hath given will He repay him again."

Special appeals were sent out as usual for The Christmas Fund. This is entirely separate from the Deaconess Discretionary Fund and appeals are made to individuals only, and none directly to Auxiliary Branches. However some contributing wished their branches to get the credit for their gifts, as follows:

## BY-LAWS.

I. The election of officers at the annual meeting shall be by ballot, each Parish or Mission having one vote.

### Amendment to By-Law No. 1.

Beginning with 1928 and thereafter on the even calendar years, the first, third, fifth, seventh and ninth Vice-Presidents, the Treasurer, Recording Secretary, the Chairman of Box Work, the Chairman of the Social Department and the Chairman of the Department of Education shall be elected by the Woman's Auxiliary at its Annual Meeting, to serve for a term of two years.

Beginning with 1929 and thereafter on the odd calendar years the President, second, fourth, sixth and eighth Vice-Presidents, the Corresponding Secretary, the Chairman of the Supply Department, the Chairman of the Speakers Bureau and the Director of the Monthly Meetings shall be elected by the Woman's Auxiliary at its Annual meeting to serve for a term of two years.

No member shall serve on the Executive Board (in the same office) more than two consecutive terms.

The United Thank Offering Director shall be elected for a term of three years, serving through a Tri-ennial Convention.

II. When a vacancy shall occur in the Executive Committee by death or resignation, or removal of residence from the Diocese, the members of said Committee shall have power, with the advice and consent of the Bishop previously obtained, to appoint an officer to fill the vacancy. The officer so appointed to serve until the next annual meeting.

III. Special meetings shall be called by the President, at such time and place as she may designate, for the purpose of stimulating interest in the work.

IV. It shall be the duty of every parochial branch to contribute annually a sum of money, the amount thereof to be determined by itself, to the Executive Committee of this Diocesan Branch, to be appropriated by them according to their discretion in the missionary work of the Church, which money shall constitute the General Fund of the Chicago Branch, and shall be so designated by the contributors.

V. The regular order of business at the annual meeting shall be as follows:

1. Office of devotion.
2. Calling of roll by branches.
3. Reading of minutes of last meeting.
4. Reports of officers and committees.
5. Election of officers.
6. Unfinished business.
7. Miscellaneous business and addresses.

VI. These by-laws may be amended at any annual meeting by a majority vote of the branches present.

Amendment to By-Law VI. The Annual Day of Prayer for Missions; the Annual Meeting; the Executive Committee and Monthly Meetings, heretofore held on fixed dates, will be subject to change, and for a sufficient reason may be held on dates to be determined by a majority vote of the Executive Committee, due notice of such change being given to all parochial branches.

VII. The Treasurer shall furnish bond for such amount as shall be determined by the Executive Committee, such bond to be paid for from the funds of the Woman's Auxiliary.

## CONSTITUTION.

### ARTICLE I.

#### Name.

The name of this organization shall be the .....  
Branch of the Woman's Auxiliary to the National Council.

### ARTICLE II.

#### Objects.

Its objects shall be:

- A. To cooperate with all of the plans undertaken by the National Council for the extension of Christ's Kingdom throughout the world.
- B. To supplement the work of the Diocesan Woman's Auxiliary to the National Council.
- C. To increase and deepen the spiritual life of the Parish by prayer, service and example.

### ARTICLE III.

#### Membership.

Any woman who endorses the projects named in Article II shall be eligible for active membership.

### ARTICLE IV.

#### Officers.

The officers shall be:

- President
- Vice President
- Secretary
- Treasurer
- Educational Secretary
- United Thank Offering Custodian
- Chairman of Box Work.

The President, Vice President, Educational Secretary, and U. T. O. Custodian shall be Communicants of the Church.

### ARTICLE V.

#### Duties of Officers.

Section 1. The President shall direct the work of the Branch; call meetings and preside over them; serve as head of a Committee on Plans for the Spiritual Development of the Branch; and be a member ex-officio of all Committees. She shall confer with the Diocesan Vice President of her District, reporting progress made and seeking counsel when desired.

Section 2. The Vice President shall preside in the absence of the President and shall act as Chairman of the Membership Committee.

Section 3. The Secretary shall give notices of meetings; keep records of them, and conduct the correspondence of the Branch. She shall send promptly acceptance or rejection of the allotment received from the Supply Department. She shall make reports at the Annual Meeting of the Branch, the Annual Meeting of the Parish, and to the Secretary of the Diocesan Branch.

Section 4. The Treasurer shall receive and disburse all funds except the United Thank Offering. She shall enter the amounts received in her books and pay out money only on the order of the Organization, preserving all vouchers. The books shall be audited annually.

Section 5. The Educational Secretary shall have charge of the study, reading, and general information. She shall attend the Diocesan Annual Course for Study Classes and conduct the Parish Class. She shall plan and conduct program meetings.

Section 6. The United Thank Offering Custodian shall make this offering known to all women of the Parish and distribute the boxes to them. The contents of these shall be presented at a Corporate Communion service semi-annually and immediately remitted to the Diocesan United Thank Offering Treasurer.

Section 7. The officers of the Branch shall meet regularly to confer upon the work of the Branch and plans for its development.

## ARTICLE VI.

### Meetings and Dues.

Section 1. The meetings of the Branch shall be held ..... (weekly, bi-monthly or monthly).

Section 2. Every baptized woman being automatically an Auxiliary member, shall designate the amount which she will voluntarily contribute to the financial program.

The Treasurer shall remit an annual due of one dollar (\$1.00) for the Branch to the Diocesan Treasurer.

Section 3. The Annual Meeting shall be held the first meeting in January.

## ARTICLE VII.

### Elections.

At the November meeting the President, with the approval of the Rector, shall appoint a Nominating Committee of three (3) members of the Auxiliary who shall report at the December meeting.

The election of officers shall be by a majority ballot at the annual meeting in January.

No officer may hold office longer than two (2) terms of two (2) years each. Vacancies occurring in any office shall be filled by the Executive Committee to serve until the next election.

## ARTICLE VIII.

### Order of Business.

The meetings shall be opened with prayer, which should include the Auxiliary and United Thank Offering prayers.

### SUGGESTIONS.

That this Constitution be read aloud once a year, preferably at the Annual Meeting.

That the larger Parishes be zoned by the U. T. O. Custodian, with a key-woman as Captain in each zone, thus increasing the scope of the Thank Offering work.

## ARTICLES OF INCORPORATION.

STATE OF ILLINOIS, } ss.  
COUNTY OF COOK.

To James A. Rose, Secretary of State:

We, the undersigned, Marie M. Hopkins, Emily Pardee Street and Frances E. McDermid, citizens of the United States, propose to form a corporation under the Act of the General Assembly of the State of Illinois entitled, "An Act Concerning Corporations," approved April 18, 1872, and all acts amendatory thereof, and that for the purpose of such organization, we hereby state as follows:

I. The name of such corporation is

**"The Chicago Branch of the Woman's Auxiliary to the National Council."**

II. The object of this corporation shall be: (a) To interest all of the congregations in the Diocese of Chicago in the different branches of missionary work, as conducted by the General and Diocesan Boards, and to the purpose of aiding said societies in carrying on the said missionary work in connection with the said Diocese and the said General Church. (b) An Auxiliary to the General Board of Missions and to the Board of Missions of the Diocese of Chicago of the Church known in law as "The Protestant Episcopal Church in the United States," and its management is to be in accordance with the constitution and canons of said Diocese of Chicago and of said Protestant Episcopal Church and not for pecuniary profit.

The corporation shall have power to receive donations, subscriptions, legacies and bequests to be used for the carrying on of the said missionary work and of the said Church in the said Diocese of Chicago and of the missionary work under the jurisdiction of the General Board of Missions of the Protestant Episcopal Church of the United States.

III. The Board of Managers shall have power to organize branches or recognize existing branches in every parish or mission in said Diocese under the rules as they may adopt from time to time. Any branch so organized, upon payment of the Annual Membership Fee, to be fixed from time to time by the By-Laws, shall be entitled to representation at the meetings of this Board, each Parish or Mission voting as a unit when demanded by two Parishes or Missions.

IV. (1) The officers of the Society shall be a Patron, a President, not less than five (5) Vice-Presidents, a Corresponding Secretary, a Recording Secretary and a Treasurer. (2) The Bishop of the Diocese shall be the Patron ex-officio.

V. The management of The Chicago Branch of the Woman's Auxiliary to the Board of Missions shall be vested in an Executive Board of not less than nine (9) nor more than twenty-one (21) Directors, of whom the Patron, the President, the Vice-President, the two Secretaries and the Treasurer shall be a part.

VI. (1) The Board of Directors shall consist of not less than nine (9) nor more than twenty-one (21) members, of whom the Bishop of said Diocese of Chicago shall, ex-officio, be one. All of the elective Directors shall be elected at the annual meeting of said corporation, which shall be held on the day after the close of the Diocesan Convention, except when the day falls on a legal holiday, when the Executive Committee of the Board shall appoint another day for the election of officers. The number of said Directors may, with the approval of the Bishop from time to time, be varied, and the Directors shall be elected in accordance with the statutes of the State of Illinois, and the By-Laws of said corporation, to be hereafter adopted. The Executive Committee shall meet monthly, except during the months of July and August.

(2) The Executive Committee shall have power, as necessity may arise, to appoint annually, with the approval of the Bishop, other officers, who shall not, however, be members of the Executive Committee.

(3) The duty of the President shall be to preside at all meetings of the Association and of the officers, to arrange for the organization of branches, to visit the same and to have the general charge of the work under the direction of the Bishop.

(4) The duty of the Vice-Presidents shall be to choose one of their number to preside in the absence of the President, to co-operate with her in the general supervision of the work of the Association and to take charge of the departments of work to which they may be assigned by the Executive Committee.

(5) The duty of the Corresponding Secretary shall be to conduct the necessary correspondence required by the Auxiliary, and to prepare such reports as are needed. The duty of the Recording Secretary shall be to send out notices of all meetings, to keep a record of the same, and to assist the Corresponding Secretary in the preparation of reports.

(6) The duty of the Treasurer shall be to receive all special and general funds; to disburse the former as the donors indicate, and the latter under the direction of the Executive Committee, and to render an account of the same at the annual meeting.

(7) There shall be a committee of two appointed to audit the Treasurer's accounts each year.

VII. The following persons are hereby selected as the directors to control and manage said corporation for the first year of its corporate existence:

Katharine D. Arnold, Vice-President.

Vincy B. Fullerton, Vice-President.

Emily Pardee Street, Vice-President.

Eleanor M. Duncombe, Vice-President.

Jessie Peabody Butler, Vice-President.

Frances E. MacDermid, Corresponding Secretary.

Addie S. Chenoweth, Recording Secretary.

Emma J. Hoyne, Treasurer.

The said Directors shall hold office until the next annual meeting of said corporation and shall then be elected at the said annual meeting herein provided.

VIII. The Bishop of the Diocese of Chicago shall ex-officio be the Patron of the said corporation, and all of the acts of the Executive Committee and Society shall be subject to his approval.

IX. These Articles of Incorporation may be altered or amended at any annual meeting by a vote of two-thirds of the members present, subject to the approval of the Bishop, and by complying with the statutes of the State of Illinois.

X. The location is in the Diocese of Chicago, in the County of Cook, in the State of Illinois, and postoffice address of its business office is at No. 510 Masonic Temple, State Street, Chicago, Illinois.
