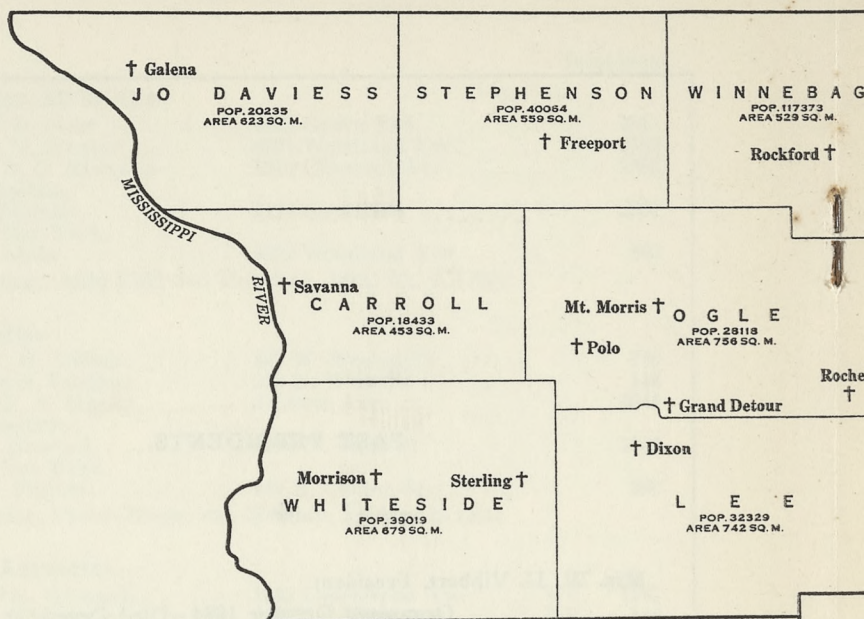

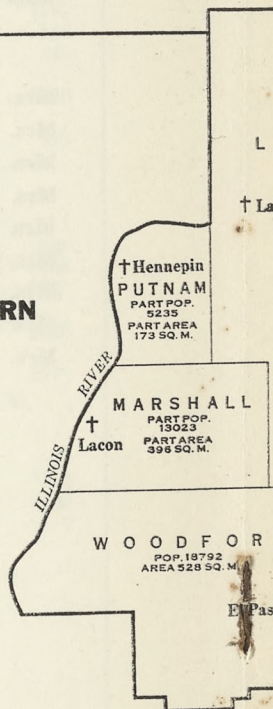

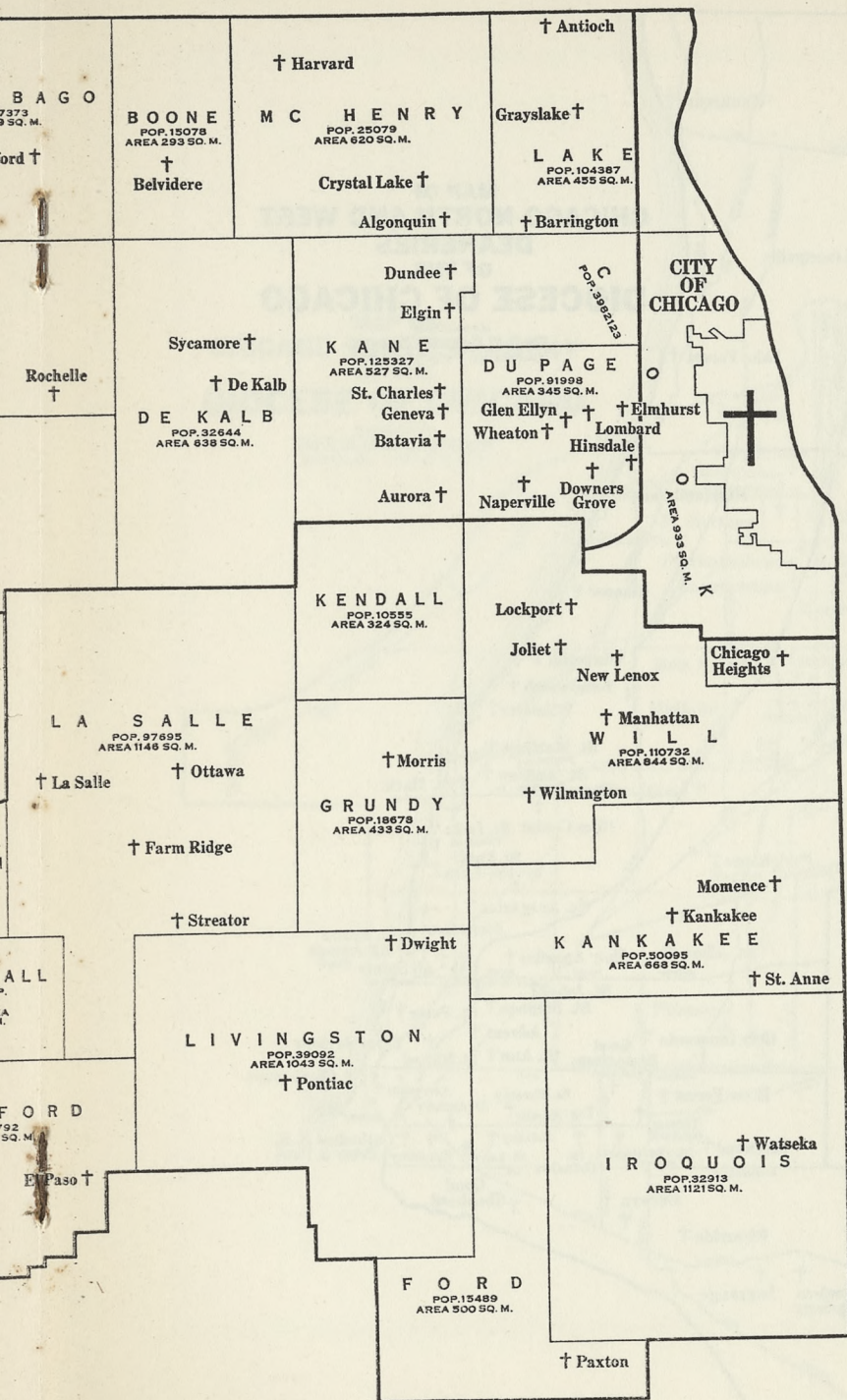


**MAP OF

DEANERIES**

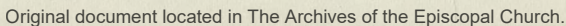

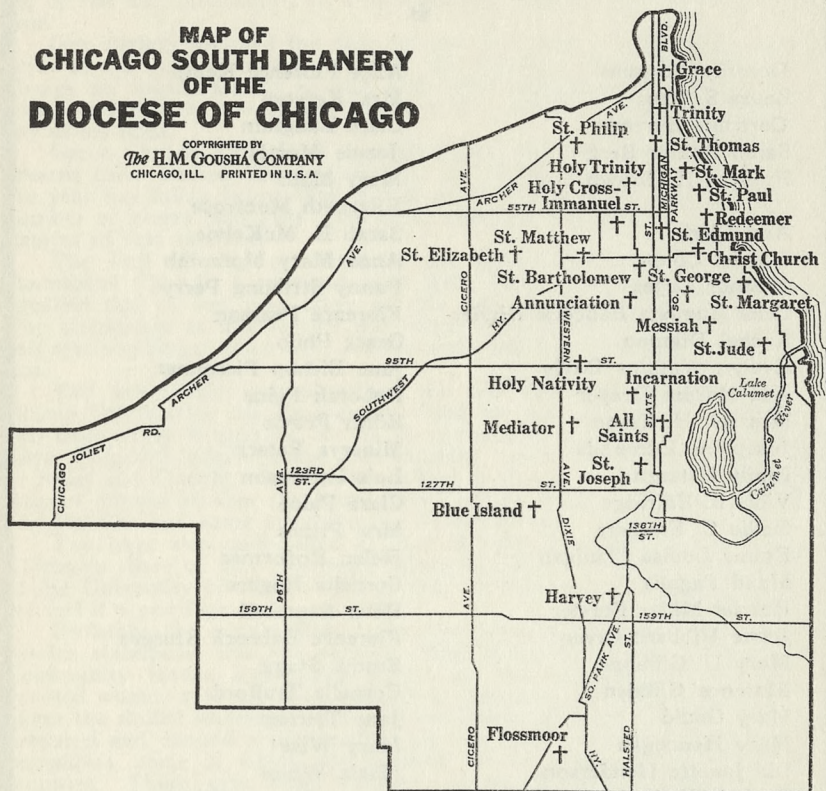

PRESIDENT'S REPORT.

Through a rift in the dark clouds which have so persistently enveloped the world, has shone Christ's body, His Church, a beacon calling us to greater service, stirring in us new life, reminding us that this path along which we are stumbling, leads, if we follow the light to a new day, and the women of the Auxiliary have seen and followed.

There has been no note of gloom or depression, no fear seen nor felt among us. Courage, enthusiasm, whole-hearted co-operation, sacrificial giving of self and possessions to a most unusual degree, has characterized the year.

Our Bishop sounded the note for our new year's endeavour in his address at our Annual meeting held at the Church of the Redeemer. He is always an inspiration to us and with the strength and vision of such a leader and mentor one cannot conceive of a supine attitude on the part of any of his flock.

Grace Church, Oak Park was filled last May with those who came to present their United Thank Offering, and while the amount given during the year has fallen below that of last year, there is a large increase in the number of givers, and gifts from small parishes and missions that bear the imprint of real sacrifice.

The Fall offering presented at the Quiet Day held in October at Emmanuel Church, La Grange with Rev. Alfred Newberry as Conductor, equalled that of last year taken at this time, quite a notable achievement. The attendance at this service was larger than at any previous Quiet Day and was significant when bad weather and distance are taken into consideration.

You generously oversubscribed the one thousand dollars pledged to Bishop Stewart for his Emergency Fund for our Church Institutions and you have made it possible for us to continue our monthly stipend to the Sister Elizabeth who is doing such excellent work with the women prisoners at Joliet and Dwight. You have enabled us too to contribute to Deaconess Adams' stipend so that the Rural Work she is doing shall have recognition and stability and some provision for its continuance.

You have also undertaken as part of your Auxiliary Special this year Chicago's share of Mrs. Davison's salary for her work in our student centre at the University of Illinois—a fine piece of missionary endeavour in which we feel it a privilege to have a part.

Probably the outstanding accomplishment of the year from a social service standpoint was the venture called Friendly Farms. At St. James' Community House, generously loaned for the purpose, large numbers of devoted women met two days each week during all the heat of summer, and, under the skilled leadership of Mrs. John Harris of Grace Church, Oak Park, prepared and canned approximately six thousand tins and jars of fruit and vegetables, some of which was donated by our missions in farming communities. There were other canning centres as well and the amount of canned goods sent our Church Institutions reached the large sum of ten thousand quart tins. Supplementing this were the jars and glasses entered by individuals and groups in the International Canning Contest at Aurora, where we were the fortunate winners of the five hundred dollar prize for the largest number of entries from one County, as well as a very handsome silver trophy. These jars, to the number of about two thousand, were returned to us for distribution, increasing the amount previously prepared to the approximate total of twelve thousand. There can be no doubt that this was a labor of love. The cheerful, enthusiastic co-operation manifested was noteworthy. No request of whatever nature met with anything but a cheerful compliance, and the fellowship of working together as the weeks passed— young women just out of college and members of St. Anna's Branch from

the Church Home for the Aged—was no insignificant part of the venture. The constant and enthusiastic co-operation of Dr. Randall in this undertaking deserves more than passing recognition and appreciation.

The Provincial Conferences held at Brent House in April were stimulating, and we wish that more had taken advantage of this opportunity for spiritual refreshment. Bishop Creighton and Mr. Franklin brought us many ideas to digest and assimilate and we can always learn from the workers in other dioceses and enjoy the fellowship which our common task creates. We have in Brent House a conference centre of which we may well be proud, but the Church in this diocese is not yet awake to the opportunities here offered for interchange of ideas and fellowship with gifted Orientals as well as intellectual stimulus of value. The lecture course given by men of proven ability on a variety of subjects during the past three months, to continue for a month or so longer, have been enthusiastically acclaimed by those privileged to hear them.

The Scholarships which some of you provided, permitted several women to attend the Racine Conference which all agree was outstanding in its spiritual opportunities.

Five delegates and one alternate attended the Provincial meeting at Cleveland in October where attention was largely focused on work with and for the young woman. The Questionnaire sent out by your first Vice-president relative to opportunities offered in the different parishes to our young women for stimulating work, which alone will enlist their co-operation, should bear fruit in due time.

The Study Class for Leaders under the able guidance of Mrs. E. J. Randall, with a registration of over fifty, has exceeded any previous class in attendance and interest manifested and should awaken an understanding and sympathetic attitude toward our Indian Missions as we realize the great opportunities and responsibility of the Church to these her children. This attendance would seem to indicate a determination to build up an alert and enlightened membership.

The members have not as yet become aware of the Diocesan Lending Library which was founded by the Auxiliary last year, as reflected in the number of books taken out, but we hope this year may witness an increase in readers and donors, which may well be anticipated if we have a better equipped room for its housing, as is our expectation. The Church Periodical Club has co-operated with gifts of books and is eager to serve in making this venture a vital force in the Diocese.

We have rejoiced at the attendance at the Monthly Meetings which has shown a large increase numerically and in the number of parishes represented. We would again lay stress on the educational as well as the inspirational advantages offered at these meetings and urge you to secure the attendance of your whole group during the year with notes carried back to the Branch for information and discussion.

We welcome four new Branches to our fellowship and rejoice that during the past year three young women have gone from this diocese to the mission field.

The Board Meetings have had an almost one hundred per cent attendance and we have had the privilege of reports from the Girls Friendly Society and the Church Periodical Club from their Chairmen who have attended most of our meetings. Your officers have faithfully administered their responsibilities, and no small part of the success of the U. T. O., the Supply Department and the Study Class is due to the devoted efforts of the Chairmen of these groups.

Your President has presided at all meetings of the Society and the Board, attended all meetings of the Church Extension Committee, many of the canning meetings and most of the meetings of the Archdeacons' Committee for Rural Work and the Social Service Council. She has visited many parishes and missions near and remote. It was her privilege to address the members of the Auxiliary of the Diocese of Fond du Lac at

their Annual Meeting, the members of the Southern Deanery in October and the Council of the Girl's Friendly Society. She had the privilege of addressing the Church Club at the dinner in May and has represented our Church at the deliberations preparatory to the exhibit of missions at the Century of Progress Exposition.

She has been made aware at all times of your loyalty and devotion to your task and co-operation with her in every plan undertaken, which has made her office a real privilege for which she is grateful.

As we look forward hopefully to a new year, may it be with a determination to witness to Him each and every day by consistent Christian living and with the song in our hearts—

"I fear no foe with Thee at hand to bless
Ills have no weight and tears no bitterness."

REPORT OF THE SUPPLY DEPARTMENT.

Seven monthly meetings have been held at Supply Department headquarters—each with an interested group attending.

It is difficult to tell in figures all the activities involved in carrying on the work of the Department—the extent of the Box work—keeping records of each Parish's achievements and of each Mission's needs—which data are statistical records of the Woman's Auxiliary of this Diocese.

The past year shows several new groups joining with us in our work.

You will be gratified to know the value of your Mission work in the "five fields" for the current year amounts to \$24,175.02. Of this amount—\$7,681.00 for Parish, \$5,453.21 for Community, \$5,073.92 for Diocese, \$5,436.16 for Nation and \$529.73 for World.

It seems only just to speak again of the splendid response to the shower for St. Luke's Hospital, Shanghai, last May, to which many so generously contributed.

Reports for the Diocesan Pantry show 93 Parishes contributing 4,667 glasses of jelly—value \$700.05.

Surgical Dressing report 10,391 dressings made during the past year.

With the constant demand for mittens and sweaters, we make an urgent plea for offers to knit these articles. We can supply the wool at reduced cost.

The Church Periodical Club has had a tea and books were contributed and the Woman's Auxiliary has bought what we could and we hope that you will find the Library more and more useful as times goes on.

REPORT OF DIRECTOR OF MONTHLY MEETINGS.

During 1932 there were seven monthly meetings held at Roosevelt Hall in the State-Lake Building. The Annual meeting was held at Church of The Redeemer and as the attendance was less than formerly the average attendance for the whole years meetings was 176 or 7 less than the average of the previous year. The attendance at the monthly meetings was better than ever before and showed an increase in general interest as they represented more parishes than in former years.

The speakers of the year were Bishop Stewart, Archdeacon Ziegler, Miss Heyden, Mrs. Wetmore, Mrs. Larkham, Dean Ness, Mrs. Biller, Miss Hazzard, Father Plummer, Deaconess Fuller, Mrs. Hebley, Bishop Moulton, Bishop Gray, and Father Gerhart.

The subjects discussed were wide in scope. Our own City and Diocesan Missions, Work among the Mountaineers, Prison work, Oriental and other University Student work, Family Life, Work for the Prevention of Blindness and Russia.

The Quiet Day held at Emmanuel, LaGrange, was conducted most helpfully by Father Newberry and was well attended.

In spite of the increase in parishes represented at the meetings there are still far too many parishes who had no representation at any meeting during the year. They are Batavia, DeKalb, Dixon, El Paso, Farm Ridge, Galena, Grays Lake, Harvard, Hinsdale, Kankakee, LaSalle, Momence, New Lenox, Ottawa, Pontiac, Rockford, Sterling, Streator, and Sycamore. In Chicago, All Angels, Calvary, Incarnation, St. Ambrose and St. Stevens. Of course those towns that lie far from Chicago cannot be expected to send representatives although they are most welcome. Suburban and local churches should for their own good co-operate with the Diocesan Branch by at least occasional attendance at the Diocesan meetings.

The parishes which attained the Honor Roll for attendance in the past year are: Grace, Oak Park, 87; St. Paul's, Kenwood, 76; Atonement, 69; St. Mark's Evanston, 65; Mediator, 64.

Redeemer, our host last year had 83 for the year, but as 50 of those were hostesses at the annual meeting, they could hardly be compared with the other parishes for a yearly average.

REPORT OF THE CHURCH PERIODICAL CLUB.

The Church Periodical Club of the Diocese of Chicago has held seven meetings with an average attendance of fourteen secretaries. Mrs. David Larcomb, our Provincial Secretary, conducted a course on methods at our convention meeting in January.

We have co-operated with Archdeacon Ziegler and Deaconess Adams in supplying prayer books, bibles, magazines, cards and church school materials for their work with the isolated, and with the Woman's Auxiliary and the Diocesan Loan Library. We have sent odd magazines, scrapbooks and cards to twenty-three institutions in the Diocese. \$655.41 has been collected and spent for books, magazines, and the Endowment Fund.

I have visited 12 parishes in the Diocese. I have had the hearty co-operation of Mrs. H. G. Armstrong, Assistant Director, and Mrs. Roland Wilder, Secretary-Treasurer, and thirty-one parish secretaries.

The following report will show a very splendid increase over last year due to the persistence of the parish secretaries through these trying times.

REPORT OF THE DEACONESS DISCRETIONARY FUND FOR 1932.

Another year has passed since last report of the Deaconess Discretionary Fund was written, it has been a hard one for everybody, certainly for the City Mission Deaconesses.

Money has never been so late coming in, making it impossible for the Treasurer to assure them of any regular monthly sum.

Twelve Auxiliary branches giving in 1931, failed to do so in 1932. 27 decreased the amount of their contributions, these made a considerable loss in the receipts.

Fifty-five gave same as before, and 6 generously increased theirs, 5 that had not given recently started again, and we were pleased to add 7 new Mission branches and Guilds to our list, all with few members, but they gave generously: one Treasurer wrote "we have only six members, but we gladly send \$2.00, and hope next year we can do more."

From 100 Branches and Guilds we received \$881.00, 2 friends gave \$17.00, offering at regular May meeting of Diocesan Auxiliary of \$32.00 was given to our Fund, and Bishop Stewart gave \$100.00 from his Diocesan Poor Fund, (this was surely a great help) making total receipts \$1,035.00, over \$250.00 less than in 1931. There are still 5 branches that have never given, we wish they would, as we need them.

Every week as visits are made by the Deaconesses in their special Institutions, or on their people outside, they find more needing some help; never is anything one could possibly call a luxury asked for, they are real necessities, and the Deaconess can only supply a few of them, and more often has to tell those in need, that she cannot help as money all gone; just imagine how she feels when obliged to do this; it is heart-rending, for we are ministering to them in Christ's Name, for our Church, of which most are members.

Sick people, especially those with Tuberculosis often need something to tempt them to eat, fruit, ice cream, a dainty sandwich, etc., such little things, but with no way to get extras if their Deaconess cannot supply, so she often buys them herself, but cannot for all.

We have 25 Institutions now on our City Mission list, the last new one is the Municipal Tuberculosis Home, for men only, two Deaconesses visit there, and tell me they find most of the hundred men destitute, with insufficient clothing, and no money to even get little personal toilet necessities, and they have not sufficient monthly allowance to be able to supply them.

Each of the four active Mission Deaconesses visit from four to eight Institutions weekly (2 going together to 4 large ones) so they are in close touch with several hundred of these people (men, women, and children)

every month; you can see she cannot do much for anyone, even if she had \$20.00 a month regularly, (which at present is not possible) though with the exception of about \$15.00 a year for postage and necessary supplies for the Treasurer, every dollar given to the Deaconess Discretionary Fund is used for relief of the City Mission poor and sick people.

The appeals for 1933 are all sent now to every Auxiliary Branch and Guild in the Diocese; may I beg each President to urge everyone of her members to give something, even if amount it small. Cannot, and will not every one sacrifice some personal pleasure, and give the cost to our Fund, so we can help more people.

Let it be said of every woman in 1933, "She hath done what she could," "Give and it shall be given unto you"; God never forgets His promises, and the more we give the more we shall receive, both in this world, and in the next. Every day He is caring for each one of us, must we not do our part by caring for His less fortunate children.

I earnestly pray all of you not to let our plea for them be in vain.

With so many appeals being made, there was much misgiving as to whether results would justify sending out as in former years the special appeal for the Christmas Fund, (this is entirely distinct from the Deaconess Discretionary Fund, and goes to individuals only); without the extra money the Deaconesses could have done very little to make the Holy Season happier for their poor and sick City Mission people; so the letters were sent with prayers that those receiving them would respond as generously as possible.

We were surely pleased as returns came in from over two-thirds of those written to; several checks were smaller than in 1931, yet with amount received, and some special gifts sent us, we were able to make between three and four thousand persons, (men, women, and children) happier for being remembered in some way, even if gifts were small; we supplied some urgent needs, though not to extent we did the year before.

BY-LAWS.

I. The election of officers at the annual meeting shall be by ballot, each Parish or Mission having one vote.

Amendment to By-Law No. 1.

Beginning with 1928 and thereafter on the even calendar years, the first, third, fifth, seventh and ninth Vice-Presidents, the Treasurer, Recording Secretary, the Chairman of Box Work, the Chairman of the Social Department and the Chairman of the Department of Education shall be elected by the Woman's Auxiliary at its Annual Meeting, to serve for a term of two years.

Beginning with 1929 and thereafter on the odd calendar years the President, second, fourth, sixth and eighth Vice-Presidents, the Corresponding Secretary, the Chairman of the Supply Department, the Chairman of the Speakers Bureau and the Director of the Monthly Meetings shall be elected by the Woman's Auxiliary at its Annual meeting to serve for a term of two years.

No member shall serve on the Executive Board (in the same office) more than two consecutive terms.

The United Thank Offering Director shall be elected for a term of three years, serving through a Tri-ennial Convention.

II. When a vacancy shall occur in the Executive Committee by death or resignation, or removal of residence from the Diocese, the members of said Committee shall have power, with the advice and consent of the Bishop previously obtained, to appoint an officer to fill the vacancy. The officer so appointed to serve until the next annual meeting.

III. Special meetings shall be called by the President, at such time and place as she may designate, for the purpose of stimulating interest in the work.

IV. It shall be the duty of every parochial branch to contribute annually a sum of money, the amount thereof to be determined by itself, to the Executive Committee of this Diocesan Branch, to be appropriated by them according to their discretion in the missionary work of the Church, which money shall constitute the General Fund of the Chicago Branch, and shall be so designated by the contributors.

V. The regular order of business at the annual meeting shall be as follows:

1. Office of devotion.
2. Calling of roll by branches.
3. Reading of minutes of last meeting.
4. Reports of officers and committees.
5. Election of officers.
6. Unfinished business.
7. Miscellaneous business and addresses.

VI. These by-laws may be amended at any annual meeting by a majority vote of the branches present.

Amendment to By-Law VI. The Annual Day of Prayer for Missions; the Annual Meeting; the Executive Committee and Monthly Meetings, heretofore held on fixed dates, will be subject to change, and for a sufficient reason may be held on dates to be determined by a majority vote of the Executive Committee, due notice of such change being given to all parochial branches.

VII. The Treasurer shall furnish bond for such amount as shall be determined by the Executive Committee, such bond to be paid for from the funds of the Woman's Auxiliary.

ARTICLES OF INCORPORATION.

STATE OF ILLINOIS, } ss.

To James A. Rose, Secretary of State:

We, the undersigned, Marie M. Hopkins, Emily Pardee Street and Frances E. McDermid, citizens of the United States, propose to form a corporation under the Act of the General Assembly of the State of Illinois entitled, "An Act Concerning Corporations," approved April 18, 1872, and all acts amendatory thereof, and that for the purpose of such organization, we hereby state as follows:

I. The name of such corporation is

"The Chicago Branch of the Woman's Auxiliary to the National Council."

II. The object of this corporation shall be: (a) To interest all of the congregations in the Diocese of Chicago in the different branches of missionary work, as conducted by the General and Diocesan Boards, and to the purpose of aiding said societies in carrying on the said missionary work in connection with the said Diocese and the said General Church. (b) An Auxiliary to the General Board of Missions and to the Board of Missions of the Diocese of Chicago of the Church known in law as "The Protestant Episcopal Church in the United States," and its management is to be in accordance with the constitution and canons of said Diocese of Chicago and of said Protestant Episcopal Church and not for pecuniary profit.

The corporation shall have power to receive donations, subscriptions, legacies and bequests to be used for the carrying on of the said missionary work and of the said Church in the said Diocese of Chicago and of the missionary work under the jurisdiction of the General Board of Missions of the Protestant Episcopal Church of the United States.

III. The Board of Managers shall have power to organize branches or recognize existing branches in every parish or mission in said Diocese under the rules as they may adopt from time to time. Any branch so organized, upon payment of the Annual Membership Fee, to be fixed from time to time by the By-Laws, shall be entitled to representation at the meetings of this Board, each Parish or Mission voting as a unit when demanded by two Parishes or Missions.

IV. (1) The officers of the Society shall be a Patron, a President, not less than five (5) Vice-Presidents, a Corresponding Secretary, a Recording Secretary and a Treasurer. (2) The Bishop of the Diocese shall be the Patron ex-officio.

V. The management of The Chicago Branch of the Woman's Auxiliary to the Board of Missions shall be vested in an Executive Board of not less than nine (9) nor more than twenty-one (21) Directors, of whom the Patron, the President, the Vice-President, the two Secretaries and the Treasurer shall be a part.

VI. (1) The Board of Directors shall consist of not less than nine (9) nor more than twenty-one (21) members, of whom the Bishop of said Diocese of Chicago shall, ex-officio, be one. All of the elective Directors shall be elected at the annual meeting of said corporation, which shall be held on the day after the close of the Diocesan Convention, except when the day falls on a legal holiday, when the Executive Committee of the Board shall appoint another day for the election of officers. The number of said Directors may, with the approval of the Bishop from time to time, be varied, and the Directors shall be elected in accordance with the statutes of the State of Illinois, and the By-Laws of said corporation, to be hereafter adopted. The Executive Committee shall meet monthly, except during the months of July and August.

(2) The Executive Committee shall have power, as necessity may arise, to appoint annually, with the approval of the Bishop, other officers, who shall not, however, be members of the Executive Committee.

(3) The duty of the President shall be to preside at all meeting of the Association and of the officers, to arrange for the organization of branches, to visit the same and to have the general charge of the work under the direction of the Bishop.

(4) The duty of the Vice-Presidents shall be to choose one of their number to preside in the absence of the President, to co-operate with her in the general supervision of the work of the Association and to take charge of the departments of work to which they may be assigned by the Executive Committee.

(5) The duty of the Corresponding Secretary shall be to conduct the necessary correspondence required by the Auxiliary, and to prepare such reports as are needed. The duty of the Recording Secretary shall be to send out notices of all meetings, to keep a record of the same, and to assist the Corresponding Secretary in the preparation of reports.

(6) The duty of the Treasurer shall be to receive all special and general funds; to disburse the former as the donors indicate, and the latter under the direction of the Executive Committee, and to render an account of the same at the annual meeting.

(7) There shall be a committee of two appointed to audit the Treasurer's accounts each year.

VII. The following persons are hereby selected as the directors to control and manage said corporation for the first year of its corporate existence:

Emma J. Hoyne, Treasurer.

The said Directors shall hold office until the next annual meeting of said corporation and shall then be elected at the said annual meeting herein provided.

VIII. The Bishop of the Diocese of Chicago shall ex-officio be the Patron of the said corporation, and all of the acts of the Executive Committee and Society shall be subject to his approval.

IX. These Articles of Incorporation may be altered or amended at any annual meeting by a vote of two-thirds of the members present, subject to the approval of the Bishop, and by complying with the statutes of the State of Illinois.

X. The location is in the Diocese of Chicago, in the County of Cook, in the State of Illinois, and postoffice address of its business office is at No. 510 Masonic Temple, State Street, Chicago, Illinois.

SUGGESTED CONSTITUTION FOR BRANCHES.

ARTICLE I.

Name.

The name of this organization shall be the
Branch of the Woman's Auxiliary to the National Council.

ARTICLE II.

Objects.

Its objects shall be:

A. To cooperate with all of the plans undertaken by the National Council for the extension of Christ's Kingdom throughout the world.

B. To supplement the work of the Diocesan Woman's Auxiliary to the National Council.

C. To increase and deepen the spiritual life of the Parish by prayer, service and example.

ARTICLE III.

Membership.

Any woman who endorses the projects named in Article II shall be eligible for active membership.

ARTICLE IV.

Officers.

The officers shall be:

President
Vice President
Secretary
Treasurer
Educational Secretary
United Thank Offering Custodian
Chairman of Box Work.

The President, Vice President, Educational Secretary, and U. T. O. Custodian shall be Communicants of the Church.

ARTICLE V.

Duties of Officers.

Section 1. The President shall direct the work of the Branch; call meetings and preside over them; serve as head of a Committee on Plans for the Spiritual Development of the Branch; and be a member ex-officio of all Committees. She shall confer with the Diocesan Vice President of her District, reporting progress made and seeking counsel when desired.

Section 2. The Vice President shall preside in the absence of the President and shall act as Chairman of the Membership Committee.

Section 3. The Secretary shall give notices of meetings; keep records of them, and conduct the correspondence of the Branch. She shall send promptly acceptance or rejection of the allotment received from the Supply Department. She shall make reports at the Annual Meeting of the Branch, the Annual Meeting of the Parish, and to the Secretary of the Diocesan Branch.

Section 4. The Treasurer shall receive and disburse all funds except the United Thank Offering. She shall enter the amounts received in her books and pay out money only on the order of the Organization, preserving all vouchers. The books shall be audited annually.

Section 5. The Educational Secretary shall have charge of the study, reading, and general information. She shall attend the Diocesan Annual Course for Study Classes and conduct the Parish Class. She shall plan and conduct program meetings.

Section 6. The United Thank Offering Custodian shall make this offering known to all women of the Parish and distribute the boxes to them. The contents of these shall be presented at a Corporate Communion service semi-annually and immediately remitted to the Diocesan United Thank Offering Treasurer.

Section 7. The officers of the Branch shall meet regularly to confer upon the work of the Branch and plans for its development.

ARTICLE VI.

Meetings and Dues.

Section 1. The meetings of the Branch shall be held (weekly, bi-monthly or monthly).

Section 2. Every baptized woman being automatically an Auxiliary member, shall designate the amount which she will voluntarily contribute to the financial program.

The Treasurer shall remit an annual due of one dollar (\$1.00) for the Branch to the Diocesan Treasurer.

Section 3. The Annual Meeting shall be held the first meeting in January.

ARTICLE VII.

Elections.

At the November meeting the President, with the approval of the Rector, shall appoint a Nominating Committee of three (3) members of the Auxiliary who shall report at the December meeting.

The election of officers shall be by a majority ballot at the annual meeting in January.

No officer may hold office longer than two (2) terms of two (2) years each. Vacancies occurring in any office shall be filled by the Executive Committee to serve until the next election.

ARTICLE VIII.

Order of Business.

The meetings shall be opened with prayer, which should include the Auxiliary and United Thank Offering prayers.
