






**MAP OF

PRESIDENT'S REPORT.

To evaluate the achievements of this past year it would seem that we must keep in mind effort expended, rather than results achieved. We have one and all labored under so many handicaps.

Our annual meeting held on February ninth at St. Luke's Pro-Cathedral is a case in point. From the standpoint of numbers it was the smallest in years, but because of the severe cold and deep snow, it required some degree of heroism on the part of those who came, some from a considerable distance. The picture Miss Elizabeth Mathews, President of the Fifth Province of the Woman's Auxiliary, drew of the church in Jerusalem and the stirring address of our beloved Bishop were adequate reward for effort made.

The presentation of the United Thank Offering at St. Mark's, Evanston, in May with Bishop Stewart as celebrant and a sermon by the Rev. George Ridgeway with Miss Helen Boyle of Japan as the afternoon speaker, was well attended, as it always is. Our U. T. O. Custodian is disappointed when our offerings fall below our former mark and yet, considering the times, we feel grateful for the sacrifices that we know were made by many, especially the small parishes and missions, and for the number of new givers.

As one evidence of spiritual vitality and growth, the attendance at the Quiet Day at St. Barnabas Church in October when Fr. White gave us some very helpful and unusual meditations, and the practically universal observance of the day of Intercession on November 11th was significant. The appreciation of these opportunities for spiritual refreshment is a measure of our desire to follow more closely the life and example of our Blessed Lord. It is greatly to be hoped that the number of these Retreats and Quiet Days may be increased.

Your interest in religious education has been shown by your continued gifts to the Auxiliary Special which has made it possible to keep Mrs. Davison in the student centre at the University of Illinois at Urbana, where she is literally "holding the line" now that there is no rector at St. John's Church and Fr. Miller is trying to do double duty. We have all desired to show our gratitude to Mrs. Randall for the remarkably fine course she gave for our Mission Study leaders. The attendance at these classes was consistently the largest for many years, which was an expression of appreciation on the part of those who came.

Lack of funds has prevented the addition of many books to the Diocesan Lending Library, but the number on the shelves is still adequate to meet the demand. We wish it were otherwise. A membership clamoring for reading matter might produce the wherewithal to satisfy the craving.

Your monthly gifts toward Deaconess Adams' stipend has put her truly outstanding work on a more stable basis. Could you but accompany the Sister Mary Elizabeth on some of her visits to the Women's Reformatory at Dwight, you would indeed rejoice that by your gifts to her you can have a share in the constructive Christian character building she is doing. Some kind of organization should be worked out, a sort of Big Sister plan, by which the discharged inmates can be given a helping hand until they are established in some way. It is to be hoped the Woman's Auxiliary can have a share in bringing this about.

It is our hope that this coming year we can enlist some of our young women in social service work following up the religious ministrations of our deaconesses in our county institutions and a consignment impetus to the growth of the Deaconess Discretionary Fund.

The call to a new line of endeavor as hostesses in our booth at the Hall of Religion during The Century of Progress Exposition, was answered with enthusiasm by approximately six hundred women and the assigned hours kept with fidelity. This has been a service which has already reaped a harvest of souls brought to baptism and will be productive of more spiritual blessings than we shall ever know. For your gracious and loyal co-operation we are most grateful.

Again Friendly Farms has received your generous support all through the summer's heat and at a time when you were on duty at the Fair. If we were not as fortunate in our competition with other groups as last year, still we are grateful for the third prize which will cover most of our expenses. The fruit and vegetables canned will be a valuable aid in tiding our church institutions over a difficult winter, and so efficiently was the work organized by Mrs. Edward J. Blair with the assistance of Mrs. John Harris that it did not fall heavily on any one individual or group. It is to be hoped that this efficient aid to our institutions and indirectly to our Bishop will be maintained so long as the emergency exists.

The Provincial Conference at South Bend, Indiana, in October was attended by a full delegation of five members. These conferences are not judicial, but inspirational and are a source of renewed courage and zeal for the common task we all share. It would be helpful if many more than those serving as delegates could attend these conferences.

We rejoice in the addition of two new branches during the year, St. Ann's at Woodstock and one in Morris, and welcome them to our fellowship in the hope that they will find no task more thrilling than that of being fellow-workers together with Him.

Our monthly meetings have had an increasingly large and representative attendance and we would urge upon all branches the wisdom of regularly appointed delegates to these meetings, the personnel to be constantly changed, and reports brought back, as a means of increased interest and enthusiasm.

Your chairman has attended all meetings of the Church Extension Committee save three and most of those of the Social Service Council and the Archdeacon's Committee. She has been unavoidably absent during five Board meetings and has also had to delegate to your First Vice-President the task of presiding at a like number of monthly meetings. As your representative, she has served on the Bishop's Pence Committee, which new endeavor is receiving your loyal support.

Your officers have been faithful in their attendance at meetings and unsparring in their efforts to co-operate with you in so far as you give them opportunity.

This Annual Meeting brings to a close five years of service which you have vouchsawed your chairman. The word is used advisedly. No field of endeavor in which she has ever been engaged has brought her the joy that has this opportunity of working with you for our Lord and Master and she is grateful for the privilege.

She would here pay tribute to the loyalty and devotion of our fellow officers and to each and every member of the Auxiliary who has shared with her in this inspiring work.

This is our Golden Anniversary. Fifty years is a long span in the life of an organization in as new a city as ours. As we round this mile stone and note the progress the years have wrought, let us go forward into a new cycle with our goal, a better informed membership in the church's work, teachings and worship, more emphasis on personal sanctification as our missionary opportunity and less on programs and finance, more prayers and meditation and more frequent communions as a means to this end, so may we go from strength to strength until we come at last into His everlasting Kingdom.

1933 REPORT OF THE SUPPLY DEPARTMENT.

There have been six meetings of the Advisory Committee during the past year.

Although Auxiliary Branches have not been officially formed, we are pleased to report work being done at Rochelle, Ill. and St. Simon's Evening Guild, Chicago, while two new branches have been formed at Morris, Ill. and Woodstock, Ill.

The department has furnished, without charge, material for sewing to thirty-one branches.

Miss Gertrude Hoag, chairman of Surgical Dressings, reports Auxiliary Branches have made 2,856 gauze dressing and 301 muslin bandages.

Miss Mary Brown, chairman Diocesan Pantry, reports 126 duplex cards were sent to Auxiliary Branches during September, and 84 of these reported sending to our institutions 4,005 glasses of jellies and jams. In addition \$46.20 was sent to St. Luke's Hospital.

The splendid work of St. Luke's Junior Auxiliary was most helpful, when we had our exhibit at the annual meeting and convention in February.

The value of your mission work in the five fields this year amounted to \$34,075.80. Of this amount \$19,603.89 for Parish, \$3,411.05 for Community, \$6,147.54 for Diocese and \$4,677.30 for Nation and \$236.02 for World.

In Chicago, All Angels, Calvary, Holy Innocents, St. Alban's, St. Luke's and St. Phillip's. The parishes who were so splendidly represented were Grace Church, Oak Park, 99; St. Paul's, Kenwood, 71; St. Luke's, Evanston, 67; Atonement, 58; St. Peter's, 53; Redeemer, 49; Mediator, 44; St. Mark's, Evanston, 43.

I might mention St. Luke's, Evanston, our host last February had 50 members in attendance, also St. Mark's, Evanston, who had the U. T. O. gathering had 50 members in addition to their monthly attendance.

REPORT OF THE CHURCH PERIODICAL CLUB.

The Church Periodical Club held six meetings with an average attendance of fourteen secretaries. An exhibit was on display at the Fair one day in each of the four months at which the officers presided.

We have co-operated with the Department of Religious Education and with Archdeacon Ziegler in work among the rural people. We have supplied bunch magazines, playing cards, books, calendars, puzzles, and scrapbooks for 37 institutions in the Diocese, also supplying good reading material for the boys in the Reforestation Camps. \$468.28 has been spent for magazine subscriptions, books and the Endowment Fund.

I visited parishes of Emmanuel Church, LaGrange, Old People's Home at Wilmington, St. Matthew's, Evanston, Trinity, Wheaton, All Saints', Ravenswood, St. Peter's, St. Barnabas', and Christ Church, Joliet. The last four now have C. P. C. secretaries and are doing splendid work.

I have had the splendid co-operation of Mrs. Henry G. Armstrong and Mrs. Robert Wilder and 35 parish secretaries.

REPORT OF AUXILIARY SPECIAL.

The Auxiliary Special is, as you will remember, the fund which takes the place of the Corporate Gift. The asking for the past year was \$1,000.00, \$660 for Mrs. Davidson's salary for her work among the students at the University of Illinois, and the remainder for the Bishop's Emergency Relief Fund. The asking of 1,000.00 was distributed over 86 parishes according to their abilities. As chairman for this fund I sent out 86 personal appeals to the parishes, and waited optimistically for the returns. My first reply was St. Chrysostom's, who most graciously and pleasantly sent in their whole quota, which incidentally was one-tenth of the whole. Others followed, but alas, many of whom I was most confident, failed to respond. In all, 48 of the 86 parishes paid their quota, \$616.00 of the \$1,000.00 came in. Mrs. Davidson's money had to be made up from other funds and the poor Bishop's Fund was entirely neglected.

It was of course a terrible year to raise money, but if each branch who failed to respond had given one bake sale or what have you the full amount would have come in. The branches who paid were in most cases those where financial stress is greatest and the more favored are among those missing. It is with much chagrin that I report the results of my efforts.

REPORT OF SOCIAL SERVICE CHAIRMAN.

During 1933 there has been an effort made to organize the Social Service work in the Woman's Auxiliary.

We know that in past years the branches have felt their responsibilities to our own Diocesan institutions and community organizations, but we believe that more can be accomplished if the work is done in an organized manner.

As a result of circular letters and personal contacts, we now have reported 27 parish Social Service chairmen, 12 of which were newly appointed during 1933.

As your chairman, may I ask that we carry on our obligations in Social Service during 1934, and that a chairman be appointed in every parish.

The duties of a parish Social Service chairman are:

1. To have women appointed to represent their parish in the interests of the different institutions and forms of Social Service work of the Episcopal Church in the Diocese of Chicago, namely, Cathedral Shelter, Church Mission of Help, House of Happiness, Lawrence Hall, St. Mary's Home for Children, Chase House and Church Home for the Aged. The representatives will be required to keep in constant touch with the work and the needs of these institutions and to keep this before the parish organizations and to see that the parish fulfills its responsibility in this work.

2. To keep in touch with the Social Service and Welfare work carried on in the community in which the church is located, such as Boy Scouts, Girl Scouts, Y. M. C. A., Y. W. C. A., Social Settlements, etc., and to see that the parish becomes interested and fulfills its duty in the community.

3. To send an annual report of the Social Service work of the branch to the Diocesan Social Service chairman.

4. To meet with the other Social Service chairmen whenever asked to do so.

REPORT OF THE DEACONESS DISCRETIONARY FUND, 1933.

On account of financial conditions in 1933, it was expected that the receipts for the Deaconess Discretionary Fund would be less; and amount received was the smallest since 1928.

Of the 103 Auxiliary Branches and Guilds contributing, about 1/6 increased their pledges; 2/3 gave the same as before, and five new ones were added to our list. These were a great help, as 6 parish and 5 missions were unable—from various causes—to give anything, and for some of them it was the first time in 10 years.

I think it is greatly to the credit of 10 new and small missions that have been contributing to the fund since 1931, that with one exception all made their usual pledges, and their interest in our City Mission work is greatly appreciated.

The above 103 pledges amounted to \$734.25, and with the offerings from one monthly meeting of the Diocesan Auxiliary, one local assembly meeting of the Daughters of the King, the members of the Clerica, and 3 individuals, the total amount received was \$793.95.

In City Missions, relief work is very essential, and the Deaconesses were greatly handicapped in this, especially last year. Even in our banner year, 1931, it was not possible to help all on our lists who needed it, and now more men and women are constantly being found with no one else to

give them even the smallest necessities so badly needed, and knowing their needs are genuine, (because we can see many of them plainly), makes it very much harder for us not to be able to supply them.

Someone talking to me of our City Mission work one day at a meeting said, "I thought you did only religious teaching, etc., and now you ask for money for relief work." I answered, "We are trying to follow Our Blessed Lord's commands. He told us to care for material needs, and Himself set the example. He usually gave the material help first and then the spiritual."

The appeals for the Deaconess Discretionary Fund for 1934 are already sent to every Auxiliary and Guild president, and we, the City Mission Deaconesses, the servants of our Lord and of the Church, and your representatives in this important field of Missionary work, earnestly plead that we may receive pledges from 100 per cent of the Auxiliary Branches and Guilds in the diocese this year. If any are not able to give as much as formerly, give something, and as generously as possible, for this fund is the only means we have for our relief work, and every dollar is needed, oh so badly, if we are to help any of these poor and mostly sick people who so deeply appreciate even the very smallest thing we are able to give them.

I was asked to make my report short; this is very hard, as I can not possibly say all I would like to, or tell you of any of our many special cases, that would surely touch your hearts and open your purses.

I will close with this little verse, which I am sure will prove absolutely true if you only follow its lesson:

"We are helped by helping others,
If we give we also get;
Seeing others as our brothers
If life's safest, surest bet;
"If we give what folks are needing,
It will pay us in the end;
And we just can't help succeeding
In this game of life, my friend."

BY-LAWS.

I. The election of officers at the annual meeting shall be by ballot, each Parish or Mission having one vote.

Amendment to By-Law No. 1.

Beginning with 1928 and thereafter on the even calendar years, the first, third, fifth, seventh and ninth Vice-Presidents, the Treasurer, Recording Secretary, the Chairman of Box Work, the Chairman of the Social Department and the Chairman of the Department of Education shall be elected by the Woman's Auxiliary at its Annual Meeting, to serve for a term of two years.

Beginning with 1929 and thereafter on the odd calendar years the President, second, fourth, sixth and eighth Vice-Presidents, the Corresponding Secretary, the Chairman of the Supply Department, the Chairman of the Speakers Bureau and the Director of the Monthly Meetings shall be elected by the Woman's Auxiliary at its Annual meeting to serve for a term of two years.

No member shall serve on the Executive Board (in the same office) more than two consecutive terms.

The United Thank Offering Director shall be elected for a term of three years, serving through a Tri-ennial Convention.

II. When a vacancy shall occur in the Executive Committee by death or resignation, or removal of residence from the Diocese, the members of said Committee shall have power, with the advice and consent of the Bishop previously obtained, to appoint an officer to fill the vacancy. The officer so appointed to serve until the next annual meeting.

III. Special meetings shall be called by the President, at such time and place as she may designate, for the purpose of stimulating interest in the work.

IV. It shall be the duty of every parochial branch to contribute annually a sum of money, the amount thereof to be determined by itself, to the Executive Committee of this Diocesan Branch, to be appropriated by them according to their discretion in the missionary work of the Church, which money shall constitute the General Fund of the Chicago Branch, and shall be so designated by the contributors.

V. The regular order of business at the annual meeting shall be as follows:

1. Office of devotion.
2. Calling of roll by branches.
3. Reading of minutes of last meeting.
4. Reports of officers and committees.
5. Election of officers.
6. Unfinished business.
7. Miscellaneous business and addresses.

VI. These by-laws may be amended at any annual meeting by a majority vote of the branches present.

Amendment to By-Law VI. The Annual Day of Prayer for Missions; the Annual Meeting; the Executive Committee and Monthly Meetings, heretofore held on fixed dates, will be subject to change, and for a sufficient reason may be held on dates to be determined by a majority vote of the Executive Committee, due notice of such change being given to all parochial branches.

VII. The Treasurer shall furnish bond for such amount as shall be determined by the Executive Committee, such bond to be paid for from the funds of the Woman's Auxiliary.

ARTICLES OF INCORPORATION.

STATE OF ILLINOIS, {ss.
COUNTY OF COOK.

To James A. Rose, Secretary of State:

We, the undersigned, Marie M. Hopkins, Emily Pardee Street and Frances E. McDermid, citizens of the United States, propose to form a corporation under the Act of the General Assembly of the State of Illinois entitled, "An Act Concerning Corporations," approved April 18, 1872, and all acts amendatory thereof, and that for the purpose of such organization, we hereby state as follows:

I. The name of such corporation is
"The Chicago Branch of the Woman's Auxiliary to the National Council."

II. The object of this corporation shall be: (a) To interest all of the congregations in the Diocese of Chicago in the different branches of missionary work, as conducted by the General and Diocesan Boards, and to the purpose of aiding said societies in carrying on the said missionary work in connection with the said Diocese and the said General Church. (b) An Auxiliary to the General Board of Missions and to the Board of Missions of the Diocese of Chicago of the Church known in law as "The Protestant Episcopal Church in the United States," and its management is to be in accordance with the constitution and canons of said Diocese of Chicago and of said Protestant Episcopal Church and not for pecuniary profit.

The corporation shall have power to receive donations, subscriptions, legacies and bequests to be used for the carrying on of the said missionary work and of the said Church in the said Diocese of Chicago and of the missionary work under the jurisdiction of the General Board of Missions of the Protestant Episcopal Church of the United States.

III. The Board of Managers shall have power to organize branches or recognize existing branches in every parish or mission in said Diocese under the rules as they may adopt from time to time. Any branch so organized, upon payment of the Annual Membership Fee, to be fixed from time to time by the By-Laws, shall be entitled to representation at the meetings of this Board, each Parish or Mission voting as a unit when demanded by two Parishes or Missions.

IV. (1) The officers of the Society shall be a Patron, a President, not less than five (5) Vice-Presidents, a Corresponding Secretary, a Recording Secretary and a Treasurer. (2) The Bishop of the Diocese shall be the Patron ex-officio.

V. The management of The Chicago Branch of the Woman's Auxiliary to the Board of Missions shall be vested in an Executive Board of not less than nine (9) nor more than twenty-one (21) Directors, of whom the Patron, the President, the Vice-President, the two Secretaries and the Treasurer shall be a part.

VI. (1) The Board of Directors shall consist of not less than nine (9) nor more than twenty-one (21) members, of whom the Bishop of said Diocese of Chicago shall, ex-officio, be one. All of the elective Directors shall be elected at the annual meeting of said corporation, which shall be held on the day after the close of the Diocesan Convention, except when the day falls on a legal holiday, when the Executive Committee of the Board shall appoint another day for the election of officers. The number of said Directors may, with the approval of the Bishop from time to time, be varied, and the Directors shall be elected in accordance with the statutes of the State of Illinois, and the By-Laws of said corporation, to be hereafter adopted. The Executive Committee shall meet monthly, except during the months of July and August.

(2) The Executive Committee shall have power, as necessity may arise, to appoint annually, with the approval of the Bishop, other officers, who shall not, however, be members of the Executive Committee.

(3) The duty of the President shall be to preside at all meeting of the Association and of the officers, to arrange for the organization of branches, to visit the same and to have the general charge of the work under the direction of the Bishop.

(4) The duty of the Vice-Presidents shall be to choose one of their number to preside in the absence of the President, to co-operate with her in the general supervision of the work of the Association and to take charge of the departments of work to which they may be assigned by the Executive Committee.

(5) The duty of the Corresponding Secretary shall be to conduct the necessary correspondence required by the Auxiliary, and to prepare such reports as are needed. The duty of the Recording Secretary shall be to send out notices of all meetings, to keep a record of the same, and to assist the Corresponding Secretary in the preparation of reports.

(6) The duty of the Treasurer shall be to receive all special and general funds; to disburse the former as the donors indicate, and the latter under the direction of the Executive Committee, and to render an account of the same at the annual meeting.

(7) There shall be a committee of two appointed to audit the Treasurer's accounts each year.

VII. The following persons are hereby selected as the directors to control and manage said corporation for the first year of its corporate existence:

Katharine D. Arnold, Vice-President.
Vincy B. Fullerton, Vice-President.
Emily Pardee Street, Vice-President.
Eleanor M. Duncombe, Vice-President.
Jessie Peabody Butler, Vice-President.
Frances E. MacDermid, Corresponding Secretary.
Addie S. Chenoweth, Recording Secretary.
Emma J. Hoyne, Treasurer.

The said Directors shall hold office until the next annual meeting of said corporation and shall then be elected at the said annual meeting herein provided.

VIII. The Bishop of the Diocese of Chicago shall ex-officio be the Patron of the said corporation, and all of the acts of the Executive Committee and Society shall be subject to his approval.

IX. These Articles of Incorporation may be altered or amended at any annual meeting by a vote of two-thirds of the members present, subject to the approval of the Bishop, and by complying with the statutes of the State of Illinois.

X. The location is in the Diocese of Chicago, in the County of Cook, in the State of Illinois, and postoffice address of its business office is at No. 510 Masonic Temple, State Street, Chicago, Illinois.

SUGGESTED CONSTITUTION FOR BRANCHES.

ARTICLE I.

Name.

The name of this organization shall be the
Branch of the Woman's Auxiliary to the National Council.

ARTICLE II.

Objects.

Its objects shall be:

- A. To cooperate with all of the plans undertaken by the National Council for the extension of Christ's Kingdom throughout the world.
- B. To supplement the work of the Diocesan Woman's Auxiliary to the National Council.
- C. To increase and deepen the spiritual life of the Parish by prayer, service and example.

ARTICLE III.

Membership.

Any woman who endorses the projects named in Article II shall be eligible for active membership.

ARTICLE IV.

Officers.

The officers shall be:

President
Vice President
Secretary
Treasurer
Educational Secretary
United Thank Offering Custodian
Chairman of Box Work.

The President, Vice President, Educational Secretary, and U. T. O. Custodian shall be Communicants of the Church.

ARTICLE V.

Duties of Officers.

Section 1. The President shall direct the work of the Branch; call meetings and preside over them; serve as head of a Committee on Plans for the Spiritual Development of the Branch; and be a member ex-officio of all Committees. She shall confer with the Diocesan Vice President of her District, reporting progress made and seeking counsel when desired.

Section 2. The Vice President shall preside in the absence of the President and shall act as Chairman of the Membership Committee.

Section 3. The Secretary shall give notices of meetings; keep records of them, and conduct the correspondence of the Branch. She shall send promptly acceptance or rejection of the allotment received from the Supply Department. She shall make reports at the Annual Meeting of the Branch, the Annual Meeting of the Parish, and to the Secretary of the Diocesan Branch.

Section 4. The Treasurer shall receive and disburse all funds except the United Thank Offering. She shall enter the amounts received in her books and pay out money only on the order of the Organization, preserving all vouchers. The books shall be audited annually.

Section 5. The Educational Secretary shall have charge of the study, reading, and general information. She shall attend the Diocesan Annual Course for Study Classes and conduct the Parish Class. She shall plan and conduct program meetings.

Section 6. The United Thank Offering Custodian shall make this offering known to all women of the Parish and distribute the boxes to them. The contents of these shall be presented at a Corporate Communion service semi-annually and immediately remitted to the Diocesan United Thank Offering Treasurer.

Section 7. The officers of the Branch shall meet regularly to confer upon the work of the Branch and plans for its development.

ARTICLE VI.

Meetings and Dues.

Section 1. The meetings of the Branch shall be held
(weekly, bi-monthly or monthly).

Section 2. Every baptized woman being automatically an Auxiliary member, shall designate the amount which she will voluntarily contribute to the financial program.

The Treasurer shall remit an annual due of one dollar (\$1.00) for the Branch to the Diocesan Treasurer.

Section 3. The Annual Meeting shall be held the first meeting in January.

ARTICLE VII.

Elections.

At the November meeting the President, with the approval of the Rector, shall appoint a Nominating Committee of three (3) members of the Auxiliary who shall report at the December meeting.

The election of officers shall be by a majority ballot at the annual meeting in January.

No officer may hold office longer than two (2) terms of two (2) years each. Vacancies occurring in any office shall be filled by the Executive Committee to serve until the next election.
