








**MAP OF

**TOTAL AREA 15,328 SQ. M.**



## ANNUAL REPORT OF THE PRESIDENT

1934-1935

In the yearly report of the Executive Secretary of the Woman's Auxiliary, Mrs. Lindley suggested five means of testing our work for measuring its efficiency in relation to present day conditions. They were Unity, Co-operation, Training, Spiritual Growth. These have been in the mind of your Chairman as we have listened to the preceding reports, for the value of summing up a year's work lies in gaining a perspective by which we can plan for the future more wisely and bravely, building on the foundation of the past.

Compiling an annual report is often an experience in personal humility, and today your Chairman is so much more conscious of her deficiencies as your leader than when she took the chair a year ago. Since then she has presided at the six monthly meetings and eight executive board meetings, at the U. T. O. Presentation, the 50th Anniversary Celebration and one Regional meeting after the Convention. She has held conferences with the District Vice-Presidents, the Parish Presidents, and two district groups of officers. She was present at Lockport for their Centennial and had a part in the program. She attended the Sectional meeting in Rockford, which marked the first annual meeting of the Rock River District. Committees have been formed and attended as the need has arisen. She has missed only one of the monthly meetings of the Church Extension Department of the Diocese, and has attended most of the meetings of the Town and Country Council. She represented you at the World Day of Prayer at the First Methodist Temple, and enjoyed the privilege of reading the Scripture lesson. It was her pleasure to attend several of the events commemorating the Centennial of St. James Church, having a place with other Diocesan organizations at the final service. Invitations have been accepted in twenty branches where your Chairman has spoken. Many had to wait for another year because there are only five days a week upon which auxiliaries ordinarily meet. She had a part in a conference of older girls held by the G. F. S. and at a Mothers' and Daughters' Tea given by the Daughters of the King. These intimate contacts she has especially appreciated.

Your Chairman has twice been to Seabury Western Seminary, once as a guest at dinner and again for a conference with the Senior Class on the "Work of the Woman's Auxiliary." During the summer conference in Kenosha there was a "Presidents' Day" at which time a summary was made of the course which preceded it. Two unusual pilgrimages have been made, one to Champaign where a group of five saw the Student Centre in action, and another to Pontiac and Dwight, where twenty-five women were thrilled with the work that Sister Mary Elizabeth is doing there in the woman's prison.

One new venture has been made this year, to bring together the evening branches. So happy and seemingly worthwhile was the one joint meeting held that another is scheduled for February 19th, and it is sincerely hoped that we shall enlist more evening branches of business and professional women during the new year. So much for the duties which have come to your Chairman by virtue of her office.

To sum up in a few words the work that has been so splendidly carried on by your faithful officers is difficult, but it is a satisfaction to your Chairman because it gives her the opportunity of expressing appreciation of the devotion that has gone into the year's work and the warm friendships which have grown out of working together.

Testing the year for **Unity**, it is gratifying to see how many of our parishes are banding all of the women together for service in the five fields, and where there are several organizations there is less feeling of separateness and a recognition that they are each a part of the whole. Since New York is commanding the Guild Auxiliary, or Woman's Auxiliary, working in departments, that is an objective for us to work toward more generally this coming year.

Testing for **Co-operation**, your Chairman believes that there has been decided growth in understanding one another. The purpose of this group is to enlist the women in every way that is furthering Christ's Kingdom rather than to promote itself. In this spirit we can press forward earnestly and sympathetically with the G. F. S. and the D. of K. seeking to co-ordinate and correlate rather than overlap and duplicate. Your Social Service Chairman has persistently urged support of the Diocesan Social Service program, seeking to connect each branch directly with each Institution. Generous response was made by our women when Mrs. Frederick Seymour so ably marshalled us for the Friendly Farms Project of the Diocese, and Mrs. John VanderVries met the same cordiality in calling for Hostesses at the Hall of Religion. Penland Cabin again claimed many of our women as workers. Co-operation with Town and Country Council has given that group a Vice-President and Secretary from our Board, and financially we have kept up a part of Deaconess Adams' stipend, thus allying ourselves with the Religious Education Department. In that connection, we may also remember that Mrs. Fowkes sits in on the Religious Education Department at its monthly meetings. There has been a generous response through the branches to the Deaconess Discretionary Fund, and it seems that this work of devoted women will always be close to the hearts of Auxiliary members. And what a joy it has been to co-operate further with City Missions by helping to maintain Sister Mary Elizabeth in her work among the women at Dwight.

When we test for **Training**, it is well to remember that at the summer conference we had our first opportunity to present a course in Auxiliary training, and that Mrs. Fowkes and Mrs. Leete carried it through effectively with help from other Board members. Our belief in churchly training for young people has been evidenced in our Auxiliary Special, in continued support of the student worker at the University of Illinois. Mr. Hubbard's class for leaders in "Christ in the Modern World" made possible many well taught parish groups. It is a disappointment to some of us that the Charlotte Fords Lending Library is not more generally used. Perhaps if you will look there you will find just what you want for Lenten reading: 14 North Michigan, Room 307.

In the test by **Gifts**, we value our projects not so much in dollars and cents as the love they represent. Our objectives have begun at home and have reached around the world. When we recognize the real sacrifice that much of the giving bespeaks, we could wish, not for more **generous** women, but for more women as unselfish. It is worthy of note, in passing, that whereas the value of our parish work reported has increased, our pledges to the Church's program have also grown, and you were glad to hear that our U. T. O. is larger this year than last. Box work has met generous response, and the heart of your Box Chairman rejoices in the extra shower today, for she does not have "can't" in her vocabulary.

It is more difficult to test for **Spiritual Growth** than material. The Day of Intercession was not kept quite so generally as last year, but the very helpful Quiet Day under Dr. Bowen was unusually fine in point of attendance. Many parish programs are scheduling Days or Hours of Prayer and Meditation, and Corporate Communions, and this part of the work should receive special emphasis as we go forward. Only our Lord can know how close we come to His Reality.

It has been a year rich in two special events. First, the Triennial when a full delegation represented you at Atlantic City, and were filled with inspiration which they had tried to disseminate. The theme of the Convention "If we be His Disciples," we are all seeking to interpret in terms of Christian Citizenship, greater missionary zeal, and a deeper Life of the Spirit.

We have celebrated our Golden Anniversary and beautifully preserved the record of those fifty years, so ably compiled by Mrs. George Clinch. As we close this year, your Chairman would pay tribute to the officers and committees who have made possible, with your co-operation, whatever accomplishments there have been. The District Vice-Presidents, who make no

yearly report, have showed by their monthly reports to the Board, an unfailing devotion and tireless effort in keeping in touch with their branches. To those officers retiring after four years of faithful service, your Chairman cannot possibly express what their experience and understanding meant to her a year ago. We are confident of their continued interest and usefulness. And to each and every one of you who has helped this year in any way to make the whole complete, she would express grateful appreciation. The spirit evident in your undertakings has been:

"Christ has no hands but our hands,  
To do His work today,  
He has no feet but our feet  
To lead men in His way.  
He has no tongues but our tongues  
To tell men how He died,  
He has no help but our help  
To bring them to His side."

Williamson on "Brief Glimpses of Our Missions in the Orient," Mrs. George O. Clinch on "First Fifty Years of the Woman's Auxiliary in this Diocese," Colonel Alex Davis on "Parable of the Two Roads" and Rev. Harold L. Bowen, D.D., who conducted the meditations for the Quiet Day. Other speakers were Rev. David Clarke who told of what our church is doing in South Dakota, Miss Grace Lindley, the Executive Secretary of the Woman's Auxiliary, Rev. Herbert L. Miller and Mrs. Sapp on "Student Work at University of Illinois," and Rev. Frederick P. Houghton on survey of Indian Work. At the Annual Meeting Bishop Stewart gave a stirring message.

With the continued growth devotionally and spiritually of the members, under the consecrated leadership of Mrs. Albert Cotsworth, Jr., as president, may our Chicago Branch continue to strive for unity with each other and a closer fellowship with God.

### REPORT OF EDUCATIONAL DEPARTMENT.

The Normal Class for leaders in 1934 was splendidly conducted by Father Hubbard. The subject "Christ in the Modern World" was one full of vital questions of the age—stimulating thought and discussion in the fields of economics, industry, political movements, race problems, and in fact, an endless number of topics. Of course we did not settle any of the questions raised—but there was discussion and some constructive thinking.

The attendance at the Normal classes averaged about 40 from about 20 parishes. Right here may I make a plea for more study classes? Study, as you know, is a vital part of our program and this year's topic, "Orientals in American Life" is one on which we should be informed. You know, when we understand people we like them, lack of understanding leads to suspicion. We send missionaries to Oriental countries to carry the Gospel with its teaching of brotherhood—and when some of those Orientals come here we forget they are our brothers. The book used for a text this year "Orientals in American Life" by Albert W. Palmer is most interesting and teaches itself. Every parish could have a study class. All you need is the book and the will to try!

The Auxiliary was given a part in the Summer Conference at Kenosha where we conducted an Auxiliary Class which was well attended.

As Educational Chairman, I was a delegate to the Triennial Meeting at Atlantic City and on my return reported the Convention in seven parishes. During the year have been called to a number of parishes to speak on Educational Work. Have sat in at two meetings of Department of Education of the Diocese.

The Auxiliary Library, now called the Charlotte Folds Memorial Library, is growing slowly with some worthwhile additions. We urge you to avail yourselves more fully of its privileges.

### REPORT OF THE SUPPLY DEPARTMENT, 1934.

Six regular meetings of the Advisory Committee were held during the year with an average attendance of nine persons.

Our Chairman of Surgical Dressings reported 1,011 dressings made the past year. The Chairman of the Diocesan Pantry reported 93 branches

have given 4,333 glasses of jelly, valued at \$641.91, to our Diocesan Institutions. In addition \$43.25 was sent to St. Luke's Hospital. Three branches reported they could send nothing this year, and twenty-two branches have not reported.

This year many branches have reported to us money they have sent to our Diocesan Auxiliary Treasurer and also the United Thank Offering, therefore the totals may surprise you, when comparing with totals of other years.

The value of our work this year in the five fields amounts to \$53,319.81 distributed as follows:

Parish—\$31,390.59.  
Diocese—\$10,854.96.  
Community—\$3,580.34.  
Nation—\$5,031.66.  
World—\$2,462.26.

The Missions you have worked for this year included three (3) Indian Missions, eleven (11) Southern Mountaineers and two (2) colored, one of the latter a hospital allotment. There were two other hospital allotments—Emerald Hodgson, at Sewanee, Tenn. and Christ Hospital, Topeka, Kan.

We wish to mention the splendid box which St. Anna's branch of our Church Home for Aged Persons sent to The Four Morganton Missions, valued at \$91.00. Among the contents were many knitted scarfs for the mountain children.

## REPORT OF MONTHLY MEETINGS.

The Chicago Branch of the Woman's Auxiliary held six monthly meetings in Roosevelt Hall in the State-Lake Building, during the year 1934, with an average attendance of 118 from 66 parishes.

The annual meeting was held at the Church of the Redeemer, with an attendance of 440 from 70 parishes. Our United Thank Offering meeting was held at the Church of the Atonement, with an attendance of 437 from 65 parishes.

The Auxiliary meetings were resumed in September with a Quiet Day at the Church of the Advent. Fr. Bowen giving the meditations on "The Way of Vision."

On October 25th, was held the Golden Jubilee meeting, at Saint James Church. Mrs. George O. Clinch wrote and delivered the history of the Woman's Auxiliary in this Diocese for the First Fifty Years. This history has since been printed in book form. The attendance at this time was 372 from 58 parishes.

During 1934 every parish in Chicago with the exception of two, and all but twenty of the rural parishes were represented at one of the meetings.

Honorable mention for total attendance at monthly meetings should be made of Grace Church, Oak Park, with 47, Saint Luke's Pro-Cathedral, Evanston 34, and the Church of the Mediator and Saint Christopher's Oak Park, tying for third place with 33. The parishes outside of the Metropolitan area deserving special mention, because of the distance they come are Aurora with a total of 10 for the year, La Salle with 2, Belvidere, Plano, the Bishop's Branch No. 1, Freeport, Morris, Rockford and Wilmington each having 1.

We had the pleasure of hearing the following speakers, Bishop Stewart, Fr. Houghton, Fr. Brinker, Mrs. Treadway, Fr. Clark, Fr. Carr, Miss Lindley, Fr. Bowen, Mrs. Williamson, Mrs. Clinch, Fr. Miller and Col. Davis, each bringing a very interesting and inspiring message.

We also heard the reports from the delegates to the Auxiliary Triennial in Atlantic City.

At the December meeting Mrs. Sapp, the Student Worker, at the University of Illinois, sang two songs as part of the program.

The Church Periodical Club of the Diocese of Chicago has held seven meetings with an average attendance of fourteen secretaries. #### REPORT OF AUXILIARY SPECIAL.

Early in the year 1934, your chairman of this fund sent out eighty-nine letters to branch presidents throughout the diocese, asking each branch to give its proportionate share of the amount needed for the year. If all had responded, we should have had about \$900.00, but the total amount received was actually \$553.25. By using the balance of \$133.50 on hand December 31, 1933, we were able to pay the salary of our student worker at the University of Illinois for the year 1934. This left a balance December 31, 1934, of \$56.75, from which the January 1935 salary of \$52.50 was paid, leaving a balance January 31, 1935, of \$4.25. Seven parishes gave more than was asked of them, forty-three paid their quota in full and eight others gave something. If the four large parishes who gave nothing had sent even one-half of what was asked of them, the sum needed could easily have been raised. The only other ones who did not respond at all were small parishes and missions. It is our earnest desire that every parish and mission in the diocese shall have a share, even if small, this year in the support of this work which Bishop Stewart has asked us to help maintain.

She has held two conferences for Parish Custodians, one at Kenosha in July, the other at Diocesan headquarters in January; attended the Triennial Convention in Atlantic City as a delegate from the Woman's Auxiliary; has been present at five town and country council meetings. Also the Mission Study Classes for leaders.

Visited forty parishes, of which twenty-three were suburban and country. One thousand nine blue boxes have been given out to parish custodians and 813 "Romance of the Blue Box" leaflets.

It was her privilege to be present when the youngest branch of the Woman's Auxiliary was organized recently, with vigor and enthusiasm St. Mary's by the Lake, Crystal Lake.

The financial report of the United Thank Offering is on the leaflet with the Treasurer's Report and the total amounts to \$635.81 more than 1933. A small gain but happily forward.

#### SOCIAL SERVICE CHAIRMAN—REPORT FOR 1934

As a result of our work in the past two years we have reported Social Service Chairmen from the following 31 parishes: Church of the Advent, All Saints (Ravenswood), All Saints (Roseland), Church of the Atonement, Church of the Holy Nativity, Church of the Incarnation, Church of the Mediator, Church of the Redeemer, St. Barnabas, St. Bartholomew's, St. Chrysostom's, St. George's, St. Timothy's, Trinity, Aurora; St. Luke's, Dixon; Church of Our Saviour, Elmhurst; St. Andrew's, Evanston; St. Mark's, Evanston; St. John's, Flossmoor; St. Mark's, Geneva; Trinity, Highland Park; Christ Church, Joliet; Church of the Holy Spirit, Lake Forest; Trinity, Niles Center; Grace Church, Oak Park; St. Mary's, Park Ridge; Emmanuel Church, Rockford; Christ Church, Streator; All Saints, Western Springs, and Watseka.

These Chairmen are active in their parishes and during the past year have co-operated with the Diocese in supporting the institutions. The total, including the jelly for the institutions, sewing (material furnished), clothing, canning, pledges, and work in the rural districts, amounts to \$8,790.65.

The Social Service in the parishes and communities amounts to \$2,162.51. This includes food for relief, Red Cross work, and gifts of money to various civic organizations.

As a special project the Social Service Chairmen co-operated in furnishing many household articles required by Sister Mary Elizabeth in her Pontiac home for girls paroled from the Dwight Reformatory.

As your Chairman, I have attended monthly meetings of the Social Service Dept. of our Church, Joint Committee on Motion Pictures, Christian Citizenship Council, many Civic Social Service conferences, meetings at our institutions, Board of Directors of the Associated Church Charities and have held one group meeting of the Social Service Chairmen.

A committee, representing all sections of the city, is being formed to assist with the Social Service in our auxiliary branches. Mrs. Frederick Seymour, Mrs. E. O. Adomeit and Mrs. A. E. Williams will be members of the committee.

## REPORT OF THE DEACONESS DISCRETIONARY FUND FOR 1934

It is a pleasure to be able to report that the last three months of the year, contributions to this Fund greatly increased, for during the other months money had come in so slowly that I was very discouraged. I decided, therefore, in September, to try once more, sending to all Branches not heard from, another strong letter of appeal for money, the need being so great. The result was certainly satisfactory, and when the year closed, many had responded, some even sending larger sums than they had pledged. Only 5 Parishes and 6 Missions were unable to give. These included 3 that had never responded. However, 3 new small Missions (with few members) each generously sent a dollar—Morris, Woodstock, and Wilmington—and 3 new Guilds (not connected with the Auxiliary) also contributed. We heartily thank them and hope that their interest in City Missions will continue.

The number of Branches and Guilds giving to this Fund has increased each year since 1928, when by request of the President of the Diocesan Woman's Auxiliary, I assumed full charge of sending out to the President of each Branch in the Diocese, appeals for pledges for the Deaconess Discretionary Fund.

In 1927, 40 Branches and Guilds made pledges; in 1934, 113 made pledges (10 more than in 1933). The amount received from them was \$810.35. This, with special offerings from the Diocesan December Meeting, the Local Assembly of the Daughters of the King, Members of the Clerica, and a gift from Bishop Stewart, made a total of \$852.75—about \$70.00 more than in 1933. This was a help, as you all know. City Missions work is growing all the time. And not only are there more people to be cared for, but more Institutions could be visited and still better work done at some of those now on our list, if we had one or two more Deaconesses on the Staff. Unfortunately, there is not any money for their support, so we do the best we can with only four active ones.

This is my last report as Secretary-Treasurer of the Deaconess Discretionary Fund, as I have found that though the work was voluntary and I was happy in doing it, writing so many letters in the interest of City Missions (over 1,400 in 1934) was overtaxing my strength. I need scarcely say that I shall miss the many kindly letters I have received from Branch Presidents and Treasurers, and I want here to thank them and all the Diocesan Officers for their help given me in so many ways all the past years since I began my work in City Missions.

Before closing, dear friends, the members of all Auxiliary Branches and Guilds, I want to ask if you have ever realized that it is not merely *our* work, but *yours* too, that the Deaconesses on the City Missions Staff are doing. For many good reasons, you cannot give your time or make it your life-work to visit among the poor and sick (some afflicted in mind as well as in body) in the various Institutions, also following up those who return to the City and keeping in touch with them as long as necessary, but there are two things every one of you can do. First: Help us with your Prayers, that He whose commands we are trying to obey, by caring for His poorer brethren, will give us strength and wisdom to do and say the right things that will do the most good. And Second: Let everyone help by giving money for this Fund in 1935, so that when the year closes, the amount received, I hope, will not still be \$400.00 short of what it was in 1931, which year was the best since this Fund was started, but still not as much then as was needed. If all of you will do your part, I am sure we will not have to pass by so many without supplying their wants.

Some members I know make personal sacrifices in order to contribute, and we appreciate their generosity. "To do good, and to distribute, forget not; for with such sacrifices God is well pleased."

Many of the City Missions people have seen far better days, and have done their share in helping others; and now they have to go without many

real necessities, but few complain, hard as it is for them, through no fault of their own, to be obliged to depend on Charity. I could tell you many sad and pitiful stories, but I must close, hoping that you will remember these last words:

"Give as you would to the Master  
If you met His searching look;  
Give as you would of your substance  
If His Hand your offering took.

'And must I be giving again and again?'  
'Yes,' said the Angel, looking me through,  
'Give as the Father has given to you.'"

## BY-LAWS.

I. The election of officers at the annual meeting shall be by ballot, each Parish or Mission having one vote.

### Amendment to By-Law No. 1.

Beginning with 1928 and thereafter on the even calendar years, the first, third, fifth, seventh and ninth Vice-Presidents, the Treasurer, Recording Secretary, the Chairman of Box Work, the Chairman of the Social Department and the Chairman of the Department of Education shall be elected by the Woman's Auxiliary at its Annual Meeting, to serve for a term of two years.

Beginning with 1929 and thereafter on the odd calendar years the President, second, fourth, sixth and eighth Vice-Presidents, the Corresponding Secretary, the Chairman of the Supply Department, the Chairman of the Speakers Bureau and the Director of the Monthly Meetings shall be elected by the Woman's Auxiliary at its Annual meeting to serve for a term of two years.

No member shall serve on the Executive Board (in the same office) more than two consecutive terms.

The United Thank Offering Director shall be elected for a term of three years, serving through a Tri-ennial Convention.

II. When a vacancy shall occur in the Executive Committee by death or resignation, or removal of residence from the Diocese, the members of said Committee shall have power, with the advice and consent of the Bishop previously obtained, to appoint an officer to fill the vacancy. The officer so appointed to serve until the next annual meeting.

III. Special meetings shall be called by the President, at such time and place as she may designate, for the purpose of stimulating interest in the work.

IV. It shall be the duty of every parochial branch to contribute annually a sum of money, the amount thereof to be determined by itself, to the Executive Committee of this Diocesan Branch, to be appropriated by them according to their discretion in the missionary work of the Church, which money shall constitute the General Fund of the Chicago Branch, and shall be so designated by the contributors.

V. The regular order of business at the annual meeting shall be as follows:

1. Office of devotion.
2. Calling of roll by branches.
3. Reading of minutes of last meeting.
4. Reports of officers and committees.
5. Election of officers.
6. Unfinished business.
7. Miscellaneous business and addresses.

VI. These by-laws may be amended at any annual meeting by a majority vote of the branches present.

Amendment to By-Law VI. The Annual Day of Prayer for Missions; the Annual Meeting; the Executive Committee and Monthly Meetings, heretofore held on fixed dates, will be subject to change, and for a sufficient reason may be held on dates to be determined by a majority vote of the Executive Committee, due notice of such change being given to all parochial branches.

VII. The Treasurer shall furnish bond for such amount as shall be determined by the Executive Committee, such bond to be paid for from the funds of the Woman's Auxiliary.

## ARTICLES OF INCORPORATION.

STATE OF ILLINOIS, {ss.  
COUNTY OF COOK.

To James A. Rose, Secretary of State:

We, the undersigned, Marie M. Hopkins, Emily Pardee Street and Frances E. McDermid, citizens of the United States, propose to form a corporation under the Act of the General Assembly of the State of Illinois entitled, "An Act Concerning Corporations," approved April 18, 1872, and all acts amendatory thereof, and that for the purpose of such organization, we hereby state as follows:

I. The name of such corporation is  
"The Chicago Branch of the Woman's Auxiliary to the National Council."

II. The object of this corporation shall be: (a) To interest all of the congregations in the Diocese of Chicago in the different branches of missionary work, as conducted by the General and Diocesan Boards, and to the purpose of aiding said societies in carrying on the said missionary work in connection with the said Diocese and the said General Church. (b) An Auxiliary to the General Board of Missions and to the Board of Missions of the Diocese of Chicago of the Church known in law as "The Protestant Episcopal Church in the United States," and its management is to be in accordance with the constitution and canons of said Diocese of Chicago and of said Protestant Episcopal Church and not for pecuniary profit.

The corporation shall have power to receive donations, subscriptions, legacies and bequests to be used for the carrying on of the said missionary work and of the said Church in the said Diocese of Chicago and of the missionary work under the jurisdiction of the General Board of Missions of the Protestant Episcopal Church of the United States.

III. The Board of Managers shall have power to organize branches or recognize existing branches in every parish or mission in said Diocese under the rules as they may adopt from time to time. Any branch so organized, upon payment of the Annual Membership Fee, to be fixed from time to time by the By-Laws, shall be entitled to representation at the meetings of this Board, each Parish or Mission voting as a unit when demanded by two Parishes or Missions.

IV. (1) The officers of the Society shall be a Patron, a President, not less than five (5) Vice-Presidents, a Corresponding Secretary, a Recording Secretary and a Treasurer. (2) The Bishop of the Diocese shall be the Patron ex-officio.

V. The management of The Chicago Branch of the Woman's Auxiliary to the Board of Missions shall be vested in an Executive Board of not less than nine (9) nor more than twenty-one (21) Directors, of whom the Patron, the President, the Vice-President, the two Secretaries and the Treasurer shall be a part.

VI. (1) The Board of Directors shall consist of not less than nine (9) nor more than twenty-one (21) members, of whom the Bishop of said Diocese of Chicago shall, ex-officio, be one. All of the elective Directors shall be elected at the annual meeting of said corporation, which shall be held on the day after the close of the Diocesan Convention, except when the day falls on a legal holiday, when the Executive Committee of the Board shall appoint another day for the election of officers. The number of said Directors may, with the approval of the Bishop from time to time, be varied, and the Directors shall be elected in accordance with the statutes of the State of Illinois, and the By-Laws of said corporation, to be hereafter adopted. The Executive Committee shall meet monthly, except during the months of July and August.

(2) The Executive Committee shall have power, as necessity may arise, to appoint annually, with the approval of the Bishop, other officers, who shall not, however, be members of the Executive Committee.

(3) The duty of the President shall be to preside at all meeting of the Association and of the officers, to arrange for the organization of branches, to visit the same and to have the general charge of the work under the direction of the Bishop.

(4) The duty of the Vice-Presidents shall be to choose one of their number to preside in the absence of the President, to co-operate with her in the general supervision of the work of the Association and to take charge of the departments of work to which they may be assigned by the Executive Committee.

(5) The duty of the Corresponding Secretary shall be to conduct the necessary correspondence required by the Auxiliary, and to prepare such reports as are needed. The duty of the Recording Secretary shall be to send out notices of all meetings, to keep a record of the same, and to assist the Corresponding Secretary in the preparation of reports.

(6) The duty of the Treasurer shall be to receive all special and general funds; to disburse the former as the donors indicate, and the latter under the direction of the Executive Committee, and to render an account of the same at the annual meeting.

(7) There shall be a committee of two appointed to audit the Treasurer's accounts each year.

VII. The following persons are hereby selected as the directors to control and manage said corporation for the first year of its corporate existence:

Katharine D. Arnold, Vice-President.  
Vincy B. Fullerton, Vice-President.  
Emily Pardee Street, Vice-President.  
Eleanor M. Duncombe, Vice-President.  
Jessie Peabody Butler, Vice-President.  
Frances E. MacDermid, Corresponding Secretary.  
Addie S. Chenoweth, Recording Secretary.  
Emma J. Hoyne, Treasurer.

The said Directors shall hold office until the next annual meeting of said corporation and shall then be elected at the said annual meeting herein provided.

VIII. The Bishop of the Diocese of Chicago shall ex-officio be the Patron of the said corporation, and all of the acts of the Executive Committee and Society shall be subject to his approval.

IX. These Articles of Incorporation may be altered or amended at any annual meeting by a vote of two-thirds of the members present, subject to the approval of the Bishop, and by complying with the statutes of the State of Illinois.

X. The location is in the Diocese of Chicago, in the County of Cook, in the State of Illinois, and postoffice address of its business office is at No. 510 Masonic Temple, State Street, Chicago, Illinois.

## SUGGESTED CONSTITUTION FOR BRANCHES.

### ARTICLE I.

#### Name.

The name of this organization shall be the .....  
Branch of the Woman's Auxiliary to the National Council.

### ARTICLE II.

#### Objects.

Its objects shall be:

- A. To cooperate with all of the plans undertaken by the National Council for the extension of Christ's Kingdom throughout the world.
- B. To supplement the work of the Diocesan Woman's Auxiliary to the National Council.
- C. To increase and deepen the spiritual life of the Parish by prayer, service and example.

### ARTICLE III.

#### Membership.

Any woman who endorses the projects named in Article II shall be eligible for active membership.

### ARTICLE IV.

#### Officers.

The officers shall be:

- President
- Vice President
- Secretary
- Treasurer
- Educational Secretary
- United Thank Offering Custodian
- Chairman of Box Work.

The President, Vice President, Educational Secretary, and U. T. O. Custodian shall be Communicants of the Church.

### ARTICLE V.

#### Duties of Officers.

Section 1. The President shall direct the work of the Branch; call meetings and preside over them; serve as head of a Committee on Plans for the Spiritual Development of the Branch; and be a member ex-officio of all Committees. She shall confer with the Diocesan Vice President of her District, reporting progress made and seeking counsel when desired.

Section 2. The Vice President shall preside in the absence of the President and shall act as Chairman of the Membership Committee.

Section 3. The Secretary shall give notices of meetings; keep records of them, and conduct the correspondence of the Branch. She shall send promptly acceptance or rejection of the allotment received from the Supply Department. She shall make reports at the Annual Meeting of the Branch, the Annual Meeting of the Parish, and to the Secretary of the Diocesan Branch.

Section 4. The Treasurer shall receive and disburse all funds except the United Thank Offering. She shall enter the amounts received in her books and pay out money only on the order of the Organization, preserving all vouchers. The books shall be audited annually.





Section 5. The Educational Secretary shall have charge of the study, reading, and general information. She shall attend the Diocesan Annual Course for Study Classes and conduct the Parish Class. She shall plan and conduct program meetings.

Section 6. The United Thank Offering Custodian shall make this offering known to all women of the Parish and distribute the boxes to them. The contents of these shall be presented at a Corporate Communion service semi-annually and immediately remitted to the Diocesan United Thank Offering Treasurer.

Section 7. The officers of the Branch shall meet regularly to confer upon the work of the Branch and plans for its development.

#### ARTICLE VI.

##### Meetings and Dues.

Section 1. The meetings of the Branch shall be held .....  
(weekly, bi-monthly or monthly).

Section 2. Every baptized woman being automatically an Auxiliary member, shall designate the amount which she will voluntarily contribute to the financial program.

The Treasurer shall remit an annual due of one dollar (\$1.00) for the Branch to the Diocesan Treasurer.

Section 3. The Annual Meeting shall be held the first meeting in January.

#### ARTICLE VII.

##### Elections.

At the November meeting the President, with the approval of the Rector, shall appoint a Nominating Committee of three (3) members of the Auxiliary who shall report at the December meeting.

The election of officers shall be by a majority ballot at the annual meeting in January.

No officer may hold office longer than two (2) terms of two (2) years each. Vacancies occurring in any office shall be filled by the Executive Committee to serve until the next election.

#### ARTICLE VIII.

##### Order of Business.

The meetings shall be opened with prayer, which should include the Auxiliary and United Thank Offering prayers.

That this Constitution be read aloud once a year, preferably at the Annual Meeting.

That the literature of the Church Missions House (281 Fourth Avenue, New York) be kept on file by the Educational Secretary.

That the larger Parishes be zoned by the U. T. O. Custodian, with a key-woman as Captain in each zone, thus increasing the scope of the Thank Offering work.
