PRESIDENT'S ANNUAL REPORT

Since it was the thought of your Board that too many statistics were undesirable at this meeting, your Chairman has not tabulated the number of letters received and written, telephone calls and personal conferences that make up part of every officer's routine. She has presided at the seven monthly business meetings and the board meetings preceding them; also at the June Board meeting held at Brent House where we enjoyed the gracious hospitality of Mrs. Biller, Brent House has been visited on two other occasions during the year. By virtue of her office your Chairman has been an Auxiliary member of the Church Extension Department of the Diocese and a part of the Town and Country Council, each meeting monthly. She spent a delightful day at St. Alban's School with this second group and has addressed each of the three extra Metropolitan Deaneries in neighborhood meetings and conferences with officers. However, the real work in town and country has been done by the Deanery Vice-Presidents and Miss Larrabee as correspondent under the inspiring leadership of our beloved Archdeacon Ziegler and we shall always be grateful that in his new work as Bishop he will wear a gift expressive of our love for him. Your Chairman's place in the Centenary Committee was a recognition of the Woman's Auxiliary and has called for little activity on her part. Such Federation occasions as luncheons for Kagawa, and Stanley Jones, The World Day of Prayer and the Conference on Cause and Cure of War have given her helpful association with Christian women other than our own Auxiliary and it was gratifying to find that our Delegate to the Woman's Department of the Federated Churches had created such a cordial relation with this fine group. A signal honor was conferred upon your Chairman as one of four women to address the Spring meeting of the Church Club and she did so very mindful of the fact that she was your representative. Again as your representative she spoke to a neighborhood meeting of Church women in Eau Claire, Wis., where interchange of ideas was perhaps mutually helpful. She regrets having had to decline calls to three other Diocesan meetings where she would undoubtedly have received equal inspiration. It was her privilege to be at the Kenosha Conference for several days and to have a part in the class instructions. She presided at Auxiliary Day when we were charmed with Father Flagg's talk on Liberia. Auxiliary Day seems a splendid venture that is bound to serve a purpose. She was in Madison with your five delegates to the Provincial Synod. The theme of that conference "Student Work" is close to our hearts and we who listened to Bishop Stewart's charge to the Convention, in which he emphasized the work with youth, and again heard his thrilling appeal to the young people themselves at the Mass Meeting, somehow feel that one big objective of our work this year must be to enlist more and more these young women who are just coming into their maturity and to have them feel how eagerly we are waiting to share with them the great joy of service to our Lord. Often we have heard that it is as difficult to let go a job as to take it on and we must strive for a balance in this matter of spreading responsibilities that we may spread deep concern. The younger women may not do things just as we have always done them—but perhaps they will do them as well, or better in their own way.

During the year 1936 it has been the privilege of your Chairman to visit thirty parishes in the Diocese. In most instances these visits were to parish branches but some were the occasion of neighborhood meetings already spoken of as well as Officers' Conferences in the City and Suburban Districts. Rallies in the extra Metropolitan Deaneries have seemed especially valuable since our monthly so-called Diocesan meetings naturally draw their attendance largely from the city and suburban parishes. The place and work of the Sectional Vice-President is a vital factor in the life of the Auxiliary. In each part of the Diocese these officers have been actively at work the past year, and may I urge upon each new parish president to make early contact with her Deanery Vice-President, for she is anxious to understand your special needs and to help you in meeting them. Through her cooperation and knowledge of the field many matters come to the Board which your President alone could not

discover and yet would like to clarify. Your Chairman cannot say too strongly how she has depended upon this particular group of loyal co-workers and has found them ever ready and competent to carry out to their branches the plans and projects of the Auxiliary Program. The other officers have made their own reports and you know something of the extent and breadth of that program.

Your first Vice-President has fulfilled her own duties with infinite exactness and yet has found time to do the unexpected things that come to a vice-president. To her too your Chairman expresses deep appreciation and wants you to know how much the close contact with such a rare spirit has meant to her personally.

The experiment of combining the Box work with Supply Department has proven itself wise and knowing that the officer carrying both has often labored under the handicap of ill health the past year, makes us the more conscious of her unselfish devotion.

There seem to have been some discouragements to the Educational Chairman, but all that she has undertaken she has seen through valiantly and Latin America has become more to us than a place on the map. She is not satisfied that we limit ourselves to a perfunctory course of study for a prescribed period, but asks us to accept the Educational Department as an open door of opportunity to know more, that we may love more and do more about it. Give her your loyal support!

Training in Christian Citizenship finds its expression in Social Service Work. The Chairman of this department has been feeling her way this first year and expects your definite cooperation in her concrete plans for 1937. The Deacon's Aid Committee of this department offers the privilege of personal service under trained leadership and we hope that many will be drawn into it, particularly those young women who are eager for work that is thrilling.

The encouraging increase in your U. T. O. we believe is partially due to the wise plan inaugurated this year of spreading the responsibility of it among Deanery Committees and we hope you will support the continuance of this plan. However, it is also due to the enthusiasm of your Parish Custodians and to the expansion of your own interest and the more general use of the Blue Box. In October our offering will be presented upon the golden alms basin at the Triennial. Are we making it an offering commensurate with our gratitude and is that gratitude commensurate with our rich blessings?

We shall continue our support of the Student work and any who heard Dr. Wedel talk on Tuesday night at the Convention, realizes fully that here indeed is our newest field of missionary endeavors. Let the Chairman of this Fund visit some of your branches and tell you of the nation wide college program.

The detail work of the Diocesan branch is carried so ably by the two secretaries and the treasurer that their value is self evident yet your Chairman would point out to you what a comfort it has been to her that everything did run smoothly. With these should be included the Chairman of Monthly Meetings who has provided you with such splendid programs and has carried out every part of these with scrupulous care.

And right here may I speak of the untiring work of our Custodian of the Supply Department. Busy as she is with office routine, she always finds time to give an extra lift to some parish officer who may need it, and is graciously responsive to an extra call from the Board.

Under the direction of the Publicity Chairman, The Woman's Page in the Diocese has continued enlightening and of interest. Other publicity she has attended to as it was needed. She will welcome your items each month.

A new Board member is added at this meeting. A Chairman for Evening work. This development has had the deep concern of your Chairman who counts it a real privilege to have been close to this splendid group of business women who have so much to offer us. May she point out to each parish president that it is a part of her responsibility to link up, somehow, her auxiliary program with the needs of this group.

The G.F.S. and the C.P.C. have brought reports to our monthly Board meetings and it is our wish to cooperate more heartily with all that they are doing. The C.P.C. Secretary has undertaken to strengthen the Prayer Partner plan and already its possibilities are more generally understood. The formation and promotion of more prayer groups is a worthy objective for this year.

As your Chairman has visited she has never presumed to carry a new message but has rather sought to interpret very humbly our share in the response to that old message "Go ye into all the world". She believes that the world begins at home and extends for each of us as far as we can visualize it spiritually. She feels it is a hopeful sign that many parishes in the Diocese are unifying woman's work and understanding that New York makes no distinction where our work is done if the Mission of the Church is being fulfilled by its accomplishment. There are difficulties in grasping this newer and broader conception of Auxiliary work and she has sought to clear away some of them. It is gratifying that many well balanced programs are formed and used by the branches—if you haven't seen some of these in our exhibit, do take time to do so.

It has been a very deep happiness for your Chairman to serve you and to have had the experience of knowing so many Church women in an intimate way. She is grateful to all of you who have received her so cordially. The glory of the Auxiliary work to her is its inclusion of all women and its recognition of all talents. This universal call she has sought to emphasize and would leave with you a simple poem which many of you have heard her read as expressive of this thought.

When the President of the Church Club remarked on Monday night that your Chairman was about to sing her swan song, it seemed to her that it might be a lament, at severing a relation which has held for her such inexpressible joy. But over and above the lament it is a peon of thanksgiving that she should have been, with her poor bag of tools, a link in the chain of those who bind together the women of this Diocese in the service of the Master.

To each is given a bag of tools
A shapeless mass and a book of rules
And each must make, ere life has flown
A stumbling block or a stepping stone."

ANNUAL REPORT OF THE VICE-PRESIDENT

During the past two years, your vice-president has had the pleasure of representing you on the Board of the Woman's Department of the Chicago Church Federation. This affiliation with the Department has given the Woman's Auxiliary many opportunities to share in the Interdenominational luncheon meetings arranged for outstanding visiting missionaries including, Dr. Ida Scudder of Vellore, India, Dr. Kagawa of Japan, Dr. E. Stanley Jones of India, Dr. Frank Laubach of the Philippines and Miss Muriel Lester of England. Participation in the World Day of Prayer has been a happy experience as has our contacts with the women of the other denominations.

The regular meetings of the Town and Country Council and the Social Service department of the diocese have been attended whenever possible. It was a privilege to have been one of your delegates to the Provincial Synod at Madison in October, and to the Cause and Cure of War Conference last month.

Believing that the Woman's Auxiliary offers as great an opportunity for service to others, as many of the secular organizations, your vice-president has endeavored to interest the younger women in the Deaconess Aid Committee. We have had an enthusiastic response to every request, and a desire for definite service has been manifested. For more than a year, Mrs. Skinner and Mrs. Le Moyne of Grace Church, Oak Park, visited the Cook County Hospital regularly each month with Deaconess Parsons and when obliged to discontinue their visits in June, they had endeared themselves to many of the patients who eagerly looked forward to their friendly visits. With the splendid support of Mrs. Fitts, the president of the Junior Guild and Auxiliary of St. Luke's, Evanston, volunteers were secured to carry on the monthly visits. Under the direction of Deaconess Parsons, three Aids visit about 125 patients in the fracture wards of Cook County Hospital, distributing packages of home-made candy and cookies, occasionally a cup of ice cream and as many magazines and playing cards as the Aid has been able to secure. Making a friendly visit in the name of the Church to those who spend months at a time in this great institution, has been of value we think.

The City Missions groups of St. Luke's and St. Mark's, Evanston, were happy to provide a picnic at Lincoln Park in June for Deaconess Lyon's little girls from the Frances Juvenile Home. St. Mark's group also provided refreshments for a party sponsored by Deaconess Lyon at the Psychopathic Hospital in November and sent bags of candy for 100 patients at Christmas time. Mrs. PenDell of Christ Church, River Forest, has been a faithful Aid to Deaconess Lyon throughout the year. The Auxiliary of St. John's Flossmoor, gave two supper parties for more than 100 each at Oak Forest during the year; also the Auxiliary of St. Ambrose, Chicago Heights, gave a party to 130 bed patients in the women's section. These parties were planned with Deaconess Parsons's co-operation and have brought happiness to each one who participated. Mrs. McDougall of St. Clement's, Harvey, has given invaluable assistance at Oak Forest to the deaconess.

An effort to organize a motor corps was made in the spring with some success. Auxiliary members of St. Clement's, Harvey and St. Ambrose, Chicago Heights, deserve special mention for their generous response to the request for drives for some of our people at Oak Forest; also to Mrs. Seymour Neill of Christ Church, Chicago, who took several patients chosen by Deaconess Wilson and Deaconess Weaver, from the Home for Incurables for a drive each Monday in June. A welcome change for our people who are unable to leave the confines of the Home. Mrs. Zweible of St. Mark's, Evanston and Mrs. Warren of St. Chrysostom's, were happy to use their cars on several occasions driving Deaconess Lyon and Deaconess Parsons on special calls. There is real need for such assistance to our deaconesses and perhaps the motor corps may develop more definitely this year.

Your generosity during the past year in making caps and shawls for the patients at the Cook County Tuberculosis Hospital has been appreciated by Deaconess Wilson. It has been necessary only to mention the need, to receive instant offers to make them. This sort of work is vital and worth all it costs in time, material and effort.

This has been a year of joyful service to our Lord and of deep appreciation to Mrs. Cotsworth for the loving kindness and co-operation constantly given.

EDUCATIONAL DEPARTMENT

During the past year the Educational Department has conducted two series of Normal classes. During last February those on Latin America were very ably presented at St. James' Parish House, by Mrs. Hoskins. Due to the extremely cold weather the attendance was less than we had hoped for, the average being eighteen from twelve parishes. However, many classes were held without the Normal aid and we have forty-nine parishes reported as having studied Latin America in some way. Hoping to make these classes more available to you as to weather and location, the committee arranged for our 1937 study class on the "Negro in America" to be given by Mrs. Righter at the YWCA rooms at E. Monroe St. during October and November. The experiment failed. Mrs. Righter did a splendid job but the average attendance was 6 from not more than 4 parishes. We will not do that again. The study book for the current year is "A Preface to Racial Understanding," by Chas. S. Johnson to be had here at the Auxiliary Exhibit or from the Supply Department for 60 cents. If, instead of a class on this subject you prefer to have a speaker, we have three good ones to offer, Mrs. Righter, Fr. Suthern and Fr. Martin. May I urge you to avail yourselves of their services?

Wherever there is a study class in a parish we might consider it good Auxiliary work to build up attendance for that class. If no class exists will you try to instigate one? Study something—if not the suggested subject, then something else, Special Mission field, Peace, Prayer, Church History, Prayer Book, Bible, Religion in the Home or whatever most appeals to your group.

The Auxiliary Classes at Kenosha Conference were "The Negro in America" led by Mrs. Righter and a general Auxiliary course, the first three days of which were on Christian Citizenship led by eminent specialists in their fields of History, Social Service and Economics; the rest of the time taken by Auxiliary leaders in their various fields.

Auxiliary Day at Kenosha was well attended by 137 people representing five Dioceses and 33 Chicago parishes. They heard a stimulating address on Liberia by Fr. John Flagg, O.H.C.

As Educational Chairman I have spoken in eight parishes and sat in at four meetings of the Department of Religious Education of the Diocese.

The department furnished two scholarships to the Kenosha conference. The conference is a grand opportunity for stimulating interest in the Church work, and few investments will bring you better return than to send one or more of your women to make use of that opportunity. If you have no one to send please make room in your budget for a contribution to the Educational Fund for Scholarships.

ANNUAL REPORT OF THE SUPPLY DEPARTMENT.

It is with a feeling of profound gratitude that I bring to you this morning a summary of the work done by the Parishes in the five fields, as reported to this department in the annual reports for 1936.

102 Branches reporting as follows:

30 Branches did not report as of this date.

The Box Work went to six Institutions, including a box to Liberia weighing about 500 lbs.; besides 21 personal boxes for Missionaries and their families.

As the majority of Branches noted the annual report blanks were headed with the following 3 questions:

1. Did your Branch celebrate the 65th Anniversary of the Founding of the Woman's Auxiliary?

106 responded as follows: 38 in the affirmative, 42 negative and 26 did not answer the question.

2. Did your Branch consider the subject for the Lenten Study Class, "Latin America"?

34 Branches answered yes, 41 answered no, and 31 did not answer the question.

3. Did your Branch observe Armistice Day for intercessory prayer?

62 answered yes, 20 answered no, and 24 did not answer the question.

The Chairman of the Diocesan Pantry reports 89 branches sending 3,650 glasses of jelly, 137 quarts of fruit, 666 cans fruits and vegetables to the Diocesan Institutions, valued at \$667.00 plus a check for \$54.00 donated by Church of the Holy Spirit, Lake Forest.

During this year, 39 Branches have bought material from this department; 13 received free supplies, as well as 7 individuals in the rural district.

More than 500 letters were written and various leaflets were sent to all Branches. The supplies for the Educational Dept. were handled through this department; about 50 books have been loaned by the Charlotte Folds Mem. Library. Various Branches of the Woman's Auxiliary held committee meetings in the Supply Dept. room, such as: Nominating Com., Com. on Revision of By-Laws, U.T.O. and others.

I am very sincere when I say I believe this report would be most incomplete unless mention be made of one who the past several years has done more than any of us realize to put the Supply Dept. where it is today, therefore I am happy to pay tribute to our fine custodian, Miss Irma Arzbacher, for her efforts and courtesy shown this department and to the various Parish Branches.

REPORT OF MONTHLY MEETINGS

Seven monthly meetings of the Chicago Branch of the Woman's Auxiliary have been held in Roosevelt Hall of the State-Lake Building, since the Annual Meeting of February, 1936, with an average attendance of 139 from seventy-one parishes.

The three other meetings of the year were all well attended. At Saint Chrysostom's Church for the Annual Meeting 510 were present from seventy-eight parishes; 381 from sixty-nine parishes at the United Thank Offering meeting at Saint Peter's Church; and 198 from thirty-five parishes at Trinity Church on the Quiet Day.

Honorable mention for total attendance during the year at the monthly meetings should be made of Saint Christopher's, Oak Park, with sixty-six; Grace, Oak Park, with fifty; and Saint Paul's, Kenwood, with forty-seven.

Many messages of inspiration and interest were brought to the meetings by the following guest speakers: Bishop Stewart, Father Parker, O.H.C., Dean Emerson, Father Bowman, Sister Mary Elizabeth, S.C.S.F., Mrs. Luther, Father White, Father Hanner, Mrs. MacNair, Dr. Franklin, Father Stark, Dr. Randall, Miss MacNair, and Miss Gray.

The Church Periodical Club is a cooperating agency working in and through all organizations in the work of the church, for the spread of Christ's Kingdom.

Seven meetings have been held including a Corporate Communion with Bishop Ziegler as Celebrant and a Book Tea. At two of these meetings the guest speakers were Rev. John Pickell and Miss Genrose Gehri. Ten new parishes have been added to our list making a total of 67 active parishes. Thirty-one Diocesan Institutions and nine other institutions throughout the world have been regularly supplied with reading material.

The Church Periodical Club shared with the other Diocesan organizations in the exhibits at the convention held in St. Chrysostom's last February.

Through the splendid cooperation of the parish secretaries we have been able to comply with the many appeals made to your Director at the National Conference for Rural Workers at Madison even including a Victrola and typewriter in perfect condition. The sum of \$239.83 has been spent for magazine subscriptions, endowment fund, stationery, freight, etc.

I have visited 29 parishes, attended 2 Deanery meetings, the National Conference at Madison and the Synod of the Fifth Province in Madison. With the fine assistance of Mrs. Armstrong and Miss Brown, many parishes, church schools and Girls' Friendly, we are able to make the following report:

I had the pleasure of attending the Provincial Synod at Madison where I visited Saint Francis House, the center for Episcopal students attending the University of Wisconsin. It was an inspiration to learn from Father Kelley about his work among the future leaders of our church.

U. T. O. ANNUAL REPORT

The promotion and work for the United Thank Offering has been carried on in our Diocese during the past year by a committee of eight women representing the respective Deaneries.

The result has been that four Parishes who have not responded before, have made contributions and seven who had lapsed more or less of late years are now active again. Our Spring and Fall offerings were encouragingly larger this year and we have reason to believe that with continuing effort this our Triennium Year will be more successful still for the gift which we will send as our United Thank Offering from the Diocese of Chicago.

ANNUAL REPORT OF THE SOCIAL SERVICE COMMITTEE OF THE WOMAN'S AUXILIARY FOR 1936

The Social Service Committee has received from the Auxiliaries of sixty parishes reports of the social work that is being done. These reports came to us in response to a letter and questionnaire sent out by the Chairman of the Social Service Committee the latter part of November to all Social Service Chairmen and to the Presidents of Auxiliaries which have not as yet appointed a Social Service Chairman.

We find from these reports that most auxiliaries have representatives for some of the Diocesan Social Agencies, only a few have representatives for all; others have no representatives. However, the great majority of the Auxiliaries reporting, whether they have a representative or not, make some contribution (large or small), through money, clothing, food or services—such as, assisting in the selling of tickets for benefits; assisting with tag day; sewing for the institutions; doing clerical work or supplying motor service both for workers and for the children and elderly people who live in our church homes. Many of the parishes do an amazing amount of work for the agencies as well as assist to a marked degree financially.

The reports revealed further that there is considerable work being done in many parishes, large and small, for their own communities, while in others nothing is done locally.

It was most revealing, and certainly interesting, to note the extent and variety of social work being done in their own community by some of the smaller parishes.

Many of the Auxiliaries have co-operated with their local social and relief agencies, assisted individuals and families; supplying money, food, clothing and furniture; finding work for the unemployed; contributing to the Y.W.C.A., Y.M.C.A., Girl and Boy Scouts, Needlework Guild, Infant Welfare, Day Nurseries; sewing for thrift shops which support a community nurse; assisting in work done for their local hospitals, for those in our prisons, veterans' hospitals, Cook County Hospital, Elgin and Kankakee Hospitals, and Oak Forest Infirmary.

During the past year the Social Service Department has had four meetings. The last one was a Social Service Tea given at St. James' Community House on December 7th. There were fifty guests present in spite of the fact that many of those invited were unable to attend because of the bazaars being held in their parishes that week.

At this meeting Dr. Herbert W. Prince, Rector Christ Church, Lake Forest, who is Chairman of the Diocesan Council of Social Service, spoke on the Social Work of the Episcopal Church, giving a comprehensive and most understandable picture of the broad scope of this branch of the work of the Church as it is outlined by the National Council, as well as presenting our Diocesan and Parish relationship to the general plan.

Dr. Prince went quite thoroughly and most interestingly into the various subjects with which social work must concern itself—such as, Unemployment, Relief, Housing, Delinquency, Marriage and Divorce, Industrial Problems, Racial Problems, Contemporary Social Movements, Peace and War, and the relationship of our Christian Philosophy to all of these movements and problems.

At this meeting Mrs. Frederick Seymour, our First Vice-President, told a very intimate and personal story of the Deaconess Aid work; and Miss Caroline Larabee spoke of the work done through the Town and Country Missions, explaining the calls which will come through this Committee from time to time for clothing and occasional small sums to take care of the needs brought to the attention of Father Bowman in his work. Both of these Committees are now a part of the Social Service work of the Woman's Auxiliary. Miss Ann Hull, the new head of the House of Happiness, was introduced to those present, everyone being delighted to have an opportunity to meet her.

Your Social Service Committee stands ready to supply information concerning Study Courses on the various social problems of the day. These have been outlined by the Social Service Department of the National Council. They would doubtless afford interesting Lenten Study Work.

REPORT OF DEACONESS DISCRETIONARY FUND, 1936.

We are in the dawn of a new year, but we are still hearing echoes of 1936. Echoes of gratitude and appreciation from those we have been able to encourage and cheer because of this Fund.

It would be impossible to tell you into how many different directions the Deaconess Discretionary Fund goes and how much comfort and help it brings.

In our County and State institutions where comforts and luxuries are scarce the Discretionary Fund brings cheer and encouragement in a dozen different ways. Little dainties in the way of food, warm clothing, car-fare when patients leave the hospital, sometimes taxi fare when discharged patients are too weak to get home any other way. Room rent paid and food provided to tide over the time between hospital and connection with relief agencies. Flowers for Chapel Altars for special services. Gifts of crosses and Crucifixes to patients at their Baptisms and Confirmations. Books of devotion and many emergencies too numerous to mention.

A patient after spending seven years in a Sanitarium was told she was as well as she ever could be and her bed was needed for a sicker person. During her stay in the Sanitarium her husband disappeared. This is not an unusual occurrence; often we find patients lose track of friends and relatives after prolonged illnesses. This woman had nothing. For years she had worn the clothes provided by the institution. She had no income of any kind and her only friends were those whom she had made in the Sanitarium. All she had left was her Church so she turned to us for help. Here the Discretionary Fund came in; it provided her clothing and food and paid her room rent until the Relief Agency made necessary investigations and began operating.

A devoted member of one of our parishes was left alone, sick and penniless. We were called in to help. After finding a life insurance policy we were able to place this sick woman in a home by turning the policy over to the home. The Discretionary Fund provides clothing and other small needs for this sick old woman and she will be cared for the rest of her earthly life.

A baby was born to one of our Church girls in a Tuberculosis Sanitarium and we were notified to provide a home for the baby at once, as the father had no way of caring for the child and there was no one else who would take the responsibility. The baby could not remain at the Sanitarium; within twenty-four hours we had the baby taken from the Sanitarium and placed with the Children's Home and Aid Society. The Discretionary Fund providing the first expenses necessary until the father was able to carry on.

We could tell you many more such stories, but you can see from these few glimpses into City Missions that we could not carry on this work without the Fund you so generously give us, and we are very grateful.

This Fund is Sacramentally fulfilled through service and each one of you has a definite part in this service through the gifts you give.

Christian Service brings us to the throne of Christ and the Blessed Virgin, His Mother.

REPORT OF THE DEPARTMENT OF EVENING GUILDS.

Our President, Mrs. Cotsworth, has given special attention to the place of the business woman in the Church's program. As she visited parishes she found Evening Auxiliaries whose members could not attend the monthly meetings, thus missing the inspiration which they always give. She called the leaders of these groups into a council, and plans were made for some evening meetings with Missionary speakers.

Last February the Council elected a representative who was to sit in at the Woman's Auxiliary Board meetings and help Mrs. Cotsworth in visiting branches, acting as a liaison officer between the Woman's Auxiliary and the business woman.

It has been a great privilege as well as a pleasure to serve as this representative in 1936, and I am glad to report that the Evening Division of the Woman's Auxiliary has become a definite organization. Our meetings have been delightful. We have come to know and enjoy each other, and have been brought into closer touch with the Missionary program of the Diocese, the Nation and the World.

We have held two Council meetings this past year, and three Diocesan dinner meetings. A splendid Lenten meeting was held March 17th at the Church of the Ascension, with a Quiet Hour conducted by Father Stoskopf. Eighty were present, representing thirteen parishes. Ninety-five people attended an enthusiastic meeting at St. Paul's, Kenwood, on May 4th, with Mrs. Cotsworth, Mrs. Belliss and Mrs. Hartigan as speakers. The fall meeting was held at St. Chrysostom's, November 4th, with 116 present. Addresses were given by Miss Hammond from China, Miss Gladys Gray from Japan, Mrs. Charles S. Williamson and Bishop-elect Ziegler.

As Chairman of Evening Guilds, I have attended in addition eight monthly meetings and seven Board meetings of the Woman's Auxiliary; three Deanery meetings, a conference of U. T. O. custodians at St. Mark's, Evanston, the Provincial Synod at Madison, and a brief meeting of delegates at the Kenosha Conference. I have had also the great pleasure of visiting five Evening Guilds, and have had many contacts which I hope eventually will mean new branches.

Many parishes have Evening Guilds which are not members of the Woman's Auxiliary. They are members of our Division, however, and we hope that they will soon see the previous value of joining hands with the women of the Church, and enlarging their vision and influence. One such Guild, St. Margaret's, of the Church of the Advent, has become a member of the W. A. this year, and we hope that in 1937 more will do the same.

The business or professional woman, with her trained mind, has much to contribute to Church work. The Church has everything to offer her in fellowship, service, and spiritual resources. In the coming year we hope to develop our work still further, and plead for opportunities to do this. If any Rector or Auxiliary President is interested, or knows of women who are not in any Guild, but could go to the Diocesan meetings, I shall be happy to be of use to them.

May I express our deep gratitude to Mrs. Cotsworth who has always been an inspiration to us, and to the members of the Board who have been generous in their cooperation; also to Miss Christine Jacobs, our efficient secretary.

GIRLS FRIENDLY SOCIETY, 1936.

Leadership was the keynote of the 1936 program of the Girls Friendly Society. Mrs. Cleon E. Bigler led a discussion on leadership at an Associates meeting. Mrs. Leonard Purcell arranged for a Conference for Candidate leaders. The younger members conference was held at the G. F. S. Holiday House at Glenn, Michigan. Delegates were given training in program making, missions, the use of natural instincts, and personality factors necessary to good leadership. Mrs. Benson Belliss and Mrs. John R. King presented the topics.

The fiftieth anniversary of the G. F. S. of St. James' Church was commemorated with a pageant which was written especially for the occasion by Mrs. King. A scholarship fund was established and is available for the members of the society for educational purposes.

Miss Genrose Gehri spoke of her work at the G. F. S. Council meeting which was one of the social service projects for the year. Chase House and St. Luke's Hospital was included in the pledge card. The Diocesan organization supplied a scholarship for a girl at Bantoc, P. I. and contributed \$130.00 to the National Missionary Project, to support an assistant at St. Faith's School, Yang Chow, China.

Four North Side branches had a regional meeting at St. Mark's, Evanston. This was a new venture, and was the means of making known to over one hundred members the Diocesan work of the Society, its officers and their work. Four South Side branches arranged the Annual Meeting at Holy Cross-Immanuel Church. Seven Associates represented Chicago at the National Council held in St. Louis. At that time Mrs. Cleon E. Bigler was elected National Head of Candidates, and Mrs. John R. King, Vice-President of the Province, succeeding Mrs. Richard Austin.

Branches throughout the Diocese have co-operated with other church organizations whenever possible: members are serving on Altar Guilds, as Church School teachers, and singing in church choirs. We feel that our program, which embraces missions, social service, and service to the church, is training our members for a fuller service to the church in years to come. The year has been a very interesting one, and modest but definite progress has been made in the development of leadership.

BY-LAWS.

- I. The election of officers at the annual meeting shall be by acclamation.

Amendment to By-Law No. 1.

Beginning with 1928 and thereafter on the even calendar years, the first Vice-President and four Deanery Vice-Presidents, the Treasurer, Recording Secretary, the Chairman of Supply Department and Box Work, the Chairman of Social Service and the Chairman of Education shall be elected by the Woman's Auxiliary at its Annual Meeting, to serve for a term of two years.

Beginning with 1929 and thereafter on the odd calendar years the President, four Deanery Vice-Presidents, the Corresponding Secretary, the Director of Evening Branches and the Director of the Monthly Meetings shall be elected by the Woman's Auxiliary at the Annual Meeting to serve for a term of two years.

No member shall serve on the Executive Board (in the same office) more than two consecutive terms.

The United Thank Offering Director shall be elected for a term of three years, serving through a Tri-ennial Convention.

II. When a vacancy shall occur in the Executive Board, the members of said Board shall have power to appoint some one to fill the unexpired term.

III. Special meetings shall be called by the President, at such time and place as she may designate, for the purpose of stimulating interest in the work.

IV. It is the duty of every Parish Branch to contribute to the General Fund of the Chicago Branch of the Woman's Auxiliary for its running expenses and also to pledge, as they are able, to the projects on the Pledge Card.

V. The Treasurer shall furnish bond for such amount as shall be determined by the Executive Board, such bond to be paid for from the funds of the Woman's Auxiliary.

VI. At the November Board meeting the President shall appoint a Nominating Committee of four members who shall report at the annual Meeting.

VII. The regular order of business at the annual meeting shall be as follows:

1. Devotions.
2. Minutes of last Annual Meeting.
3. Business—Announcements.
4. Reports of officers and committees.
5. Election of officers.
6. Memorial and message from the Bishop.
7. Offering and Roll Call.

VIII. These by-laws may be amended at the Board meeting preceding the Annual Meeting. Amendments to be endorsed at the Annual Meeting by a majority vote of those present.

These by-laws were amended by the Executive Board at the meeting January 7, 1937 and the action endorsed at the Annual Meeting of the Chicago Branch of the Woman's Auxiliary, February 4, 1937.

ARTICLES OF INCORPORATION

STATE OF ILLINOIS, } ss.
COUNTY OF COOK.

To James A. Rose, Secretary of State:

We, the undersigned, Marie M. Hopkins, Emily Pardee Street and Frances C. McDermid, citizens of the United States, propose to form a corporation under the Act of the General Assembly of the State of Illinois entitled, "An Act Concerning Corporations," approved April 18, 1872, and all acts amendatory thereof, and that for the purpose of such organization, we hereby state as follows:

I. The name of such corporation is
"The Chicago Branch of the Woman's Auxiliary to the National Council."

II. The object of this corporation shall be: (a) To interest all of the Parishes and Missions in the Diocese of Chicago in the different branches of missionary work, as conducted by the General and Diocesan Boards, and to the purpose of aiding said societies in carrying on the said missionary work in connection with the said Diocese and the said General Church. (b) An Auxiliary to the National Council and to the Diocesan Council of the Diocese of Chicago of the Church known in law as "The Protestant Episcopal Church in the United States", and its management is to be in accordance with the Constitution and Canons of said Diocese of Chicago and of said Protestant Episcopal Church and not for pecuniary profit.

The corporation shall have power to receive donations, subscriptions, legacies and bequests to be used for the carrying on of the said missionary work and of the said Church in the said Diocese of Chicago and of the missionary work of the National Council.

III. The Board of Directors shall have power to organize branches or recognize existing branches in every parish or mission in said Diocese under the rules as they may adopt from time to time.

IV. (1) The officers of the Society shall be an Honorary President, a President, not less than five (5) Vice-Presidents, a Corresponding Secretary, a Recording Secretary and a Treasurer. (2) The Bishop of the Diocese shall be the Honorary President.

V. The management of the Chicago Branch of the Woman's Auxiliary to the National Council shall be vested in an Executive Board of not less than nine (9) nor more than twenty-one (21) members, of whom the Officers and elective Directors shall be a part.

VI. All of the Elective Directors shall be elected at the annual meeting of said corporation, which shall be held on the day after the close of the Diocesan Convention, except when the day falls on a legal holiday, when the Executive Board shall appoint another day for the election of officers. The number of said Directors may, from time to time, be varied, and the Directors shall be elected in accordance with the statutes of the State of Illinois, and the By-Laws of said corporation, to be hereafter adopted. The Executive Board shall meet monthly, except during the months of July, August and September.

(2) The Executive Board shall have power, as necessity may arise, to appoint annually, other chairmen, who shall not, however, be members of the Executive Board.

(3) The duty of the President shall be to preside at all meetings of the Association and of the officers, to arrange for the organization of branches, to visit the same and to have the general charge of the work under the direction of the Bishop.

(4) The duty of the First Vice-President shall be to preside in the absence of the President, to co-operate with her in the general supervision of the work of the Association and to take charge of the departments of work to which she may be assigned.

(5) The duty of the Corresponding Secretary shall be to conduct the necessary correspondence required by the Auxiliary, and to prepare the Year Book and have it printed. The duty of the Recording Secretary shall be to send out notices of all meetings and keep a record of the same.

(6) The duty of the Treasurer shall be to receive all special and general funds; to disburse the former as the donors indicate, and the latter under the direction of the Executive Board and to render an account of the same at the monthly and annual meetings.

(7) The Treasurer's yearly accounts shall be audited by credited accountants.

VII. The following persons are hereby selected as the directors to control and manage said corporation for the first year of its corporate existence:

Vincy B. Fullerton, Vice-President.
Emily Pardee Street, Vice-President.
Eleanor M. Duncombe, Vice-President.
Jessie Peabody Butler, Vice-President.
Frances E. MacDermid, Corresponding Secretary.
Addie S. Chenoweth, Recording Secretary.
Emma J. Hoyne, Treasurer.

The said Directors shall hold office until the next annual meeting of said corporation and shall then be elected at the said annual meeting herein provided.

VIII. The Bishop of the Diocese of Chicago shall ex-officio be the Patron of the said corporation, and all of the acts of the Executive Committee and Society shall be subject to his approval.

IX. These Articles of Incorporation may be altered or amended at the Board meeting preceding the Annual Meeting. Amendments are to be endorsed at the Annual Meeting by a majority vote of those present.

X. The location is in the Diocese of Chicago, in the County of Cook, in the State of Illinois, and postoffice address of its business office is at No. 510 Masonic Temple, State Street, Chicago, Illinois.

SUGGESTED CONSTITUTION FOR BRANCHES.

ARTICLE I.

Name.

The name of this organization shall be the
Branch of the Woman's Auxiliary to the National Council.

ARTICLE II.

Objects.

Its objects shall be:

A. To cooperate with all of the plans undertaken by the National Council for the extension of Christ's Kingdom throughout the world.

B. To supplement the work of the Diocesan Woman's Auxiliary to the National Council.

C. To increase and deepen the spiritual life of the Parish by prayer, service and example.

ARTICLE III.

Membership.

Any woman who endorses the projects named in Article II shall be eligible for active membership.

ARTICLE IV.

Officers.

The officers shall be:

President
Vice President
Secretary
Treasurer
Educational Secretary
United Thank Offering Custodian
Chairman of Box Work.

The President, Vice President, Educational Secretary, and U. T. O. Custodian shall be Communicants of the Church.

ARTICLE V.

Duties of Officers.

Section 1. The President shall direct the work of the Branch; call meetings and preside over them; serve as head of a Committee on Plans for the Spiritual Development of the Branch; and be a member ex-officio of all Committees. She shall confer with the Diocesan Vice President of her District, reporting progress made and seeking counsel when desired.

Section 2. The Vice President shall preside in the absence of the President and shall act as Chairman of the Membership Committee.

Section 3. The Secretary shall give notices of meetings; keep records of them, and conduct the correspondence of the Branch. She shall send promptly acceptance or rejection of the allotment received from the Supply Department. She shall make reports at the Annual Meeting of the Branch, the Annual Meeting of the Parish, and to the Secretary of the Diocesan Branch.

Section 4. The Treasurer shall receive and disburse all funds except the United Thank Offering. She shall enter the amounts received in her books and pay out money only on the order of the Organization, preserving all vouchers. The books shall be audited annually.

Section 5. The Educational Secretary shall have charge of the study, reading, and general information. She shall attend the Diocesan Annual Course for Study Classes and conduct the Parish Class. She shall plan and conduct program meetings.

Section 6. The United Thank Offering Custodian shall make this offering known to all women of the Parish and distribute the boxes to them. The contents of these shall be presented at a Corporate Communion service semi-annually and immediately remitted to the Diocesan United Thank Offering Treasurer.

Section 7. The officers of the Branch shall meet regularly to confer upon the work of the Branch and plans for its development.

ARTICLE VI.

Meetings and Dues.

Section 1. The meetings of the Branch shall be held
(weekly, bi-monthly or monthly).

Section 2. Every baptized woman being automatically an Auxiliary member, shall designate the amount which she will voluntarily contribute to the financial program.

The Treasurer shall remit an annual due of one dollar (\$1.00) for the Branch to the Diocesan Treasurer.

Section 3. The Annual Meeting shall be held the first meeting in January.

ARTICLE VII.

Elections.

At the November meeting the President, with the approval of the Rector, shall appoint a Nominating Committee of three (3) members of the Auxiliary who shall report at the December meeting.

The election of officers shall be by a majority ballot at the annual meeting in January.

No officer may hold office longer than two (2) terms of two (2) years each. Vacancies occurring in any office shall be filled by the Executive Committee to serve until the next election.

ARTICLE VIII.

Order of Business.

The meetings shall be opened with prayer, which should include the Auxiliary and United Thank Offering prayers.

SUGGESTIONS.

That this Constitution be read aloud once a year, preferably at the Annual Meeting.

That the larger Parishes be zoned by the U. T. O. Custodian, with a key-woman as Captain in each zone, thus increasing the scope of the Thank Offering work.
