DIOCESE OF CHICAGO**

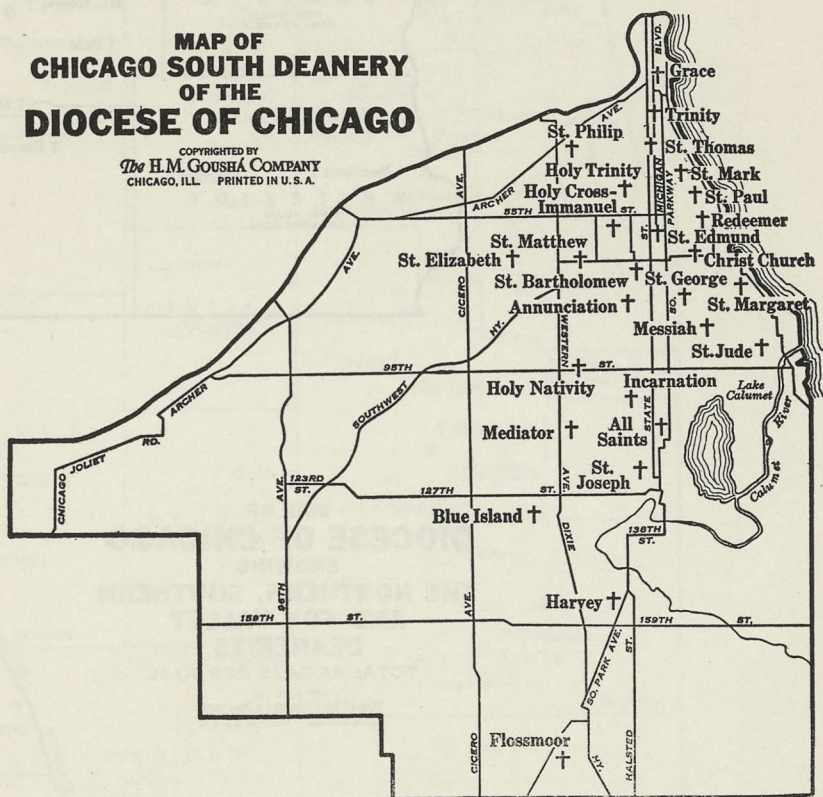

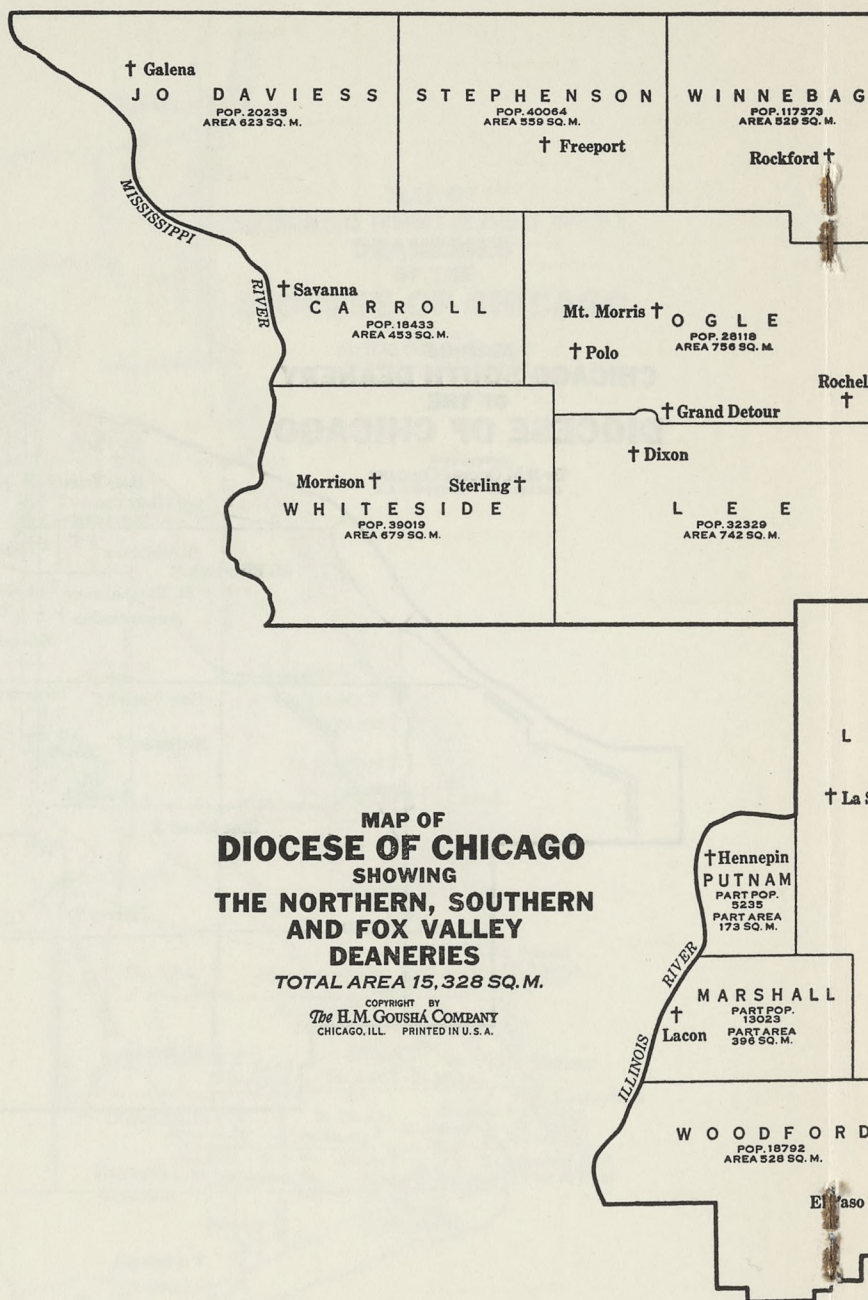


# **MAP OF CHICAGO SOUTH DEANERY OF THE DIOCESE OF CHICAGO**

## PRESIDENT'S ANNUAL REPORT

A year ago, the doors to larger opportunity were opened to your president, who was privileged to share with you for a few brief months, closer companionship in the service of the Master.

Her report for that period will be one of thanksgiving for those few months, when she had a glimpse of the sunrise of opportunity and the companionship with "those whose feet are in the pathway leading to the fields of unselfish service." At all times she was aware: of your hearty cooperation; the loyalty of each Board member, whose service is an inspiration to service; the constant assistance and thoughtfulness of Mrs. Cotsworth, into whose capable hands she gratefully placed the affairs of the Auxiliary; and to our Bishop whose sympathetic interest and understanding was a blessing.

The key-note for the year's work was struck by Bishop Hobson, chairman of the Forward Movement commission, in his address at the annual meeting. He asked us to raise our conception of missions to a higher level, to realize that the mission of the church includes the whole vision of the church, and that we must accept our responsibility to share one with another, "the joy of being missionaries for Christ."

As a result of his challenge, a conference was held in April at which Miss Gladys Gray, one of our own missionaries home on furlough from Sendai, Japan, was invited to meet with the vice-presidents of the districts and deaneries, to discuss the plan of promoting a closer relationship between the members of the Auxiliary, and those missionaries who have been sent to the mission field from our own diocese. In order to have a definite personal contact direct from the mission field, two missionaries were allocated to each of the eight districts and deaneries with the vice-president as liaison officer for all activities in the field at home and abroad. The missionaries to be known and their work followed with sympathetic interest in the vice president's district or deanery. Reports to be made by a vice-president at each of the monthly meetings of the Chicago branch. Miss Gray's enthusiastic response to the idea, gave us courage to hope that the other missionaries would cooperate in our endeavor to create a deeper and more personal knowledge of our representatives in the field. The letters sent by your president to each missionary stating the desire of the Auxiliary to develop a deeper sense of unity and fellowship in the field and missionary, brought responses that are most gratifying. The correspondence between the vice-presidents and their missionaries has been valuable to all concerned.

The Forward Movement was also stressed at the conference. The vice-presidents again enthusiastically supporting the plan to know and care more about the mission of the church, accomplishing this in urging the use of the Forward Movement literature put out as a guide and help to all. The Forward Movement offers to each one an opportunity "for deepening the spiritual life, helping the church to go forward, and gaining mastery over oneself."

A conference on the "Missionary Motive," sponsored by the Forward Movement commission, was held at Seabury-Western Seminary in May, to which your president was invited.

During the spring three conferences for officers were held in the North Shore district, the Northern deanery and the Western deanery. It was also a stimulating experience to visit eight parish branches, to have the privilege of knowing more intimately the members of each branch, and to realize their enthusiasm and devotion "to the task that is set before them."

Meetings of the Town and Country Council, the Supply department, the Diocesan Evening Guild and correspondence amounting to 105 letters written by your president, are happy memories.

One of the important changes of the year, that took place at the March meeting, was the new meeting place for the Chicago branch from Roosevelt



Hall in the State-Lake Building, where we had met for eighteen years, to the attractive rooms on the 21st floor of the Real Estate Building, 32 W. Randolph St.

Your president of those first few months of the year, wishes to thank you for the many expressions of sympathy and for the prayers offered for her recovery during her illness. She has been constantly comforted by the words of our devoted friend, the late Father Newbery, who said, "Go in the faith that God never lets you go without His helping hand."

### REPORT FOR 1937 OF ACTING PRESIDENT.

It has been the earnest endeavor of your present chairman to carry forward the year's work just as the President you elected last February planned it, and she believes sincerely that whatever we have accomplished has been due largely to her inspiring start and the high standard which she set for us. Every department has functioned with care and efficiency so that as usual much appreciation is due each of the officers and special chairmen. Particularly do we say "Thank You!" to those devoted persons whose terms expire this year, and who pass on their work to new hands. They will be greatly missed but we welcome the new workers with enthusiasm and assure them of our cooperation. During the past year your Vice-President has become your Acting President, and has found it very easy and pleasant to slip back into the chair. She is appreciative of your gracious acceptance of the necessity. She presided at three board meetings and the general meetings which followed, and at one special luncheon held to hear Paul Rusch talk on the work of the Brotherhood of St. Andrews in Japan. This venture was so successful that she dares to express the hope of similar luncheons when other distinguished speakers are in our city. In passing, may she express appreciation to the Program Chairman for the splendid speakers provided for every meeting.

Her duties have included attendance at meetings of the Church Extension Department, the Town and Country Council, and the Board of Trustees for the Centenary Fund, as well as special conferences with officers when they were needed. She presided at the annual Auxiliary day at Racine when our own Bishop was the speaker, and was present at the three meetings of the Evening Guilds. The gratifying attendance at these latter has justified our adding their President to our Board. She again had the privilege of holding a seminar with the Seniors at Seabury-Western Seminary on the subject of Auxiliary work. She has accepted invitations to speak at six parish branches, and on March fourth she will have a part in the Inter-denominational World Day of Prayer in Savannah.

Your Chairman reports her humble part in a National Symposium on Religion and Youth held here last February when she was invited to open discussion on reaching the privileged young person from ten to twenty years. She welcomed an opportunity to address a Church group of young people on the Program of the Church. We are definitely committed by the past tri-ennial to closer cooperation with the G. F. S. and other young people's work. Already we have sitting in with our Board a representative of G. F. S. and we are asked to add this year some young woman who can bring us closer knowledge of youth and the Church's program for young people. Your Chairman attended the tri-ennial at Cincinnati in October as one of your delegates to the Woman's Auxiliary, and was privileged to bring a message of those great meetings to the Church Club of Chicago at their meeting in the fall. Each of your delegates is glad to carry to your branches details of those inspirational two weeks, when the theme of our deliberations was "Fellowship in Faith and Work." Triennial packet. Perhaps the most



significant part of the whole Convention, at least it seemed so to this delegate, was the spirit of unity, and the desire for unified purpose, unity in our share of the Church's work, unity with all parts of the Church's Program, and unity with the Christian world at large. As a concrete effort in this direction in our own particular field more and more the parishes are unifying all woman's work, or correlating it very definitely.

In the digest of your Treasurer's report three items in comparison with last year bring encouragement. The branches report an increase in contributions for Diocesan work, and a very substantial increase in their gifts to the Church's program, which means we are supporting the Bishop in his acceptance of the National responsibility of the Diocese,—for it helps to meet the Quota. At the same time our U. T. O. has increased (both for the past year and for the Tri-ennial) not so much as our U. T. O. Treasurer would have liked, because it does not yet represent every woman, but sufficiently to convince us that our thoughts are not centered on ourselves exclusively. May these three measures of our love and devotion go forward and multiply in the year which we shall soon begin under new leadership.

## REPORT OF EDUCATIONAL DEPARTMENT.

The Woman's Auxiliary is organized to provide a channel through which the National Council can arouse church women to the needs of the people among whom the church is at work—or should be at work. That a response may be made, we must know the needs. The more we know, the more interest is aroused, and when a need is known, what Christian woman fails to do something to help?

The Educational Department is primarily for the purpose of keeping our women intelligently informed of the work of the church and the needs of people with whom she works. May I make one last plea for a short regular review of church news at every program meeting? Keep informed as to what is happening in the church. If we knew about as many missionaries as we do movie stars, and contributed as much for their work as we do to the movies, how encouraged those missionaries would be!

The study classes last year were not so good. There were fewer classes than heretofore but those who studied "The Negro in America" found it very interesting. This year we are offering "Rebuilding Rural America" and "What is this Moslem World," both subjects of interest and importance. We had the privilege of splendid normal classes for both subjects in the Interdenominational Missions Institute late in September.

Those who attended found the teaching stimulating and helpful. So few of our women were there, however, that on January 24th, we held a one day normal class to present the materials and subjects for study.

Mrs. H. P. Hoskins presented the work on Rural America most interestingly and sold her topic so well in the morning session that when I presented the Moslem World in the afternoon my sales were few! It is an interesting subject too! Books and helps on both topics can be had here in our Auxiliary Exhibit or from the Supply Department.

As your Educational Chairman during the past year I visited and addressed eight parish branches and one sectional meeting, represented you on the Board of the Woman's Department of the Church Federation, and attended the Round Table of Jews and Christians, a conference of Educational Chairmen of the Province at Brent House, the Interdenominational Missions' Institute, an Interracial Conference in Evanston and attended General Convention acting as delegate one day.

Our Auxiliary class at the Racine Conference was well led the first week by Mrs. Reimer of Houghton, Michigan and less successfully led by myself the second week. Bishop Stewart gave us a fine talk on missions on Auxiliary Day when a large group of women attended the Conference.

My work as Educational Chairman has been most interesting to me and I regret my accomplishments have been so few.

## ANNUAL REPORT OF THE SUPPLY DEPARTMENT.

It is always a joy to your Supply Department Chairman to be privileged to bring to you the summary of all the missionary work done by yourselves and your Diocesan Auxiliaries.

You will be pleased to know that the value of your mission work in the five fields for the year 1937 amounts to \$74,734.20, divided as follows: Parish, \$50,865.24; Diocese, \$14,944.24; Community, \$2,870.95; Nation, \$5,269.94, and the World, \$783.83.

The box work for the past year was sent to five missions, five personal \$5.00 Christmas boxes, five to Missionaries and their families, and one to a Catechist.

Perhaps the most outstanding work done was that undertaken for St. Luke's Hospital, Manila, P. I., for which the following work was sent: 6,765 gauze compresses, 3,900 gauze squares, 21 operating gowns and 23 convalescent robes for patients; also a goodly number of household supplies.

Besides the allotted box work, several branches made layettes for use of the Town and Country Council in the Rural Field, and many hoods and shawls for the patients in the Municipal Sanitoriums visited by the City Deaconesses.

A report from the Diocesan Pantry shows 4,082 glasses of jelly, 101 cans of fruit and vegetables sent to our Diocesan Institutions representing a total value of \$629.00.

A special and most urgent appeal has come for many surgical dressings for the use of our Missionaries in China and may I also remind you that there are some supplies still needed for the Mission boxes for this year.

On your annual report blanks sent to this department the past month 111 branches out of a possible 130 have reported; 34 reported that they had under consideration in some way the subject for study, "A Preface to Racial Understanding," 44 did not, and 36 did not reply to the question. 34 branches observed Armistice Day as a day of Intercessory Prayer, 42 did not and 38 did not report on this question.

In ending this report may I express my sincere appreciation to the 120 branches that accepted their allotments of our Box Work and for their cooperation, and extend to the remaining branches an invitation to join in this splendid missionary box work this year. May I also give public thanks to Miss Irma Arzbacher, the Supply Dept. Custodian for her major share in the running of this department.

### REPORT OF MONTHLY MEETINGS.

Since the Annual Meeting of the Chicago Branch of the Woman's Auxiliary in 1937, there have been six monthly meetings held in the Masonic Hall of the Chicago Real Estate Board Building, with an average attendance of one hundred and forty-two from seventy-one parishes.

At the Annual Meeting held in the Church of the Atonement there were four hundred and eighty present from sixty-eight parishes. Four hundred and thirty-two from seventy branches attended the meeting at Christ Church for the Spring presentation of the United Thank Offering; and between three and four hundred were present at the Fall presentation service held at Saint James' Church.

The parish branch, having the largest total attendance present at the monthly meetings was Saint Christopher's, Oak Park, with a total of sixty-two for the year; second, Saint Paul's, Kenwood, with fifty-six; and third, Saint Luke's Pro-Cathedral, Evanston, with forty-five.

The year of 1937 might be called the Bishop's year, since nearly half of the guest speakers were bishops. They were Bishop Stewart, Bishop Hobson, Bishop Roberts, Bishop Zeigler and Bishop Cross. The other guest speakers were Dean Emerson, Mr. Joshi, Miss Marston, Canon Bridgeman, Deaconess Parsons and Dr. Wei. Each one brought to the meetings messages of great interest and inspiration, telling us of the work being done in our own city and diocese, in the nation, also of the Indians, the Forward Movement, and the missionary work in India, Jerusalem and China.

## ANNUAL REPORT OF THE CHURCH PERIODICAL CLUB, 1937

The aim of the Church Periodical Club throughout the fifty years of its growth, as a cooperating agency with all organizations of the Church, has been for the spread of Christ's Kingdom and the enriching of individual lives, bringing together those who have reading matter to share, with those who, for various reasons, do not have it.

During the past year seven meetings have been held including a Corporate Communion with the Rev. John Pickells as Celebrant and a Book Tea when 200 books were donated for the benefit of the library at Rosebud Mission in South Dakota. The Rev. Sidney Waddington of the Philippines was the guest speaker. Sixty-seven parishes are sharing in the work and through the splendid cooperation of officers and parish secretaries, reading material, including 49,507 magazines, has been regularly supplied 34 Diocesan institutions and 16 in other parts of the world, 39,500 greeting cards have been distributed besides books, scrapbooks, games, puzzles, victrolas, typewriters and spectacles.

An active part has been taken in the Town and Country Council.

Two delegates from this diocese represented the Church Periodical Club at the General Convention at which time the society was reorganized. Your Diocesan Director was elected Church Periodical Club president of the Fifth Province.

The Chicago branch contributed with others in the province toward the gift of books for Brent House celebrating the Golden Jubilee of the Church Periodical Club.

Corporate Communion were held in many parishes January 8th to commemorate the founding of the Church Periodical Club. Also various affairs throughout the Diocese to raise a gift of \$50.00 for the Endowment Fund.

A modest effort is being made to supply Prof. Paul Rousch with much needed books for a general working library for his Community Center and St. Andrew Brotherhood Headquarters. We shall be happy to submit the list to anyone wishing to contribute a book.

In the Church Periodical Club the story that counts is of human contacts, of personal service. It is friend sharing with friend and as such our many donors and secretaries "Carry On" with simplicity, that we may find a still larger and wider field of service and blessings in the years to come.

## REPORT OF THE DIOCESAN UNITED THANK OFFERING CUSTODIAN

What does the United Thank Offering mean to the women who give it? Obviously, an acknowledgment of benefits received. But when asked to speak in various places on the appeal of this phase of the thank offering, we found it also means: a way of sharing in the Forward Movement; a way of working for peace; of experiencing unity; of forgetting ourselves; of growing in constant awareness of God; of enlargement of personality; as well as an easy way of fulfilling that hard command, "Go Ye into all the world."

The United Thank Offering Exhibit upstairs attempts to answer the year's suggested theme-question in another way, and to show that there is no one set of givers and another of receivers. Dolls of many nations, kinds and colors, are bound together by a golden chain of thankfulness, passing thru the individual Blue Box used by Africans, mountaineers and ourselves alike, and then thru a larger Blue Box often used by parish custodians, and here representing the three steps in the ingathering of the whole. I should like to have the chain charged with a current, to make graphic the fact that we are not only bound together by a common motive, thanksgiving, but that each individual in the great chain is both giver and receiver; is held to the fellowship by that current, and must also transmit it to all the others.

That is what the current of God's love does. It is the energizing power thrilling us individual receiving links till we are surcharged with awareness of His care and blessings so that we pass on the current thru the medium of the Blue Box offering given at the moment, daily or hourly; then twice a year emptied into the larger parish box; united again at the diocesan altar; stored in the national generator at New York; and loosed into all the world after each Triennial distributes that accumulated force into lives again. The dolls show some of the nurses, teachers, college workers, whose given lives the U. T. O. has made available to go into all the world, passing the current on to foreign dolls, the strangers we don't know until the Current surcharges them and they in turn become transmitting links in the chain of a united Thank Offering.

Your diocesan U. T. O. Committee and Custodian have functioned on



three levels as a transmitting link; first, carrying the message as above by talks, articles, exhibit, personal contacts at meetings and two teas; second, as a secretarial link, contacting the 108 parish and mission units with one another and with national headquarters, thru three general letters, uncounted individual ones, pamphlets and blue boxes as requested, and 450 copies of the United Thank Offering number of the "Spirit of Missions" sold in April by the deanery members. The third is the treasurer's function of collecting, tallying and counting money at the semi-annual diocesan presentations.

This year the "diocesan altars" have been at Christ Church, Woodlawn, where, on May 27th \$4,768.69 was offered, and \$3,231.71 at St. James', Chicago, on September 30th, nearly a month early because of the Triennial presentation also falling in this 1937. Thanks to the policy of prompt transmission of diocesan U. T. O. funds to national headquarters Chicago's offering for the past triennium had "generated" \$514.68 interest.

Imagine the great moment at the Triennial Convention when your representative laid on the famous Golden Alms Basin at that perfect Corporate Communion service of October 7th, an envelope that loosed into all the world again the power represented by Chicago's \$21,198.51. Imagine the inspiration of meeting in the flesh those who have so long been famous names in missionary stories, hearing them tell how their rural mountain people or Liberians, for instance, had raised their Thank Offerings which in 1937 joined with yours to make the grand total of \$861,693.07.

With this power released it was found that the retiring fund was materially increased; more workers could have the coveted designation of "United Thank Offering worker"; training could be maintained; and a tiny amount was voted for repairs in the field,—but it wasn't enough to provide any new buildings this time.

Mrs. Cotsworth suggests that Chicago diocese make possible some buildings during the succeeding triennium by increasing the number of women and girls sharing in the joy of the United Thank Offering. With this inspiration let us start today to keep strong and pulsing the current of God's power that binds us all as both givers and receivers in the United Thank Offering.

#### REPORT OF SOCIAL SERVICE COMMITTEE FOR 1937

The report of the Social Service Committee for 1937 consists primarily of a summary of the plans and recommendations that have grown out of the addresses and open forum discussions at our two Social Service meetings—the one in June, held at St. Mark's, Evanston, when we were graciously entertained at luncheon by the Junior Guild, and the other at St. James' Parish House in December, followed by a Tea given by the Social Service Committee. Invitations to these meetings were sent to the Social Service Chairmen, to all Presidents of the Auxiliary branches, asking that they send representatives in order that they might become acquainted with this branch of the Auxiliary work as well as to those in the Diocese doing social work. At the June meeting there were seventeen and at the December meeting thirty, including the Committee, present.

During the year our Committee took care of an emergency call for a family of four young Church girls by bringing their needs for complete outfitting in clothes to the attention of four Auxiliary branches. They were most generously and beautifully cared for by the Auxiliaries in Kenilworth, Winnetka, and Glencoe and by The Rectors Guild of Highland Park.

At both of our meetings this year the Reverend Walter K. Morely, our Diocesan Social Service Executive, was the speaker.

At the June meeting the subject under discussion was "The Social



Service Chairman in Her Parish." This subject was discussed at length under the following outline, which gives briefly the ground covered.

First, the necessity for presenting the social point of view to the Rector, if he does not already have it, and of working thru him in the parish.

Second, the need to recognize the use of prayer as an aid to the effectiveness of the work.

Third, the outlining of details regarding the mechanics of a social service program in the parish, stressing the importance of having a Social Service Committee, the whole program being a group activity, composed of those in the parish interested in social thinking or in studying social problems. It is advisable to secure the help of a trained social person. If there is no trained leader in the parish, it is suggested the Social Chairman visit the local social agency in her community and offer to cooperate with her. "Co-operation" is the keynote of all work with any social agency.

"A Friendly Visitor's Committee" is also of value, and has a place in a parish social service program.

Finally, aside from actually taking part in the solution of some specific social problems, we have the educational side of our program.

I. The study of broad social and community problems;—the determination and molding of public opinion within the Church.

II. The discovery of the neighborhood by the parishes for the purpose of meeting effectively special problems there;—the Church's mission being to show the friendliness of religion.

At our meeting at St. James' in December, when Father Morely again spoke and led the discussion, the subject considered was "The Division in the Department's Work,"—that is the type of program each group might wish to take up. These were discussed under two heads: "Religious Social Service" and "Social Action."

"Religious Social Service" includes work in social institutions, such as our City Missions and in the specific church institutions and agencies. These represent "Social Work."

"Social Action" is a consideration of the Church's stand on social problems,—its social philosophy and ideals.

Each group carrying out a social service program must select the type of work it will do; that is, either study the Church's problems and become familiar with its stand on social questions of the day; or do some specific social work. To do both at one time is confusing.

The study of the problems in one's own community depends upon the type of neighborhood the parish is in. For example a group located in a parish on the South Side of Chicago in the industrial center would be interested in a study of the attitude of the Church on the questions of Industrial Relations, the Relationship between Capital and Labor, Unemployment and Relief, etc.

From the Diocesan point of view, the Department of Social Service looks to the Woman's Auxiliary Social Service Chairman in each parish as its contact to get a complete picture of all social work that is being done.

Your outgoing chairman and the members of this committee would like to leave with each Auxiliary branch a plea for united cooperation in the carrying out of the plans that have been formulated during the past year.

## REPORT OF THE DEPARTMENT OF EVENING GUILDS

We are happy to report that the Evening Guilds of the Diocese are becoming more closely organized with an increasing sense of being a part of the Woman's Auxiliary—the corporate body of the women of the Church. The chairman of this department has been made a member of the Board of the Woman's Auxiliary, thereby giving definite recognition to the business woman in the counsels of the Church's Mission, with the privileges and responsibilities which come with such an honor.

Our policy this year has been to make our members better acquainted with missionary fields and their workers. We sponsored four general evening meetings in 1937, beginning with an informal dinner together at the Annual Convention. The attendance at these gatherings ran from 75 to 110. At the Lenten meeting at the Church of the Atonement, Fr. Morley spoke to us on Social Service, Fr. Braithwaite on the needs for a Nursery School for colored children at St. Andrew's, Evanston, and Mrs. Frederick Seymour and Mrs. Cotsworth gave inspiring talks on the ideals of the Woman's Auxiliary. In the evening, Fr. Newbery gave a deeply beautiful series of meditations in the Church. We are grateful indeed for the privilege of hearing him at that time.

The Spring meeting at St. Mary's Home introduced it for the first time to many of our members. The Reverend Mother spoke to us, and also Mrs. Rattray on the U. T. O., and Miss Marston of the National Board, on her trip to Oriental mission fields. Bishop Cross and Miss Marston addressed the splendid fall meeting at St. Chrysostom's, on the General Convention. Thus, in one year, we have presented Social Service, Diocesan and foreign missions, the work of the Sisters of St. Mary, and struck a deeply spiritual note at our Lenten meeting. All business and professional women of the Diocese are welcome to these dinners, whether they belong to local Guilds or not.

We also, as true daughters of the Auxiliary, raised a little money—\$26.00 from the offering at our Lenten meeting, which was given to St. Andrew's Day Nursey; and \$30.00 at the Spring card party, which we divided among China relief, St. Mary's Home, and The Fort Valley Industrial School for Negroes.

As Chairman, I have enjoyed visiting seven branches, besides attending Deanery and Board meetings of the Woman's Auxiliary; and had the thrilling experience of a week at the General Convention. At that Convention, almost for the first time, mention was frequently made of the place of the business and professional woman in the work of the Church. By the next Triennium, I hope she will have found her place. She has a great contribution to make, with her talents, her techniques, her trained mind. As we work together, our objectives will become more clearly defined. It is challenging to have these eager groups coming into the Woman's Auxiliary. Two have joined this year, the Evening Guild of the Church of the Ascension, and St. Margaret's Guild of All Saints, Roseland; and new guilds are being started, which we hope will join, notably at St. Joseph's, West Pullman and at St. Chrysostom's. If any parish is thinking of starting an evening guild, I shall be very happy to visit or confer with them.

We have had splendid cooperation from the clergy and officers of the Woman's Auxiliary. The Vice-Presidents especially have been helpful. Much of our success has been due also to the interest and diligence of our Secretary-Treasurer, Miss Christine Jacobs of Grace Church, Oak Park.

This report would not be complete without a word of sincere appreciation for the inspiration and guidance given us by our Presidents this year, Mrs. Frederick Seymour, whose resignation we deeply regret, and Mrs. Albert Cotsworth, Jr., who has nurtured the Evening Guild Division from the beginning. We are fortunate indeed in having had such leaders.

## BY-LAWS.

I. The election of officers at the annual meeting shall be by acclamation.

### Amendment to By-Law No. 1.

Beginning with 1928 and thereafter on the even calendar years, the first Vice-President and four Deanery Vice-Presidents, the Treasurer, Recording Secretary, the Chairman of Supply Department and Box Work, the Chairman of Social Service and the Chairman of Education shall be elected by the Woman's Auxiliary at its Annual Meeting, to serve for a term of two years.

Beginning with 1929 and thereafter on the odd calendar years the President, four Deanery Vice-Presidents, the Corresponding Secretary, the Director of Evening Branches and the Director of the Monthly Meetings shall be elected by the Woman's Auxiliary at the Annual Meeting to serve for a term of two years.

No member shall serve on the Executive Board (in the same office) more than two consecutive terms.

The United Thank Offering Director shall be elected for a term of three years, serving through a Tri-ennial Convention.

II. When a vacancy shall occur in the Executive Board, the members of said Board shall have power to appoint some one to fill the unexpired term.

III. Special meetings shall be called by the President, at such time and place as she may designate, for the purpose of stimulating interest in the work.

IV. It is the duty of every Parish Branch to contribute to the General Fund of the Chicago Branch of the Woman's Auxiliary for its running expenses and also to pledge, as they are able, to the projects on the Pledge Card.

V. The Treasurer shall furnish bond for such amount as shall be determined by the Executive Board, such bond to be paid for from the funds of the Woman's Auxiliary.

VI. At the November Board meeting the President shall appoint a Nominating Committee of four members who shall report at the annual Meeting.

VII. The regular order of business at the annual meeting shall be as follows:

1. Devotions.
2. Minutes of last Annual Meeting.
3. Business—Announcements.
4. Reports of officers and committees.
5. Election of officers.
6. Memorial and message from the Bishop.
7. Offering and Roll Call.

VIII. These by-laws may be amended at the Board meeting preceding the Annual Meeting. Amendments to be endorsed at the Annual Meeting by a majority vote of those present.

These by-laws were amended by the Executive Board at the meeting January 7, 1937 and the action endorsed at the Annual Meeting of the Chicago Branch of the Woman's Auxiliary, February 4, 1937.

## ARTICLES OF INCORPORATION

STATE OF ILLINOIS, } ss.  
COUNTY OF COOK.

To James A. Rose, Secretary of State:

We, the undersigned, Marie M. Hopkins, Emily Pardee Street and Frances C. McDermid, citizens of the United States, propose to form a corporation under the Act of the General Assembly of the State of Illinois entitled, "An Act Concerning Corporations," approved April 18, 1872, and all acts amendatory thereof, and that for the purpose of such organization, we hereby state as follows:

I. The name of such corporation is  
"The Chicago Branch of the Woman's Auxiliary to the National Council."

II. The object of this corporation shall be: (a) To interest all of the Parishes and Missions in the Diocese of Chicago in the different branches of missionary work, as conducted by the General and Diocesan Boards, and to the purpose of aiding said societies in carrying on the said missionary work in connection with the said Diocese and the said General Church. (b) An Auxiliary to the National Council and to the Diocesan Council of the Diocese of Chicago of the Church known in law as "The Protestant Episcopal Church in the United States", and its management is to be in accordance with the Constitution and Canons of said Diocese of Chicago and of said Protestant Episcopal Church and not for pecuniary profit.

The corporation shall have power to receive donations, subscriptions, legacies and bequests to be used for the carrying on of the said missionary work and of the said Church in the said Diocese of Chicago and of the missionary work of the National Council.

III. The Board of Directors shall have power to organize branches or recognize existing branches in every parish or mission in said Diocese under the rules as they may adopt from time to time.

IV. (1) The officers of the Society shall be an Honorary President, a President, not less than five (5) Vice-Presidents, a Corresponding Secretary, a Recording Secretary and a Treasurer. (2) The Bishop of the Diocese shall be the Honorary President.

V. The management of the Chicago Branch of the Woman's Auxiliary to the National Council shall be vested in an Executive Board of not less than nine (9) nor more than twenty-one (21) members, of whom the Officers and elective Directors shall be a part.

VI. All of the Elective Directors shall be elected at the annual meeting of said corporation, which shall be held on the day after the close of the Diocesan Convention, except when the day falls on a legal holiday, when the Executive Board shall appoint another day for the election of officers. The number of said Directors may, from time to time, be varied, and the Directors shall be elected in accordance with the statutes of the State of Illinois, and the By-Laws of said corporation, to be hereafter adopted. The Executive Board shall meet monthly, except during the months of July, August and September.

(2) The Executive Board shall have power, as necessity may arise, to appoint annually, other chairmen, who shall not, however, be members of the Executive Board.

(3) The duty of the President shall be to preside at all meetings of the Association and of the officers, to arrange for the organization of branches, to visit the same and to have the general charge of the work under the direction of the Bishop.



(4) The duty of the First Vice-President shall be to preside in the absence of the President, to co-operate with her in the general supervision of the work of the Association and to take charge of the departments of work to which she may be assigned.

(5) The duty of the Corresponding Secretary shall be to conduct the necessary correspondence required by the Auxiliary, and to prepare the Year Book and have it printed. The duty of the Recording Secretary shall be to send out notices of all meetings and keep a record of the same.

(6) The duty of the Treasurer shall be to receive all special and general funds; to disburse the former as the donors indicate, and the latter under the direction of the Executive Board and to render an account of the same at the monthly and annual meetings.

(7) The Treasurer's yearly accounts shall be audited by credited accountants.

VII. The following persons are hereby selected as the directors to control and manage said corporation for the first year of its corporate existence:

Vincy B. Fullerton, Vice-President.

Emily Pardee Street, Vice-President.

Eleanor M. Duncombe, Vice-President.

Jessie Peabody Butler, Vice-President.

Frances E. MacDermid, Corresponding Secretary.

Addie S. Chenoweth, Recording Secretary.

Emma J. Hoyne, Treasurer.

The said Directors shall hold office until the next annual meeting of said corporation and shall then be elected at the said annual meeting herein provided.

VIII. The Bishop of the Diocese of Chicago shall ex-officio be the Patron of the said corporation, and all of the acts of the Executive Committee and Society shall be subject to his approval.

IX. These Articles of Incorporation may be altered or amended at the Board meeting preceding the Annual Meeting. Amendments are to be endorsed at the Annual Meeting by a majority vote of those present.

X. The location is in the Diocese of Chicago, in the County of Cook, in the State of Illinois, and postoffice address of its business office is at No. 510 Masonic Temple, State Street, Chicago, Illinois.

## **SUGGESTED CONSTITUTION FOR BRANCHES.**

### **ARTICLE I.**

#### **Name.**

The name of this organization shall be the \_\_\_\_\_  
Branch of the Woman's Auxiliary to the National Council.

### **ARTICLE II.**

#### **Objects.**

Its objects shall be:

A. To cooperate with all of the plans undertaken by the National Council for the extension of Christ's Kingdom throughout the world.

B. To supplement the work of the Diocesan Woman's Auxiliary to the National Council.

C. To increase and deepen the spiritual life of the Parish by prayer, service and example.

### **ARTICLE III.**

#### **Membership.**

Any woman who endorses the projects named in Article II shall be eligible for active membership.

### **ARTICLE IV.**

#### **Officers.**

The officers shall be:

President  
Vice President  
Secretary  
Treasurer  
Educational Secretary  
United Thank Offering Custodian  
Chairman of Box Work.

The President, Vice President, Educational Secretary, and U. T. O. Custodian shall be Communicants of the Church.

### **ARTICLE V.**

#### **Duties of Officers.**

Section 1. The President shall direct the work of the Branch; call meetings and preside over them; serve as head of a Committee on Plans for the Spiritual Development of the Branch; and be a member ex-officio of all Committees. She shall confer with the Diocesan Vice President of her District, reporting progress made and seeking counsel when desired.

Section 2. The Vice President shall preside in the absence of the President and shall act as Chairman of the Membership Committee.

Section 3. The Secretary shall give notices of meetings; keep records of them, and conduct the correspondence of the Branch. She shall send promptly acceptance or rejection of the allotment received from the Supply Department. She shall make reports at the Annual Meeting of the Branch, the Annual Meeting of the Parish, and to the Secretary of the Diocesan Branch.

Section 4. The Treasurer shall receive and disburse all funds except the United Thank Offering. She shall enter the amounts received in her books and pay out money only on the order of the Organization, preserving all vouchers. The books shall be audited annually.



Section 5. The Educational Secretary shall have charge of the study, reading, and general information. She shall attend the Diocesan Annual Course for Study Classes and conduct the Parish Class. She shall plan and conduct program meetings.

Section 6. The United Thank Offering Custodian shall make this offering known to all women of the Parish and distribute the boxes to them. The contents of these shall be presented at a Corporate Communion service semi-annually and immediately remitted to the Diocesan United Thank Offering Treasurer.

Section 7. The officers of the Branch shall meet regularly to confer upon the work of the Branch and plans for its development.

## ARTICLE VI.

### Meetings and Dues.

Section 1. The meetings of the Branch shall be held .....  
(weekly, bi-monthly or monthly).

Section 2. Every baptized woman being automatically an Auxiliary member, shall designate the amount which she will voluntarily contribute to the financial program.

The Treasurer shall remit an annual due of one dollar (\$1.00) for the Branch to the Diocesan Treasurer.

Section 3. The Annual Meeting shall be held the first meeting in January.

## ARTICLE VII.

### Elections.

At the November meeting the President, with the approval of the Rector, shall appoint a Nominating Committee of three (3) members of the Auxiliary who shall report at the December meeting.

The election of officers shall be by a majority ballot at the annual meeting in January.

No officer may hold office longer than two (2) terms of two (2) years each. Vacancies occurring in any office shall be filled by the Executive Committee to serve until the next election.

## ARTICLE VIII.

### Order of Business.

The meetings shall be opened with prayer, which should include the Auxiliary and United Thank Offering prayers.

## SUGGESTIONS.

That this Constitution be read aloud once a year, preferably at the Annual Meeting.

That the literature of the Church Missions House (281 Fourth Avenue, New York) be kept on file by the Educational Secretary.

That the larger Parishes be zoned by the U. T. O. Custodian, with a key-woman as Captain in each zone, thus increasing the scope of the Thank Offering work.
