## MINUTES OF THE ANNUAL MEETING

---

The twenty-third annual meeting of the Woman's Auxiliary to the Board of Missions was opened with a service in the Chapter House of S. John's Cathedral, Tuesday, June 4, 1907, at 10 a. m. The Rev. Mr. Trimmer of Greeley preached the sermon from the text, "Go ye therefore, and teach all nations." Matt. 28:19. The preacher drew a strong contrast between conditions existing in heathen countries before and after the preaching of the Gospel, and drew a vivid picture of the conquest of the world by the power of that Gospel. About one hundred and fifty received the Holy Communion.

After the service the Bishop expressed his thanks for the work done by the Auxiliary during the year. The President expressed a desire that the annual report be printed and bound under separate covers. She also emphasized the necessity of every member paying the annual dues of fifty cents, and also the need of setting aside a specific sum to be given by her to Missionary Bishops at the General Convention. The following nominating committee was appointed: Mrs. Crowe, Mrs. Mills and Mrs. Atwater.

The Secretary of the Junior Auxiliary outlined the methods of junior work. The Secretary of the Babies' Branch read a paper describing the inception of the Babies' Branch or Little Helpers.

Mrs. Burnham spoke of the Spirit of Missions and the Colorado Churchman. The meeting took a recess for luncheon.

At 2 p. m. the meeting was resumed. Prayer was offered by the Rev. Mr. Marshall. The President addressed the Auxiliary. The Minutes of the last annual meeting were read.



The report of the Recording Secretary was received. (See Appendix A.)

The report of the Corresponding Secretary was received. (See Appendix B.)

The report of the Treasurer was received. (See Appendix C.)

The report of the Secretary of the Babies' Branch was received. (See Appendix D.)

The report of the Librarian of the Church Periodical Club was received. (See Appendix E.)

The report of the Secretary of the Altar Department was received. (See Appendix F.)

The report of the Treasurer of the United Offering was received. (See Appendix G.)

Mrs. Spalding thanked the Auxiliary for donations to S. Luke's Hospital. The Girls' Friendly Society reported thirty-one dollars (\$31.00) given for missionary purposes.

Mrs. Ethelbert Ward explained the object of the Church League of the Baptized. The Missionary Associate, Miss Kerr, reported. She also reported that Wolfe Hall had contributed twenty-five dollars (\$25.00) for missions, thirty-one dollars (\$31.00) for S. Luke's Hospital, and twenty-five dollars (\$25.00) for Honolulu.

Roll call was responded to by 104 delegates, representing 24 parishes and missions. Pledges amounting to seven hundred and forty-nine dollars (\$749) were made by parishes, missions and individuals.

It was moved by Mrs. Williams and seconded by Mrs. Ruter, that Article 9 of the Constitution be amended.

Carried.

It was moved by Mrs. Brown and seconded by Mrs. Ward that the annual report be printed under separate cover from the Council Journal.

part of the year, her sister, Miss Carter, was appointed to fill her place during her absence.

A new field of usefulness has been opened to us in the formation of a diocesan branch of the League of the Baptized. At a meeting held in S. Luke's church, Montclair, on April 24, the object of this League was explained, and the President appointed Mrs. Ethelbert Ward to take charge of the work.

In reporting the meetings held during the year, the secretary is limited in her knowledge to those having taken place in Denver. She would suggest that in the future, in order to have a more complete report, some record be sent her of the meetings held and subjects considered by the parish branches outside the city of Denver.

The United Missionary meetings of the year in this city have numbered fifteen, two more than in the preceding year. The average attendance has been fifty-six. The average number of churches represented at these meetings, ten. The subjects chosen for consideration have been thoughtfully and interestingly presented, some by our own members, and some by different members of the clergy. Several times we have been privileged to listen to inspiring addresses from the Bishop of Salt Lake and our own dear Bishop. On May 11, the Rev. Wm. Cabell Brown, of the Brazilian Mission, spoke to the Auxiliary of his work in Brazil.

At one of the meetings a discussion was carried on in regard to the study classes, which are being formed in different parts of the country by the Educational Secretary of the Board of Missions, the Rev. Everett P. Smith. The hope was expressed that classes might be formed in this diocese.

We note with sadness the death of Mrs. C. L. Mercer, for many years identified with S. Peter's church, and a faithful and devoted member of the Auxiliary.

COLORADO BRANCH OF THE WOMAN'S AUXILIARY  
TO THE BOARD OF MISSIONS.  
CONSTITUTION REVISED.

---

## ARTICLE I.

This Association shall be called the Colorado Branch of the Woman's Auxiliary to the Board of Missions.

## ARTICLE II.

Its object shall be to aid the General Missions of the Church, Domestic, Foreign and Diocesan.

## ARTICLE III.

It shall be composed of all women of the Diocese who are interested in missionary work, and who contribute to the Association at least fifty cents annually.

## ARTICLE IV.

Its officers shall consist of a President, five or more Vice-Presidents, Recording Secretary, Corresponding Secretary and a Treasurer.

## ARTICLE V.

Each Parish in the Diocese may be represented in the Association by two delegates, who, with the officers above mentioned, shall constitute the Board of Managers. The President and Secretary of any Ladies' Aid Society may act as delegates, or in parishes where no Ladies' Aid Society exists, the Rector may be asked to appoint the delegates.

## ARTICLE VI.

The President shall call an annual meeting of the Association at the time and place of the meeting of the Annual Convocation, and may call other meetings at her discretion after conference with the other officers.



## ARTICLE VII.

The Vice-Presidents shall assist the President in carrying out the purposes of the Association, one of them presiding at any meeting in her absence or at her request.

## ARTICLE VIII.

The Recording Secretary shall keep the minutes of all meetings and prepare an annual report. The Corresponding Secretary shall send out all notices of meetings as directed by the President, conduct the correspondence of the Association, particularly with the delegates and with the General Secretary of the Auxiliary in New York. The Treasurer shall receive and pay out all contributions, keeping account of the same, and shall prepare an annual report.

## ARTICLE IX.

The Delegates shall do all in their power to increase an interest in Missionary work in their respective parishes, shall obtain as many members as possible for the Association, circulate the Collects and Leaflets of the Woman's Auxiliary, forwarding to the several Treasurers all moneys collected and shall attend the meetings of the Board of Managers and especially the annual meeting of the Association as faithfully as may be in their power.

## ARTICLE X.

This Constitution shall only be amended at an Annual Meeting and by the advice and with the consent of the Bishop.











## Counselors to Parochial Officers

---

Impress upon the women of your parish that they may become by virtue of their baptism members of the auxiliary. Urge them to recognize this claim by working along the appointed lines, and by giving such dues as your Parish Branch may settle upon.

Every Branch is expected to give to the United Offering, Diocesan and General Missions, and report to Diocesan Treasurer, and to do its share of the work as planned by Diocesan Officers.

After this, develop any diocesan or general work that has the approval of your rector, after consulting with Diocesan Officers.

The "*United Offering*" is the Thankoffering presented at every Triennial service of the Woman's Auxiliary. The offering of 1907 will be laid on the Altar at the Triennial Celebration, October, 1907, in Richmond. It will be given for Woman's Work in the Domestic and Foreign Fields. Every woman is given an opportunity to share in the great Thankoffering. The birthday plan for raising the United Offering has been adopted successfully in many Diocesan branches.

Take the "Colorado Churchman" and read to your Branch the Woman's Auxiliary page. Keep ready for reference a Church Almanac with clergy list, the *last report of your Diocesan Branch* Miss Emery's last report and the *Spirit of Missions*; and keep in supply, copies of the Auxiliary prayers, leaflets from the Church Missions House, mite chests for the United Offering, and leaflets for the Junior Auxiliary work.

When a project is laid before your Branch, do not fail to report its action, after due deliberation.

When preparing a Missionary Box, write to Diocesan Corresponding Secretary for name of recipient and information concerning his needs. Report to her when box is sent.

Remit by express, P. O. order, bank drafts or checks, never by bank notes.

Report changes of address, or temporary absence, and do not fail to notify the Corresponding Secretary when changes occur in your list of officers. Apply to the Secretaries of the various departments for further information.

The Annual Meeting is held on the Tuesday preceding the Annual Council held the first week in June.
