**Minutes of the Annual Meeting of the Woman's
Auxiliary of the Diocese of Colorado,
June 2, 1908.**

The twenty-fourth annual meeting of the Woman's Auxiliary to the Board of Missions was opened with a service in the Chapter House of St. John's Cathedral, Denver, Tuesday, June 2nd, 1908, at 10 a. m.

The Rev. William J. Cordick, of Trinidad, preached the sermon from the text, "The Master calleth for thee." St. John 11:28.

He spoke of the universality of the call, the same message in all ages, and of the Woman's Auxiliary helping to spread the Gospel.

About 150 persons received Communion after the service.

The Bishop announced the business meeting of the Woman's Auxiliary, also the services and programs of the Council and the Receptions.

He also spoke of Rev. Mr. Wilkins, of Los Angeles, Secretary of the Society, to raise \$5,000,000 for the "Aged Clergy Relief Fund," who would be here during the Council and make an address at the Missionary meeting, Wednesday evening, June 3d.

He thanked the Auxiliary for all it had done in the past, hoping it would give \$1,000 in money this coming year, if consistent with other work. He told of Miss Emery writing that eleven (11) boxes had been sent into this Diocese, and of the great work of the Woman's Auxiliary in general. He also said a round \$1,000,000 had

been given for Missions, including the "Men's Thank Offering."

He spoke of his contemplated trip to England and explained the "Pan-Anglican Congress of Missions" and the various programs in prospect at the conference.

Mrs. Olmsted took the chair and gave notice to delegates to see Mrs. Mills about entertainment. She wished the Auxiliary reports might be printed under separate covers.

Mrs. Burnham moved that 500 be printed under separate covers. Mrs. Ruter seconded the motion. It was carried.

The President appointed the nominating committee, consisting of Mrs. Charles Cobb, Mrs. Platt Rogers, of Denver, and Mrs. Weeks, of Colorado Springs, and stated that roll-call would occur at 3 o'clock.

She said she wished questions asked and explained about different funds of the Auxiliary, and duties of members of the Woman's Auxiliary, especially General Missions, and stated that the Woman's Auxiliary of Colorado had given during the past year in boxes and money \$2,625.

Mrs. Kate Brown told of the Lectern League and its objects, and invited all to the Annual Reception June 5th, 1908. Mrs. Burnham spoke further on the subject and of her interview with Rev. Everett P. Smith of the Missions House, New York.

Adjournment for luncheon.

At 2 p. m. the meeting was resumed. Prayers were said by Rev. Mr. Holoran.

The minutes of the annual meeting of June 4th, 1907, were read.

Rev. Dr. Mills spoke for the Colorado Churchman, the Bishop's paper, telling of its contents, with news of Woman's Auxiliary meeting, etc. He said there was no Episcopal family but what could afford and ought to take the Colorado Churchman.

He also spoke of some books to be sold to help a clergyman's family. This clergyman could never get well and the books were there at the Chapter House.

He desired that return certificates of delegates be handed to him, that he might see to their being signed; should there be 50, the railroad rate might be effective.

The Acting Secretary's report was read and accepted.

The report of Corresponding Secretary was received.

Miss Clinton asked that the names of President and Officers of the different branches outside of Denver be sent her.

The report of Treasurer was received.

The report of Mrs. Frank A. Ellis, Assistant Treasurer of General Missions, was given. She explained the apportionment plan and how to raise it.

The report of Junior Auxiliary was received.

The report of Babies' Branch was received.

The report of Secretary of Church Periodical Club was received.

The report of Director of Altar Department was received.

The report of Treasurer of United Offering was received.

Roll call was responded to by 150 delegates, representing 23 Parishes and Missions.

Pledges amounting to seven hundred and fifteen and one-half dollars (\$715.50) were made by parishes, missions and individuals.

The hearing of reports was then resumed.

The Associate Missionary, Miss Kerr, reported and gave an account of the missionary work of Wolfe Hall students.

Mrs. M. B. Wheaton made a lengthy and very interesting report of St. Luke's Hospital, its management and equipment among the best in the West with a capacity of 140 beds.

The report of the Girls' Friendly Society was read. All of the foregoing reports were accepted.

Mrs. Burnham spoke of the expected absence of the President during the early autumn, and hoped for the same loyal support of the members as in the past. A safe and restful journey with best wishes of all were extended.

She also spoke of the "Spirit of Missions," as being world wide in its information, and that we do not appreciate our advantages in this civilized and so-called Christian country.

After the reading of the minutes and their approval the meeting adjourned.

**Report of Acting Secretary at Annual Meeting of Woman's
Auxiliary, June 2, 1908.**

In giving the report for the Recording Secretary, the Acting Secretary can speak of the seeming increase of attendance and manifest interest in all branches, yet the average attendance will, perhaps, not be as great, owing to the larger number of meetings, some of which were held in the suburban parishes, where members have not been regular attendants at the other meetings.

In attending the meetings at Golden, Arvada and Littleton, the pleasure, enthusiasm, and great interest displayed, by the members there and those going, were very beneficial. It is hoped that these outside branches may be better represented at the meetings another year.

New branches have been formed at Ft. Collins, St. Barnabas' and the Cathedral, Denver.

The Recording Secretary, owing to illness, has been able to attend only the first ten meetings, and her place has been filled, to the best of her ability, by the Acting Secretary.

The Corresponding Secretary, Mrs. J. F. Barber, owing to poor health, was obliged to resign, and her place since has been most ably filled by Miss Carrie Clinton.

I would say, as your Recording Secretary did in her last report, that there is not much for her to tell about the actual work of the Auxiliary or the results of the labor of the different branches, and their Secretaries will give reports.

It is to be regretted that Mrs. Kramer's suggestion, "that some record be sent her, of the meetings held and the subjects considered by the parish branches outside the city of Denver," has not been complied with. As it would not limit her knowledge to the meetings held in Denver and the suburbs, the Acting Secretary would second her suggestion for the coming year.

The average attendance has been 54. There have been 17 meetings, being 2 more than last year. The average number of churches and missions represented at these meetings has been 11.

The subjects on the programs for the different meetings have been fulfilled, by papers from members and discussions by different clergymen.

The Bishop has addressed us on several occasions.

At the meeting at St. Luke's, Montclair, April 7th, Miss Ware of Sioux City, Iowa, made a most interesting address, and at the meeting at St. James Mission, Berkeley, May 6th, an Indian clergyman, Rev. Sherman Coolidge, made an address on his work among the Shoshone Indians.

It has been a great deprivation not to have had our dear, beloved Mrs. Kramer with us, and see her face and enjoy her efficient services the past few months.

Report of the Junior Department of the Woman's Auxiliary to the Board of Missions,

FOR THE YEAR ENDING APRIL 30, 1908.

The Secretary has written sixty-six (66) letters and postals and sent out one hundred and fifteen (115) cards and pamphlets. Twelve (12) branches of the J. A. are on the books and work has been reported from ten (10) of them. Five of these branches have a regular organization, the other seven are branches that comprise the members of the Sunday School.

The General Secretary desired that the Juniors of Colorado give \$50 towards General Missions and make special offerings for the work in China, but it has not been possible to concentrate the work in this way. The various branches have chosen special objects according to the chief interest in their parishes. Consequently the offering for General Missions is but \$22.14. However, we trust this full amount may be given before September as another offering will be made at St. Barnabas' on Whitsunday, and the Juniors of St. Mark's having effected a thorough organization, will make an offering during the summer. Several branches are faithfully studying

the Missions field and using the prayers of the Order, as well as giving in large proportion to their resources. There is encouragement in the fact that the offerings for the year for a variety of objects exceed last year's by \$23.44.

We trust the next year may show an increase in the number of branches and more concerted action in meeting the requests of the General Secretary, Miss Emery. The financial report for the year is as follows:

The department has on hand at this time one Green Altar Frontal, donated by Calvary Church, Golden.

**Colorado Branch of the Woman's Auxiliary to the
Board of Missions.**

Constitution Revised.

ARTICLE I.

This Association shall be called the Colorado Branch of the Woman's Auxiliary to the Board of Missions.

ARTICLE II.

Its object shall be to aid the General Missions of the Church, Domestic, Foreign and Diocesan.

ARTICLE III.

It shall be composed of all women of the Diocese who are interested in missionary work, and who contribute to the Association at least fifty cents annually.

ARTICLE IV.

Its officers shall consist of a President, five or more Vice-Presidents, Recording Secretary, Corresponding Secretary and a Treasurer.

ARTICLE V.

Each Parish in the Diocese may be represented in the Association by two delegates, who, with the officers above mentioned, shall constitute the Board of Managers. The President and Secretary of any Ladies' Aid Society may act as delegates, or in parishes where no Ladies' Aid Society exists, the Rector may be asked to appoint the delegates.

ARTICLE VI.

The President shall call an annual meeting of the Association at the time and place of the meeting of the

Annual Convocation, and may call other meetings at her discretion after conference with the other officers.

ARTICLE VII.

The Vice-Presidents shall assist the President in carrying out the purposes of the Association, one of them presiding at any meeting in her absence or at her request.

ARTICLE VIII.

The Recording Secretary shall keep the minutes of all meetings and prepare an annual report. The Corresponding Secretary shall send out all notices of meetings as directed by the President, conduct the correspondence of the Association, particularly with the delegates and with the General Secretary of the Auxiliary in New York. The Treasurer shall receive and pay out all contributions, keeping account of the same, and shall prepare an annual report.

ARTICLE IX.

The Delegates shall do all in their power to increase an interest in Missionary work in their respective parishes, shall obtain as many members as possible for the Association, circulate the Collects and Leaflets of the Woman's Auxiliary, forwarding to the several Treasurers all monies collected and shall attend the meetings of the Board of Managers and especially the annual meeting of the Association as faithfully as may be in their power.

ARTICLE X.

This Constitution shall only be amended at an Annual Meeting and by the advice and with the consent of the Bishop.

Counsels to Parochial Officers

Impress upon the women of your Parish that they may become by virtue of their baptism, members of the Auxiliary. Urge them to recognize this claim by working along the appointed lines, and by giving such dues as your Parish Branch may settle upon.

Every Branch is expected to give to the United Offering, Diocesan and General Missions, and report to Diocesan Treasurer, and to do its share of the work as planned by Diocesan Officers.

After this, develop any Diocesan or general work that has the approval of your Rector, after consulting with Diocesan Officers.

The "*United Offering*" is the Thankoffering presented at every Triennial service of the Woman's Auxiliary. It will be given for Woman's Work in the Domestic and Foreign Fields. Every woman is given an opportunity to share in the great Thankoffering. The birthday plan for raising the United Offering has been adopted successfully in many Diocesan Branches.

Take "The Colorado Churchman" and read to your Branch the Woman's Auxiliary page. Keep ready for reference a Church Almanac with Clergy list, the *last report of your Diocesan Branch* Miss Emery's last report and the *Spirit of Missions*; and keep in supply copies of the Auxiliary prayers, leaflets from the Church Missions House, mite chests for the United Offering, and leaflets for the Junior Auxiliary work.

When a project is laid before your Branch, do not fail to report its action, after due deliberation.

When preparing a Missionary Box, write to Diocesan Corresponding Secretary for name of recipient and information concerning his needs. Report to her when box is sent.

Remit by express, P. O. order, bank drafts or checks; never by bank notes.

Report changes of address, or temporary absence, and do not fail to notify the Corresponding Secretary when changes occur in your list of officers. Apply to the Secretaries of the various departments for further information.

The Annual Meeting is held on the Tuesday preceeding the Annual Council held the first week in June.
