Woman's Auxiliary

Minutes Twenty-Sixth Annual Meeting of the Colorado
Branch Woman's Auxiliary, Held in the Chapter
House May 31, 1910

The Holy Communion was celebrated at 10 a. m., by the Rt. Rev. Charles S. Olmsted, Bishop of Colorado, assisted by the Rev. W. W. Williams. The gospel was read by the Rev. Frank Hale Touret. Hymns, "The Morning Light Is Breaking," "From Greenland's Icy Mountains," and "Jesus, Lover of My Soul," were sung. The Bishop Spalding Memorial Communion Set was used. The Rev. Frank Hale Touret, of Fort Collins, preached a most inspiring and helpful sermon from 2 Cor. XI, 29, "Who Is Weak and I Am Not Weak." One hundred and fifteen communicants attended this opening service.

The offertory, which was \$21.63, will be devoted to the work of the Auxiliary. Immediately after the service the business session was called to order, the President, Mrs. C. S. Olmsted, presiding.

Miss Emery's Annual Letter was read.

The reports of the following Officers were submitted: Recording and Corresponding Secretaries, Treasurer, Assistant Treasurer General Missions, Secretaries of Junior Auxiliary and Babies' Branch, Acting Treasurer of United Offering, Librarian Church Periodical Club, Director Altar Department, and Missionary Associate.

A report of the Girls' Friendly Society was also read by Mrs. Claire Foster.

On motion of Mrs. Ethelbert Ward, seconded by Mrs. Wolfe, these reports were accepted.

Adjournment for luncheon.

Precisely at 2 p. m. the afternoon session was opened with prayer and an earnest and helpful address by Bishop Olmsted, who pointed out that the total amount of work done by the Auxiliary was in some respects not up to the average of three years ago.

Roll call was responded to by 159 (including 2 visitors), representing 27 parishes. Pledges for Diocesan Missions were taken.

The report of the Committee on "Revision of the Constitution" was read by the Corresponding Secretary in the absence of the Chairman and members of the committee. After some discussion, it was moved by Mrs. F. W. Oakes, seconded by Mrs. F. H. Touret of Fort Collins, that the Revised Constitution be substituted for the old Constitution. Carried.

The report of the Purchasing Committee for the "Bishop Spalding Memorial" was read by Mrs. Wolfe, in the absence of the Chairman. Immediately following the reading of this report, the Rev. C. I. Mills, on behalf of the Vestry and Congregation of Ascension Memorial Church, made a fitting acknowledgement of the exquisite Silver Communion Set, the gift of the Colorado Branch of the Woman's Auxiliary to Ascension Memorial Church. He said no more fitting memorial could have been given of the late Bishop Spalding, who had freely given his life for the extension of the Church in Colorado.

Mr. Mills said the Communion Set had been used at the morning celebration and was still in the Chapter House, so that the members of the Auxiliary might have an opportunity of seeing it.

The President extended hearty thanks for herself and the Auxiliary as a whole to the members of both Special Committees for their most acceptable work.

It was moved by Mrs. Wolfe, seconded by Mrs. Evans of Fort Collins, that "the sermon preached this morning

by the Rev. F. H. Touret be printed and copies distributed among the members of the Auxiliary." Carried.

The Secretary read a set of resolutions sent out by the officers of the Connecticut Branch, regarding delegates to the Triennial Meeting. On motion of Mrs. Kramer, these resolutions were endorsed.

The election of officers was next in order.

Announcements were made of the Wolfe Hall graduating exercises to be held in the Chapter House, Tuesday evening at 8 o'clock, followed by a reception at Wolfe Hall; of the Missionary Meeting on Wednesday evening, and of the reception to be given by Bishop and Mrs. Olmsted at Wolfe Hall on Thursday evening, from 8 till 10 o'clock.

Mrs. Hoffman spoke of the Summer School of Missions to be held at Boulder.

Mrs. N. G. Burnham spoke of the work of the Lectern League and invited the delegates to the annual reception on Friday afternoon, June 3rd, at the Y. W. C. A.

She also announced an automobile trip about the city had been arranged for the visiting delegates at the close of the afternoon session.

A discussion of "Methods of Work" by visiting delegates followed.

Mrs. Marburg of St. Stephen's Church, Colorado

Springs, told of all that had been accomplished in that parish, including the good work done by a visiting nurse.

Mrs. Carman, Canon City, described the organization of a branch of the Woman's Auxiliary.

Mrs. Clement, Fort Morgan, spoke of Auxiliary work.

Mrs. Curtis, West Plum Creek, gave an interesting account of Auxiliary meetings and the faithfulness of the members.

Mrs. Fenton, Boulder, told how the Branch was formed there.

Mrs. Bonnell, of Greeley, advocated interesting Juniors in collecting boxes belonging to the Babies' Branch.

Mrs. Rogers, Holy Trinity, Pueblo, spoke of the W. A. Branch lately organized in that parish.

Mrs. Evans, Fort Collins, described the devoted work accomplished and the money raised by the self-sacrifice of some of the members.

Mrs. F. H. Touret, of Fort Collins, gave a most inspiring talk on Missions, suggesting that the greater part of the time at the annual meeting be devoted to addresses from missionaries, in order that the delegates might be stimulated to fresh zeal and more definite work.

Mrs. N. G. Burnham followed, speaking of the Colorado Churchman which always gives the missionary news of the Diocese.

Mrs. Wolfe announced she had subscription blanks for the Spirit of Missions.

The President, Mrs. Olmsted, said notices of meetings would be sent to out-of-town branches, and that she hoped some Missionary Bishops might address the Auxiliary during the coming year.

It was moved by Mrs. Rubidge, seconded by Miss Clinton, that the Auxiliary reports for 1909-10 and program for 1910-11 be printed. Carried.

Moved by Mrs. Touret of Fort Collins, seconded by

Mrs. Hoffman, that "before the Triennial every Colorado branch of the Woman's Auxiliary be asked to make a special pledge to be put in the hands of a special committee to use at the General Convention." Carried.

Personal pledges for Diocesan Missions were taken.

With the reading and approval of the minutes the meeting adjourned.

REPORT OF THE RECORDING SECRETARY.

In making my report as Recording Secretary it is a great pleasure to record an increase in the number of Branches and a constantly growing interest throughout the Diocese in the work of the Auxiliary.

During the past year four new Branches have been organized, viz.: at Trinity Memorial, Denver; Holy Trinity, Pueblo; Christ Church, Canon City; St. John's, Boulder.

There are ten Branches of the Junior Auxiliary and thirteen of the Babies' Branch.

Of the sixty-four Parishes and organized Missions in the Diocese, ten have sent missionary boxes; thirty have made pledges for Diocesan Missions; twenty-three have paid the Woman's Auxiliary apportionment for General Missions, and thirty have contributed to the United Offering.

From September 14, 1909, to May 24, 1910, inclusive, there have been seventeen United Missionary meetings, one being held in each of the Denver churches and at Calvary, Golden; St. Matthew's, Arvada; St. Luke's, Montclair, and St. Paul's, Littleton. Mrs. Frank L. Bishop, the First Vice-President, presided at the first two, in the absence of the President, Mrs. Olmsted. The average attendance at these meetings was fifty-four, the average number of churches represented, ten. Thirty-five visitors have been present at different times during the year.

The largest attendance at any one meeting was 81, the smallest number at any one meeting, 15.

The program which was kindly suggested by Bishop Olmsted proved unusually interesting and was most efficiently car-

ried out. Most able papers were prepared and read on the subjects assigned, which were:

- Instruction in Auxiliary Work.
- Christ's Mission to the World.
- Work of Christ's Apostles.
- Persecution of Missionaries.
- Missions of the Greek Church.
- Roman Propaganda.
- Moravian Missions.
- Obstacles to Missionary Work in the Field.
- Obstacles to Missionary Work at Home.
- Great Women Missionaries.
- Bishop Heber.
- Missionary Spirit in American Colleges.
- Bishop Berkeley.
- Missions of Valle Cruces.
- Junipero Serro.
- Early Jesuit Missions in America.

Bishop Olmsted has also addressed the Auxiliary at five different times, and Archdeacon Schofield has awakened new interest in the Missions of the Diocese by vivid and graphic descriptions of his work.

A special meeting was called on Tuesday, June 8, when the minutes of the twenty-fifth annual meeting were read and approved. Three other special meetings of the Auxiliary officers were called by the President during the year.

An attempt has been made to ascertain the number of Parish Branches taking up mission study of any kind. A full report was not obtained, however. St. John's Cathedral, St. Stephen's, St. Barnabas', Denver, and St. Luke's, Fort Collins, and Trinity, Trinidad, report mission study and program missionary meetings. St. Mark's, Denver, held a most successful Lenten lecture course. Trinity Memorial, Denver, and St. Paul's, Fort Morgan, report addresses and readings on Missionary topics, while St. Stephen's, Colorado Springs, in connection with the four neighboring Parishes, has held Missionary teas, when a paper on some part of the mission field was given.

A Quiet Day for the Auxiliary was held at Wolfe Hall on Saturday, February 26, the meditations given by Bishop Olmsted were wonderfully inspiring and helpful.

A beautiful silver Communion Set known as the "Bishop Spalding Memorial," has been purchased by the committee ap-

pointed for that purpose, and presented on behalf of the Auxiliary to Ascension Memorial Church, where it was used for the first time on Easter Day.

At the United Meeting held at Trinity Church, a motion was made by Mrs. Frank Bishop to the effect that the United Meetings should be held only once in each month, taking the churches alphabetically, and that the offerings be put in the hands of the Auxiliary Treasurer.

After a thorough discussion the motion was carried and will be put in force next year. Mrs. Peeps, the faithful Treasurer of the United Offering, resigned in April. Her place has been ably filled by Mrs. Wolfe.

As was the case last year, programs of the United Meetings will be printed and sent to each Parish in the Diocese, with the earnest hope that any member of the Auxiliary who may be in Denver at the time of a meeting will make a special effort to be present.

With the increase of missionary knowledge comes a realization of the tremendous importance of missionary work, and surely each member of the Auxiliary will do her part in sending the glorious light of Christ's Gospel to those who still are in darkness and the shadow of death.

REPORT OF THE JUNIOR DEPARTMENT OF THE WOMAN'S AUXILIARY TO THE BOARD OF MISSIONS FOR THE YEAR ENDING APRIL 30, 1910.

The Secretary has received financial reports from ten branches and from time to time has learned of the study work

done by them, which shows a healthy condition in the few branches that exist. She regrets that it has not been possible to do more aggressive work in increasing the number, Trinity Church, Greeley, being the only new branch.

The General Secretary asked that effort be made to educate the Juniors in the practicability of making their offerings for General Missions, and at the same time studying the entire field. The wisdom of this is apparent, as the amount given for General Missions is \$108.57, when the apportionment was only \$50.00.

It is desired that the Branches send samples of handiwork to the Junior Exhibit at the General Convention, and I trust you will assist my successor in making a creditable display.

**RESOLUTIONS PASSED AT THE MEETING OF THE BOARD
OF MANAGERS OF THE CONNECTICUT BRANCH
OF THE WOMAN'S AUXILIARY, MAY 3, 1910.**

Resolved, That the representatives and alternates for the Triennial of the Woman's Auxiliary be appointed by their Bishop, or elected by their Diocesan Auxiliary Officers, and shall not exceed five (5) in number.

Resolved, That representatives at the Triennial Meeting shall be active members of the Woman's Auxiliary in their own Diocese or Missionary District.

Resolved, That the names of the representatives with their alternates be sent to the General Secretary at least one month before the Triennial Meeting, otherwise they will not be recognized as delegates.

Resolved, That the seats for the delegation shall be assigned by lot and shall be retained during the Session.

Resolved, That the President of the Diocesan Branch where the Triennial is held, be Honorary President of the Meetings, and in addition, that the General Secretary at each Triennial, appoint a Committee to nominate another Auxiliary Officer as Chairman who shall preside at the business meetings.

Resolved, That these Resolutions be sent to the other Branches of the Woman's Auxiliary.

**CONSTITUTION ADOPTED AT THE ANNUAL MEETING
MAY 31, 1910.**

ARTICLE 1. NAME.

This Association shall be called the Colorado Branch of the Woman's Auxiliary to the Board of Missions.

ARTICLE 2. OBJECT.

The object of this Association shall be to aid and supplement the work of the Board of Missions by awakening Missionary zeal among the Churchwomen of the Diocese, diffusing missionary intelligence, raising money for missionary objects, encouraging the formation of Parochial Branches throughout the Diocese, and by daily prayer for Missions.

ARTICLE 3. MEMBERSHIP.

All baptized women and children of the Diocese are considered members of this Association. Members of the Junior

Branches may be boys or girls. All infants up to the age of seven years may be enrolled in the Babies' Branch.

ARTICLE 4. OFFICERS.

The officers of this Association shall be a President, five or more Vice Presidents, Recording Secretary, Corresponding Secretary, Treasurer, Assistant Treasurer, who shall also be Treasurer for General Missions; Treasurer of the United Offering, Director of the Junior Auxiliary, Director of the Babies' Branch, Director of the Altar Department and Missionary Associate.

Vacancies shall be filled by the Board of Managers.

ARTICLE 5. ELECTIONS AND APPOINTMENTS.

The President, the Vice President, the Recording Secretary, the Corresponding Secretary, the Treasurer and the Assistant Treasurer shall be elected by the body at the Annual Meeting. The Treasurers of the United Offering, the Director of the Junior Auxiliary, the Director of the Babies' Branch, the Director of the Altar Department and the Missionary Associate shall be appointed by the President.

ARTICLE 6. BOARD OF MANAGERS.

The Officers of the Auxiliary with two delegates from each Parish and Mission in the Diocese shall constitute the Board of Managers, seven members to form a quorum.

The Delegates shall be appointed by the President of the Parish Auxiliary or the Rector.

Where no Branch of the Auxiliary has yet been organized, the President of the Women's Guild may with the Rector select the Delegates.

ARTICLE 7. ALTAR DEPARTMENT.

The object of the Altar Department is to assist in supplying chancel furnishings to Churches and Missions in need of such articles. To create a fund for this purpose, every Altar Guild in the Diocese is asked to contribute one dollar yearly.

ARTICLE 8. AUDITING COMMITTEE.

An Auditing Committee of two persons to be appointed by the President shall examine the accounts and vouchers of the Diocesan Treasurers and report the result at the annual meeting.

ARTICLE 9. MEETINGS.

During Council Week the regular, annual meeting with election of officers shall be held, preferably at the same place as the Council. There shall be eight regular meetings between the

months of September and June. Special meetings may be called at any time by the President, and at these meetings only such business shall be transacted as is specified in the call.

ARTICLE 10. DUTIES OF OFFICERS.

The President shall preside at the Annual Meeting, at all regular and special meetings, and at the meeting of the Board of Managers.

The Vice Presidents shall assist the President in carrying out the purposes of the Association, one of them presiding at any meeting in her absence or at her request.

The Recording Secretary shall keep the minutes of all meetings and prepare an annual report.

The Corresponding Secretary shall, at the direction of the President, send out all notices of meetings and shall conduct the correspondence of the Association, particularly with the delegates and with the General Secretary of the Auxiliary in New York.

The Treasurer shall collect all assessments, receive pledges and contributions, take charge of the offerings at Auxiliary Meetings, and at the direction of the Board of Managers pay out all moneys, keeping account of same, and presenting a report at monthly and annual meetings.

The Assistant Treasurer shall assist the Treasurer at any time, but shall especially undertake the raising of money for General Missions.

The Treasurer of the United Thank Offering shall receive and forward to the General Treasurer of that fund all United Offering moneys and shall work for increased contributions.

The Director of the Junior Auxiliary shall endeavor to have Junior Auxiliary Branches formed in all Parishes and Missions, and shall make an annual report of all work done by these Branches.

The Director of the Babies' Branch shall promote systematic giving to Missions among little children, and make a report of her collections at the annual meeting.

The Secretary of the Altar Department shall collect the yearly dues from Altar Guilds, take charge of all contributions of altar furnishings, and at the direction of the Auxiliary respond to all requests.

The Missionary Associate shall assist the President in organizing Auxiliary Branches throughout the Diocese.

ARTICLE 11. DUTIES OF DELEGATES.

The Delegates shall do all in their power to increase the interest in Missionary work in their respective Parishes, shall endeavor to add to the active membership of the Association, circulate the collects and leaflets of the Woman's Auxiliary, see that all moneys collected are forwarded to the several treasurers, and when possible attend the meetings of the Board of Managers and the Annual Meeting of the Association.

ARTICLE 12. PLEDGES.

At the Annual Meeting, parish and personal pledges shall be made to enable the Auxiliary to meet its obligations for Diocesan and General Missions.

ARTICLE 13. ASSESSMENTS.

Each Parish and Mission in the Diocese shall be asked to contribute annually towards the current expenses of the Auxiliary a sum apportioned in accordance with the number of its communicants, those having one hundred communicants or less, to pay one dollar, those having over one hundred and less than three hundred, two dollars, all over three hundred and less than five hundred, three dollars, and those having over five hundred, four dollars.

ARTICLE 14. AMENDMENTS.

This Constitution may, with the approval of the Bishop, be amended by a two-thirds vote of the members present at the Annual Meeting, at least one month's notice of the proposed amendment having been given to each Parish and Mission in the Diocese.

Counsels to Parochial Officers

Impress upon the women of your Parish that they may become, by virtue of their baptism, members of the Auxiliary. Urge them to recognize this claim by working along the appointed lines, and by giving such dues as your Parish Branch may settle upon.

Every Branch is expected to give to the United Offering, Diocesan and General Missions, and report to Diocesan Treasurer, and to do its share of the work as planned by Diocesan Officers.

After this, develop any Diocesan or general work that has the approval of your Rector, after consulting with Diocesan Officers.

The "*United Offering*" is the Thank-offering presented at every Triennial service of the Woman's Auxiliary. It will be given for Woman's Work in the Domestic and Foreign Fields. Every woman is given an opportunity to share in the great Thank-offering. The birthday plan for raising the United Offering has been adopted successfully in many Diocesan Branches.

Take "The Colorado Churchman" and read to your Branch the Woman's Auxiliary page. Keep ready for reference a Church Almanac with Clergy list, the *last report of your Diocesan Branch*, Miss Emery's last report and the *Spirit of Missions*; and keep in supply copies of the Auxiliary prayers, leaflets from the Church Missions House, mite chests for the United Offering, and leaflets for the Junior Auxiliary work.

When a project is laid before your Branch, do not fail to report its action, after due deliberation.

When preparing a Missionary Box, write to Diocesan Corresponding Secretary for name of recipient and information concerning his needs. Report to her when box is sent.

Remit by express, P. O. order, bank drafts or checks; never by bank notes.

Report changes of address, or temporary absence, and do not fail to notify the Corresponding Secretary when changes occur in your list of officers. Apply to the Secretaries of the various departments for further information.

The Annual Meeting is held on the Tuesday preceding the Annual Council held the first week in June.
