REPORT OF ANNUAL MEETING.

The twenty-seventh annual meeting of the Colorado Branch of the Woman's Auxiliary took place in the Chapter House of St. John's Cathedral on Tuesday morning, June 6th, beginning with the celebration of the Holy Communion by Bishop Olmsted, assisted by Dean Hart and the Rev. R. Langford, of Cripple Creek. The service began with Hymn 135. Owing to the illness of the Rev. Thomas Costello Johnson, of Boulder, who was the appointed preacher for the day, the usual auxiliary service was omitted. One hundred and fifty communicants were present at this service, and the offering (which will be used for work of the auxiliary), was \$11.15.

After the service Bishop Olmsted spoke briefly to the delegates and members, expressing his pleasure that such a large number were present and his appreciation of the work done during the past year.

The President, Mrs. C. S. Olmsted, took the chair, and gave her annual address of welcome to the delegates and members. Miss Emery, the general W. A. Secretary of the Board of Missions, New York, sent a letter of greeting, which was read by Miss Clinton. This year the annual reports of the Diocesan officers were printed and distributed instead of being read. The reading of lengthy reports had in years past consumed so much valuable time that it was determined to try this new plan. The members were each given a printed report, which they read at their leisure during the luncheon hour, and acted upon them at the end of the afternoon session. This plan seemed to meet with general approval.

Announcement was made of a meeting of the Sixth Missionary Department, to be held at Duluth on September 1st, 2nd and 3rd. The President hoped to go herself and appointed Miss Kerr as one delegate. Others to be named later.

About half an hour was pleasantly and profitably spent in a helpful discussion of the work of the Junior Auxiliary, by Miss Robinson, of Epiphany; Mrs. Rockafellow, of Canon City; Mrs. F. A. Ellis, of St. Barnabas'; Miss Clinton, of St. Mark's; Miss Kerr, of Wolfe Hall, and Mrs. Alfred Barnes Bell, the Diocesan Secretary of Colorado Juniors. The principal points brought out were: the prime importance of organizing these Junior branches in every parish and mission of the Diocese; the necessity of arousing the children's interest by work; study of the mission field (especially in work done for children like themselves); systematic giving and prayer.

There were two resignations—Mrs. F. A. Ellis, Treasurer of General Missions, whose place is filled by Miss Gertrude King, and Mrs. G. A. Schofield, librarian of the Church Periodical Club, whose successor has not yet been appointed.

The Auxiliary accepted with regret these resignations. Many thanks are due these officers, who, by their patient and faithful work, have laid substantial foundations in their different departments.

Our second Vice-President, Mrs. J. T. Humphrey, of Grace Church, Colorado Springs, has been removed by death since the last annual meeting. Mrs. Elizabeth Cass Goddard, of St. Stephen's, Colorado Springs, was elected to the vacant office. Mrs. Rockafellow, of Canon City, is fifth Vice-President. With these exceptions, the list of officers remain unchanged and will be found in another part of *The Colorado Churchman*. Luncheon was served in the crypt by the following Churches: St. Mark's, St. Peter's, Ascension Memorial, St. Luke's, Montclair; Calvary, Golden, and St. Thomas', Park Hill.

The afternoon session was held in the study hall of Wolfe Hall, and was opened with the singing of the hymn, "Christ For the World We Sing."

Archdeacon Schofield gave an earnest address on his work in the Diocese. He mentioned a number of gifts received during the year, among others, a communion service with the requisite altar linen from the Fort Collins Branch of the W. A.; also altar linen from St. Stephen's, Colorado Springs.

A most pleasing feature of the afternoon was the five-minute addresses given by Auxiliary members, the limited time being the only drawback. The afternoon was not long enough for all the interesting and helpful suggestions, the last speakers cutting their remarks to the shortest possible length, and in one or two cases, omitting the talk altogether. Mrs. Perkins, of Vineland, New Jersey, brought the greetings of the New Jersey Auxiliary to the younger Auxiliary in Colorado.

Mrs. B. W. Bonell brought out the point that it is only the Church that has a true missionary spirit that

prosper in its parish life. Without that missionary spirit, a parish stagnates and dies.

For the first time pledges for General Missions were taken according to Article 12 of our constitution, which reads:

"Article 12. Pledges. At the annual meeting, parish and personal pledges shall be made to enable the Society to meet its obligations for Diocesan and General Missions."

A special committee, appointed February 5, 1908, has fixed the minimum amount for each parish at one-third of the amount pledged by that parish for Diocesan Missions. There seemed to be some slight misunderstanding of this pledge, some of the delegates thinking one-third of their Diocesan pledge was to be used for General Missions, whereas, if a parish gives \$30.00 for Diocesan Missions, it is asked to give at least \$10.00 for General Missions, making a total of \$40.00 (forty dollars). The day was saddened by the news of the death of one of our faithful members, Mrs. Gibbs, of St. James', Berkeley, whose hospitality had been extended to the Auxiliary at the April meeting. There was no business of any importance to be transacted.

With the singing of "Blest Be the Tie That Binds," one of the most helpful meetings in the annals of the Auxiliary came to a close. Mrs. C. F. Hendrie, of 741 Washington Street, most kindly gave a delightful reception for the Auxiliary from 4:30 to 6. A large number of delegates and members were present. Those who assisted were Mrs. C. S. Olmsted, the Misses Hendrie, the Misses Hart, Mrs. Kate Brown, Mrs. N. O. Vosburgh, Jr., Miss Ruth Olmsted, and Miss Gertrude King.

At 8 o'clock Tuesday evening a missionary meeting was held at St. Mark's Church, which was fairly well attended. It opened with the singing of "Onward, Christian Soldiers!" A number of the city Clergy, with their vested choirs, took part in the procession, as did Bishop Brewster, of Western Colorado, and our own Bishop; Bishop Olmsted took the short service. Bishop Brewster,

of Western Colorado, was the first speaker. He told in a most interesting way of missionary work in his own Diocese, and of the difficulties encountered, owing to the large area and scattered population.

The Rev. C. H. Remington, of Mexico, spoke of the Church in that republic; of the revolution which has lately been convulsing the country, and went on to prove that our own Church has a peculiar fitness for ministering to the native Mexican.

R. C. C. Rollit, of the Sixth Missionary Department, who was expected to speak, was unable to be present.

Mr. John Wood, corresponding secretary of the Board of Missions, gave a most inspiring and helpful address. He brought greeting from Miss Emery, the Woman's Auxiliary Secretary of the Board of Missions, and a word of encouragement with the hope that the good work of the past is but a pledge of the better work in the future. He also brought greetings from the Board of Missions to this branch of its Auxiliary. He spoke of the status of woman in non-Christian lands, proving conclusively that to Christianity woman owes all that makes life worth living, and said that it was the duty and privilege of every Christian woman to extend to her less fortunate sisters the blessings which had come to her through the light of the gospel. He asked for workers and hoped that perhaps some of the younger members of the Auxiliary might be moved to offer themselves as laborers in the mission field to go to those women to whom only women can minister and whom only Christian women can free from inherited prejudice and darkness and give to them their rightful heritage—the glorious womanhood of the Christian countries. He referred to Miss Ridgeway's self-sacrificing work in Africa, and spoke feelingly of the severe loss to the Board in the death of Miss Farthing in Alaska, concluding with an appeal to the women of the Auxiliary to do their utmost to help in the work of God, by constant work, by gifts and by unceasing prayer.

TWENTY-SEVENTH ANNUAL REPORT OF RECORDING
SECRETARY.

In accordance with the resolution passed in February, 1910, the United Missionary Meetings have been held only once in each month, from October to May, inclusive, and the offering given has been put in the hands of the W. A. Diocesan Treasurer, one-tenth to be devoted to General Missions. At the December meeting it was decided to change the date of the United Meetings from the first Tuesday in each month to the fourth.

The President, Mrs. C. S. Olmsted, presided at six meetings; the First Vice-President, Mrs. Frank Bishop, at one, and the Recording Secretary at one. One new branch organized at St. Peter's, Denver.

Bishop Olmsted most kindly suggested a very interesting program, which was intelligently carried out, and proved both helpful and instructive.

All Saints', Denver—"The Prayer Book as a Missionary," by Rev. J. W. Ohl.

Ascension Memorial, Denver—"The Physician in the Mission Field," Dr. Palmer.

Calvary, Golden—"Pensioning of Aged Clergy," Rev. C. M. Pullen.

Emanuel, Denver—"Bishop Pattison and His Work," Mrs. Whitmore.

Epiphany, Denver—"Bishop Hannington," Miss Treherne.

St. Barnabas, Denver—Junior Work discussed by Miss Kerr, Miss Clinton, and Mrs. F. A. Ellis. Also a Missionary play, "The Bishop's Pocket Book," by the Epiphany Juniors.

St. James', Berkeley—"Work in Africa," Mrs. Thurman.

St. John's Cathedral—"Resumé of Year's Work," Mrs. E. LeN. Foster; "Missionary Work," Rev. Mr. Remington, of Mexico.

Largest number present at any one meeting, 94.

Smallest number present at any one meeting, 35.

Average attendance, 58.

Seven visitors have been with us at different times during the year.

There have been two Special Meetings of Diocesan Officers. Also a meeting at Wolfe Hall on February 21, when Deaconess Goodwin of New York gave an inspiring address. A reception

followed, when those present were given an opportunity of meeting the Deaconess.

The Auxiliary is grateful to the Rev. C. H. Marshall for his kind interest which prompted him to set apart "Auxiliary Day" at both of the meetings of the Northern Deanery. At the first of these meetings, held in St. Stephen's Church, Denver, Rev. F. F. Kramer, Rev. H. S. Foster, and Rev. T. H. Schofield gave their impressions of the General Convention. Mrs. E. LeNeve Foster spoke of the Auxiliary gathering held at the same time.

At the second meeting, which took place at St. John's Church, Boulder, February 23, the Auxiliary had again the pleasure of listening to Deaconess Goodwin. Short addresses were also given by Miss Kerr, Miss Campbell, Mrs. H. F. Hoffman, Mrs. E. LeNeve Foster, and Mrs. Ethelbert Ward. On this occasion the Boulder ladies most kindly entertained the delegates at luncheon. Branches are urged to arrange for boxes *only* through the Diocesan Corresponding Secretary, and to send money *only* through the Diocesan Treasurer, so that their work may be credited by the New York Board. For some years past two members of the St. Barnabas Branch have given a \$100.00 scholarship to St. Mark's Mission, Alaska, which our Treasurer cannot report, as the money was not sent through her.

Since the last annual meeting Mrs. J. F. Humphrey, one of our most valued members, and for many years one of our Vice-Presidents, has been called to her rest. We shall miss her presence and never-failing interest; but she has entered into the light and joy of that life beyond the grave.

At the beginning of Lent a United Meeting of all Denver Branches was held in the Crypt of St. Mark's Church, in an endeavor to bring about concerted action for Lenten Missionary

work and study. Various plans were discussed and formulated, and members were assigned subjects for papers, such as:

"What the G. F. S. A. Did for Missions Last Year."

"What the Colorado G. F. S. Did for Missions Last Year."

"What the Colorado G. F. S. Will Do for Missions This Year."

After Easter, another United Meeting was held, and it was found that much practical good had been accomplished by the united effort of all Branches. Papers—instructive and interesting—had been prepared and read, and a surprisingly large number of articles of clothing made by busy fingers or provided by generous hearts for Missionary boxes. The plan had proved such a success that it may well be tried another year.

Constitution.

ARTICLE 1. NAME.

This Association shall be called the Colorado Branch of the Woman's Auxiliary to the Board of Missions.

ARTICLE 2. OBJECT.

The object of this Association shall be to aid and supplement the work of the Board of Missions by awakening Missionary zeal among the Churchwomen of the Diocese, diffusing missionary intelligence, raising money for missionary objects, encouraging the formation of Parochial Branches throughout the Diocese, and by daily prayer for Missions.

ARTICLE 3. MEMBERSHIP.

All baptized women and children of the Diocese are considered members of this Association. Members of the Junior Branches may be boys or girls. All infants up to the age of seven years may be enrolled in the Babies' Branch.

ARTICLE 4. OFFICERS.

The officers of this Association shall be a President, five or more Vice Presidents, Recording Secretary, Corresponding Secretary, Treasurer, Assistant Treasurer, who shall also be Treasurer for General Missions; Treasurer of the United Offering, Director of the Junior Auxiliary, Director of the Babies' Branch, Director of the Altar Department and Missionary Associate.

Vacancies shall be filled by the Board of Managers.

ARTICLE 5. ELECTIONS AND APPOINTMENTS.

The President, the Vice-President, the Recording Secretary, the Corresponding Secretary, the Treasurer and the Assistant Treasurer shall be elected by the body at the Annual Meeting. The Treasurers of the United Offering, the Director of the Junior Auxiliary, the Director of the Babies' Branch, the Director of the Altar Department and the Missionary Associate shall be appointed by the President.

ARTICLE 6. BOARD OF MANAGERS.

The Officers of the Auxiliary with two delegates from each Parish and Mission in the Diocese shall constitute the Board of Managers, seven members to form a quorum.

The Delegates shall be appointed by the President of the Parish Auxiliary or the Rector.

Where no Branch of the Auxiliary has yet been organized, the President of the Women's Guild may with the Rector select the Delegates.

ARTICLE 7. ALTAR DEPARTMENT.

The object of the Altar Department is to assist in supplying chancel furnishings to Churches and Missions in need of such articles. To create a fund for this purpose, every Altar Guild in the Diocese is asked to contribute one dollar yearly.

ARTICLE 8. AUDITING COMMITTEE.

An Auditing Committee of two persons to be appointed by the President shall examine the accounts and vouchers of the Diocesan Treasurers and report the result at the annual meeting.

ARTICLE 9. MEETINGS.

During Council Week the regular, annual meeting with election of officers shall be held, preferably at the same place as the Council. There shall be eight regular meetings between the months of September and June. Special meetings may be called at any time by the President, and at these meetings only such business shall be transacted as is specified in the call.

ARTICLE 10. DUTIES OF OFFICERS.

The President shall preside at the Annual Meeting, at all regular and special meetings, and at the meeting of the Board of Managers.

The Vice-Presidents shall assist the President in carrying out the purposes of the Association, one of them presiding at any meeting in her absence or at her request.

The Recording Secretary shall keep the minutes of all meetings and prepare an annual report.

The Corresponding Secretary shall, at the direction of the President, send out all notices of meetings and shall conduct the correspondence of the Association, particularly with the delegates and with the General Secretary of the Auxiliary in New York.

The Treasurer shall collect all assessments, receive pledges and contributions, take charge of the offerings at Auxiliary Meetings, and at the direction of the Board of Managers pay out all moneys, keeping account of same, and presenting a report at monthly and annual meetings.

The Assistant Treasurer shall assist the Treasurer at any time, but shall especially undertake the raising of money for General Missions.

The Treasurer of the United Thank Offering shall receive and forward to the General Treasurer of that fund all United Offering moneys and shall work for increased contributions.

The Director of the Junior Auxiliary shall endeavor to have Junior Auxiliary Branches formed in all Parishes and Missions,

and shall make an annual report of all work done by these Branches.

The Director of the Babies' Branch shall promote systematic giving to Missions among little children, and make a report of her collections at the annual meeting.

The Secretary of the Altar Department shall collect the yearly dues from Altar Guilds, take charge of all contributions of altar furnishings, and at the direction of the Auxiliary, respond to all requests.

The Missionary Associate shall assist the President in organizing Auxiliary Branches throughout the Diocese.

ARTICLE 11. DUTIES OF DELEGATES.

The Delegates shall do all in their power to increase the interest in Missionary work in their respective Parishes, shall endeavor to add to the active membership of the Association, circulate the collects and leaflets of the Woman's Auxiliary, see that all moneys collected are forwarded to the several treasurers, and when possible attend the meetings of the Board of Managers and the Annual Meeting of the Association.

ARTICLE 12. PLEDGES.

At the Annual Meeting, parish and personal pledges shall be made to enable the Auxiliary to meet its obligations for Diocesan and General Missions.

ARTICLE 13. ASSESSMENTS.

Each Parish and Mission in the Diocese shall be asked to contribute annually towards the current expenses of the Auxiliary a sum apportioned in accordance with the number of its communicants, those having one hundred communicants or less, to pay one dollar, those having over one hundred and less than three hundred, two dollars, all over three hundred and less than five hundred, three dollars, and those having over five hundred, four dollars.

ARTICLE 14. AMENDMENTS.

This Constitution may, with the approval of the Bishop, be amended by a two-thirds vote of the members present at the Annual Meeting, at least one month's notice of the proposed amendment having been given to each Parish and Mission in the Diocese.

Counsels to Parochial Officers.

Impress upon the women of your Parish that they may become, by virtue of their baptism, members of the Auxiliary. Urge them to recognize this claim by working along the appointed lines, and by giving such dues as your Parish Branch may settle upon.

Every Branch is expected to give to the United Offering, Diocesan and General Missions, and report to Diocesan Treasurer, and to do its share of the work as planned by Diocesan Officers.

After this, develop any Diocesan or general work that has the approval of your Rector, after consulting with Diocesan Officers.

The "United Offering" is the Thank-offering presented at every Triennial service of the Woman's Auxiliary. It will be given for Woman's Work in the Domestic and Foreign Fields. Every woman is given an opportunity to share in the great Thank-offering. The birthday plan for raising the United Offering has been adopted successfully in many Diocesan Branches.

Take "The Colorado Churchman" and read to your Branch the Woman's Auxiliary page. Keep ready for reference a Church Almanac with Clergy list, the last report of your Diocesan Branch, Miss Emery's last report and the Spirit of Missions; and keep in supply copies of the Auxiliary prayers, leaflets from the Church Missions House, mite chests for the United Offering, and leaflets for the Junior Auxiliary work.

When a project is laid before your Branch, do not fail to report its action, after due deliberation.

When preparing a Missionary Box, write to Diocesan Corresponding Secretary for name of recipient and information concerning his needs. Report to her when box is sent.

Remit by express, P. O. order, bank drafts or checks; never by bank notes.

Report changes of address, or temporary absence, and do not fail to notify the Corresponding Secretary when changes occur in your list of officers. Apply to the Secretaries of the various departments for further information.

The Annual Meeting is held on the Tuesday preceding the Annual Council held the first week in June.
