TWENTY-NINTH ANNUAL REPORT OF THE RECORDING SECRETARY FOR THE YEAR ENDING JUNE 1, 1913.

During the past year, from October until May, inclusive, there have been eight regular United Meetings of the Colorado Branch of the Woman's Auxiliary held in the following Churches on the fourth Tuesday of each month: Trinity Memorial, All Saints', Ascension Memorial, Emmanuel, Epiphany, St. Barnabas, Calvary Golden, and St. John's Cathedral; the president, Mrs. C. S. Olmsted presiding. Each meeting has been opened with a short service, followed by a business session, where reports from the various departments of the Auxiliary showing the progress of the work have been presented; then a program under the direction of a Program Committee (of which Mrs. H. Hoffman, our Educational Secretary, is Chairman) has been given, the subject this year being "Japan," and the text-book used, the one authorized by the Educational Department of the Board of Missions—"Japan Advancing Whither?" The papers on the various topics have in all cases been thoughtfully prepared and much interest has been manifested throughout the entire course.

In addition, the Auxiliary has had the privilege of listening to addresses from Mr. John Wood, general secretary of the Board of Missions; Rev. C. C. Rollitt, departmental secretary; Rev. Mr. Clark of the Rosebud Mission; S. D. and Dr. Sedgwick of New York, all of whom were present at the October meeting.

In January, Mrs. Passmore of Minneapolis, gave a most interesting address on Foreign Missions; in February Archdeacon Schofield spoke of our Diocesan Missionary work and at the April meeting the Rev. C. C. Rollitt gave a Missionary talk.

Bishop Olmsted has been present at three meetings, when he addressed the Auxiliary.

Largest attendance, 135. Smallest attendance, 38. Average attendance, 83, against 55 last year.

One special meeting of the officers was called by the President on the afternoon of April 29th, at the Bishop's house.

A Quiet Day for the Woman's Auxiliary was held at Trinity Memorial Church on Thursday, February 13th, by Bishop Olmsted; between fifty and sixty women were present.

On Tuesday evening, April 15th, the Rev. C. C. Rollitt gave a lecture on Japan in St. Mark's Church. The lecture, which was illustrated by stereopticon views, was much enjoyed.

One new Branch of the Auxiliary has been organized at Creede, and the Boulder Branch has been reorganized.

A request that Colorado give a scholarship of \$100 a year to the Nenana Mission School, Alaska, has come before the Auxiliary, and will be acted upon at the annual meeting; in connection with this, it might not be amiss to say that all money contributions should be sent through our Diocesan treasurer in order that proper credits can be made. The treasurer can not report money which does not pass through her hands. Two devoted members of the St. Barnabas Branch have for some years been giving an Alaskan scholarship, but as the money is not sent through our Diocesan treasurer it does not appear in her report.

Both our president, Mrs. Olmsted, and the Departmental Secretary, Mr. Rollitt, have during the past year urged upon our members the duty of subscribing to our Missionary Magazine, "The Spirit of Missions;" its price brings it within the reach of all; every word is of interest; it brings us in personal touch with those who are doing the Master's work in both the Home and Foreign Field. With knowledge of the conditions, interest and enthusiasm will be aroused, and with gifts of prayer, service and money offered in an understanding and fervent spirit, we can share in the great work of extending Christ's Kingdom.

REPORT OF THE EDUCATIONAL SECRETARY.

This first year of definite educational work carried on by a special secretary has been a year of preparation, largely, of foundation laying; of hard work, and yet a year full of promise and rich in the reward of accomplishment. Mission Study has been put on a firm basis as a very real part of the work of the Woman's Auxiliary here in Colorado; it is no longer experimental—it is a growing factor in Missionary activities. Without doubt, "Mission Study is the crux of our present Missionary problems; interest, prayer, gifts, depending upon information. The purpose of studying the lives of Missionaries is that we may live Missionary lives."

The Educational Secretary has sent out letters and pamphlets explaining the work and plan of campaign to every Auxiliary listed with the corresponding secretary. She has visited Boulder, Colorado Springs, Golden and Sedalia, besides various Parishes in Denver, in the interests of the educational work. She has personally organized seven study classes, and has taught six study classes, including a Normal Class of fifteen members, representing eleven different Parishes; one Junior Class and four regular study classes. Of the members of the Normal Class, five taught study classes, seven helped to form study classes, two arranged for Reading Circles and four helped to plan and carry out study meetings or Missionary conferences.

The books studied this year have been of vital interest. The Home Book, "The Conquest of the Continent," gives a clear, concise and readable account of the Church's work here in our own land, something that every loyal Churchman and Churchwoman should know. The Foreign Book, "Japan Advancing—Whither?" is a fascinating study of that wonderful little nation. While the Junior Book, "The Honorable Little

Miss Love," gives an intimate and living glimpse into the lives of the children of Japan, and the way the Missionaries work in that far-off land. The reports show forty-nine copies of the Conquest in use in this Diocese; eighty-five of Japan Advancing, and seventeen of the Junior Book. There are probably many more that have not been reported.

During the year 151 women have been enrolled in the fifteen study classes in the Diocese, with an average attendance of 121.

The Educational Secretary wishes to express to the Woman's Auxiliary her appreciation of their interest, enthusiasm and support in this new line of Missionary endeavor.

Bishop Rhinelander says: "I want to leave with you the thought of the unused, unrealized resources of the Church. It is like a mighty reservoir full to the brim with a flood of waters. The Missionary spirit in the Church is a trembling and thrilling pressure seeking an outlet. May we all study Missions, in order that the spirit may have its way with us, leading us to a complete sacrificial surrender to the will of God."

PRESIDENT'S ADDRESS.

Members and Friends of the Woman's Auxiliary:

We welcome you all to the Twenty-ninth Annual Meeting of the Colorado Branch of the Woman's Auxiliary to the Board of Missions.

We have before us the report of the work done in the past year; we look to see if we have gone forward in our efforts and results. Our aim is to grow in knowledge of the work, and in prayerfulness, that our usefulness may be increased each year. We are happy to note that work of the Educational Secretary is increasing, and that this next year will see many more Study Classes on Missionary programmes started in the Branches throughout the Diocese.

We are asking the Vice-Presidents to join more heartily with us in the important work of the Auxiliary. Will not each one make it her privilege and duty to help extend the work, in the Parishes or Missions, in her own immediate vicinity, helping to organize Branches where there are none, to increase the membership and to encourage those already at work? Many Guilds are giving or working a portion of their time through the Auxiliary. Will not you help us find out how many organized Branches there are, and how many Guilds are working through the Auxiliary?

There has been some misunderstanding in the past two or three years about General Missions and the Apportionment.

Many Branches feel that if they pay their apportionment to the Diocesan Treasurer of the Auxiliary, that their Parish does not get credit for it. That is not so. But to make it more plain, would it not be well to adopt a resolution, as has already been done in one Diocese, similar to this:

Resolved: That all moneys raised by Parish Branches of the Woman's Auxiliary, for the apportionment made by the General Board of Missions, should be paid to the Diocesan Treasurer of the Auxiliary, as heretofore, the Treasurer of the Parish Branch being careful to report promptly this action to the Treasurer of the Vestry of her Parish, the Diocesan Treasurer of the Auxiliary to forward these sums to the Diocesan Treasurer, if there be one, otherwise to the Treasurer of the General Board of Missions, Mr. George Gordon King, stating the amount given by each Parish Branch, that he may so credit it.

It has been suggested that a semi-annual meeting of the Auxiliary be held in December or January. If that plan is not

feasible, we would suggest that the women of the Auxiliary, who may be coming to Denver for shopping or other purposes, arrange the time so that an hour or two may be given to the United Meetings of the Auxiliary, held in the afternoon of the fourth Tuesday in each month, from October to June. Notice of these meetings will be found in the October number of the Colorado Churchman.

In that way we shall come into closer and more frequent contact, and come more in touch each with the other's work.

On October the eighth, the General Convention will open in New York City. At the same time the triennial meeting of the Woman's Auxiliary will take place, and delegates from every branch of the Domestic and Foreign field will be present. Frequent meetings and conferences of the several departments of the Auxiliary will be held, and inspiration and encouragement received by all who attend. The great service, at which the triennial United Thank Offering will be presented, will be held on Thursday, October 9th, at 10 o'clock.

Would it not be well and profitable to us, if every member of this great Auxiliary would attend, if possible, a celebration of the Holy Communion, on St. Michael's and All Angel's Day, the 29th of September; the Saints' Day first preceding, the General Convention opens; remembering the Auxiliary in our prayers, and asking God's blessing upon its work.

MINUTES.

The 29th Annual Meeting of the Colorado Branch of the Woman's Auxiliary to the General Board of Missions was held in the Chapter House of St. John's Cathedral, Denver, on Tuesday, June 3, 1913.

The Holy Communion was celebrated in St. John's Cathedral at 9:30 a. m., by the Right Rev. C. S. Olmsted, S. T. D., Bishop of Colorado, assisted by the Very Rev. H. Martyn Hart, Dean of the Cathedral; hymn 254 was sung.

Fifty-nine Communicants attended this opening service, and the offertory amounted to \$10.35.

At the conclusion of the service the members and delegates assembled in the Chapter House for the business session, which was opened by the singing of hymn 253: "Fling Out the Banner."

The President, Mrs. C. S. Olmsted, gave her annual address of welcome to the delegates and members.

The Corresponding Secretary read Miss Emery's annual letter, and gave out notice of the supper to be held in St. Mark's Parish House for both churchmen and churchwomen, to be followed by a Missionary meeting.

By request, the letter from Rev. C. E. Betticher, asking that the Colorado Branch of the Woman's Auxiliary give a scholarship of \$100.00 a year to the Mission School at Nenana, Alaska, was read. On motion of Mrs. Touret of Grace Church, Colorado Springs, seconded by Mrs. T. A. Schofield of the Cathedral, Denver, it was resolved that \$100.00 be pledged for the Alaska scholarship.

Mrs. Persifer Cooke stated that for some years two members of the St. Barnabas' Branch had been giving a scholarship to this school.

A letter from Mrs. E. C. Dewey, resigning her office as Directress of the Altar Department, was read. Moved by Mrs. F. A. Ellis, seconded by Mrs. Atwater, that "this resignation be accepted with much regret." Carried.

The election of Diocesan officers came next in order. Mrs. Henry Read, chairman of the Nominating Committee, spoke of the wish of the President and officers that the vice-presidents take an active interest in the work and aims of the Auxiliary by stimulating Missionary interest in their respective centers, then presented her report, as follows:

Shutt, Fort Collins; Fifth Vice-President—Mrs. Rockafellow, Canon City; Sixth Vice-President—Mrs. Fine, Boulder; Seventh Vice-President—Mrs. Fred Shaw, Cripple Creek; Eighth Vice-President—Mrs. Caroline Baldwin, Greeley; Ninth Vice-President—Mrs. Hart, Pueblo (Church of the Ascension); Recording Secretary—Miss Edith Brent, 1200 Steele Street, Denver; Corresponding Secretary—Miss Carrie Clinton, 448 York Street, Denver; Treasurer—Miss Gertrude R. King, 1221 Race Street, Denver.

There were no nominations from the floor, and it was moved by Mrs. Touret, seconded by Mrs. Skinner, that the Secretary be instructed to cast the ballot. Carried.

The President thanked the officers and members of the Auxiliary for their help and interest of the past year; she made the following appointments:

Treasurer, United Offering—Mrs. E. Le Neve Foster, The Perrenoud, Denver; Secretary, Junior Auxiliary—Mrs. Alfred Barnes Bell, 1360 Birch Street, Denver; Secretary, Babies' Branch—Mrs. T. A. Schofield, 1264 Clarkson Street, Denver; Correspondent, Church Periodical Club—Miss Anna P. Livingston, Canon City; Director, Altar Department—Mrs. Martha Fisher; Educational Secretary—Mrs. H. F. Hoffman, 2141 Vine Street, Denver.

Moved by Mrs. Touret, seconded by Mrs. Skinner, that an appropriation of \$25 be made for the expenses of the Educational Secretary. Carried.

The Educational Secretary explained that it is now impossible to get transportation, consequently she can not visit as many Branches as she would like.

A discussion followed as to the method of payment of Diocesan and General Missions. The Rev. W. H. Doggett of St. Peter's, advocating that the Woman's Auxiliary pledge for Diocesan Missions be credited to the Parish apportionment. Dean Hart defined the Woman's Auxiliary as "auxiliary to the General Board of Missions in New York."

The president called on Bishop Olmsted, who spoke enthusiastically of the St. Mark's supper and Missionary meeting, suggesting that the ladies themselves settle the question of pledges.

A motion made by Mrs. Hathaway of St. Stephen's, Colorado Springs, "That pledges be paid through Parish Treasurers to the Diocesan Treasurer," was withdrawn by her, and on motion of Mrs. Touret, the roll was called and pledges taken for Diocesan and General Missions. Roll call was responded to by 169, representing 27 Parishes and Missions; three visitors were present. The pledges for Diocesan Missions amounted to \$444.25; the pledges for General Missions to \$153.91.

The discussion on "creating a Missionary atmosphere in the home, and in the Church," was omitted, for lack of time.

The President stated the reports of the officers had been printed and distributed, and requested they be read by members and delegates during the luncheon hour. The meeting adjourned for luncheon.

Business was resumed at 2 o'clock, and the meeting was opened by singing hymn 205. Pledges were taken for the Alaska scholarship, amounting to \$52. The President requested that Parishes which had not yet made pledges and wished to do so, to notify the Diocesan Treasurer.

Moved by Mrs. Touret, seconded by Mrs. Skinner, "that the annual reports of the officers be approved." Carried.

The Educational Secretary urged upon the members and delegates the importance of subscribing to the "Spirit of Missions," and drew attention to the new Missionary publication

of the New York Board, also of the new library of 5,000 volumes in the Church Mission House, and of the course of study for the coming year—China.

As Bishop Partridge, who was to give an address, was unavoidably late, the order of the program was changed and the Conference on "What the Woman's Auxiliary is Doing in Colorado," followed. Mrs. T. A. Schofield told of the little Helpers. Mrs. B. W. Bonell spoke of the importance of work among our young people, and of interesting them in the Young People's Missionary Society of the Church—the Junior Auxiliary.

Mrs. Touret told of the Woman's Auxiliary. Mrs. E. LeNeve Foster of the United Thank Offering. Mrs. H. F. Hoffman of Mission Study, and Mrs. E. C. Dewey of the work of the Altar Department.

Bishop Olmsted introduced Bishop Partridge, who gave a most inspiring address on Missionary work in China and Japan.

The Rev. C. C. Rollitt, who was on the program, was not present.

The afternoon offering was \$1.70.

Notices were given of the Wolfe Hall graduating exercises and reception on Tuesday evening, and of the Girls' Friendly Tea on Thursday afternoon, to both of which the delegates were invited.

The minutes were read and approved, and the meeting adjourned.

DEFINITIONS.

The following definitions will be found helpful:

General Missions are those Missions of the Church for which the General Board of Missions is responsible.

Domestic Missions are such Missions, supported by the General Board, as are situated within the jurisdiction of the Government of the United States.

Foreign Missions are such Missions, supported by the General Board, as are beyond the jurisdiction of the Government of the United States.

Diocesan Missions are Missions within the Diocese which receive support from the Diocesan Board of Missions, outside the limits of one's own Parish or Mission.

The United Offering is the Thank Offering presented at every Triennial service of the Woman's Auxiliary.
