THIRTY-FIRST ANNUAL MEETING OF THE COLORADO DIO-
CESAN BRANCH OF THE WOMAN'S AUXILIARY TO
THE BOARD OF MISSIONS, HELD IN THE CHAP-
TER HOUSE OF ST. JOHN'S CATHEDRAL,
DENVER, ON TUESDAY,
JUNE 8, 1915.

The Thirty-first Annual Meeting of the Colorado Branch of the Woman's Auxiliary to the Board of Missions was held in the Chapter House of St. John's Cathedral on Tuesday, June 8, beginning with a celebration of the Holy Communion in the Cathedral at 9 a. m. Dean Hart officiating. The hymns sung were "Lord Remember Me," "Thy Kingdom Come," and "Jesus Lover of My Soul."

The Dean gave a short but most helpful address, the keynote being "Love", taken from the Epistle for the day. Ninety-three attended this opening service. The offertory amounted to \$12.20.

After the service the delegates and members assembled in the Chapter House where the business session was held, the First Vice-President, Mrs. Frank L. Bishop, in the chair.

The proceedings opened with the prayer "Direct Us O Lord," being said in unison, after which Mrs. Bishop read her address of welcome.

The Corresponding Secretary read the resignation of the President, Mrs. C. S. Olmsted.

On motion of Mrs. Mantz, the following resolution was carried: "That the resignation of Mrs. Olmsted be accepted with regret, and that the Secretary be authorized to send to her the greetings of the Colorado Branch of the Woman's Auxiliary, and its grateful appreciation of her faithful service."

A letter from Mrs. Wheaton, president of the Cathedral Branch, thanking the Auxiliary for its expression of sympathy in her recent bereavement, was read.

The report of the Committee on Constitution was read by the chairman, Mrs. Mary Shelby Wolfe, who explained that slight changes in wording in no way affecting the meaning had been made since sending out the printed copies. Mrs. Wolfe moved the adoption of her report; it was seconded by Mrs. Alfred Barnes Bell and carried. The acting president announced that inasmuch as the constitution just adopted stated in Article X that "At the annual meeting each Parish or Mission is entitled to one vote by a delegation representing that Parish or Mission," a recess of five minutes would be given in order that the delegates might be seated according to Parishes.

The report of the Nominating Committee was presented by the chairman, Mrs. E. W. Robinson, as follows:

President—Mrs. Frank L. Bishop; First Vice-President—Mrs. Shelby Wolfe; Second Vice-President—Mrs. F. H. Touret; Third Vice-President—Mrs. Rockafellow; Fourth Vice-President—Mrs. Bonell; Fifth Vice-President—Mrs. Hollenbeck; Recording Secretary—Miss Brent; Corresponding Secretary—Miss Clinton; Treasurer—Mrs. Ridley; United Offering Treasurer—Mrs. E. LeNeve Foster.

The Honorary Vice-President, Mrs. N. G. Burnham, took the chair for the election.

There being no nominations from the floor, it was moved by Mrs. Robinson, seconded by Mrs. Claire Foster, that the report be adopted, and the Secretary instructed to cast the ballot. Carried. The president, Mrs. Frank L. Bishop, was warmly greeted as she took the chair. The following appointments were made:

Secretary Junior Auxiliary—Mrs. Alfred Barnes Bell; Secretary Little Helpers—Mrs. T. A. Schofield; Educational Secretary—Mrs. H. F. Hoffman; Correspondent Church Periodical Club—Miss Anna P. Livingston; Director Altar Department—Mrs. E. C. Dewey; Secretary "Spirit of Missions"—Mrs. L. O. Trowbridge.

Committees were appointed as follows: Entertainment—Mrs. G. W. Cooke, Miss Adele Perrenoud, Mrs. Thomas Skinner; Printing—Miss Clinton, Miss Brent, Mrs. Henry Read; Auditing—Mrs. C. G. Mantz, Miss Gertrude King. The committee appointed last year to keep in touch with the council on Wolfe

Hall matters was continued, and consists of Miss Spalding, Mrs. Henry Read, Mrs. N. O. Vosburg Jr., Mrs. Charles G. Mantz, Miss Letts.

The question of the Alaskan Scholarship given by the Branch for the past two years, was brought up; it was moved by Mrs. Touret, seconded by Mrs. Wolfe, that the Alaskan Scholarship be continued. Mrs. Touret, speaking of the value of definite pledges, and suggesting the Branches have an "Alaskan afternoon" in aid of the fund, and Mrs. Wolfe asking the aid of each Parish and Mission, voting was by roll call of Parishes, the motion was carried.

Roll call was responded to by 145, representing 28 Parishes and Missions. Pledges for Diocesan Missions amounting to \$562.00. For General Missions, \$163.60; for the Alaskan Scholarship, \$73.50.

The Corresponding Secretary read a letter from Miss Emery on Auxiliary work. It was moved by Mrs. Frank A. Ellis Jr., seconded by Mrs. Alfred Bell, that a copy of Miss Emery's letter be sent each vice-president with the request that each district shall act upon it. Carried.

Mrs. E. LeNeve Foster gave a most interesting account of a visit to the Los Angeles Branch at the time of the annual meeting.

Mrs. Ruffner gave a report of the work of the Lectern League.

Mrs. Wolfe emphasized the fact that all Auxiliary Parish Branches must send money through Mrs. Ridley, the Diocesan treasurer.

At 12:00 o'clock business was suspended while the noon-day prayer was offered. Mrs. J. E. Robinson spoke of the Boulder Summer School of Missions. Miss Clinton of the G. F. S. Holiday House, Blue Jay Inn. Mrs. Chamberlain of the Church Convalescent Home, and Mrs. Touret of the coming conference at Estes Park.

Mrs. Trowbridge made an appeal for subscribers to the Spirit of Missions.

Miss Clinton and Miss Campbell presented the work of the Girls' Friendly Society.

Archdeacon Schofield gave a brief address on Auxiliary work. He was followed by Rev. Canon Houghton, who spoke of the educative value of the Mission Play, and Rev. J. A. Stansfield, who urged the members of the Auxiliary to interest themselves in the Diocesan paper, the Colorado Churchman.

Mrs. Jones spoke of her appreciation of the space kindly given by the Colorado Churchman to the Convalescent Home, and announced an entertainment to be given in aid of that institution on June 17th.

Mrs. George Stahl told of the coming campaign on behalf of the Children's Hospital.

The President extended an invitation to the newly-elected officers to take seats on the platform during the afternoon session; she also called a meeting of the vice-presidents at 1:30 and asked that the reports of officers, which had been printed, be read during the luncheon hour by delegates. Announcement was made of the tea to be given by the Cathedral Branch at the close of the afternoon meeting; also that subscriptions for the Colorado Churchman would be received at the entrance of the room.

At 1:00 o'clock a recess of an hour was taken for luncheon, which was served in the Guild Room. At 2:00 p. m. the meeting was opened by Archdeacon Schofield with prayer, and the hymn "O Zion Haste" was sung.

The Auditing Committee presented the following report: "Your Auditing Committee begs leave to report that upon the resignation of the Diocesan Treasurer on February 1, 1915, the accounts were examined and found correct. At the close of the fiscal year the treasurer's accounts and vouchers have again been examined and found to be correct."

On motion of Miss Jacobeit, seconded by Mrs. Skinner, the reports of the officers were adopted.

The minutes of the meeting were read and approved.

The minutes of the vice-presidents' meeting were read.

Mrs. R. B. H. Bell sang "There Were Ninety and Nine."

The Rev. F. H. Touret of Grace Church, Colorado Springs, gave a most inspiring and helpful address, urging his hearers to endeavor to introduce in their respective Parishes two constructive things: 1. The Duplex Envelope System; 2. The monthly remittances of Missionary money to the treasurer at the Church Mission House, New York, Mr. George Gordon King.

Announcement was made of the entertainment of delegates at the "Buckingham". The hymn "Fling Out the Banner," was

sung, and the offertory amounting to \$19.00 was taken; the meeting concluded with the Benediction, after which tea was served in the Guild Room by the ladies of the Cathedral Branch.

At the meeting of the vice-presidents, held at 1:30, there were present the president, Mrs. Bishop; Mrs. Wolfe, Mrs. Bonell, and Mrs. Touret, also the corresponding and recording secretaries. With the help of Archdeacon Schofield the districts were defined as follows: The Denver district, in charge of Mrs. Wolfe, to include Arvada, Boulder, Byers, Castle Rock, Golden, Hugo, Littleton and Sedalia; the Greeley district, in charge of Mrs. Bonell, to include Fort Morgan, Fort Collins, Fort Lupton, Longmont, Loveland, Sterling, and Windsor; the Colorado Springs district, in charge of Mrs. Touret, to include Cripple Creek, Victor, Manitou, Colorado City, Chico Basin and Divide; the Canon City district, in charge of Mrs. Rockafellow, to include Florence, Salida, Pueblo, and Leadville; the Trinidad district, in charge of Mrs. Hollenbeck, to include Walsenburg and Aguilar.

THE PRESIDENT'S ADDRESS.

As the Acting President of the Woman's Auxiliary, I extend to you all my most hearty greeting, especially to our delegates from out-of-town. I extend to you all my thanks for the support and assistance you have given me since I undertook the Auxiliary work in Mrs. Olmsted's absence. I have greatly missed her and trust she and Bishop Olmsted are greatly improved in health. To the officers I am most deeply indebted. They are the ones who have kept our organization together, by being at all times loyal, efficient, persevering, and in every way helpful to your presiding officer.

During the year some of our best loved members have passed away, and although knowing that they have found the perfect rest, we remaining mourn their loss.

Necessarily, since last year's election, there have been several changes in the officers, but withal, our showing is most gratifying. Our treasurer's report states that every Parish in the Diocese paid all its pledges before the annual closing of the books on May 15th. This is not only very encouraging but it is unusual.

At the annual meeting last June, it was voted to continue

the \$100 pledge for the Alaskan Scholarship. To make up this amount we were obliged to take some money from our general fund; this should not be necessary as we should be prepared to meet with pledges the full amount if we vote to continue its payment.

Our report shows that we have been able to contribute to many different Missionary projects, a little offering which we have sent with our earnest prayers for the success of the work.

In the May "Spirit of Missions", in the article "How a Christian Minister May Best Serve the World," it says: "One way is to make good people efficient," that is my idea of a good officer of any organization. Make the most of your members, find out their strong points and use the right people in the right place. One may be a good educator, one a good collector, one a good organizer, and best of all, one may be kind, tactful and friendly. Watch the people! I am speaking especially to the officers of the Auxiliary.

When a committee is to be appointed, have some one in mind who can do the work, and ask the president to appoint them. When you know or hear of some one who is doing good work in your Parish or who could if they would, seek them out and report them to your Clergyman, to the president of your Parish Auxiliary, and to the president of the United Auxiliary. Let us use these workers and by showing our appreciation, bring out the best in them.

The United Auxiliary should be the greatest, grandest organization of Church women in every State. In every Church and Mission in the Diocese we must have Parish branches, and leaders of these branches must instruct their members to support the United body, by their presence, their prayers and their offerings, otherwise they are unfaithful; they must aid the mother Auxiliary so that it may with ease meet the demands made upon it. At United Meetings, when important questions like the Alaskan Scholarship, the Clergy Relief Fund, etc., are brought up, vote intelligently and if your Parish can not contribute toward such a fund, do not vote for it and expect others to fulfill the pledge.

Let us endeavor this year to think of this Auxiliary work as a privilege and not as a burden, and let us with every dollar that we contribute thank God that we are able in strength, in will, in means, to carry on and glorify this great and beautiful work of His.

THIRTY-FIRST ANNUAL REPORT OF THE RECORDING SECRETARY FOR THE YEAR ENDING JUNE 1, 1915.

It is a pleasure to note that the Diocesan Woman's Auxiliary work is steadily going forward in all departments, as will be seen in reports from the various officers. Each Parish and Mission has paid pledges in full and paid them in time to be credited in the Annual Report of the Treasurer.

In addition to the Parish pledges and assessments the Alaskan Scholarship of \$100 has been paid, \$50 has been given to the General Clergy Relief Fund, \$124 for Educational work, and \$20.50 to the Emergency Fund.

The number of organized branches cannot be accurately given as complete reports were not returned.

There are 10 Junior Branches and 11 Branches of Little Helpers.

Seven regular united meetings have been held during the year, viz.: At All Saints in October; Church of the Ascension in November; Epiphany in January; St. Barnabas' in February; St. John's Cathedral in March; Emmanuel in April, and St. Paul's in May. The December meeting was omitted, all the Parishes being invited to join in the Cathedral meeting when Mrs. John Ely gave an address. Mrs. Olmsted, the President, presided at the first meeting; in her absence Mrs. Frank L. Bishop, the First Vice-President, presided at five meetings, and Mrs. Wheaton, President of the Cathedral Branch, at one. The program for the year has been the reviewing of the "Spirit of Missions," a resumé of the current number being given at each meeting with the exception of the one in March, when the Auxiliary had the great pleasure and privilege of hearing Bishop Partridge of Kansas City speak on the work in China and Japan. The largest number present at any one meeting was 93. The smallest number 66. The average attendance being 74. Sixteen visitors were present at different times during the year.

Archdeacon Schofield, Rev. J. Stansfield, Rev. H. A. O'Malley, and Canon Holoran have addressed the Auxiliary, and at a meeting at the Cathedral on January 4th Mrs. John Ely of Shanghai, China, gave a most interesting and forceful talk on her work in St. Mary's School.

Miss Margaret Hobart of the Church Missions gave two of her fascinating impersonations at the Chapter House on Sunday afternoon, April 18, followed by an earnest address on

Auxiliary work. And at St. Barnabas' Church on April 22nd Bishop Lloyd, President of the Board of Missions, spoke. His earnest words were an inspiration to all who heard him.

Four special meetings of officers have been called by the Acting President and the Committee on the Revision of the Constitution held four meetings.

A Corporate Communion took place at St. Mark's on Tuesday morning, February 2nd. Rev. Canon Houghton being the celebrant. About forty were present.

In February the resignation of Miss Gertrude R. King, our most efficient and faithful Treasurer was received with deep regret. Mrs. Shelby Wolfe most kindly consented to act until the Annual Meeting. The resignation of Mrs. Eaton, Directress of the Altar Department, was accepted with regret, and Mrs. Dewey, assisted by Mrs. Skinner, has been good enough to take charge of the work. The Educational work has made great advance, both in point of interest and increase in number of classes. The text-book for the year, "The Social Aspect of Foreign Missions," has proved to be of unusual interest.

Since the last annual meeting three of our members have been taken from us. Mrs. Fred Copeland, Mrs. Julia A. Bishop, and Mrs. W. R. King, who for the last five years was Vice-President of the St. Barnabas' Branch. Their never failing interest in the work of the Auxiliary will be greatly missed but they have entered into the "unspeakable joys which God has prepared for them that unfeignedly love Him."

REPORT OF THE SECRETARY FOR THE SPIRIT OF
MISSIONS FOR THE YEAR 1914-1915.

I was appointed Secretary for the Spirit of Missions by the President, Mrs. C. S. Olmsted, at the Council in June, 1914. I immediately wrote the Board of Missions for advice in the best way to bring about a wider circulation of our valuable church organ. It has been splendid in giving me every possible help, lending plenty of literature to distribute, but the greatest aid being a complete list of every 1914-1915 subscriber in our Diocese. I am sure that you will be interested to know that there are five subscribers in Boulder, five in Canon City, nineteen in Colorado Springs, eighty-eight in Denver, nine being new ones, three in Fort Collins, seven in Pueblo, two in Salida, and but one faithful reader each in Arvada, Ault, Buffalo Creek, Central City, Edgewater, Estes Park, Fairplay, Fort Lupton, Larkspur, Las Animas, Sedalia, Trinidad, and Windsor. Of course, I expect the clergy always have a copy and attempt to distribute it, but just think, in these many (thirteen) towns, their having but one faithful reader of *The Spirit of Missions* to stand by them, and in an enlightened way help to keep alive the great and wonderful mission work of the Church.

I wonder not that the clergy get completely disheartened in even trying to present to their listless flock the subject of missions—the great cause for which so many are gathered together here today.

To many it seems merely to mean an annual event only. The time has come that to make a success of anything we must be well and thoroughly posted, and I find that some Presidents of Auxiliaries and of Guilds, who often represent the missionary work of the Parish, when there is no Auxiliary formed, do not even take *The Spirit of Missions*, which is granted by all denominations even, to be the very best Missionary magazine of all the fifty published in the United States and Canada, and it is only \$1.00 a year or 75 cents, and the quarter can be dropped in the United Offering box.

I asked the Board of Missions if they would compose for me a special letter to which I could add a personal plea suitable to the place or condition of Parish. As far as I knew I sent out nearly twenty-five of these, some to places like Longmont, where no subscription is taken. I received many pleasant replies from these letters, more encouraging than discouraging ones. Have had the pleasure of interviewing several of the clergy, every one but one promising to talk up *The Spirit of Missions* harder than

ever. I have also asked the Board of Missions to send sample copies to the towns where none are taken, and this I trust, they have done. It was my intention to phone to every delinquent Denver subscriber urging her or him to renew without delay, but as illness has prevented this I am going to seize this opportunity to beg of you to cheer the hearts of those working so hard for and in God's great mission field, by renewing or subscribing now, today, for this best of all church magazines. I have just received the special offer the Board has sent out, of four months for only 25 cents. Will not every churchman take advantage of this great trial offer? I feel sure that after you have had The Spirit of Missions upon your library table for four months and for only 25 cents, that your entire family will feel that they can never afford to be without it, not only for the knowledge, but for the personal inspiration and help it brings into each of our lives, not letting us forget that Christ told each and every one of us to go into all the world and spread the gospel to every creature, everywhere.

Constitution.

Article 1.—Name.

This Branch shall be known as The Colorado Diocesan Branch of the Woman's Auxiliary to the Board of Missions.

Article 2.—Object.

The object of this Branch shall be to aid and supplement the work of the Board of Missions, and under its direction to forward the Missionary work of the Church throughout the world, by awakening Missionary zeal among the churchwomen of the Diocese, diffusing Missionary intelligence, raising money for Missionary objects, encouraging the formation of Parochial branches throughout the Diocese, and by daily prayer for Missions.

Article 3.—Membership.

All baptized women in this Diocese willing to carry out the purposes of this Branch shall be considered members.

Article 4.—Officers.

The officers of this Branch shall be a President, not less than five Vice-Presidents (one to be chosen from each district), Recording Secretary, Corresponding Secretary, Treasurer, United Offering Treasurer, Educational Secretary, Secretary of the Junior Auxiliary, Secretary of the Little Helpers, Secretary of the Altar Department, Correspondent of the Church Periodical Club, and Secretary of the "Spirit of Missions."

Article 5.—Board of Directors.

The Diocesan officers shall constitute the Board of Directors, five members to form a quorum.

Article 6.—Committees.

There shall be an Auditing, Entertainment, Printing, Educational, and Nominating Committee.

Article 7.—Duties of Officers.

Section 1. The President shall preside at all regular and special meetings, and at all meetings of the Board of Directors.

Sec. 2. The First Vice-President shall supervise the work of the Denver district, and shall act in the absence of the Presi-

dent or at her request. The other Vice-Presidents shall supervise the work of their respective districts, calling at least two united meetings during the year and reporting to the Board of Directors.

Sec. 3. The Recording Secretary shall keep the minutes of all meetings, and prepare an annual report.

Sec. 4. The Corresponding Secretary shall, at the direction of the President, send out all notices of meetings, and shall conduct the correspondence of the Branch. She shall receive from the General Secretary of the Woman's Auxiliary the requirements for boxes, and place them in the Parish branches. She shall make an annual report of boxes sent.

Sec. 5. The Treasurer shall receive all assessments, pledges, and specials (except the United Offering), take charge of the offering at Auxiliary meetings, and shall expend money only by order of the President and Secretary, keeping account of the same, presenting a monthly and annual report.

Sec. 6. The United Offering Treasurer shall furnish the Parish Treasurers with United Offering boxes and leaflets, and bring to their attention in other ways the purposes of the United Offering. She shall receive semi-annual collections and put these amounts at interest. Each year she shall render a report of the progress of the offering, and each third year make it ready with its accumulated interest for presentation at the Triennial Service of the Woman's Auxiliary.

Sec. 7. The Educational Secretary shall prepare herself to instruct in all branches of the Woman's Auxiliary work, and especially for the training of Parish leaders for study classes. She shall cooperate with the Educational Department of the Board of Missions, and with the Assistant Secretary of the Woman's Auxiliary in New York for Mission Study in all their plans, and each year follow as far as she may be able, the study courses presented by them, and shall make an annual report.

Sec. 8. The Secretary of the Junior Auxiliary shall endeavor to have junior branches formed in all Parishes and Missions. She shall receive and forward all moneys, and make an annual report of all work done by these branches.

Sec. 9. The Secretary of the Little Helpers shall promote the daily prayer and systematic giving among little children. She shall receive and forward all moneys, and shall make an annual report.

Sec. 10. The Secretary of the Altar Department shall collect yearly dues from Altar Guilds, take charge of all contribu-

tions of altar furnishings, and at the direction of this Branch, respond to requests and make an annual report.

Sec. 11. The Correspondent of the Church Periodical Club shall conduct all affairs of said Club, and make an annual report.

Sec. 12. The Secretary of the "Spirit of Missions" shall make every effort to increase the subscription list throughout the Diocese.

Article 8.—Duties of the Board of Directors.

The Board of Directors shall meet at least twice during the year, and additional meetings may be called at any time by order of the President. It shall plan the year's work for the Branch, shall fill all vacancies, and shall decide all questions referred to it. Its decision shall be final.

Article 9.—Duties of Committees.

Section 1. The Auditing Committee, composed of two persons appointed by the President, shall examine all accounts and vouchers annually, and report the same.

Sec. 2. The Entertainment Committee, composed of three persons appointed by the President, shall provide entertainment for delegates attending the annual meeting.

Sec. 3. The Printing Committee, composed of three persons appointed by the President, shall attend to the printing of the annual report and all programs.

Sec. 4. The Educational Committee, composed of the Educational Secretary and six other persons, appointed by the President, shall carry on the work assigned to the Educational Secretary.

Sec. 5. The Nominating Committee, composed of three persons appointed by the President, one month previous to the annual meeting, shall report at the annual meeting.

Article 10.—Meetings.

During Council Week the regular annual meeting with election of officers shall be held, preferably at the same place as the Council. In addition to the annual meeting there shall be eight monthly meetings during the year, beginning with October. Special meetings may be called at any time by the President. At these meetings only such business shall be transacted as is specified in the call. At the annual meeting each Parish or Mission is entitled to one vote by a delegation representing that

Parish or Mission. At any meeting upon request any question may be voted upon by Parishes, each Parish or Mission having one vote.

Article 11.—Pledges.

At the annual meeting Parish pledges shall be made to enable this Branch to meet its obligations for Diocesan and general Missions.

Article 12.—Assessments.

Each Parish and Mission in the Diocese shall be assessed annually for the current expenses of this Branch a sum apportioned in accordance with the number of its communicants. Those having 100 Communicants or less, to pay \$1.00; those having over 100 and less than 300, \$2.00. All over 300 and less than 500, \$3.00, and those having over 500, \$4.00.

Article 13.—Elections and Appointments.

The President, the Vice-Presidents, the Recording Secretary, the Corresponding Secretary, the Treasurer and the United Offering Treasurer shall be elected by the body at the annual meeting. The Secretary of the Junior Auxiliary, the Secretary of the Little Helpers, the Secretary of the Altar Department, the Correspondent of the Church Periodical Club, the Educational Secretary, and the Secretary of the "Spirit of Missions" shall be appointed by the President.

Article 14.—Rules of Order.

In all meetings of this Branch Roberts' "Rules of Order" shall be the authority on parliamentary law.

Article 15.—Amendments.

This Constitution, with the approval of the Bishop, may be amended or revised by a two-thirds vote at the annual meeting, at least one month's notice of the proposed amendment or revision having been given to each Parish and Mission in the Diocese.
