**MINUTES OF THE THIRTEENTH ANNUAL
MEETING OF THE WOMAN'S
AUXILIARY.**

On Wednesday, May 11th, at 9 o'clock, the thirteenth annual meeting of the Diocesan Branch to the Board of Missions convened in the Church of the Incarnation, Dallas. The Rector, Rev. Jas. T. Lodge, celebrated the Holy Communion.

Meeting was called to order by the Vice President, Mrs. Ramage, the President being absent owing to the illness of her husband; she remembered us with appropriate words of greeting.

After the Auxiliary prayer, the Secretary read the minutes of the last meeting, and, with slight corrections, they were approved.

Eight branches responded to roll call, which was two more than last year.

Instead of the usual President's address, the chair gave us thirteen points of interest for the help of the Auxiliary, as follows:

1. The help the Branches have received from the Woman's Auxiliary Department in St. Andrew's Call.

2. Our first duty is to raise the three hundred dollars asked by the General Board. Of the one hundred thousand, our part is three hundred, our Juniors is fifty, and our Babies, twenty-five.

3. Our last united offering was \$414. At least \$500 should be sent to Cincinnati.

4. Each Branch should have a Junior Auxiliary in its Parish.

5. Also a Baby's Branch.

6. St. Andrew's Sunday School, Fort Worth, presents for general adoption its Missionary Plan. See Call, February, 1910.

7. Each Branch should establish a Branch in the nearest Parish or Mission that now has none, during this

year, and see that a delegate comes to the next annual meeting.

8. A delegate from this Diocesan Branch is expected to attend the Seventh Missionary Department meeting in St. Louis next January.

9. The Prayer League is commended.

10. Last year's special in the Diocese was for Mineral Wells. This year our General Missionary will ask for help in his work.

11. A well ordered Parish Branch has its full share in the following: (1) Apportionment for General Missions. (2) United Offering. (3) Diocesan Missions. (4) Bishop Garrett Scholarship in St. Mary's College, and (5) Dues to the Diocesan Branch, (6) Specials within and without the Diocese.

12. Hospital Sunday—Thirteenth Sunday after Trinity—See that it is announced in due time in your Parish or Mission.

13. Continue our united study of Missions. The Committee in charge has done excellent work and has been reappointed.

Reports from the Corresponding Secretary, Treasurer and Diocesan Treasurer of the United Offering were read and filed. Librarian of the Church Periodical Club reported not many encouraging replies from circulars sent out. There were numbers of ladies who pledged their support for the following year. The motion was adopted to have a librarian appointed from each branch.

It was moved to have a Finance Committee appointed to pro-rate the \$300 asked for General Missions from our Diocesan Branch. Mrs. Free, Mrs. Roswell and Mrs. Robinson were appointed as the committee.

The chairman of the Educational Committee reported good work done by most of the branches, study including Brazil, Mexico, Porto Rico and Cuba. The same committee of last year was appointed. For the following year's study course, "Church Work Among the Mountaineers of the South" was adopted.

A very interesting and prosperous report was read from the All Saints' Hospital, Fort Worth. It still needs the loyal support of all the parishes. The Thirteenth

Sunday after Trinity will be observed as Hospital Sunday.

Mrs. W. T. Burch, business manager of St. Andrew's Call, made an offer to one woman in each branch half of every subscription she paid in for the paper, and suggested that every Parish and Mission have a representative of this paper.

Mrs. Robinson moved that the council be requested to suggest to the clergy the adoption of the Duplex System for offerings, consisting of perforated envelopes in two parts—marked for us—for others.

The offerings of the morning's session were \$8.45, divided as usual between the Church Periodical Club and the Church Mission Publishing Company.

Adjourned for luncheon at 1 o'clock.

At 2 p. m. meeting was called to order. The chair introduced Rev. Mr. Berry, General Missionary, who gave an outline of his work, and places that needed immediate help, asking the Auxiliary for its support. The Auxiliary pledged \$200 for a mission at Spurr, to be raised at once by each active member giving one dollar.

Miss Taft, General Secretary for the Y. W. C. A., formerly Secretary of the Juniors Auxiliary of the Dioceses of Ohio, gave us a very interesting talk on Mission work.

Mrs. Ramage and Mrs. Free were elected as delegates and Mrs. Wallace and Mrs. Berry as alternates to the triennial meeting in October.

Mrs. Wallace moved that five cents be added to the regular dues of each member to help defray the delegates' expenses to the triennial meeting. Carried.

For the lack of time, the papers selected by the Educational Committee were omitted.

Mrs. Harper and Mrs. Davis were appointed as a committee to see to the publishing of the Annual Report.

Mrs. Robinson and Mrs. Neblett were chosen as two to attend the Seventh Missionary Conference meeting, to be held in St. Louis.

Meeting adjourned to attend a reception at St. Mary's.

Meeting called to order the morning of 12th at 10 o'clock.

Report from the Babies' Branch was read.

The Treasurer further reported receipts from Miss Emery for \$252.35 for our apportionment

Treasurer requested to notify Miss Emery of same and to have Treasurer's report read from September to September.

Each branch was requested to send names of their two delegates to Mrs. Wallace in time for the annual meeting.

Corresponding Secretary was instructed to send a copy of the Annual Report to the colored school in Lawrenceville, Va.

Two days have been decided on for our annual meeting, opening on the afternoon of the opening day of the Council. Two delegates and two alternates are to be sent, two votes being allowed for each branch.

A cordial vote of thanks was extended the women of the Church of the Incarnation for their hospitality.

Meeting adjourned.
