CONSTITUTION OF WOMAN'S AUXILIARY DIOCESE OF DALLAS

1. This branch shall be known as the Dallas Diocesan Branch of the Woman's Auxiliary to the Board of Missions.

2. Its purpose shall be to forward in every possible way within the diocese the interests and plans of the Board of Missions.

3. Its membership shall be composed of the parish branches within the diocese.

4. Its officers shall be a president, first and second vice presidents, corresponding and recording secretaries, treasurer, United Offering treasurer, educational secretary, librarian of Church Periodical Club, and secretary of the Spirit of Missions.

5. The president shall call meetings and preside over them, and with the other officers shall plan the affairs of the branch. She shall serve as Chairman of a Committee on the Devotional Life of the Branch.

6. The first vice president, in the absence of the president, shall perform her duties, and shall act as chairman of a Committee on Section B of the Woman's Auxiliary.

7. The junior president, elected by the Junior Auxiliary, by virtue of her office, becomes second vice-president and in the absence of the president and first vice president shall perform the duties of the president. She shall act as chairman of a Committee on Junior Work.

8. The corresponding secretary shall give notice of all meetings, and shall conduct the general correspondence of the branch. She shall serve as chairman of an Extension Committee.

9. The recording secretary shall keep the list of Parish Branches, the minutes of all meetings of the branch, and aid the corresponding secretary as such help may be needed.

10. The treasurer shall receive all moneys for the expenses of the branch and pay such bills as are endorsed by the president. She shall receive and forward all moneys given to redeem pledges made by the diocesan branches, and shall present an itemized statement of receipts and disbursements at the annual meeting of the branch. She shall serve as chairman of a Committee on Finance.

11. The United Offering treasurer shall furnish the women of the parishes with United Offering boxes and leaflets, and bring to their attention in other ways the purposes of the United Offering. She shall keep a list of the contributors, and make semi-annual collections and put

these amounts at interest. Each year she shall render a report of the progress of the offering, and each third year make it ready, with accumulated interest, for presentation at the Triennial Service of the Woman's Auxiliary. She shall serve as chairman of a Committee on the United Offering.

12. The educational secretary shall prepare herself for the training of parish leaders of study classes. She shall seek out one or more such leaders in every parish or mission, and personally, or by correspondence, train them for their work. She shall cooperate with the Educational Department of the Board of Missions; and each year follow, as far as she may be able, the study courses presented by them. She shall serve as chairman of a Committee on Missionary Information.

13. The librarian of the Church periodical Club shall endeavor to interest all women in the distributing of literature in the Mission field. She shall keep a record of the magazines and periodicals sent out and report the same at the meeting of the branch.

14. The secretary of The Spirit of Missions shall keep a list of subscribers in the Diocese, shall receive reports from each parish and mission as to the number of their subscriptions annually, and shall use every possible effort to have the magazine placed in every home in the Diocese. She shall keep constantly before the church women especially the wonderful advantages this magazine affords in all departments of church work.

15. Annual dues of \$2.50 shall be collected from each Branch, and they are also expected to contribute annually to the Delegate's Expense Fund.

16. After each Triennial the Constitution shall be read and acted upon at the first annual meeting of the Branches and amendments and changes may be made by a two-thirds majority vote.

MINUTES OF THE TWENTY-FIRST ANNUAL MEETING OF THE WOMAN'S AUXILIARY.

After the beautiful and impressive Communion Service at St. Matthew's Cathedral, Tuesday morning, with Bishop Moore as celebrant, assisted by Dean Ray, the Auxiliary repaired to Synod Hall, where the Council was organized. Bishop Moore's address in which he gave a most interesting account of his present and prospective work, was greatly enjoyed by all present.

At one o'clock luncheon was served, and at two o'clock

the Woman's Auxiliary was formally opened with prayer at the Woman's Room of the Parish House, by Dean Ray.

After the roll call, and reading and approval of the minutes of the previous meeting, Mesdames Belsterling and Loughborough were appointed to write to Mrs. Stevenson, expressing the sorrow and sympathy of the Auxiliary in her recent bereavement.

Mrs. Herring, the president, then read a most beautiful and forceful letter from Miss Lindley, in which she spoke most encouragingly of our Mission and War Work, begged us to put first things first, and "Be strong, my daughters, and valiant men."

Great emphasis was laid upon prayer, which was the keynote of the whole meeting.

Sixteen branches responded to roll call, and a new branch at Decatur, with three members, was reported. It was decided to make no change in the time and place of the Annual Auxiliary Meeting, and gratifying to know that women of our own communion are leading in war work.

The Rev. Charles Pardee, secretary of the Church Building Fund, which was organized 37 years ago and has aided many parishes in securing churches and parish houses that would otherwise have gone without gave an interesting account of the organization. This fund gives away annually \$35,000.00, the maximum gift being \$1,000, and loans are made at 5 per cent interest.

When Mrs. Wallace announced that Mrs. Atwill would again make her home in Dallas next fall there was great pleasure expressed at her return.

Miss Russ, the second vice president and Junior president, gave a fine report, in which she stated that there are twelve Junior branches, including two new ones, and a box sent to Indian Missions at Christmas valued at \$60.00.

The annual meeting being held this year at St. Andrews, Fort Worth, on June 11.

Mrs. W. J. Lawther, the educational secretary, gave a most interesting account of her work, and asked all the branches to answer the following questions, and send the answers to her:

1st. What sort of educational material is most needed in your diocese?

2nd. In what ways can the educational department at the Church Missions House be of help to you?

Miss Howard, the corresponding secretary, thanked the branches for their prompt replies to the questionnaire and letters recently sent out, which greatly aided her in her

work, and also gave a delightful account of the Synod at Oklahoma City, in January, where Mrs. Lawther and herself were delegates.

Miss Rice, the treasurer, reported total receipts from May 1917, to January, 1918, \$940.77; also Denton Fund \$225.35. Most branches being in sound financial condition. The greatest increase being in the Incarnation branch. It was decided to blot out the small deficit on scholarships by dividing it among the branches which had not previously given toward it.

Mrs. Loughborough the United Offering treasurer, in her splendid report, stated \$218.85 for the September offering and \$320.54 for the May offering, and total of \$895.40. Special mention of her untiring efforts and remarkable success were spoken of by the president.

Mrs. McCutcheon, the diocesan secretary of the Spirit of Missions, reported Mineral Wells six regular subscriptions, and one new one; Cleburne five subscriptions; Incarnation fourteen renewals. She spoke most humbly of her office, which she thought should be abolished, but it was decided her valuable assistance could not be dispensed with. Her report would have been much fuller had not many secretaries failed to report new subscriptions and renewals to her.

Mrs. Belsterling, the librarian of the Church Periodical Club, reported many magazines and periodicals sent to various army camps, Alaska and other places; and asked that current literature and no stale magazines be sent. The collection amounted to \$10.35, to be equally divided between the Magazine Club, and the Church Periodical Club.

Mrs. Belsterling also spoke of St. Matthew's Home for aged women, and showed the photographs of the two Bishops taken the day of Bishop Moore's consecration. The net proceeds of these pictures was given to the home, and \$26.00 was realized from them.

The Pilgrimage of Prayer was observed in nearly all parishes and was a great source of help and comfort notwithstanding the warm season, and many of the clergy being on their vacation. Great sorrow was warmly expressed at the death of our beloved co-worker, dear Mrs. Robert Gibson, one of the foremost of our Auxiliary members, and the following resolutions were drawn up, to be sent to her family and recorded in the minutes.

Whereas, God in His infinite power and wisdom has seen fit to take from His Church on Earth unto His Church in Paradise the soul of his most devoted servant.

And whereas, our sense of loss and desolation at this meeting without her familiar presence and wise and devout direction, is only compensated by our knowledge that she is now enjoying the reward that can only come of a devout life, fully lived.

And whereas, it is meet and fitting that the sorrow of this Woman's Auxiliary be expressed to her bereaved family and sorrowing friends.

Therefore, be it resolved that we now and here express the love we hold for her person, the deference we had for her wisdom, the admiration we possessed for her character.

It shall long remain an inspiration to have known one so fixed in her opinion of right and wrong, and so steadfast in the right, so unselfish of her time, of her energies and her substance, and so unobtrusive in her works of righteousness. The characteristics mark the life of Mrs. Robert Gibson, whose light shone upon us in the years of her age, whose passage is but a benediction, and whose death is but a resurrection.

May light eternal shine upon her, and may her life long cast a benediction upon all who knew her.

Mesdames Herring and Wallace were elected delegates, and Peyton and Datson alternates to the synod meeting at Waco in October. Mrs. Loughborough read the United Offering Catechism, which has been published in leaflet form for distribution. It throws much needed light upon our well beloved "Blue Box."

A letter of warm appreciation was received from the beneficiary of the Alexander C. Garrett Scholarship at Seawane, and was greatly appreciated by the Auxiliary.

The United Offering service was held at the Cathedral Wednesday, at nine o'clock, Dean Ray being the celebrant, assisted by the Rev. H. G. Hennessy. Immediately following this service we repaired to the parish house where unfinished business from the previous day was resumed.

A report from All Saints Hospital, Fort Worth, stated the hospital to be in splendid financial condition and hoped to be free from debt soon, also four boxes of linen highly appreciated, received from different branches. The splendid report from St. Barnabas Mission, Denton, filled us all with enthusiasm, and we hope the much needed church will

soon be a reality. A guild has already been formed, and an auxiliary branch will be started soon.

Bishop Moore has made two visitations to Denton recently and is much enthused over the field there.

At twelve o'clock noon day prayers were said by Dean Ray, including the prayer for our soldiers.

About 12:30 luncheon was served at the Oriental Hotel and at two o'clock the Auxiliary and Council met in joint session at Synod Hall.

Subject, "Co-operation in our Work for Diocesan Missions."

The chairman being the Rev. Charles Clingman, and the speakers, Mrs. Herring, Mr. Offenhauser, the Rev. H. G. Hennessy and Bishop Garrett. The closest attention was paid to each and every address, so much enjoyed by all.

At 3:30 the Auxiliary again took its place in the Woman's Room of the Parish House, where Capt. Godolphin gave an interesting address concerning his life at Camp Bowie.

Bishop Moore also spoke to us on Missions, and wishes all to help and co-operate with him in his many enterprises. He is trying to work out his plan of circuits and urges us to "keep our heads cool, and hearts warm." He also urged us to try to reach individuals for Diocesan Missions, and hopes to have a pledge for Denton.

Mr. Hennessy again spoke of the Diocesan paper which he is anxious to see circulated, urging that we give the same our earnest moral support. In this as in all previous addresses, "Co-operation" was the keynote of them all.

A letter of appreciation from Dean Carrington concerning the St. Mary's scholarship was read. He urged the continuance of this work.

PLEDGES FOR MAY, 1918, TO MAY, 1919

A motion was made and carried that the "Junior Lantern" was to be at the disposal of Bishop Moore in his work and that any improvements on the lantern were to be paid for out of the "Extension Fund."

All were very happy to hear the telegram read from their former president, Mrs. Atwill.

Mr. Eckel of St. Andrew's spoke to the Juniors and showed them how each one had their part in the great work of the church just as the men in the country's service have their many duties in the making of our great national army.

In his address, Mr. Datson of Trinity said no matter how small our gifts, they would be multiplied if they were given in Christ's name.

The box for the Emerald Hodgsan Hospital, Sewanee, Tennessee, was valued at \$93.20.

It was voted to send a Diocesan Christmas box again. The secretary will notify us where the box is most needed.

As a result of St. Matthew's Sunday school winning the Trinity Banner three years in succession, it now belongs to them. Bishop Moore offered a new banner to be given to the Sunday school making the largest Lenten offering per capita. This banner is to be presented at the Junior meeting, no Sunday school ever holding it for their own, except for the year of their winning it.

The president appointed the following committee to interest the Sunday school to work for this banner and to get the reports of the offering—Mr. Eckel, Miss Rice, Mrs. Wigely.

At one o'clock the meeting adjourned for lunch, which was enjoyed by all.

At two o'clock the meeting was called to order again.

It was voted that the 1919 hospital box be sent to All Saints Hospital, Fort Worth.

We were glad to hear Mr. Boswell, superintendent of St. Andrew's Sunday school, speak a few words of welcome to us.

Bishop Moore talked to us on the importance of Junior Work and asked that we renew, especially, our Diocesan Special and Junior Extension Fund. He also asked for a new pledge—the Denton Emergency Fund—a fund to be used at his discretion in furthering the work at Denton. He told us that the "Diocesan Special" would be used im-

mediately to purchase a communion service for some mission in the Diocese.

Mrs. Belsterling explained about the Church Periodical Club and asked the Juniors to help in this part of the work.

After a rising vote of thanks to St. Andrew's for their kindness and hospitality, the meeting adjourned.

From 3 o'clock to 5:30 all enjoyed an auto ride to Camp Bowie and the aviation fields.

Mrs. Clingan resigned July 1st. Mrs. Tomlinson appointed to fill her place.
