

Purpose:

1. To understand what each Society is trying to do and how each may coöperate in a united call to service through the Church.
2. To lay out a 5 Fold Plan of service concerning the work of the whole Church for all women of the Parish.
3. To devise ways and means of enlisting every woman in the Parish to take some part in this plan.

NOTE - This chart represents an imaginary Parish. A real unit of the League would include the existing Parish Societies for women and older girls (not in the Church School Service League.) Where there is only one group of women, the 5 Fold Plan of service makes the basis of a unit of the League.

MINUTES  
of the  
TWENTY-FOURTH ANNUAL MEETING  
of  
THE WOMAN'S AUXILIARY

The Twenty-fourth Annual Meeting of the Woman's Auxiliary, held at the Church of the Holy Cross, Paris, was opened by the President immediately following Holy Communion, celebrated by the Bishop Coadjutor.

After the reading of the minutes Miss Rice, Diocesan Treasurer, explained that our expenses exceeded the amount taken in from annual dues, and moved that dues be raised from two fifty (\$2.50) to three fifty (\$3.50.) The motion was carried.

Branches then responded to roll call by reading of reports and payment of dues. Committee reports followed.

Mrs. J. T. Roundtree, United Offering Treasurer read a splendid report, showing an amount almost double that of the last report. She laid emphasis on the fact, however, that we must doubly increase our efforts for the coming year, as word has come from Miss Lindley that the mark set for the United Offering in 1922 is one million dollars.

The President read a letter from Rev. Louis Lopps on his missionary work in Wisconsin. This was of special interest as the Auxiliary in this Diocese sent boxes of clothing to Rev. Lopps and his family last year.

The matter of taking action on the Shepherd-Towner Bill was next brought up. A motion was carried to the effect that action on this bill be referred to the women as members of clubs but no action be taken by the Auxiliary.

An appeal was read by Mrs. Hennessey for two thousand (\$2,000) dollars per year for three years from the Seventh Province, for the support of a medical missionary in Nopala, New Mexico. Two hundred twenty-eight (\$228) dollars per year for three years would be required from the Dallas Diocese, and a motion was carried to pledge that amount by the Branches.

Now followed a most interesting and instructive ad-

dress by Bishop Partridge on the missionary needs and opportunities in China.

Miss Rice read a letter concerning pledges and instructions for making them from Chas. A. Thompkins, Assistant Treasurer to the Presiding Bishop and Council.

A telegram was read from the President of the Woman's Auxiliary of the Diocese of Texas, in council at Houston, extending best wishes. A motion was carried to acknowledge same and extend greetings in reply. Also a resolution was adopted that a telegram be sent to our beloved Bishop Garrett, from the Auxiliary in session in Paris.

A committee consisting of Mrs. Chapman, Mrs. Herring, Mrs. Lawther and Mrs. Eckel was appointed to confer with the Bishop in regard to the Sewanee Scholarship Fund.

Archdeacon Verdon then told of splendid work being done by the women at Ranger and Eastland, and at the request of the President held noon-day prayers for missions.

The Auxiliary then adjourned for luncheon.

Afternoon business session was resumed at 3:30, following a joint meeting in the Parish House in regard to St. Mary's College.

A fine report of the work at All Saints Hospital was read by Mrs. Bevan, President of the Board of Trustees. Charity work amounting to eight thousand (\$8,000) dollars was done in 1920. The great need for the annex was stressed and the Hospital is looking forward to owning its own laundry and artesian well. The co-operation and help of all branches is earnestly desired.

A report from the diocesan Secretary of the Spirit of Missions was read. Also a report from the Corresponding Secretary, Mrs. A. L. Bussey, was read. The resignation of this secretary accompanied the report, and the motion was carried that the President be allowed to appoint a successor at her discretion.

Mrs. Biller, National Organization Secretary, now spoke on the work of the Woman's Auxiliary and Church Service League. The three fundamental principles for which the work stands are:

Sanctity of the Home,  
Dignity of the State,  
Glory of the Church.

Stress was laid upon the importance of building devotional home life, also church and church school attendance.

Following this the Extension Fund was explained. This is a fund to defray traveling expenses of the President and Educational Secretary in the Diocese, and a motion was carried to include this in the list of pledges in the journal.

The resignation of Mrs. Birge as Librarian of the Church Periodical Club accompanied her report and Mrs. Griffith of Terrell was elected.

Tuesday morning session was opened with a talk by Bishop Moore, explaining the necessity of organizing a Diocesan Council of the Church Service League. This Council to be composed of one representative on Religious Education, one on Social Service and one on General Guild Work and three members each from the Auxiliary, Daughters of the King and Girl's Friendly Society.

The first three representatives were appointed by the Bishop as follows: Mrs. W. A. Smith, Deaconess Affleck, and Mrs. Fred Newman.

The Auxiliary and Daughters of the King appointed their representatives, and the Council elected the following officers:

President—Mrs. W. A. Smith.

Secretary—Mrs. J. T. Rountree.

Treasurer—Mrs. W. J. Lawther.

A resolution introduced by Mrs. Lawther was adopted in regard to the Sewanee Scholarship Fund. This action placed six hundred (\$600) dollars now on hand for this fund at the disposal of the Bishop for the assistance of Mr. Zeigler to complete his ecclesiastical studies.

Mrs. Herring now spoke concerning the Emery fund. This is to be a thank offering from the Woman's Auxiliary throughout the United States. It will be gathered during this year and presented to the Presiding Bishop and Council as a trust fund to be known as the "Emery Fund" in grateful appreciation of what the three Emery sisters have meant to the Auxiliary during its fifty years of existence. The income from the fund will be used for missionaries at home on furlough for board, medical care, study or recreation. It is hoped that every member of the Auxiliary will have her share in this fund.

Pledges were handed in by the delegates to the chairman of the committee on Dispatch of Business.

Miss Rice now read her treasurer's report, which was adopted.

Deaconess Emily N. Ridgeley, who is supported in Foreign Mission fields by the Daughters of the King, now gave a most interesting and helpful talk on her work in China.

A resolution introduced by Mrs. Ellis was adopted to change the name of the Alaskan Scholarship to the Hudson Stuck Memorial Scholarship in Alaska.

Dean Lathrop of New York, Secretary of the Department of Christian Social Service, gave a short address on the Social Service Problems of the Church.

The president appointed Mrs. George Bruce Fuller of Wichita Falls, for Diocesan Box Secretary.

Mrs. Eckel now offered a resolution of thanks to the Paris Branch for their splendid hospitality.

An invitation was extended by St. Matthews Cathedral Branch of Dallas for the annual meeting at the time of the Diocesan Council in January, 1922.

There being no further business the meeting was closed with prayers by Rev. Hennessey.
