CONSTITUTION OF WOMAN'S AUXILIARY
DIOCESE OF DALLAS

1. This branch shall be known as the Dallas Diocesan Branch of the Woman's Auxiliary to the Board of Missions.
2. Its purpose shall be to forward in every possible way within the diocese the interests and plans of the Board of Missions.
3. Its membership shall be composed of the parish branches within the diocese.
4. Its officers shall be a president, first and second vice-presidents, corresponding and recording secretaries, treasurer, United Offering treasurer, educational secretary, librarian of Church Periodical Club, and secretary of the Spirit of Missions.
5. The president shall call meetings and preside over them, and with the other officers shall plan the affairs of the branch. She shall serve as chairman of a Committee on the Devotional Life of the Branch.
6. The first vice-president, in the absence of the president, shall perform her duties, and shall act as chairman of a Committee on Section B of the Woman's Auxiliary.
7. The junior president, elected by the Junior Auxiliary, by virtue of her office, becomes second vice-president, and, in the absence of the president and first vice-president, shall perform the duties of the president. She shall act as chairman of a Committee on Junior Work.
8. The corresponding secretary shall give notice of all meetings, and shall conduct the general correspondence of the branch. She shall serve as chairman of an Extension Committee.
9. The recording secretary shall keep the list of parish branches, the minutes of all meetings of the branch, and aid the corresponding secretary as such help may be needed.
10. The treasurer shall receive all moneys for the expenses of the branch and pay such bills as are endorsed by the president. She shall receive and forward all moneys given to redeem pledges made by the diocesan branches, and shall present an itemized statement of receipts and disbursements at the annual meeting of the branch. She shall serve as chairman of a Committee on Finance.

11. The United Offering treasurer shall furnish the women of the parishes with United Offering boxes and leaflets and bring to their attention in other ways the purposes of the United Offering. She shall keep a list of the contributors, and make semi-annual collections and put these amounts at interest. Each year she shall render a report of the progress of the offering, and each third year make it ready, with accumulated interest, for presentation at the Triennial Service of the Woman's Auxiliary. She shall serve as chairman of a Committee on the United Offering.

12. The educational secretary shall prepare herself for the training of parish leaders of study classes. She shall seek out one or more such leaders in every parish or mission, and personally, or by correspondence, train them for their work. She shall co-operate with the Educational Department of the Board of Missions, and each year follow, as far as she may be able, the study courses presented by them. She shall serve as chairman of a Committee on Missionary Information.

13. The librarian of the Church Periodical Club shall endeavor to interest all women in the distributing of literature in the Mission field. She shall keep a record of the magazines and periodicals sent out and report the same at the meeting of the branch.

14. The secretary of the Spirit of Missions shall keep a list of subscribers in the diocese, shall receive reports from each parish and mission as to the number of their subscriptions annually, and shall use every possible effort to have the magazine placed in every home in the diocese. She shall keep constantly before the church women especially the wonderful advantages this magazine affords in all departments of church work.

15. Annual dues of \$3.50 shall be collected from each branch, and they are also expected to contribute annually to the Delegate's Expense Fund, and to the Extension Fund, which is a fund to defray traveling expenses of the president and educational secretary in the diocese.

MINUTES
of the
TWENTY-FIFTH ANNUAL MEETING
of
THE WOMAN'S AUXILIARY

The Twenty-fifth Annual Meeting of the Woman's Auxiliary, held at St. Matthew's Cathedral, Dallas, was opened by the President immediately following Holy Communion, celebrated by the Bishop Coadjutor Rev. Harry T. Moore, assisted by Father Smith.

The Corresponding Secretary, Mrs. Paul Welch, read a letter of resignation from Mrs. May Vance Whitley, former Recording Secretary. It was moved that the resignation be accepted with regrets, and that the President appoint a Recording Secretary. The motion carried and Mrs. Albert H. Bevan was appointed Recording Secretary.

After the reading of the minutes the Corresponding Secretary read a telegram from Miss Lindley, stating Miss Emery died January 10th, 1922. The President reported having answered this telegram and that she also sent wreath in the name of the Woman's Auxiliary of the Diocese of Dallas.

Mrs. Herring made a motion that resolutions be sent on the death of Miss Emery. Mrs. Hennessey seconded the motion. The motion was carried. Mrs. Hennessey was appointed Chairman of committee for drawing up resolutions on Miss Emery's death, her committee being Mrs. Wm. Belsterling, Mrs. W. A. Smith and Mrs. Thatcher.

Resolutions: "Whereas, it has come to the knowledge of this meeting of the Woman's Auxiliary of the Diocese of Dallas that during the present session Miss Julia C. Emery, who was practically the founder of this organization, and has spent a lifetime devoting her great talents, industry and love to its well-being, has passed from this painful life to her reward. Now, therefore, be it resolved that this meeting rather than express its regret that a life well spent has ended, that it thank the Maker of all things that in his divine providence that he gave such a life and inspiration to the world whose foundation will for all time bear fruit in this organization, and that we be given renewed power to build to the glory of God and the salvation of men."

Officers then responded to roll call by reading of reports, and Branches reports followed.

Miss Elnora Rice, Diocesan Treasurer, made her financial report and moved that her report be adopted. The motion was carried.

It was suggested by the President that the Corresponding Secretary send Mrs. Griffith, Librarian of Church Periodical

Club a letter of cheer in her illness. The President suggested that the Corresponding Secretary also send Mrs. Armstead Brooks, Educational Secretary a telegram of congratulation on the birth of her new son.

An appeal was made by Mrs. T. M. Cox, Diocesan Secretary of the Spirit of Missions to the Auxiliary to co-operate still more in the spread of the Spirit of Missions.

Mrs. Herring read a letter of greeting from Miss Emery to the Auxiliary.

The President reported that Mr. Zeigler, Candidate for Holy Orders from the Diocese of Dallas, has been transferred to the Diocese of South Texas.

After Mrs. Fuller, former Box Secretary, read her report, she read a letter from Mr. Partrige of California thanking the Woman's Auxiliary for the lovely box sent them at Christmas time.

The Recording Secretary then read a letter of resignation as Box Secretary from Mrs. Fuller. Mrs. Van Hook moved that resignation be accepted and appreciation of Mrs. Fuller's work be conveyed by a rising vote of thanks. The motion was carried.

Mrs. Herring nominated Mrs. Wood of St. Andrew's, Dallas, for Diocesan Box Secretary. Mrs. Wood was unanimously elected.

With deep regret the Auxiliary learned of the deaths of five faithful workers during the year: Mrs. J. G. McCaskey, Trinity Church, Fort Worth; Mrs. Elizabeth S. Malley, Trinity Church, Fort Worth; Mrs. Lombardy, St. Matthew's, Dallas; Mrs. Elizabeth Pool Allan, and Mrs. Dora Witherspoon of St. John's, Corsicana.

A speech of Greeting was made by Bishop Coadjutor Rev. Harry T. Moore at the end of which he introduced Mrs. Loring Clark of Chattanooga, Tenn. Mrs. Clark spoke very briefly of the box work of the Auxiliary.

Mrs. Lawther moved that the Box Secretary add fifteen dollars as express charges to each assessment for box quota. Miss Rice reported a bill of \$12.64 for express on Box Work. Mrs. Fuller volunteered donation to cover bill. This was accepted with thanks.

The Corresponding Secretary read a letter to the President from Miss Eva D. Corey relative to the place women should take in the legislative body of the Church. Mrs. Clark was asked to speak on the subject. Motion was made and carried that the women go on record as being unfavorable to the election of women as representatives in the legislative bodies of the Church.

Mrs. Clark was asked to speak to the Auxiliary on the subject, which she most ably did, explaining her views to the ladies. Motion was then made and carried that the women go on record as being unfavorable to the election of women as representatives in the legislative bodies of the church.

It was moved that the bill for flowers sent for Miss Emery be paid immediately, each branch assuming equal part of the debt. The motion was carried.

The Corresponding Secretary read a letter from Mrs. Ames in regard to her work as our provincial representative of the Seventh Province.

The Corresponding Secretary read a letter from Bishop Moore concerning the Institute in the diocese. Mrs. Herring moved that we try to arrange for an institute in the fall. Mrs. Marshall seconded the motion and the motion was carried. The Auxiliary accepted Dallas as place for the institute, the Church of the Incarnation extending their hospitality to entertain the delegates at that time.

The Corresponding Secretary read a letter from Miss Grace Lindley about women in Japan asking hearty co-operation of the Auxiliary.

Mrs. Wm. Belsterling read the resolutions on the death of Mr. Wm. B. Robinson, one of the most earnest and faithful workers in the Church for years.

Resolutions: "Whereas, the news of the death of William B. Robinson, long member of this Diocese, has been flashed to this meeting now in session. And, whereas, though he was not a member of this organization, his sanctity of life, liberality in giving, and steadfastness of purpose have been an example to us and to his family that has added largely to our work and accomplishment. Now therefore, be it resolved that the sorrow of the Woman's Auxiliary now in council assembled be expressed, and that a copy of this resolution be spread upon the minutes of this meeting and copies be sent to the members of his family."

A motion was made and carried that the Treasurer be authorized to send sum of Sewanee scholarship to be used for some young man in the ministry since we have no candidate in this diocese. The Treasurer reported a deficit of \$40.00 in the Dr. Macey Pledge. She suggested that the Extension Fund of about thirty-five or forty dollars be used, or that each branch assume their part to pay. Mrs. Chapman reported a deficit on Scholarship of Sewanee of \$25.00, also a small deficit on Hudson Stuck Memorial Fund.

Mrs. Clark suggested that mimeographed copies of the minutes of the Triennial be sent to each branch.

Delegates as follows were elected to attend the Triennial: Mrs. J. D. Covert, Mrs. J. T. Rountree, Mrs. J. S. Herring, Mrs. S. W. Marshall, and Mrs. W. A. Smith. The Alternates were: Mrs. H. G. Hennessey, Mrs. F. T. Datson, Mrs. Johnston, Mrs. Weary, and Mrs. T. G. Knight.

Tepashana* An excellent report of All Saints Hospital was read by Mrs. Knight, Secretary of the Board of Trustees. One hundred and seven (107) free patients were admitted to the Hospital during the year and the actual cost of this charity work was over four thousand (\$4,000.00) dollars. The institution is practically self-sustaining, but lacks capital for expansion. The pressing need for an Annex was emphasized with the hope that the interest and practical sympathy of our church people may be aroused in giving material assistance in this vital work. Mrs. Knight moved that her report be adopted. The motion was carried.

A rising vote of thanks was given the women of St. Matthew's Cathedral for their hospitality and lovely entertainment shown the delegates during the meeting.

There being no further business the meeting was closed with prayer by the President.

OUR PROVINCIAL PLEDGE.

The following resolution was adopted at the Synod meeting of the Woman's Auxiliaries of the Province of the Southwest held at Waco in October, 1920, at which ten of the eleven diocesan and district branches were represented:

"Resolved, that the Woman's Auxiliaries of the Southwest pledge, for a period of three years, 1921, 1922, and 1923, the sum of \$2,000.000 annually to the support of the Medical Missionary in charge of the House of Hope, Nopala, Mexico, the physician being Dr. Macy. Be it further

"Resolved, that this pledge be apportioned among the four District Branches and seven Diocesan Branches of the Province by a committee of three to be appointed by the presiding officer of this meeting; that the Executive Boards of the four District Branches and the seven Diocesan Branches apportion the Diocesan Pledge among the parish branches; that the District and Diocesan Treasurers remit payment in the usual manner, to Mr. Lewis B. Franklin, and that notice of such remittance be made to the Secretary-Treasurer of our Provincial Branch."

The Secretary-Treasurer of the W. A. of the S. W. Province reported that Dr. Macy had been transferred to Zamboango, P. I., and the above pledge is to continue as "Dr. Macy's salary" by action taken at the meeting in St. Louis this year. It is desired that every parish and mission assist by contributions as generally as possible, AS IT WILL APPLY ON THE QUOTA, being a "designated contribution." The contribution should be sent by the parish or mission treasurer of the Auxiliary, to the Auxiliary Diocesan Treasurer, who remits to the Diocesan N. W. C. treasurer who in turn forwards the gift to Mr. Lewis B. Franklin at the national headquarters.

Our share toward this pledge is \$228.50. The Diocesan Treasurer reported a deficit of \$40.00 for 1921. Can we not make this up.
