MINUTES
OF THE
Twenty-Sixth Annual Meeting

The Twenty-Sixth Annual Meeting of the Woman's Auxiliary, held at St. Andrews, Fort Worth, was opened by the President immediately following Holy Communion celebrated by Bishop Coadjutor Harry T. Moore, assisted by the Rev. C. B. La Bagh.

After the reading of the minutes, the President asked Rev. C. E. Snowden to speak to the ladies concerning pledges in the diocese that applied on quota and concerning Foreign Life Insurance. Mr. Snowden very ably explained these subjects.

The President then appointed nominating committee for the election of Diocesan Officers for the Auxiliary. This committee consisted of Mrs. Herring, Mrs. Eckel, and Mrs. Rountree.

The branches then responded to roll call with payment of dues and reports of branches followed.

Mrs. Emmon Rolfe moved that Mrs. Lawther be sent to Graham as a missionary in answer to a personal appeal for aid from Mrs. L. A. Porter of that city. Many responses in the way of money, linens, and altar fixtures were made to this call from Graham.

The Delegates then responded to roll call by reading of reports. All reports were accepted and approved with the exception of the report of the Secretary of the Spirit of Missions, which was held until afternoon session for approval, at which time it was accepted.

Mrs. Wood, Diocesan Box Secretary, read a letter of commendation from Bishop Moore for the box sent to the Tubercular Hospital in Tuscon, Arizona, by the Auxiliary. Mrs. Wood read also a letter of thanks for this box from Dr. Edward C. Clark, in charge of the hospital.

Mrs. Wood then read a letter from Mrs. Frances B. Baldwin of Middlesboro, Ky., thanking the Auxiliary for the lovely box sent at Christmas time.

Mrs. Wood then read from Mrs. Gertrude Gray, Secretary of the Province of the Southwest, a letter of congratulation on the manner in which the Auxiliary in this diocese has carried on its supply work.

Mrs. Wood was given a rising vote of thanks and appreciation for her work during the past year.

Mrs. Lawther moved that annual dues in addition to covering printing of annual reports also cover the assessment of twenty dollars a year for three years to be used for hotel expenses of the national representative to the National Executive Board Meetings, the apportionment for each branch to be determined by the executive board. This motion was carried.

Mrs. Griffith moved that resolutions be drafted on the deaths of all members during the past year. The President appointed Mrs. Rolfe, Mrs. Smith, and Mrs. McCurry to serve on this committee.

Resolutions: Whereas, God has removed from the realm of human existence to the rest of Paradise five women of the working force of the Woman's Auxiliary. And, whereas, this body has sustained a loss in their passing. Be it resolved, that the names of Mrs. Bertha Dollahyte Grinnan, Terrell; Mrs. Laura B. Seaman, Greenville; Mrs. R. E. L. Miller, Mineral Wells; Mrs. A. J. Townsend, Commerce; Miss Florence Meyers, Trinity, Fort Worth, be recorded upon the memorial page of our Diocesan Annual Report, and that our heart-felt sympathy be tendered the branches where they worked, and through them to the families of our former co-workers.

The Recording Secretary read the Constitution and Mrs. McCurry moved that the Constitution be placed in the hands of a committee for revision. The motion was carried and Mrs. C. K. Lee, Mrs. Newman, Mrs. Boswell and Mrs. Marshall were appointed to serve on this committee.

The Corresponding Secretary read a letter of resignation from Mrs. Hennessy. Mrs. Cox moved that the Secretary be instructed to write a letter to Mrs. Hennessy expressing the appreciation of the Auxiliary for her work with us, and conveying the regrets of this organization that she leaves this diocese. The motion was carried.

The Corresponding Secretary read two letters from Bishop Moore concerning the Sewanee Scholarship, and reply thereto from Miss Rice.

The Corresponding Secretary read a letter from Dean C. K. Benedict regarding Rev. Milton J. Swift's application for entering The University of the South.

The Corresponding Secretary read a letter from Mr. Finney, Vice Chancellor of the University of the South, acknowledging receipt of check for Mr. Swift.

The Corresponding Secretary read a letter from Miss Lindley expressing the need of a Church Women's Rest Home called the Emery Memorial Home, a house for training deaconesses, and for women missionaries on furlough.

Mrs. Griffith moved that the body go into executive session for election of officers. The motion was carried.

Mrs. Griffith moved that Mrs. Herring appoint a Parliamentarian and a Corresponding Secretary. The motion was carried. Mrs. Herring appointed Mrs. E. H. Eckel as Parliamentarian, and Mrs. C. M. Alexander as Corresponding Secretary.

Mrs. Cox moved that the ladies of St. Andrews be given a rising vote of thanks for the lovely hospitality shown the delegates during the Council. Mrs. Griffith made an amendment to this motion in that all ladies in Fort Worth who assisted in the entertainment of the delegates be included in this vote. The amendment was accepted and the motion was carried.

Mrs. J. H. Bevan, President of the Board of Trustees of All Saints Hospital, read a wonderful report on the work done during the past year by this institution. She emphasized the need of capital for expansion, and the need of young women in the different parishes in the Diocese to enter the training school for nurses. Mrs. Bevan moved that her report be accepted. The motion was carried.

Mrs. Griffith moved that Bishop Garrett be sent a telegram of appreciation for his beautiful inspiration at the opening of the Council. The motion was carried.

Mrs. Griffith moved that the retiring officers be given a rising vote of thanks. The motion was carried.

The Committee on the Revision of the Constitution then made their report. It was moved that the revised Constitution be accepted. The motion was carried.

Miss Rice moved that pledges be handed to her in writing instead of orally. The motion was carried.

Mrs. Lawther announced that Miss Tillotson would hold an Institute next November in Dallas and asked that the ladies attend.

After prayer by Bishop Moore, there being no further business, the meeting adjourned.

CONSTITUTION OF WOMAN'S AUXILIARY DIOCESE OF DALLAS

1. This branch shall be known as the Dallas Diocesan Branch of the Woman's Auxiliary to the National Council.
2. Its purpose shall be to forward in every possible way within the diocese the interests and plans of the National Council.
3. Its membership shall be composed of the parish branches within the diocese.
4. Its officers shall be a president, first and second vice-president, corresponding and recording secretaries, treasurer, United Thank Offering treasurer, educational secretary, librarian of Church Periodical Club, secretary of the Spirit of Missions, supply secretary, and parliamentarian.
5. The president shall call meetings and preside over them, and with the other officers shall plan the affairs of the branch. She shall serve as chairman of a Committee on the Devotional Life of the Branch.
6. The first vice-president, in the absence of the president, shall perform her duties.
7. The corresponding secretary shall give notice of all meetings, and shall conduct the general correspondence of the branch.
8. The recording secretary shall keep the list of parish branches, the minutes of all meetings of the branch, and aid the corresponding secretary as such help may be needed.

9. The treasurer shall receive all moneys for the expenses of the branch and pay such bills as are endorsed by the president. She shall receive and forward all moneys given to redeem pledges made by the diocesan branches, and shall present an itemized statement of receipts and disbursements at the annual meeting of the branch. She shall serve as chairman of a Committee on Finance.

10. The United Thank Offering Treasurer shall furnish the Women of the parishes with United Offering boxes and leaflets, and bring to their attention in other ways the purposes of the United Offering. She shall keep a list of the contributors, and make semi-annual collections and put these amounts at interest. Each year she shall render a report of the progress of the offering, and each third year make it ready, with accumulated interest, for presentation at the Triennial Service of the Woman's Auxiliary. She shall serve as chairman of a Committee on the United Offering.

11. The Educational secretary shall prepare herself for the training of parish leaders of study classes. She shall seek out one or more such leaders in every parish or mission, and personally, or by correspondence, train them for their work. She shall co-operate with the Educational Department of the Board of Missions, and each year follow, as far as she may be able, the study courses presented by them. She shall serve as chairman of a Committee on Missionary Information.

12. The librarian of the Church Periodical Club shall endeavor to interest all women in the distributing of literature in the Mission field. She shall keep a record of the magazines and periodicals sent out and report the same at the meetings of the branch.

13. The secretary of the Spirit of Missions shall keep a list of subscribers in the diocese, shall receive reports from each parish and mission as to the number of their subscriptions annually, and shall use every possible effort to have the magazine placed in every home in the diocese. She shall keep constantly before the church women especially the wonderful advantages this magazine affords in all departments of church work.

14. Each branch shall pay annual dues to provide funds for printing of journal and for the expenses incurred by Provincial Representative on National Executive Board. (2) Such dues shall be determined by the Diocesan Executive Board.

15. The Constitution and by-laws may be amended at a regular meeting of the Diocesan Executive Board by two-thirds vote of those present.
