

Presiding Bishop and National Council

At 2:00 P. M., Tuesday, February 8th, 1927, at St. Andrew's Church, Fort Worth, Texas, the annual meeting of the Auxiliary was opened by a Quiet Hour conducted by the Reverend Goodrich R. Fenner, of Christ Church, Oak Cliff. His message on "Intercessory Prayer" was beneficial to all present.

REPORT OF EDUCATIONAL SECRETARY

Mrs. H. G. Lucas

Of the thirty-eight branches of the Woman's Auxiliary of the Diocese all but five report some kind of educational work. Some have conducted regular discussion groups with each person having a text-book; some have less intensive study and discussion groups; some have had program meetings with papers or informal talks;

some have had addresses by returned missionaries or travelers; some have answered roll-call with Bible quotations or items of missionary interest; some have had reading during the meetings; and some have had only an occasional program or talk on some phase of the Church's Mission. Ten branches report definite Bible study, and, as last year's Lenten study is included in the period reported on we find the text-book "That Freedom" most frequently used, nine branches reporting it. Five branches have already started on this year's text "Beyond City Limits," three studied "The World and I"; two, "My Father's Business"; one, Lenten articles in "The Witness"; one, "Peace"; and a number, the "Spirit of Missions," the Church's Program, and the Church.

Your Secretary has found the interest displayed in educational work and the requests for information and help most gratifying. During Lent she sent to each branch suggestions about study and other information from headquarters, and in the fall again sent to each branch suggestions about the year's work. In addition she has written forty-five other letters about various phases of the work, and three articles for the Woman's Auxiliary Page of "The Diocese of Dallas." She took advantage of the Woman's Auxiliary study course at the Summer Conference and of the Provincial Educational Conference at Tulsa. At the Provincial Synod at Tulsa she led the W. A. Conference at the Joint Session on Rural Work. She attended, besides her own District Meetings, two others, those at Waxahachie and Cleburne and has visited five other branches in the interest of the work.

There are four suggestions she would like to make:

1. Study the Text-book for the year, "Beyond City Limits."
2. Have your educational leader or some other interested person attend the entire course at the Summer School.
3. Do not be satisfied with reaching only your own Auxiliary members with your educational work, but endeavor, by interesting programs and the like, to interest others of your Parish.
4. Remember that in study, we are loving and worshipping God "with our minds."

District No. 3 Meets

The first meeting of District No. 3 of the Woman's Auxiliary of the Diocese of Dallas met at the Church of the Holy Cross, Paris, on October 6. The District is composed of the following places: Trinity, Bonham; Christ Church, Clarksville; Epiphany, Commerce; St. Luke's, Denison; St. Paul's, Greenville; St. Mark's, Honey Grove; Holy Cross, Paris; St. Stephen's, Sherman; St. Phillip's, Sulphur Springs; St. James', Texarkana. Denison, Paris, Sherman, Texarkana and Bonham had delegates at the meeting.

At 10 o'clock there was a celebration of the Holy Communion. The Rev. Mr. Smith celebrated, assisted by the Rev. Mr. Sidders. Immediately following the celebration the meeting was called to order by Mrs. Rountree.

Mrs. W. J. Lawther was first on the program, speaking to the women on "The Message." She emphasized the fact that "The Message" was to guide the spiritual life of the women for the next three years, and that it was a process for the awakening of the women of the church. She also stressed the importance of personal dedication and explained to the women what was meant by a prayer-partner, suggesting that each branch take up this phase of the work.

Mrs. J. H. Meyers spoke briefly on the United Thank Offering and asked that all branches have their fall offering to her by October 10th. Mrs. Rountree offered suggestions of means by which the offering may be increased.

The morning session was closed with noon-day prayers led by the Rev. Mr. Harris.

Delegates were taken to the Hotel Gibraltar for luncheon. Before luncheon the Doxology was sung, after which the Rev. Mr. Dobbins said the blessing.

After lunch the meeting was called to order by Mrs. Rountree. At this time Bishop Moore spoke to the women, saying that the watchword was their responsibility to the church, which is the same everywhere, in the mission and in the largest parish. He reminded the women that this responsibility carried with it the

privilege of being a member of the church. He also spoke of the young men of the diocese now studying for the ministry, and expressed the hope that in a year or so the Auxiliary would be able to sponsor another Educational Scholarship.

Mrs. Wood spoke on the box work, explaining the method in which the box work is carried on at New York and also in our own Diocese. She told the meeting that before our Diocesan boxes leave, Bishop Moore comes to her home and offers a prayer for the senders and receivers. She urged that the spring box work be hand work and that it be taken as our Lenten work. She suggested that each branch get in communication with the missionary to whom their box is to be sent and that we get in more personal touch with these people. She also read parts of letters from different missionaries.

Mrs. McCurry opened her talk to the Auxiliary with a quotation from Dean Chalmers on money. She gave a review of pledges for 1926, urged a better knowledge of the pledges and suggested that we back the Nation Wide Campaign in their work. Mrs. McCurry also spoke on the Gold and Silver offering which is to be used to rebuild St. Margaret's in Japan. She stated that in nineteen Dioceses \$70,000 had been raised through this offering. She displayed the collection which she has received.

Mrs. M. G. Smith spoke about the Spirit of Missions and the Church Periodical Club, emphasizing the great value of the magazine.

Mrs. Lawther spoke on the Corporate Gift. The amount this Diocese will try to raise within the next three years is \$500. The proceeds of the Corporate Gift will go to several places designated by the New York office.

There was a short general discussion of the plans and problems of the different branches, after which the Bishop closed the meeting with prayers.

Report District Number Four, Corsicana

This district is composed of St. John's, Corsicana; St. Mary's, Hillsboro; St. Alban's, Hubbard and St. Paul's, Waxahachie.

St. John's, Corsicana, has two branches of the Auxiliary, making a total of five branches for our District. Some of the things accomplished by the District Meetings are: first, they give opportunity for those women who cannot attend annual meetings to become acquainted with the Diocesan officers and through them to have more intimate touch with the work of the Auxiliary, thus a better understanding of it; second, fellowship is engendered; third, the informality of these meetings gives opportunity for free discussion; fourth, a quickening of the sense of responsibility and a desire to extend the work.

These are some of the things noted. At our District Meeting in Waxahachie, only two of the five branches were represented, owing to the weather. Report of District Number Five, Brownwood

District No. 5 has had two meetings, one in the spring and one in the fall. The first was at Brownwood, with an attendance of 40, representing the churches at Hamilton and Brownwood and visitors, the Hamilton people driving the 60 miles over and 60 back under bad weather conditions. It was opened by Communion Service at the church, followed by luncheon and meetings at the Country Club. The Bishop, our Diocesan President, Mrs. Lawther, and Miss Russ of the Department of Religious Education made us happy by their presence and inspired us with their addresses.

A feature of the fall meeting at Hamilton was the attendance of the men and young people, in fact it was a "family affair." The Bishop, assisted by the Rev. Mr. Power of Brownwood, celebrated the Holy Communion and addressed a crowd that filled the pretty little church. All regreted greatly the absence because of continued sickness of the Rev. Mr. LaBagh. Dinner was served to more than 60 people at the beautiful and hospitable home of the W. A. Moores, and the men said if they could be assured of such delicious repast there would be no trouble about the attendance of the men at the District meetings. One of the Brownwood men made a short talk during the dinner and the men then adjourned to the lawn for an informal meeting while the women had their afternoon session. We were delighted that we had with us besides the Bishop, Mrs. Lawther, Mrs. Herring, Mrs. Wood, and Miss Russ, each of whom made most interesting talks and led in informal discussions. Incidentally, this Sunday morning service was the only Communion Service the Hamilton people have been able to have during the winter.

We feel that these District Meetings are of inestimable value, especially to the more distant parts of the Diocese, as they afford practically the only opportunity most of the church people have of coming in contact with Diocesan officers and others outside their own Parish. They broaden us by giving us an insight into some of the National and Diocesan questions and make us feel a real part of the big General Church. They inspire us with the feeling of fellowship and sense of unity and make our own problems seem less formidable by getting together and bringing different viewpoints to bear and so realizing that our difficulties are not peculiar to one locality.

As a direct result of the Brownwood meeting Branch B, Brownwood was organized. After the Hamilton meeting Mrs. Herring and Miss Russ visited Stephenville and started a branch there, though there is no church. We hope that before long the Dublin Guild will decide to affiliate.
