At 2:00 p. m., Wednesday, January 30, 1929, at St. Matthew's Cathedral Parish House, Dallas, Texas, the Thirty-second Annual Meeting of the Woman's Auxiliary was opened by the First Vice President, Mrs. J. S. Herring, in the absence of the President, Mrs. W. J. Lawther, who was called to the bedside of her father who was seriously ill.

The following Greeting from our absent President was read:
My Dear Auxiliary Women:

Through Mrs. Herring I want to welcome you to this, the Thirty-second Annual Meeting of the Woman's Auxiliary in the Diocese of Dallas.

I am grateful to each of you for having made possible the accomplishment of a splendid year's work. You have all worked hard, but I know there is not one woman among you but who has considered it a privilege to have had a share in the work.

We are told so often that Missionary effort is the outcome of the valuing of one's own privilege in Our Blessed Lord's Kingdom. Your work has shown that you firmly believe this because you have put into action the belief that the Woman's Auxiliary's privilege is to help the mind, the body, the soul of man. You have not tried to escape service, because you have learned that in order to bear our own burdens, we have to help others in the bearing of theirs.

To the Diocesan Officers I am exceedingly grateful. They have co-operated and helped in every way. It is difficult to single out any one, but a few I want to mention by name. Mrs. Wood has done her work under the greatest handicap. She has been ill since last summer, but even her physical suffering did not prevent the work being done in her splendid way. Mrs. Belsterling also worked under the handicap of recuperating from a serious operation, but it never once dimmed the happiness she took in the work. Mrs. Warren has had a great sorrow, and Mrs. Newman has had much illness.

As you know Mrs. Thorne resigned as Treasurer last June. I did not get any one to succeed her until August. Mrs. Malcom, because she was an enthusiastic Auxiliary worker,

as well as a very dear personal friend of mine, came to my rescue and offered to take the books off my hand. She is excellent with figures, and has been the greatest help in the work, and I cannot adequately express my gratitude to her. Whatever confusion and mistakes arose, please lay the blame on me, as she acted under my instructions each time.

Whatever suggestions you have please make them, as it will be much easier for your incoming Board to act.

I bespeak for them the same splendid and willing co-operation you have always given your present Board.

An offering was taken up for the Church Publishing Co., and the Church Periodical Club.

Mrs. Herring gave the Auxiliary a splendid talk on the Extension of the Kingdom of God and stressed upon all members that they foster the work of Evangelism.

Motion was made and carried that all funds go to our Diocesan Treasurer, so that this Auxiliary would get credit for all pledges from this Diocese.

Motion made and carried to have a discussion on pledges at the first of the meeting, even if it necessitated tabling Parish Reports.

Motion made and carried that an Official Pledge Sheet be mailed out with Report Blanks, with amounts needed for each Pledge on this sheet.

Mrs. Eckel, of the Committee for the Revision of the Canons made the following report:

Article 4 shall read "It's officers shall be a President, First, Second, and Third Vice Presidents, Corresponding and Recording Secretaries, Treasurer, Educational Secretary, Director of Church Periodical Club, Secretary of the Spirit of Missions, Supply Secretary and Parliamentarian. These Officers to be elected in the year previous to the General Convention."

Article 10 shall have inserted after the words "shall make semi-annual collections" "on Maundy Thursday and St. Luke's Day, October 18th."

These revisions were adopted as recommended.

A communication was read from the Rev. Mr. Salmon of the Church of the Resurrection, asking for help in organizing an Auxiliary. The following Committee was appointed to co-operate in this work: Mrs. J. H. Myers, Mrs. Wm. Belsterling and Mrs. R. H. Steger.

Minutes of this meeting were read and approved and after Benediction by the Rev. Mr. Garner of Terrell, the meeting adjourned.

REPORT OF EDUCATIONAL SECRETARY.

As I come to the end of my three year's term as your Educational Secretary, I wish to tell you what a pleasure this has been, for you have given me such splendid co-operation and have seemed so interested in our work. As is always the case with the leader of a program, I feel I have gained a great deal more than I have given.

Since there has been a yearly report, I shall not attempt to summarize the three years, but give a report of only the past year.

An increasing number of branches are having regular study and programs, devoting at least part of the time at from one to three meetings a month to educational work; some have weekly study during Lent also. A good majority are studying or are planning to study the text-book of the year, *The New Africa*. Other subjects studied were the Bible, Prayer Book, Spirit of Missions, Building the City of God, Our Church Carrying Out Her Commission.

A new departure was the getting up and the printing of a year book of programs, which has seemed to prove helpful. A copy was

sent to each branch together with suggestions for leaders about references and materials. Eight branches ordered copies of the year book for each member and a total of 151 copies were sold at a nominal cost which helped defray the cost of printing.

In the Fall information about the Day of Intercession during General Convention was sent to each branch.

In addition, during the year, I have written 59 letters, mostly in answer to inquiries, and sent material and books in 11 instances.

One disappointment was that the rather extensive trip planned for Deaconess Pitcher had to be called off because of her illness. However, she did visit several places, which were inspired, I know, by her earnestness and her interesting account of her work in China.

In June, at the request of the Secretary for College Work of the National Department of Religious Education I attended at Hollister, Missouri, one of the 10 Regional Conferences of the Student Y. W. C. A. and Y. M. C. A. It was a most interesting and inspiring experience and brought to me a deep personal realization of the great importance of the Student work, a phase of our Church's work which attracted a great deal of attention at General Convention.

From Hollister I went as a guest of the Diocese of Missouri to their Summer Conference at Columbia, Missouri.

Later, while in Minneapolis, I spent a day with the Diocesan Educational Secretary of Minnesota, and attended with her two sessions of the Minnesota State School of Missions (Interdenominational).

In October, as you know, I had the honor of seeing one of your delegates to the Triennial. So you see I have had some varied and most worth-while educational privileges.

At General Convention it was wonderful to see the great interest taken in the Study Classes. 47 courses were offered and every class was filled to overflowing, with a total enrollment of nearly 3,000. Our own Dean Chalmers was dean of this "Training Institute."

In fact, throughout the whole convention I was impressed with the stress laid on educational work. "Inform the people of the facts, and there will be little trouble in getting them to work and give."

If we are guided by the resolutions passed at the Triennial the scope of our educational work is greatly enlarged. It is to be more than informing the women of the Auxiliary about all phases of the Church's work, we are also to help educate and inform all the women of the Church, the young people and the men; moreover we are to "help educate public opinion" on matters tending towards bringing about the Kingdom of God on earth. If you would be informed of the tremendous field for educational work, read again your Diocesan President's splendid report of the Convention, and also get a copy of the "Minutes of the Triennial," which may be obtained from the Church Missions House, 281 Fourth Avenue, New York, at 10c a copy.

REPORT OF SPIRIT OF MISSIONS

In 1927 there were 220 Subscriptions.

In 1928 there were 273 Subscriptions, as follows:

**CONSTITUTION OF WOMAN'S AUXILIARY
DIOCESE OF DALLAS**

1. This Branch shall be known as the Dallas Diocesan Branch of the Woman's Auxiliary to the National Council.

2. Its purpose shall be to forward in every way possible within the Diocese, the interests and plans of the National Council.

3. Its membership shall be composed of the Parish Branches within the Diocese.

4. Its Officers shall be a President, First, Second and Third Vice Presidents, Corresponding and Recording Secretaries, Treasurer, United Offering Treasurer, Educational Secretary, Director of Church Periodical Club, Secretary of the Spirit of Missions, Supply Secretary and Parliamentarian.

5. The President shall call meetings, preside over them, and with the other Officers, shall plan the affairs of the Branch. She shall serve as Chairman of a Committee on the Devotional Life of the Branch.

6. The First Vice President, in the absence of the President, shall perform her duties.

7. The Corresponding Secretary shall give notice of all meetings and shall conduct the general correspondence of the Branch.

8. The Recording Secretary shall keep the list of Parish Branches, the minutes of all meetings of the Branch, and aid the Corresponding Secretary as such help may be needed.

9. The Treasurer shall receive all moneys for the expenses of the Branch, and pay such bills as are endorsed by the President. She shall receive and forward all moneys given to redeem pledges made by the Diocesan Branches, and shall present an itemized statement of receipts and disbursements at the annual meeting of the Branch. She shall serve as Chairman of a Committee on Finance.

10. The United Thank Offering Treasurer shall furnish the women of the Parishes with United Offering Boxes and leaflets, and bring to their attention in other ways, the purposes of the United Offering. She shall keep a list of the contributors, and make semi-annual collections on Maundy Thursday and Saint Luke's Day, October 18th, and put these amounts at interest. Each year she shall render a report of the progress of the offering, and each third year make it ready, with accumulated interest, for presentation at the Triennial Service of the Woman's Auxiliary. She shall serve as Chairman of a Committee on the United Offering.

11. The Educational Secretary shall prepare herself for the training of Parish leaders of study classes. She shall seek out one

or more such leaders in every Parish or Mission, and personally, or by correspondence, train them for their work. She shall co-operate with the Educational Department of the Board of Missions, and each year, follow as far as she may be able, the study courses presented by them. She shall serve as Chairman of a Committee on Missionary Information.

12. The Director of the Church Periodical Club shall endeavor to interest all women in the distributing of literature in the Mission field. She shall keep a record of the magazines and periodicals sent out and report the same at the meetings of the Branch.

13. The Secretary of the Spirit of Missions shall keep a list of subscribers in the Diocese, shall receive reports from each Parish and Mission, as to the number of their subscriptions annually, and shall use every possible effort to have the magazine placed in every home in the Diocese. She shall keep constantly before the Church women especially, the wonderful advantages this magazine affords in all departments of Church work.

14. Each Branch shall pay Annual Dues to provide funds for printing of the Journal and for the expenses incurred by Provincial Representatives on National Executive Board. Such dues shall be determined by the Diocesan Executive Board.

15. The Constitution and By-Laws may be amended at a regular meeting of the Diocesan Executive Board by two-thirds vote of those present.
