PRESIDING BISHOP AND NATIONAL COUNCIL

The Thirty-fifth Annual Meeting of the Woman's Auxiliary convened on January 27th, 1932, at 2 o'clock, P. M. at St. Matthews Cathedral.

The meeting was called to order by Mrs. H. G. Lucas, President and was opened with prayer by Dean Wood, who gave the Devotional and an inspiring message in which he said that the fundamental requirement for everyone today is a sense of union with God and that this sense of union could be found nowhere more definitely than in a devotion to the Holy Eucharist, the broken body and the shed blood of Christ, where we feed on the food of immortality. He charged the members of the Woman's Auxiliary to let 1932 be known as the Eucharistic year and to go back home and see and experience Jesus and the results would be amazing.

Twenty-five branches responded to Roll Call with one hundred and thirteen delegates and visitors present.

The minutes of the Executive Board Meeting held October 26th, 1931, were read and approved.

Mrs. Lucas called attention to the Exhibits and asked that everyone be sure to look at them.

Following this announcement, Mrs. Lucas, President, gave her report and delivered the President's message. She stated that she had traveled 3,190 miles in the Diocese the past year and had contacted 27 branches, which included every branch in the Diocese but three. She represented the Diocese of Dallas at the General Convention in Denver as Chairman of the Findings Committee of Property and Economic Conditions. She also substituted for Mrs. J. C. Tolman at the Summer Conference, teaching the Woman's Auxiliary course. She announced that Incarnation, Dallas and Good Shepherd, Wichita Falls now have only one organization of women in the church known as the Woman's Auxiliary, all groups working in the church as chapters of the Auxiliary.

Esther Brown, U. T. O. worker among the negroes, from the National Council, was introduced and gave a very interesting outline of her work. She urged that the white woman keep in closer touch with the negro branches and see that they were taught more about the work of the Woman's Auxiliary so that they would understand it more thoroughly. She also asked that we keep them in mind the next Tri-ennial and help to send a negro delegate, if they needed assistance.

Mary Elizabeth Hunt, who has charge of the kindergarten and Day Nursery in our colored mission, the Church of the Resurrection gave a

report of her work, showing that she had accomplished a great deal with limited means. A collection was taken up for the colored Day Nursery amounting to \$33.50, which was given to Mrs. Hunt.

Reports were called for from the officers of the Diocese.

The President, Mrs. H. G. Lucas, included her report in her message, which she gave at the beginning of the meeting.

First Vice-President, Mrs. W. J. Lawther, gave no report.

Second Vice-President, Mrs. J. S. Herring, report later as Diocesan Extension Chairman.

Third Vice-President, Mrs. J. R. Boswell gave no report.

Recording Secretary, Mrs. Jas. G. Oakley gave no report.

Corresponding Secretary, Mrs. J. E. Moore reported that she had written thirty-three letters during the year.

Treasurer, Mrs. J. T. Rountree gave a detailed report of the finances of the Auxiliary for the year, stating that she had a balance in bank of \$251.75. Mrs. Rountree stated that some of the new branches had been confused as to when their dues and pledges were due and that she had receive dsome money since she had closed her report. She asked permission to return her report the following day with these amounts added. The request was granted.

Educational Secretary, Mrs. Earnest May reported that 19 branches out of the 30 active branches had studied last year's text on India. Twenty branches have started or definitely planned to study this year's text book, "Building a Christian Nation."

United Thank Offering Treasurer, Mrs. B. A. Fowler reported that she had taken \$2,311.00 to the Tri-ennial in September and since then she had received \$115.69 more. The total amount given from the Diocese of Dallas for the three years amounted to \$8,254.33.

The meeting adjourned promptly at 4 o'clock P. M., when the officers, delegates and visitors were entertained at tea at the home of Mrs. Walter Sistrunk on St. Andrew's Drive, to reconvene at 9 A. M., January 28th.

The Second session of the convention opened at 9 o'clock A. M., Jan. 28th, at St. Matthew's Cathedral with the annual corporate communion, Bishop Moore was celebrant. The offering at this service went for the United Thank Offering.

The business session opened at 10 A. M. with Mrs. Lucas, the President, presiding. The minutes were read and approved.

Bishop Moore addressed the body, commending the President for her many visits and the women for their splendid work in the Auxiliary in the past year. He said again, as he has said before, how much assistance to him the Woman's Auxiliary was and how he could always depend on them to do the work they had set out to do. The fact that the space that had been assigned to them as a meeting place had proven to be so inadequate that they had to meet in the church building was significant of their interest in their work, he said. It proved to him that there was no depression in the Woman's Auxiliary, and the Bishop said that this fact should go down on the records.

The reports of the Officers were continued.

Supply Box Secretary, Mrs. W. A. Porter, gave a splendid report of the box work done the past year, telling where each box was sent. The amount spent being \$1,537.02; the balance in bank being \$50.13. She stated she had written 250 letters and thanked the branches for the splendid co-operation.

Assistant Supply Secretary, Mrs. A. B. Wood, gave no report.

Spirit of Missions Secretary, Mrs. C. E. Roberts, reported a total of 248 subscriptions to the Spirit of Missions in the Diocese, 18 of these subscriptions being given as Christmas Gifts from the Supt. of one of the Church Schools in the Diocese to his teachers. She recommended this plan for everyone, saying that if we carried it out, the number of magazines being read in the Diocese would increase greatly and so many more of our people would be informed about our work in the mission fields.

Church Periodical Club Director, Mrs. J. F. Rennie reported that Dallas had contributed 100% to the Library Fund and that some of the other branches had given to this fund, also. She stated that she had written 124 letters, 10 cards and had attended 5 District Meetings.

Mrs. Lucas read a very interesting report of the Committee on Devotionals, saying that there had been 178 Corporate Communion, 8 prayer groups and 15 branches used the World Day of Prayer.

The reports from the committees on Missions, Christian Social Service, Religious Education, Diocesan Extension, Enlistment and Training, Publicity and Promotion were laid on the table.

The Treasurer reported that there was about \$313.00 in the bank that had been given for Advance Work in the Diocese. As the Diocese has no Advance Work program at present, the National Council advised that this money could be used toward completing a dormitory for small girls in Anvik, Alaska, if we desired to spend it in that way. A motion made by Mrs. Lawther that we send \$300.00 of this money for this purpose was carried. A motion made by Mrs. W. D. Bratton that we give the remaining amount to the Provincial Pledge was also carried and the Treasurer was instructed to send the money as voted.

Mrs. Lucas next introduced Mrs. D. D. Taber, National Field Secretary, who gave a very interesting and instructive talk. She suggested that Vice-Presidents might do splendid work as heads of different Departments. The plan of doing our work through the departments and making a special study of the particular departments was suggested as probably the best and most satisfactory arrangement. She urged all who possibly could to go to the Leadership Training Institute to be held in Waco in March. There will be five national officers there and it will be a meeting extremely instructive and worthwhile. She also urged that we turn our thoughts and interest toward the student work and pledge to the Student Workers Fund. The students of today are the church leaders of tomorrow, and the strength of the church in the future lies in our ability to keep the young people in touch with Christ.

Mrs. Lawther presented the following resolution which was adopted.

Whereas—We have heard from Mrs. Taber of the value of Offering of Life Committee, through which we can further the work of the Church by training students, and

Whereas—Our Diocese is not undertaking an Advance Project this year, and

Whereas—There is no longer a St. Mary's College,

Therefore be it resolved, that we merge the two pledges the Corporate Gift for Advance Work and the Bishop Garrett Scholarship at St. Mary's into a fund to be used in helping students, especially those who are considering the Church as a vocation, and furthermore, we recommend that this fund be called The Bishop Garrett Student Fund.

The Reverend W. Brooke Stabler was next introduced by Mrs. Lucas. Rev. Stabler is the National Secretary for College Work and gave a most inspiring address. He called attention to the fact that while the population had increased 78% over a period of fifty years, the college student increase was 450%. There is only about 1 1-6% of the population of our country Episcopalian, but 6% of the students in the important colleges of the country are Episcopalian. There are forty thousand of our young people in the colleges in the United States. Often there is no one to meet them. It is the hope of the Church to place a student worker or a minister in all colleges, thereby helping to keep the feet of our young people in the King's Highway.

Miss Baldwin, Student worker at C. I. A., Denton spoke next of her work at the school. She said the work done is a continuation of the Religious Education begun in the Church School. They meet on Sunday evenings at the Y. W. C. A. for worship, programs and social half-hour. They have monthly Corporate Communion.

Miss Rachel Sumners, Sec. of Young People's Work in the Diocese, told of the young people's work and of the student work that had been done at S. M. U. She introduced Eddie Thompson, Diocesan President of Y. P. F. who gave a talk on the work done in the Fellowship. Miss Sumners displayed a replica of the Fellowship pin beautifully carved in wood by Rev. Beesley of Mineral Wells, to be used as a yearly award to the Fellowship doing the best work.

Mrs. Agnes B. Bonnell, Supt. of St. Matthew's Home gave a report of her year's work done there. She told of a day's routine in the Home, of some of the needs of the little children and of some of the problems confronting her from time to time.

The meeting adjourned, and the noonday prayers were read by the Rev. Edward S. Barlow.

Lunch was served at 12:30 by the ladies of St. Matthew's Cathedral. Immediately after lunch the Group Conferences were held in Garrett Hall.

At 2:30 P. M. the afternoon business session opened. The reading of the minutes were dispensed with to make time for other things.

The President asked that all branches observe World Day of Prayer.

Deaconess Smith thanked the Auxiliary for the pledges made for the Retiring Deaconess' Fund.

The President requested that the delegates see that the new pledges were mailed to the Treasurer as soon as possible after they return home.

Mrs. Fowler presented the following resolution, which was adopted.

Whereas—The women of the Church are greatly concerned with the devotions attendant upon Lenten service, and

Whereas—They are particularly engaged during the Holy Week with the hours of devotion and preparation for Easter,

Therefore, it is recommended by the Executive Board that the time for the presentation of the United Thank Offering be changed from Maundy Thursday to Ascension Day.

Mary Elizabeth Hunt presented Richard Jenkins, colored, who is a candidate for the ministry, who spoke to the body of his desire to make good as a minister.

Mrs. Patrick, Diocesan President of Nevada was introduced by Mrs. Herring.

The minister's wives present were next introduced.

Mrs. Lucas offered the Porto Rican Embroidery Exhibit to any branch who thought they could sell some of it.

Mrs. F. M. Mote, a member of the Board of St. Matthew's Home, suggested that anyone wishing to do something in their parish for the Home, might form a Home Fund Club with dues of 25 cents a month per member.

Miss Alice Taylor, Supt. of All Saint's Hospital gave the financial report for the year. She made a most appealing talk on some of the different charity cases that she had taken during the year. She stated they had done 27% more free work last year than ever before.

Mrs. Lucas announced that it had been decided in the President's Conference to ask a representative of the Girl's Friendly Society from the National Council to visit the Diocese to work out a program that would take care of the girls below the teen age, this program to be along the lines of the work done in the Woman's Auxiliary.

The District Presidents were called on to make their reports.

District I, Mrs. R. H. Steger, reported 2 District meetings.

District II, Mrs. J. W. Chenault, reported 1 meeting.

District III, Mrs. Allen Birge, reported 2 meetings.

District IV, Mrs. W. A. Lang, reported 1 meeting.

District V, Mrs. J. E. Moore, reported 2 meetings.

District VI, Mrs. Allison, reported 1 meeting.

The District meetings were reported to be very successful at all places.

Fourteen branch reports were heard, the rest were turned in to the President.

The question was brought before the house as to whether the money collected for the U. T. O. should be kept in Dallas during the period between General Convention or sent to the U. T. O. Department in New York. A motion was made to leave the decision to the Executive Board. The motion carried.

A motion was made to leave the appointment of delegates to the Provincial meeting, to be held in St. Louis in the fall, to the Executive Board. The motion carried.

The Resolutions Committee offered the following resolutions,

Resolved: That the Woman's Auxiliary of the Diocese of Dallas wish to express our sincere appreciation to the clergy and members of the Cathedral Parish and to the Woman's Auxiliary of St. Matthew's for their generous hospitality shown the delegates and visitors to this convention.

Resolved: That we wish to thank Mrs. Sistrunk and the ladies for honoring the delegates and visitors of the Auxiliary with the lovely tea at Mrs. Sistrunk's home, and Mr. Weismann and the choir of St. Matthew's Cathedral for their beautifully rendered musicale.

Resolved: That we wish to extend our appreciation to Mrs. Taber, Rev. Mr. Stabler, Miss Sumners, Miss Baldwin and Miss Brown for their most interesting and instructive talks.

EXECUTIVE BOARD MEETING

Wichita Falls, Texas Oct. 26, 1931.

A meeting of the Executive Board of the Woman's Auxiliary of the Diocese of Dallas was called to order by the President, Mrs. H. G. Lucas, on Oct. 26, 1931, at the Country Club, Wichita Falls, Texas.

It was decided to use the money heretofore pledged to St. Mary's Scholarship to train some young person in the Diocese for church work.

The President stated that it had been customary to pay a \$5.00 fee to belong to the Intre-Racial Commission and as this fee had been taken care of personally by Mrs. Herring in the past, it was decided that henceforth it would be paid from the President's Discretionary Fund.

It was discussed whether or not it would be wise to undertake to pay the expenses of each officer to all board meetings. It was decided that this would take too much money and that it would be better to let each officer assume her own transportation costs.

It was decided that it would be necessary to have at least two board meetings during the year, one in the spring and one in the fall.

Plans were discussed for arranging the program for the Council, which meets in January.

Mrs. Lucas stated that she would have Brooke Stabler, Secretary for College and Young People's work on the National Council as the main speaker and that she would ask Miss Baldwin, the student worker at Denton, to speak.

The branch reports will be called for this year and read on the afternoon of the second day. These reports must be brief and accentuate only the high lights of the years work. Statistics must be left out.

The chairman of all committees will be asked to make a report of their progress during the year.

It was suggested that the matter of considering District Presidents as the Diocesan Vice-Presidents should be gone into and Mrs. Jas. G. Oakley was asked to communicate with other Diocese as to what definite work was assigned to their Vice-Presidents in their Diocese. If this suggestion was found to be practical it was recommended to present it as an amendment before the next General Convention.

At least four districts were thought necessary and the custom for each one attending to pay twenty-five cents for their lunch was advised so that the small parishes could afford to have a district meeting.

The matter of having District meetings regularly was recommended and the District Chairmen were to be notified.

The recommendation to have the United Thank Offering Spring presentation on Ascension Day was accepted. Mrs. Fowler was asked to work out this change.

It was decided that the report of each Executive Board meeting be read at the annual meeting and placed in the year book.

All reports are to be limited and a time-keeper is to be appointed so that no one will speak over their allotted time.

It was recommended that we have a banquet the first night of the Council with a Pageant or camp movies or music, arranged by the Young Peoples Fellowship.

The meeting adjourned to meet again the day before the Council.

Mrs. J. G. Oakley made the motion to send the U. T. O. money immediately to New York on receipt of it, thereby relieving the Diocesan Treasurer of the responsibility of it for three years. The motion carried.

Mrs. Oakley made the motion to allow the President the privilege of appointing the Provincial Delegates to go to St. Louis in the fall. The motion carried.

Mrs. Lucas requested that if any member of the Board knew of any one interested in being a delegate to the Provincial meeting to please advise her.

There being no further business, the meeting adjourned.

PRESIDENT'S REPORT

It is my duty and privilege at this time to give an accounting of my year's work as your Diocesan President. The theme of the President's Conference at the Triennial was "The Job of Being President". It is a real job, but I wish I could impart to every Parish President, Auxiliary member, and yes, to every Churchwoman the realization that comes that being in any way a part of this great organization is a worth-while job, a job, that is worth much more than all the bridge, parties, and other affairs we sometimes have to forego. A worth-while job because we are working for the really worth-while things of life, the spreading of the knowledge of Christ and the extension of the Kingdom of our Lord in every sphere of life, and we are doing this work through the agency established by our Lord Himself, His Church.

It seemed to me that the better we knew each other personally, the better we could work together. I have therefore visited as many Districts and Parishes as possible and have during the past year attended 16 District and Parish meetings, travelling 3,190 miles in the Diocese and have "contacted", as the business men say, at least some of the women in 27 branches—all but 3. Of the letters, telegrams, and long distance telephone calls, I have no accurate record.

It was my privilege as President, to attend the great Triennial at Denver last September. There were 435 delegates to the Auxiliary present from 100 Dioceses and Missionary Districts, and 2,000 women registered, besides the Bishops, clergy and laymen. At our Bishop's Dinner we found there were about 30 men and women present from our Diocese. All

of your other delegates, Mmes. Fowler, May, Porter and Simpson, one alternate, Mrs. Bradford, also attended, as did your Spirit of Missions Secretary, Mrs. Roberts, who also represented you at the C. P. C. Conferences. You have had full reports of the Convention at District and Parish meetings, so we are not taking time for that now, except to remind you that the theme of the Auxiliary was **THE KINGDOMS OF OUR LORD**, which was presented and discussed under the 5 great headings: Family Life, Property and Economic Conditions, Inter-racial Contacts, International Relationships, Religious Thinking Today. These are to be the basis of our study, prayer, and work during the next three years. Your Diocesan Branch had its definite part, as your President was appointed Chairman of "Findings" Committee on Property and Economic Conditions.

As Diocesan President it also devolved on me to substitute for Mrs. Tolman as leader of the two Woman's Auxiliary Courses at our Summer Conference. One very definite result came of this, the securing of Miss Martha Sullenberger of Corsicana to help with the Diocesan Extension work, as Supervisor of the Church Correspondence School. You will hear of her work later, and also that of our Extension Chairman, Mrs. Herring. I bespeak your especial interest as that is a phase of our work I think should be developed this year.

We were fortunate in having one of our National Executive Officers with us for a week last Spring. Her schedule was rather strenuous for her, as she visited 8 places,—Denison, Denton, Wichita Falls, Ft. Worth, Brenckenridge, Brownwood, Corsicana, and Texarkana; but we appreciated her so much we wanted to use her every minute. We are in the midst now of an experiment that, I am sure, will greatly strengthen our work. Mrs. D. D. Taber, National Field Secretary, is in the Diocese for about seven weeks. You will hear Mrs. Taber this afternoon.

In spite of the depression and general feeling of discouragement prevalent, our branch reports show a spirit of progress and optimism. In answer to the question, "Has the past year been one of general progress?" practically all the branches answered, "Yes". A tabulation and analysis of the various reports is most interesting. 12 gave as reasons for progress, "Increased interest and attendance." Our new branch, Hillsboro, of 12 members, reports almost 100% attendance at nearly all meetings. One branch mentioned "activity of all members, splendid co-operation", a point I should like to stress, for Church and Church organizations should be examples of living together in Christ, there is no place for sensitiveness, jealousy, or hard feelings.

Several branches mentioned as reasons for considering it a year of progress that they had met all pledges and several had met and made increased pledges. It is encouraging that in spite of "hard times" Churchwomen are awake to the demands of carrying on the Lord's Kingdom.

Others mentioned growth spiritually and others more study, two most important things, for work and gifts will follow if we pray enough and are informed and so really interested.

Three branches mentioned sponsoring young people's work; two more charity and welfare work; another more calls to sick and strangers.

Answers to the question "What is your objective for next year?" should prove helpful. Several answered, "Get every woman interested in Auxiliary work," another mentioned especially young women and get them to assume responsibility of office; arouse deeper interest, get inactive members interested." Two answered grow more spiritual; two,

more study; more Parish welfare work; clear Church debt; assist on Parish House debt; work towards new Parish House; help meet quota; formation of Junior Auxiliary; fulfill Auxiliary ideal; realize our Church responsibility and endeavor to become more devoted and loyal.

To the question, "What do you think should be the Diocesan Objective for the year?" the answers most frequently given were Paying the Quota, interesting more Churchwomen in the Auxiliary, help with Diocesan missions and rural work. One answer was, "The need of the hour in all organizations is more spirituality;" another mentioned more study; another training of young women for Church work; also more activity in Parish welfare work. Another good suggestion is, "To enlist the interest of every clergyman in the Diocese, and through them presenting the work of the Auxiliary by means of a Sunday morning sermon every year."

As for a summary of the work accomplished and the money given during the past year, your Treasurer will report on the pledges paid; your U. T. O. custodian on the U. T. O.; your Supply Secretary on the box work; your Social Service Chairman on Social Service and Community work; your Educational Secretary on the study.

There remains to be reported a summary of work done in the Parish, and also a report of the Devotional Life, since the Devotional Chairman has moved from the Diocese.

The emphasis on the Devotional Life has grown, most branches report; there has been one Diocesan Corporate Communion, and 178 Parish Corporate Communions. Some branches have weekly Corporate Communions; others, monthly; others only on the Presentations of the U. T. O. There have been 5 quiet days; 8 quiet hours; 16 days of intercession; there are 8 Prayer Groups; 70 persons using the Prayer Leaflet; 249 using Daily Bible Readings.

15 branches observed the World Day of Prayer. This is always the First Friday in Lent and is observed by women of all denominations throughout the world and is one of the things we can do to carry out our Lord's wish "That they may all be one." I hope more of our branches will remember it this year.

The reports on Parish work present varied activities: Purchase of altar flowers, of Communion Bread; making and care of Altar linens and hangings; gift of Vestments to Priest; purchase of electric fan, stove for Parish house, desk for study, various kinds of Church and Parish House furniture and equipment, padding kneeling benches; paying regularly for janitor service; care of Church grounds; payments on Church and Parish House debts; organ fund; serving Parish dinners; giving Christmas and other parties and picnics; visits and flowers to sick, infirm, and bereaved; pay toward keeping old lady in a "home"; visits to strangers; passing on Church papers, devotional books and tracts; college expenses of former acolyte; scholarship for student in Theological Seminary; one branch in addition to payment of own "quota pledges" paid balance due by Church on Quota.

Two of the larger Parishes, Wichita Falls and Incarnation, Dallas, have now only the one woman's organization, the Auxiliary, which meets once a month in a general inspirational meeting and other weeks in small groups; many of the smaller Parishes and Missions have only a "Guild-Auxiliary." If only the clergy and women who are not interested in the Auxiliary, but only in a local "Guild" could hear the various reports at this meeting, I think it would go a long way towards dispelling the old prejudice against the Auxiliary and help bring about the objective and ideal mentioned by many of the branches, "To have every Churchwoman an Auxiliary member."

Almost without exception when we find a strong Auxiliary, we find a strong, live Church. When we find an organization or Church that says, "We have all we can do to keep our own Church going," you can be pretty sure it is not going forward. As followers of our Lord, we cannot be content with saving our own souls, or the soul of our family, or even the souls of those in our town. We are to begin at home, but also go into the wider field.

Have had 2 conferences during the year with Mrs. Capps, Diocesan Extension Chairman.

Have spoken at the District meeting in Corsicana and at the Diocesan officers meeting in Wichita Falls and to the Auxiliary in Hillsboro about the Extension work.

Sent letters to each branch urging co-operation—asked that an Extension Secretary be appointed in each branch, also asked for a contribution for the work. Responses came from 10 branches—4 appointed secretaries, 7 sent contributions, contributions from the following branches—Hillsboro, \$1.00; Graham, \$1.00; Mineral Wells, \$1.00; Corsicana, \$2.00; Waxahachie, \$1.00; Hamilton, \$1.00. The total contribution \$7.00 was sent by me to Mrs. Rountree with the request that she credit the branches and send the money on to Mrs. Capps.

Just before the General Convention I wrote a personal letter to each woman on the list given me by Mrs. Capps and enclosed the leaflet "Seven Weeks of Prayer."

I wrote District presidents when I knew of District Meetings asking them to stress Extension work; also wrote those women nearest the place of meeting urging them to attend.

Sent copies of leaflets about Rural Life Sunday to each branch President near isolated communicants.

ST. MATTHEW'S HOME FOR CHILDREN

The report of the St. Matthew's Home for Children is, briefly, the closing of another successful year of work in our efforts on behalf of the underprivileged children entrusted to our care. We are confident that the year just closed has brought sunshine and happiness into many little hearts; which may otherwise be suffering want and deprivation.

We are deeply grateful for your generous response to our plea for fruits and provisions of all kinds, which were sent to the Home during the Holiday season. Quantities of wholesome and delicious foods were received, including some 375 quarts of home canned fruits, which have aided us very materially in providing the children with nourishing foods at a minimum of expense.

One of the accomplishments of the past year, to which we point with pride, is our success in securing the services, as Superintendent of the Home, of a trained and cultured woman, the wife of an Episcopal Clergyman, who has spent the greater portion of her life in working among children. The atmosphere of the Home, under her guidance, is more that of a church school than of a home for underprivileged children.

The staff of employees at the Home, at this time, consists of Mrs. Bonell, the superintendent referred to, Mrs. Lemmon, who has been with us a number of years as matron, Miss Carter, whose services we have part time, and who is trained in social service work, and the cook.

Financially, we have suffered during the past year as has every institution. Our income from sources upon which we have learned to rely, has been reduced very materially. We shall appreciate the cooperation of every parish in the Diocese in our efforts to maintain the high standard of St. Matthew's Home for Children. Our physical property, as you are aware, is free of debt, but is very old, and we are certain that many repairs will be needed in the near future. Our expenses have been reduced to a minimum, the last year of operation showing a substantial reduction in costs over the last preceding several years.

The health of the children has been exceptionally good during the year, and with the aid of competent physicians, who give their services and by taking precaution by administering preventive medicines against contagious diseases, we hope to maintain our record in this respect.

In conclusion we invite you to visit the Home whenever possible, as we feel that one cannot come away from the Home without a feeling of gratitude for the privilege of sharing the joy of doing God's chosen work, the caring for little children.

SOCIAL SERVICE REPORT

As is to be expected in these days of distress, all branches report a great deal of Social Service work done in co-operation with the organized agencies for relief and with other communions.

19 branches report work for our Diocesan Institutions—St. Matthew's Home for Children and All Saints Hospital, sending in addition to money gifts, boxes of clothing, food, and hospital supplies.

All forms of Community welfare were engaged in: helpers for Community Employment Bureau, case and other workers; contributions of money, clothes, food, milk and food tickets for school children; Christmas and Thanksgiving baskets; visits and magazines to jails; visits, magazines, flowers, etc. to sick and hospitals; dresses made for Salvation Army, Baby Hospital, assist in soup kitchens; money towards a police matron; picnic for College students; magazines to rural districts; comforts and quilts for welfare work; pay towards keeping old lady in "home"; payment of state and county taxes for needy family; serving on Colored Park Board and helping send woman to Prairie View Conference; toys and playground equipment for colored day nursery; linens and hospital supplies to county and other hospitals.

No money value was put on much of the work and contributions, but a total of \$1,396.47 was listed.

It would be interesting to give a complete list of the work done by the various branches, but that would be long and there would be much duplication. However, the work of one branch might especially be noted as it shows how much can be accomplished by the united efforts of the women of the Church through the Auxiliary.
