

Constitution.



ARTICLE I.

The association shall be called "The Delaware Branch of the Woman's Auxiliary to the Board of Missions." Its purpose and aim shall be in accord with those of the auxiliary. Any church woman in the Diocese, who may, during the year, promote the objects of the auxiliary by work or by contributions of money, shall be accounted a member thereof.

ARTICLE II.

Its officers shall consist of President, Three Vice Presidents, Directress for Domestic Missions, Directress for Foreign Missions, Secretary, Treasurer, and Librarian. These officers shall form an Executive Committee. All officers shall be elected by ballot unless otherwise ordered. Other votes shall be *viva voce*. In case of any vacancy occurring in offices in the interval between the several meetings, they may be filled by the Executive Committee.

ARTICLE III.

The President shall call meetings of the Diocesan Branch and of the Executive Committee, and shall preside over them. The Vice Presidents shall perform the duties of the President when she may be unable to perform them. It shall be the special work of the President and Vice Presidents to interest the women throughout the Diocese in the work of the Auxiliary.

ARTICLE IV.

The Directress shall correspond with the General Secretary of the Auxiliary (Miss Julia C. Emery, 21, Bible House, New York,) obtaining information and suggestions for work from her, each in regard to her special department. They shall be in correspondence also with the Secretaries of the parish societies, transmitting information to them; presenting objects of work before them and helping them with counsel as to methods of working, planning for meetings, procuring speakers and they shall make a report each year of work done in their two departments.

ARTICLE V.

SECTION I. The Secretary shall send out notices and keep the minutes of the meetings. She shall make an Annual Report of the Secretary, incorporating in it the Reports of the two Directresses.

SECTION II. The Treasurer shall receive the monies for the current expenses of the Association, and transmit to the Missionary Treasury such other monies as may be sent to her for that purpose, as directed by the Executive Committee.

ARTICLE VI.

There shall be Quarterly Meetings of the Association, preceeded by a meeting of the Executive Committee. The Executive Committee meeting at other times also as occasion arises, at the call of the President.

ARTICLE VII.

The annual meeting shall be held on the second Thursday in October, at a place and hour to be appointed by the Executive Committee and duly notified. When Reports shall be read and Officers for the ensuing year elected.

By-Laws.

ADOPTED NOVEMBER 3rd, 1892.—The Executive Committee of the Junior Auxiliary of the Diocese of Delaware shall attend the meetings of the Executive Committee of the Woman's Auxiliary of said Diocese.

ADOPTED OCTOBER 5TH, 1893.—When an Election of Officers is called for, the members of the several Branches shall determine among themselves, each Branch for itself, for which nominee its vote shall be cast, the voice of the majority prevailing, and a person being selected from each Branch to cast its vote. A tie of the Branch shall result in no vote in the election, and a majority of the votes of the Branches thus cast shall be necessary to an election.

Minutes of the Ninth Annual Meeting.

The Ninth Annual Meeting of the Delaware Branch of the Woman's Auxiliary was held in St. John's Church, Wilmington, October 5th, 1893, at 10:30 A. M. During the singing of hymn 200, the Bishop of the Diocese entered the church, accompanied by Rev. P. B. Lightner, of New Castle, Rev. George S. Gassner, Delaware City, Rev. Percival C. Pyle, Wilmington. At the celebration of Holy Communion, Bishop Coleman was celebrant assisted by Rev. Messrs. Lightner, Gassner and Pyle. A large number of devout women were present. The Rev. George Pomeroy Allen, of Bethlehem, Pa., delivered the missionary sermon, taking for his text, "Andrew first findeth his brother Phillip." A spirited address of inspiration and thought, outlining the benefits and scope of mission work, and defining the difference between charitable and mission work. The offertory following the sermon realized \$75.00 for the treasury of the Auxiliary. The service closed with the recessional hymn, "Jeruselem, My Happy Home," sung by the vested choir of St. John's Church. Following the service there was served an excellent luncheon, in the Parish house, to the visiting delegates, clergy and members, by the ladies of the parish.

At 2:30 o'clock the Vice President called the business meeting to order. The Bishop opening with a service of prayer. In the absence of the Treasurer, Mrs. Henry G. Morse was elected treasurer *pro tem.* The calling of the roll by the Secretary showed the presence of one hundred and six delegates and officers, representing eleven parish branches. In the absence of the President (Mrs. Littell's resignation having been regretfully accepted at a previous executive meeting) Miss Emily Rodney, Vice President, presided over the meeting. A motion was passed that a resolution of appreciation of Mrs. T. G. Littell's work in the Auxiliary be prepared. The President appointed Mrs. Leighton Coleman and Mrs. H. L. Curtis a committee to prepare the resolution. Miss Rodney then read a paper of a few minutes length on subjects connected with the

meeting, which was followed by the report of the Secretary, also reports of the Treasurer of the Auxiliary; the Foreign Directress; the Domestic Directress; the Junior Auxiliary and the Mexican Division, with its treasurers account. A motion was passed to dispense with the reading of the Parochial reports.

The Secretary read the minutes of the last Annual Meeting, also the last two executive committee meetings. Letters of suggestion and help were read from Miss Emery and others, after which the pledges were made for the work of the ensuing year.

1. The Foreign Insurance Fund.
2. The Bishop Lee Memorial Scholarship, Mexico.
3. The Clergy House, Rehoboth, Del.
4. St. Barnabas, Mission, Marshallton, Del.
5. Salary of Miss Goepp, Japan.
6. United offering toward endowment of Missionary Episcopate, \$66,000 to be raised during the next three years.
7. Systematic offerings of five cents per week for Diocesan Missions.
8. To aid in the support of the Episcopal Sisterhood in Wilmington.

The Bishop urged the claims of the Sisterhood, a field of work just established at 1009 Tatnall Street, Wilmington. Its usefulness will be felt throughout the Diocese. A motion was adopted that the Sisterhood be added to the list of pledges for the ensuing year.

The election of the officers of the Executive Committee followed, resulting in, President, Mrs. McIlvaine; Vice Presidents, Miss Emily Rodney, New Castle Co.; Miss Comegys, Kent Co.; Mrs. Hiram Burton, Sussex Co.; Directress of Domestic Missions, Mrs. C. E. Murray; Directress of Foreign Missions, Miss Sophie Rodney; Secretary, Miss Frances B. Hurd; Treasurer, Mrs. Wm. C. Lodge; Librarian, Mrs. Alex. J. Taylor.

President of the Junior Auxiliary, Mrs. P. B. Lightner, New Castle; Secretary, Miss Frances Dorr Swift, Wilmington

The Treasurer then received the annual dues. The Secretary read the By-Law prepared in accordance with the motion made at the May meeting, which was as follows: "Each parish branch shall be entitled to three delegates, with power to vote on all questions

coming before the auxiliary." A resolution was made to amend this By-Law :

WHEREAS, A system of delegates from the various parochial branches would work harm to the General and Annual meeting of the Woman's Auxiliary of Delaware by restricting individual participation, and, whereas, questions of order make it desirable that a just and considerate rule should prevail respecting the election for the General officers. Therefore be it

Resolved, That when any such election is called for, the members of the several Branches shall determine among themselves, each Branch for itself for which nominee its vote shall be cast, the voice of the majority prevailing, and a person being selected from each Branch to cast its vote. A tie of the Branch shall result in no vote in the election, and a majority of the votes of the Branch thus cast shall be necessary to an election.

A motion was adopted to incorporate this amendment in the Constitution, and have the Constitution printed with the annual report.

The committee to whom was referred the resolution regarding the resignation of Mrs. Littell, presented the following report.

Resolved, That the members of the Delaware Branch of the Woman's Auxiliary wish to place on record their grateful appreciation of the untiring labors of their late President, Mrs. T. G. Littell, and of their sorrow at her resignation.

Resolved, That they feel they cannot say too much in praise of her zealous devotion to the work of the Auxiliary and of her continued interest in promoting its prosperity.

Resolved, That the ladies of this Branch express most hearty wishes that Mrs. Littell may return home in safety and that she may have many years in which to carry on the good work to which her life has always been devoted.

Resolved, That this resolution be made public through the press ; incorporated in the report and a copy be sent to Mrs. Littell.

Resolved, That a vote of thanks be tendered to the Rev. G. P. Allen for his interesting and stirring sermon, which should be a guide and inspiration to us in our work for the coming year.

Resolved, That a way be provided to defray all expenses incidental to the office of President and Secretary.

A vote of thanks was passed to Miss Rodney for presiding at the meeting by a rising vote.

A vote of thanks was passed to the ladies of St. John's Branch for their generous hospitality by a rising vote. After a few remarks and prayer by the Bishop, the meeting adjourned to meet in St. Thomas Church, Newark, on the 2d Thursday in October, 1894.

Ninth Annual Report of the Secretary.

Right Reverend Father in God and Women of the Auxiliary.

The year ending with October, 1893, completes the ninth year of the Woman's Auxiliary in Delaware and in looking over the reports of these years one can justly feel pride in the work accomplished, and ever increasing with succeeding years. In the past year the Executive Committee has held usual its meetings for the arrangement and spreading of the interests of the Auxiliary in its various departments. The quarterly meetings have had more than usual interest, owing to the personal part our women have taken in the preparation of papers on subjects relating to the work of missions; these papers provoke discussions which circulate the thoughts and sentiments of those who have the good cause at heart, and offer suggestions which help each and all in working out some plan of action.

At our last quarterly meeting our President, Mrs. Littell, referred to her absence from the Diocese, which necessitated her resignation of the office she has filled for eight years. Her associations with the Auxiliary had been most pleasant, as the women had worked with her in unity and love, aiding and sustaining her efforts toward a larger and more abundant fulfillment of the duty every Christian owes to God's people.

The Auxiliary has yearly added more workers, and it is to be hoped a fresh interest may be awakened in those Branches which have of late confined their work at home. In their own Branch they have obligations, no one denies, but should it be confined so closely that no part be given to the thousand needy who have no house of worship, while we are adorning even to elaboration, the already comfortable House of God. Let us so divide our gifts that we may reap larger and wider benefits.

At our last executive meeting the President's resignation was regretfully accepted after many expressions of appreciation of her

faithful work. It is very important that the Secretaries of the Parish Branches should apply to the Directresses for work, or at least consult with them before offering assistance to any mission or missionaries, for by neglecting to do so mistakes are made and many cases are more than fully supplied, and others just as deserving and needy are without aid. Miss Emery particularly asks that the Secretaries apply to the Diocesan Directresses, as she keeps them informed and sends appeals to them for distribution. We have Branches of the Auxiliary in seventeen parishes with a membership of two hundred and fifty-nine, many of the number, however, are not active members.

A quiet day for women was held during Lent in St. Andrew's Church, Wilmington, conducted by Rev. Dr. Parks, of Philadelphia. A large number of women were present.

Upon each one who has been baptized into the church, devolves, as a member of Christ's Church, a great personal responsibility.

The mission work demands our prayers, our service, our talents and our gifts.

Annual Report of the Corresponding Secretary of the
Mexican Division.

OCTOBER 1ST, 1892, TO OCTOBER 1ST, 1893.

The work in Delaware has been carried on with quiet energy during the past year. The usual meetings held, funds collected, donations received. At the last annual meeting, October 15, 1892, Mr. Gordon was present, and gave a most interesting account of the benighted Indians in Mexico and their need of Gospel light. A special sum was raised for Mrs. Hooker's Orphanage last spring (as a memorial to Mrs. Hooker), which amounted to \$65.00. The Bishop Lee Scholarship has been supported as usual by the united offerings of the Woman's Auxiliary and the Sunday School of St. Andrew's Church.

In the death of Mrs. M. J. Hooker, that noble and self-denying woman, who gave many years of her life to the work of carrying on the Orphanage for Girls in the City of Mexico, the church has suffered a great loss. She "entered into rest" January 21st, 1893, leaving her all to our Domestic and Foreign Missionary Society and consigning to our care those orphaned girls.

Miss Driggs, who went out from Delaware several years ago, as Mrs. Hooker's assistant, has succeeded her as the Head of the Orphanage.

They have thirty-eight scholars and they would like to take twenty more, had they the means to support them. A girl can be supported there for \$80 per annum, American money. Mr. Forrester, in his remarks at the last meeting of the Aid, spoke of the mothers in Mexico, begging with tears in their eyes, that their daughters might be taken into the Orphanage to save them. The new Superintendent, the Rev. Henry Forrester, was appointed in December, 1892. He has taken prompt and energetic interest in the work. He speaks of the student, Sarnuel Salinas, being educated by the "Bishop Lee Scholarship," as making himself useful in the mission work, and trusts soon to have him ordained for the full work of the ministry. He is now only nineteen years of age.

Were the interest more general throughout the Diocese and the offerings correspondingly liberal, we should be able each year to forward an amount that would more adequately meet the needs of this mission, struggling along so bravely in the midst of many trials.

The contributions for the "Bishop Lee Scholarship" should be sent to Mrs. Lodge, of Claymont, Treasurer of the Woman's Auxiliary, as soon after the annual meeting as possible, and any other donations, for Mrs. Hooker's Orphanage, or General Work, can be sent to Mrs. Henry G.
