MINUTES
OF THE
Fourteenth Annual Meeting.

OF THE DELAWARE BRANCH, HELD IN TRINITY CHURCH,
WILMINGTON, NOVEMBER 3RD, 1898.

MORNING SERVICE.

The celebration of the Holy Communion at 9.30 o'clock was the first service of the day, the Bishop of Delaware being the celebrant, the Bishop of Indiana reading the Epistle, and the Bishop of Dallas the Gospel, and Archdeacon Hall, Rev. C. E. Murray, D. D., and Rev. H. Ashton Henry, assisting in the distribution of the elements. There were also in attendance Revs. S. D. Day, W. J. Wilkie, C. N. Spalding D. D., Charles A. Horne, Kensey J. Hammond, Henry Cunningham, F. M. Munson, L. L. D. and Geo. S. Gassner.

Addresses were made by Bishop White, Bishop Garrett and Bishop Morris, each pleading for his own particular work. Bishop White wanted more men, and the money to support them. Bishop Garrett wanted buildings, more particularly schools, dwelling on the benefits derived from education. Bishop Morris, who is one of our oldest bishops, and whose earnest desire is, before the next triennial meeting on the Pacific coast, to raise an endowment of \$50,000 to ensure the continuance of his work in Oregon, when he is "resting from his labors," asks if Delaware cannot give \$1,000.

At twelve o'clock the noon day prayers for missions were offered.

The Offertory amounted to \$34.00.

Immediately after the service all who were in the church were invited to partake of the luncheon, which the women of Trinity Branch had in readiness in the Parish House. Although all did not accept, more than two hundred, including all the clergy, were speedily and bountifully served, and the room in order in time for the business session.

AFTERNOON MEETING.

One hundred and forty members answered to the roll call, representing fourteen parish branches. Seven of the executive committee were present, including vice-president of Sussex Co. The full attendance was one hundred and seventy-five.

The president, in her annual address, told of her attendance upon the meetings of the Woman's Auxiliary at the Triennial Conference in Washington, of the length of time that was devoted to the important question of what the united offering for 1901 should be.

In speaking of our giving as a diocese, she said, "When we remember that in the last year Delaware has given what is worth more than money, one of her own sons, S. Harrington Littell, in the vigor of his manhood, to the work in China, it should be indeed a fresh incentive to us, to do the home work better, and a reminder that we do not sustain the work in China as well as we might." The president referred to the action of the Diocesan Officers' meeting held in Washington with reference to the Junior Auxiliary Publishing Co. It was voted "that each Diocesan branch should elect from its Executive Board one person to form a Committee from the Woman's Auxiliary to act with the J. A. P. C., this committee to meet once in three years, at the time of General Convention." It was also voted that "each diocese send an annual contribution to the J. A. P. C., one-half the value of which is to be returned to the diocese in printed matter for distribution among the Junior Auxiliary members." She made a plea for more interest in the Juniors, reminding us that they are to take our places on some day not far distant. This comes home to us at every annual meeting, when some vacant places are found. The president referred feelingly to the deaths of two parish presidents, Mrs. C. M. Bird of Trinity Branch, and Mrs. A. R. Walker of Calvary church, who have entered into the rest of Paradise since our last meeting, also to two faithful members of St. Andrew's Branch, Mrs. Charles I. duPont and Miss Cornelia Broome, who have very recently passed away. Smyrna adds to the list two most interested members, Mrs. Margaret Culbreth and Mrs. James Williams.

It was moved and seconded that the reading of the minutes of the last annual meeting be dispensed with. Carried.

The minutes of the May meeting were read and adopted, also the annual report of the secretary.

The treasurer reported the amount of money paid into the treasury

during the past year \$610.95, and \$563.65 paid out, leaving a balance of \$47.90, of which sum \$29.56 is a reserve fund for the president's traveling expenses. Balance in treasury, \$18.34.

The treasurer of United Offering Fund reported the Triennial Offering \$1203.15, instead of \$1283.15, which had previously been reported, owing to an error made by the bank officer.

Mrs. Wilson asked for instructions as to whether she should order new mite boxes, or labels for the old ones. It was decided, that we use the old boxes as far as they will go, with the hope expressed that we shall need many new ones.

Miss Warner, seconded by Mrs. Curtis, moved a vote of thanks to the treasurer of the United Offering for the faithfulness with which she has discharged her duties for the past three years, and also an expression of sympathy with her for the annoyance the error in the bank account has given her. Carried.

Mrs. Lodge made a motion, seconded by the secretary, that the election of officers be the order of the day for 3.30 o'clock. Carried.

A very interesting history of the year's work of the Juniors was read by their president, Mrs. Hall, and the secretary-treasurer read her annual report.

The secretary read the report of the correspondent of the C. P. C.

Miss M. T. Canby, secretary of the Mexican Division, read her report, which she had hoped would be supplemented with an address by Rev. Henry Forrester, but who was unable to keep his appointment, owing to a sudden summons to meet the Board of Missions. The treasurer's report was read by Miss Palmer.

Invitations were extended for the meetings for the year and accepted as follows: Epiphany, second Thursday in January, St. Andrew's, Wilmington; May meeting in Sussex County, and annual meeting in October, 1899, Immanuel church, New Castle.

The following resolutions were offered by the Executive Committee, and accepted by a rising vote:

WHEREAS, in the providence of our all wise heavenly Father, Mrs. A. R. Walker, who one year ago united with us in the solemnities of the day, has entered Paradise, therefore

Resolved, That we, now that she rests from her labors, gladly bear united testimony to her great worth. She was a sincere and devoted christian. In the home she was an example of consecrated womanhood, and in the Church she exerted an influence that reached beyond the limits of her own parish. We may well have her for an inspira-

tion, and pray God that our years may be as beautiful, unselfish and useful as hers were. She is missed because her seat is empty.

Business was suspended for a time to listen to a most eloquent address by Miss Stuart, President of the Virginia Branch, who was with us by special invitation. Her words glowing with enthusiasm gathered from the Triennial Meeting, showed in every thought the consecration of the daily life to this work of the Woman's Auxiliary.

A rising vote of thanks was extended to Miss Stuart.

All the pledges of the past year were brought before the meeting and the following were taken up for the new year: Bishop Lee Scholarship. Foreign Insurance, the work in China, Japan, Alaska, Diocesan Missions, St. Matthew's Building Fund, St. Michaels Day Nursery, and for Bishop Morris' Work in Oregon.

Mrs. Horne seconded by Mrs. Turner, moved that the offering

from the morning service be divided between the Bishops of Indiana and Dallas. Carried.

Miss Hay, seconded by Mrs. Curtis, moved that some one be appointed to collect money for Bishop Morris. Carried. The president appointed Miss Hay, of New Castle, to collect and take charge of this fund.

Mrs. Wilson, seconded by Miss Warner, moved a rising vote of thanks to our president for the earnest devotion to and interest in her Branch that she evinced during her stay in Washington. Carried.

Mrs. Hall moved that a message of condolence and expression of our sympathy be sent by the secretary to Rev. M. B. Dunlap and his family in this hour of their sorrow. Carried.

Miss Warner, seconded by many voices, moved that a rising vote of thanks be given to the bishops who have spoken to us, to the choir and to the ladies of Trinity Parish for their generous hospitality.

The Offertory at the afternoon meeting amounted to \$20.74.

After singing the Doxology the meeting adjourned.

After a short service and the singing of missionary hymns, addresses were delivered by the following speakers: Wm. R. Butler,

Esq., of Mauch Chunk, Pa.; Rt. Rev. Peter B. Rowe, Bishop of Alaska; Rt. Rev. Alexander C. Garrett, Bishop of Dallas.

14th Annual Report of the Secretary.

Right Reverend Father in God and Women of the Auxiliary:

Another year I have the honor to present to you the report of the missionary work of the women of this diocese.

While we have done nothing remarkable in the way of new work, the past year shows no flagging in the zeal and energy of the members of the different branches.

The executive officers have attended to their usual duties, in the way of meetings, and efforts to stir up an interest in parts of the diocese where the Auxiliary is not known.

The pledges made at the annual meeting have all been paid, and our United Offering has been greatly in excess of any previous year, the crowning effort of the Triennial making the Offering three-fold what it was three years ago.

Eight branches have made glad the hearts of missionary families, and the children in mission schools, with boxes well filled with comforts and the necessaries of life. The Day Nursery and Baby Hospital have been generously remembered, and when ever a needy case in our own diocese has been made known it was speedily relieved.

The Epiphany meeting at St. John's church was attended by eighty interested women. Mrs. Neilson, President of the Domestic Division of the Pennsylvania Branch, was the guest and speaker of the afternoon. Missions at home and abroad was her theme.

The May meeting was held at New Castle, when detailed reports from all the branches were made, many reporting great increase in interest, and marked advance in the spirit in which the work is done.

A Quiet Day for Women was held in St. Andrew's church on March 10th, conducted by Rev. Richard H. Nelson, rector of St.

Peter's church, Philadelphia, with four instructions on, "Faith and Faithfulness in the Kingdom of God." The offering was given to Diocesan Missions.

A large number of the women of Delaware were privileged to attend the Triennial meeting in Washington. The executive officers with two exceptions were present, and endeavored to the best of their ability to attend all meetings where something could be learned or inspiration gathered for the work that is before us in this coming year.

Miss Emery says in her last report: "If there is anything that this particular year has taught us, it is, possibly, the need of reaching the individual women throughout the Church, who do not care for the things for which the Woman's Auxiliary primarily stands, and with the approbation of their parish priests and with the unerring guidance of God the Holy Ghost, helping them to care." Are we not each one responsible in some measure for our neighbor "who does not care," and whom we could influence?

Extracts from Report of Corresponding Secretary of the Mexican Division.

November 3, 1898.

Since the last annual meeting of the Woman's Auxiliary of Delaware, the work of the Mexican Division has gone on as usual. The regular meetings have been held and reports distributed.

We have been so fortunate during this Convention year as to have with us the Rev. H. Forrester, and have heard from him many important facts as to the Episcopal Church in Mexico. We hear that our

former student, Rev. S. V. Silenas, is working faithfully, as a presbyter in charge of nine congregations. As the towns and villages in which he preaches are at various distances from La Venta where he lives, he goes on horseback from one point to another, and spends the greater part of four days in the saddle each week. Bishop Kendrick speaks of him as "the youngest and one of the most promising of our clergy baptized and brought up in the Mexican Episcopal Church." We have also a good report of our new candidate on the Bishop Lee Memorial Scholarship, i. e., Luis Caballero, who is "very good and steady," and who has already been ordained deacon. From Mrs. Hooker's Orphanage we hear, "It is doing well this year, and is in admirable condition."

Too much praise cannot be given to Miss Driggs and her staff for their devotion to their work. Of the four teachers now steadily employed, *three* were educated in the school, which speaks volumes for them and their training. Bishop Kendrick wrote recently "I shall always speak a good word for the Orphanage School in the City of Mexico. I am very enthusiastic about this work that Miss Driggs and Miss Forrester are doing. This school is the jewel of the Mexican Church."

To turn from these encouraging statements to the shady side. For want of funds to support the Dean Gray School for boys, most of the boys had to be sent home this year. Some of the clergy have been partially or wholly supporting themselves this year by secular work, but so far, without diminution of the services of the Church.

When so much good might be accomplished in a neighboring country, it is indeed lamentable that the work must be retrenched for want of sufficient support. If this younger sister of our beloved Church can have our fostering care for a few more years, we may see her grown strong and beautiful like that vine of which the Psalmist speaks: "When it had *taken root* it filled the land, the hills were covered with the shadow of it, and the boughs thereof were like the goodly cedar trees," and the "birds of the air" may yet take refuge in its branches, for there may come a time, not far distant, when the Church in Mexico can send forth missionaries to the Spanish-speaking countries around her, and aid in the christianization of "*the islands of the sea*," and so hasten the time when "the Kingdoms of this world shall become the Kingdoms of our Lord and of His Christ."
