

MINUTES  
OF THE  
Twentieth Annual Meeting.

The Twentieth Annual Meeting of the Delaware Branch of the Woman's Auxiliary was held in St. Andrew's Church, Wilmington, November 10th, 1904.

The morning session beginning at 10 o'clock consisted of the usual celebration of the Holy Communion. Archdeacon Hall was the celebrant, and was assisted by Rev. T. Gardiner Littell, Rev. J. Kensey Hammond and Rev. Hubert W. Wells. The hymn used at Missionary Meetings of the General Convention at Boston was sung, and three addresses were made. Dr. Woodward told of the medical mission work in Ngankin, China, and of the great need of a hospital building. Rev. H. M. Taitt, of Chester, Penna., Asst. Bishop elect of S. Dakota, spoke of the noble work of Bishop Hare among the Indians of his jurisdiction.

Dr. Driggs touched all hearts by the story of his eight long lonely years in Alaska, since his last visit home; he wants help to build a church and remodel a schoolhouse.

Noonday prayers for missions were read and at 12.30 o'clock luncheon was served in the Sunday-school room.

At 2 o'clock Bishop McKim of Tokio made an address, answering many questions asked him about Japan. Rev. Thomas Wetmore plead earnestly for the mountain whites of North Carolina, and for help to support the school at Arden, of which he has charge.

At 3.30 the business meeting was called to order by the President, and the following letter from our beloved bishop was read by Mrs. McIlvaine.

Dampfer Konig Albert,  
October 22, 1904.

My dear daughters in the Lord:

My first letter from land is to you and by the hand of the pilot, a letter from the sky pilot of Delaware. It is to tell you how very sorry

I am that I cannot be with you at your annual meeting, held in a parish so eminently distinguished for its zeal in the cause of missions. You know how surely I shall be with you in spirit, earnestly interested in all your proceedings. May these proceedings be so influenced and controlled by the Good Spirit Himself as to make for the welfare of the diocese and the church at large.

I want to tell you how proud I was and still am of your contribution to the United Offering—so far excelling all of such former contributions, and even those of other dioceses larger in every way.

Be not high-minded as to this or any other good work that God may enable you to do. Give Him all the glory, and count yourselves most privileged in being allowed to do something for Him. Even the best we do is far below what is His due.

I regret very much that I cannot be among those who shall have the advantage of hearing the addresses that may be delivered. I am especially sorry that I shall miss seeing again and hearing Dr. Driggs our own Delaware missionary hero. Let me in this way extend to him an affectionate and grateful welcome and assure him of our continued hearty interest in all his work. Invoking upon you God's gracious and abundant blessing, and thanking you each and all for your valued help and comfort, I am, as ever,

The following resolutions offered by Miss Hunter were adopted by a rising vote.

*Resolved*, That the Delaware Branch of the Woman's Auxiliary, now assembled in St. Andrew's Church, extend to their beloved bishop their sincere thanks and appreciation of his letter, and regret that he is not present at this time. They also desire to express to him their deepest sympathy in his recent bereavement, and would ask that the secretary be instructed to send a copy of these resolutions to the bishop, and spread the same upon the minutes.

One hundred and eighty-four responded to the roll-call representing nineteen branches.

The minutes of the May Meeting were read and approved.

The President's address, all aglow with the spirit and enthusiasm of the Auxiliary Meetings of the great Triennial, made those of us who had not shared that privilege thankful that we had been so well represented, and for the impressions brought home to the Diocesan Branch.

Mrs. Hall moved a vote of thanks to Mrs. Churchman for her very full and complete report, and that it should be loaned to any branch desiring to read it. Mrs. McIlvaine amended the motion to read, 'that the address should be printed in the the *Delaware Churchman*.' The motion was passed as amended.

The Treasurer reported receipts and expenditures for the year \$1,005.50.

Mrs. H. L. Curtis, Foreign Directress, told of the deep impression Bishop Ferguson had made on her when he talked of his work in South Africa, and of the \$87 that he had brought to the United Offering from the Woman's Auxiliary in that heathen land.

The Treasurer announced that the offerings at the two services amounted to \$62.55 and moved that \$25 should be given to Rev. Mr. Wetmore.

The motion carried.

The report of the C. P. C. was read by the Secretary. The Treasurer of the United Offering read a full report of the three years' gathering from the mite boxes which amounted to \$1,564.56.

Mrs. Hall, President of the Juniors, asked that her report be postponed until the next meeting as time was limited. She announced that she had pledged to Dr. Woodward \$100 from the Juniors of Delaware, to help furnish a childrens' ward in the hospital in Ngankin, China.

Mrs. Wilkie Sec.-Treas. of the Babies Branch read a paper written by Mrs. Burton wife of the Bishop of Lexington.

The report of Mexican Association was read by Mrs. Curlett. Mrs. McIlvaine presided at the election of officers for the ensuing year. Balloting was dispensed with and the Secretary was instructed to cast the ballot for the following officers :

Pledges were taken for the Rev. Mr. Wetmore's work and for All Saints, Tokio, Japan, in addition to those annually made by the Auxiliary.

Mrs. Charles Curtis moved that pledges be taken earlier in the day at the next annual meeting. Mrs. Charles Miller amended this motion to read, "that election of officers be first in order of business, pledges second and reports last." The motion was passed as amended.

Mrs. Curtis moved that the afternoon session of the annual meeting be confined entirely to business, which motion carried.

An explanation was made that no courtesy to the speakers of the afternoon was intended, but it was impossible to transact the necessary business in so short a time.

An invitation to hold the Epiphany Meeting in Calvary Church, Wilmington, was accepted. The Wyoming and Camden Branch, also the Delaware City Branch, extended an invitation for the May Meeting, but after some discussion it was decided to postpone the usual May Meeting until June, so that it may be held when the Diocesan Convention is in session in Wilmington, and Trinity Church was chosen as the place of meeting. Christ Church Branch then invited the Auxiliary to hold the Annual Meeting in Delaware City, which invitation was gratefully accepted. Smyrna also sent an invitation for the Annual Meeting.

By motion of Mrs. A. G. Wilson a rising vote of thanks was given to the rector of St. Andrew's parish, and the members of the Auxiliary, for their kind welcome and delicious luncheon.

After the singing of the doxology the meeting adjourned.

## Twentieth Annual Report of Secretary.

The year ending with October, 1904, completes the twentieth of the Woman's Auxiliary of the Diocese of Delaware.

The meetings held during the past year have been both encouraging and inspiring. The parish reports read at the May quarterly show an increased interest throughout the diocese, and the aggregate value of missionary boxes, and pledges paid, is greater than in any year of our history. A few parishes report the study of missions, and we look forward to the revival of the inter-parochial mission study class in Wilmington this Winter.

The Epiphany meeting in Calvary Church, Wilmington, was well attended. Mrs. Woolsey Hodge, of Philadelphia, read a very able paper on "The Right Use of Money."

The May meeting in St. James's Church, Stanton, was marked by the presence of our old friend and first president Mrs. Littell, and an address by Miss Hubbard on what she had seen of our missions in China, during a two years' visit there.

One hundred and eight were present from fourteen branches.

The special service in the interest of the United Offering Fund for

1904, held in St. John's Church on February 3d, was one long to be remembered. The celebration of the Holy Eucharist, followed by Mrs. Sioussat's earnest and eloquent address, the hour of social intercourse, while all enjoyed the hospitality of the ladies of St. John's parish, and then the gracious presence of Bishop Hare of South Dakota, with his words of counsel, and story of how he had used his share of the last United Offering, made all feel that it was a privilege to be there. We feel sure it brought forth abundant fruit in swelling the offering presented at the Triennial service at Boston.

The report of the Church Periodical Club is not very encouraging this year, but our Librarian is expecting great results from the stirring appeals that were made in Boston for a greater interest in the C. P. C.

Our Domestic Directress brings to us an even better report than her good one of last year. Twenty-five boxes have been sent, five of them united boxes. Eight have gone to clergymen and their families, nine to mission stations, one to Seaman's mission in Philadelphia, one to All Saints' Home in Baltimore, one to Mrs. Buford's Hospital in Virginia, and five to our own Babies' Hospital. Total value \$1,419.84.

The meditations of our "Quiet Day" to which we have all learned to look for help and refreshment were this year given by Rev. C. W. Bispham of Philadelphia.

"Let us recognize the spiritual root of the Auxiliary service" and help to make true Miss Emery's concluding words in her annual report that "the Woman's Auxiliary may be actually in the future what it is but feebly and in part to-day, not an organized association of women at home, helping remote individual workers in distant mission fields, but a body of women, who in Christ's Church at home and abroad, in city parish and in feeblest and remotest mission, together give of substance, of prayer, of very life itself, that Christ's Kingdom may the sooner come."

The foregoing statement of figures is also a statement that the hopes of an increased offering expressed at the Epiphany meeting last year have been more than realized, as the aggregate amount of the last three offerings is \$4023.47.

The object of the 1904 offering was very near and dear to our hearts, and a continuation of the same object for the 1907 offering, with an addition which broadens it, and makes a part of it a material memorial of the woman's effort, insures a generous support in our Diocese. At the meeting of the Woman's Auxiliary in Boston, the following resolution was offered and accepted :

*Resolved*, That the United Offering of 1907 be given to the Board of Missions for woman's work in the Domestic and Foreign fields ; including the training, sending and support of women workers, also the care of such workers when sick and disabled ; this to be interpreted to include Brazil, Hayti, Cuba and Mexico ; but that a sum not exceeding \$10,000 be devoted to some building, or extension of the same, preferably connected with woman's work, to mark the United Offering of 1907 and to be begun in that fiscal year, such building to be approved by the Board of Managers on the recom-

mendation of the General Secretary and the Secretary of the Woman's Auxiliary.

In the face of the encouragement of the past and with renewed hope and interest in the future, we shall not turn back from what we have done but press on and accomplish more than has yet been thought of.

A very important factor in the in-gathering of United Offering is the appointment of a treasurer in every parish branch, such treasurer to take charge of all boxes and leaflets, distributing the same, keeping a list of those who receive them, seeing that every woman in the parish has one, and making every box *tell*, if only for a small amount. With one of those little blue boxes always in sight to remind us, the habit of dropping in the weekly or the monthly contribution may soon be acquired.

Also to make this offering entirely acceptable in the sight of Him to whom all hearts are open, we shall not forget that it is to be a *part of ourselves*, as a thank offering—an offering over and above all other obligations which we shall meet, and with the constant and systematic giving should be a prayer, if only the few words, "We pray Thee, Lord of the harvest, send forth laborers into Thy harvest."

## Report of the President of the Junior Auxiliary.

The fourteenth annual meeting of the Junior Auxiliary was held in Trinity Church, Wilmington, Saturday, May 14th, 1904.

The morning conference was opened at 10.30 with devotional exercises, conducted by the Rev. G. Morris Wilkins, rector in charge.

Thirteen parishes responded to roll-call.

Minutes of the last annual meeting were read by the secretary, after which the President, in a short address, reviewed and commended the good work done by the individual branches. She said, "the interest manifested in the various departments of mission work was steadily on the increase, notwithstanding the small numerical force of workers. That this band of workers was not what it should be, was largely due to the very apparent lack of interest the Church at large manifests in the Junior Auxiliary. Instead of recognizing in it one of the most important of the Church's organizations, and therefore anxious to help promote it, many christian parents know very little

about it, and care less, whether their children belong to it or not, certainly not if it will at all interfere with any of their material interests or pleasures." The result is that the rank and file of the Junior Auxiliary is largely made up of children outside of the Church. Some of these come into her fold but we lose the greater majority after a certain age.

At the request of the President Mrs. T. Gardiner Littell, of New York, spoke about the work of our Church in Hangkow, where her son Rev. Harrington Littel, is stationed as one of our missionaries.

It was decided "the United Lenten Box of 1905" should be sent as usual to Dr. Driggs.

The claims of the Babies' Hospital were submitted as one of the objects worthy of consideration, for the Advent or Christmas box. The hospital is doing good work and filling a great want in our city and diocese. It is in need of children's clothing, bed linen and other household furnishings.

Prayers were offered at mid-day for missions, by the Bishop of Delaware, who made the closing address.

At 12.30 a tempting and bountiful luncheon was served on tables bright with beautiful flowers, and thus a delightful social hour was passed.

At 2 P. M. the regular annual meeting was held. To the spirited hymn "Fling out the Banner" a procession of clergy, with the Bishop of Delaware and the speaker of the day, Dr. Lloyd, entered the church. The bishop gave his greeting to the Juniors, and then spoke of the pleasure it gave him to introduce Dr. Lloyd, the General Secretary of the great missionary society of our church, and of which the Junior Auxiliary was a part, and a *very large part* in his estimation, and that of Dr. Lloyd as well.

Dr. Lloyd was very happy in his address. He spoke of the missionary work of the church and its needs, and of their share in this work.

Interesting reports were read by the parish secretaries. Some of them were very youthful, and their sweet little voices clear and distinct, were heard in every part of the church. The bishop could not refrain from giving a word of praise, adding "he knew many men and women and even some clergymen who could not do as well."

Our pledges to foreign, domestic and diocesan missions were promptly met, some "specials" given, a contribution made to the

United Offering of 1904. Several scholarships in a southern school are maintained by individual branches.

The United Lenten Box sent to Dr. Driggs, Point Hope, Alaska, was valued at \$295.00. It consisted of three large barrels, one barrel alone being filled with valuable medical supplies, the gift of some druggists in this city and Middletown. In another barrel was a quantity of candy packed and sealed in tin cases, besides dolls and work-bags for the girls, and equally charming things for the boys. There were many beautiful gifts for the Christmas-tree that will delight our little Alaskan friends. The rest of the box consisted of warm, good and new clothing, and other substantial articles.

One year ago the Juniors in connection with their annual meeting held a "Reception and Tea" from 4 to 6 o'clock, at the Day Nursery and Hospital, 207 Washington St. The silver offering on that occasion amounted to \$7.00. This sum was expended in "Mite chests" which were placed where they might from time to time gather the small contributions of friends interested in this diocesan institution. The net proceeds for the year amounted to \$87.00. In our Junior work there will arise occasions when we would like to have some money over and above that pledged, to give to some special object that may appeal to us, like Dr. Woodward's plea for the "Children's Ward" in the new hospital building in Ngankin, China. We are most anxious that Delaware's contribution to this object may be one worthy of her, and of her noble band of faithful little workers. Let us try to devise ways and means to accomplish this end, so that ours may be indeed a generous contribution, without detracting from our other objects of work and pledges.

At the close of the meeting a "Reception and Tea" was given by the Juniors at the Day Nursery and Hospital.
