A MESSAGE FROM THE PRESIDENT
TO
EPISCOPAL CHURCHWOMEN IN THE DIOCESE OF DELAWARE

An inspirational note and a call for hard work in the future ended the 1971-72 year of the Episcopal Churchwomen when our Bishop, the Rt. Rev. William H. Mead, told the Women of the Diocese that they are needed and must become involved on every decision-making level of the Church.

The Women responded by passing two motions during the annual meeting, May 18, at Christ Church Christiana Hundred. Motions carried were: (1.) "The Women of the Diocese of Delaware support the position of Bishop Mead to work for the involvement of more women at each decision-making level of the Church, ie., Parish Vestries, Diocesan Council, Standing Committee and Trustees;" and (2.) Two women are to be appointed to represent the Diocese of Delaware at the next Convocation or Caucus of the Province of Washington."

It is hoped that this step followed by dedicated effort to eliminate "tokenism" will find Women involved in a lay ministry that does not exclude their own creative roles, but brings them into the main-stream of all aspects of Church life and service.

Using the privilege of a President's Report at the annual meeting I urged the Women of the Diocese to open up the lines of communication to help the ECW Board and me to represent them better in the coming year. The need for two-way exchange of goals and innovative ideas is most quickly realized by taking a look at the dual role of the ECW President.

In one role the President presides over a twenty-one member ECW Board which meets six days each year to organize and conduct seven other general meetings of the Women. In 1971-72 there were three ECW County Days, a Kent County Christmas Tea, Devotional Day, C.S.R. Day, and the May Annual Meeting. Throughout the year each board member serves as liaison and resource person in her fields of specialization to relate the National Church, the Committee on Lay Ministries and the Diocese to the Women of each parish. To function in this liaison role each board member attends as many parish board and general meetings and special parish events as possible, and each keeps in touch with parish chairmen via letters and county workshops.

In the President's other role, i.e., representing the ECW on the Diocesan level, the need for shared communication is equally obvious. During the year I have represented the Women as ex-officio member of Diocesan Council. I served on the Outreach Division of Council until a number of women were added to the Division and, following a restructure of Council last January, I moved to the new Diocesan Goals and Guidelines Committee.

As Convenor of the R.L. 70's Tithe Screening Committee, I worked with this ad hoc group to recommend projects for the \$94,000 Tithe of 1971, and \$5,000 grant to the new Bishop of the Dominican Republic this spring. I have served as a member of the College Ministry Board which has become a new Division of Council and as a group leader during the fall Budget Convention and the 187th Annual Convention last January.

For your prayers and support which have been needed and appreciated by me and your ECW Board, I want to sincerely thank you. For the love and Christian spirit, the help and inspiration of the ECW Board, I offer thanks to Our Lord each day of the year.

ADDRESS TO E.C.W. BY BISHOP MEAD IN MAY 1972

The first meeting of the Episcopal Women's Caucus was held on October 29 and 30, 1971. Originally this Conference, funded by the Board of Theological Education, was intended for women Seminarians, Graduates, Postulants, Deacons, and those formerly referred to as Deaconesses-but the strong, favorable response of lay women at the Conference immediately broadened both the base of the movement and its goals.

Without an organized program, this group was soon provided one by the fact that the House of Bishops, meeting in the Poconos, at the same time, had that very day referred the subject of women's ordination to further study-an act, which from this Bishop's standpoint, was inexcusable. It had just been studied by a committee of the House and reported out with a vote favoring women's ordination to the Priesthood.

Understandably the Women's Caucus issued a strongly worded statement to the Presiding Bishop objecting to further study of the issue-refusing themselves to take part in any further study of the issue, and calling for immediate action by the Bishops and Diocesan Conventions.

(Perhaps, you will remember, that in my own annual address to this diocese in January, I endorsed canonical changes that would make it possible for women to be ordained to the Priesthood and to the Episcopate, and asked for a resolution to be prepared to this effect for action at a Convention of this Diocese prior to the General Convention in 1973.)

Before that meeting of the Women's Caucus in 1971 had adjourned, however, it called for Regional Meetings to be held in the spring of 1972. The first meeting of the Women's Caucus in our region was held on April 21 and 23, this past month, at Virginia Theological Seminary. I received a report of that meeting this past week.

About forty women were present, from the Dioceses of Washington, D.C., Maryland, Virginia, the four Dioceses in Pennsylvania-and some from as far away as Florida and New Hampshire. (Perhaps someone from our Diocese was there-but if she was, the report failed to mention it.)

At this latest Regional meeting, the broadening base of the movement was becoming clearly discernable. Many women members of the E.C.W., including Board members, were present. More than 85% of the group were not seeking ordination but simply "more responsible positions in the Church". Their goals involved greater participation on vestries, in Diocesan Councils, Diocesan Conventions, on Diocesan Boards, and in the general convention as lay-deputies. There were housewives there, students, volunteer workers, and several women engaged professionally in full time counseling. Their average age was well over 48, and all of them were dedicated to the principle and the spirit of lay ministries as being essential to the revitalization of the Church.

I mention this latest movement within the Church-and the Regional meeting held last month at the Virginia Seminary-because on April 29, 1969, the subject of my first address to the women of this Diocese (which, incidentally, took place in the Parish House of Christ Church, Christiana Hundred)-was on precisely those needs expressed at the Episcopal Church Women's Caucus-and I asked you to help me achieve those goals in this Diocese.

One year later, in 1970, at your meeting in St. Luke's, Seaford, I again appealed to you for help with this concern, and challenged you to place it high on the priority list of your organization. If you have responded, in an organized way, to either appeal, I am not aware of it-and I share with you this morning my disappointment. This is not to say that we haven't been making progress in our efforts to have greater participation by women in the responsible positions of this Diocese-but it has been much too slow.

In the last three years, we have elected more women to our vestries-but not nearly enough. It is still "tokenism" in almost all of our parishes. In the last three years, we have sent more women as delegates to Diocesan conventions-but not nearly enough. It is still "tokenism" on the part of almost all of our parishes. In the past three years, we have elected three women to an 18 member Diocesan Council-that's one woman and five men each year. At that rate, we'll never have more than three women on Council, because every three years one will be forced to "rotate off". That's "tokenism". The Standing Committee has no women members. That's "zero". Neither do the Trustees. That's "zero". We have elected our first woman Deputy to general convention, and I have had the privilege of appointing one woman Postulant to study for Holy Orders-which means presently, she can be ordained a deacon-period. But this, too, is "tokenism".

What do I want? What does the Church need? It's very simple. At least half of the membership of our vestries should be composed of women. At least half of our Diocesan Conventions should be made up of women delegates. At least half of the membership of Diocesan Council should be women. At least half of the membership of the Standing Committee should be women. At least half of the Trustees should be women. At least half of our representation to General Convention should be women. And at least half of our Postulants studying for Holy Orders should be women.

In every case, at least half! Now, that's very simple to remember, and I really don't believe it's a very difficult goal to achieve.

But it will be difficult without the hard work and full cooperation of the Episcopal Church Women of Delaware!

And that's what I'm asking for-for the third time in four years-for the hard work and full organized cooperation of the E.C.W.

What can you do? That's very simple, too.

At this meeting today you can 1) pass a resolution to the effect that you agree in principle with what I have been saying about this concern; 2) you can request that your president sit down with your Bishop to go over in detail this problem as it exists in this Diocese and to set forth a plan to deal with it which, then, can be presented to your Board for its consideration; and 3) you can appoint two or more of your membership to represent this Body on the Episcopal Women's Caucus so we can broaden our concern and our influence out beyond this Diocese to the whole Church, and, at the same time, receive the benefits of their insights and their learnings.

With names like Emma Lou Benignus, Marian Kelleran, and Cynthia Wedel in their membership, they must have something to offer that, indeed, will help to revitalize this Church.

Now, I know that putting before you a three-part specific request such as this leaves me very vulnerable. I could well be turned down, and I may well be turned down.

But, that's a risk I have to take, because, you see, I really do believe that in the Church "there is neither Jew nor Greek, neither slave nor free, neither male nor female; for we are all one in Christ". I simply want the Church to stop mouthing words and act like it is true. And I believe you do, too. We need your help.

I would close by thanking you, on behalf of the whole Church, for the tremendous contribution that you make, here and throughout the world, through your United Thank Offering. The good that your sacrifices, represented by your ingathering, does for Christ's sake-for His mission and ministry-is not only impressive, but is the cause of joy and thanksgiving on the part of men and women, young and old, everywhere.

God bless you for this offering, and for the ray of hope and love that it continues to bring to a world in which there is much darkness and despair. And thank you for inviting me once again to share in this celebration at which your offering is gathered and presented. It is always a great privilege for me to be with you.

EPISCOPAL CHURCHWOMEN - DIOCESE OF DELAWARE
PRAYER AND WORSHIP COMMITTEE
ANNUAL REPORT 1971 - 1972

Prayers were read at the opening and closing of each meeting of the regularly scheduled ECW Board Meetings which I attended.

In September, a letter was sent to Prayer & Worship Chairmen, or to a representative, in each of the 37 churches in our Diocese with information concerning the three "county days", with an invitation to attend the workshops scheduled at that time. At the prayer and worship workshops, about 10 persons attended each of two workshops and no one attended the one. A closing prayer was distributed to each ECW Chairman conducting workshops to be read at the 2:00 P.M. closing of all workshops at each "county day".

In October, plans were made together with the Diocesan Devotional Chairman, Father Howe, for the annual Devotional Day to be held in February. Decisions as to church, celebrant, and speakers were made at that time and reconfirmed in December. The letter announcing the event to each parish was mailed on January 14. Full details concerning date, time, location, and program were given in the letter.

Devotional Day '72 was attended by about 70 women of the Diocese. It was held Feb. 10, at St. Anne's Church, Middletown, Del., at 10:00 A.M. The Celebrant at Holy Communion was the Rev. Gregory M. Howe, Rector of Christ Church, Dover, assisted by the Rev. Michael G. Mayer, Rector of Calvary Church, Wilmington. This was followed by three addresses on aspects of prayer and worship. The Rev. Henry N. Herndon, Priest Associate, Church of the Ascension, Claymont, spoke on "The Theological Foundation of Prayer". "The Liturgical Implications of Prayer" was the subject of the Rev. Michael G. Mayer. The Rev. Simon Mein, Chaplain, St. Andrew's School, Middletown, spoke on "The Practice of Prayer". After this, luncheon was enjoyed in the Parish Hall.

In April, the Anglican Cycle of Prayer Conference in Albany, New York, was attended and expenses were paid by the ECW Board. A report on this Conference, with a resume of the sermon by Bishop Bardsley of Coventry, England, was given to Board members at our overnite meeting held at Memorial House, Rehoboth, on May 23.

It is with concern that the next year's duties will be accomplished well that I look forward to serving for 1972-73.

CONSTITUTION AND BY-LAWS
EPISCOPAL CHURCHWOMEN, DIOCESE OF DELAWARE
Adopted May 15, 1969

CONSTITUTION

ARTICLE I - Name

The name of this organization shall be the Episcopal Churchwomen, Diocese of Delaware.

ARTICLE II - Object

The object of this organization shall be to work together as committed Christians to fulfill the mission of the Church.

ARTICLE III - Membership

The membership of this organization shall be composed of all women in parishes and missions in the Diocese of Delaware.

ARTICLE IV - Officers

Sec. 1. The elected officers of the organization shall be a President, a Vice-President, a County Representative from each county, a Treasurer and a Recording Secretary. All other officers shall be appointed by the President with the approval of the Executive Board. This body of women shall comprise the Executive Board of the Episcopal Church Women.

Sec. 2. Officers shall be elected or appointed for a term of two years. Any officer may be elected or appointed for a second consecutive term of two years in the same or different office. No officer may serve in any office of the Executive Board for more than four consecutive years without a year intervening before a further election.

Sec. 3. Election of the officers shall be alternated over a period of two years. Election shall be by ballot, each Parish or Mission being entitled to one vote cast by a properly accredited member.

ARTICLE V - Executive Board

The Executive Board shall consist of the above officers, together with such chairman of committees and assistant officers as shall be required; these to be appointed by the President. Any National or Provincial Officers residing in the Diocese of Delaware shall be ex-officio members.

ARTICLE VI - Meetings

Sec. 1. There shall be one annual meeting in the spring at which time all business will be brought before the organization and officers will be installed. Special meetings may be called at the discretion of the President.

Sec. 2. There shall be a fall meeting in each county.

Sec. 3. The Executive Board shall meet subject to the call of the President.

ARTICLE VII - Amendments

This constitution may be amended at any meeting by an affirmative vote of two-thirds of those present and voting, notice having been given of the proposed changes either at a previous meeting, or by submitting the changes in writing to the Parish and Mission presidents at least two months prior to the vote.

BY-LAWS

ARTICLE I - Duties of Officers

Sec. 1. The President shall call all meetings of the organization and of the Executive Board; shall preside at the same, and perform all other duties appertaining to the office. She shall serve as a member ex-officio of all committees. At the Annual Meeting she shall appoint a nominating committee consisting of one member from each county

Sec. 2. The Vice-President shall assist the President, preside in her absence, and succeed to the office of President. In the event of a vacancy in the office of President, the Vice-President shall complete the unexpired term. The Vice-President shall be and she is hereby designated Custodian of the Book of Remembrance.

Sec. 3. The County Representatives shall encourage the organization of new groups in their respective counties and supervise the work of the groups. Each Representative shall submit a written report annually and shall be responsible for any County meetings

Sec. 4. The Recording Secretary shall keep the minutes of all Diocesan Meetings and of the Executive Board, and shall have charge and supervision of the printing and distribution of the Annual Report and other documents.

Sec. 5. The Corresponding Secretary shall conduct all necessary correspondence for the Executive Board and of the Diocesan organization and shall assist the recording secretary with the compilation and distribution of the Annual Report and other documents.

Sec. 6. The Treasurer shall receive and disburse all monies for the organization (with the exception of the United Thank Offering Fund). She shall keep an accurate account of all receipts and disbursements which shall be audited annually.

Sec. 7. The Treasurer of the United Thank Offering shall endeavor to increase and deepen interest in the United Thank Offering, and shall receive and transmit to Episcopal Church Center all the United Thank Offering monies, and make a yearly audited report.

Sec. 8. The Educational Secretary shall arrange for study classes throughout the Diocese, and give information regarding the educational work.

Sec. 9. The Director of the Church Periodical Club, a cooperating agency, shall be a member of the Executive Board and vote.

Sec. 10. The Social Relations Secretary shall have supervision of this work in the Diocese, and cooperate as far as possible with existing social agencies.

ARTICLE II - Finance

Sec. 1. In January each Parish and Mission shall be appraised of the Diocesan budget, and shall be invited to pledge for the coming year.

Sec. 2. The Finance Committee, appointed by the President, shall assist the Treasurer. Its function shall be to draw up the yearly budget for presentation to the Executive Board, Parishes and Missions, and to allocate the pledges, adjusting the amounts received to the various items.

ARTICLE III - Quorum

Fifty members shall constitute a quorum of the Organization. Ten members shall constitute a quorum of the Executive Board.

ARTICLE IV - Delegates

The delegates to the Triennial Meetings shall be the President and two members of the Episcopal Church Women to be elected by ballot. Alternates shall be appointed by the President.

ARTICLE V - Amendments

These by-laws may be amended at any meeting by an affirmative vote of two-thirds of those present and voting, notice having been given of the proposed changes either at a previous meeting, or by submitting the changes in writing to the Parish and Mission presidents at least two months prior to the vote.

SUGGESTIONS FOR PRESIDENTS

1. Make the job of being President a "first" in your life.
2. Begin all tasks with prayer and study.
3. Preside over meetings of the Parish group and the Executive Board. (The Executive Board shall consist of all elected officers, chairman of departments and chapter leaders. If you have a Diocesan officer in your group, do ask her to sit on the Board with you.)
4. Make every member of the group feel that she is important to the success of the whole group.
5. For Parishes with chapters or circles we suggest at least three overall or general meetings each year with a special program designed to help Church-women realize their role in the Church and the world.
6. Familiarize yourself with the work of the whole Church as well as the duties of all committee chairmen. Be sure your chairmen know what is expected of them and they utilize the services of the Diocesan Chairman.
7. Attend all meetings; Parish, Diocesan, and Leadership Conferences and encourage all women of the Parish to attend Diocesan Meetings.
8. Meet the newcomers to the Parish and invite them to the ECW Meetings and see that they have transportation. Membership chairman can be helpful in this duty. Also a card file on all members with pertinent information on "time and talents."
9. Keep any information or correspondence pertaining to the office. Do hand this on to your successor when your term is over.
10. Confer with your predecessor, Rector and Diocesan officer.
11. Parish President might appoint two or more persons to see that all Diocesan meetings are attended but do be careful not to exclude other women.

TO VICE-PRESIDENTS OF ALL PARISHES

It is the duty of the vice-president to act as right hand man to her president. She should acquaint herself with all phases of the work of the women in her church.

She should meet and learn to know as many of the women in the church as she can, paying particular attention to all newcomers.

In some parishes the vice-president automatically acts as program chairman, but this is entirely up to the individual parish.

The vice-president should feel it her responsibility to attend all meetings and functions held by the women, so that she is well prepared to take over in case of the president's absence.

We would suggest that at least one meeting of the executive committee should be presided over by the vice-president in order for her to gain needed experience.

UNITED THANK OFFERING TREASURER

To bring the United Thank Offering as an expression of thanksgiving into the life of every woman of the parish:

- a. Plan a special yearly program on the U. T. O. (Possibilities include the use of films or filmstrips, plays or pageants, and the exhibition of articles made at missions supported by the U. T. O.)

- b. Appoint a committee to see that every woman in the parish as well as the newly confirmed member is given a Blue Box with the available explanatory material.
- c. Arrange with the rector for Corporate Communion and Ingathering Services twice yearly.
- d. Publicize Ingatherings by means of posters, cards, bulletins, letters, etc.
- e. Keep accurate and permanent records of offerings, and report to the Diocesan Treasurer as soon as possible after each ingathering.
- f. Ask the Diocesan Treasurer for assistance, ideas, and information.
- g. Each treasurer should speak of the U. T. O. at every meeting of the ECW in her parish. She should never say "No report." Tell everyone of the satisfaction gained from celebrating your gratitude with a gift and a prayer. Help people express their thankfulness.

EDUCATION CHAIRMAN

The parish education chairman must assume the primary responsibility of widening as much as possible her own concepts of the meaning of Christian Education.

- 1. She should consult with her predecessor, rector, president, and her Diocesan Chairman of Christian Education.
- 2. She should read, and become familiar with material issued by National Council and Diocesan agencies so that she can emphasize what will be meaningful in the local situation.
- 3. She must be prepared to promote all other Departments of Episcopal Churchwomen through program and study. Communication of such information to all Churchwomen is essential. This means attending all Diocesan meetings possible —skill-training, conferences and ecumenical gatherings.
- 4. Continuing this personal study during the entire period of her term of office, she should attempt to bring every woman of the parish into a realization of the scope of the Church through a program of worship, study, and service. Using church publications such as the Episcopalian, Living Church, and other materials available in the Wilmington and Seaford Diocesan Resource Centers, the Diocesan newsletter, Communion, she has a wide choice of resources to assist her in offering study and discussion groups and programs.
- 5. As Program Chairman, or planning with the Program Chairman and other parish leaders, she should attempt to answer the needs of the women of her parish. She might plan in relation to the Christian year and the General Church program as suggested by the Triennial Meeting, the general Mission Study for the year, and the local Diocesan emphasis as set forth by the Bishop, his Cabinet and Executive Council.
- 6. She will encourage members to attend Diocesan meetings and ecumenical meetings such as the annual retreat at Camp Arrowhead, World Community Day, World Day of Prayer, Annual Quiet Day, etc.

The Community, The Diocese, the Nation and the World, is the Episcopal Churchwomen's field of operation. It is the responsibility of the parish Christian Education Chairman, through her understanding of the Church (which is mission) to promote the awareness that each Christian woman is "sent" into the community on mission to those who need her, wherever that may be.

CHURCH PERIODICAL CLUB

Purpose — To provide Bibles, Prayer Books, Hymnals, good textbooks for church workers and institutions when requested.

Responsibilities of Parish C.P.C. chairman:

- a. To encourage every member of the parish to pray for and to cooperate in this work with interest and enthusiasm.
- b. Locate schools, prisons, hospitals, and other institutions in local area where C.P.C. materials may be needed - beside the above mentioned material, games, puzzles, music records, Church School materials, playing cards may be collected for distribution.
- c. See that funds for C.P.C. work are in the women's organization budget, especially for magazine subscription to clergy and institutions in the mission field, and for a yearly contribution to the National book Fund. All funds for these contributions shall be sent to the Diocesan Director for the C.P.C. with itemized memorandum.
- d. Fill annual report and send to Diocesan Director.
- e. Consult and cooperate with Diocesan Director.

CHRISTIAN SOCIAL RELATIONS

Christian Social Relations is a way of living. It begins with our understanding of the Gospel and of the needs of others.

1. Plan a program of social relations projects for your parish. Sources of suggestions will be the Diocesan Chairman, the Diocesan office of Social Relations, and the Church Women United of Delaware. Local situations will be a guide in all activities.
2. Inform the parishes of the Presiding Bishop's Fund World Relief collecting good used clothing for Church World Service, and supplying needs for St. Michael's Day Nursery.
3. Learn of Diocesan concerns and programs for the aging, mental health, institutions, etc.
4. Exercise responsibility for social legislation by reporting opinion of your group to legislators.
5. Attend all meetings arranged by the Diocesan Chairman, or send a substitute.
6. Send a report of your activities to the Diocesan Chairman.

DEVOTIONAL CHAIRMAN

The first responsibility of the Parish Devotional Chairman is the nourishment of her own spiritual life through prayer, study, regular church attendance, and encourage other Churchwomen to do the same.

This prepares her, with the cooperation of the President, Program Chairman and Educational Chairman, to plan devotions that every meeting may be both unified in theme and centered in God's love for His world. In so doing, she works with the assistance of the Rector, who is the spiritual leader of the parish.

So prepared, she will lead devotions sometimes, encouraging and helping others to lead at other times, always stimulating group participation and action which stems out of worship.

Where there are two or more groups, guilds or chapters, she appoints, and aids where necessary, devotional leaders for those groups.

At the same time, she makes available information concerning Retreats, Quiet Days, Bible Study groups and prayer groups, encouraging interest shown in any of these activities. She, also, will help the parish librarian in a selection of devotional resources. She will be cognizant of, and encourage participation in interdenominational worship.

With thoughtful, well-planned devotions the parish chairman can help to keep a group aware of the Christ-centeredness and healing nature of the Church's work in the world.

CHURCH WOMEN UNITED REPRESENTATIVES

Purpose - working as a part of the whole of Christ's Church is of major concern to Episcopal Churchwomen. One expression of concern is our contribution to and relationship with Church Women United recognizing that social needs in a community can better be met by cooperation of all Christian bodies, always enlarging the scope of ecumenical relations. Through prayer and study, witness and service all the women of the Church may better understand the vital necessity of every effort to heal the Body of Christ.

The responsibilities of the parish representative to Church Women United, therefore, are as follows:

1. She should attend meeting of CWU Representatives.
2. She is thus enabled to serve as liaison between the local group of CWU and her parish organization by reporting to her local group special meetings, projects, needs, etc. of the local CWU group and by distributing related materials.
3. She should encourage women to participate in all CWU activities, especially World Community Day, World Day of Prayer and May Fellowship Day.
4. She should cooperate with parish C.S.R. Chairmen in the collection of good used clothing for Church World service and disaster appeals.
5. Looking to her Diocesan Representative to CWU for ideas and information, she should plan a special get-together with the women of other denominations in her community, inspiring them with the necessity of looking at the community in which they live before trying to determine what their areas of work might be.

ALTAR GUILD

1. Reverently care for the altar and its vestments.
2. Prepare for all services of the church.
3. Each Altar Guild sets its own regulations under the sanction of the Bishop of the Diocese and the Priest in charge of the Parish.
