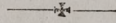

The opening service of the District Branch of the Woman's Auxiliary, for the working year, 1884-'85, was held in St. John's Church, Washington, November 4th, 1884. Although the day was stormy, five of the Clergy of the District and representatives from nearly all the Parish Branches were present. The Holy Communion was Celebrated by the Rev. J. H. Elliott, D. D., Rector of the Ascension, and an address made by the Rev. W. A. Leonard, Rector of St. John's.

Regular meetings for business have been held every month during the winter, with an average representation of six Parishes. Although the actual value of boxes reported is less than that of last year, owing to unusual demands upon some of the workers in their own Parishes, yet it is hoped that the Auxiliary in its quiet way has helped to increase Missionary interest among the Church women of the District. Surely all who attend the meetings must feel the benefit of uniting ourselves in this way; "taking sweet counsel together," as to the various methods of work; listening and responding, as far as possible, to appeals for help from the mission field; hearing the grateful letters that always make us wish to do so much more than we have done; and joining in earnest prayer for the unity of the Church, for her Missions and her Missionaries. But how much more good might be accomplished if *all* the Parishes in the District were united in this common work! How might a spark of true charity be kindled that in time should melt away the cold, unchurchly spirit of *congregationalism* from among us! For this we shall never cease to strive and pray.



We have already seen the benefit of united interest in the impulse given, through the Auxiliary, to varied phases of Church work, resulting in two such organizations as the "Association for Works of Mercy" and "St. Mark's Friendly League for Mission Work." During the past year the League has spread out new Branches, and has brought forth noble fruit; in it the children have done good work for Missions and for their own Parishes. As the report of the League—now numbering six Branches in this city—was read at the Annual Service on Saint Mark's Day, it is not included in the Auxiliary Report; but it may not be amiss to mention that the aggregate value of the League's contributions, in boxes and money, were reported as \$944.40, an advance of \$667.00 over last year. A special Service for the Auxiliary was held on January 23d, in the Church of the Ascension, when the Right Rev. Bishop Elliott, of Western Texas, made a most interesting address; telling of the needs of the great Missionary field in the West, and of how the Auxiliary may help to supply them.

The closing Service for the year was held in St. John's Church, Washington, on Tuesday, May 12th, 1885. The Holy Communion was celebrated by the Right Rev. the Bishop of Louisiana, who addressed the members of the Auxiliary in kind and encouraging words, dwelling chiefly on the meaning of our name—*help*—and showing that the life of helpfulness is the true Christian life. In conclusion he appealed to all the Parishes in the District to unite in this common work. The Annual Report was read by the Rev. A. F. Steele, Rector of St. Mark's.
