FOURTH ANNUAL REPORT OF THE DISTRICT & AUXILIARY.



The opening service of the District Branch of the Woman's Auxiliary, for the working year just ended, was held in St. John's Church, November 3, 1885. The Holy Communion was celebrated by the Rev. J. A. Buck, Rector of St. Paul's Church, Rock Creek, and an address given by the Rev. Dr. Giesy, Rector of the Church of the Epiphany. After the Service a business meeting was held, when the Parishes of Epiphany and St. Luke's united themselves with the Auxiliary, and vacancies in the offices of President and Vice-President were filled. It was very encouraging to welcome two new Parishes at the beginning of the winter's work.

The regular monthly meetings for business have been generally well attended, and the report of boxes shows a large increase in value over that of last year. A new feature of our work during the past winter was the preparation of three *general* boxes, to which all Parish Branches were invited to contribute. The first was sent, before Thanksgiving Day, to the family of a Clergyman in our own neighborhood; the second, at Christmas, to Mrs. Brent's school for colored people at Gordonsville, Virginia; and the third, at Easter, to the Indian Mission at Pine Ridge Agency, Dakota. Such united work not only draws us closer together, but gives each Parish Branch, however small, an opportunity of doing some Missionary work. Boxes from Parishes were sent, in most cases, to Missionaries in our own Diocese, named by the Bishop at the suggestion of the General Secretary in New York; but some have gone to distant parts of the field; and we have united, as heretofore, in supporting a

Memorial Scholarship in St. Mary's School, Shanghai, China, and in contributing to the erection of a Mission Hospital at Tokio, Japan.

A special Service for the Auxiliary was held in St. John's Church, January 15, when a sermon was preached by the Right Reverend, the Bishop of Northern Texas.

The closing Service was held in the same Church on Tuesday, May 18. The Holy Communion was celebrated by the Rev. Dr. Leonard, Rector of St. John's, an address given by the Rev. Dr. Mallory, and the Annual Report read by the Rev. Mr. Reazor.


