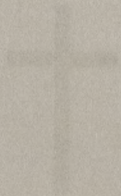

## — FOREWORD —

I send to every member of the Woman's Auxiliary throughout the Diocese cordial and affectionate greetings, and renewed expressions of my gratitude for the faithful and generous service rendered during the past year.

It is an occasion for deep gratitude to know that this great organization has maintained, without diminishing generosity, both its interest and enthusiasm for the cause of Missions both here and throughout the world. Even in the face of a widespread depression, the members of the Auxiliary have "carried on," and always with increasing zeal. If the example of our women could be reflected in the life of the whole Church, the cause of Missions would receive freshened impulse. I strongly believe that now, as never before, we need to press the claims of our Lord's Kingdom. The hope of civilization resides in a fresh affirmation of our faith, and a more practical demonstration of its value in all the concerns of our life.

The diminishing receipts of our General Board in New York will necessitate a curtailment of our missionary work. I fully realize that this condition grows out of the world-wide depression and the more limited incomes of our people. I am reminded in this connection, that when England was exhausting her reserves and carrying on her part of the World War, the contributions to Missions increased rather than diminished.

I am thankful to say that the contributions of this Diocese, considered in the light of those given by other and stronger Dioceses, give us a place of honor and worthy distinction in the Church at large. I should like to remind all the members of the Auxiliary that the gifts for Missions in our Diocese give a very definite impulse to our own local Missions, and that without them, we should find ourselves seriously embarrassed in prosecuting the work we have in hand.

In the face of all the problems that surround us, may we have the courage to say with the great Apostle, St. Paul: "None of these things move me." For my own part I believe that the present critical situation affords us an opportunity for extending our Lord's Kingdom such as we have never hitherto known.

Again assuring every member of the Auxiliary in every Parish of my grateful appreciation of her loyalty to the great cause, I am, as always,

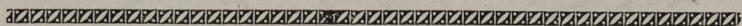

It has been a pleasure to assist in this work and I thank all who have so generously contributed to the Bishop Payne Divinity School Fund.

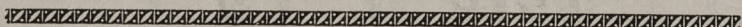

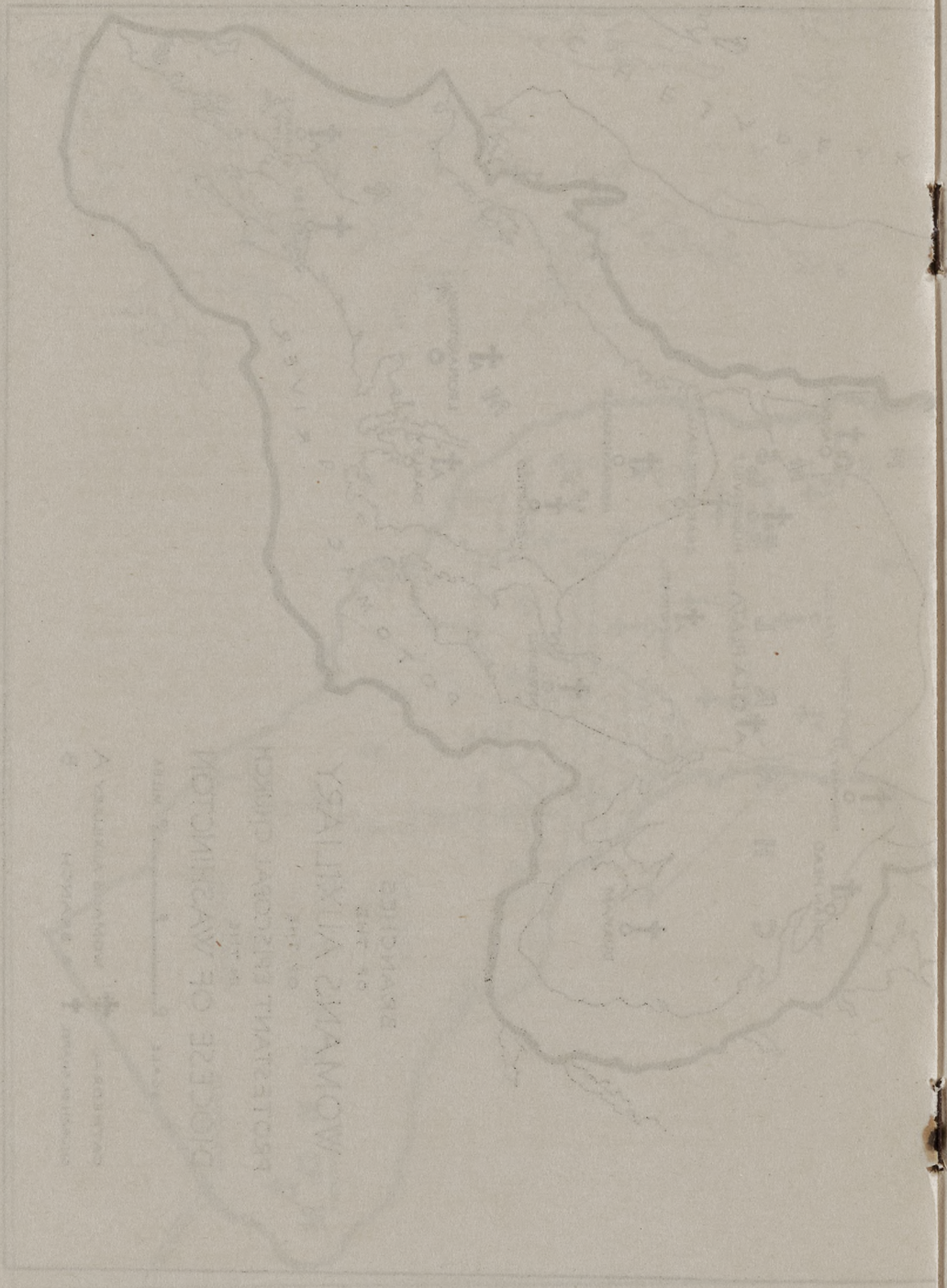














## EDUCATIONAL SECRETARY

A year of great activity and useful study is closing. Beginning just a year ago, we had a six-weeks Normal Class on the development of Christianity in India. The classes ran in three sections each Friday for six weeks. This made it possible for all who wished to attend, and the spirit was enthusiastic and earnest. The result was THIRTY-THREE CLASSES IN THE PARISHES.

Lent over, we went back to our study of The Church's Program, and finished up the remaining parts of this very helpful plan during April and May. May and June are always active months in the Rural Churches. In each of the Counties the Diocesan Educational Secretary has visited several branches:—Montgomery County: Olney, Barnesville and Chevy Chase. Prince George's: Laurel, Hyattsville, Bowie, Bladensburg, Upper Marlboro, Clinton, Brandywine, Croom, Broad Creek, and College Park. Charles County: Hughesville, Newport, LaPlata, Indian Head, Pomonkey, Durham, and Wayside. St. Mary's County: Charlotte Hall, Mechanicsville, Chaptico, Leonardtown, St. Andrew's, and St. Mary's City.

The tour of St. Mary's County under the direction of Mrs. Metcalf, the Vice-President, was something new. Mrs. Graham and I went to every Branch and every group, but one, in the County.

The two Woman's Auxiliary Services at Clinton and at Holy Trinity in July and September, by invitation of the Laymen's Service League, were outstanding.

Summer Conferences were better attended than ever before in June and July. Montgomery and Prince George's Counties had a pilgrimage to every church and chapel with national leaders in charge. Miss Beardsley represented the Woman's Auxiliary. It was our great privilege to have her for a short session on Saturday morning, when the Educational Secretaries could meet her, hear her and ask her questions.

Normal Classes were held in the District, in Charles, St. Mary's and Prince George's Counties. Also, there has been an Educational part in each of the county meetings.

In conjunction with the Department of Religious Education, one of our number has conducted a series of evening classes of coaching for the Church School Teachers, rotating in the city churches, one Sunday evening in each month. Great help was obtained from the case of books loaned us from the Cathedral Library last year, and we hope to have another case this year for use in our study of "Building a Christian Nation", which has to do with conditions in our own country. The Church's Program will complete the year's work.

## THE RECORDING SECRETARY

Year of 1931

The Woman's Auxiliary of the Diocese of Washington consists of 71 Branch Auxiliaries, of which 11 are "B" Branches. The approximate membership is 2,032. Two branches were discontinued during the year: Ascension, Silver Spring, and All Saints' Night Branch. Three new branches were organized: St. Margaret's Night Branch, All Saints' Girls' Branch, and St. Columba's Branch.

Seven business meetings were held during the year, one of which was at 8 o'clock in the evening, and six at the regular hour of 2 o'clock.

The average attendance at these meetings was 192, representing an average of 38 Branches. The greatest number of Branches represented at any one meeting was 48, in January and November, and the largest attendance was 312 at the January, 1931 meeting.

Seven Corporate Communion Services were held during the year.

At the January, November and December meetings, held in St. John's Church, Epiphany, and Bethlehem Chapel, respectively, these services preceded morning Missionary addresses given by Rev. Claude Pickens of China, Bishop McKim of Japan, and Dr. Danner, Secretary of the American Mission to Lepers, the Rev. Leo G. McAfee from Upi, Philippine Islands, and Mrs. Judd, wife of the Governor of Hawaii. The two latter spoke in St. Alban's Guild Hall following the Annual Memorial Service in Bethlehem Chapel, conducted by Bishop Freeman.

In February, the Corporate Communion was held in St. Paul's, Rock Creek, and preceded the Annual Officers' Conference, at which time Conference groups, conducted by Diocesan officers were arranged for Parish Presidents and Vice-presidents, Secretaries, Treasurers, United Thank Offering Custodians, Church Periodical Club Secretaries, Supply Secretaries, Educational Secretaries, Devotional Chairmen, and "B" Branches.

In March, the Corporate Communion was held in St. Thomas' Church, and preceded a service of Devotions and Meditations conducted by Mr. William C. Sturgis.

A Service of Communion, Devotions and Meditations, conducted by Canon Peter, and arranged by the Devotional Department, was held in Trinity Church, Anacostia, on May 22nd.

On September 17th, during the time of the great United Thank Offering Presentation Service in Denver, a Communion Service was arranged by the Diocesan U. T. O. Custodian, and held in Epiphany Church, using the same hymns being sung in Denver.

A joint meeting of the Woman's Auxiliary and the Department of Religious Education was held in Epiphany Church on the evening of March 17.

The Vice-Presidents of the 4 Counties held 6 County meetings during the year.

The Executive Committee, comprising 15 officers, held 7 regular and 2 special meetings during the year with an average attendance of 13.

Others speakers who addressed regular business meetings of the Auxiliary were: The Bishop of Washington; the Rev. Charles Warner, speaking on the Bishop Payne Divinity School; Rev. A. Abbott Hastings on St. Michael's Mission, Ethete, Wyoming; Rev. William G. Branch, on India; Dr. Robert Patton and Mr. Battle on the Advance Work Program and the American Church Institute for Negroes; Rev. Franklin J. Clark, Secretary of the National



Council; the five Delegates from the Woman's Auxiliary of the Diocese of Washington to the Triennial meeting at Denver; and the four recipients of Woman's Auxiliary Scholarships to Summer Conferences.

The Executive Committee, at its December meeting, heard the Rev. Wm. R. Moody, Chairman of the Diocesan Department of Religious Education, speak on a project for young people which he hopes may be developed through the endorsement of the Woman's Auxiliary in co-operation with the Department of Religious Education.

Under her intelligent, enthusiastic and tireless leadership, much has already been accomplished in spite of many difficulties, and in loyalty and affection to her and to our Church, the goal of \$30,000.00 will yet be attained.

The Parish Branches have collected and distributed \$437.23. Of the 43 Branches, 5 are inactive.

While some of the items in the foregoing report show lower figures than those of last year, we feel that the work has been valuable and progressive. In addition to the institutions and persons in the Diocese who have been benefitted, books and magazines have been sent, from the Diocesan Rooms, to 5 Bishops, 17 Clergymen, and Missionaries, to 12 Universities, Colleges and Schools, and to 3 Hospitals.

Working with the Smiley Library, we have helped to send out 5 more Rural Lending Libraries, making 13 of these helpful collections of books that are circulating among the parishes.

We have contributed \$10.00 toward an Encyclopedia Britannica for Bishop Littell's Iolani School, and \$10.00 for Hymnals for a promising Mission School in Alexandria.

When, at Denver, the offering for the Book Endowment Fund was presented at the Corporate Communion of the Church Periodical Club, more than half of the entire amount was given by this Diocese.

A scrap-book, made by a young girl in one of our branches, was so beautifully and intelligently done, that it was used as a model at the Convention before being sent to the mission in China for which it was designed.

The story selected by the Central Office for its pre-Christmas publicity leaflet, "A Christmas Journey for the Church Periodical Club", was written by our Mrs. Henry T. Cook.

With Mrs. Harris, our truly wonderful Registrar, and Mrs. Couden and Mrs. Garlock as Packing Committee, we now have the able and devoted help of Mrs. Staats as Secretary.

Counting on the continued and constant help of each Branch Secretary, we hope the coming year may be one of even greater usefulness.

In response to the questionnaire which was sent out this fall we find that we have about 131 members in the diocese, and we have contributed to the United Thank Offering, Supply Work, Advance Work, some have had study classes, and some have found interesting work to do in the mountains of Virginia.

We look forward to another year hopefully relying on His ever-present power, believing as some one has said: "We need to care for only two things: that we do always our best and that we do what we do through love for Christ."

## THE KULING SCHOOL FUND

I submit the following report as custodian of funds sent through the Diocesan Auxiliary of the Episcopal Church for Kuling, the school for missionary children in Central China, for the year 1931. I feel sure some checks must have been sent direct to New York, as the full amount to date is only \$7, sent through St. Paul's Church, Washington. Last year we sent \$73. May I read to you a statement received from the New York office? "The Trustees confirmed the recommendation of the Board of Managers in China that the organization should be kept intact and that the school should be reopened in the autumn, either in Kuling or in the temporary quarters in Wuhu. I am writing now with the approval of the trustees about the financial situation. My purpose is not to ask for additional assistance but rather to say that if it seems well to you, as we hope it will, to continue your support, you make your gifts for the coming year in at least half the amount you have been in the habit of sending. This does not mean that the full amount would not be used to the School's advantage, but we are making the suggestion for these reasons: (1) the generosity of the School's friends has, on account of the existing situation, enabled us to carry through the past year and leave on hand a comfortable balance to meet immediate needs; (2) the school will carry on for the present on a reduced scale and so should not need, with what we have in hand, more than 50 per cent approximately of its normal income; (3) conditions prevailing today are such that nearly all personal incomes are reduced, while everywhere demands that must be met are multiplied.

"Kuling is glad and grateful to be in such a position as to be able to suggest that part of what has been so loyally provided for its maintenance may for the present, in all fairness, be diverted to other purposes. If emergency arises you may be certain that we shall promptly inform our friends. Another year, or when the school is able again to run under normal conditions we shall need the full income."

The C. S. S. Program is operating in twenty-six parishes. The usual April meeting was held at the Church of Our Saviour, Brookland, at which the Rev. Bland Tucker spoke on our work in Japan. At that meeting the Birthday Thank Offering was stressed, as it was to be given in Denver in the Fall. The amount given by this Diocese was \$356.59. The B. T. O. for the last three years has been collected for the children's ward in St. Luke's Hospital, Tokyo. While the amount is not large, there has been an increase every General Convention. At the Advent meeting in Ascension Mrs. Fletcher spoke on Honolulu, and a pageant on the B. T. O., written by the Supervisor of the C. S. S. P., was given by the children of Ascension. The B. T. O. for the next three years will go toward the building of a chapel in the new building of the Iolani school in Honolulu. 919 Christmas gifts were sent to Ingham and Endicott, Va., the total value, \$459.50. We also sent \$53.00 to Japan for Christmas gifts in Bishop Nichols' Diocese, bringing the total value of our boxes to \$512.50. We sent hymnals costing \$12.00 to a parish in Southern Maryland, and \$5.00 to Mr. Dow for his work in the City Mission. The parishes report having raised and given to the Parish, Community, Diocese, Nation and World the total amount of \$1,131.14.

The Little Helpers have raised \$7.80 this year.
