THE PRESIDENT'S MESSAGE

The Woman's Auxiliary of this Diocese is 61 years old. I am wondering if our organization of splendid women has fulfilled the ideals of that early group who had the vision to separate from the state of Maryland and form their own Diocesan branch. We have increased in members and branches since then, it is true, but would those who started us off as an organization have done any differently? Have we in very truth carried the torch to the best of our ability? Are we really His Disciples?

I go back to an extract from Bishop Freeman's address on our Golden Anniversary in 1925:

"The Woman's Auxiliary has one supreme and supremely important mission. I want you to realize the importance that attaches to this greatest of women's organizations in our Church, the Woman's Auxiliary. God has endowed you with a great responsibility. Follow this with single mindedness of purpose. Do not be led into entangling alliances with other organizations. Keep to your work for the cause of missions, the importance has never been greater than now and it is a tremendous responsibility."

I think those words hold true today as they did then.

There are two forces fighting throughout the world, religion and irreligion, Christianity and godlessness. The task of the Christian Church is both to carry the message of Christ to the individual soul and to create a Christian civilization. It rests with us whether we make the cause of Christ a big adventure or a petty thing. Are you every one, as a special recruiting officer in your branch, carrying the message to every woman in your parish to see that she responds to Church work of some kind in order to carry out her responsibility as a communicant member of the Episcopal Church? Are the young people especially realizing their responsibility? Are you trying to develop leadership in your own branch?

Leadership calls for a definite plan of action, faith in yourself, confidence in your co-workers and the persistence to do the best you can with whatever tools you may have at hand.

There is a lack of adequate support due primarily to the ignorance of the majority of church members who seem to know very little about the words of our Saviour, "Go ye into all the world", hardly anything of their church history thus leaving them in a primary grade instead of having graduated with a degree ready to go forward in the work of the church with complete understanding. This ignorance is ours in part to overcome, for an ignorant church is a retreating church. Bishop Binsted feels that the Woman's Auxiliary is the best informed group of women in the church. With an informed membership there is a truer sense of responsibility for the support of the whole program of the church.

The past year has been a busy one. There have been changes in personnel in the group of Diocesan officers but we start the New Year with all vacancies filled and the sincere hope that this particular branch of the Woman's Auxiliary may go forward as never before. I take this opportunity to thank all those who are working with me, especially those who have helped to promote the work of this organization so successfully. It is with regret that we note that there are still Churches in this Diocese without branches of the Woman's Auxiliary. It is also noted with much regret that two senior branches and one junior branch have disbanded, the first two owing to a change in the churches. This of course means harder work for the recruiting officers, for the ranks must be filled if we are to go forward during the coming year. Women of all parishes and of all ages should share in the work of the church.

If we have faith in our ability to master the obstacles which beset our paths, and if we truly believe, then all things are possible.

"So nigh is grandeur to our dust,
So near is God to man,
When Duty whispers low, Thou must,
The youth replies, I can."

PRINCE GEORGE'S COUNTY

The work of the Woman's Auxiliary in Prince George's County shows a growing interest and enthusiasm manifested in the splendid attendance and encouraging reports of the branches at both the Spring and Fall meetings.

The former was held May 14, 1935, at St. Barnabas Church, Oxon Hill, with Holy Communion celebrated by the Rector, The Rev. William H. Heigham. His sermon was on the subject of The Cross.

Following the business session in the afternoon, Miss Lillian Brown of St. Anne's Mission, Alberene, Virginia, made a most moving address, telling of her life and experience among the mountain people. The various Diocesan officers present made short talks on their departments, which always adds to the interest and proves stimulating to the work.

The Fall meeting which took place at St. Barnabas, Leeland, October 17, 1935, began with Holy Communion, celebrated by The Rev. J. C. M. Shrewsbury, who was assisted by The Rev. F. A. Cook of Holy Trinity Parish. An address on the Forward Movement by The Rev. Clyde Brown, followed.

At the afternoon session plans for the Winter's work were announced by Branch Presidents. Mrs. Holt, Diocesan President, greeted the gathering and gave a stirring talk, urging renewed zeal for the Church's mission, as exemplified by the Woman's Auxiliary. The officers and visitors from Washington made an impressive delegation.

The high light of the afternoon was the address on Peru by Mrs. Paul G. Ledig of Bethesda, who appeared in native costume, and charmed her hearers with her presentation of the life, manners and customs of the people and the worthwhileness of the work among them. An interesting exhibit of arts and crafts of great variety was an attractive feature.

The Prince George's County branches are carrying on with faith and zeal, with high hopes of interesting more women in the parishes and of adding a new branch at Epiphany, Forestville, in the near future.

We meet monthly, usually a half-hour before the Diocesan meeting, for a short period of intercessory prayer and then to plan and discuss our work and distribute literature.

We wish to record our thanks to the busy clergyman and doctor who gave of their valuable time, and to all, for their helpful, practical, and inspiring messages.

On March fifth, Dr. T. A. Conover conducted a Quiet Day on "The Christian Faith and Practice as outlined in the Forward Movement". It was well attended and a most profitable day. The simplicity and saintliness of the conductor was most impressive.

An opportunity to meet with those of other communions was afforded by "The World Day of Prayer" as observed annually the first Friday in Lent.

The May meeting being the last until November, plans were suggested for activities during the summer such as the following:

1. To use daily the Auxiliary Prayers, and Mid-day Prayer for Missions which bind us together wherever we are.
2. To visit the Shut-ins and the sick.
3. To go over the list of members with the president and call on those who take no part or appear indifferent and revive their interest. Try to increase membership.

Mention should be made of the Whitsun-tide Morning of Devotion held June sixth at the Church of the Epiphany and planned by that very active Devotional Group. To Dr. Phillips our thanks are due for his inspiring talks along the thought of Discipleship.

The new Chairman of Junior Branches called an Officers' Conference for the evening of October twenty-fifth. Mrs. H. L. Choate presided over the Devotional Conference and was pleased with the interest and possibilities of these younger women. The committee is ready and anxious to serve them in every way and particularly to visit their groups.

About two thousand leaflets were distributed for the Armistice Day of Prayer. From all accounts it was more generally observed throughout the diocese, this being the third consecutive year of its observance.

With the Forward Movement invigorating the life of our Church members by stressing the importance of Prayer, Bible Reading, and Discipleship, we feel the year ahead should be one of deeper consecration and greater progress—a little nearer the time "when the earth shall be filled with the glory of God as the waters cover the sea."

SOCIAL SERVICE COMMITTEE

In the second year of its existence the Social Service Committee, with its increased membership, has been able to be of considerable benefit to our Episcopal City Mission in its great work in aiding the poor and needy.

Our Committee now consists of twenty-six social service secretaries and it is hoped to further increase the number of parishes and consequently the number of social service secretaries, so that practically every church will be represented.

It is therefore urged that the Committee make every effort to interest parishes not represented, in order that this work may be carried on to meet the ever increasing needs.

Special efforts were made, both at Thanksgiving and at Christmas, to secure donations of funds, clothing and food supplies. The results were gratifying indeed and the Mission has been better able to meet its constant demands.

At Thanksgiving the donations enabled the Mission to care for 125 needy men, women and children, and at Christmas a total of 300 baskets of choice fruits were packed and distributed to the shut-ins at the various hospitals and institutions. In addition, 50 baskets of food were sent to families in an effort to make the season for them a happy one.

Many of the branches, through their social service secretaries and others, have sent considerable clothing, food supplies, toys and furniture to the Mission at various times during the year, especially during the past few months when needs were greater because of the severe cold weather.

Twenty-one Auxiliary branches pledged a certain amount of money during the year to be sent to Mr. Dow for relief work:

Other Auxiliary branches, including St. Stephen's and The Incarnation; Christ Church, Kensington; St. John's; and individuals, have sent generous money donations during the year.

A total of \$299.89 was received for relief work. This amount includes funds received from pledges.

Certain Auxiliary branches, as a result of information received from Mr. Dow, City Missioner, purchased clothing, especially for children, and others have sent numerous boxes and packages of clothing and food to the Mission.

All Souls Memorial Church continued to be generous in cash donations, assisting in individual cases and in furnishing food and clothing. This is especially mentioned because All Souls Church has been the most responsive in this practically new social service work. Of course many others, too, have made splendid contributions, and even the smallest donations and packages of food and clothing are appreciated; and it is hoped that not only our present social service secretaries and their assistants will continue their good work, but that the interest of others will be sought and obtained so that needed funds, groceries, clothing, etc., may be secured during the coming year to help Mr. Dow and his assistants to take care of unfortunate families and individuals in distress.

I take this opportunity of extending thanks to all of the social service secretaries and our other good friends for their thoughts, contributions of funds, donations of clothing, furniture and food supplies.

Mr. Dow deeply appreciates the assistance and donations of the Auxiliary. It should be remembered, however, that while the maximum possible benefit has been attained during the year it has been impossible to fully meet the calls that Mr. Dow is constantly receiving for help. It is therefore urged that every effort be made to further this useful welfare work.

The Woman's Auxiliary to the National Council in the Diocese of Washington consists of 59 Branch Auxiliaries and 10 Junior Woman's Auxiliaries. The total membership is approximately 1200.

REPORT OF THE EDUCATIONAL DEPARTMENT

This department thinks numbers are significant, and that an increase in the Normal Classes enrolment, new Educational groups with new leaders in three branches, as well as a general increase in the Educational work, indicate progress. We held six pre-Advent Normal classes with thirty-six on the roll and an average attendance of twenty-seven, and six pre-Lenten Normal classes with a roll of thirty-five and an average attendance of twenty. Reports sent in from the Branch study classes last April, show by actual count that we are in touch with over six hundred women of the Diocese, just half of those in the Auxiliary, and our goal is of course, to reach them all. With the disbanding of Advent Parish, we have lost one class, though several of its members still attend the Normal classes and we know their good work is going on in the parishes they have joined.

Our subject, "Understanding Japan," was timely and most interesting and we went over the ground geographically, politically, historically, nationally, as well as religiously, discovering how important and how comprehensive the work of our Church is in Japan. The Educational Department had charge of the Diocesan meeting held at Christ Church, Georgetown, when the Reverend Bland Tucker gave us an address on Japan, where he lived for several years, so bringing us into direct touch with the Church there.

One of the accomplishments of the year was an Educational Conference held at Holiday House, Mt. Vernon Highway, May 16, at which sixty-one were present. We began with one of the luncheons for which Holiday House is famous, then met in the Chapel for discussion, reports and a pre-view of the work ahead. We hope to expand this idea in the province.

REPORT OF THE KULING SCHOOL COMMITTEE, 1935

The past year of the work of the Kuling School Committee has been most encouraging. In January a meeting was called by the Rev. Z. B. Phillips, D.D., the Chairman. Dr. Hart, rector of St. John's Church, and Dr. McCartney, Pastor of the Church of the Covenant were asked to serve on this Joint Committee. Ways for raising money for the school were discussed. Mr. Roy Allgood, headmaster, was in this country on furlough and came to Washington bringing colored slides of the school. On February 8th, the lecture was held in the Church of the Covenant. Mrs. Edmund Lee, a former missionary in China and at present at Chatham Hall, Va., came and spoke on what the school meant to the missionaries and what it did for their children. A silver offering was taken and pledge cards were available for those who wished them. Some made pledges for three years some for one year. The expenses for the evening were very small as the speakers wished to donate their services to the cause of Kuling. At that entertainment from cash, checks and pledges the amount of \$179.65 was realized. Since then a number of contributions have been received which brings the total amount for the year to \$366.40.

We regret the three resignations due to illness or overwork which were received from Mrs. Charles Wood and Mrs. Walter Compton, of the Presbyterian group and from Mrs. Katherine Hopkins of the Episcopalian group.

It is a keen pleasure to me that Dr. Phillips has appointed Mrs. Russell Borhek as my successor for I feel confident the work for Kuling School will go forward.

Let us call to mind the necessity of sending aid to our faithful missionaries in distant fields, who need our prayers and gifts for the education of their children.
