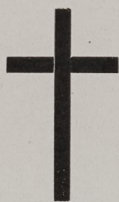

Throughout my entire ministry of forty-three years, as Rector of Parishes and as Bishop, I have looked to the Auxiliary as one of the stablest and most consecrated of our Church organizations. Entirely apart from the work the Auxiliary does and the liberal contributions it makes to the cause of missions it has large value in keeping our Parishes informed as to the progress of the missionary enterprise at home and abroad. That this contribution is reflected in the life of every parish is made evident by the increasing gifts that are made to the missionary cause. It must be gratifying to the Auxiliary to know that while this Diocese made a commitment to general missions for the year 1936 of \$25,000, there has been transmitted to the Council in New York over \$31,000. I am confident that the members of the Auxiliary share with me the satisfaction I feel in this growing interest in the missionary enterprise. Although little is said concerning the silent and substantial gifts made by the Woman's Auxiliary to the United Thank Offering Fund, that represents in a very real sense sacrificial giving and in the aggregate does so much to maintain the service rendered by women in the far-flung missionary field year in and year out, in periods of prosperity as in those of depression, still the Auxiliary carries on, asking for no undue praise and seeking no reward. Its one central interest is the cause of the Kingdom throughout the world.

I pay personal tribute to the unfailing devotion of the members of this noble Church organization, and through the pages of the Year Book, I express my gratitude to each and every member.

She takes this opportunity to thank all those who have carried on the work with her during the past year. Words of appreciation fall far short of the mark when she realizes the tremendous amount of work each Diocesan Officer has done.

With new branches both senior and junior, a larger number present at the monthly meetings thus making a larger average attendance for the year, and an increase in our missionary budget, the branches present a splendid showing for 1936.

There should be no "specials," of any kind until all regular obligations are met. "There is romance in a special but loyalty in the support of the budget. This great thing that we do together," calls for all the support of every branch until a glorious victory is achieved and as usual that victory depends upon the individual members, your President can only point the way.

Many branches have been visited as well as the Maryland Counties embraced in this Diocese and everywhere there is earnest work and the spirit of cooperation. Your President attended the Orkney Conference in June, the Provincial Synod in October and the Richmond Conference in November, each one a very real help and inspiration.

Our Bulletin has been reduced to three issues a year but our portion of the provincial budget and our Missionary Quota both have been increased and so we try to measure up to the necessary requirements. If the Woman's Auxiliary is to arouse the concern of the women of today it must engage in activities of tremendous significance.

High hearts are never long without hearing some new call, and those whose worship is action and whose action is ceaseless aspiration go on from strength to strength. May we all do that during the New Year 1937.

Both have been branch Presidents for many years, untiring in their efforts to promote the Auxiliary cause. These branches have reorganized under able leaders.

The Fall meeting was held November 6, 1936, at Christ Church, Clinton, with the Rev. James Valliant celebrating Holy Communion. A spirited address by the Rev. Walter Archbold followed.

At the afternoon session plans for the winter's work were announced by the branch presidents. Mrs. Holt, Diocesan President greeted the gathering and gave an impressive talk while other diocesan officers presented the work of their departments.

The guest speaker was the Rev. Oliver J. Hart of St. John's, Washington, whose inspiring and challenging address was the high point of an interesting day.

The names of Mrs. George Harris of St. Luke's, Bladensburg and Mrs. Melborne of St. Phillips, Laurel, were offered in nomination as county vice-president and secretary for the next three years.

This year we have emphasized the importance of keeping in close touch with our missionaries. We hope the page in the Year Book with the prayers and names of those gone forth from our Diocese is known and used. The committee took the Rev. and Mrs. C. L. Pickens and family for their prayer-partners. Several letters have been written and received and part of one letter published in the "Auxiliary News." At Easter we sent them "North to the Orient" by Anne Lindbergh and later a check for \$13.00 for their work. We feel we have been "drawn into closer fellowship with them" and they in turn have been encouraged and helped by our interest and prayers.

There have been several conferences: at one, the Rev. Mr. Armstrong of Christ Church gave an inspiring short meditation; at another Miss Elizabeth Barber, a retired missionary spoke to us on Prayer.

"Religion in Family Life" was the subject of an all-day conference at Holiday House on May 19th. We were most fortunate to have Mrs. Harper Sibley to conduct it. She most ably presented the subject and we wish to record our thanks and appreciation. There were seventy-four present from twenty-three branches and we trust that plans have been considered to present this important subject to the parishes.

The literature for the Armistice Day of Prayer was again distributed and the day is generally observed in the Diocese. A small but increasing number have met with the other communions the first Friday in Lent for the World Day of Prayer.

We continue to meet a half hour before the monthly meeting. Our largest attendance was 47, at the March meeting before the Quiet Day conducted by Dr. Don Frank Fenn.

Our colored branches have shown much interest in the devotional work and been most responsive. We visited one rural group in Southern Maryland which impressed us with its deep earnestness. They have built a hall for their Church School and meetings.

The Forward Movement literature has been given publicity and has proved most helpful.

May we use this inspiring literature and go "Forward."

THE RECORDING SECRETARY

The Woman's Auxiliary to the National Council in the Diocese of Washington is made up of sixty-five Branch Auxiliaries and thirteen Junior Woman's Auxiliaries. The total membership is approximately 1,400.

During the year, one Parish consolidated its Senior and Junior branches; four new Senior branches were formed; one Senior branch reorganized; and three new Junior branches started.

Six business meetings were held during the year. The average attendance was 189. (This figure is based on roll call at four meetings—actual count at one—and estimated number at two meetings. At the four meetings when roll was called, there was an average of 36 Branches represented.) The greatest number of branches represented at any one meeting was forty-seven, and the largest attendance 311—both at the January meeting. Following the Annual Memorial service at the Cathedral, an officers' conference was held in Satterlee Hall.

Four of the six meetings were preceeded by a Corporate Communion. The Autumn presentation of the United Thank Offering was made at a Celebration of the Holy Communion. "A Quiet Day" was held in March, replacing the usual business meeting.

At the January meeting three new officers were elected to serve for three years following their election. They are:

UNITED THANK OFFERING

In the year 1936, \$6,027.44 has been presented as a United Thank Offering from the Women of the Diocese of Washington.

The presentation services were held on April 26, 1936 at 8 p. m., at Epiphany Church with Dr. Ze Barney Phillips as preacher and on October 22, 1936 at St. Thomas' Church when the Rev. Herbert A. Donovan told of his personal knowledge of the work of the United Thank Offering.

As Diocesan United Thank Offering Treasurer, I have attended all Diocesan and Executive Committee Meetings, four County meetings and upon invitation have attended seven Parish Branches where I have told what the United Thank Offering does and the joy received from the use of the Blue Box.

It was my privilege to go as a delegate to both the meeting of the Province held in Wilmington, Delaware, in October and to Richmond, Va., in November, to the Regional Conference of Auxiliary Leaders. At the latter conference, I learned that it was far wiser to send the United Thank Offering to Mr. Franklin, National Treasurer of the Episcopal Church, twice a year, as he was able to obtain a larger rate of interest, than the banks allow on savings accounts, said interest to be credited to the Diocese.

I, therefore, after the motion of the Executive Board, sent to Mr. Franklin \$11,741.15 the offering of this Diocese for the last two years.

In the next year, it is our hope that every woman in every parish may own and use a Blue Box so that when the offering is presented next October at the time of the General Convention, it may be one of which we can be proud.

REPORT OF THE EDUCATIONAL SECRETARY

The first year of any secretary's triennium cannot be but to some extent experimental. Coming into office at Easter she has so far been continually facing new responsibilities, as well as changes in the office of department Librarian. The much regretted retirement of both Miss Mary and Miss Martha Burton, successively, from this indispensable post has necessarily implied some lack of coordination. I am fortunately able to announce as present Librarian, Mrs. Charles Shaffer, 3443 Oakwood Terrace.

There have been held during 1936 one series of pre-Lenten normal classes by Miss Hyde on Latin America and one series by Mrs. Peirson on The Development of Missions in America. Leaders from twenty-nine branches have attended these classes.

Miss Hyde's after-Easter reports show the average attendance at the parish branch classes to have been 366, for the 24 reports returned. This of course indicates a much larger number reached to some extent, out of an estimated total membership of these branches of 760. This we believe to be a good advance over previous years, but in matters of education, leaders can at best only make haste slowly.

During the current season the present secretary is teaching two subjects instead of one, believing that by so doing she may cover a wider field. Her first series, already named, has been designed primarily to strengthen leaders, although the subject is most certainly suitable for branch classes. The pre-Lenten subject will be Africa.

Other 1936 activities include the annual educational conference held at G. F. S. Holiday House in May. At this time both the Rev. F. Bland Tucker and Miss Ridgeley, formerly of Liberia, addressed the gathered leaders, greatly to their interest and profit. During a most pleasant luncheon hour we were favored by the presence of an African princess!

The secretary has, in addition to attendance at the regular spring and fall county meetings, met twenty-five women from Prince George's and St. Mary's counties in a special Educational afternoon in November at the home of Mrs. Sothoron, Charlotte Hall. This experiment proved pleasant and successful, and others of like character may hereafter be attempted. The secretary is also greatly interested in her visits to city parish branches, as opportunity offers.
